The ornamental design for a quadruped robot, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and top perspective view of a quadruped robot, showing our new design;

FIG. 7 is a top plan view thereof;

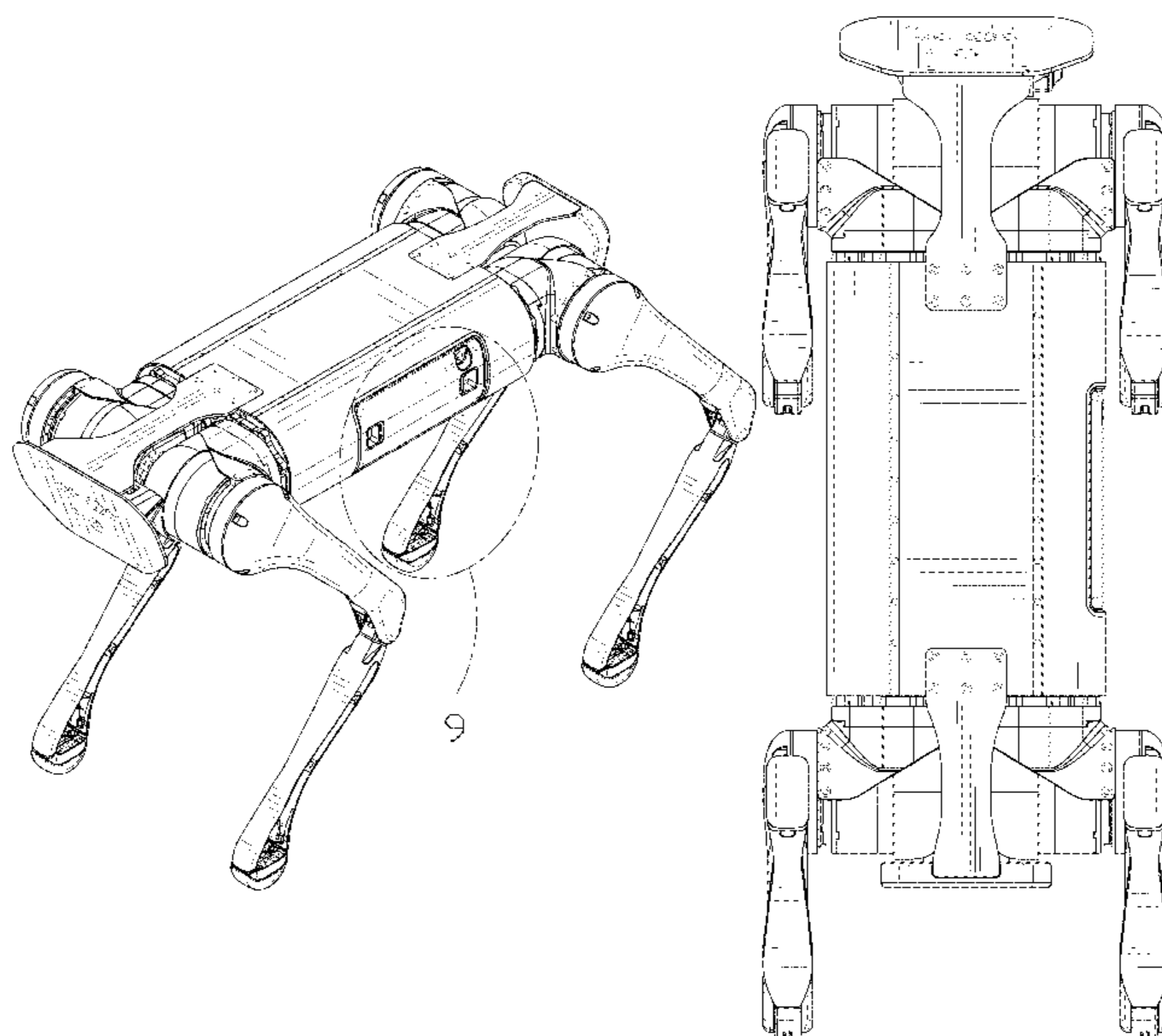
FIG. 8 is a bottom plan view thereof;

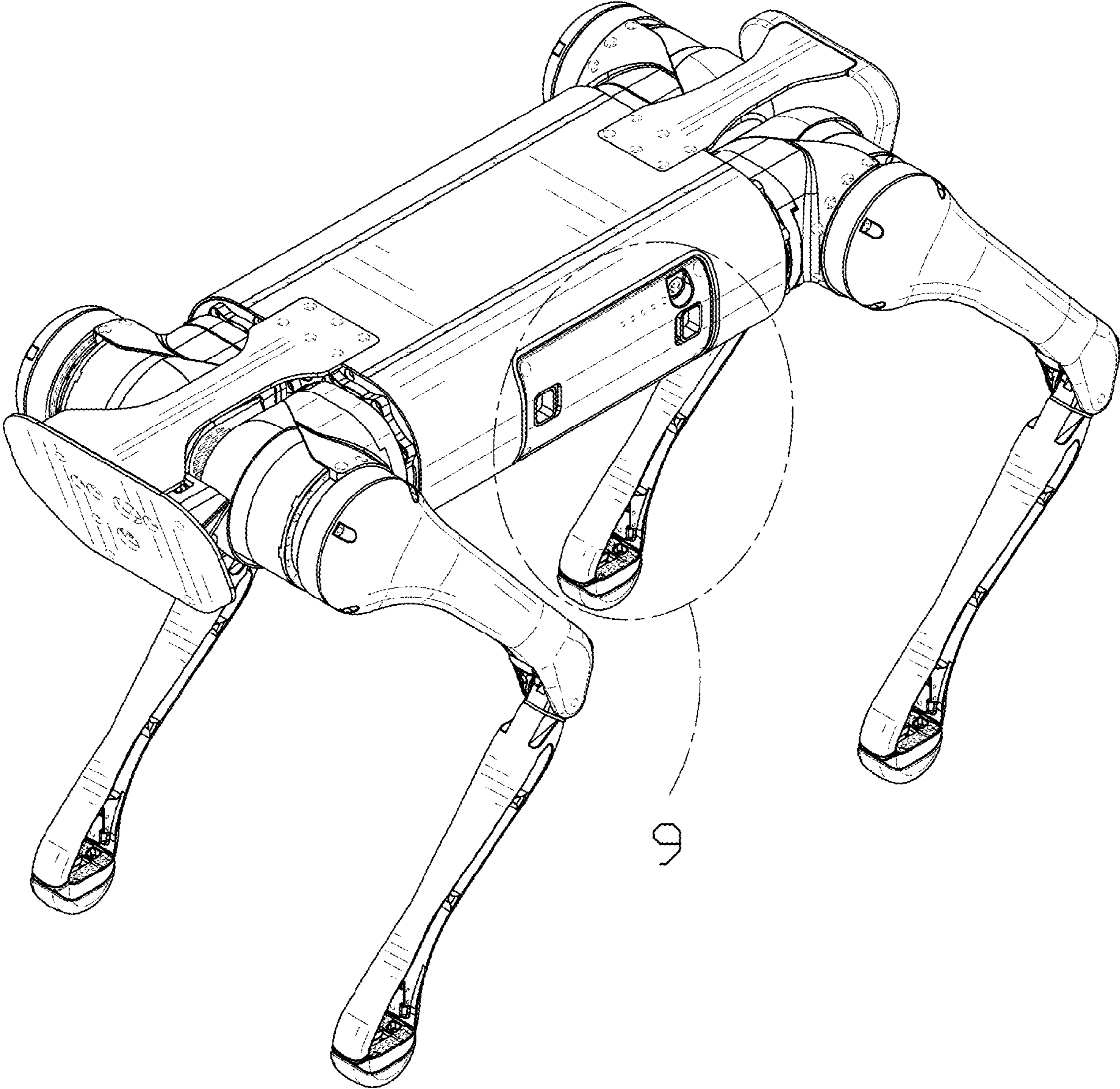

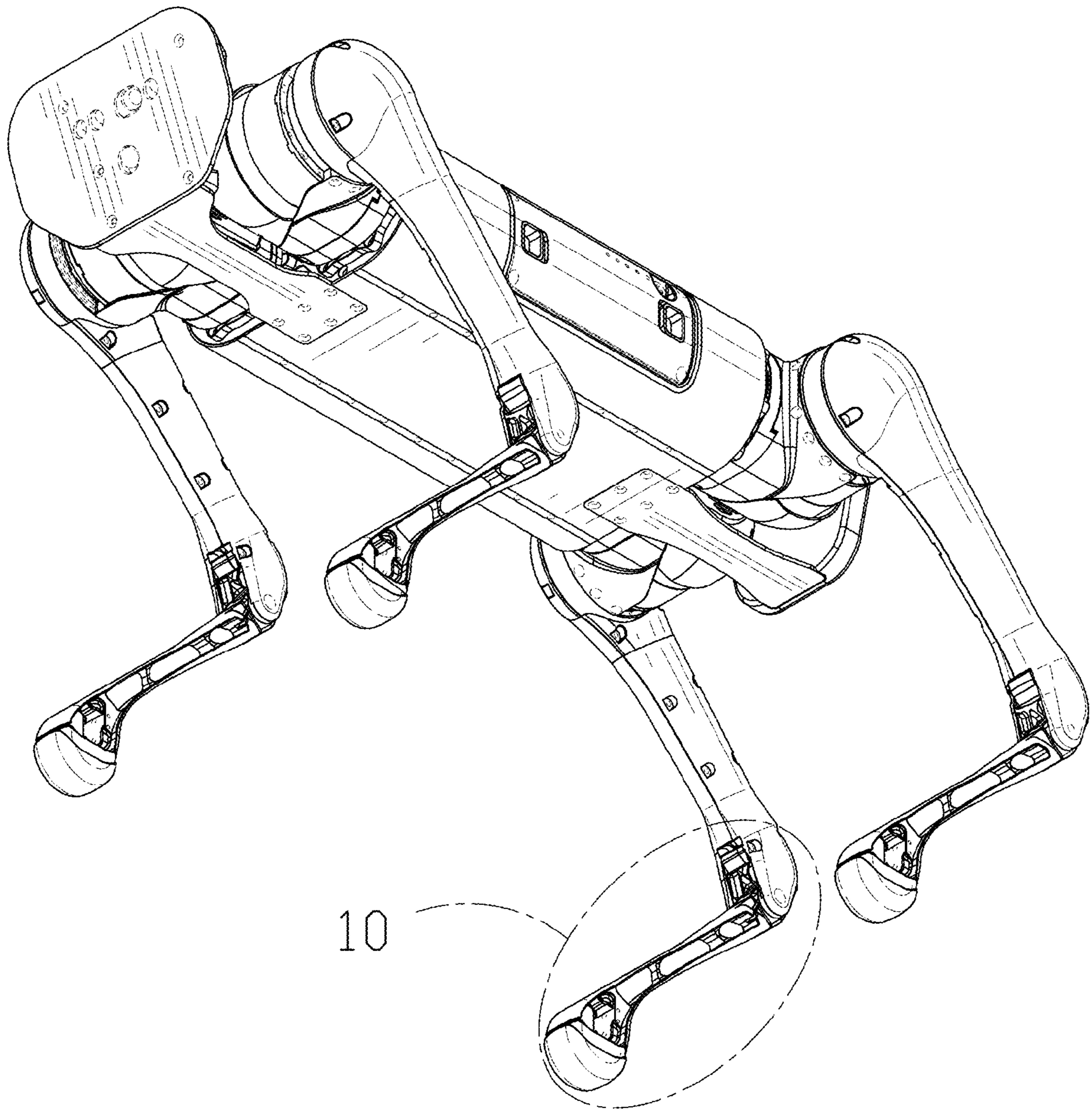

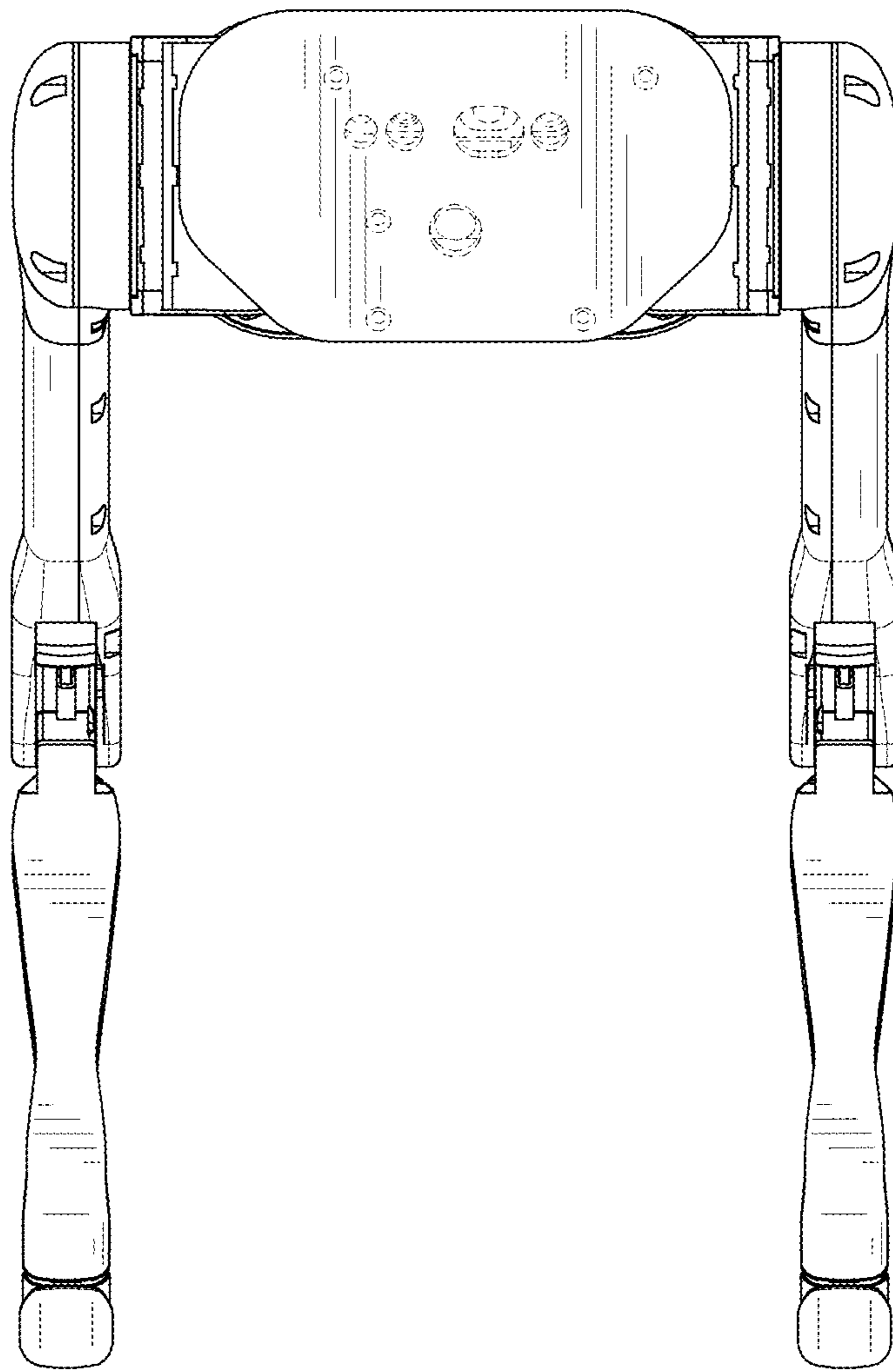

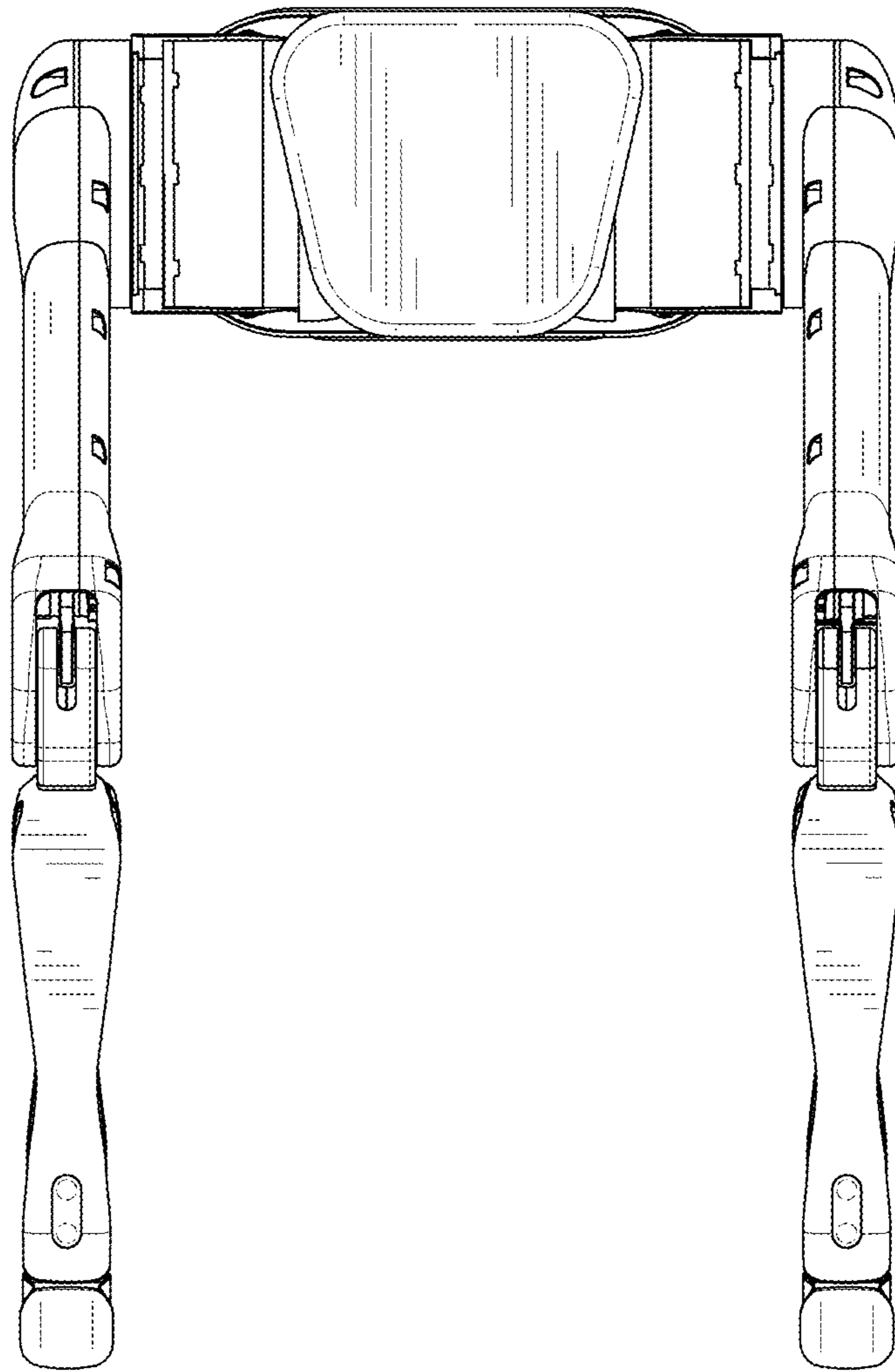

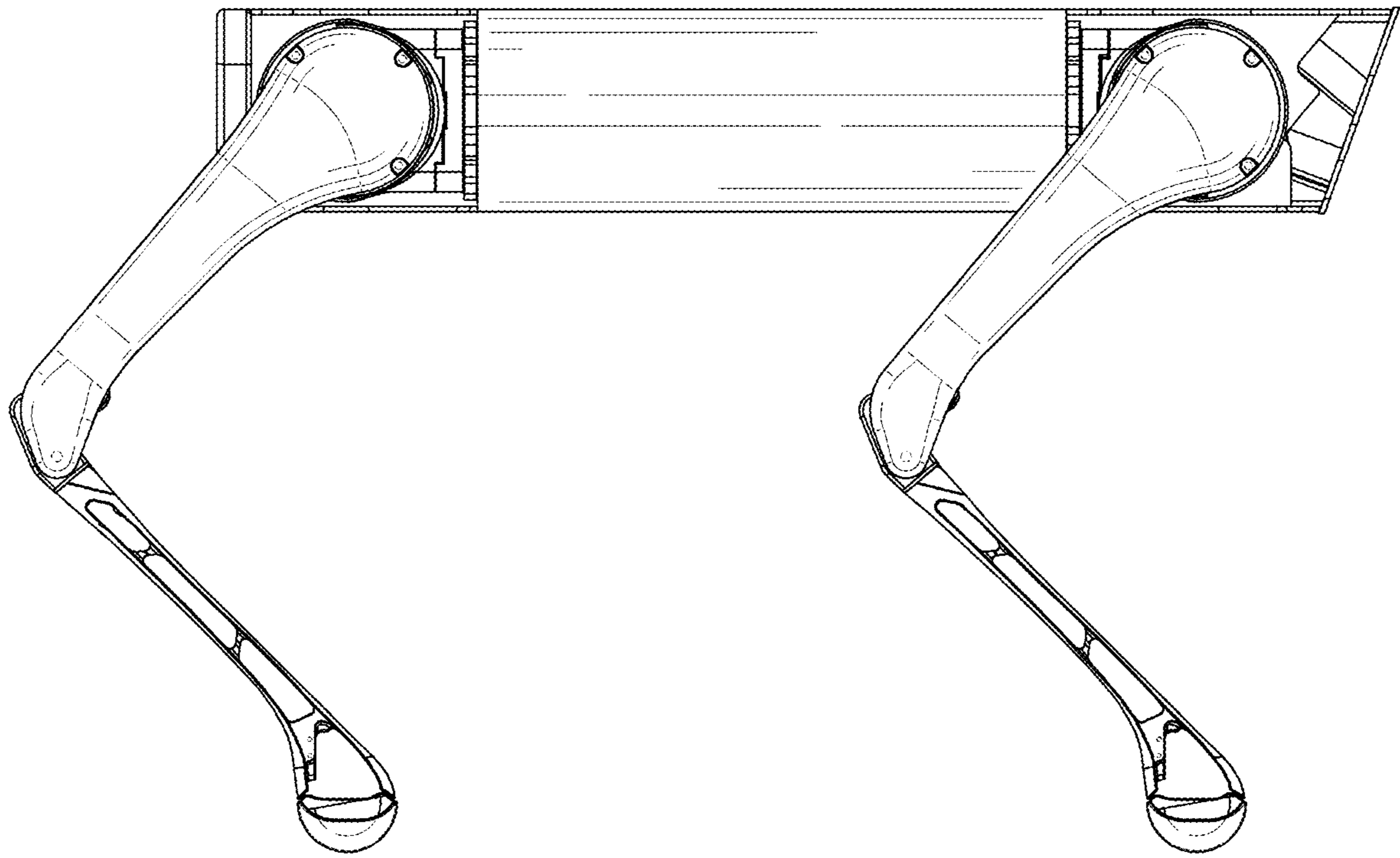

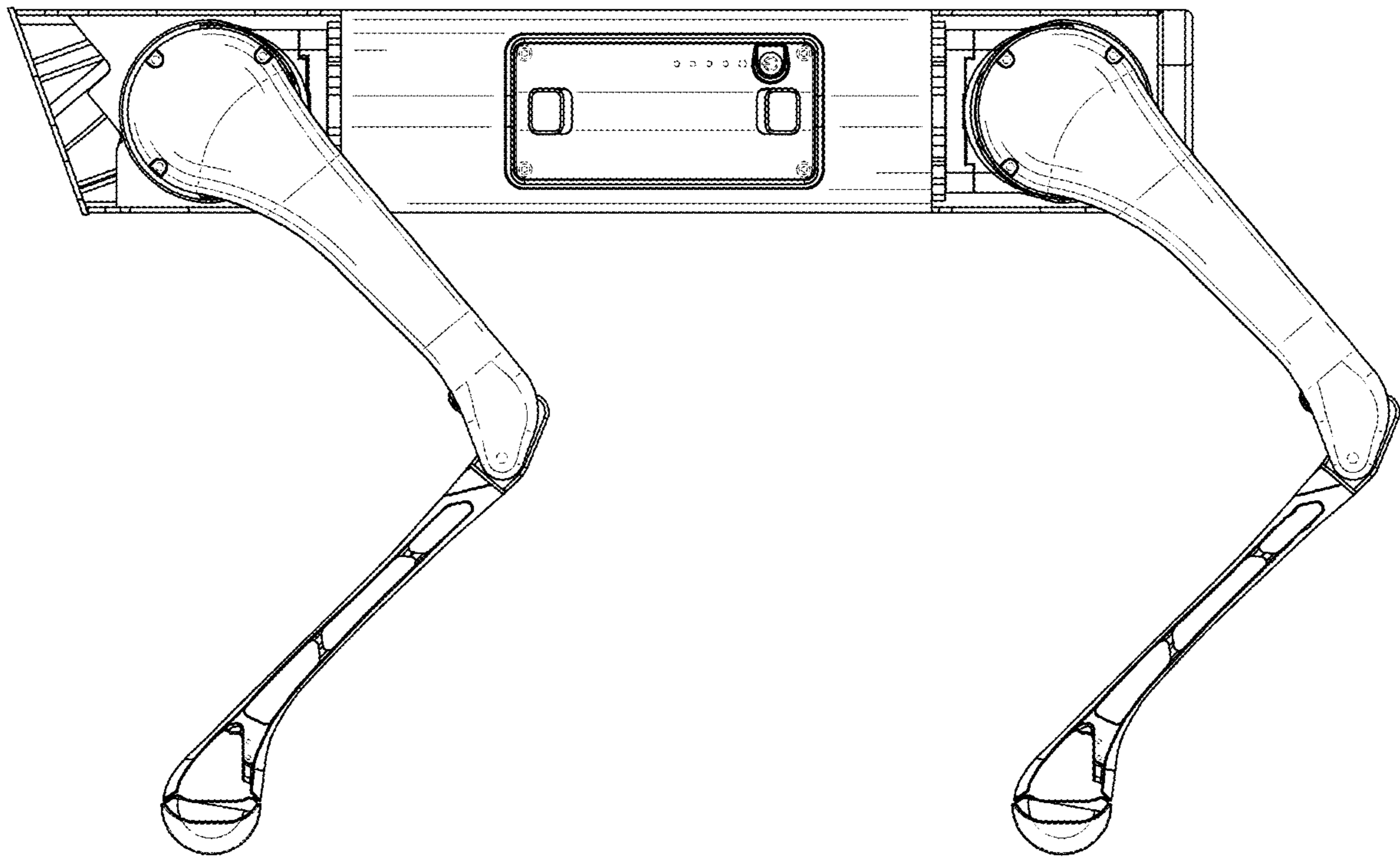

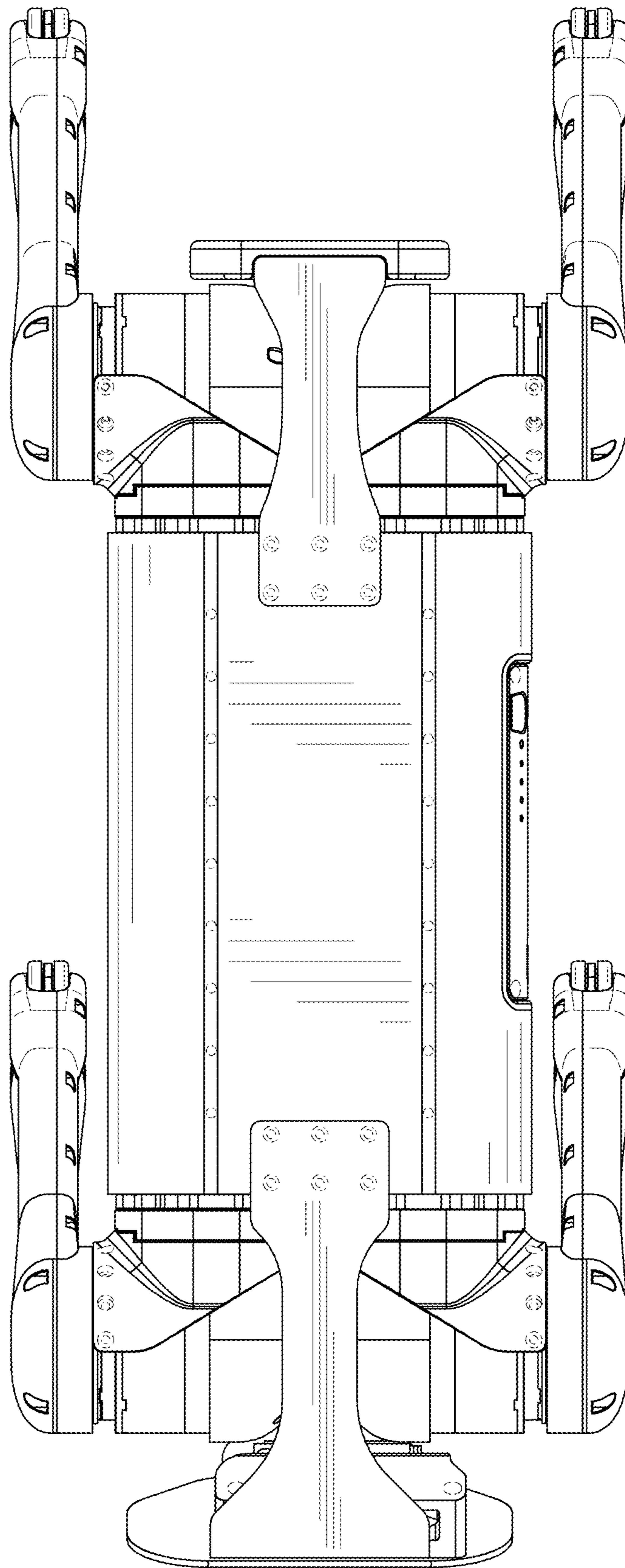

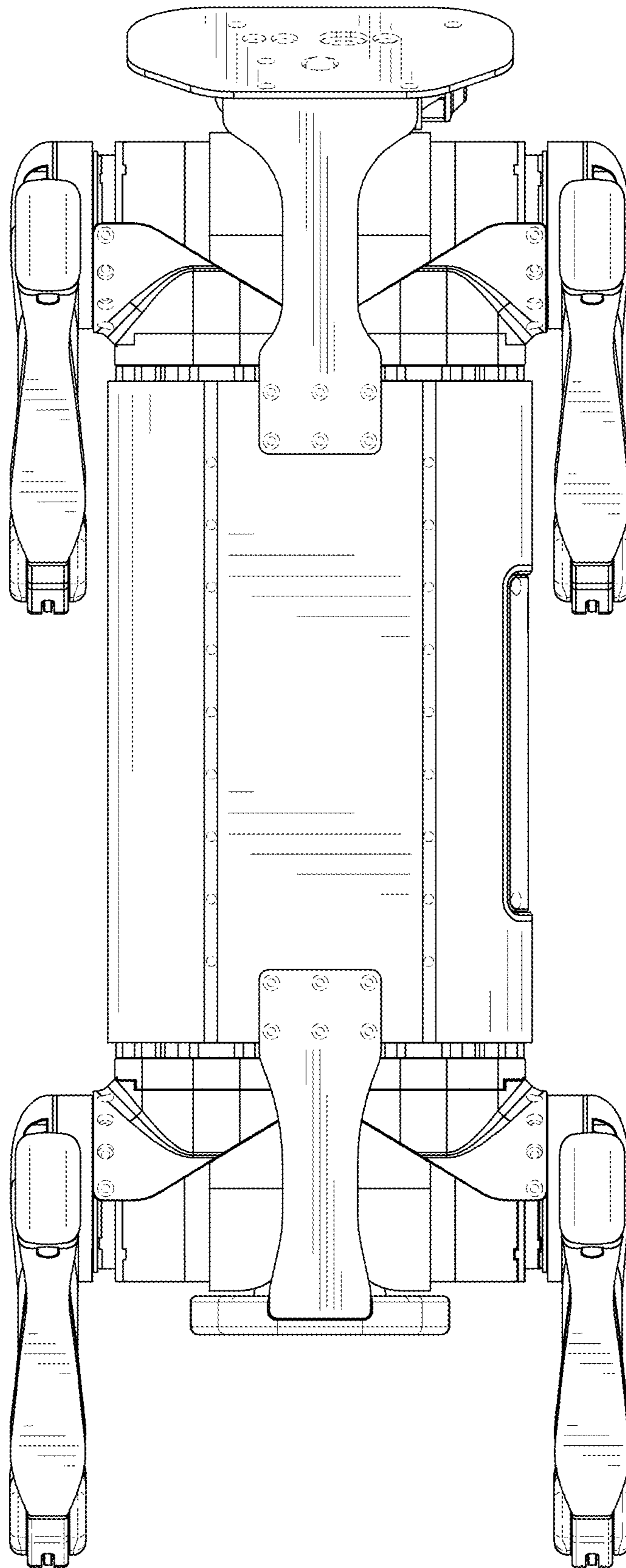

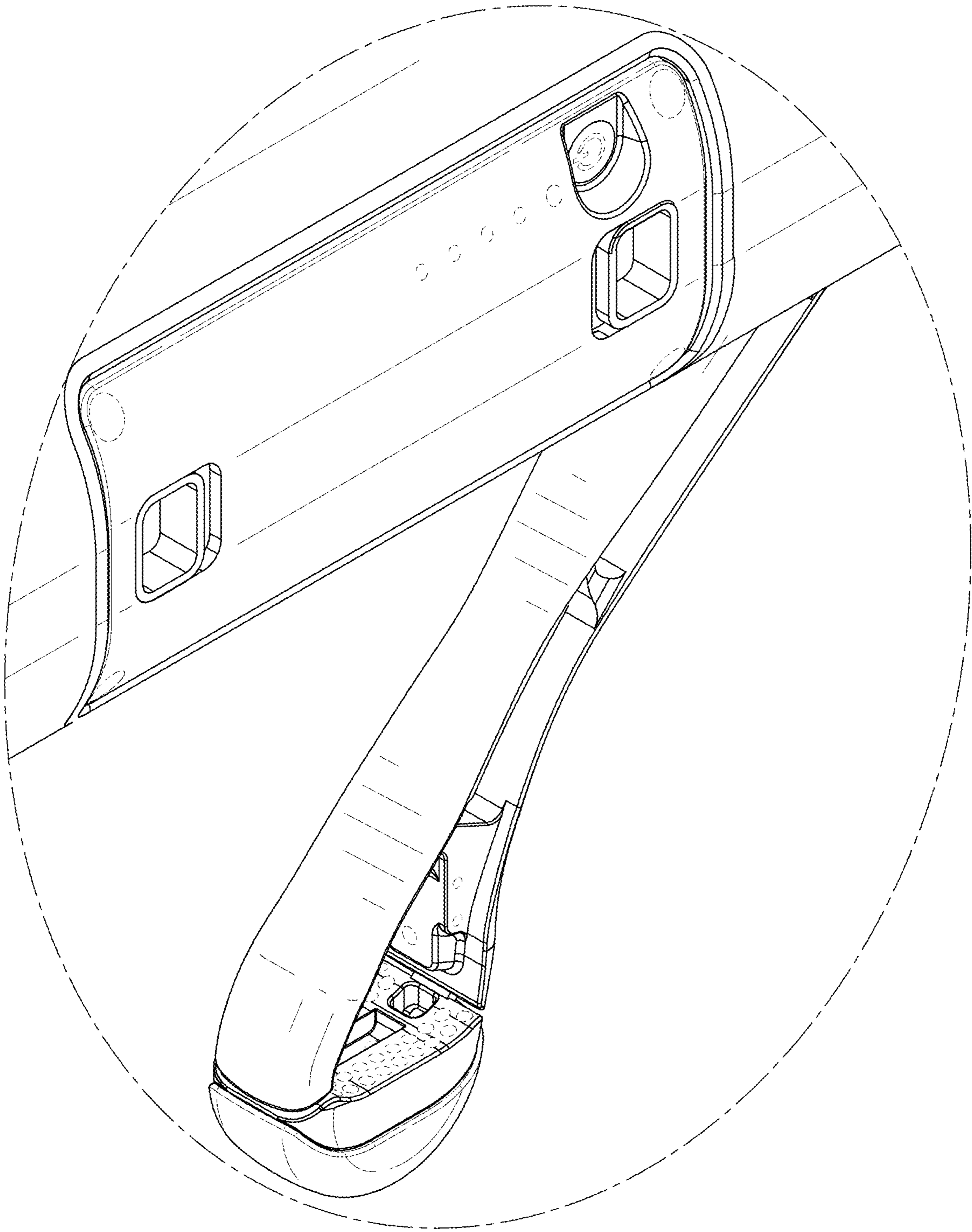

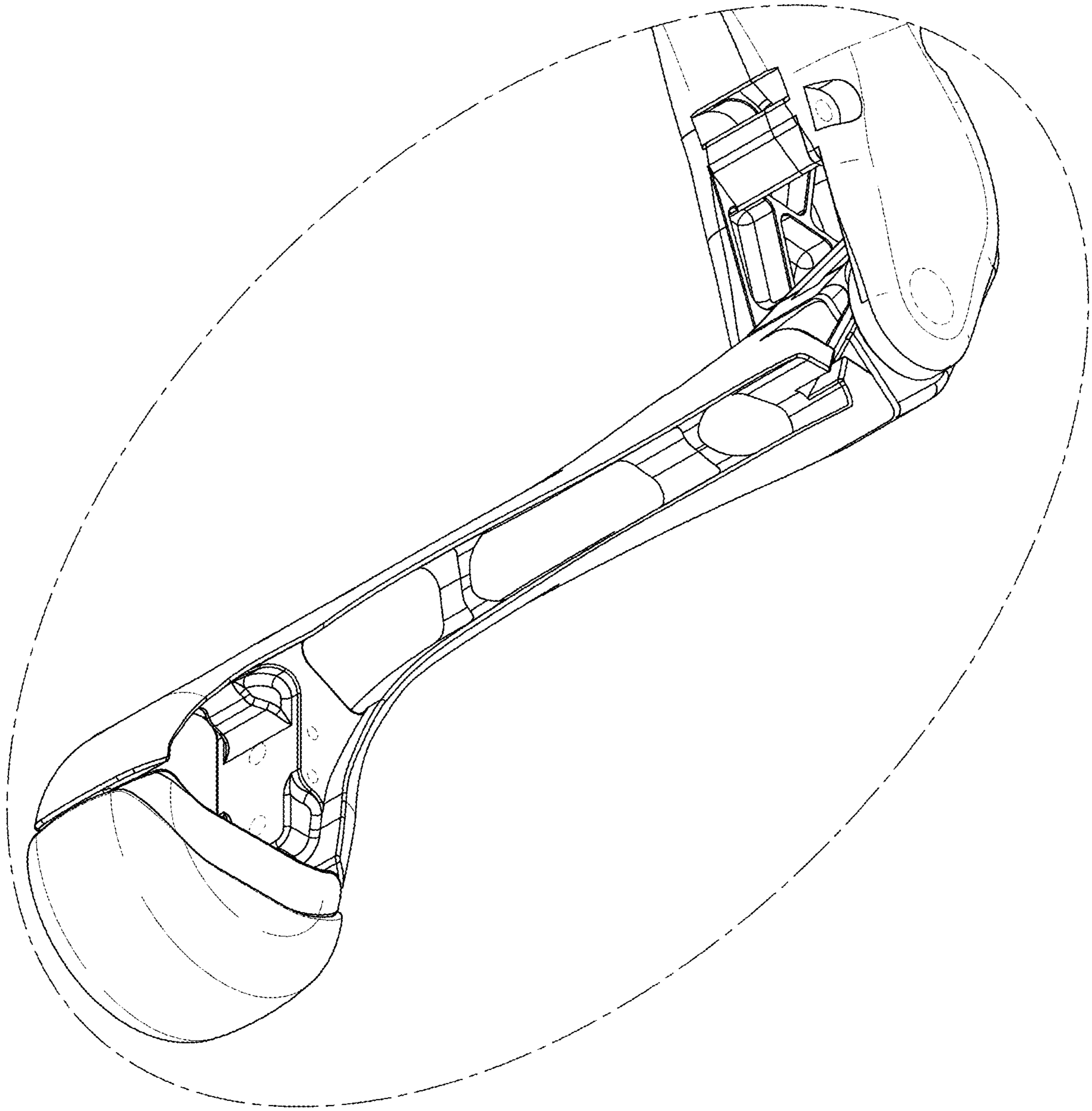
