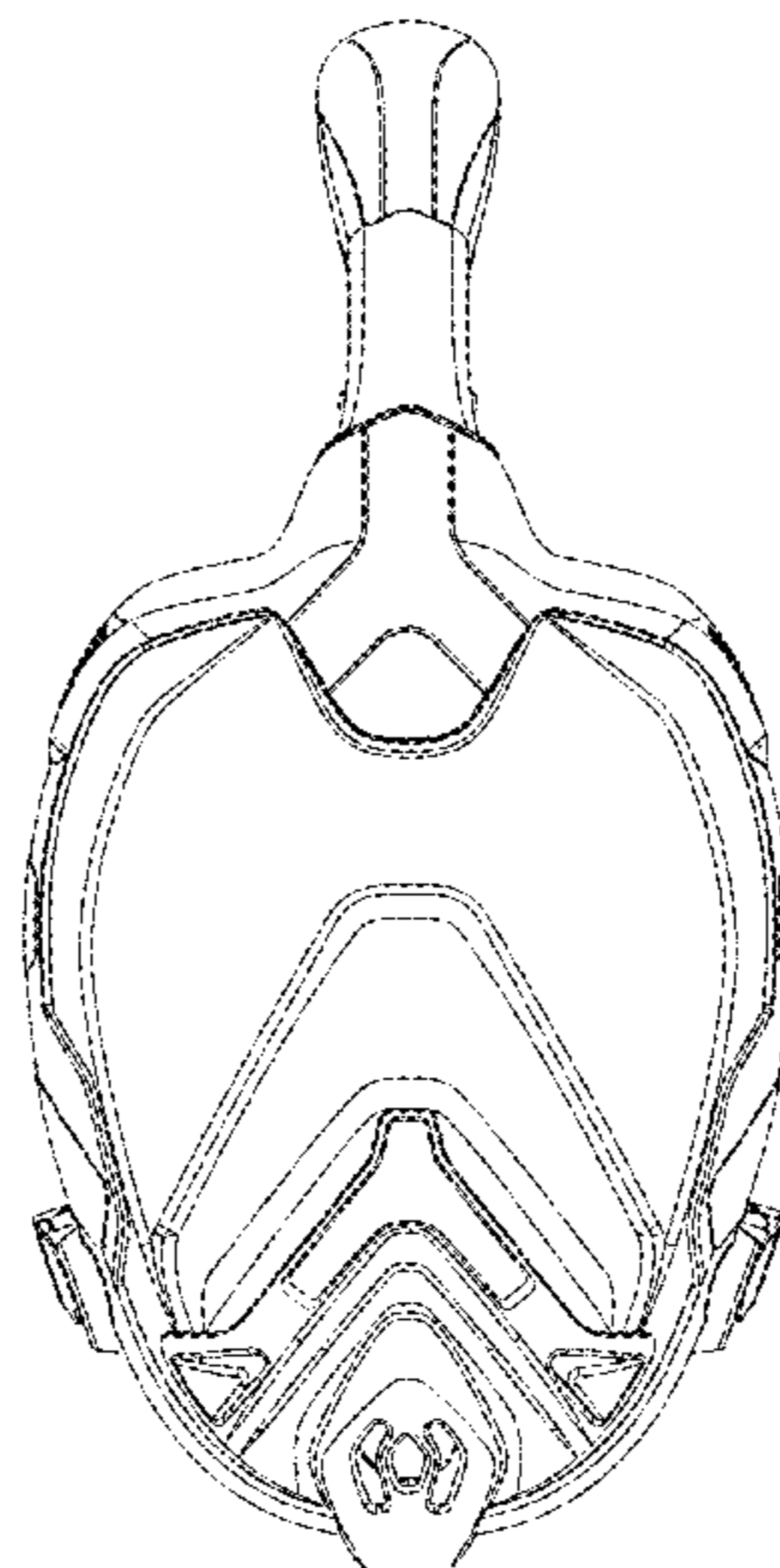
(57) **CLAIM**

The ornamental design for a snorkel mask, as shown and described.

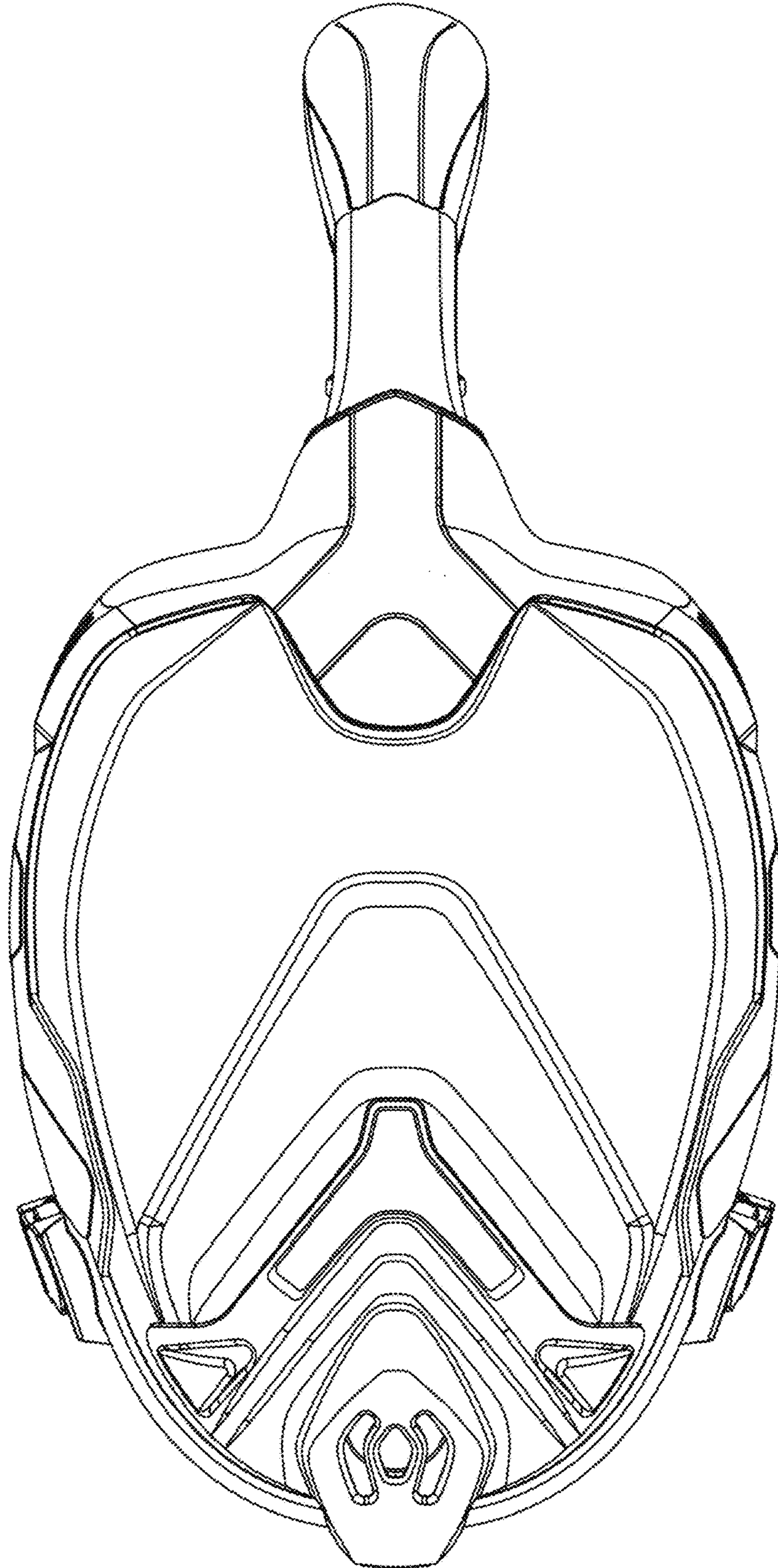
DESCRIPTION

1. Snorkel mask

 The broken lines shown in Figure 1.2 illustrate portions of the snorkel mask that form no part of the claimed design.

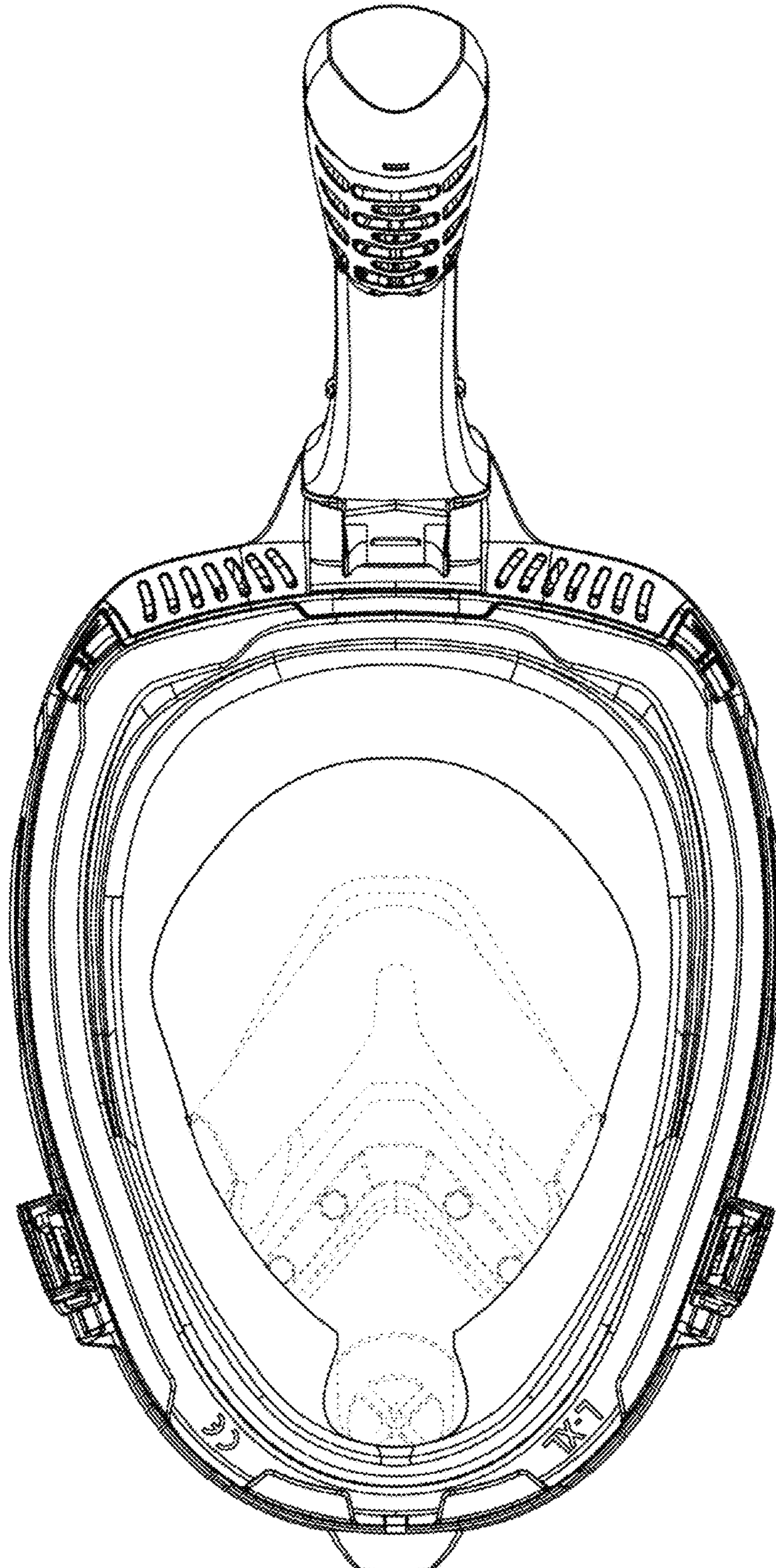

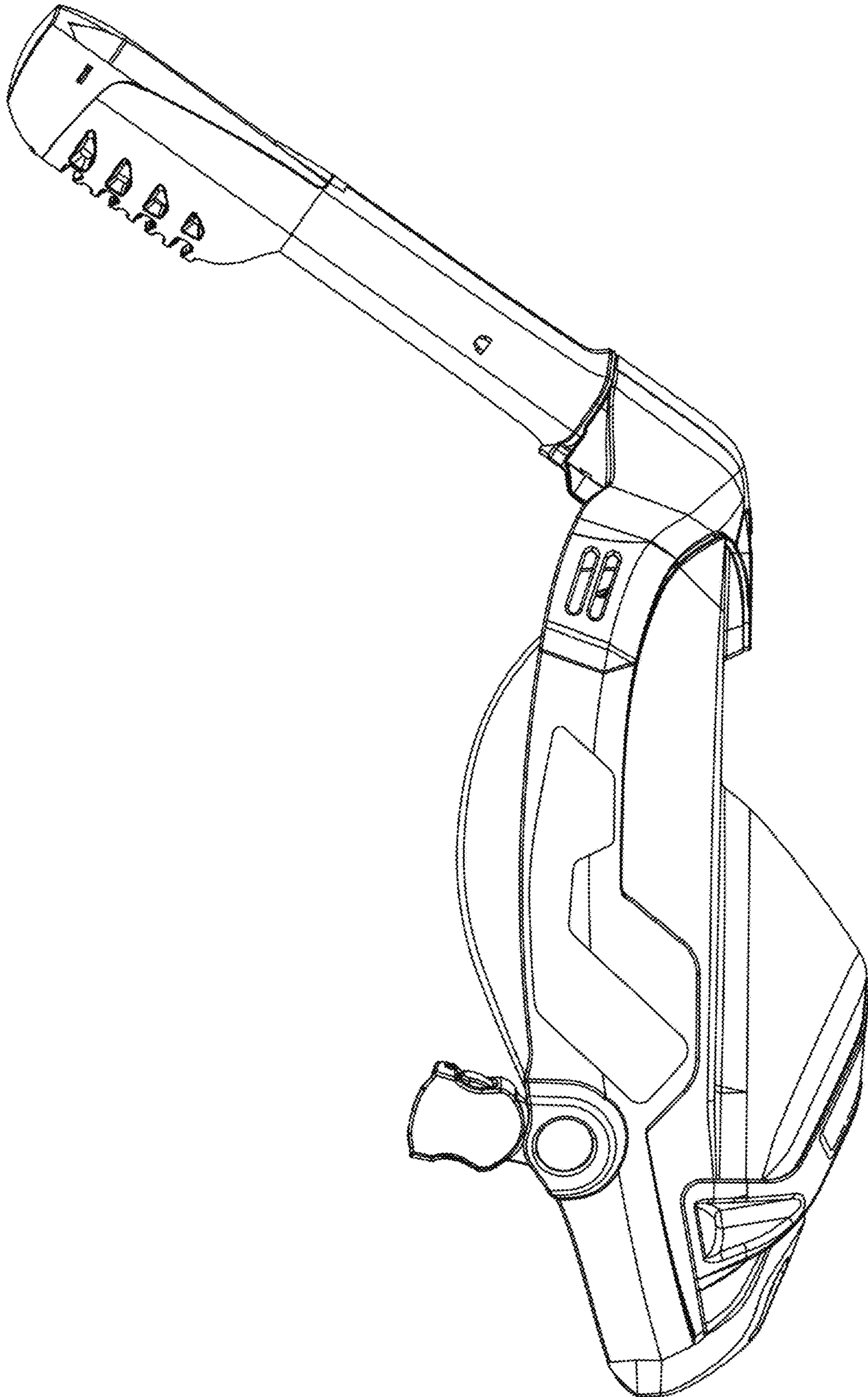

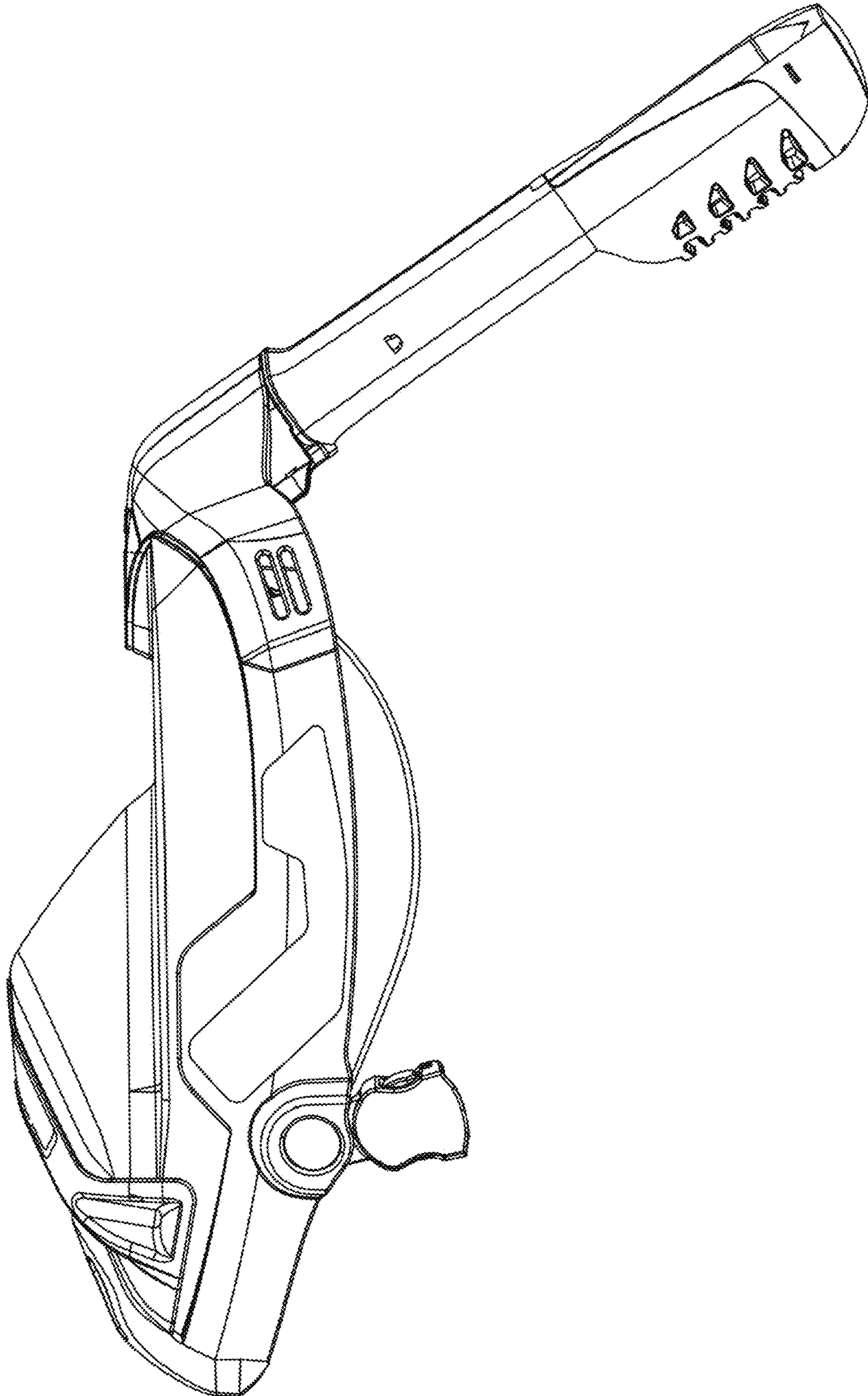

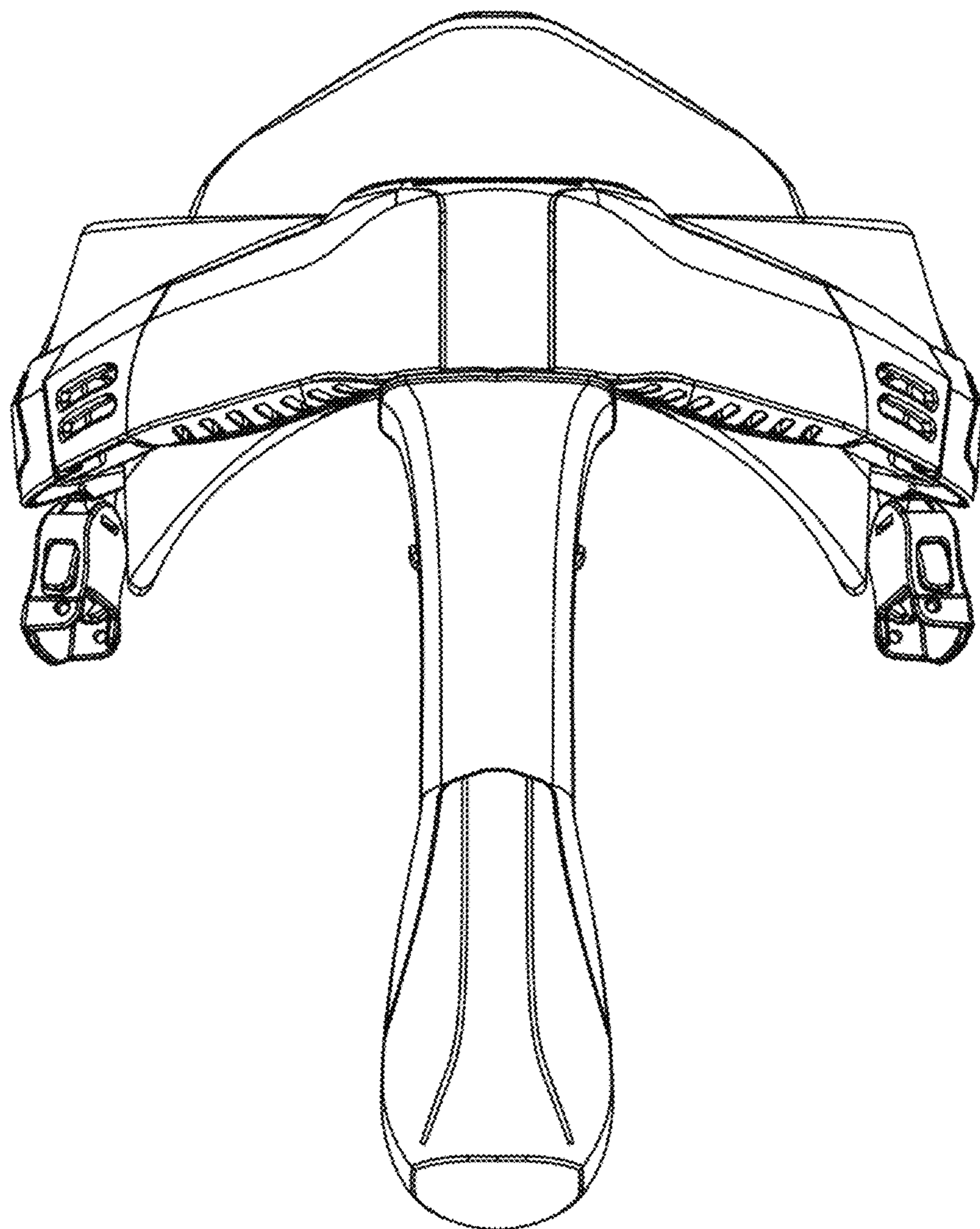
