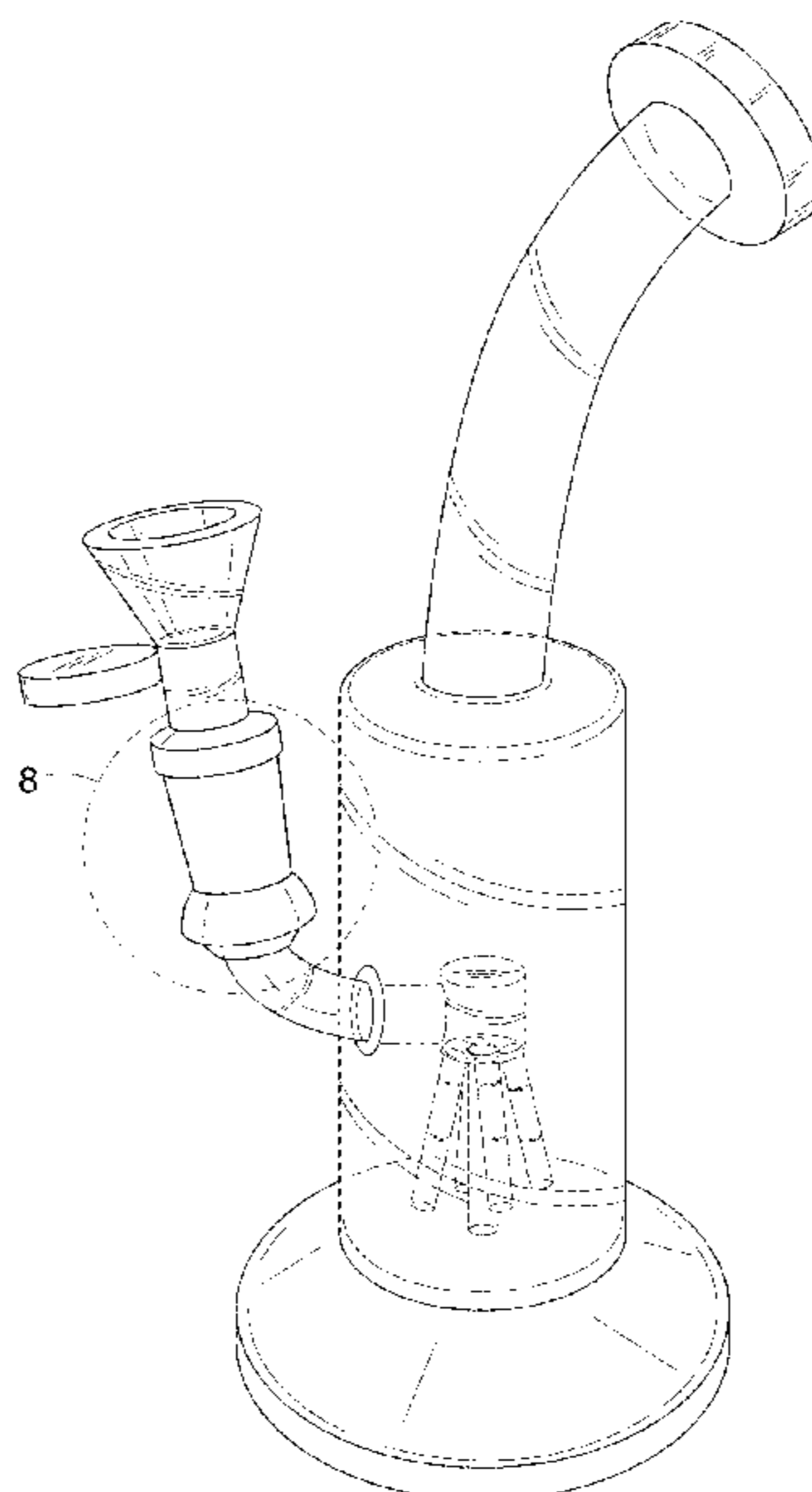
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a water pipe, showing my design.  
FIG. 2 is a front elevation view thereof.  
FIG. 3 is a rear elevation view thereof.  
FIG. 4 is a right side elevation view thereof.  
FIG. 5 is a left side elevation view thereof.  
FIG. 6 is a top plan view thereof.  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is an enlarged view of an area labeled 8 in FIG. 1.

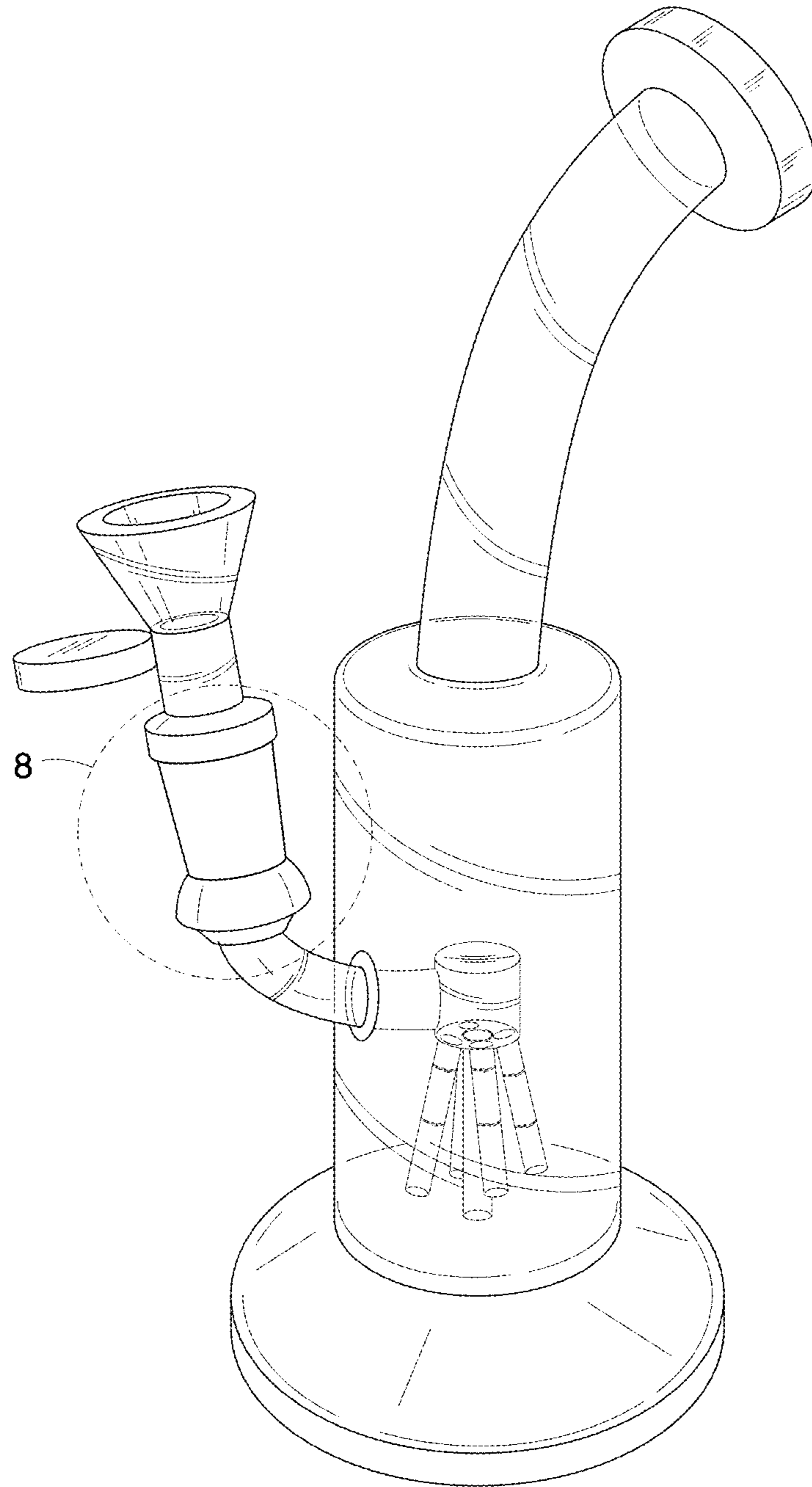

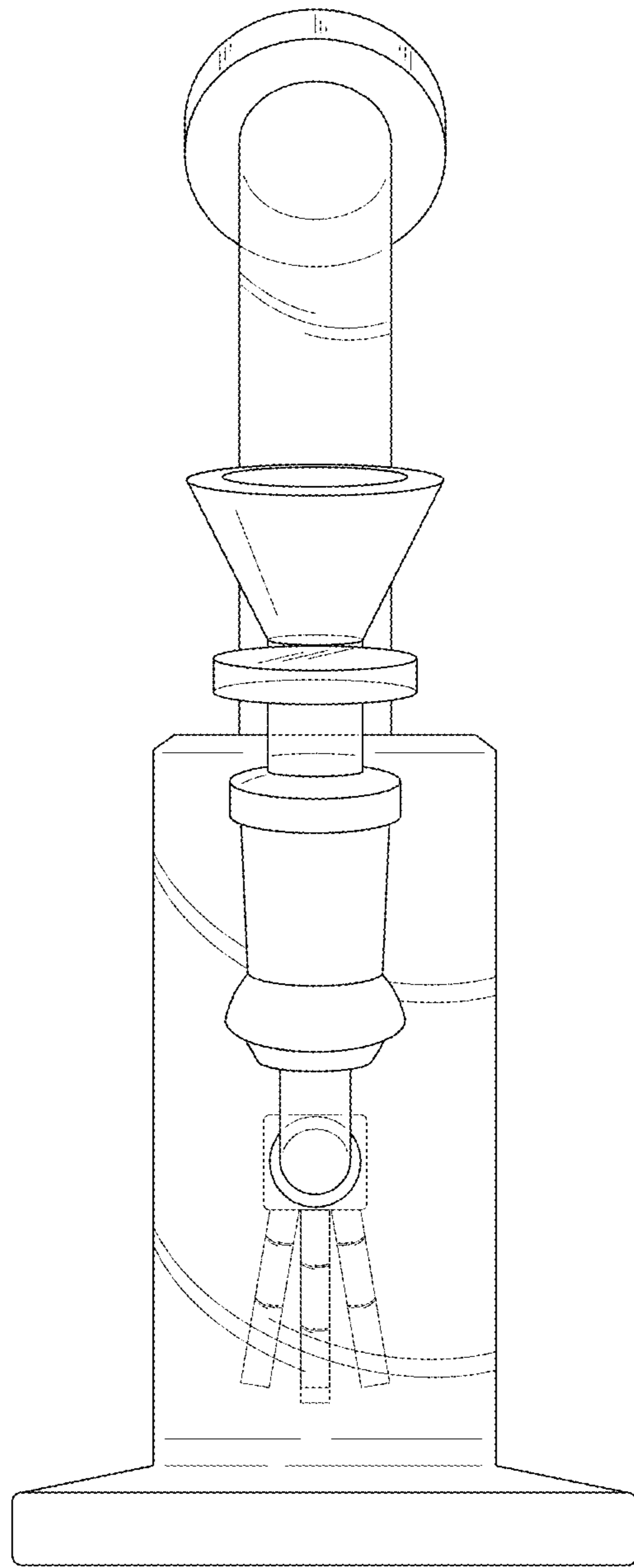

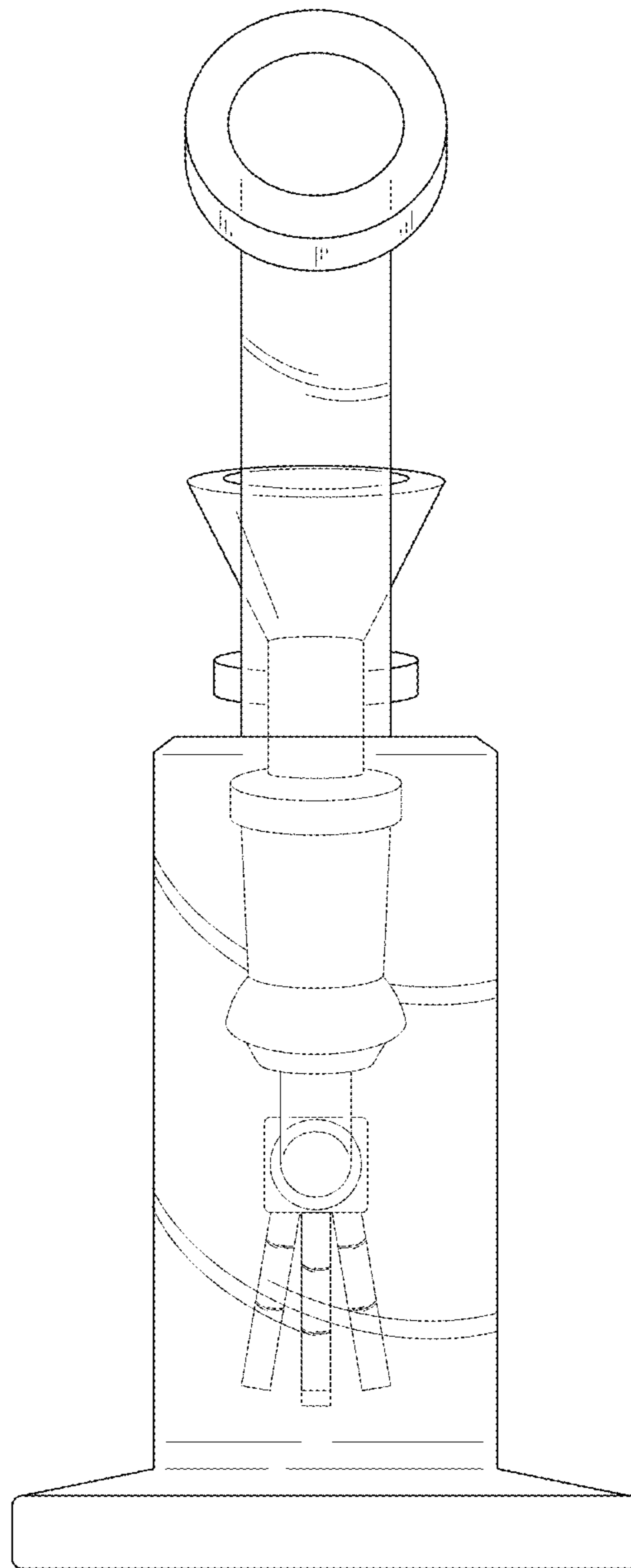

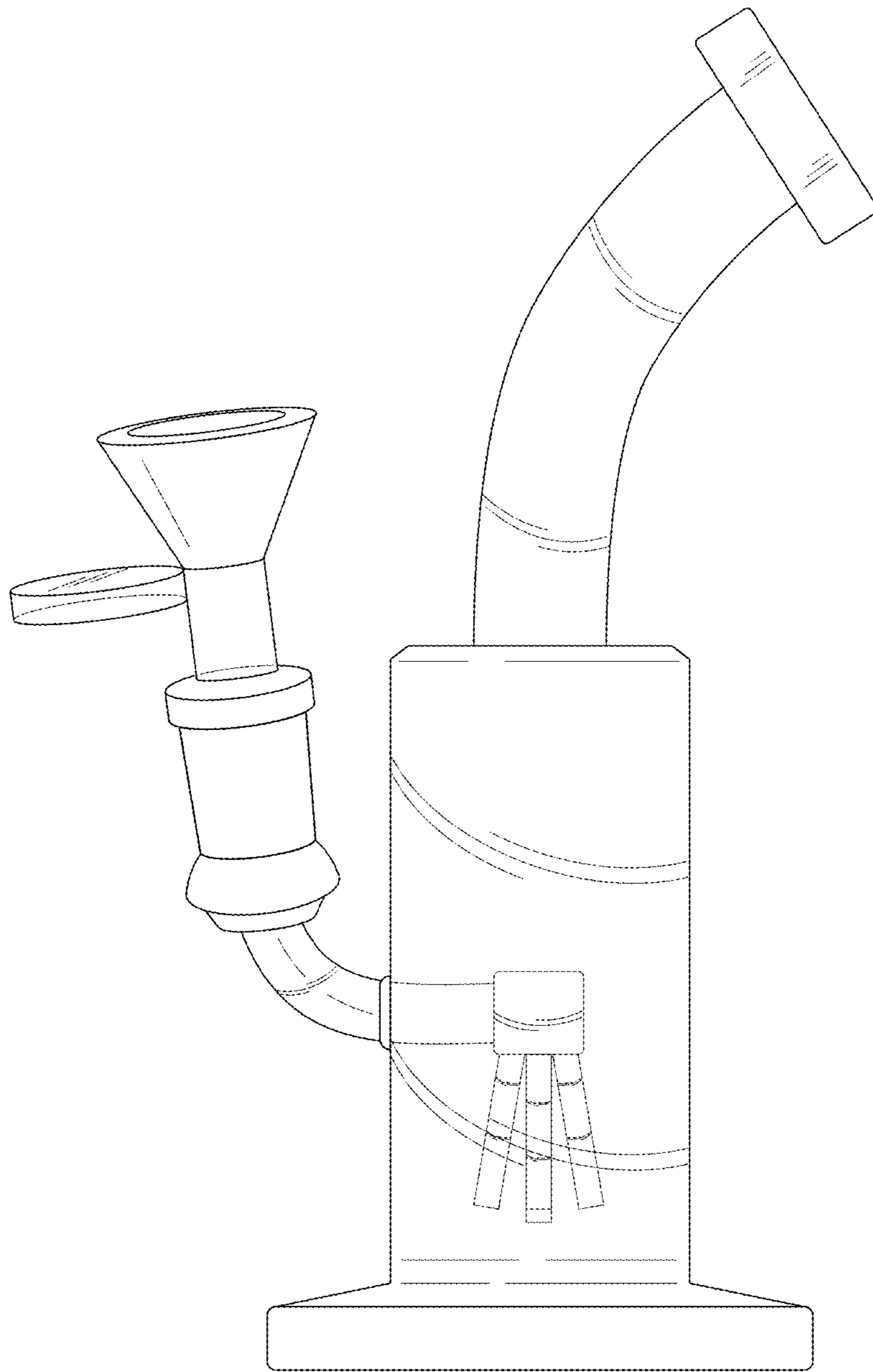

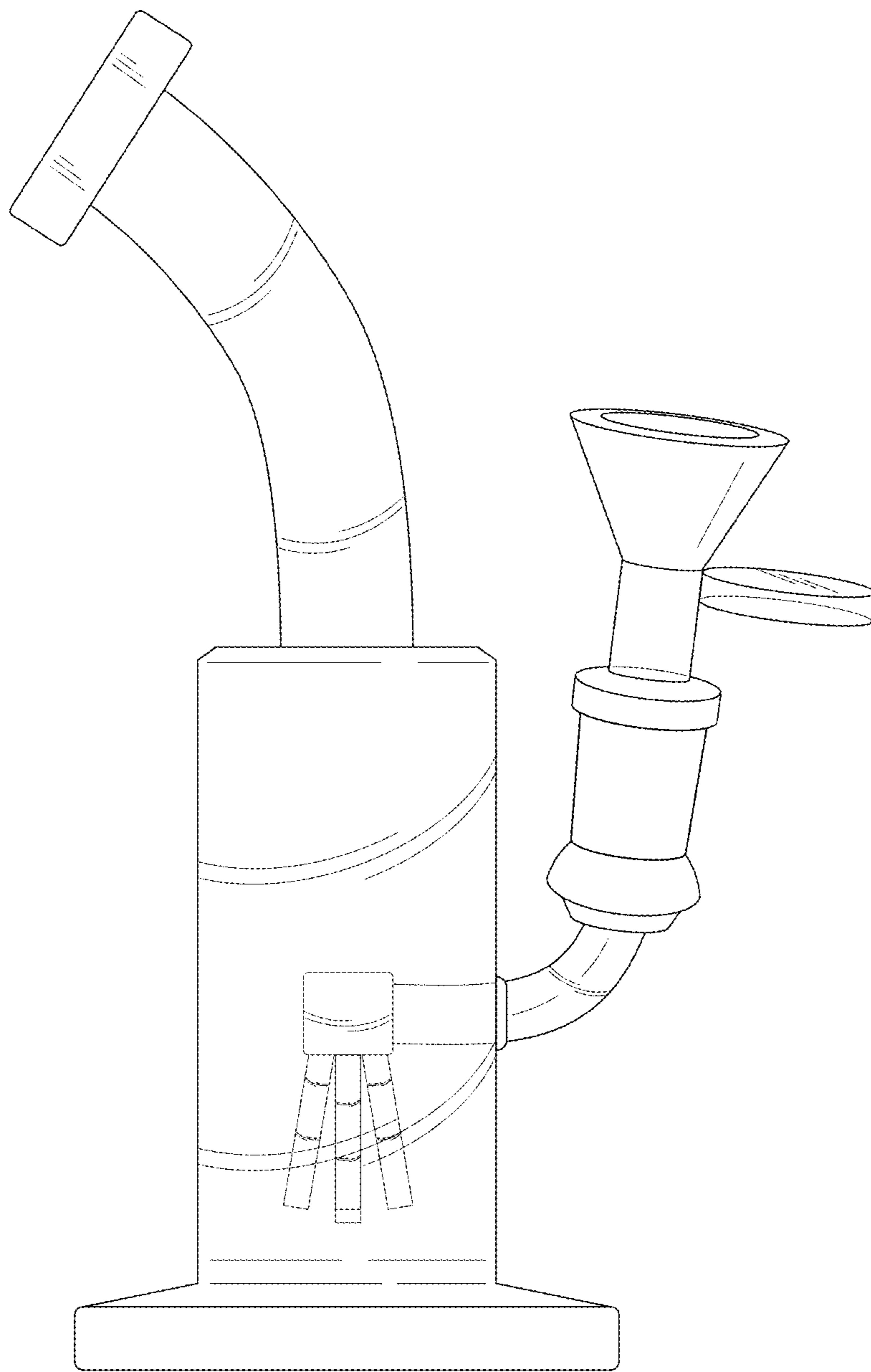

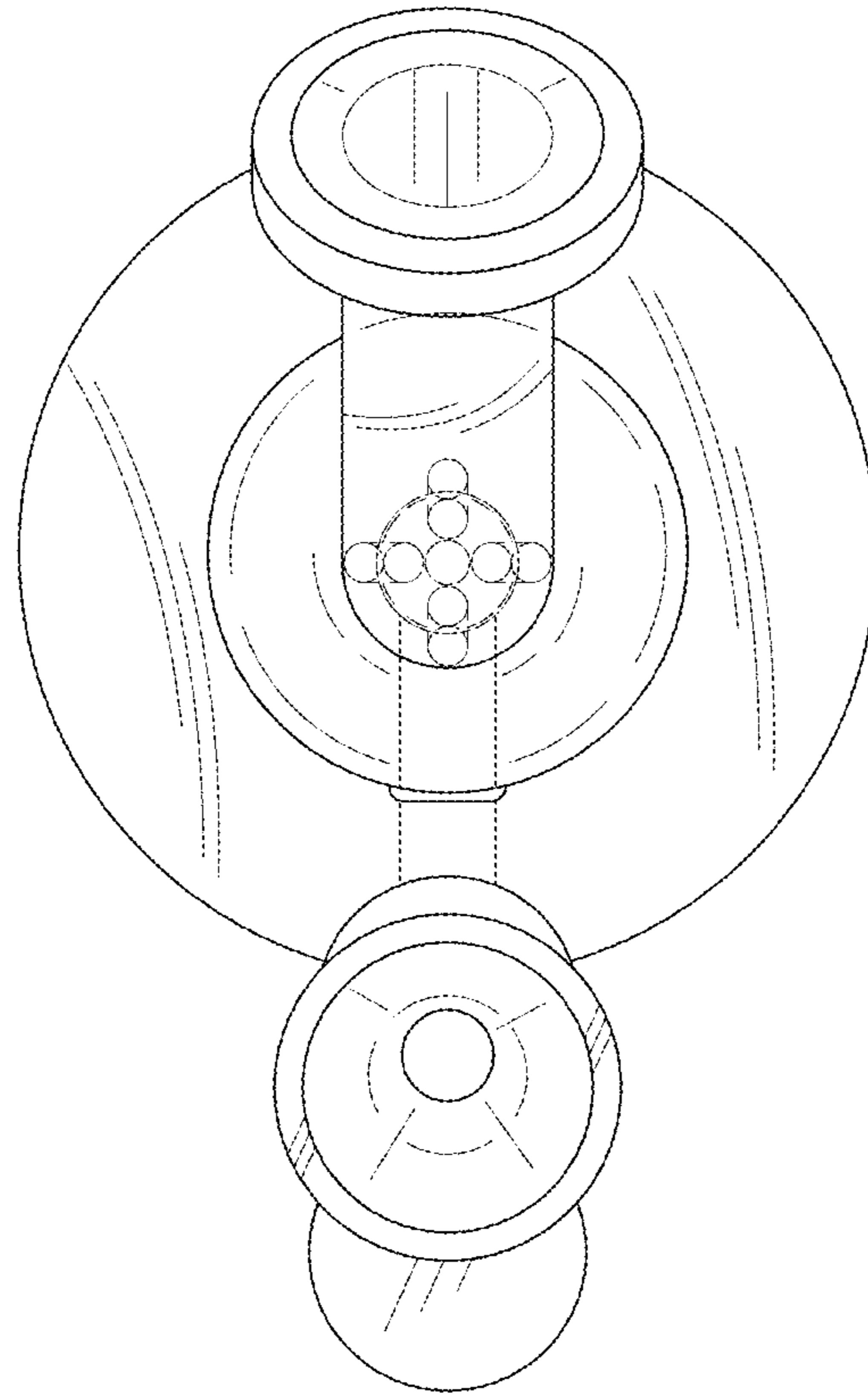

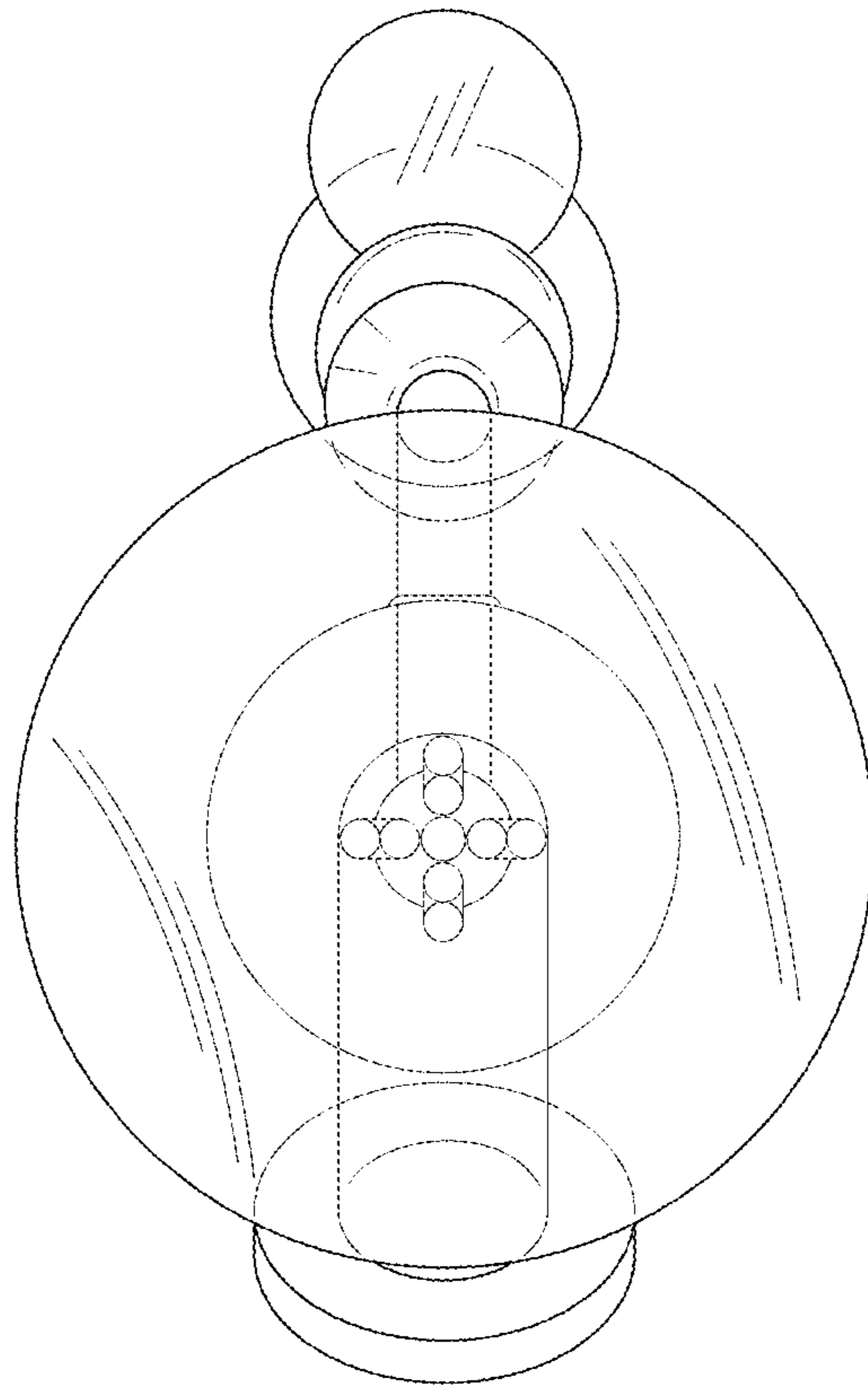

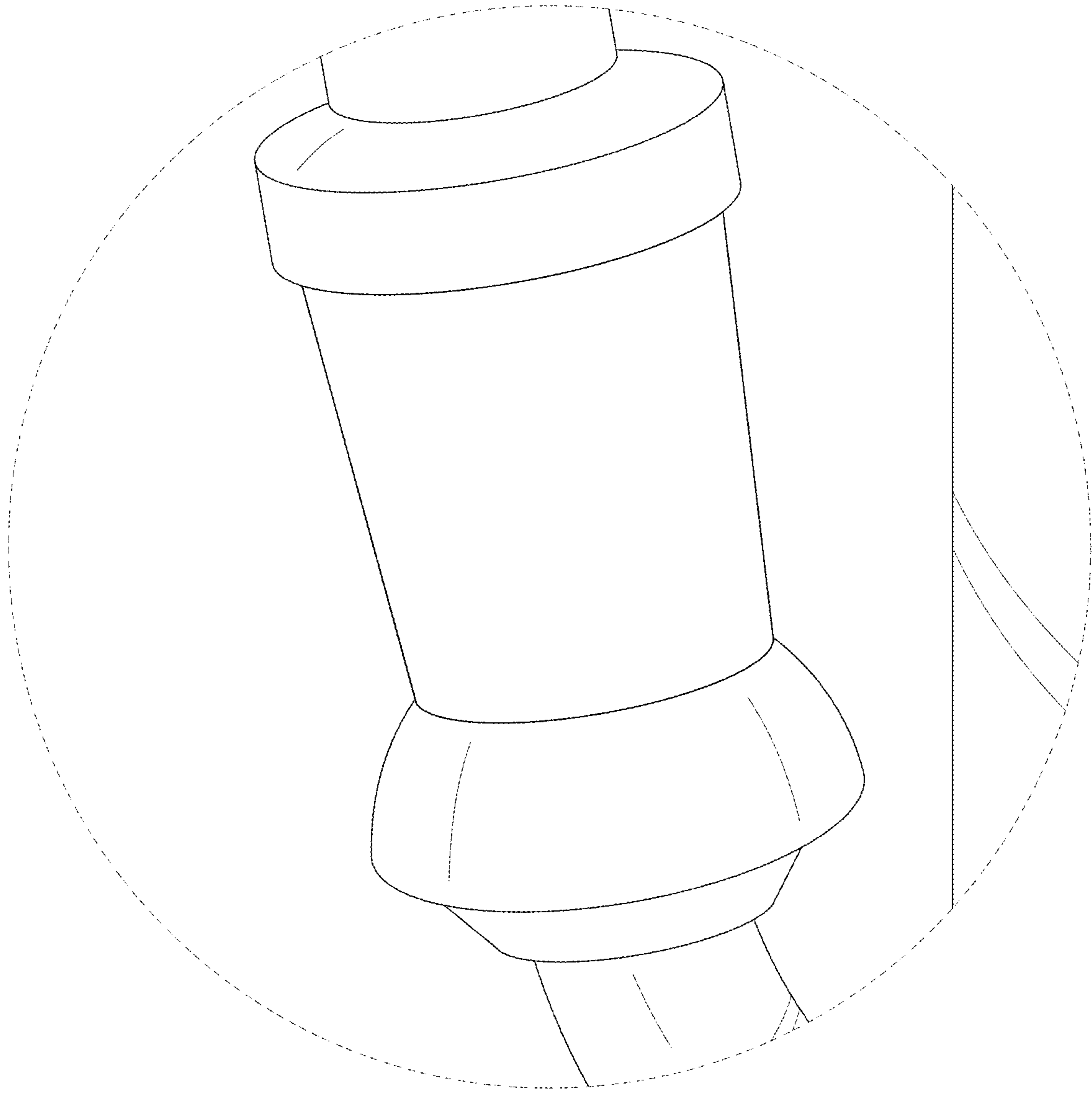
