(57) **CLAIM**

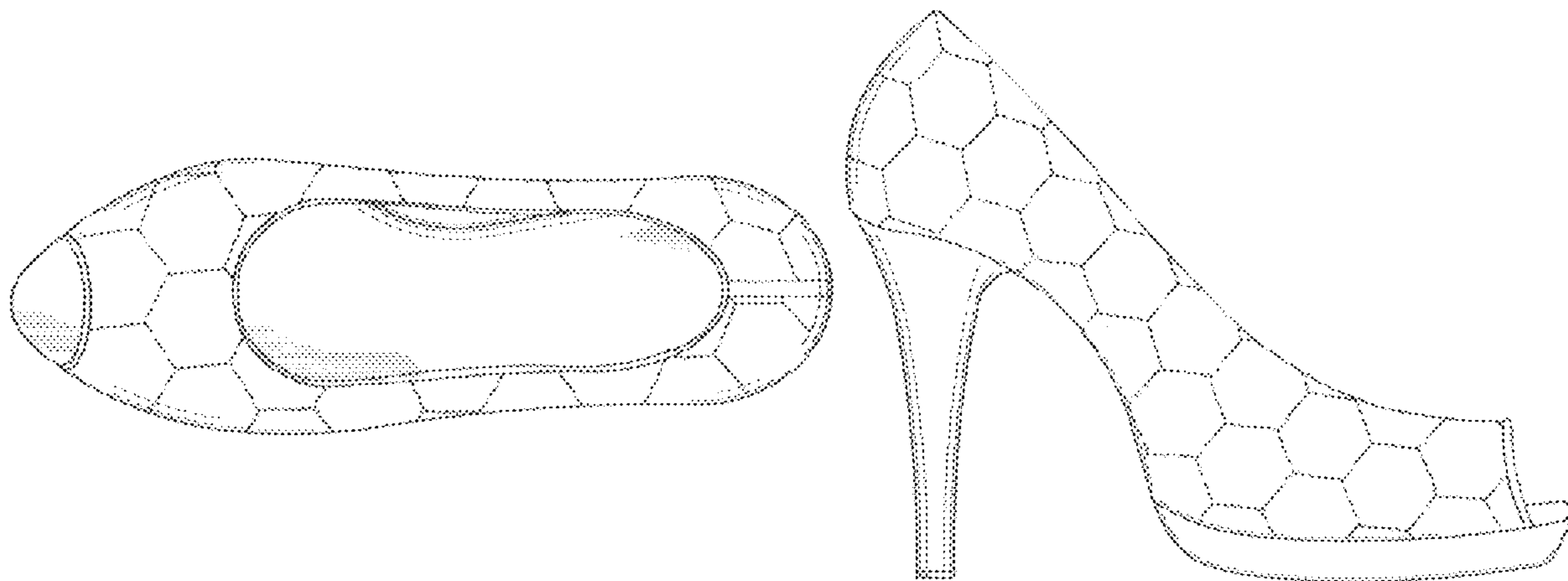
The ornamental design for a soccer high heel shoe, as shown and described.

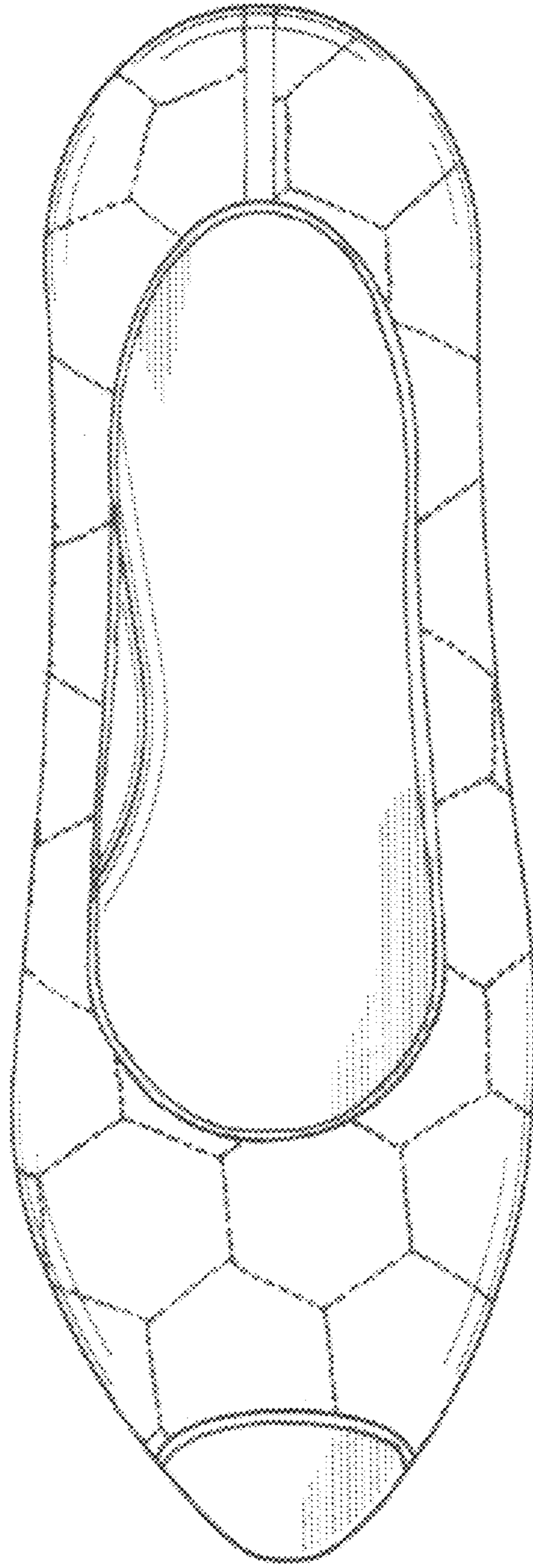

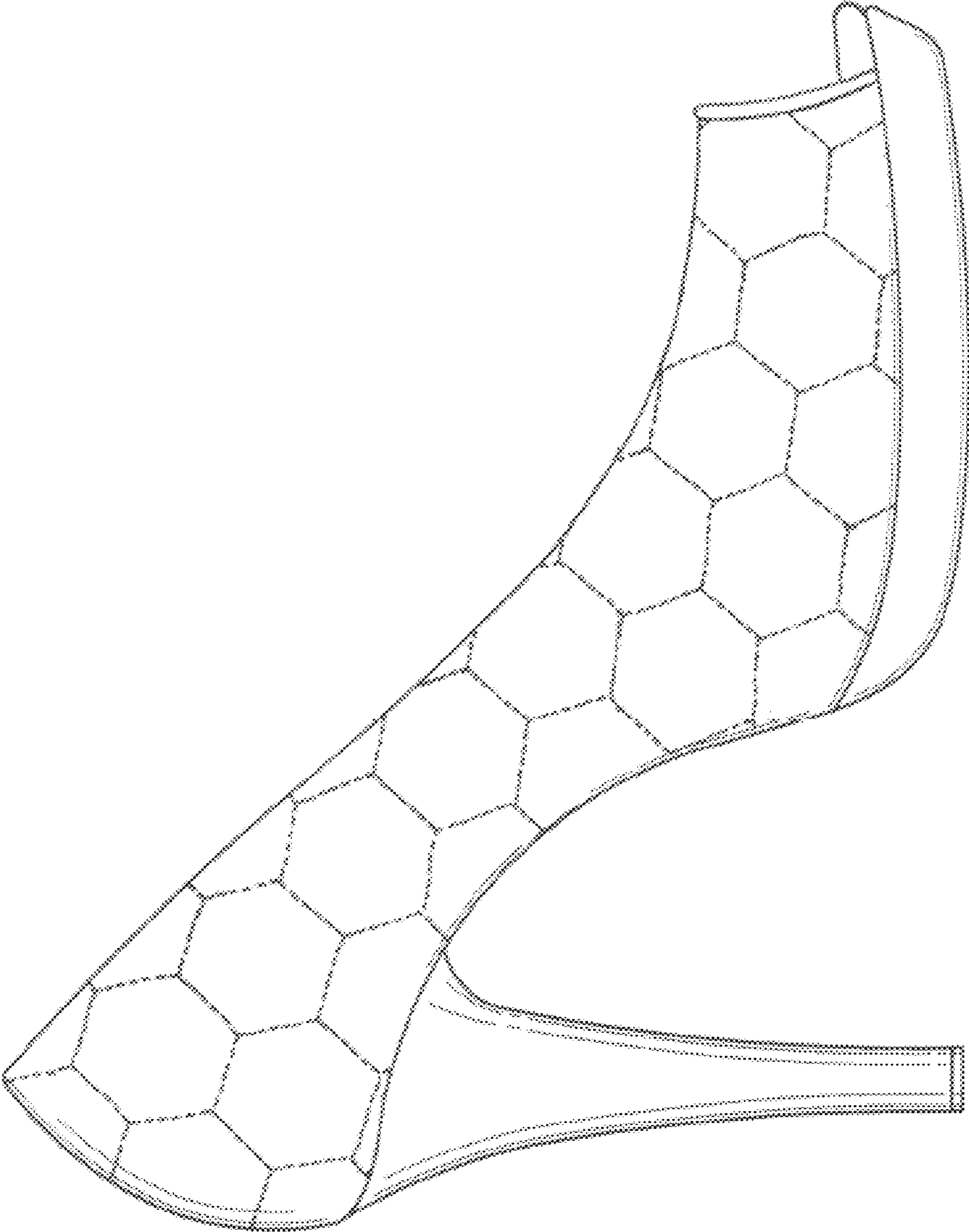

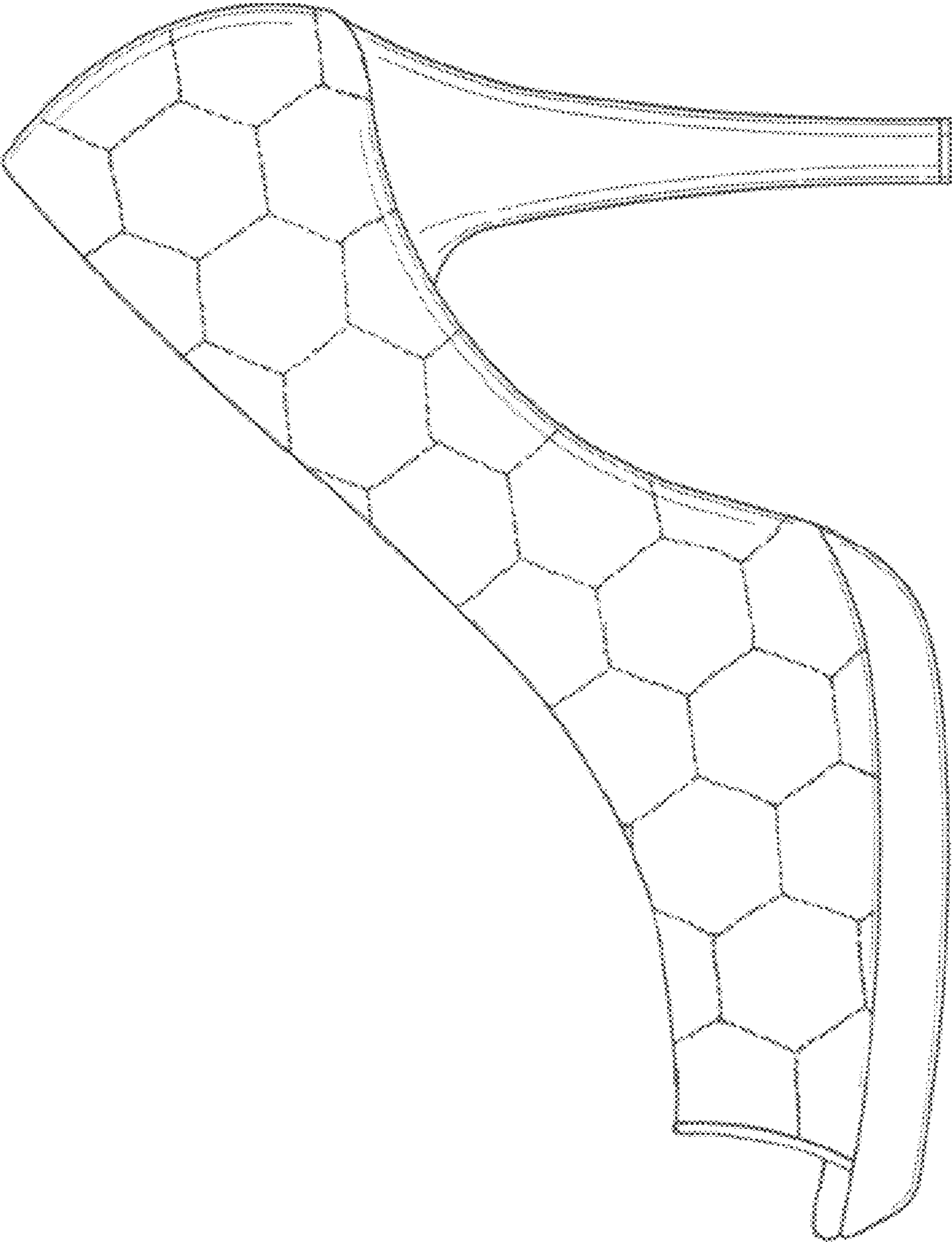

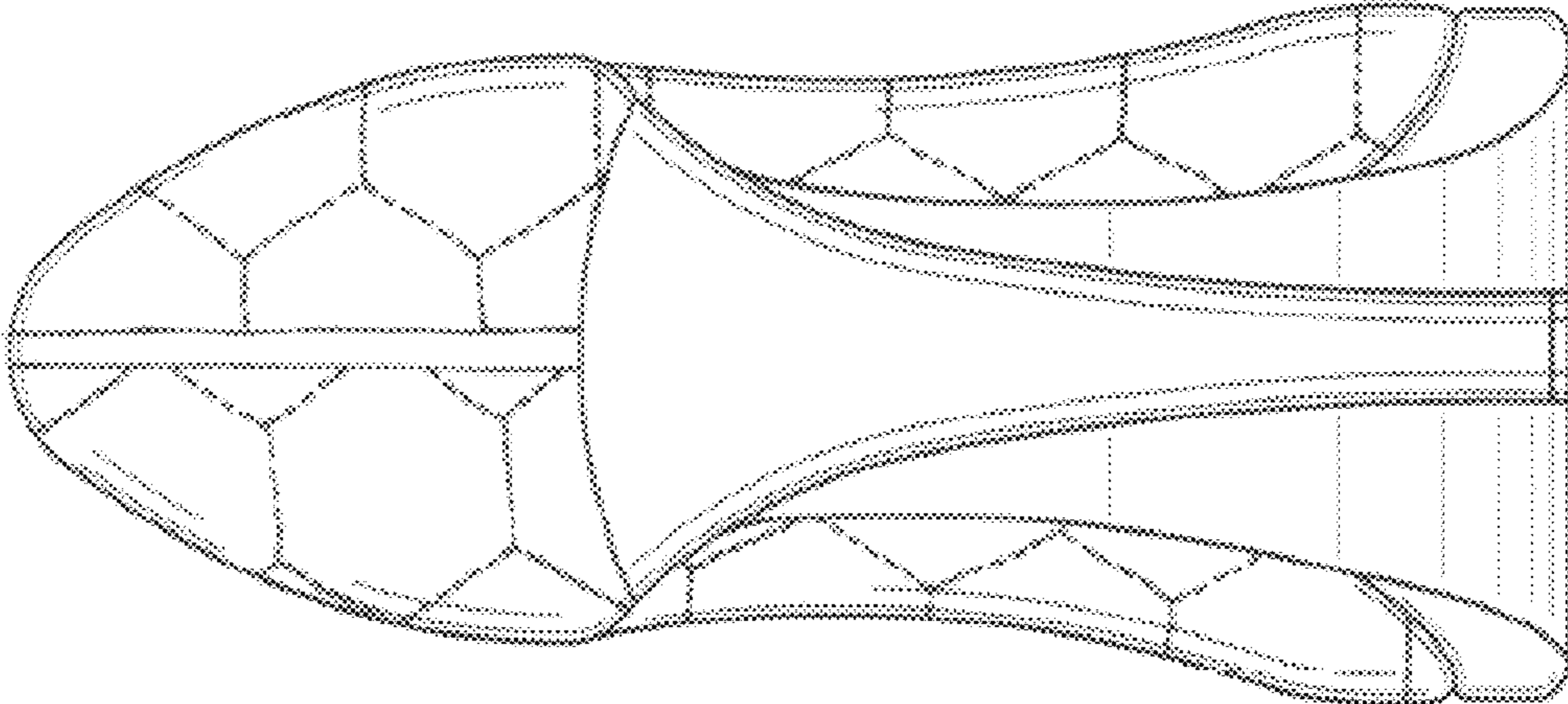
