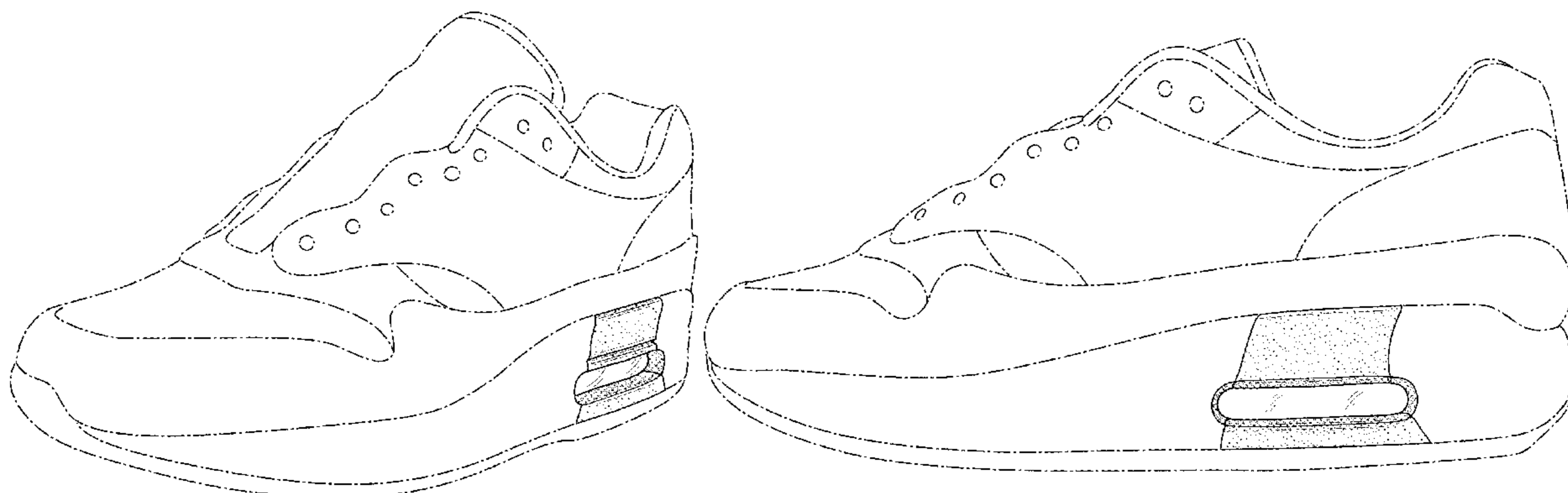
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is a rear perspective view thereof;  
FIG. 4 is a front perspective view of a shoe showing an alternative embodiment of my new design;  
FIG. 5 is a side view thereof; and,  
FIG. 6 is a rear perspective view thereof.  
The curved oblique shade lines represent a translucent or transparent appearance. The broken lines depicting the remainder of the shoe form no part of the claimed design.

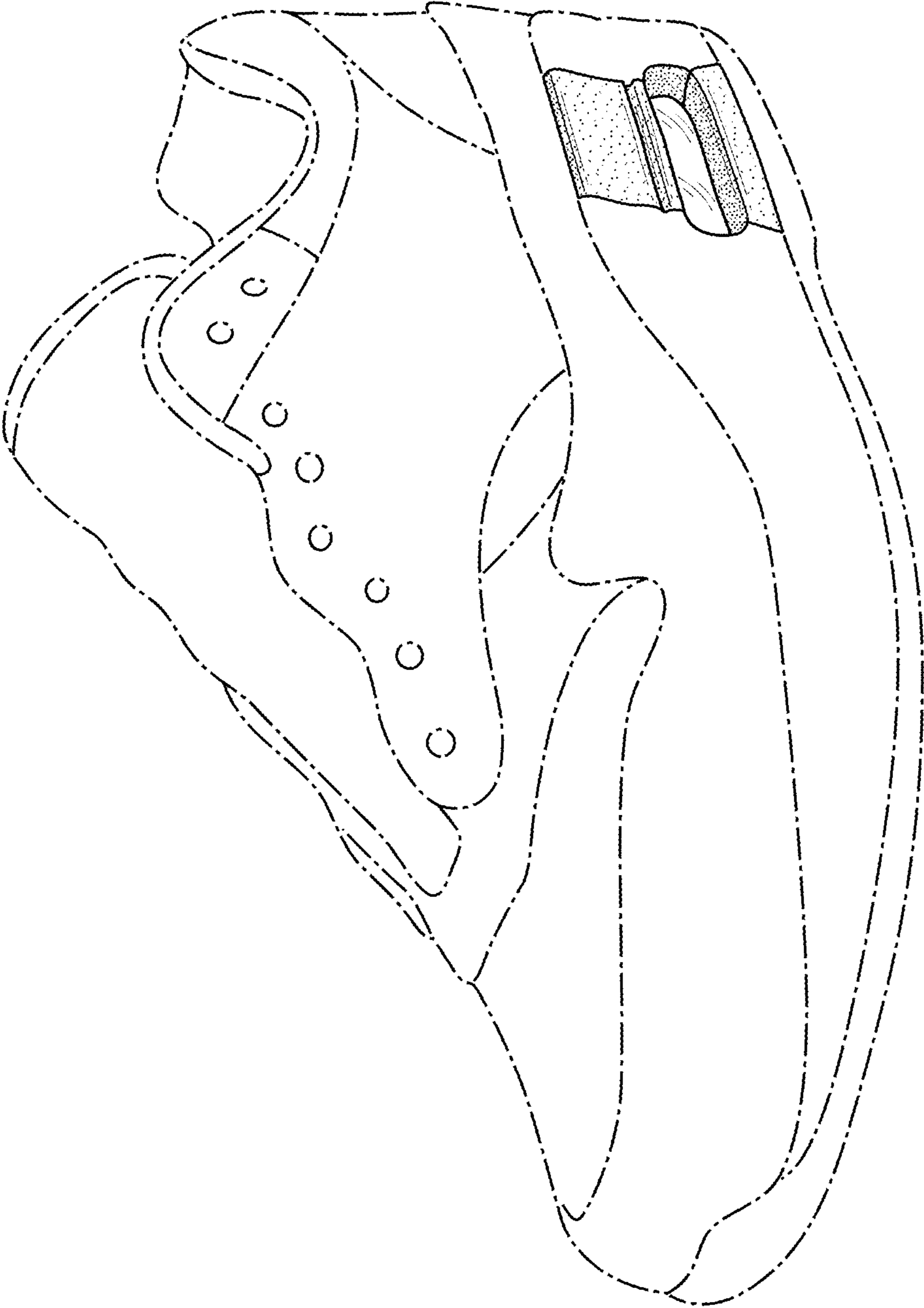

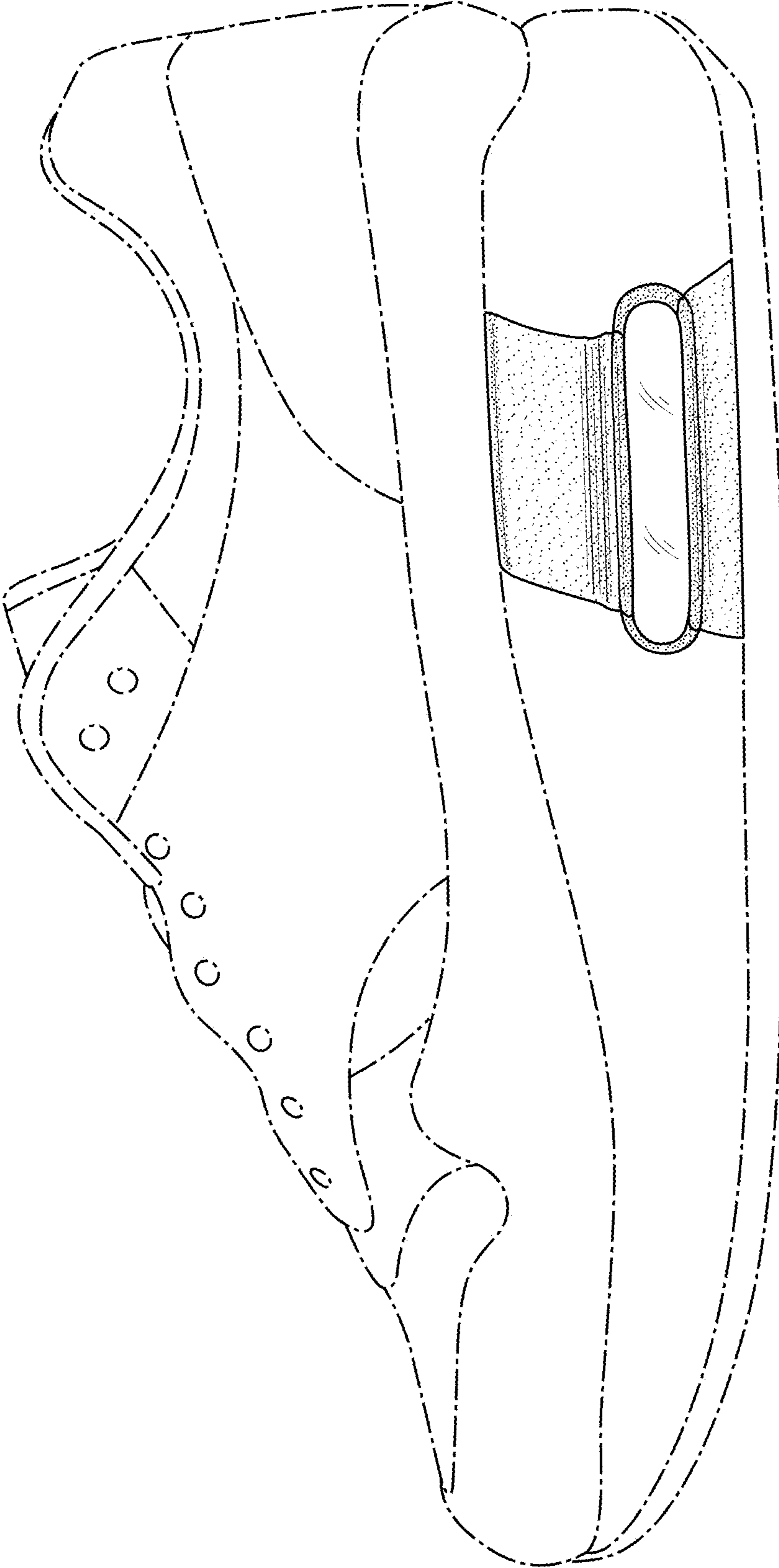

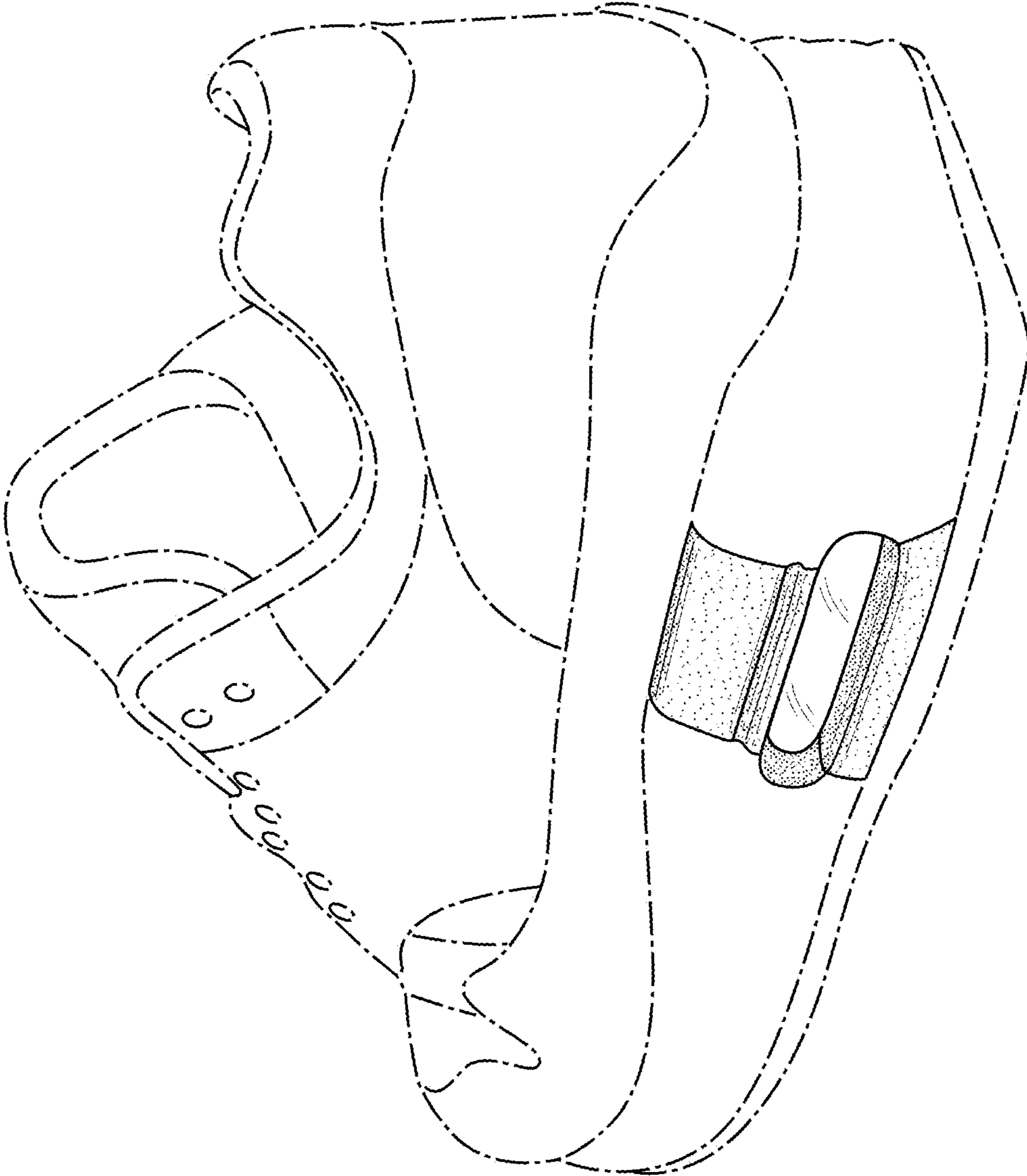

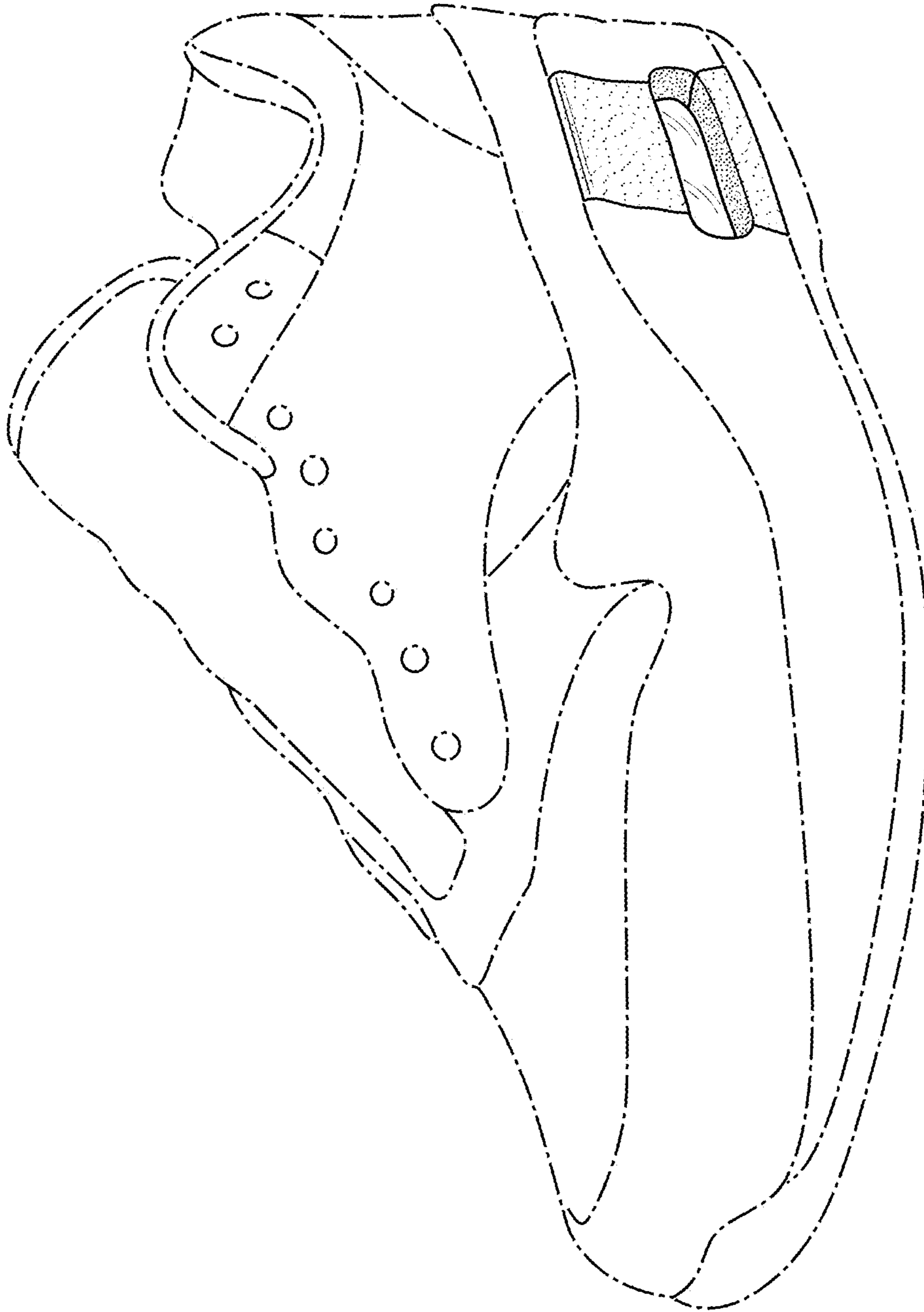

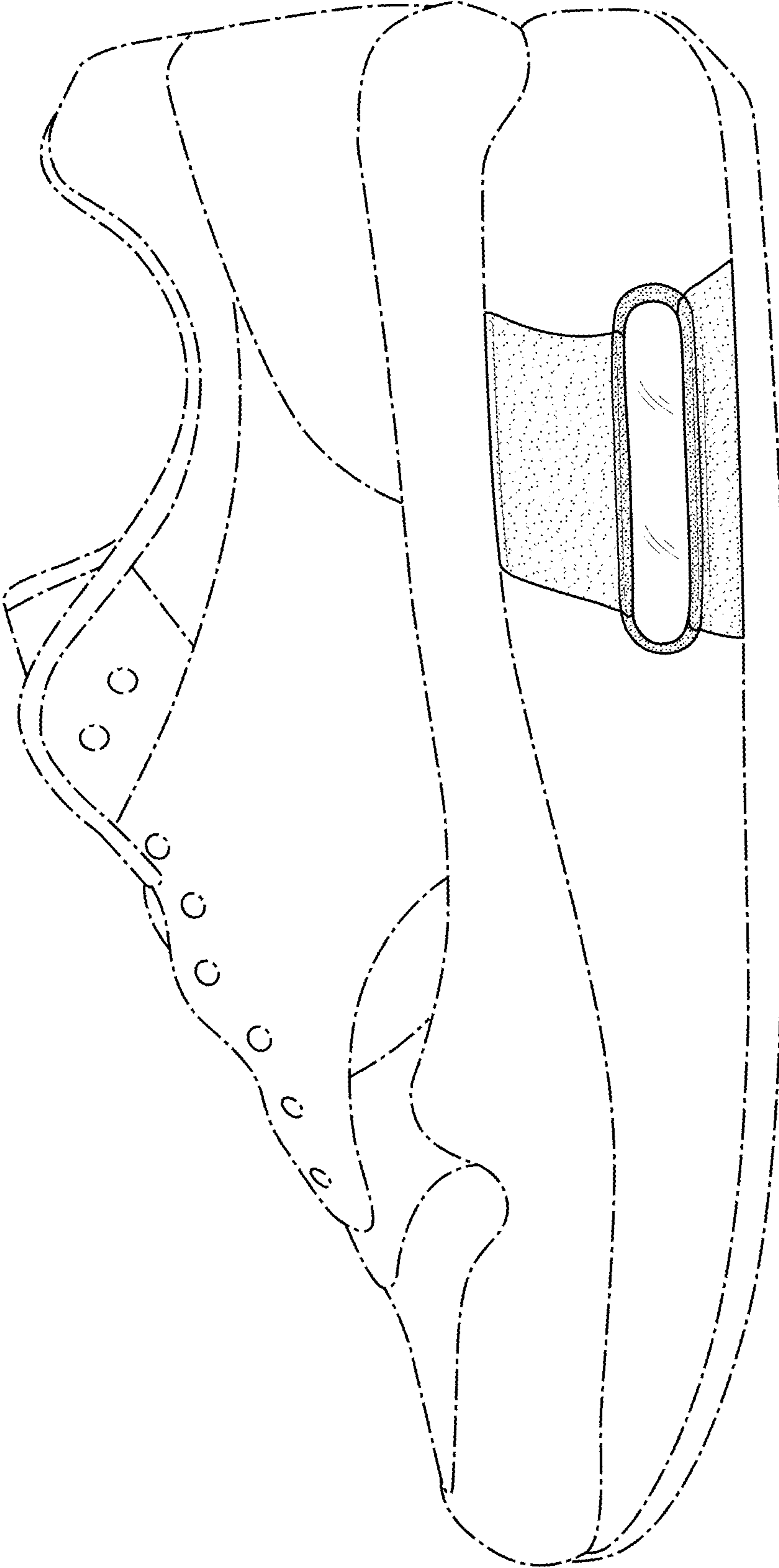

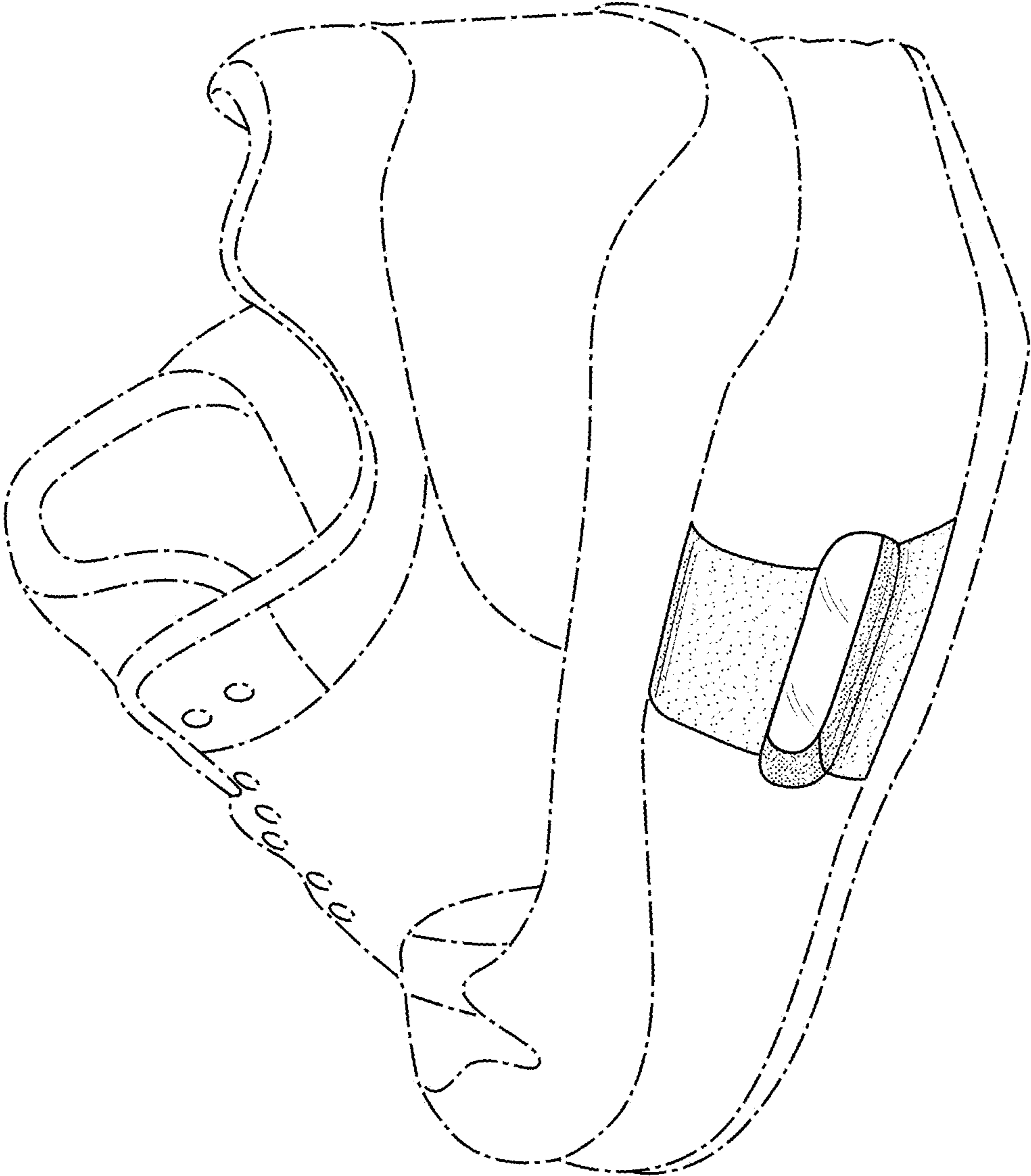
