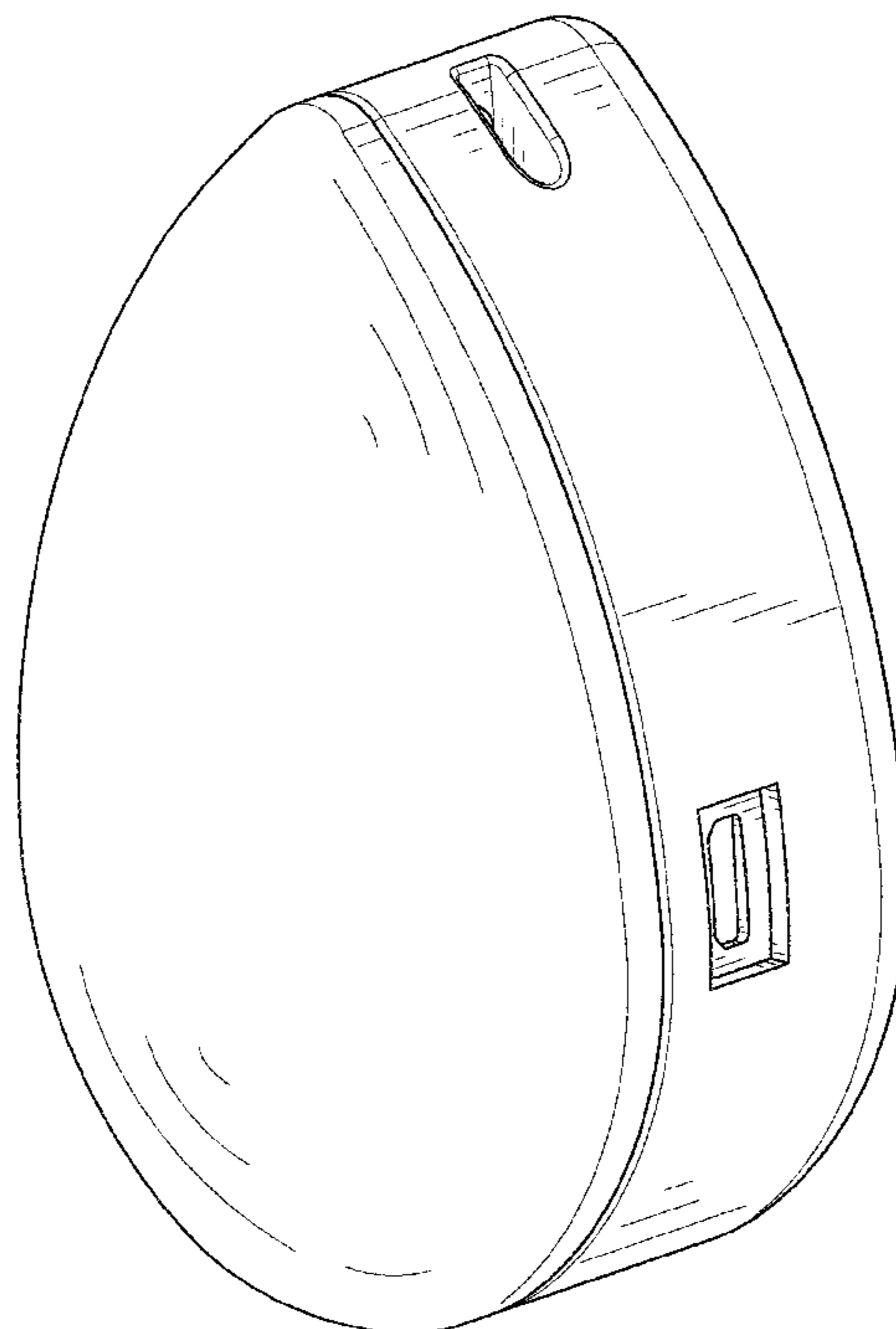
(57) **CLAIM**

The ornamental design for an earphone case, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of an earphone case showing my new design;
FIG. 2 is a rear, left side, top perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof;

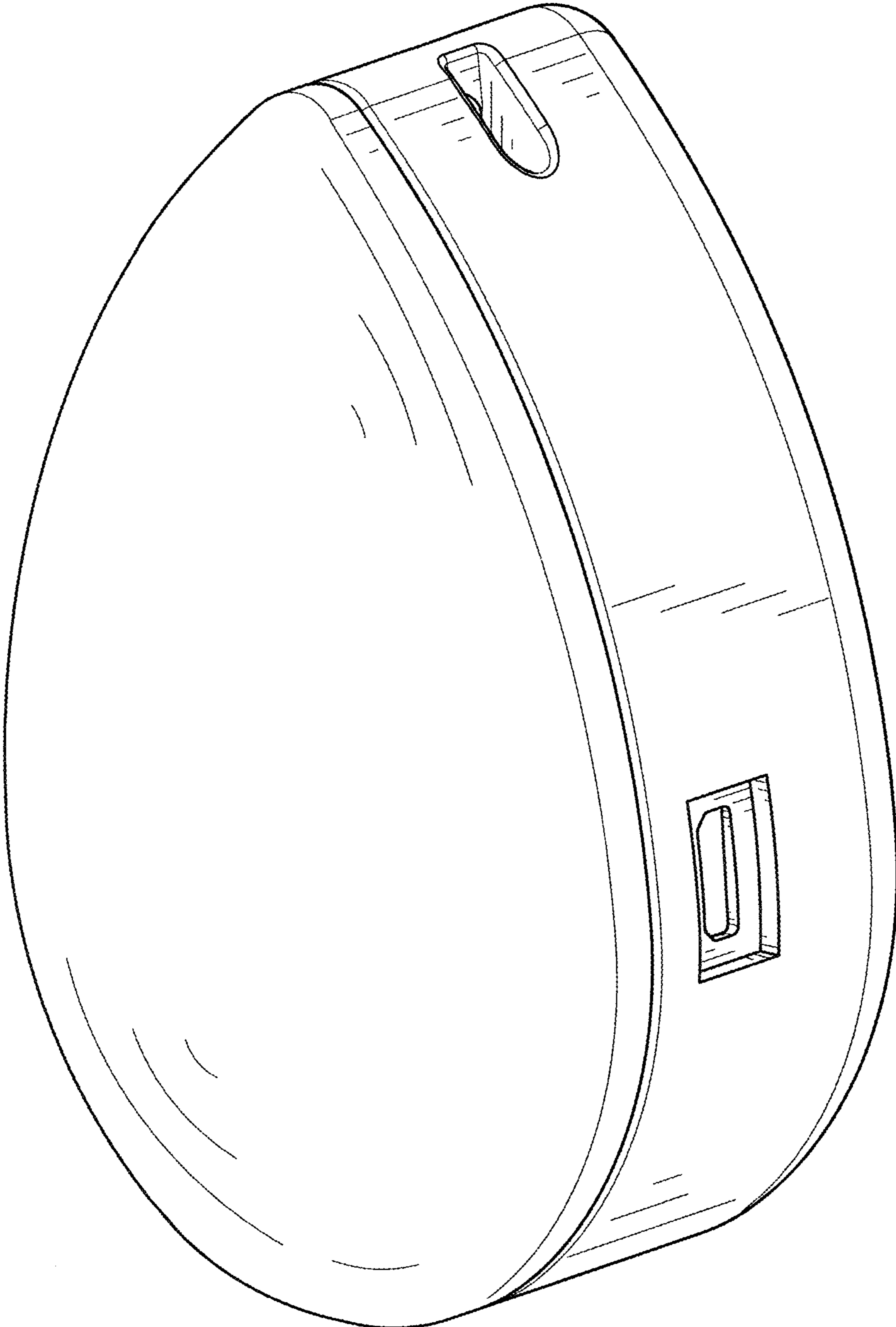

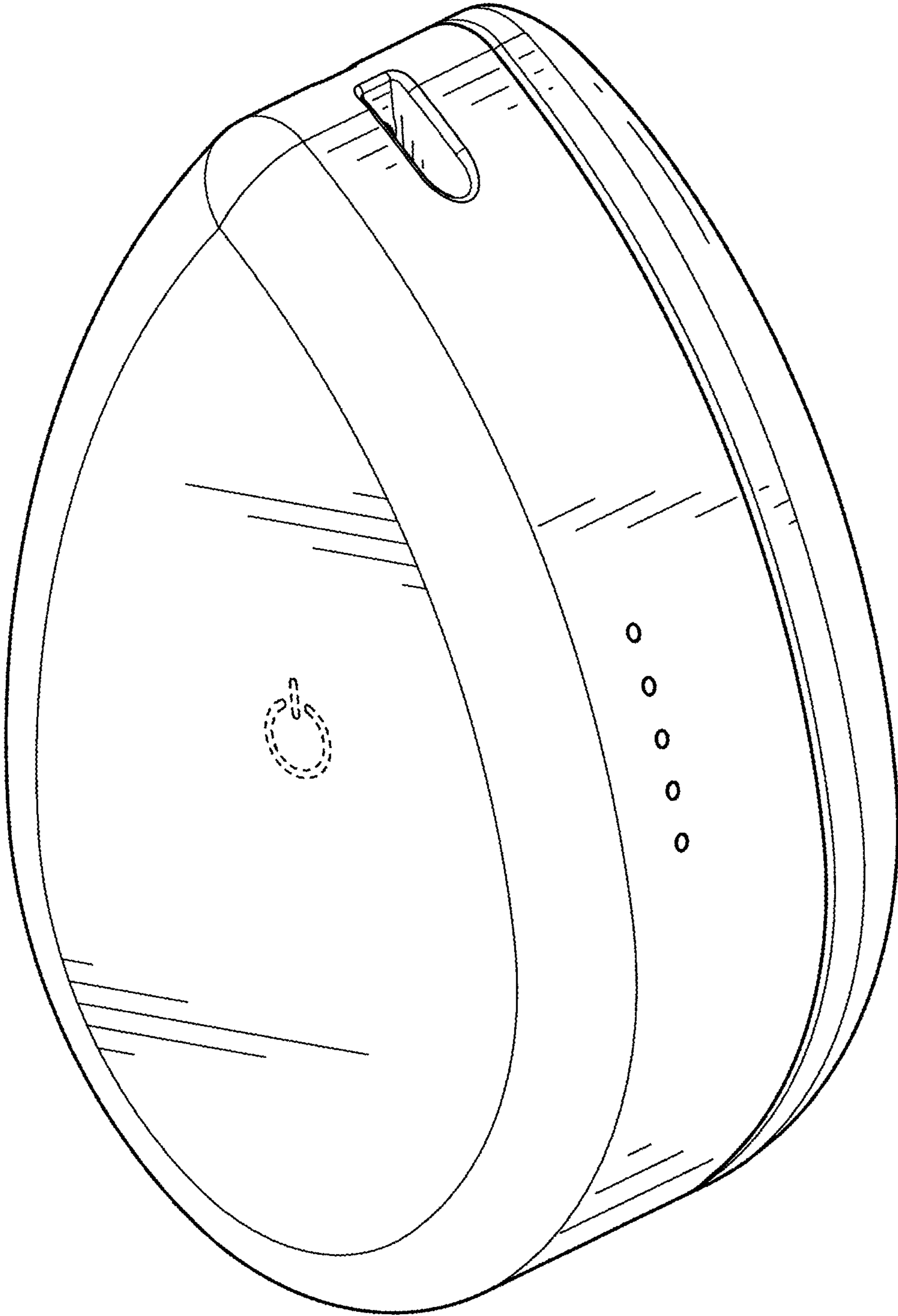

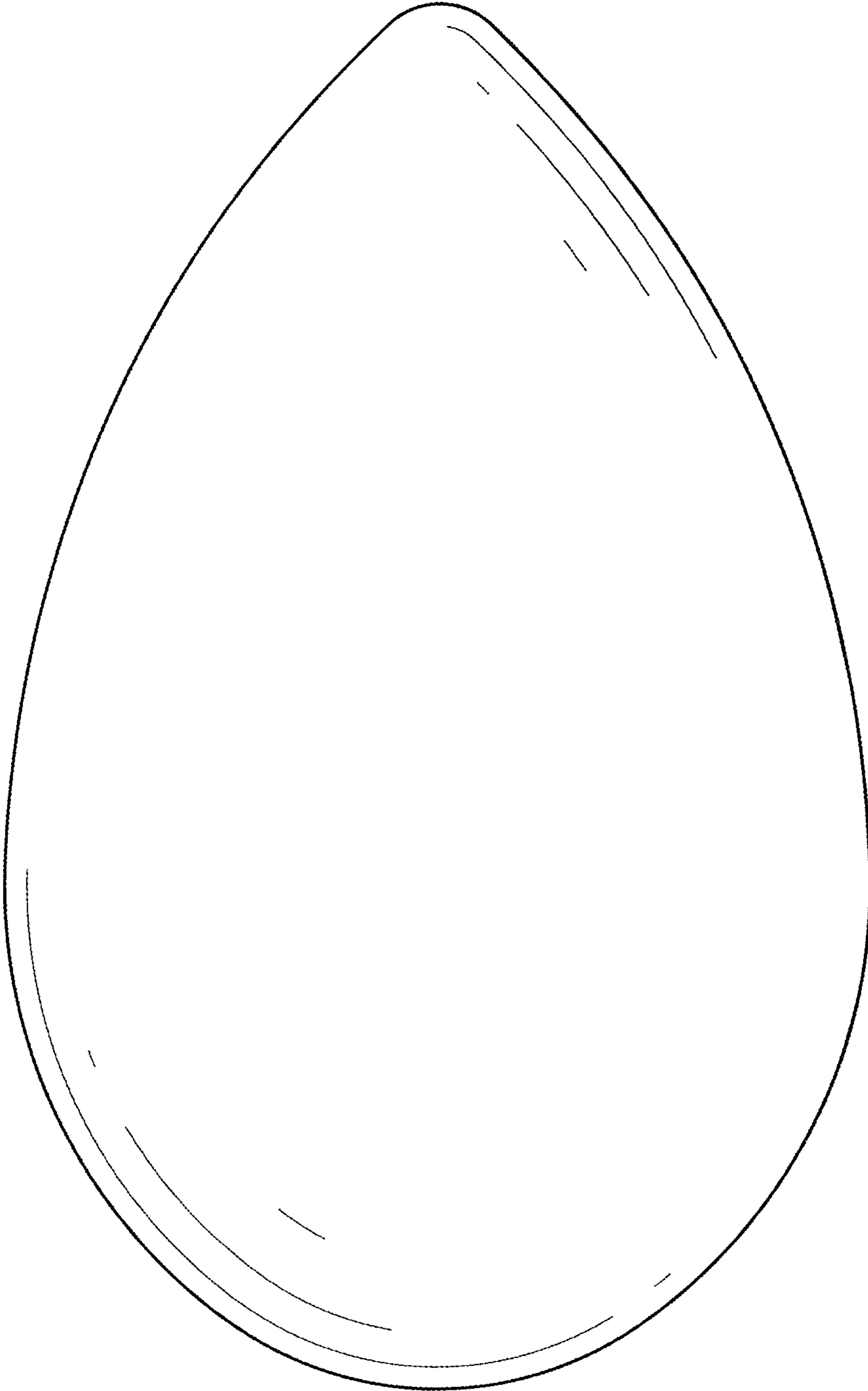

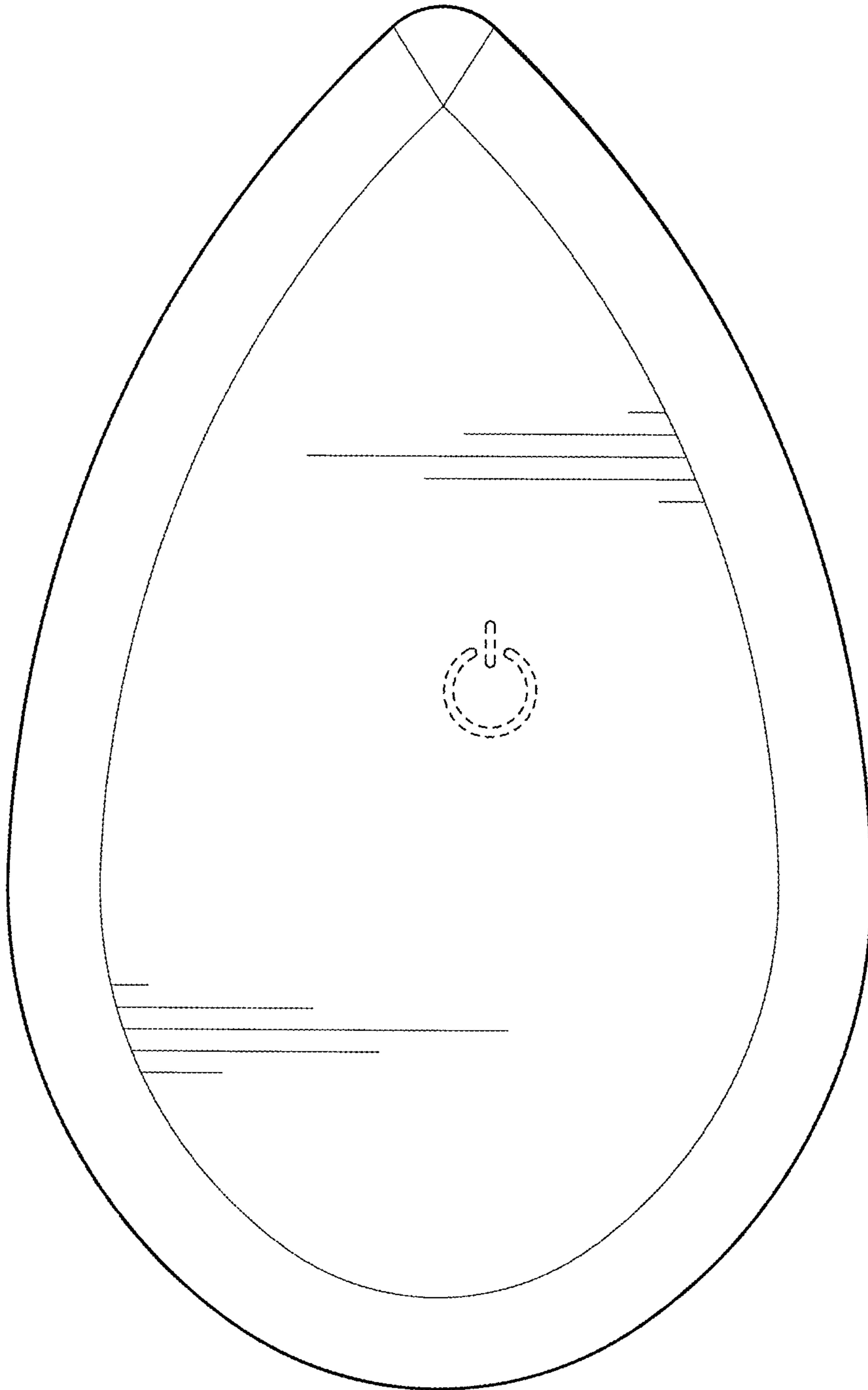

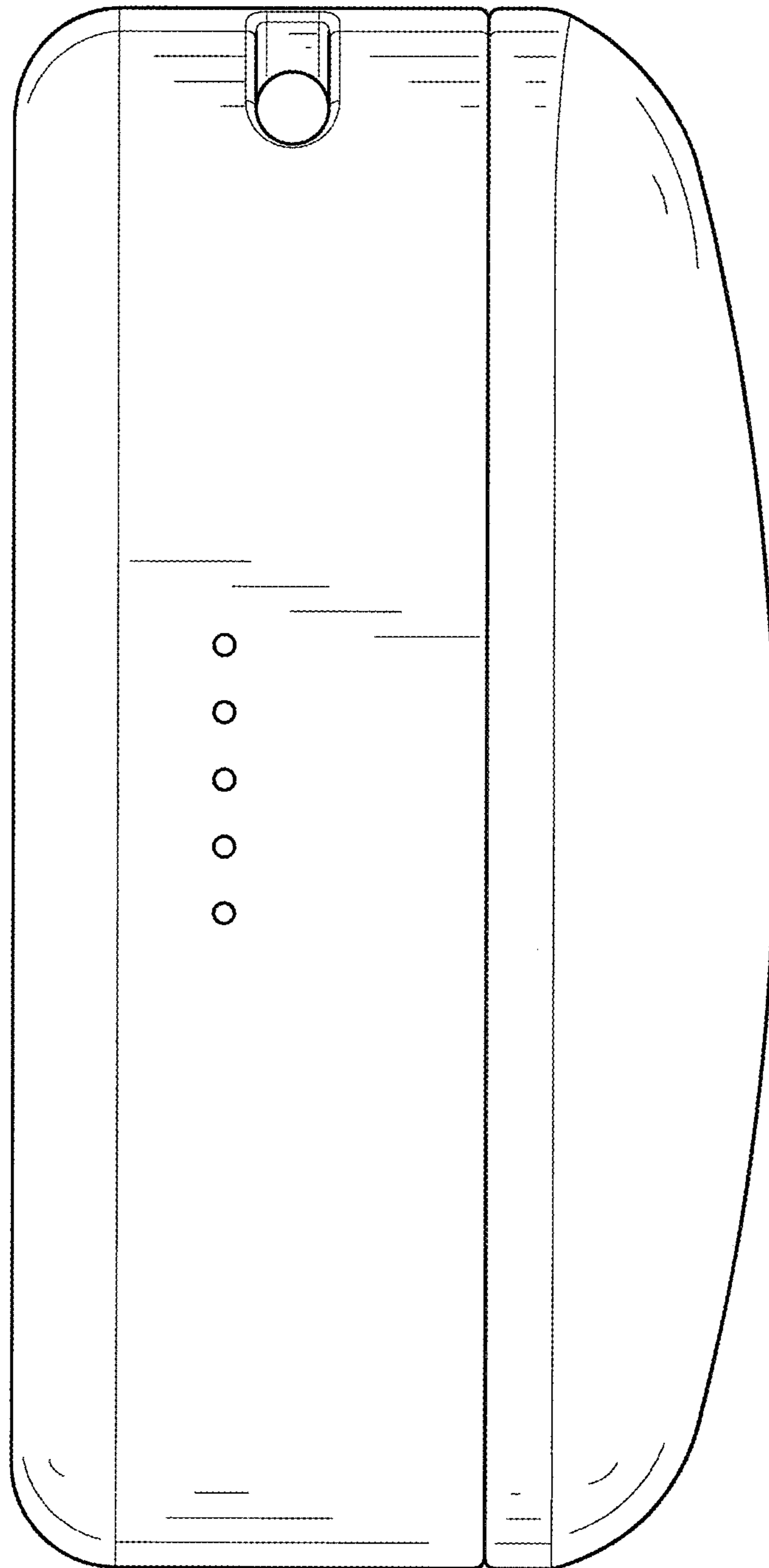

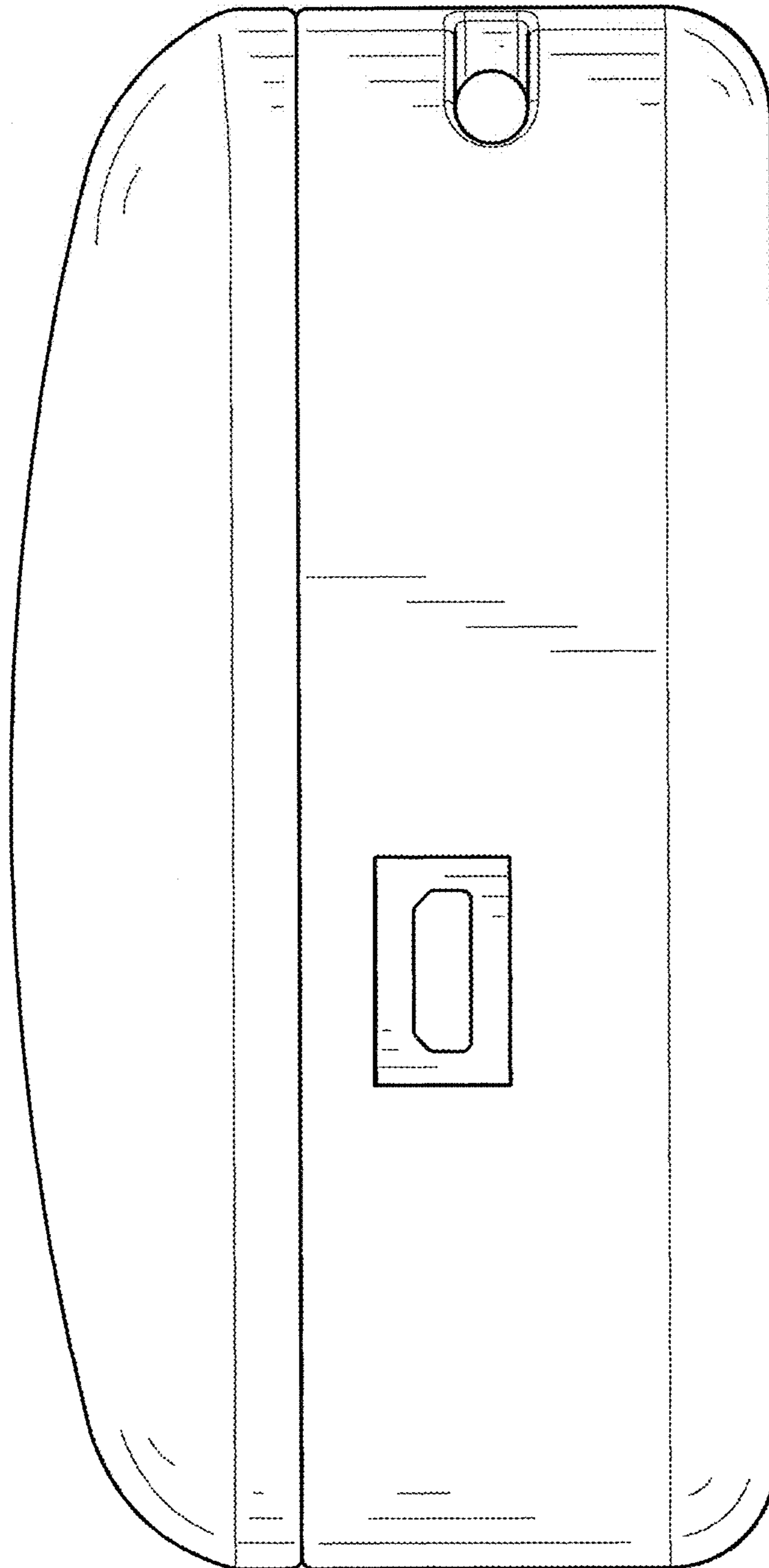

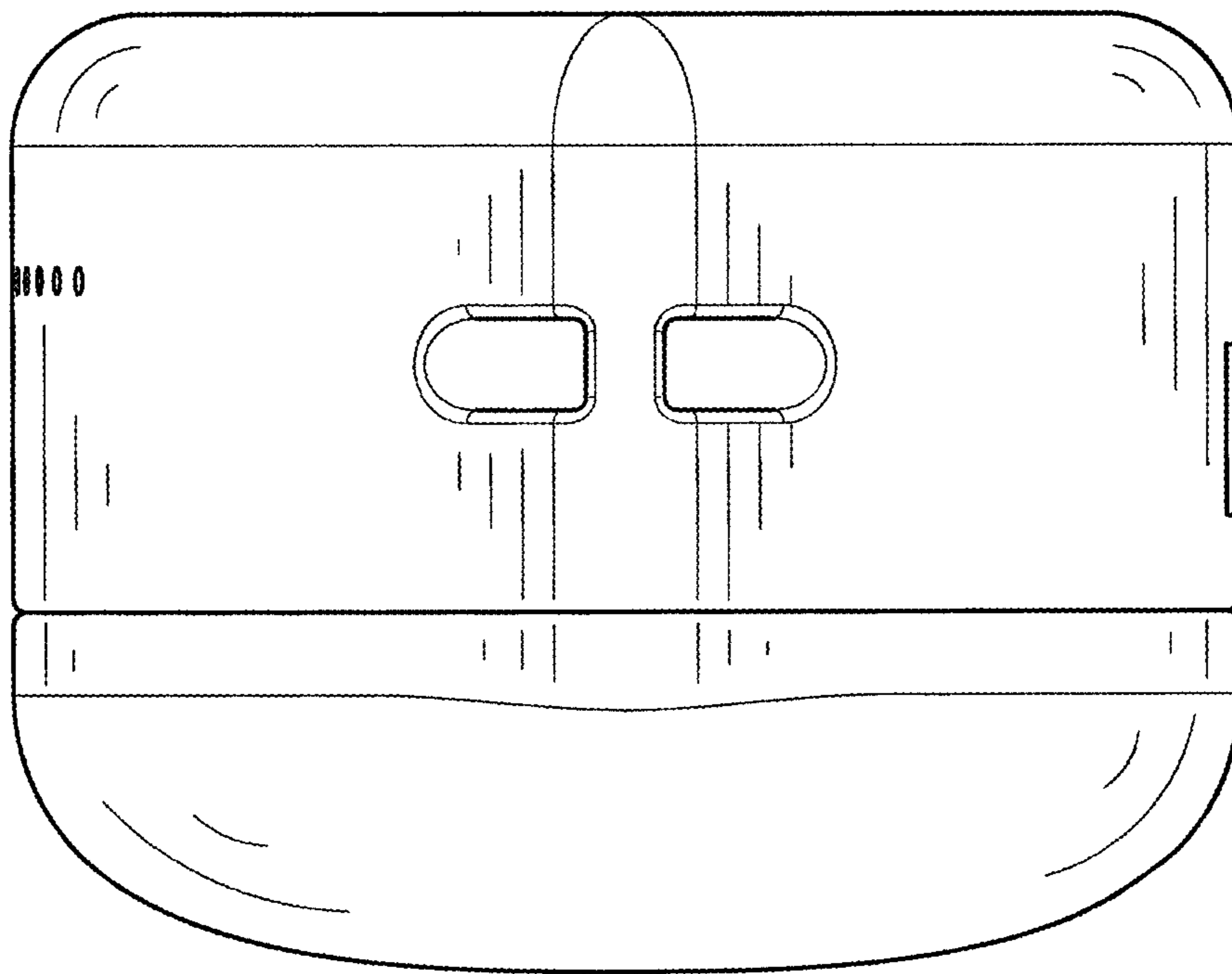

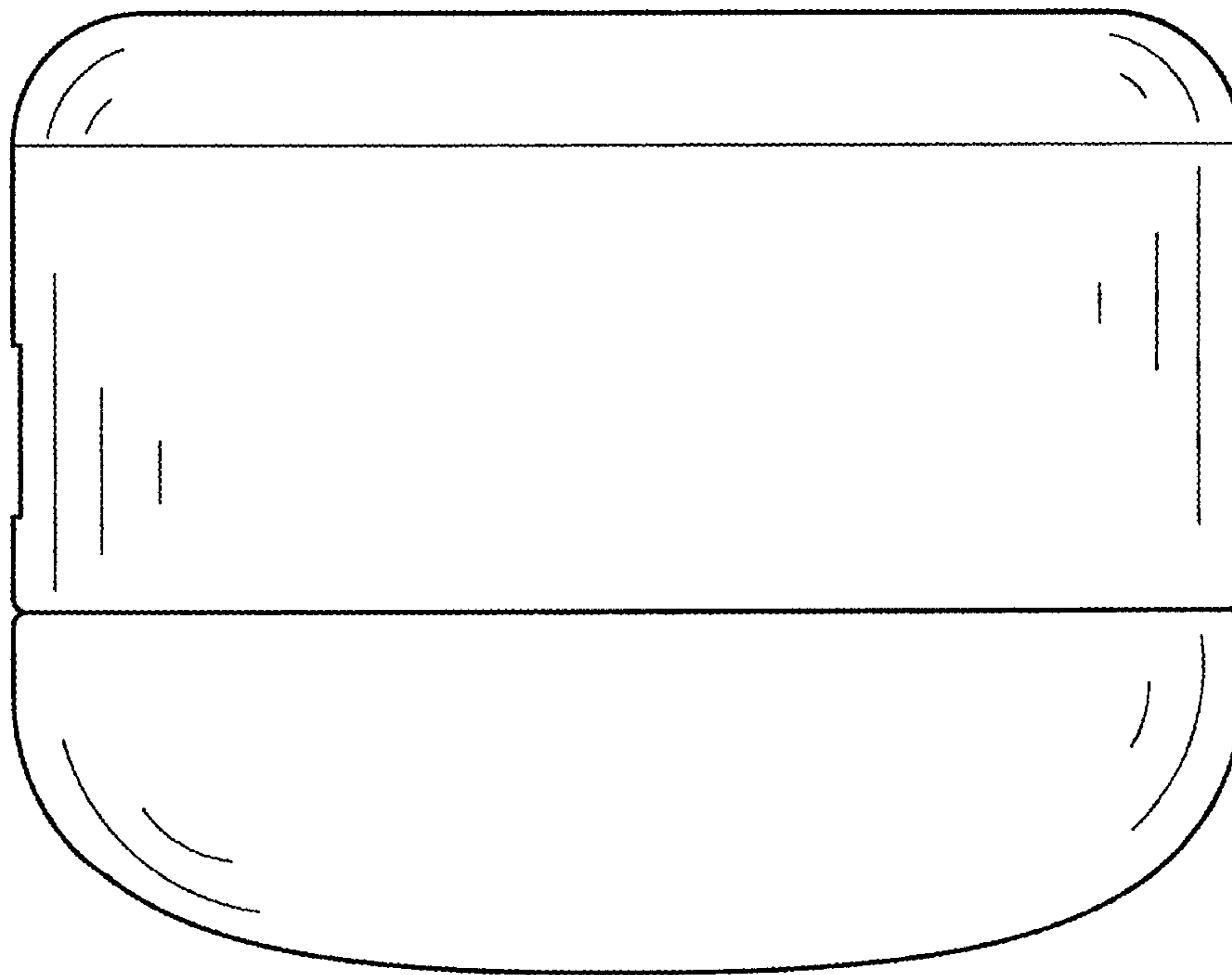
