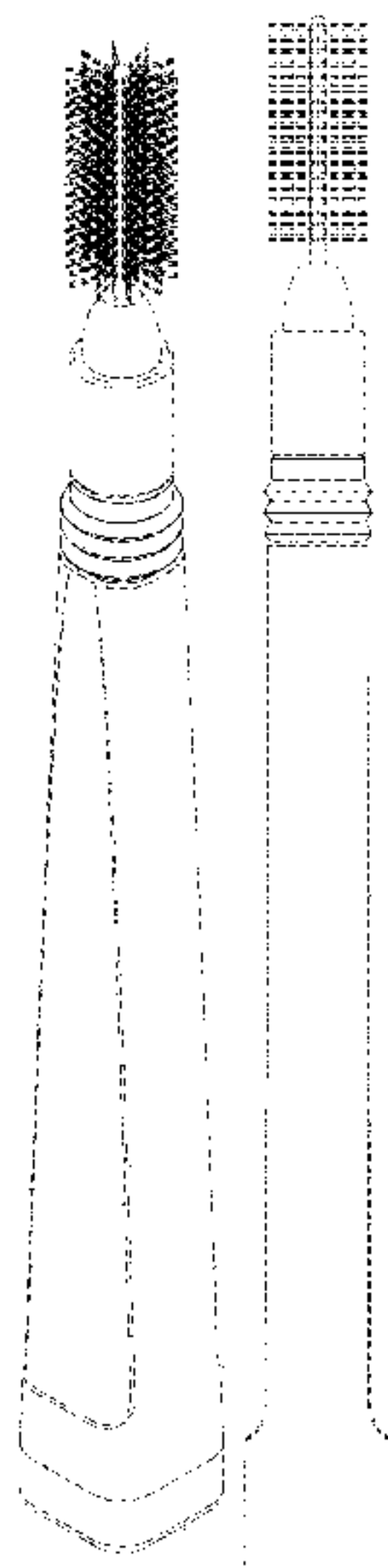
The ornamental design for an interdental brush, as shown and described.

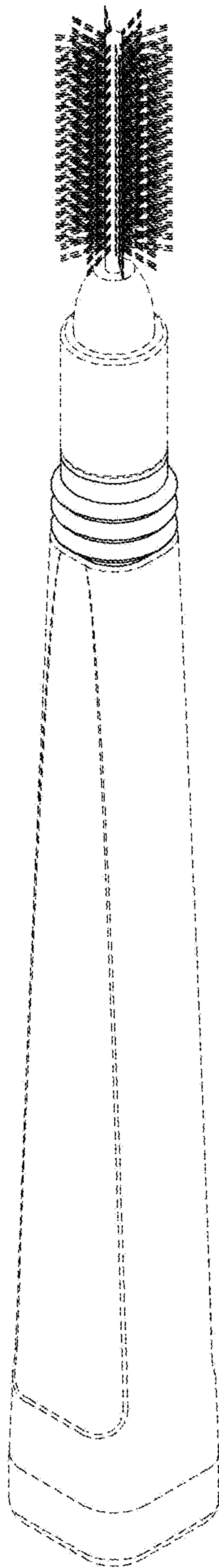

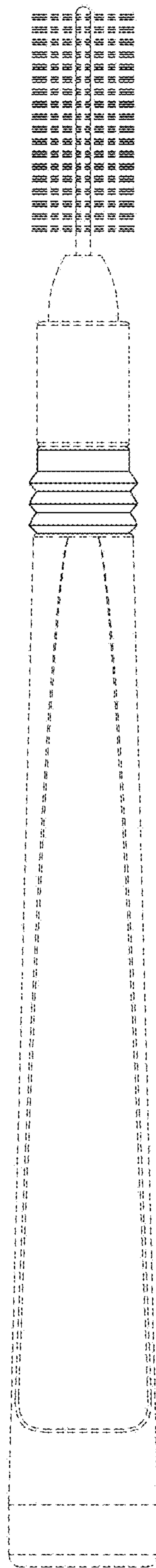

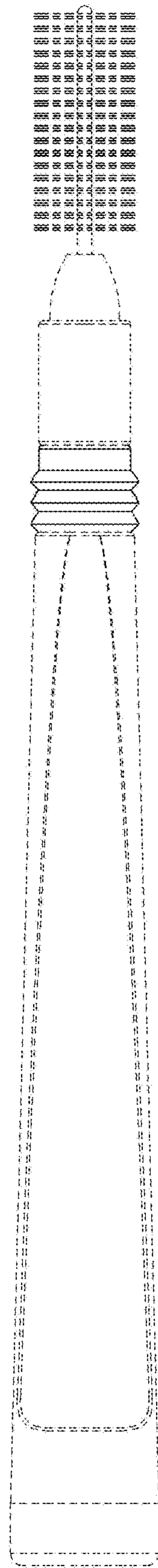

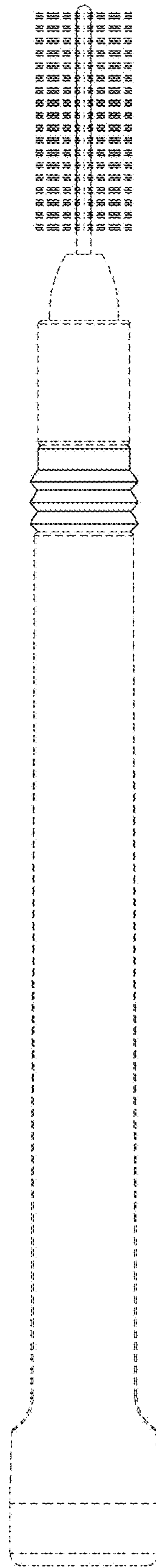

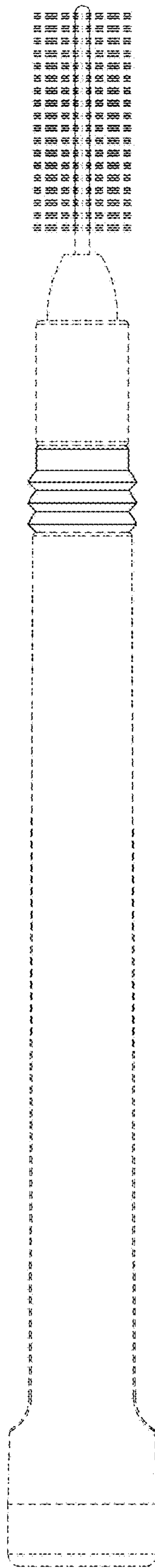

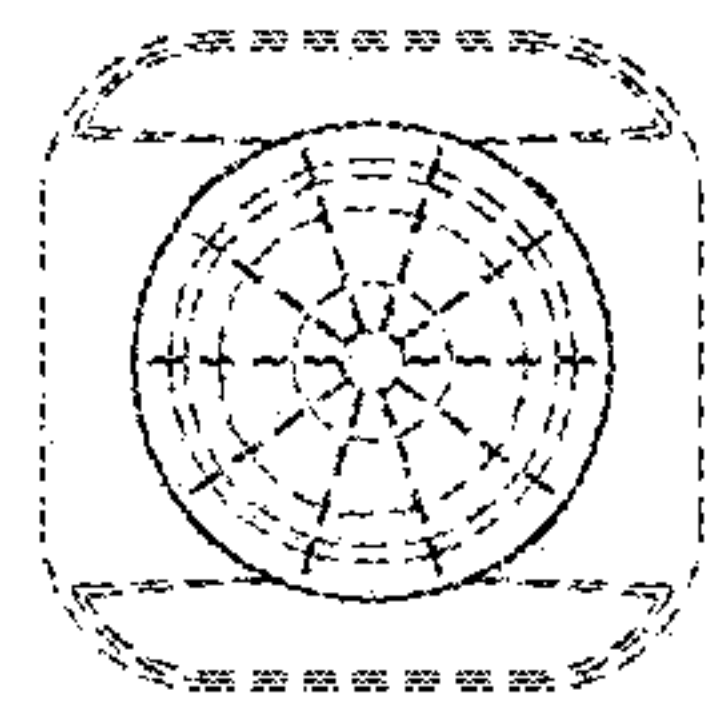

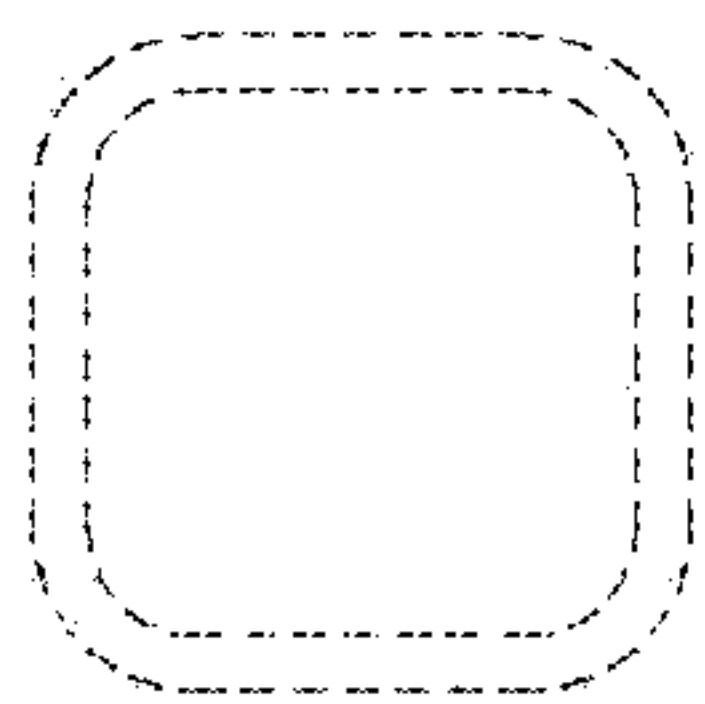
