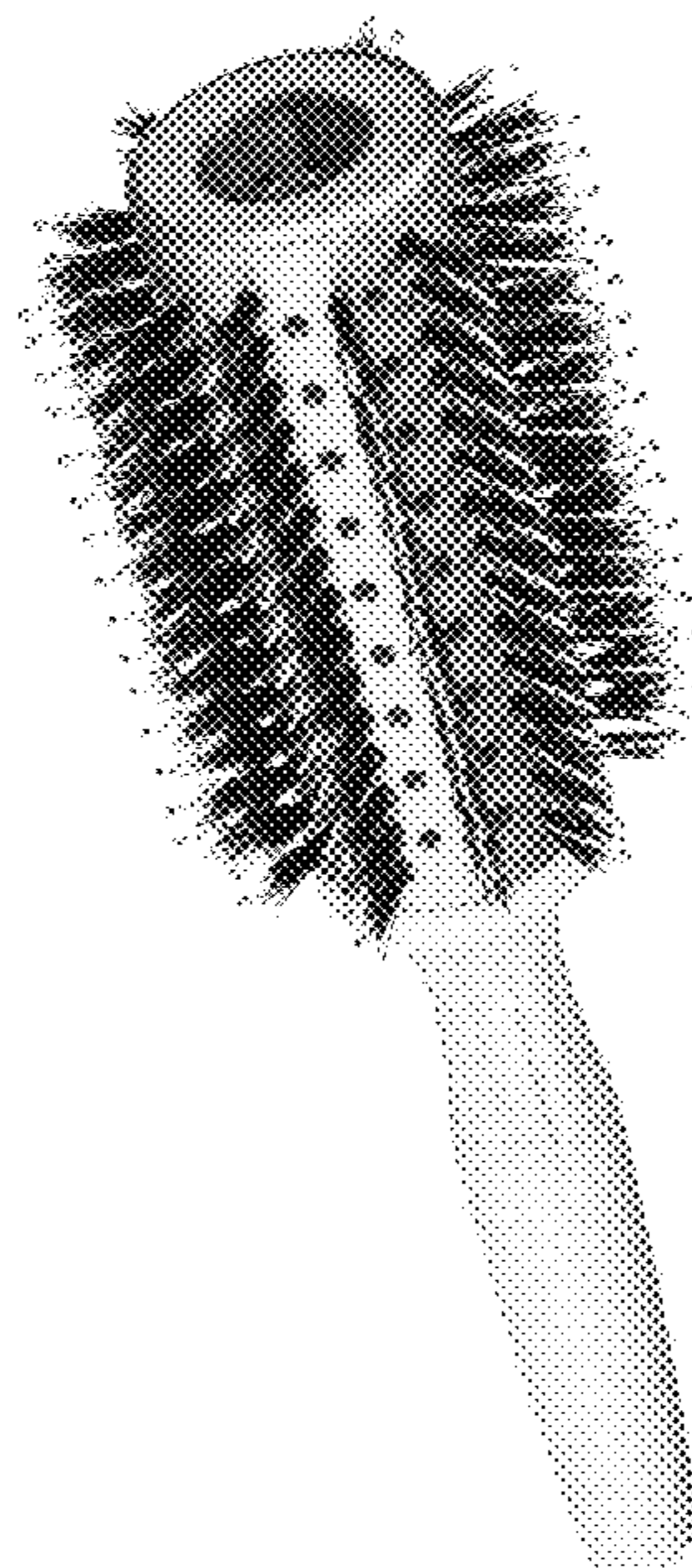
FIG. 5 is a left side view of the hair brush of FIG. 1; the right side view, front view, and rear view are the same.

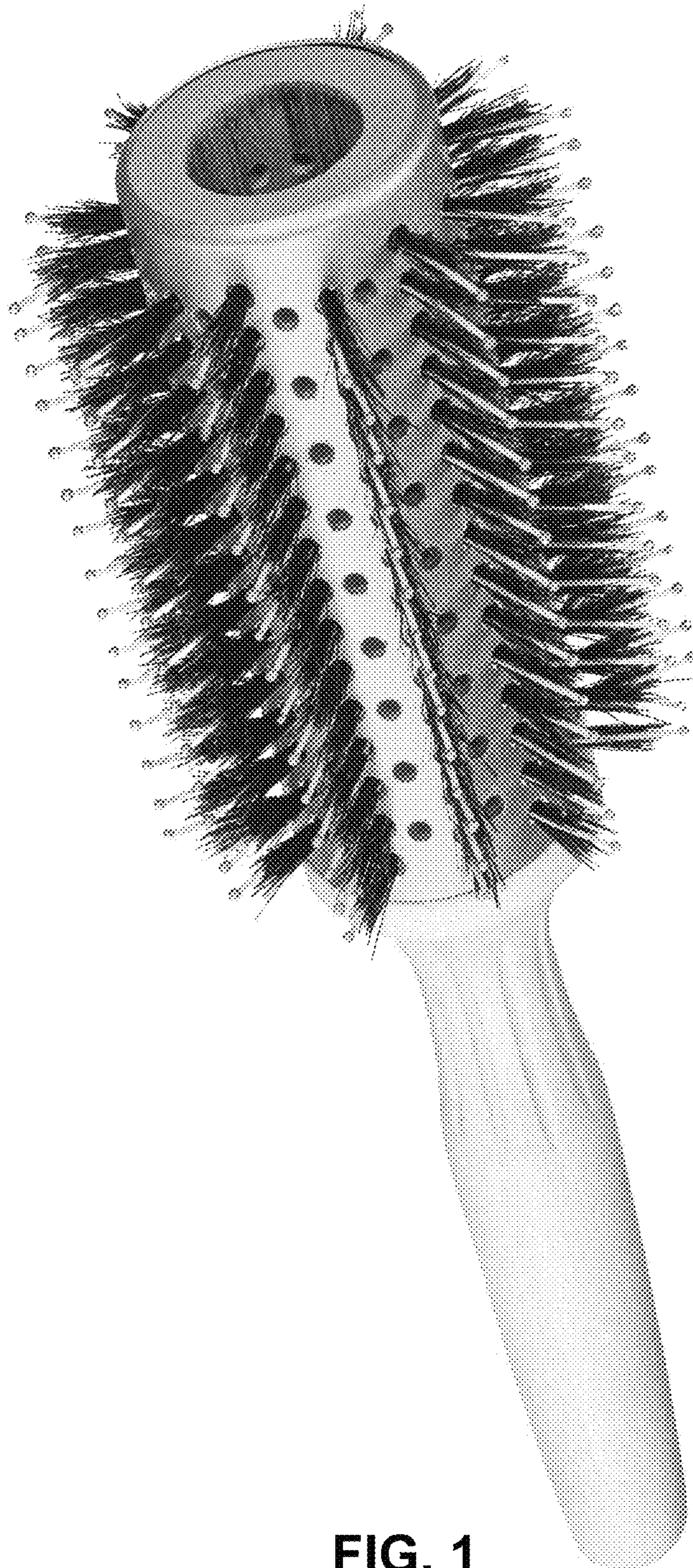
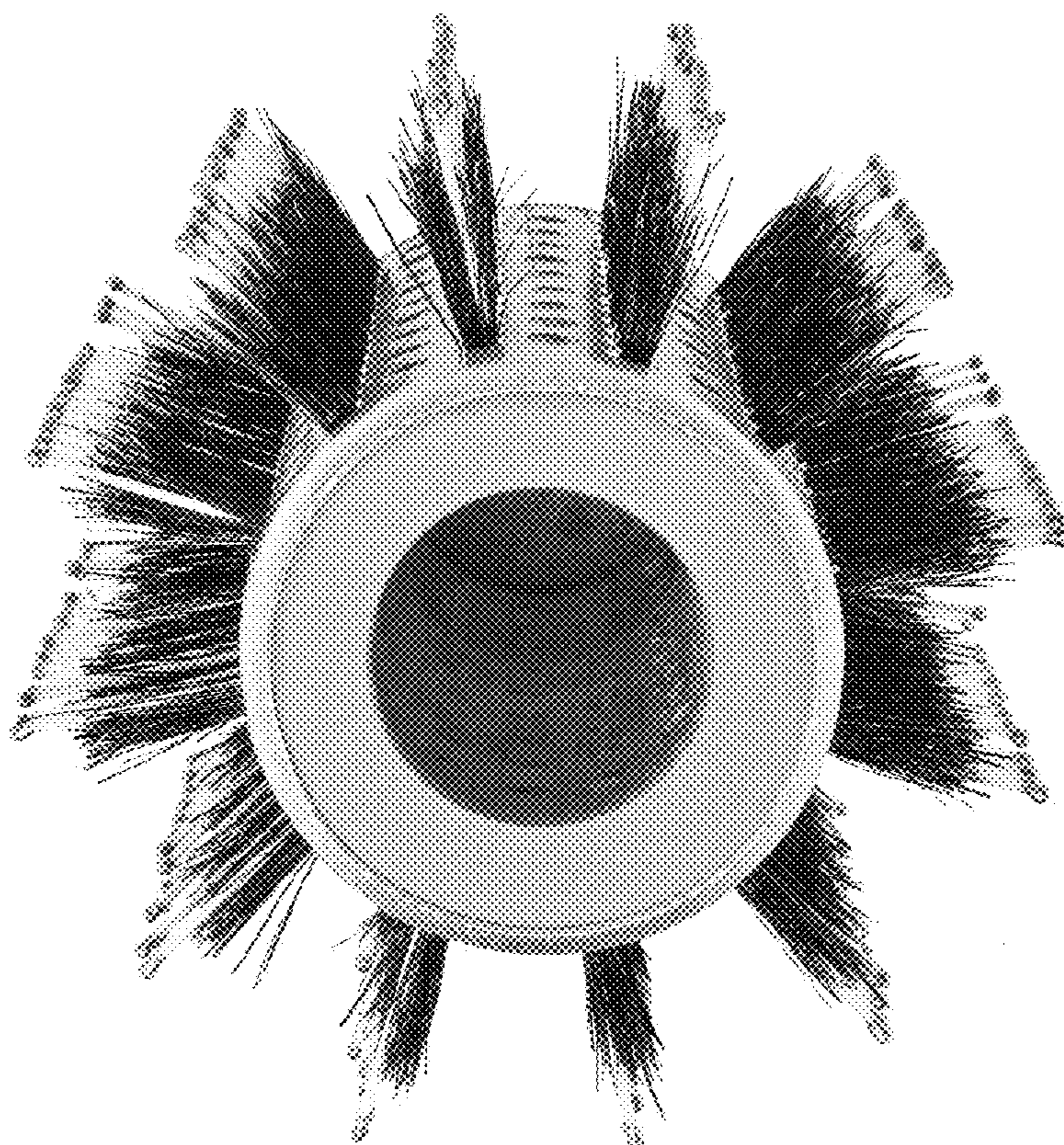
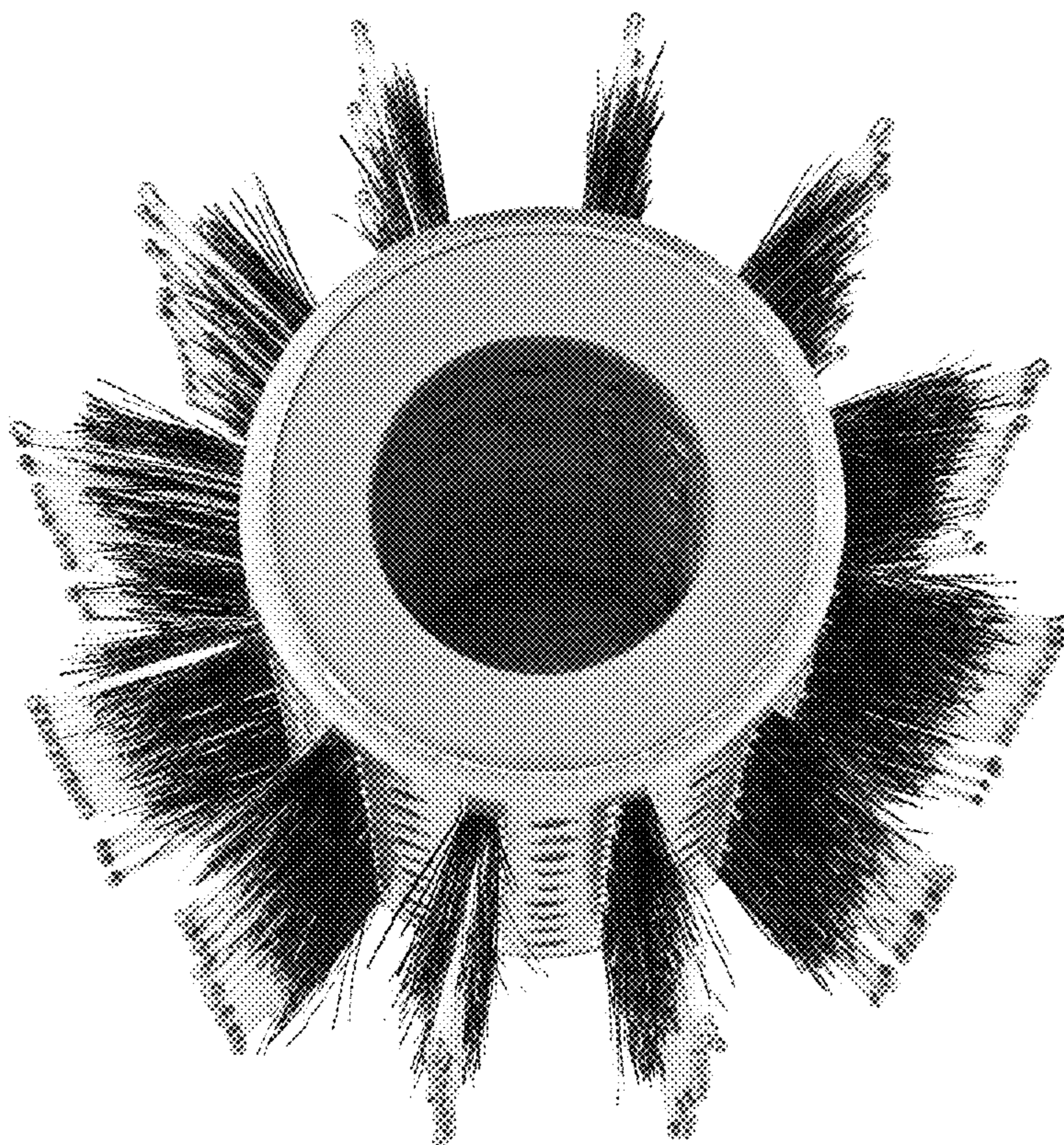

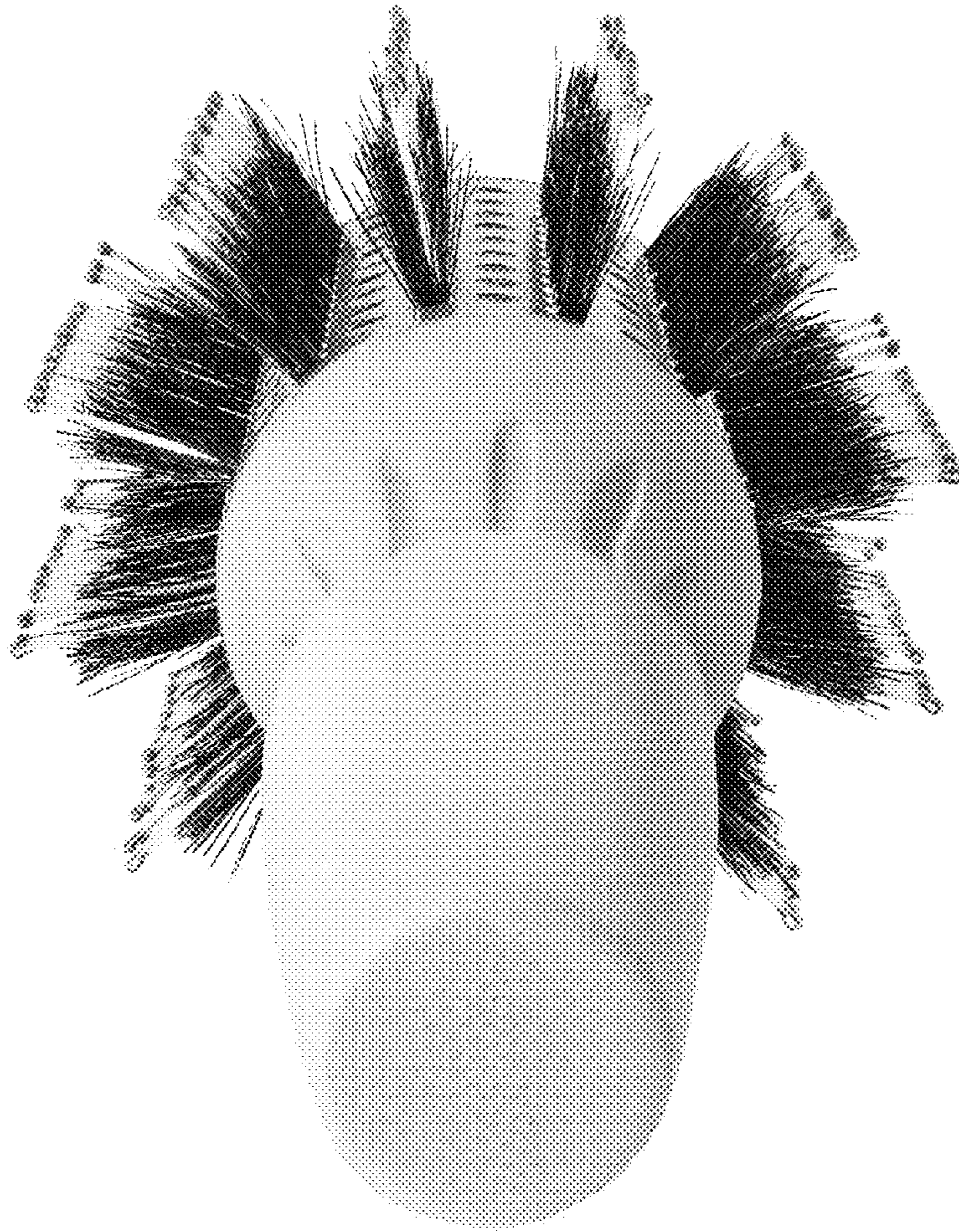

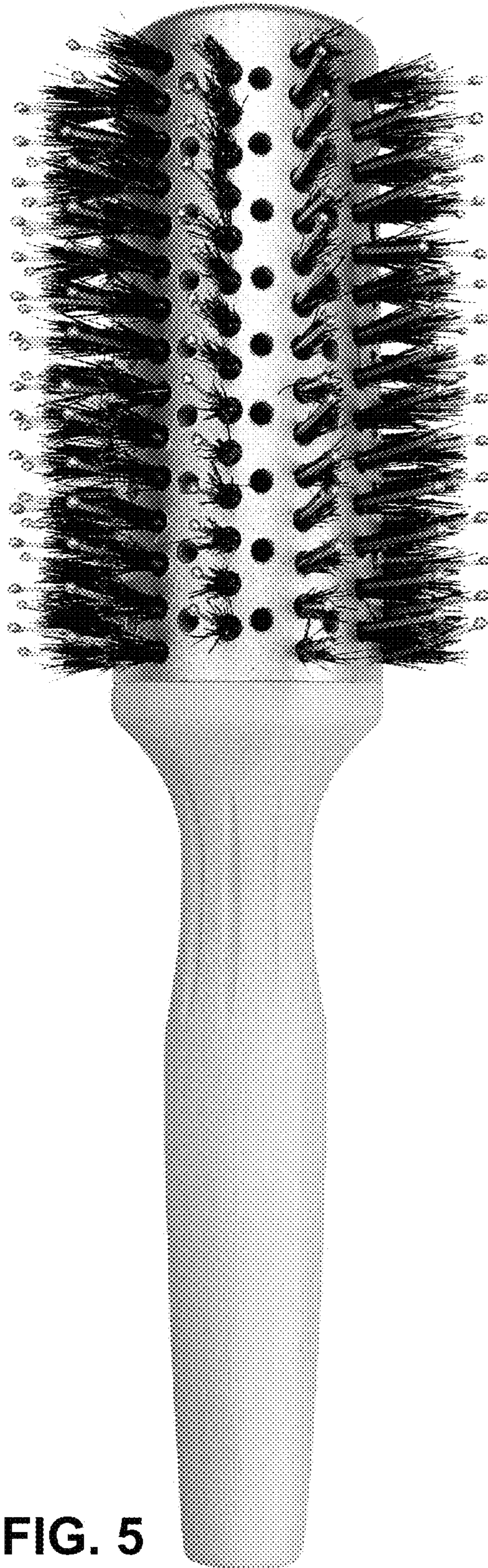
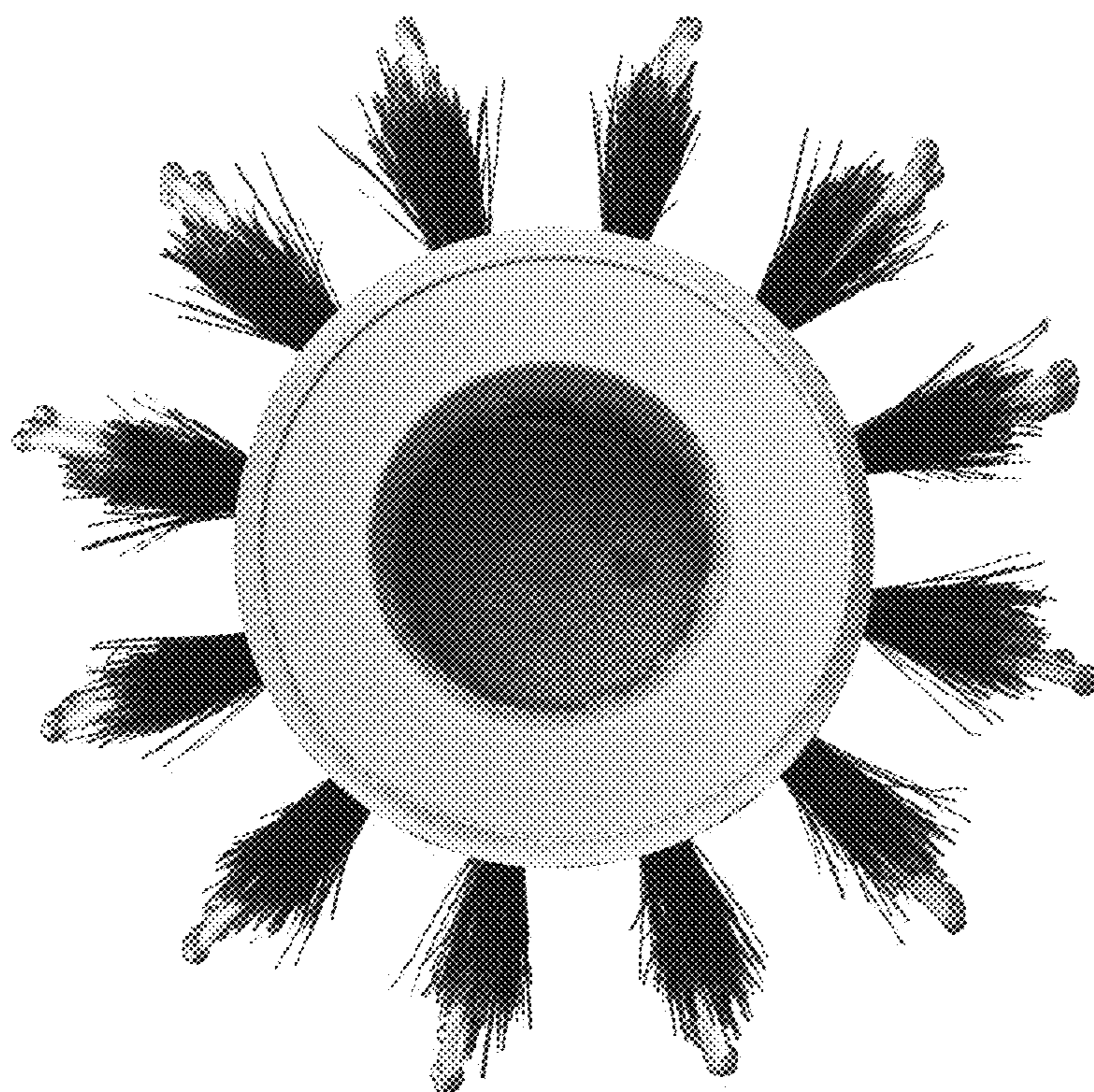
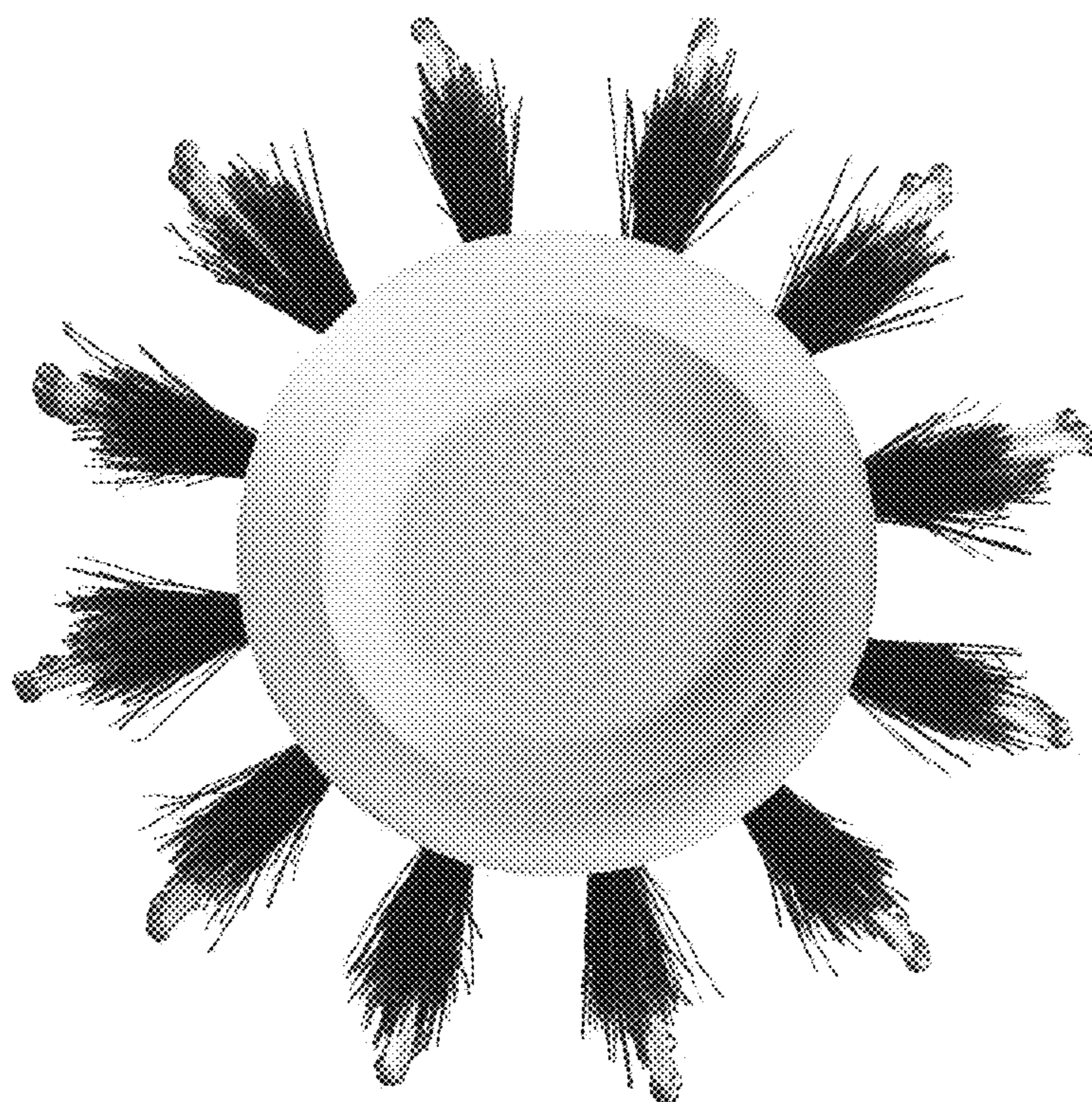
