I claim the ornamental design for the office chair, as shown and described.

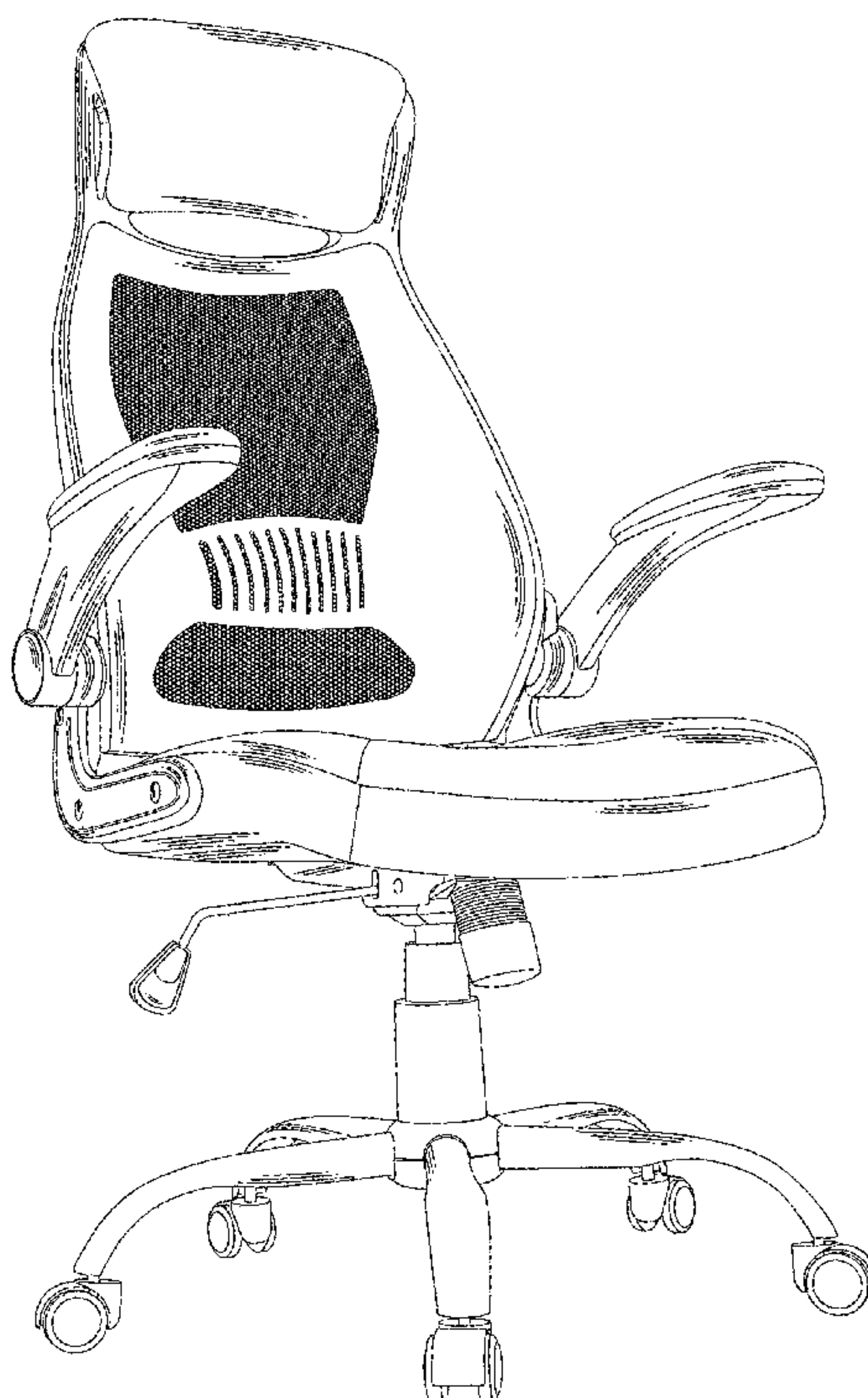
DESCRIPTION

FIG. 1 is a perspective view of an office chair showing my new design;

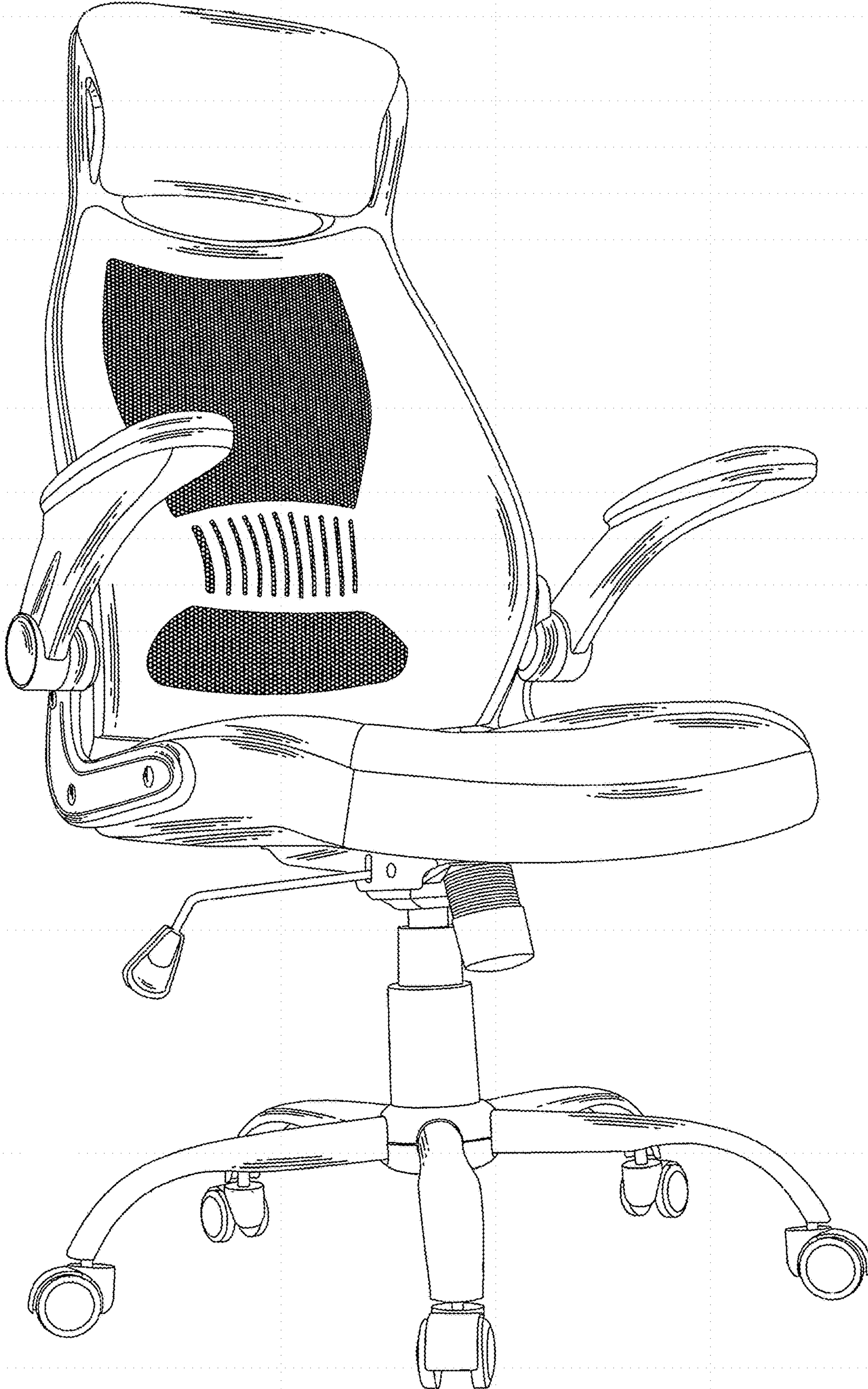

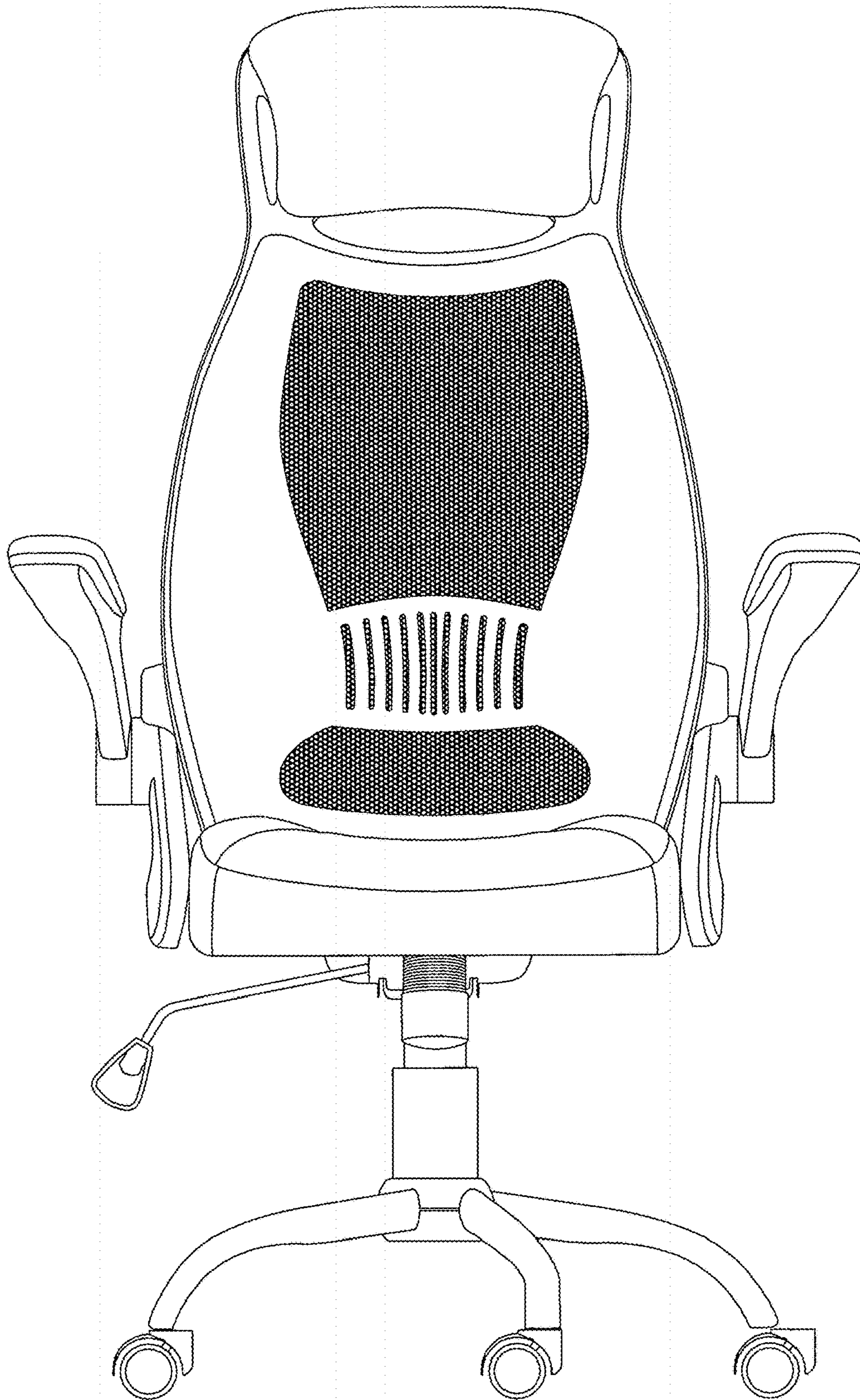

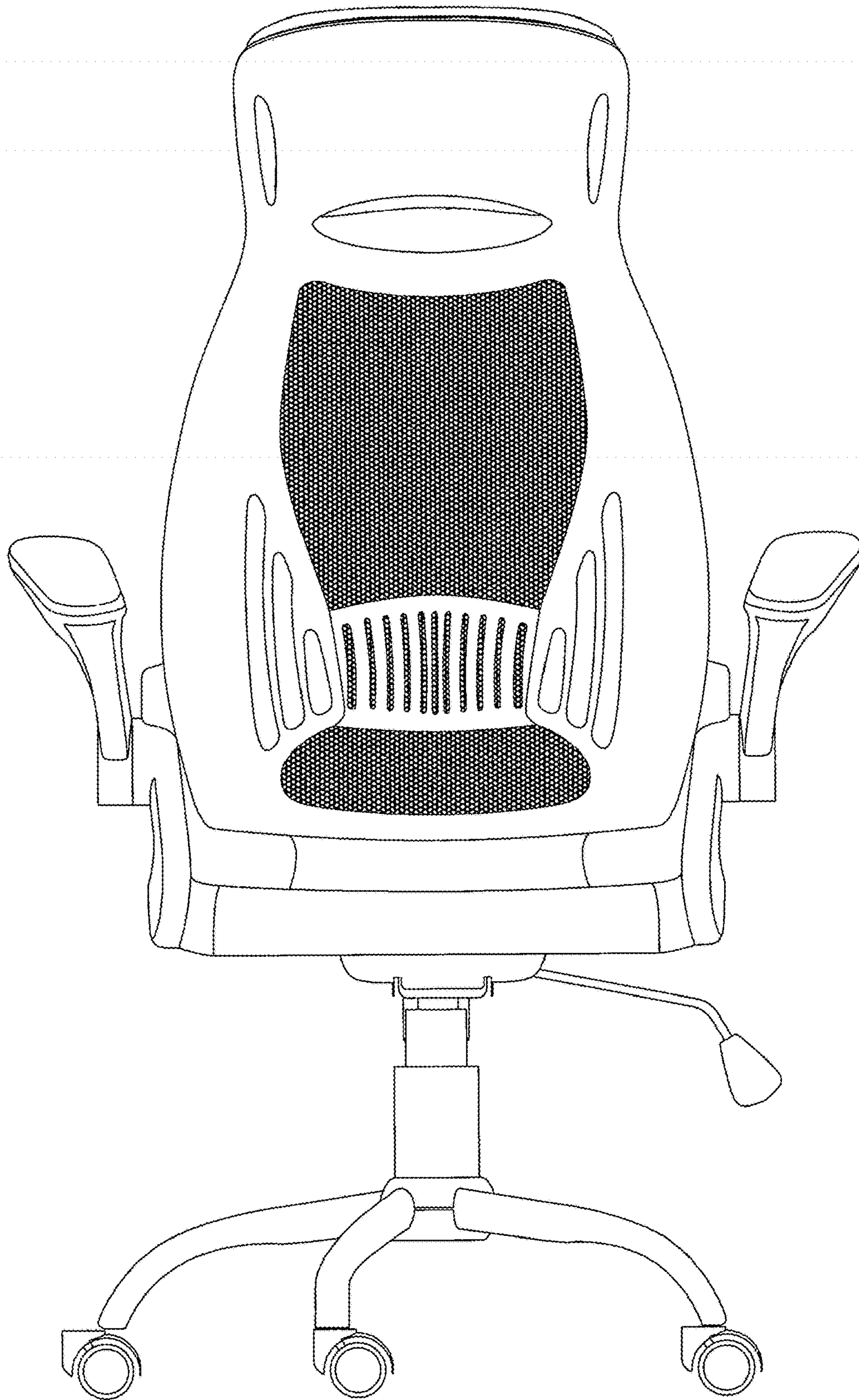

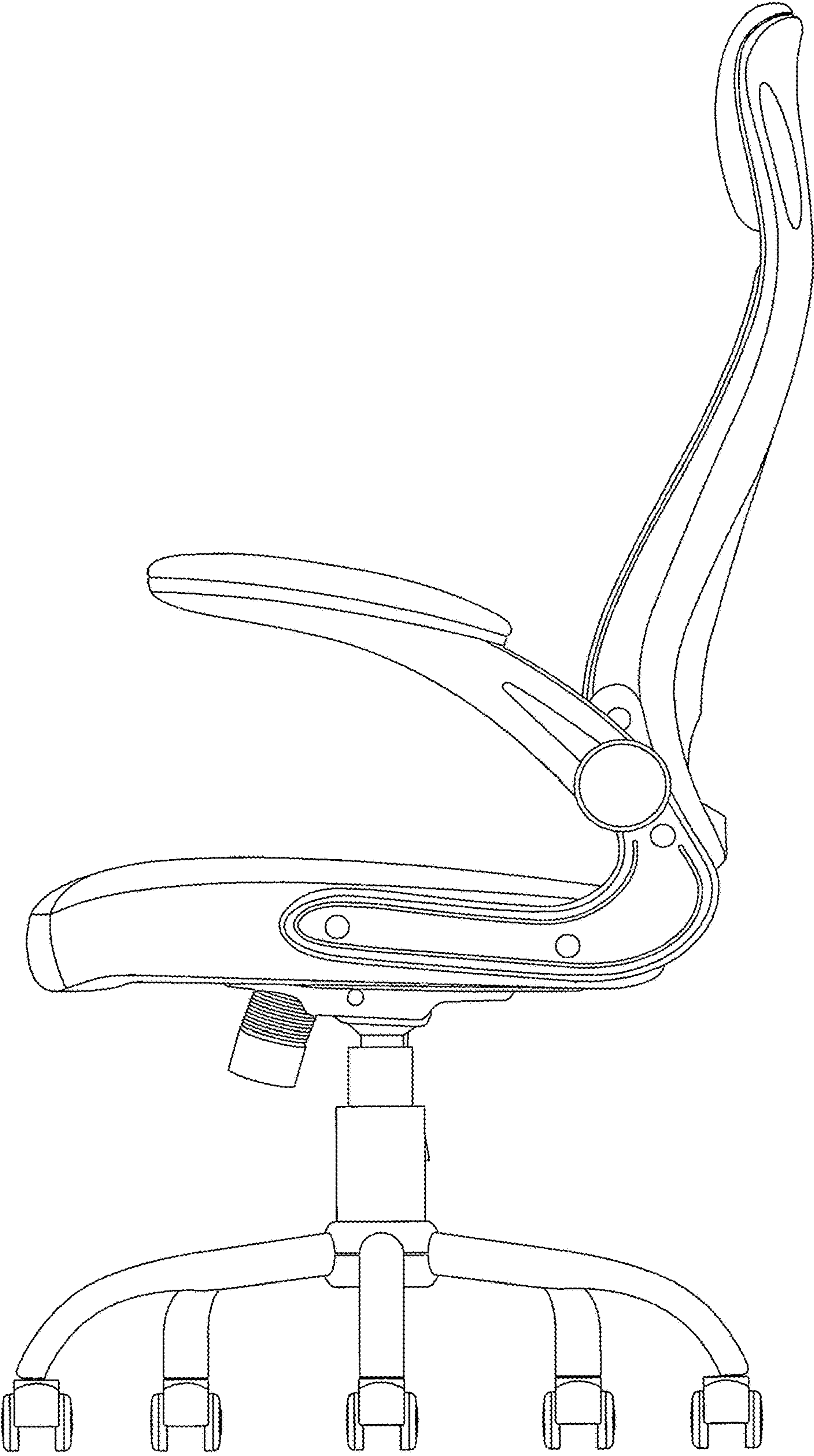

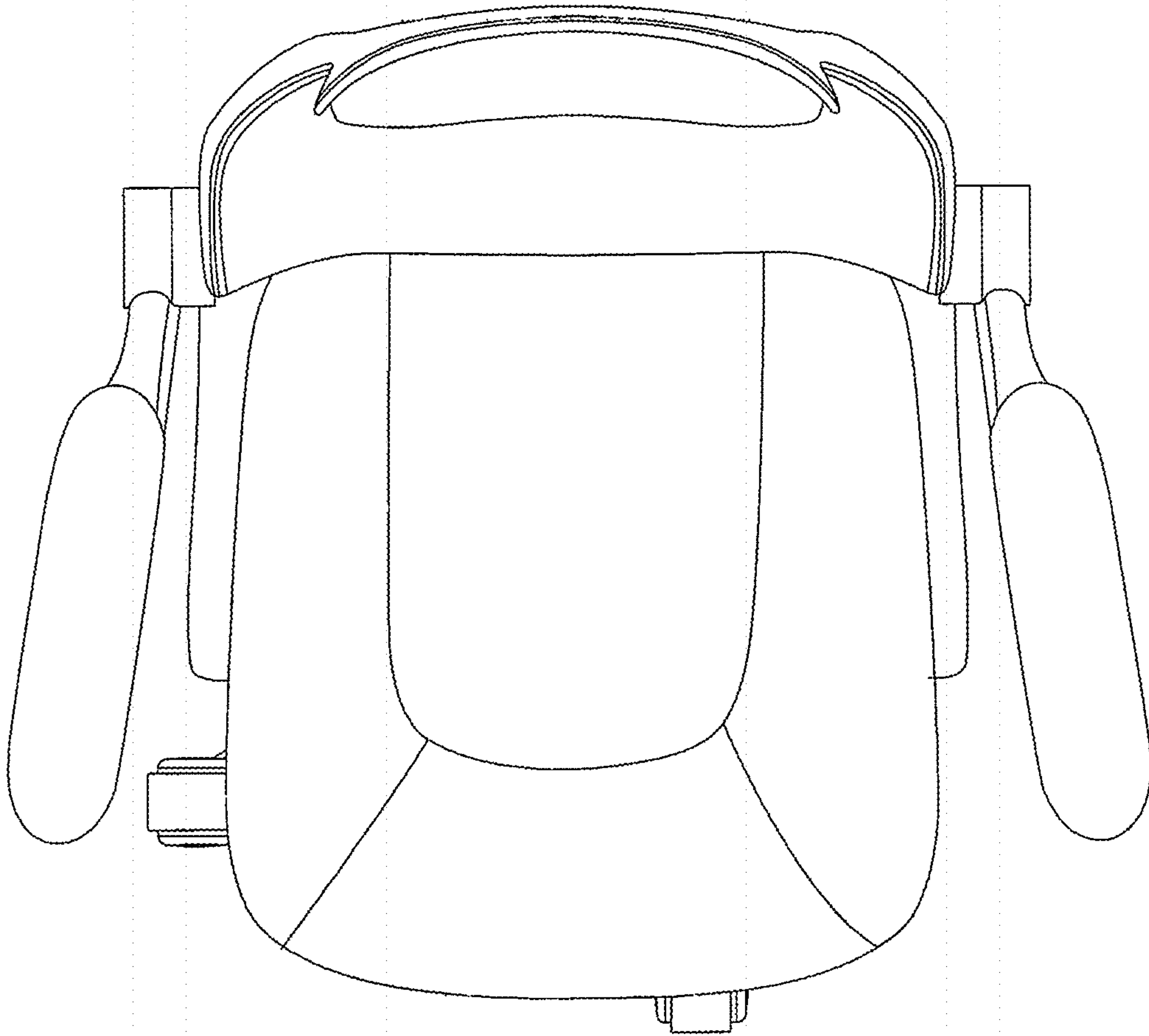

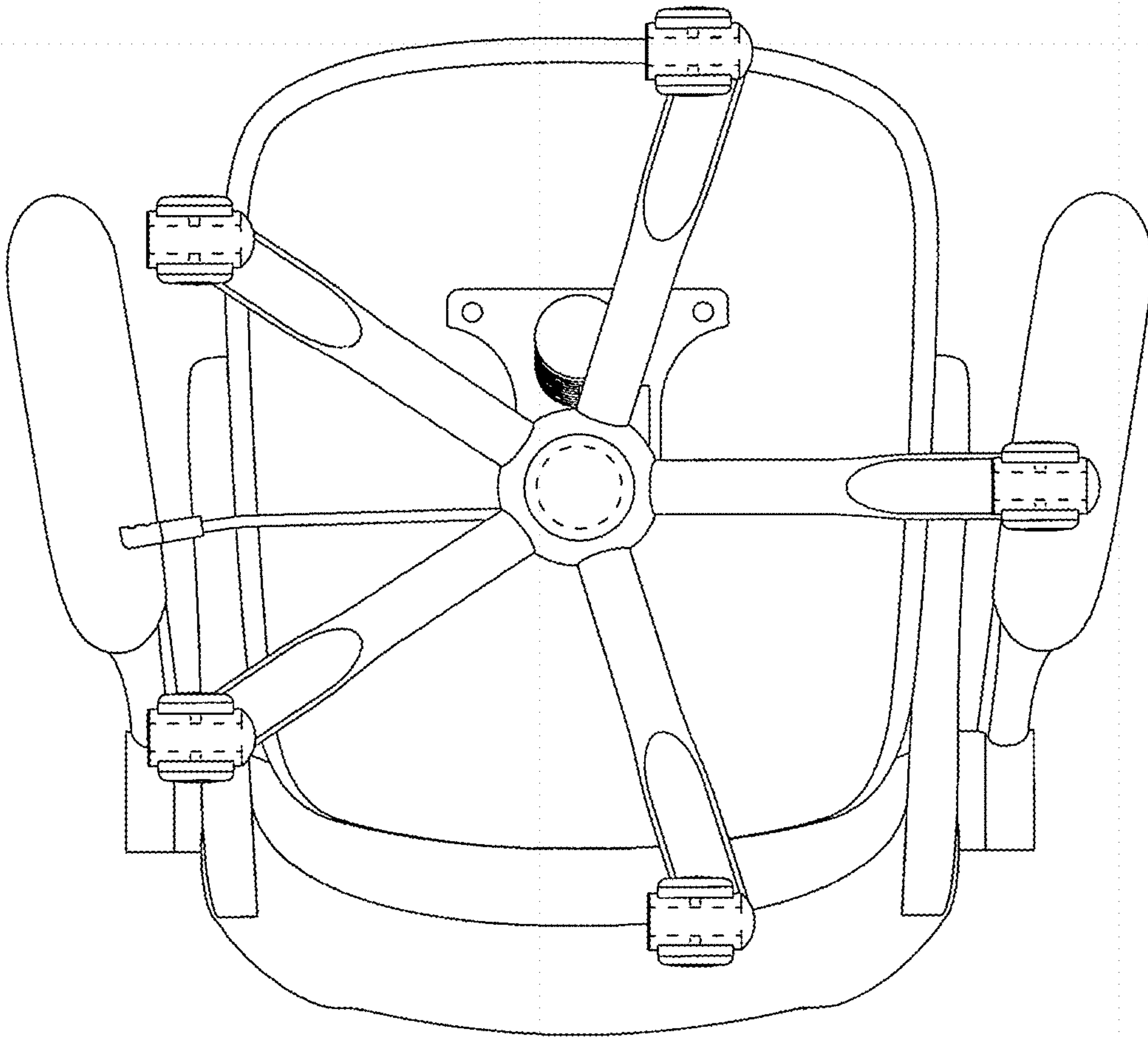
