DESCRIPTION

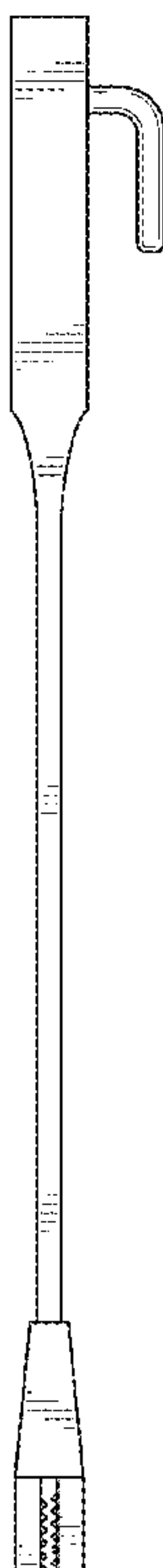

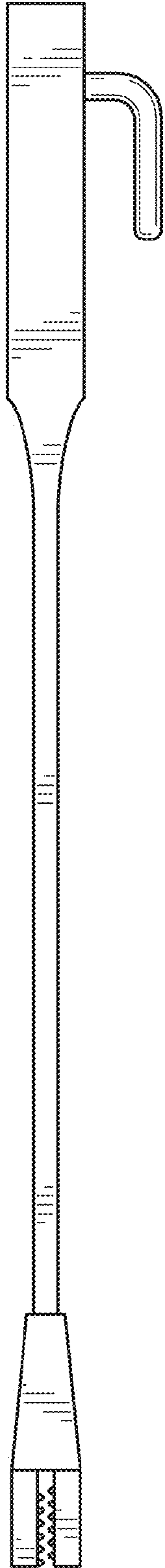

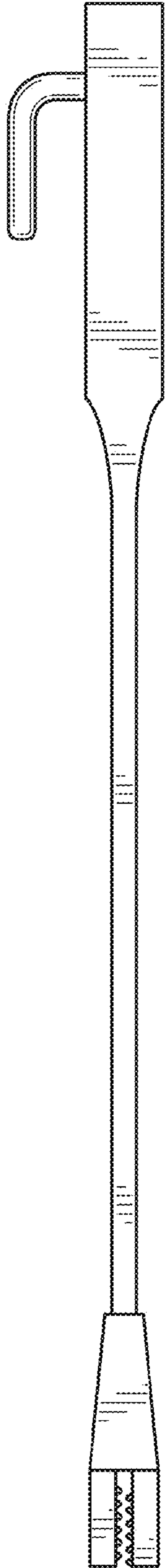

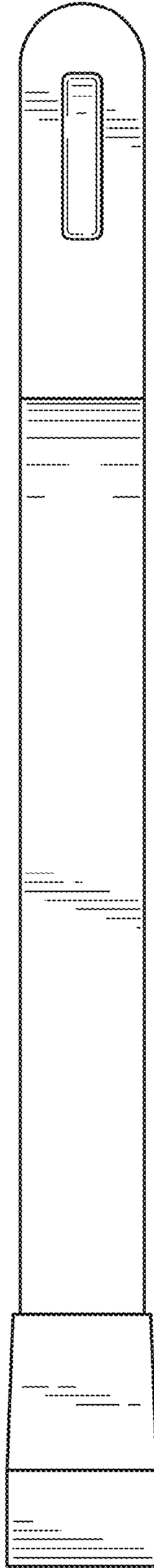

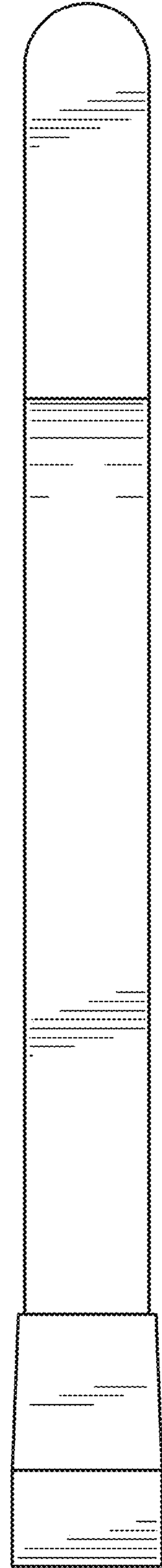

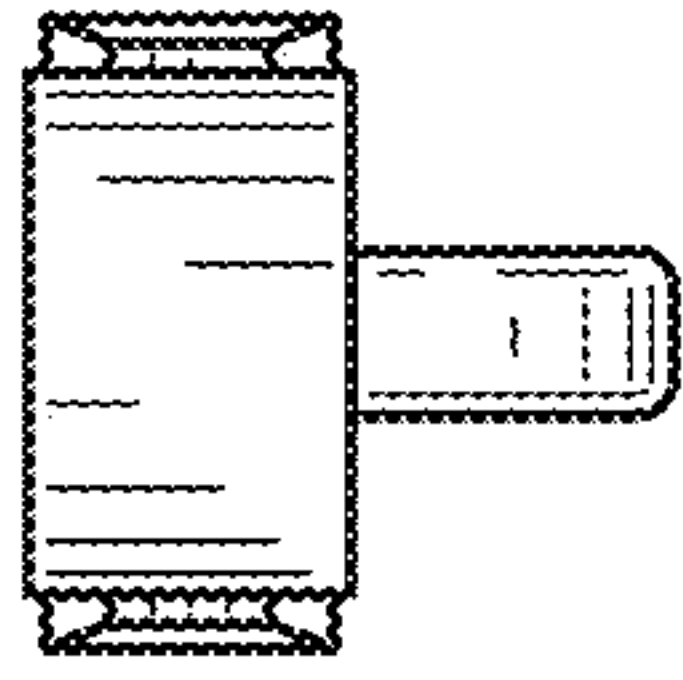

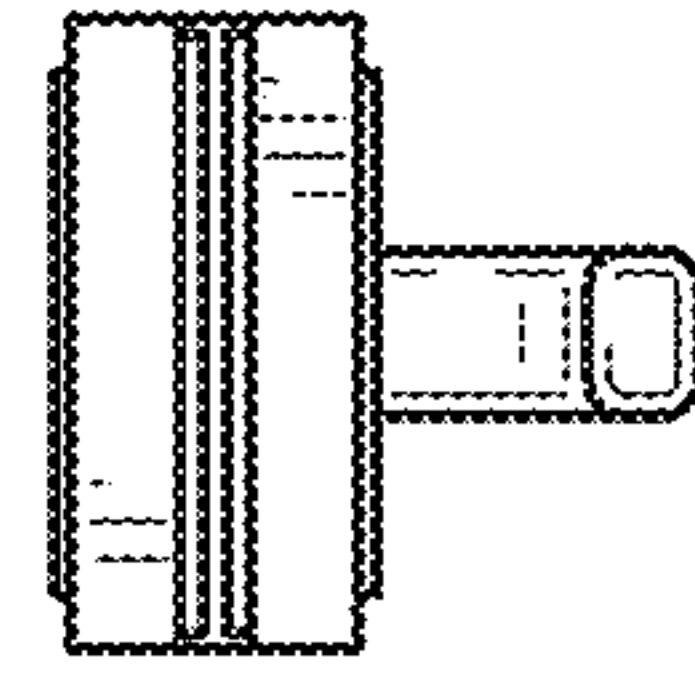
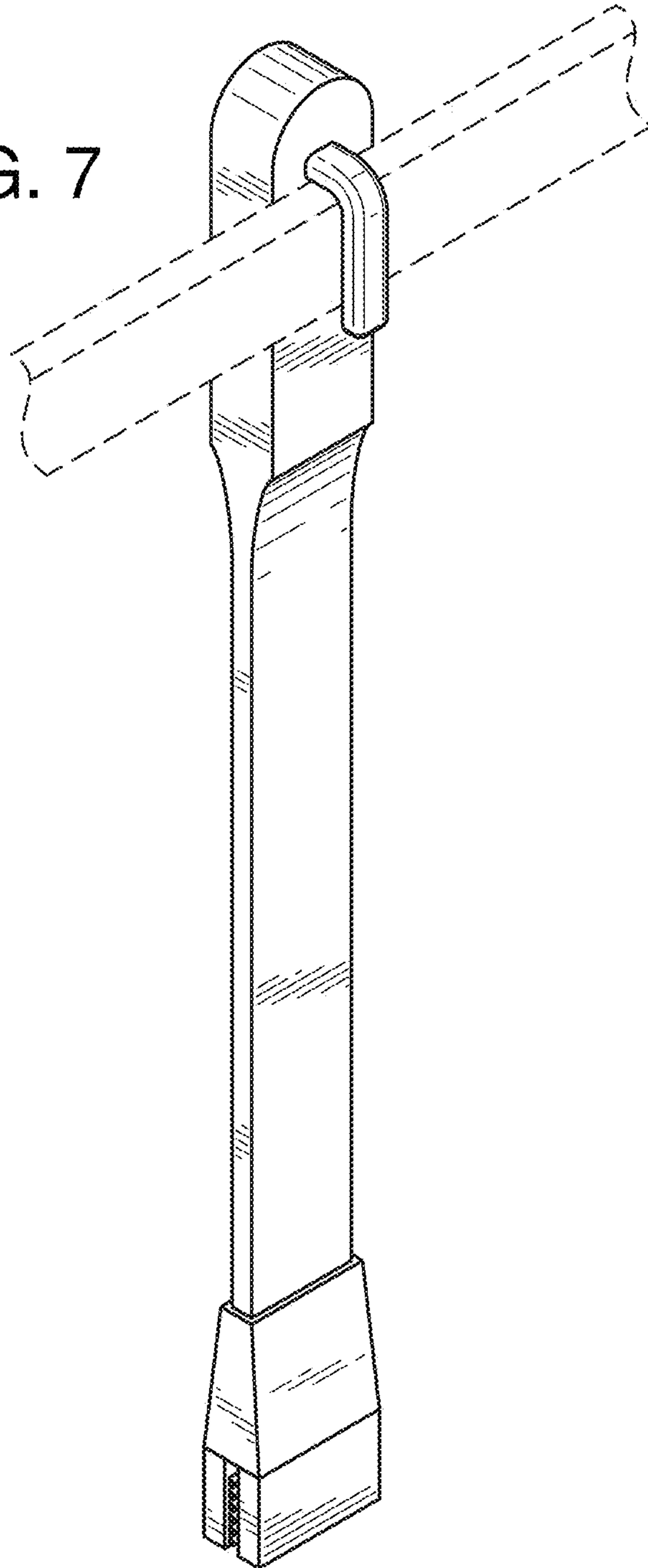

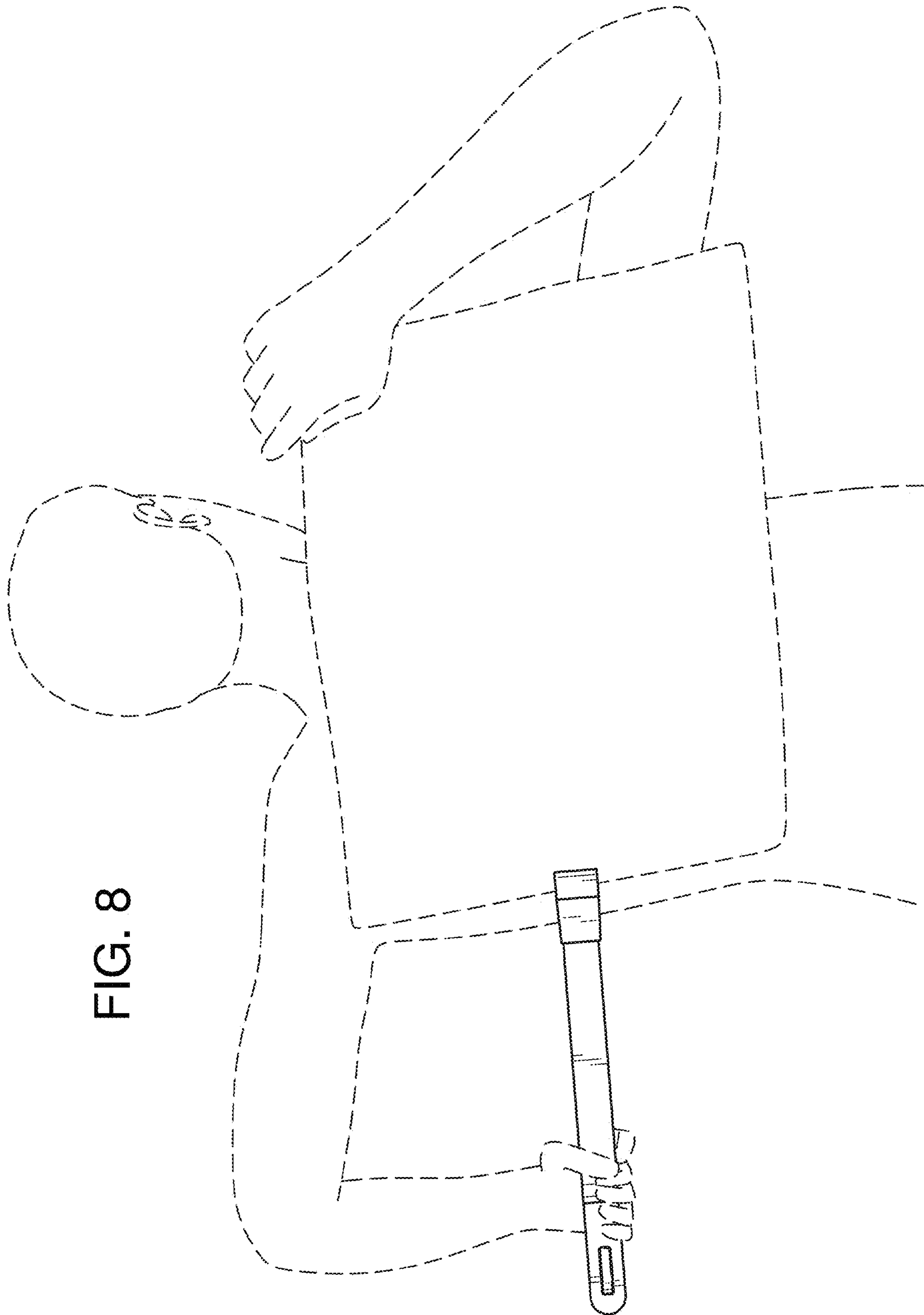
