(57) **CLAIM**

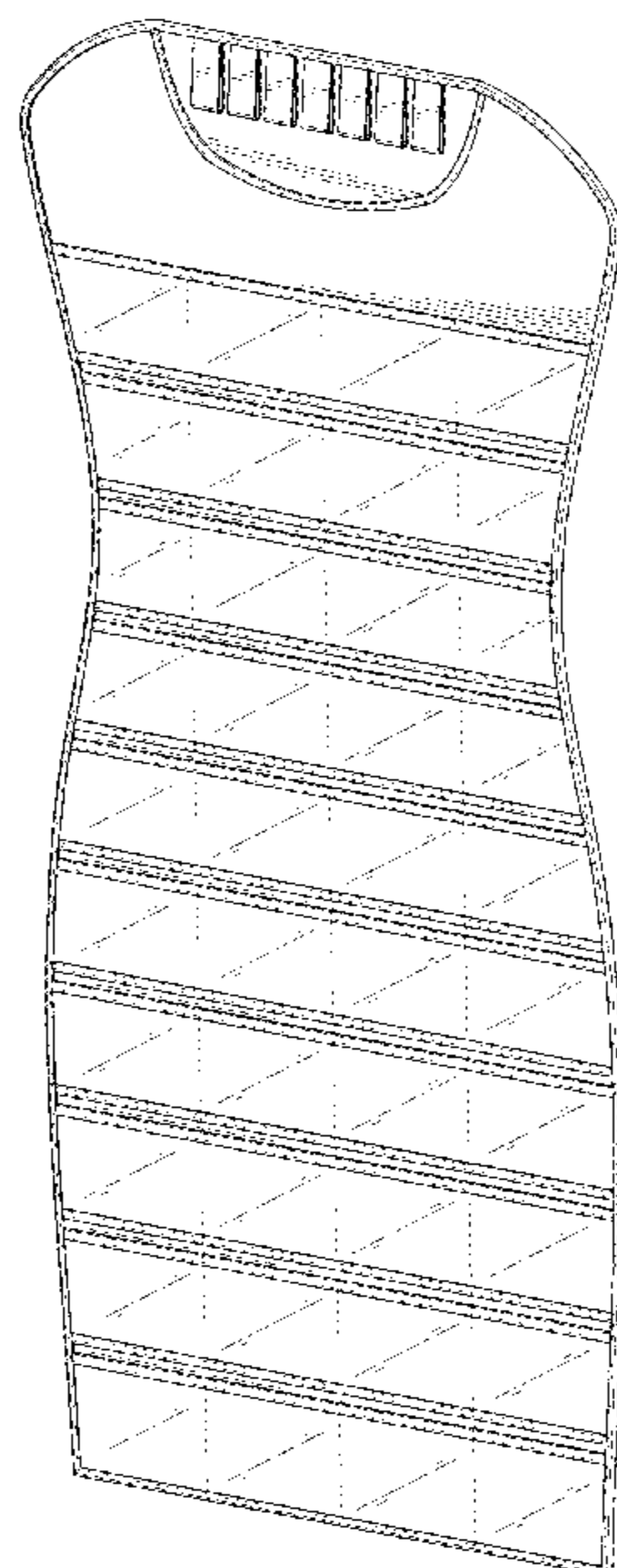
The ornamental design for a jewelry organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of a jewelry organizer showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof; and,
FIG. 5 is a front, right side, top perspective view of the jewelry organizer showing the jewelry organizer being hung upon a clothes hanger.
The broken lines depict environmental that forms no part of the claimed design for the jewelry organizer.

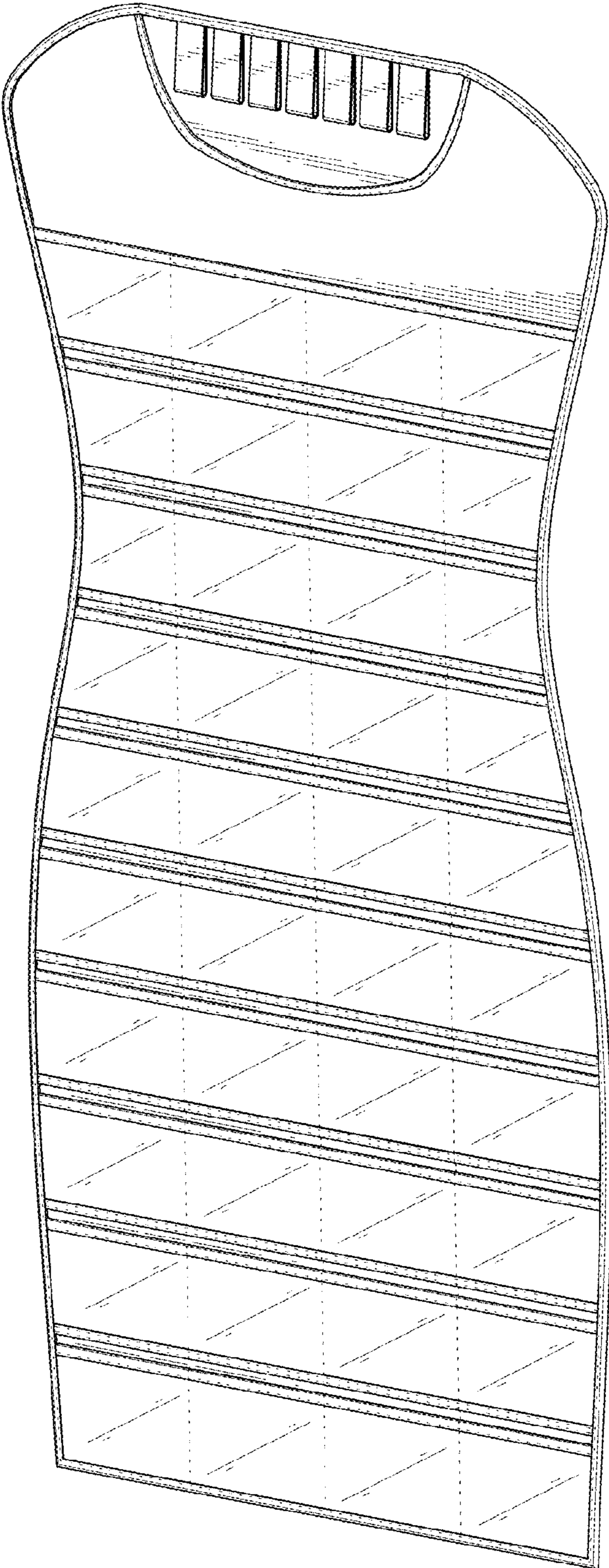

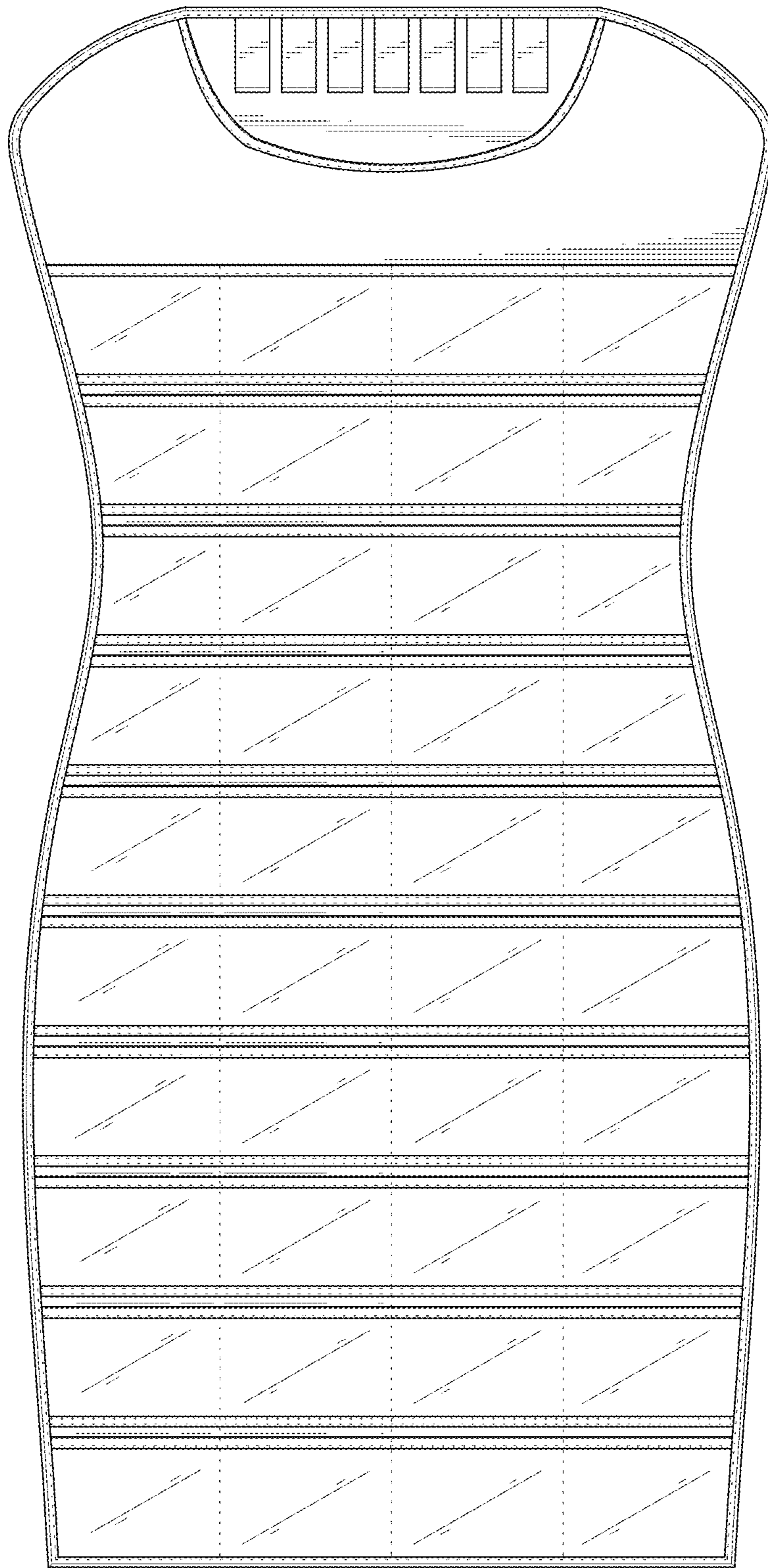

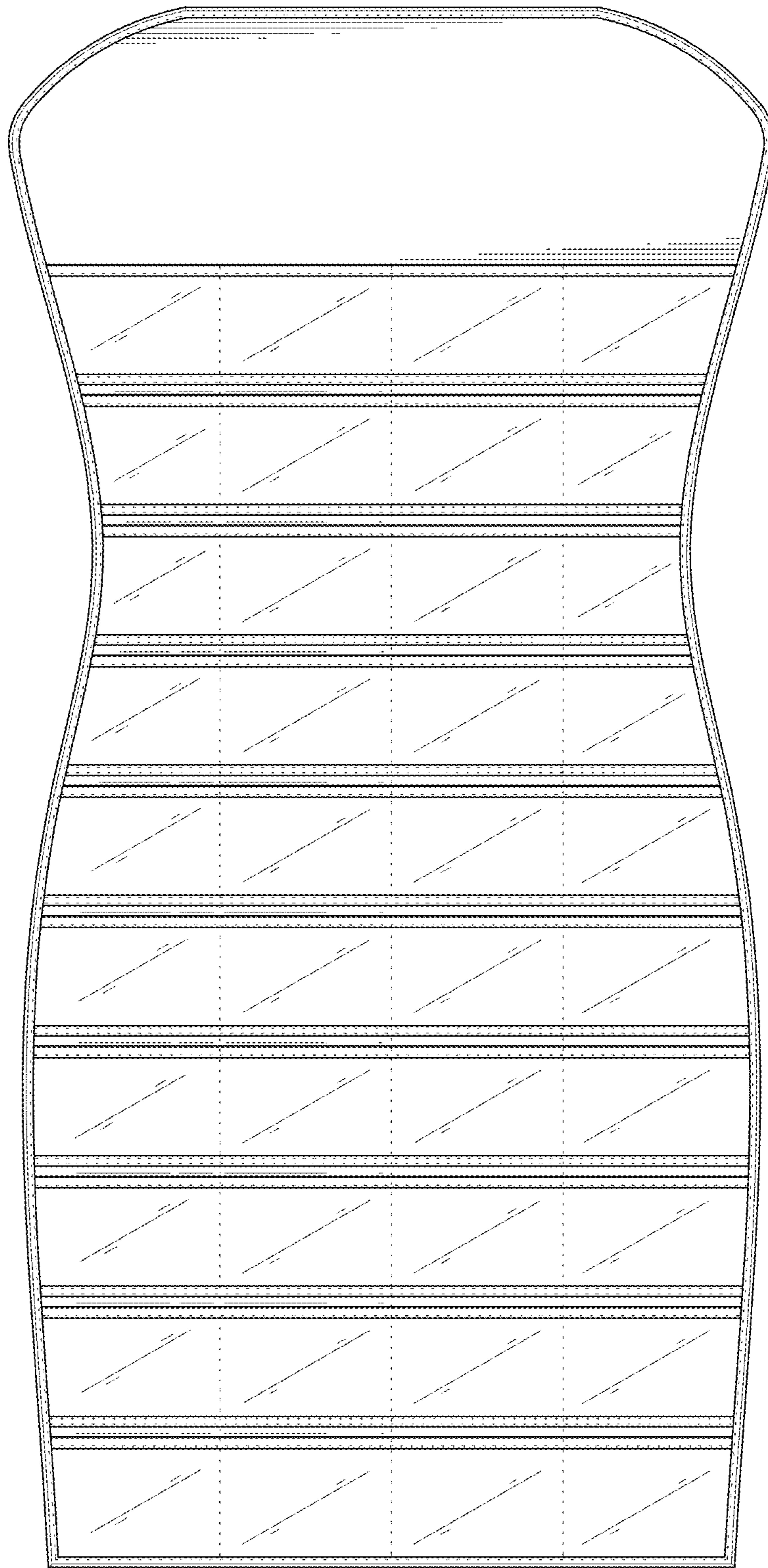

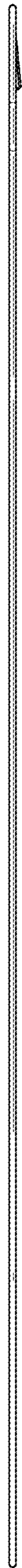

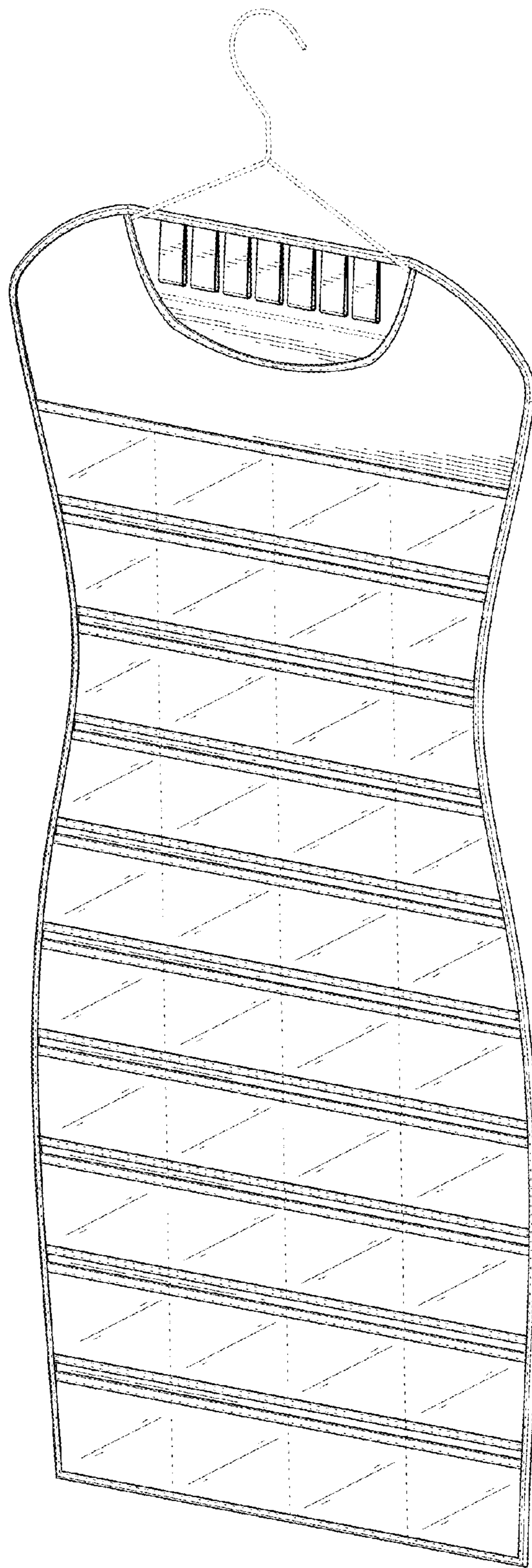
