(57) **CLAIM**

The ornamental design for a pet relief station, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the pet relief station showing the design with the front cover plate open and interior shelves deployed.

FIG. 2 is a front elevational view of the pet relief station shown in FIG. 1.

FIG. 3 is a rear elevational view of the pet relief station shown in FIG. 1.

FIG. 4 is a left side elevational view of the pet relief station shown in FIG. 1.

FIG. 5 is a right side elevational view of the pet relief station shown in FIG. 1.

FIG. 6 is a top plan view of the pet relief station shown in FIG. 1.

FIG. 7 is bottom plan view of the pet relief station shown in FIG. 1.

FIG. 8 is a perspective view of another embodiment of the pet relief station showing the design with the front cover plate open and interior shelves folded.

FIG. 17 is a rear elevational view of the pet relief station shown in FIG. 15.

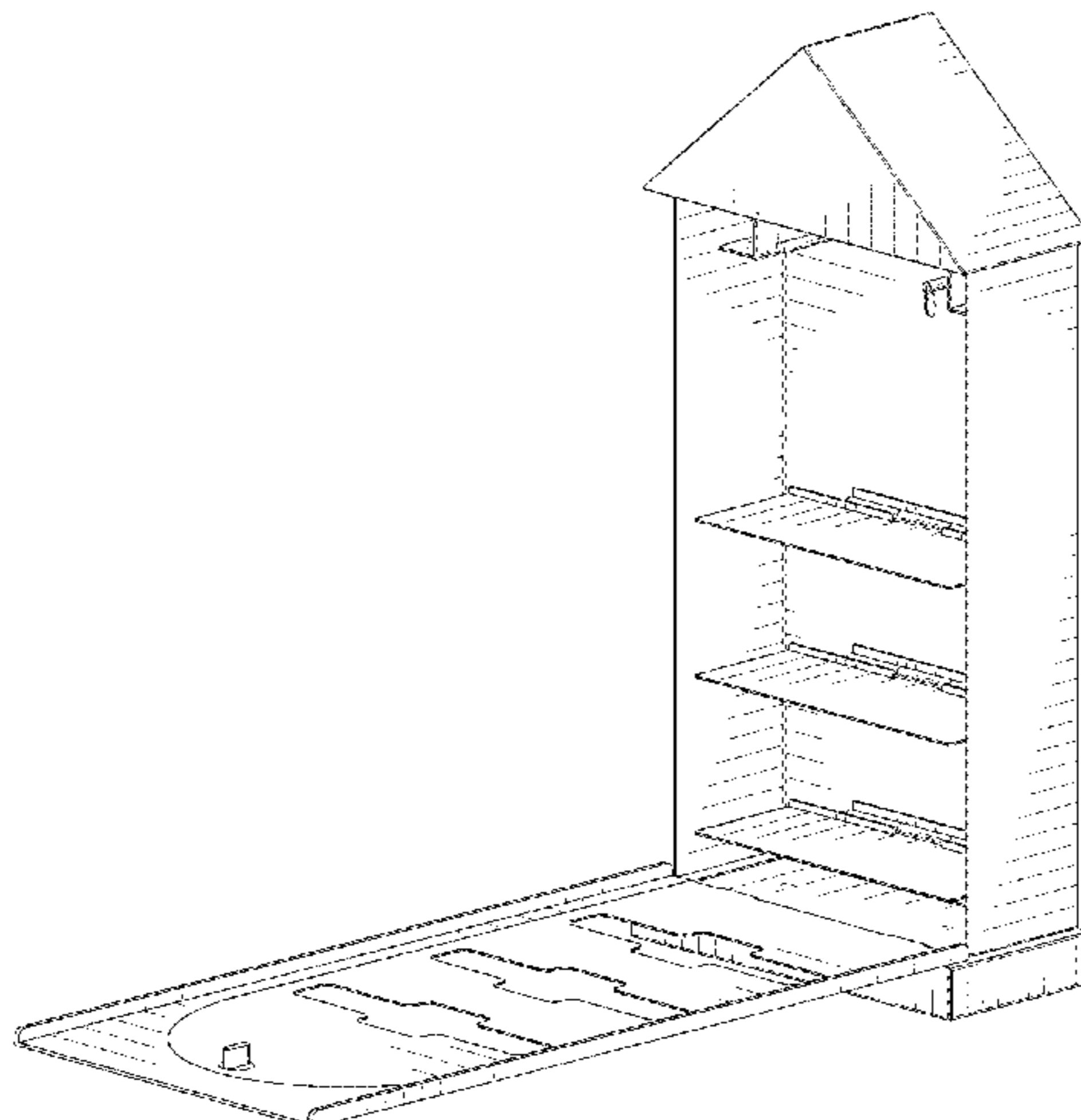
FIG. 18 is a left side elevational view of the pet relief station shown in FIG. 15.

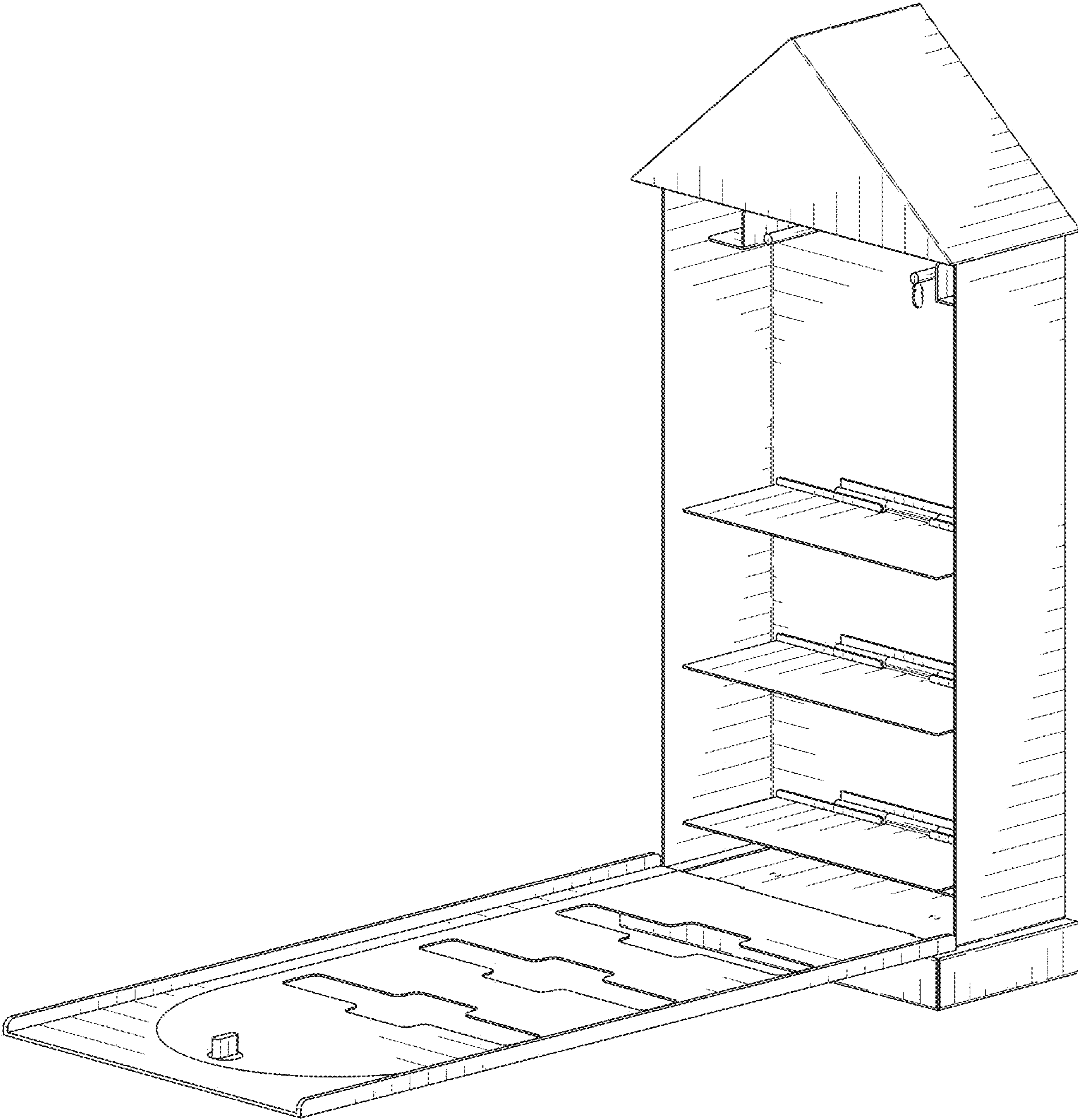

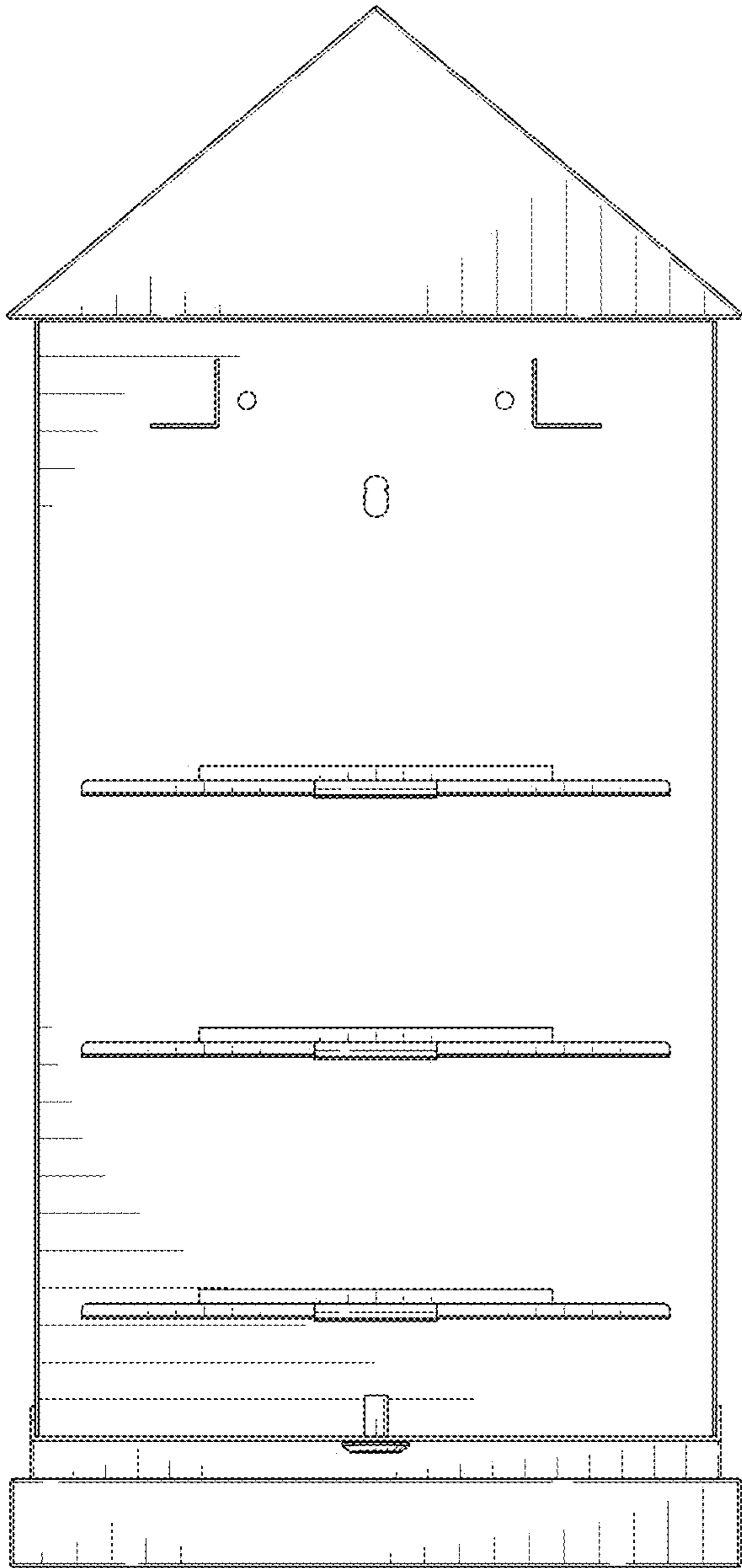

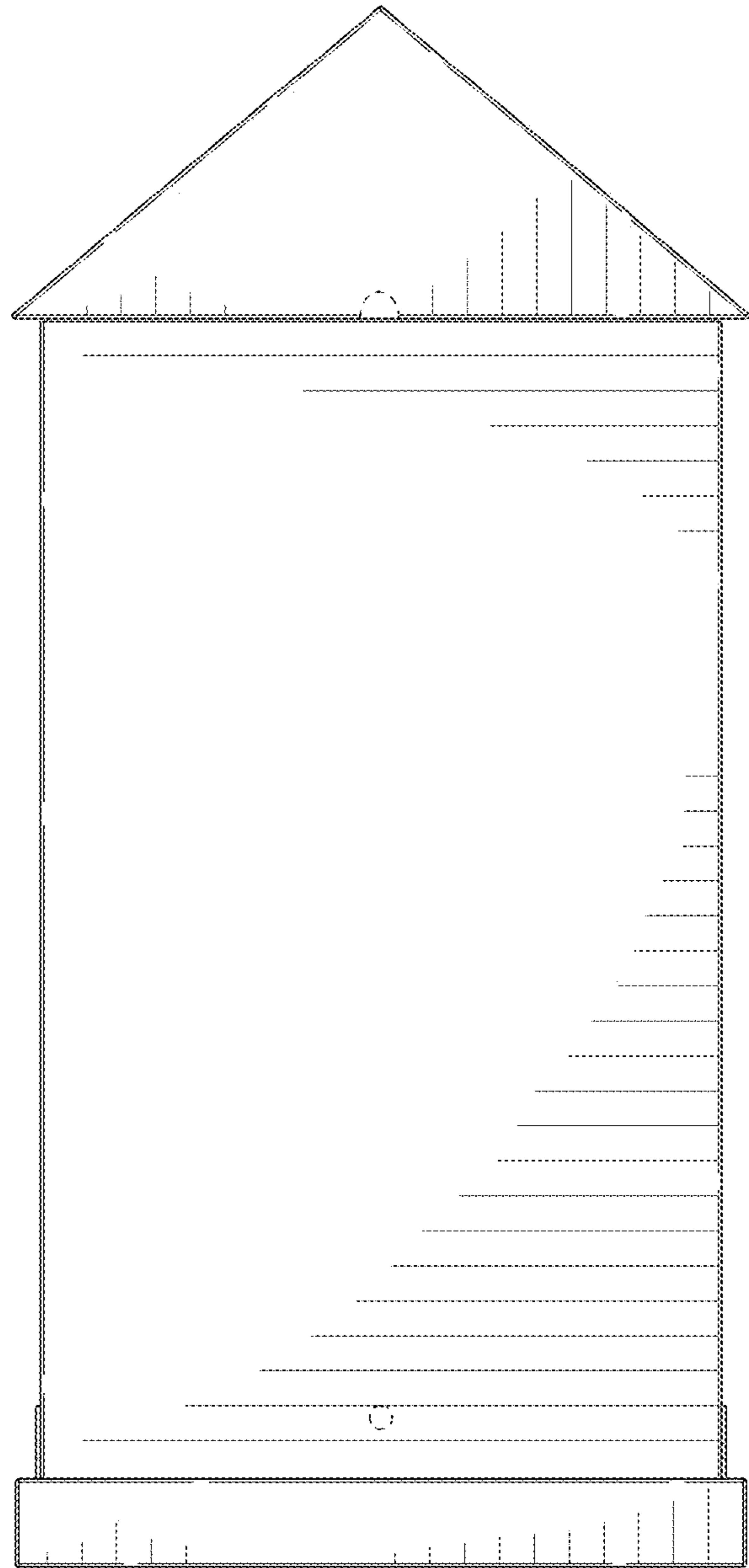

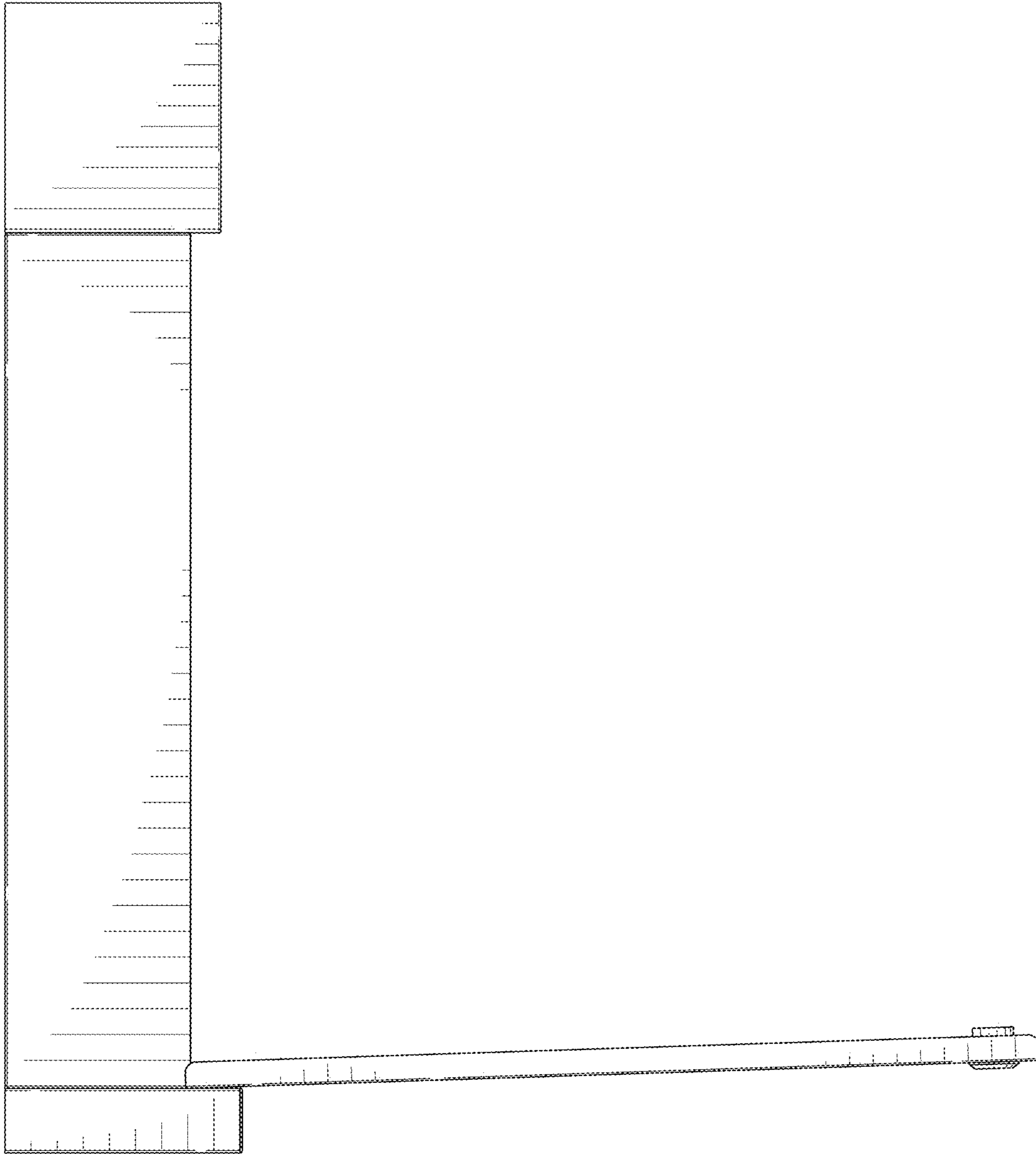

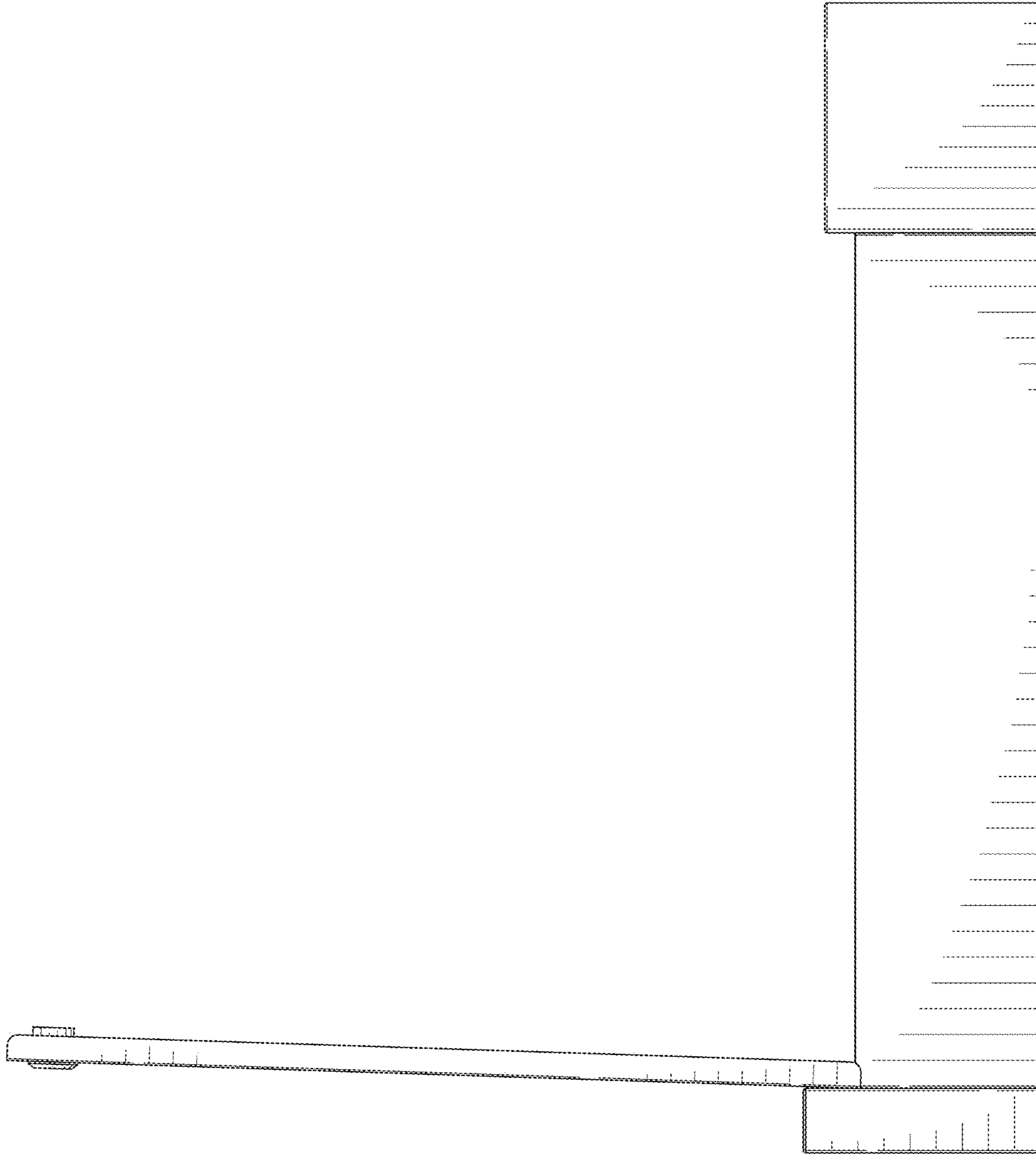

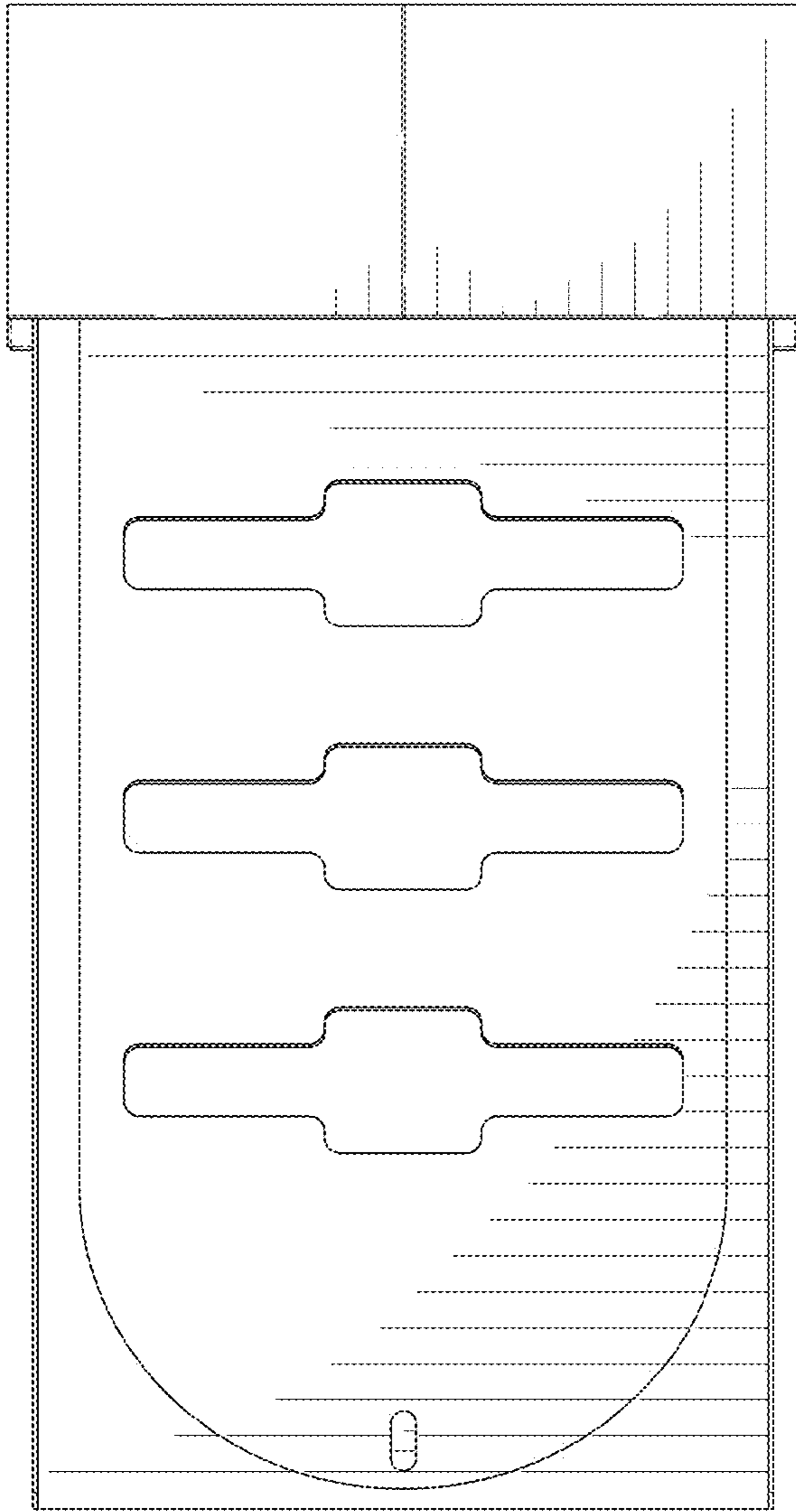

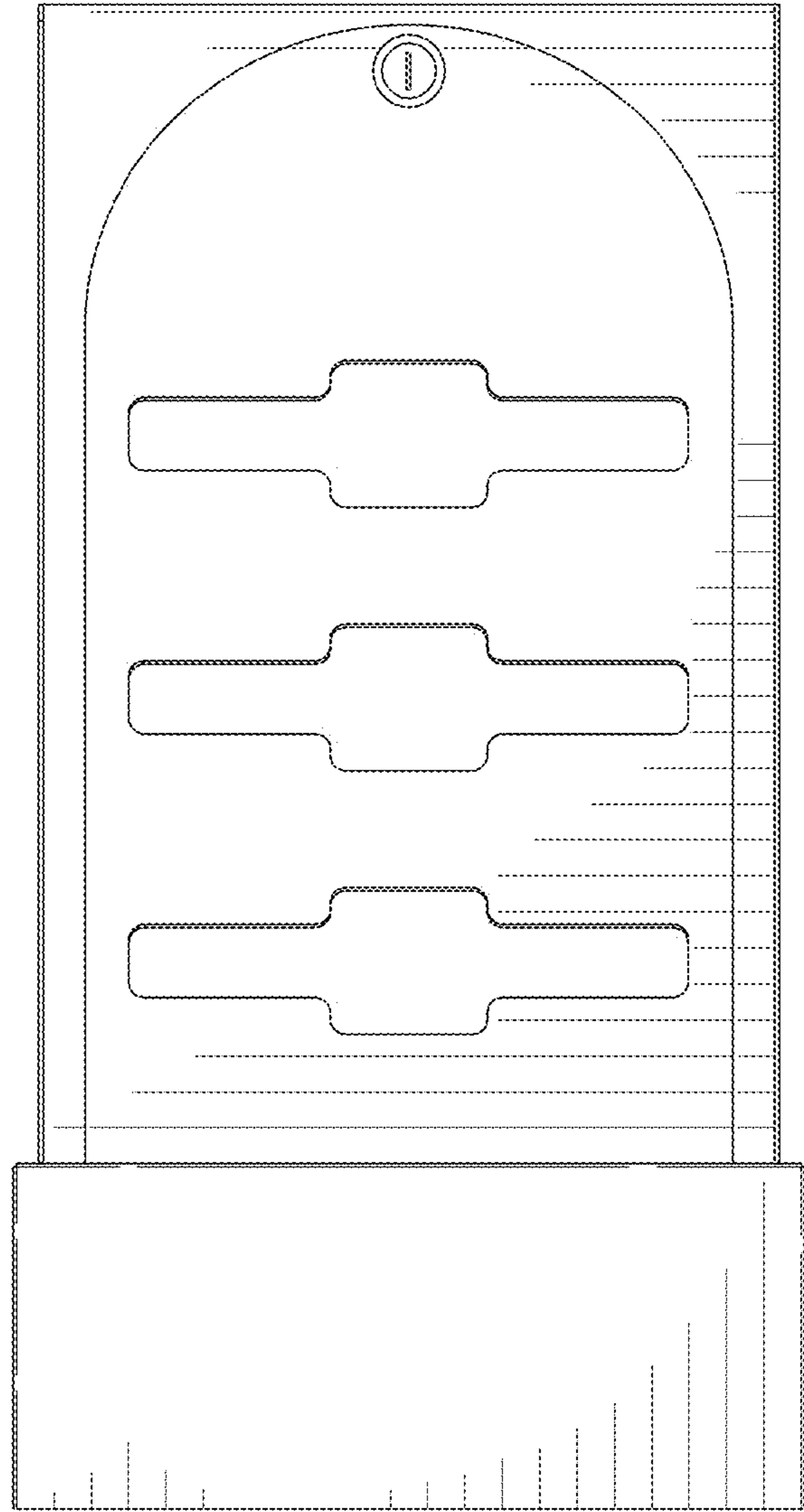

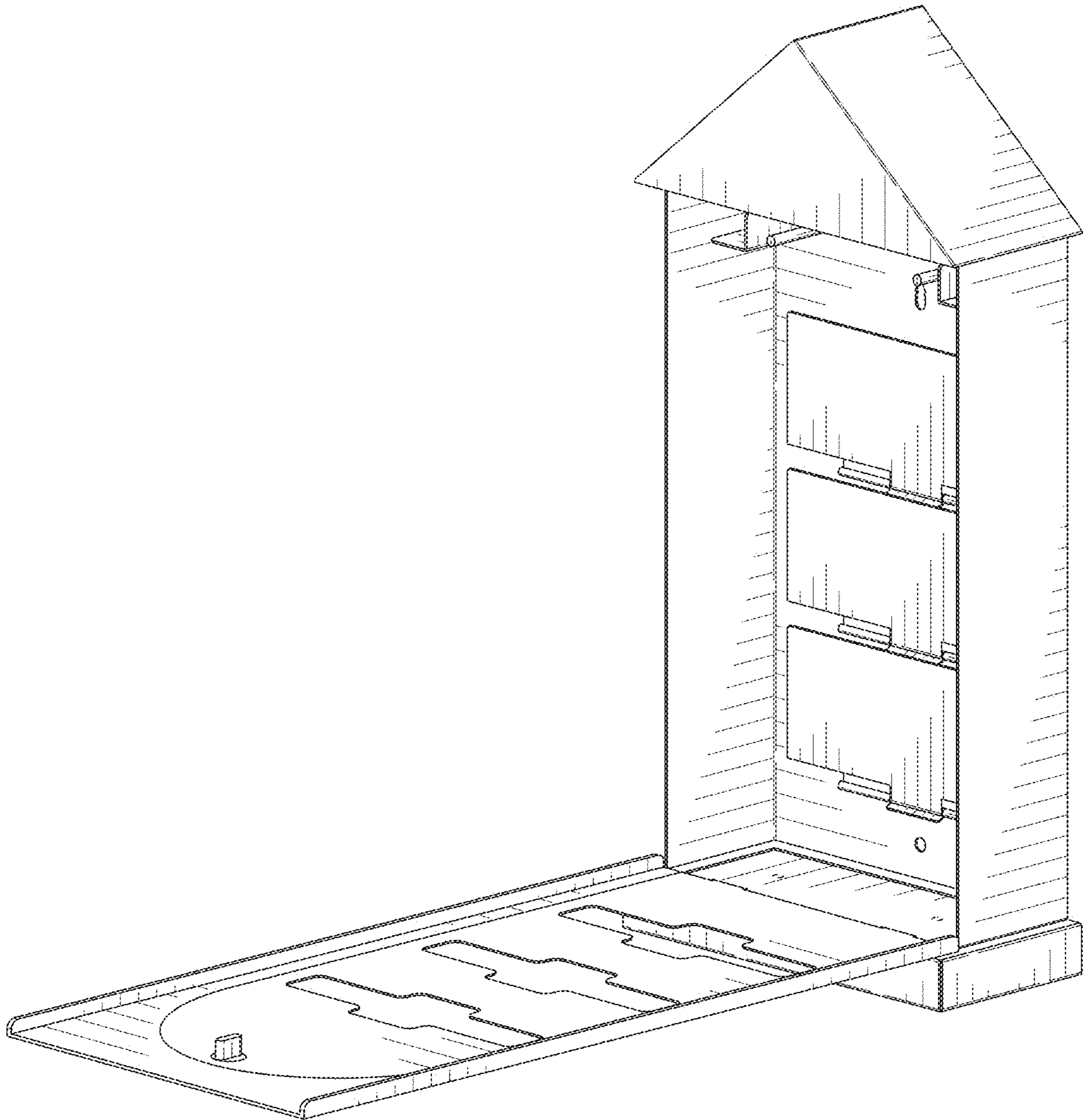

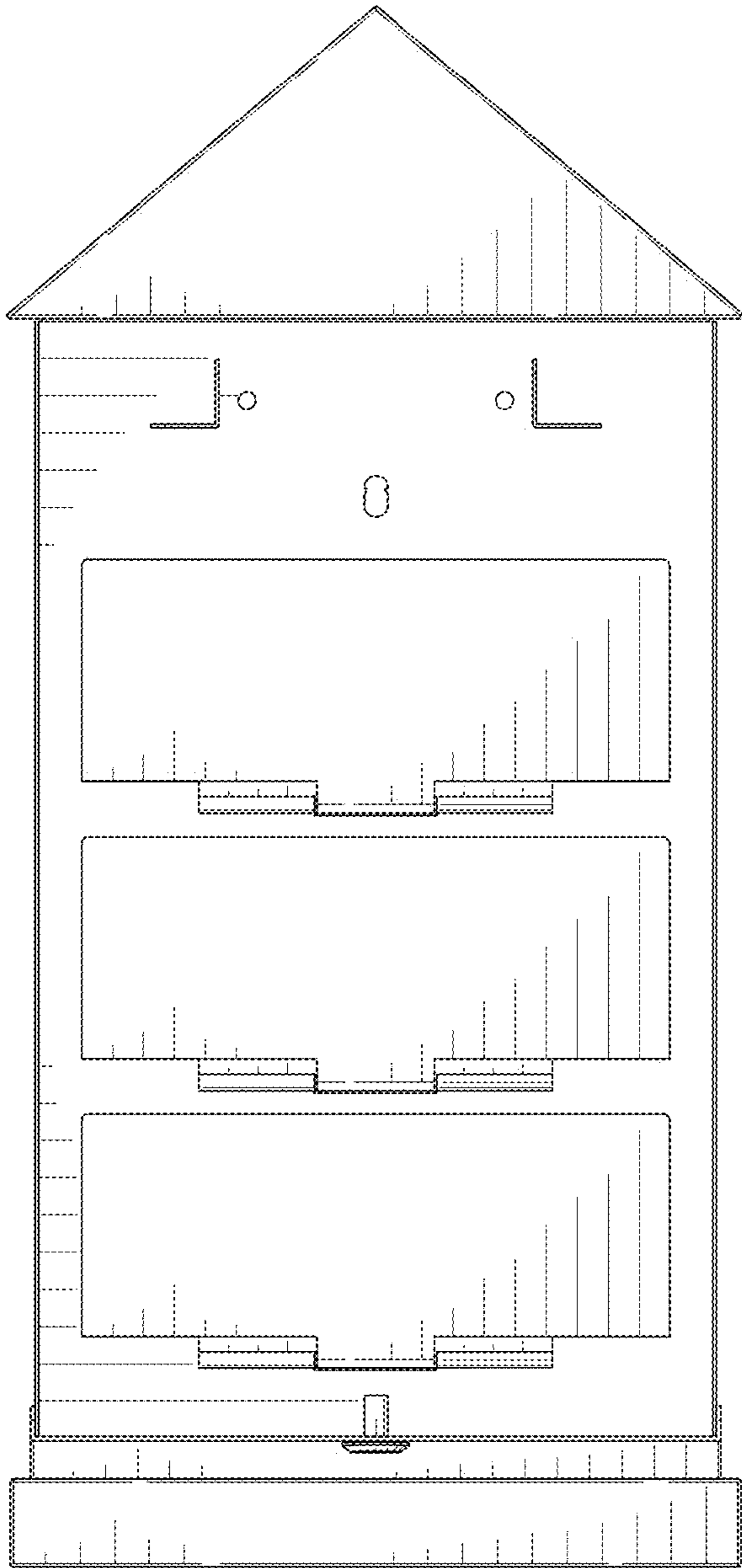

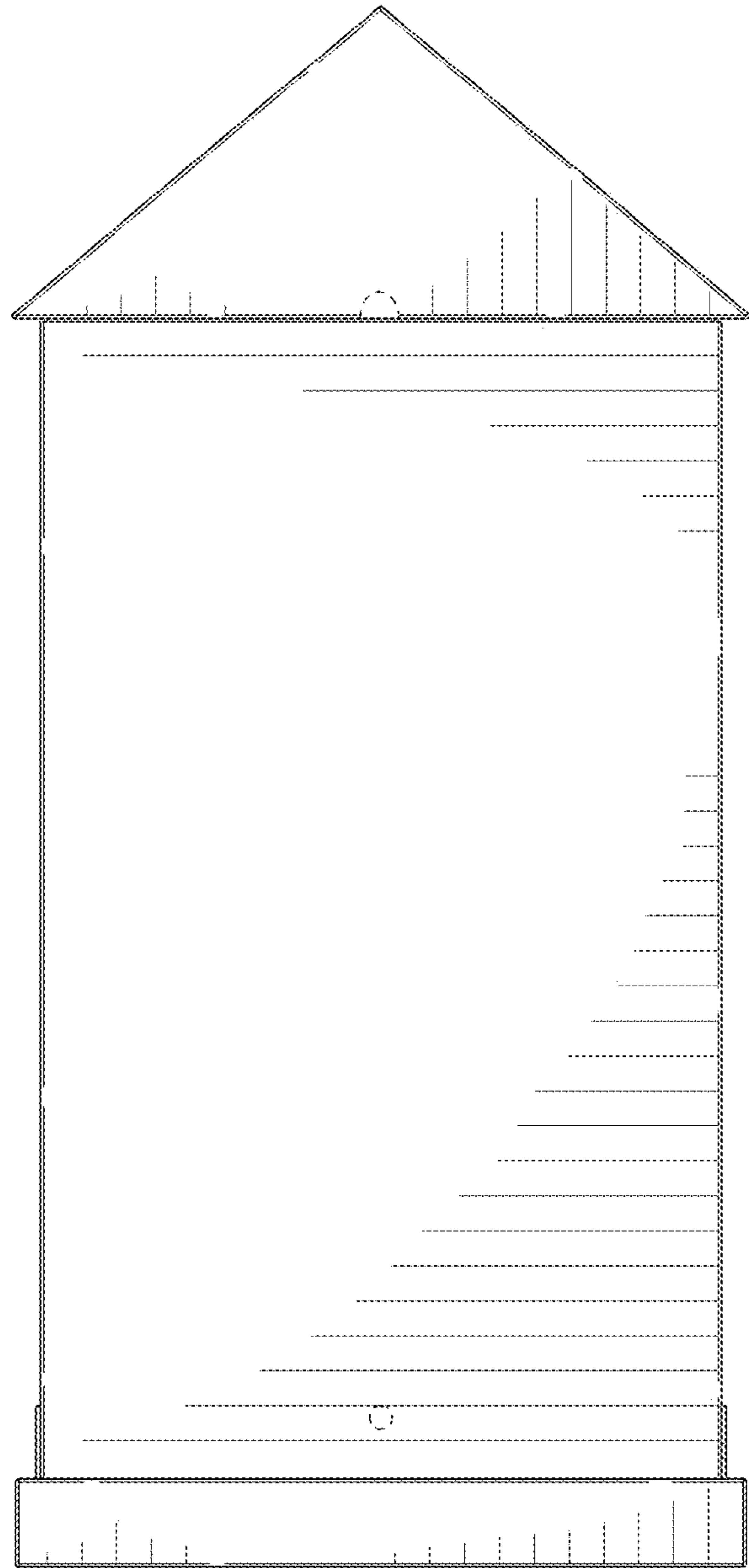

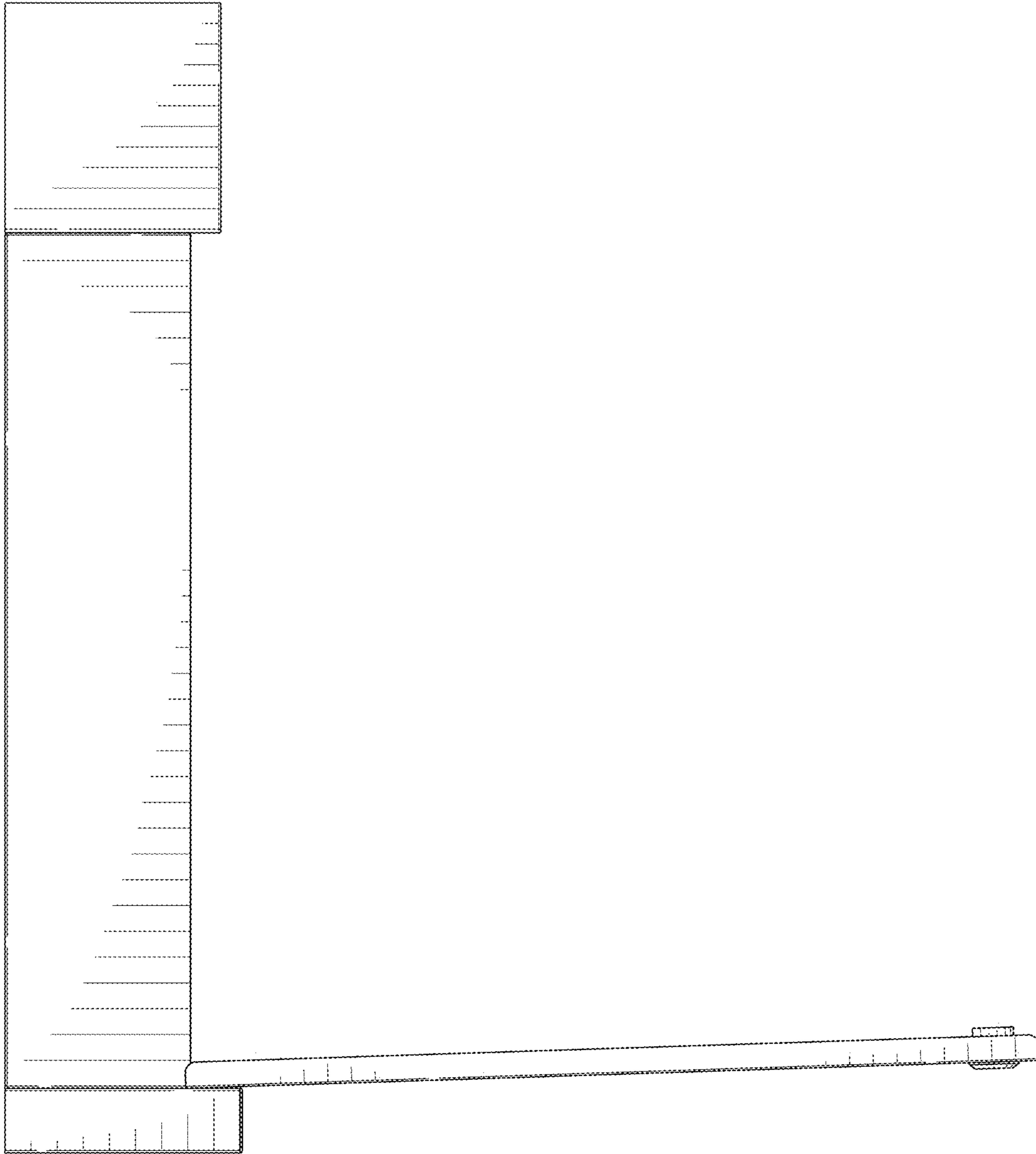

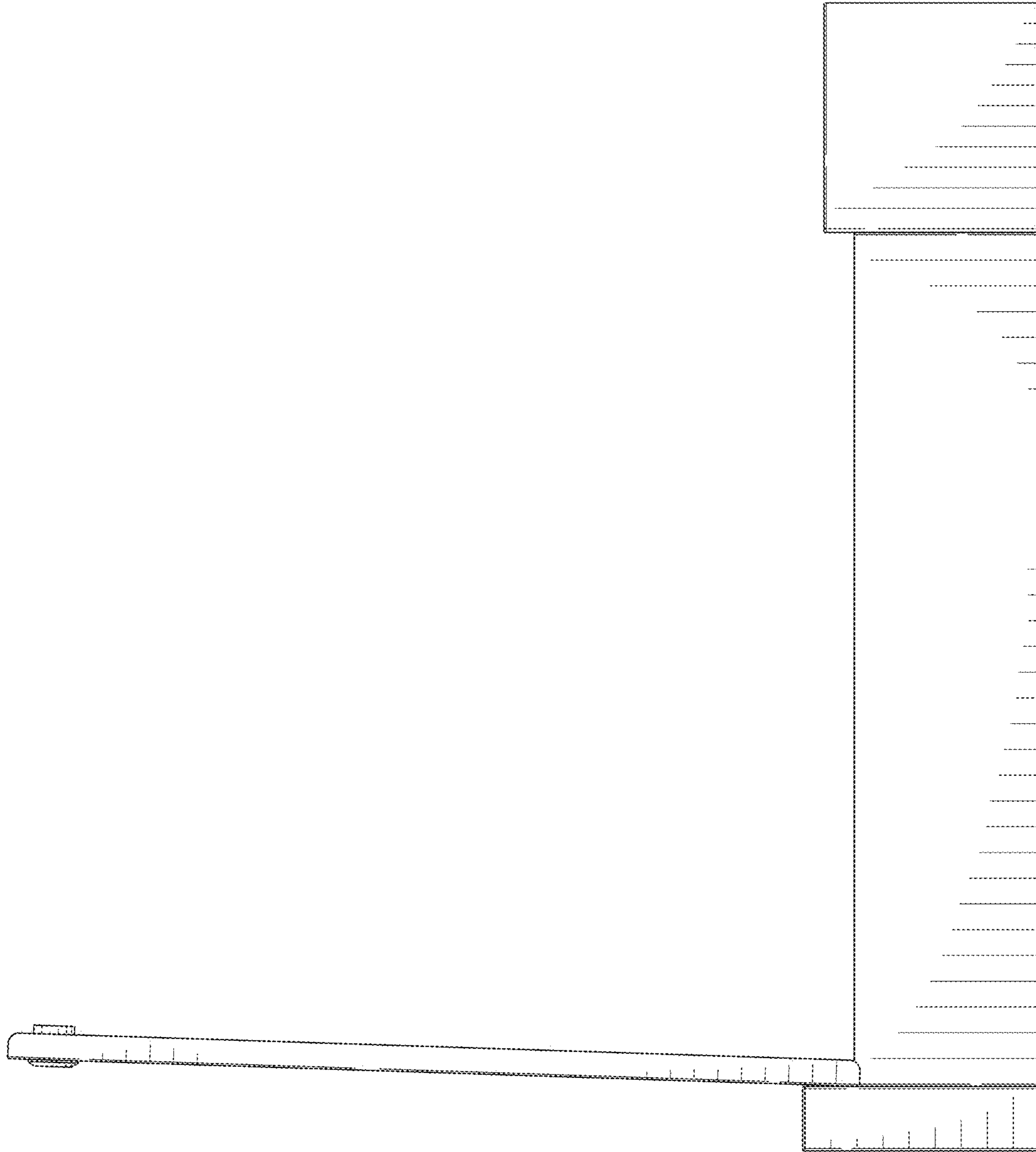

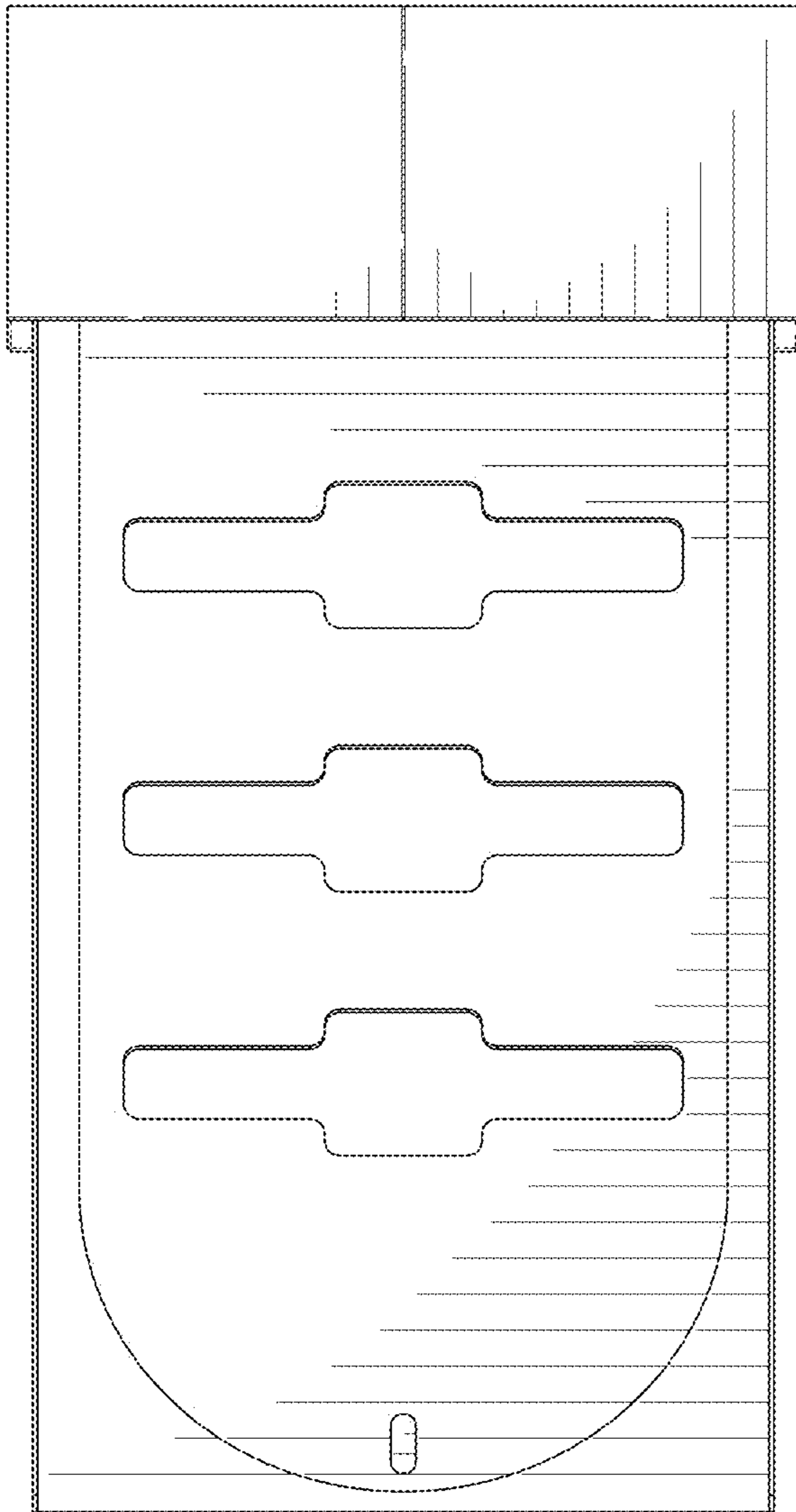

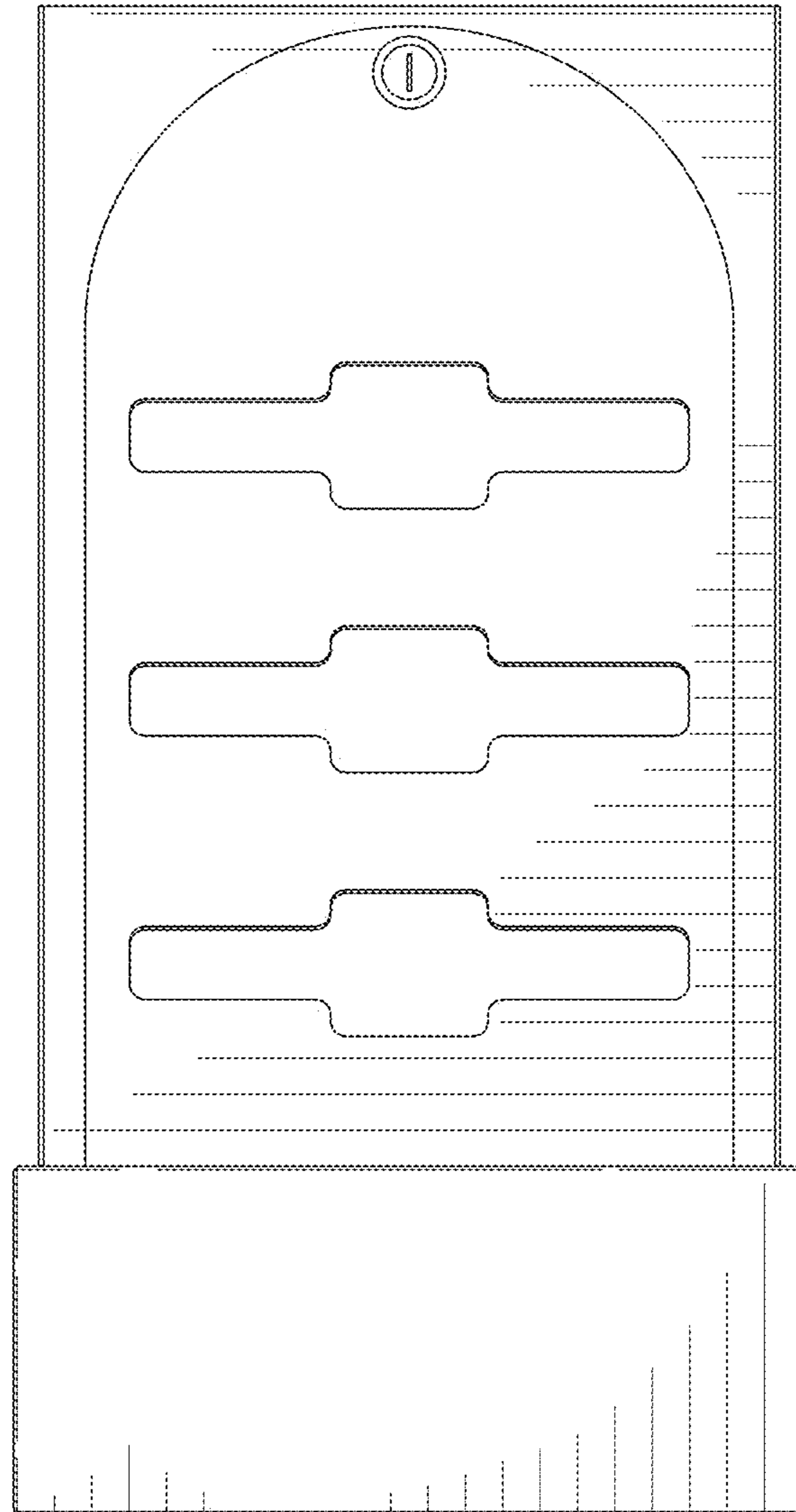

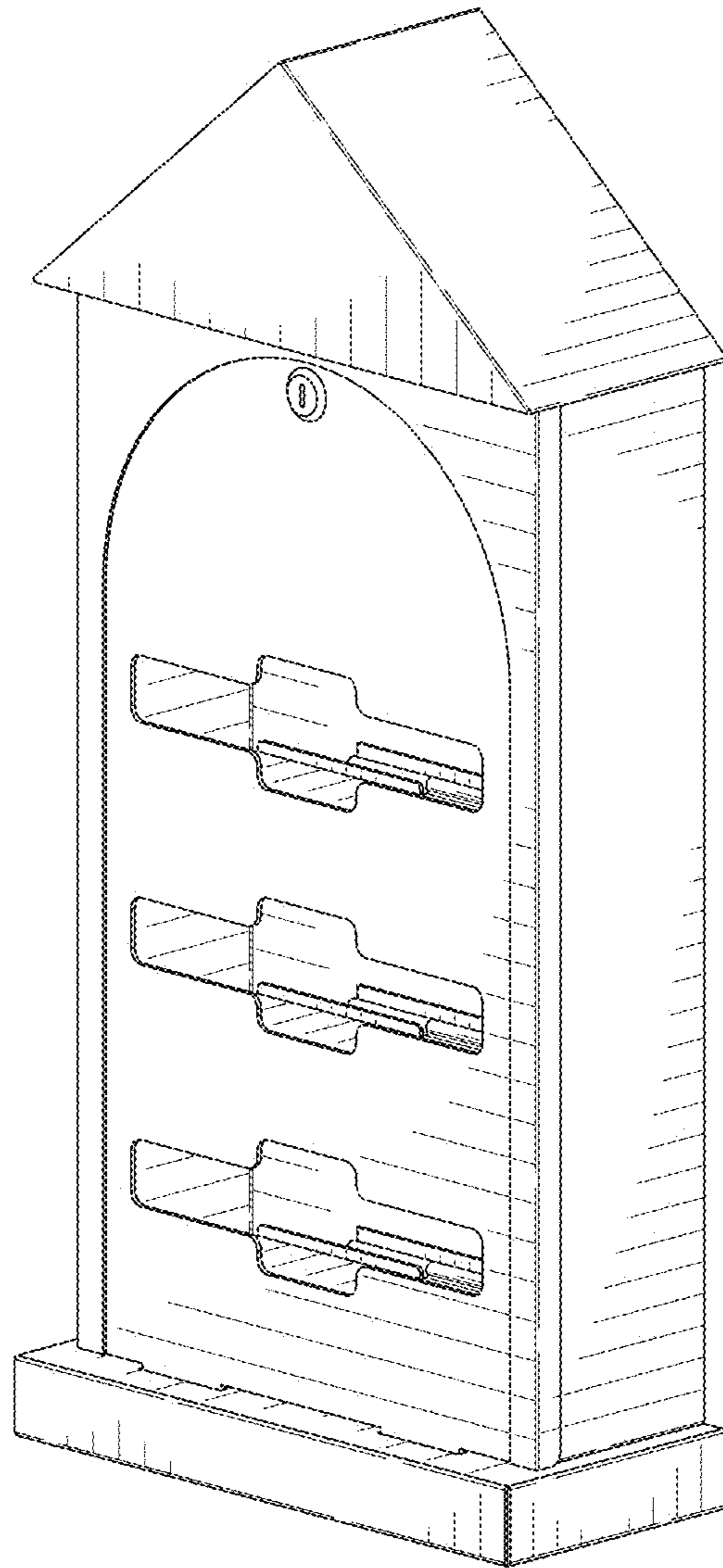

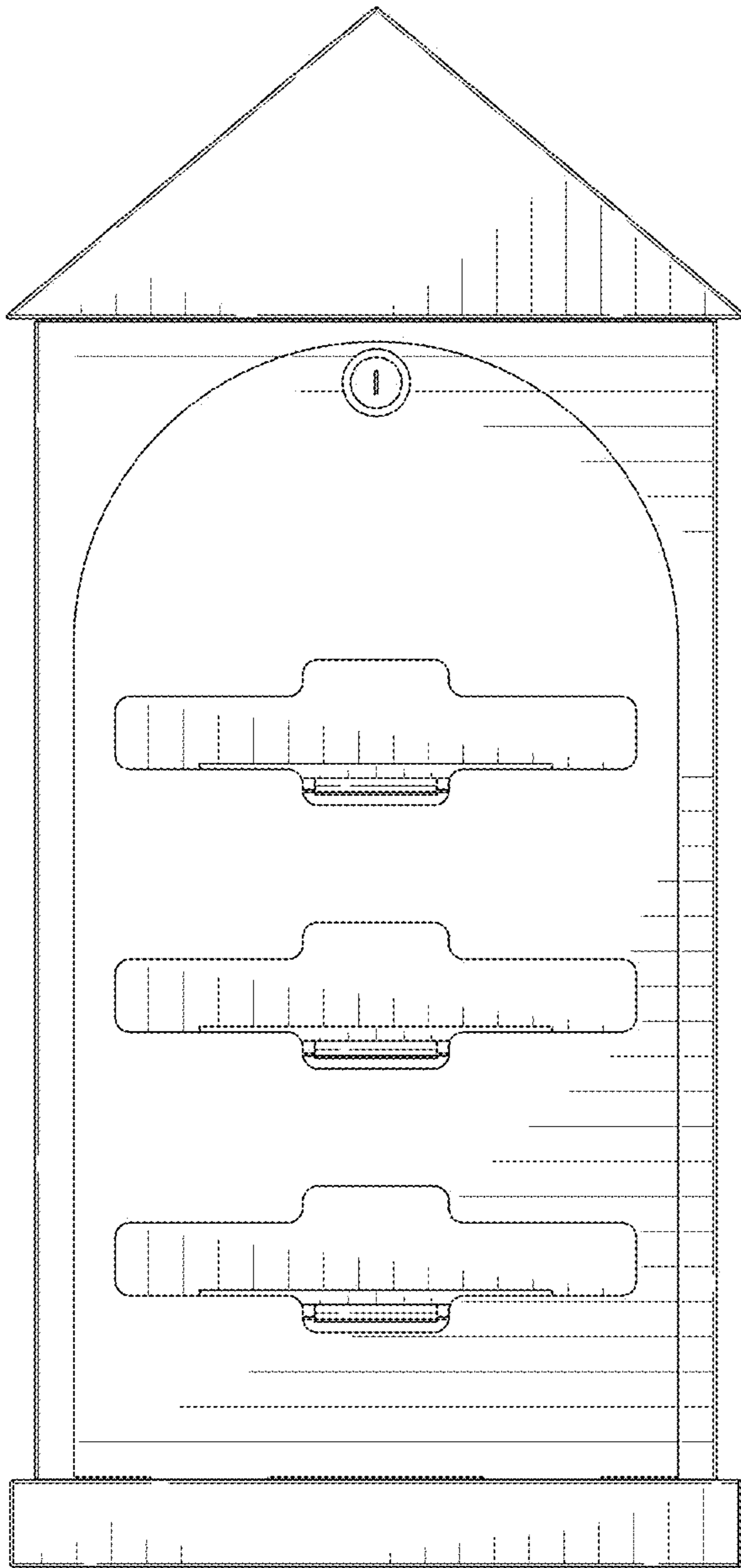

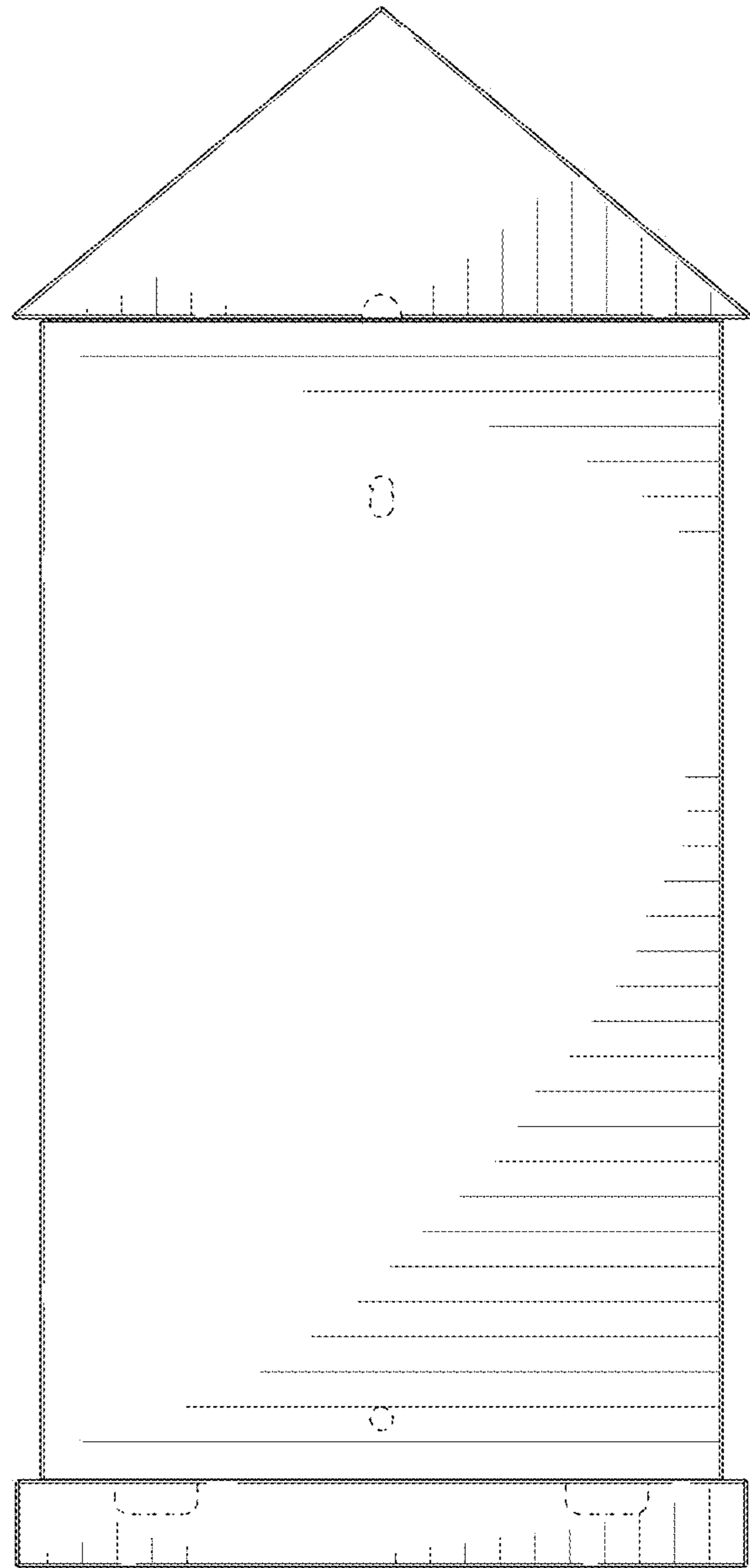

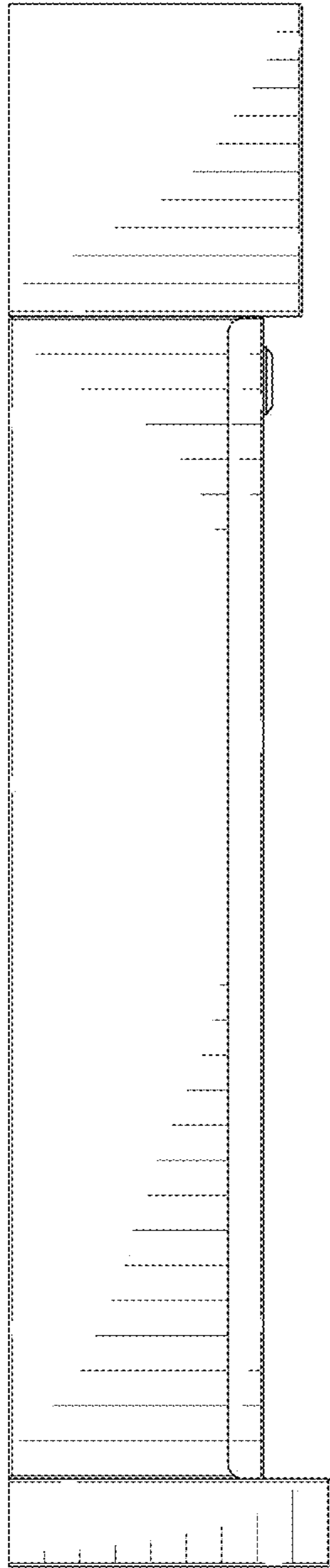

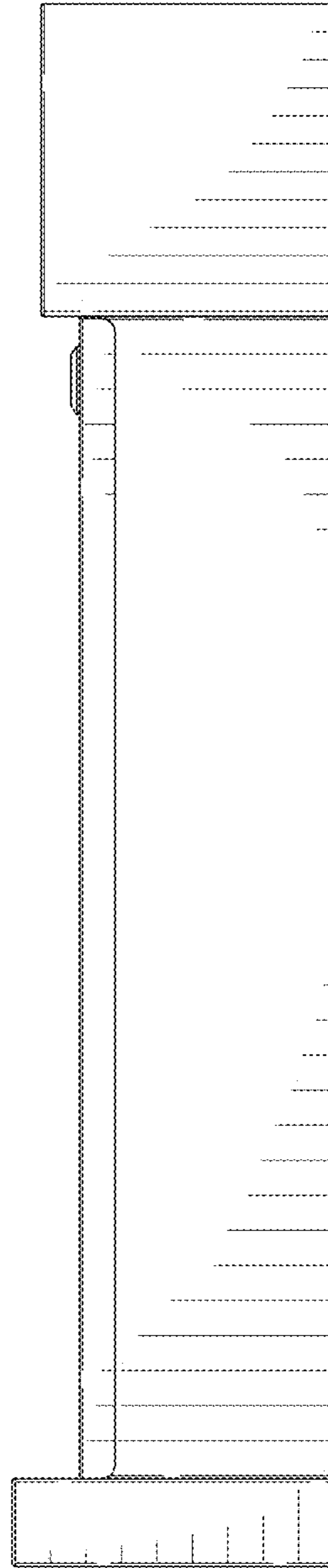

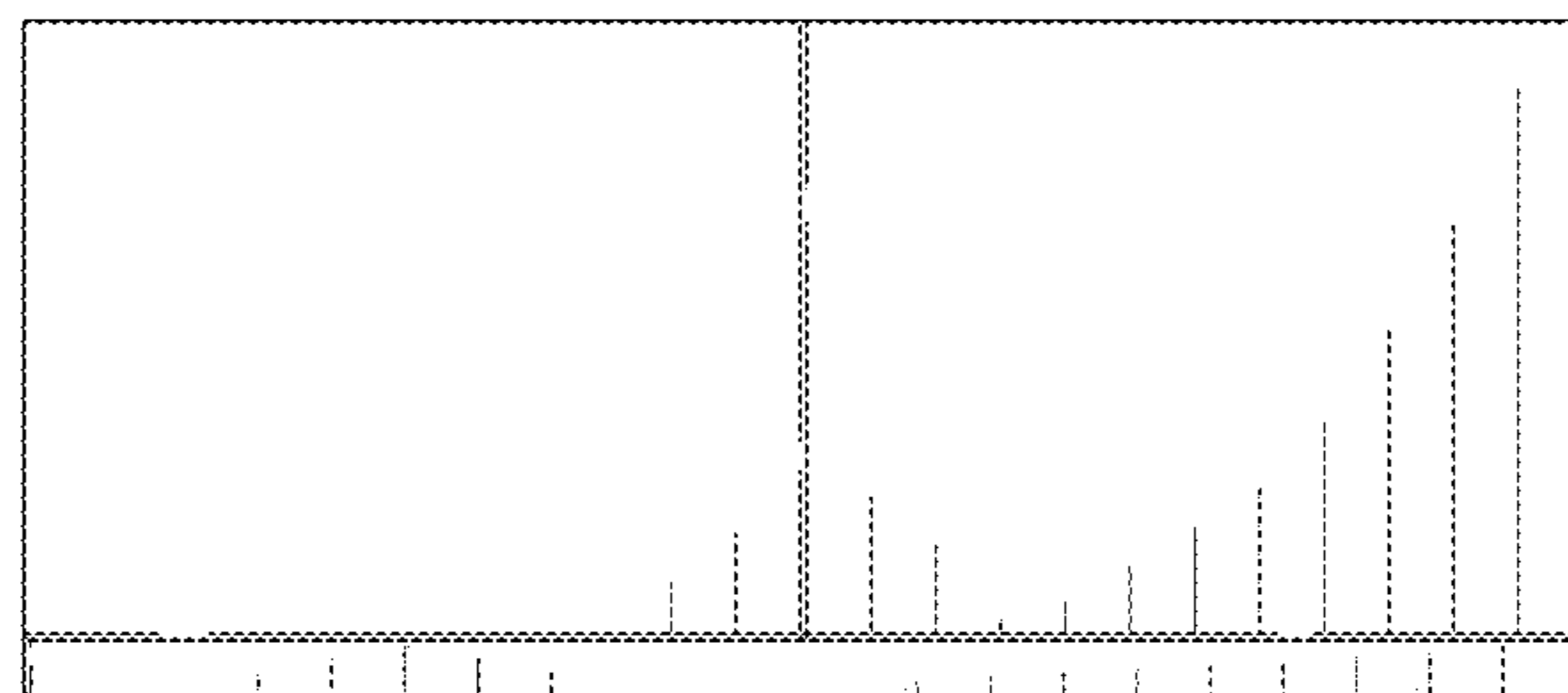
