FIG. 6 is a left-side elevation view thereof; and,

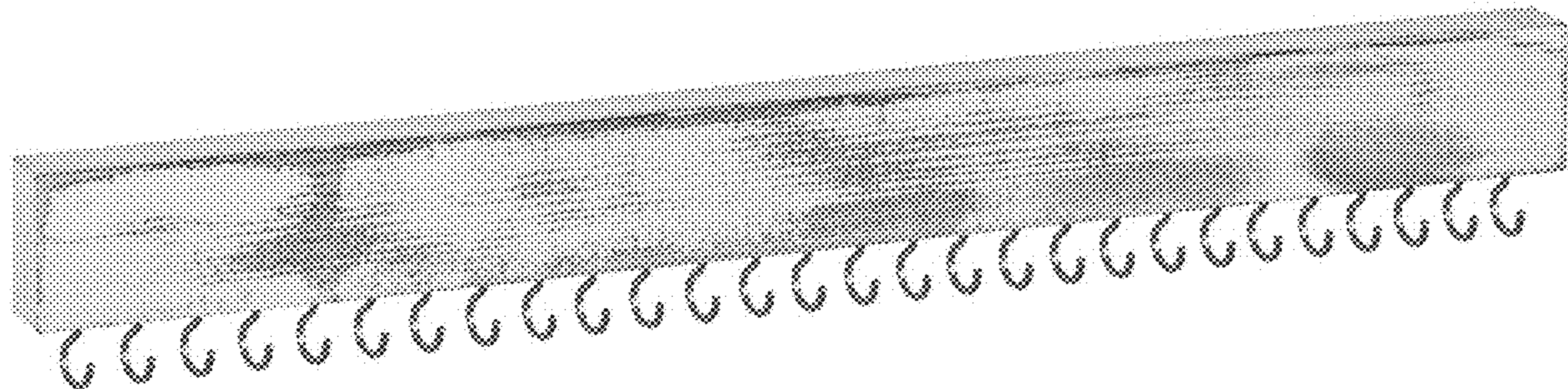
FIG. 7 is a right-side elevation view thereof.

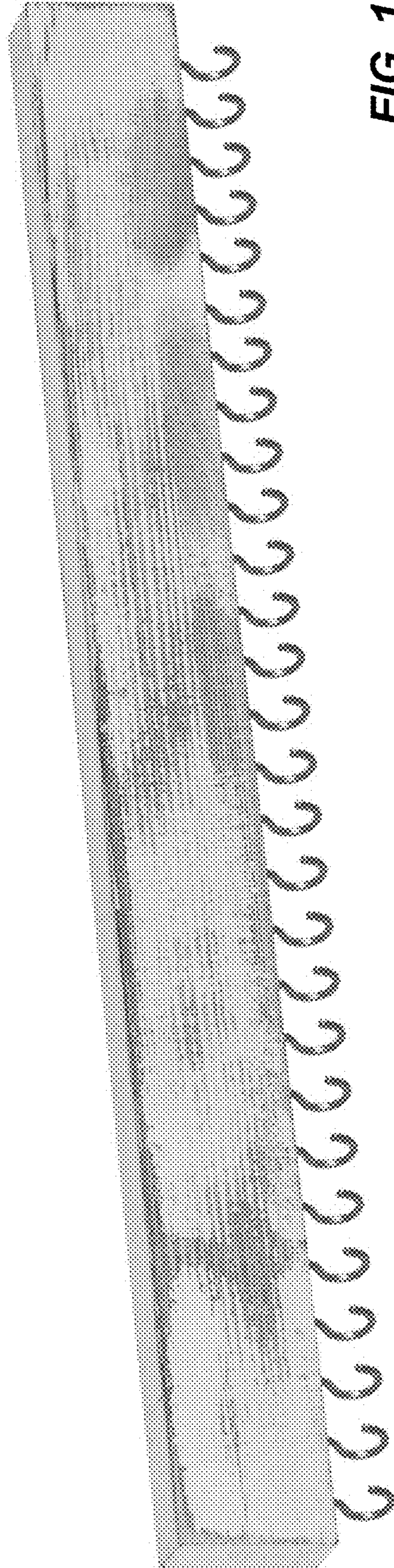

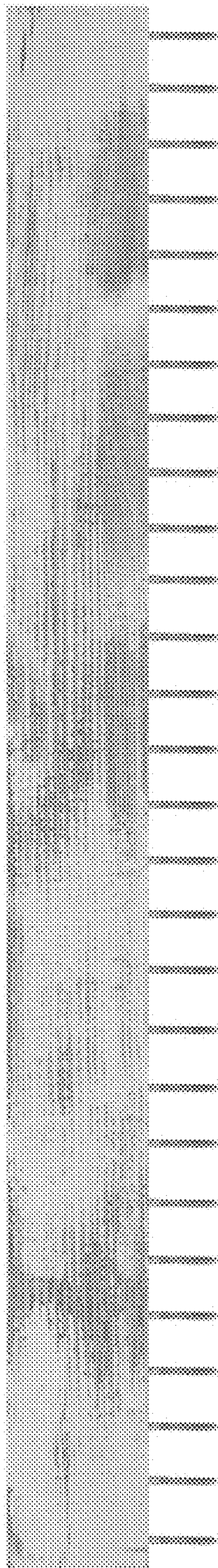

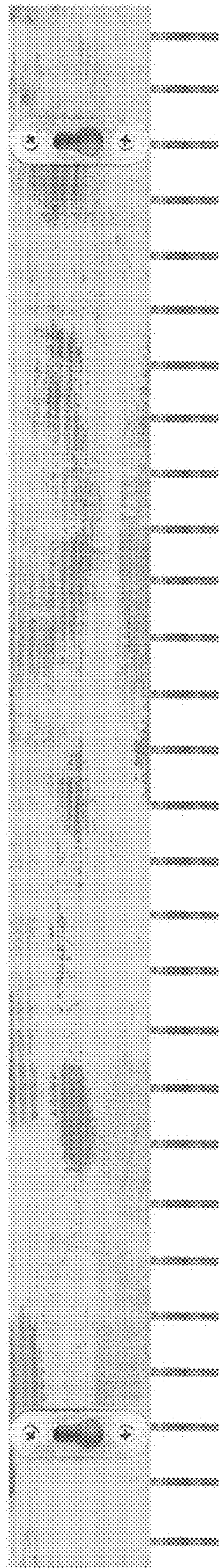

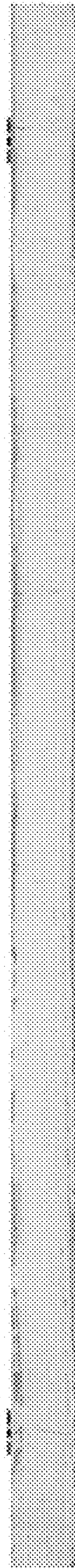

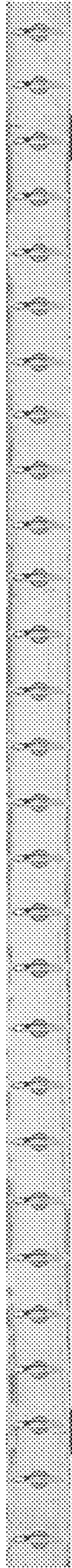

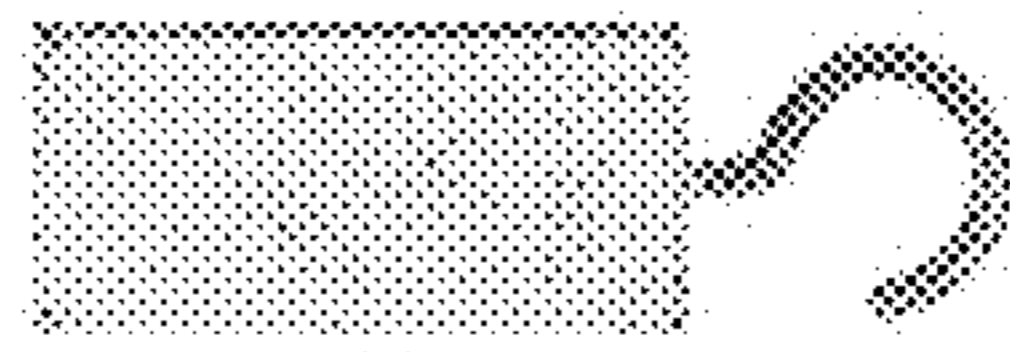
