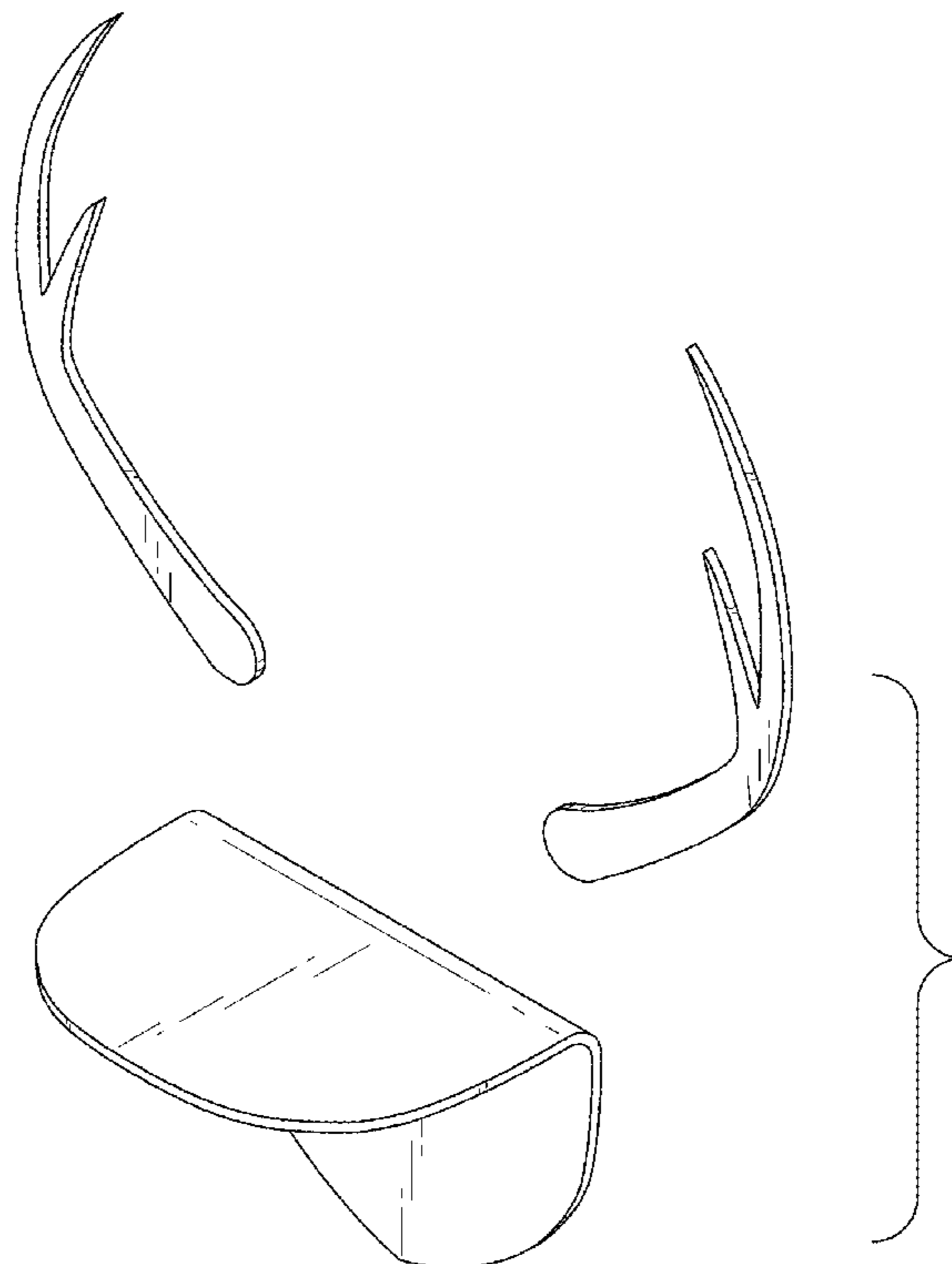
The ornamental design for a shelf, as shown and described.

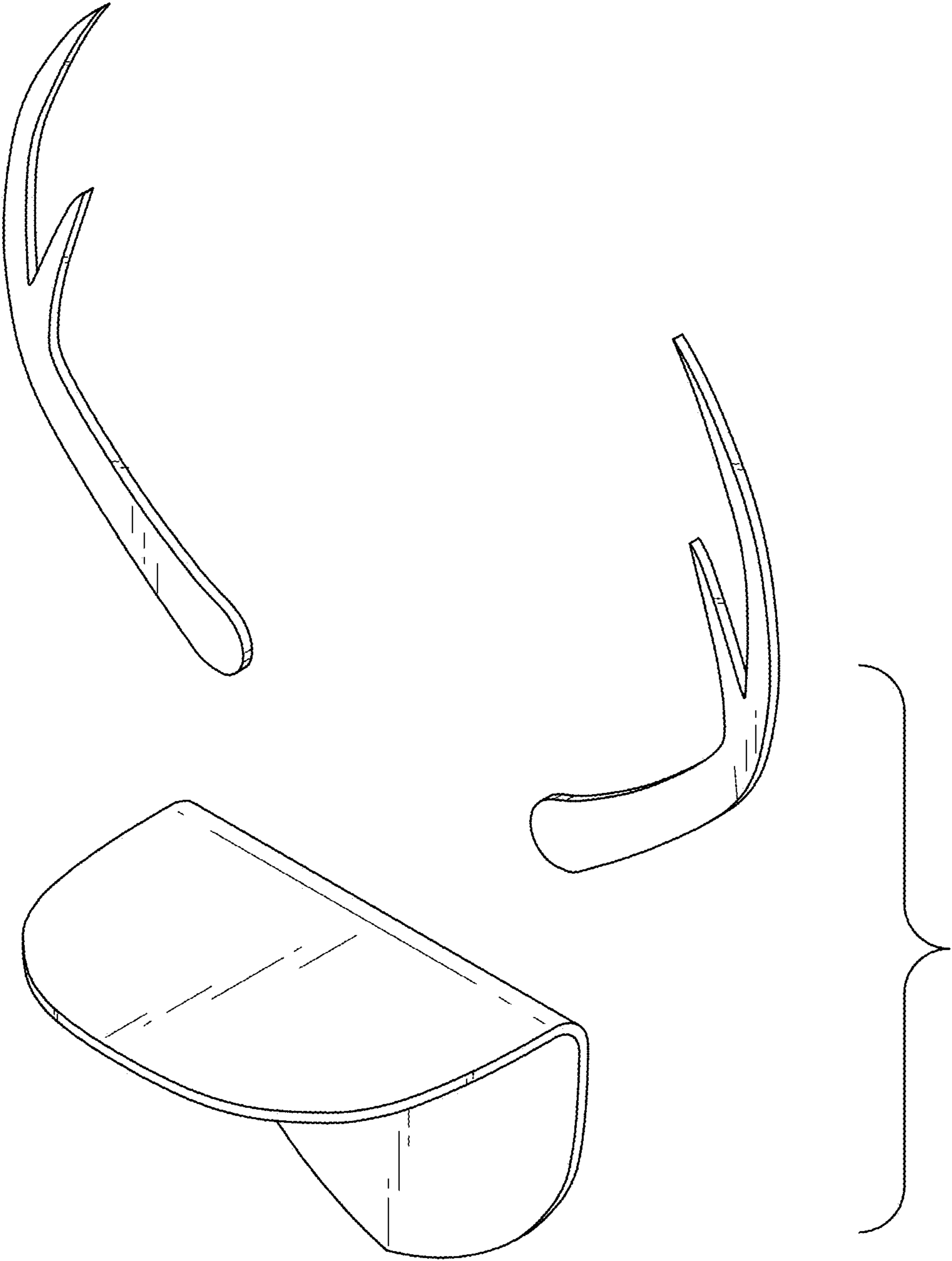

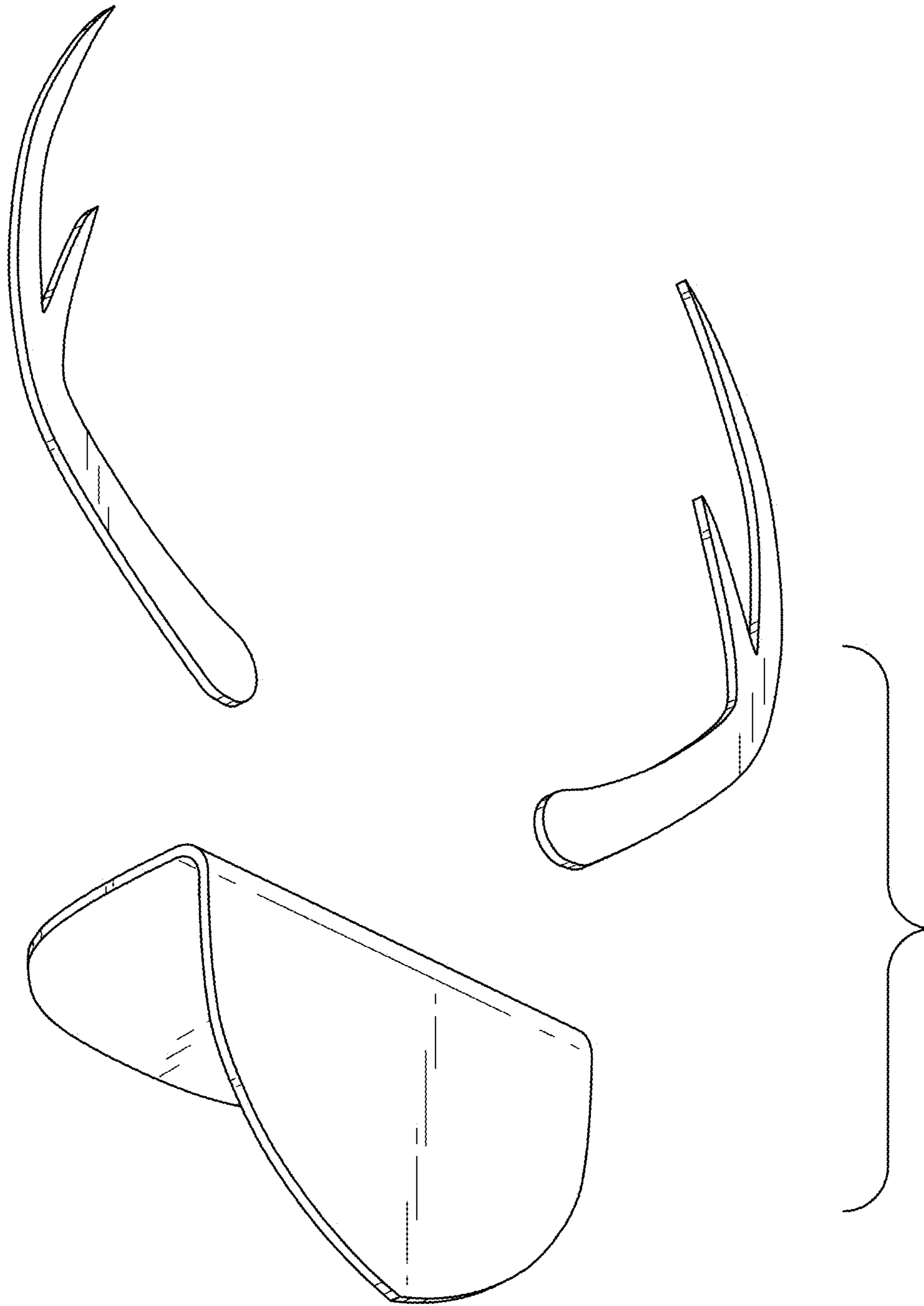

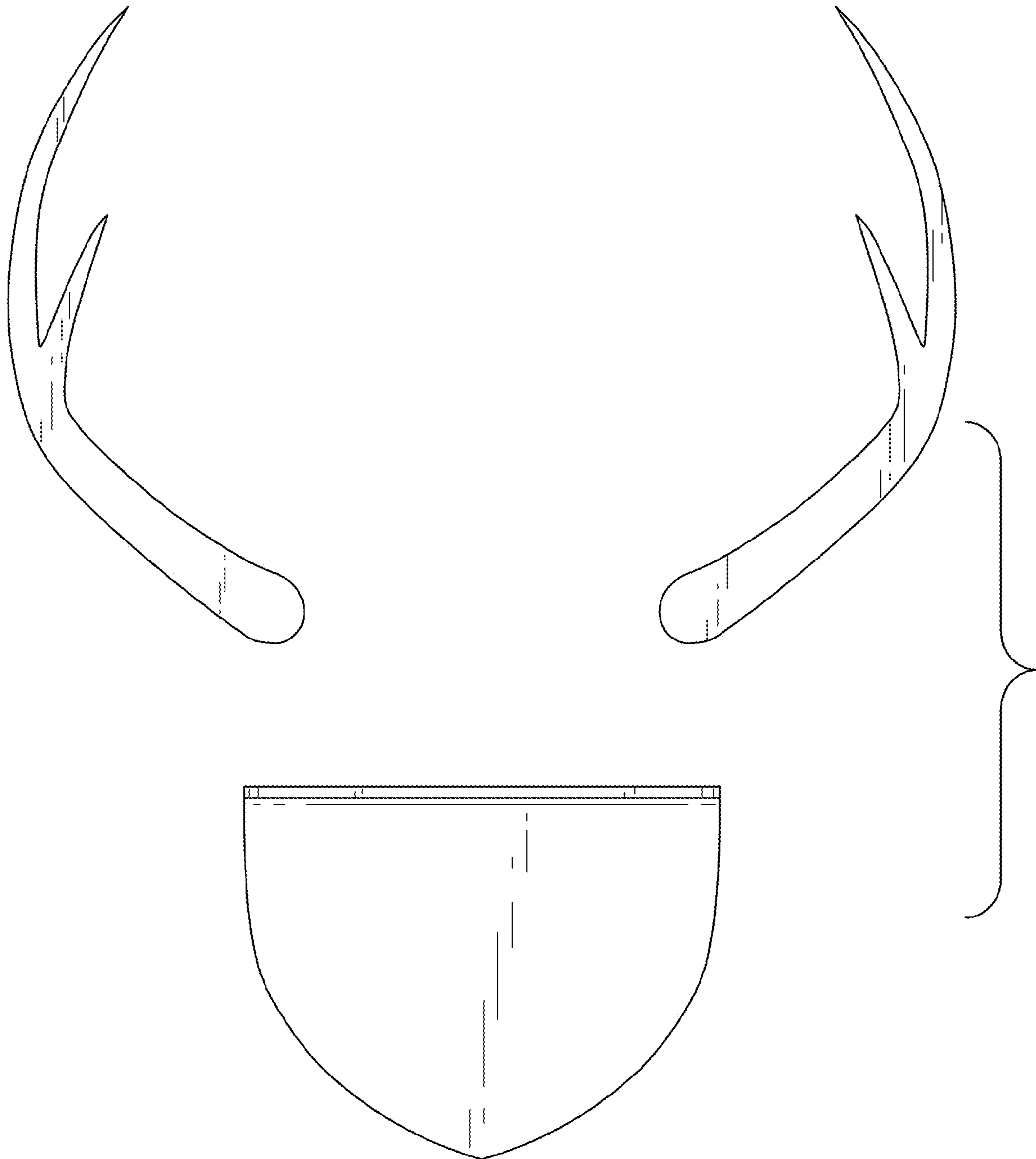

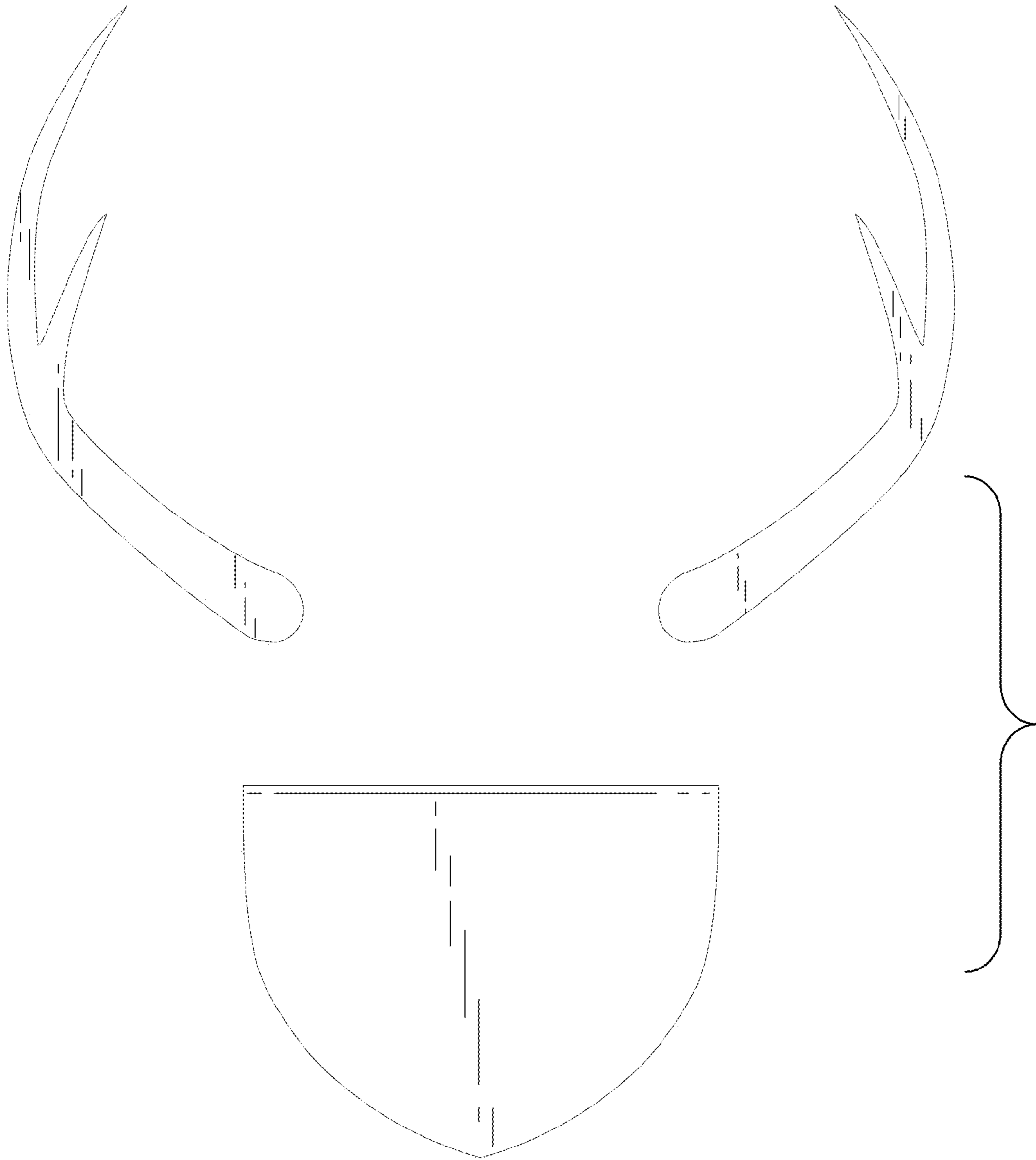

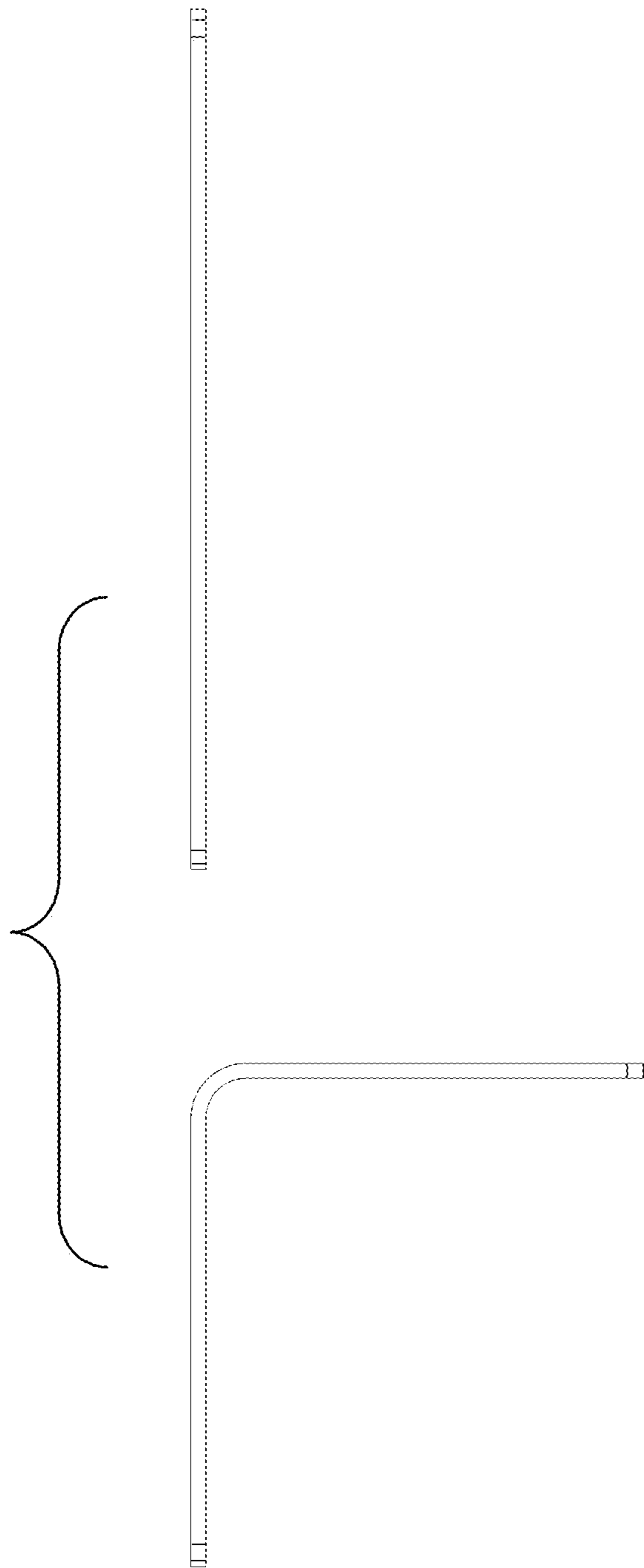

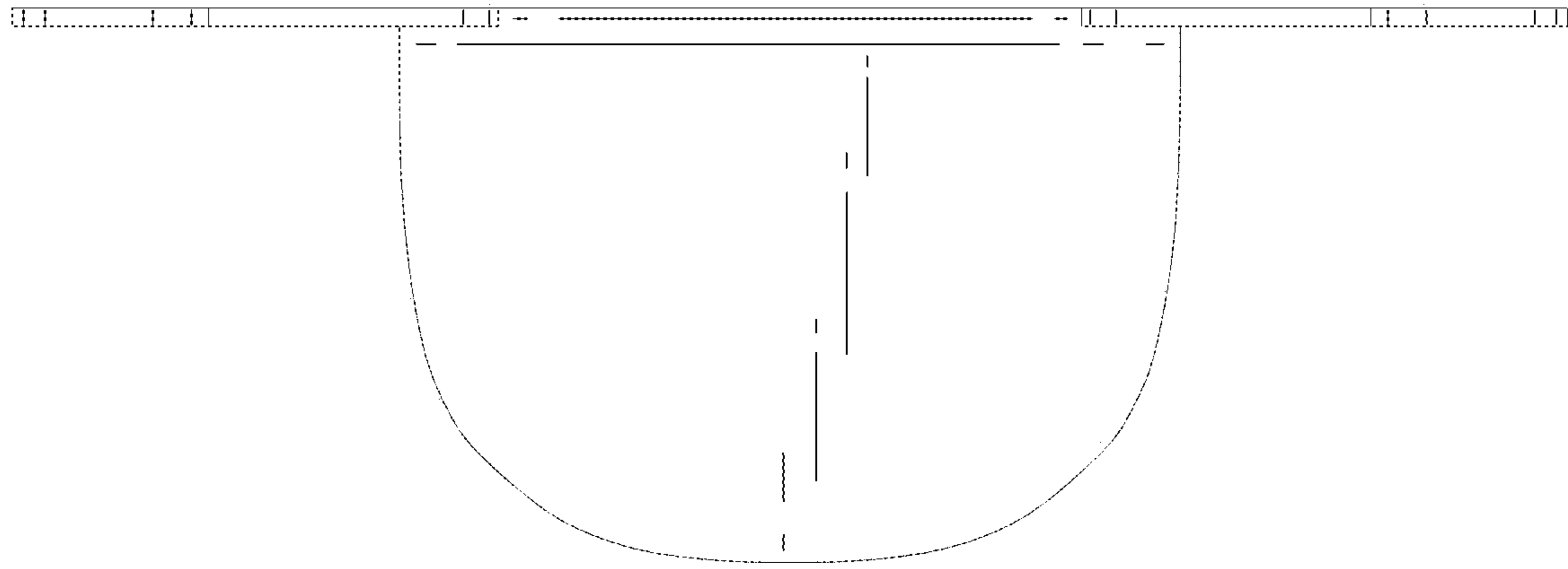

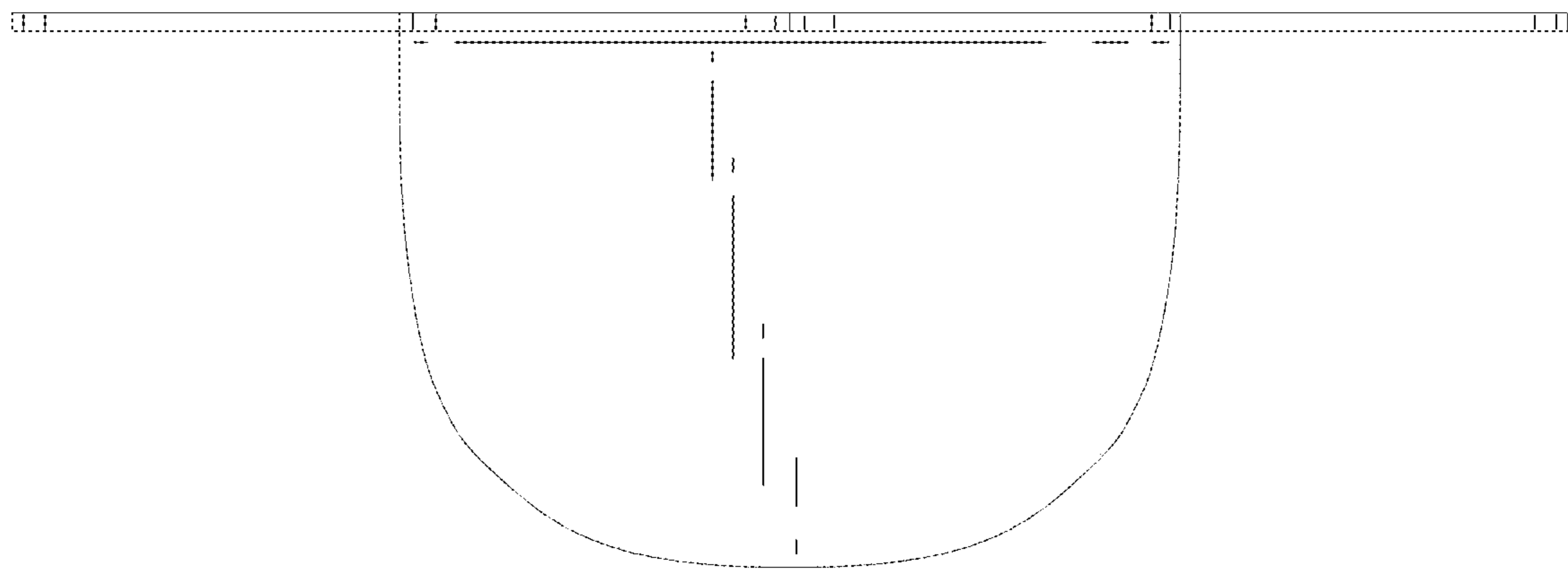
