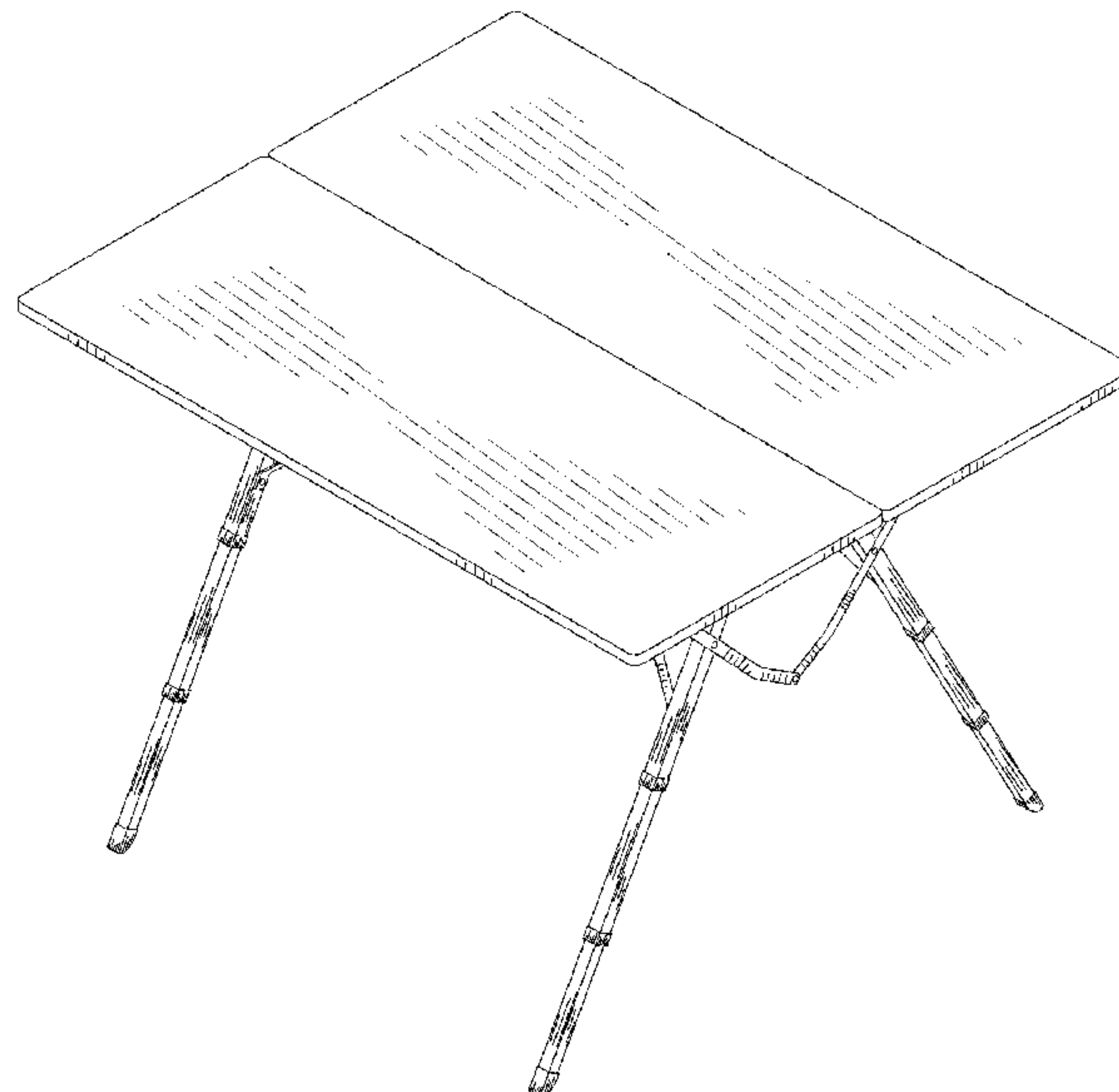

DESCRIPTION

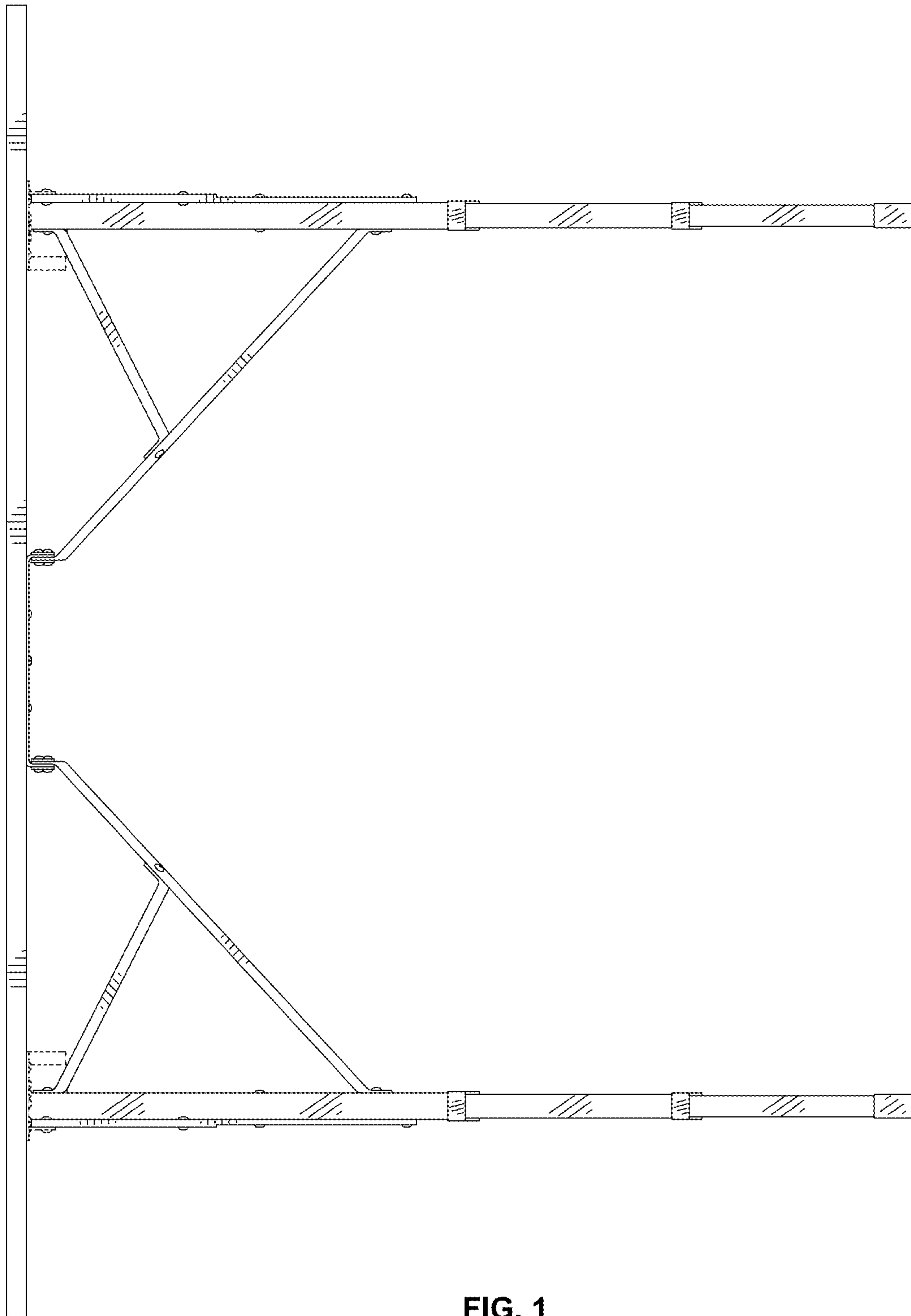

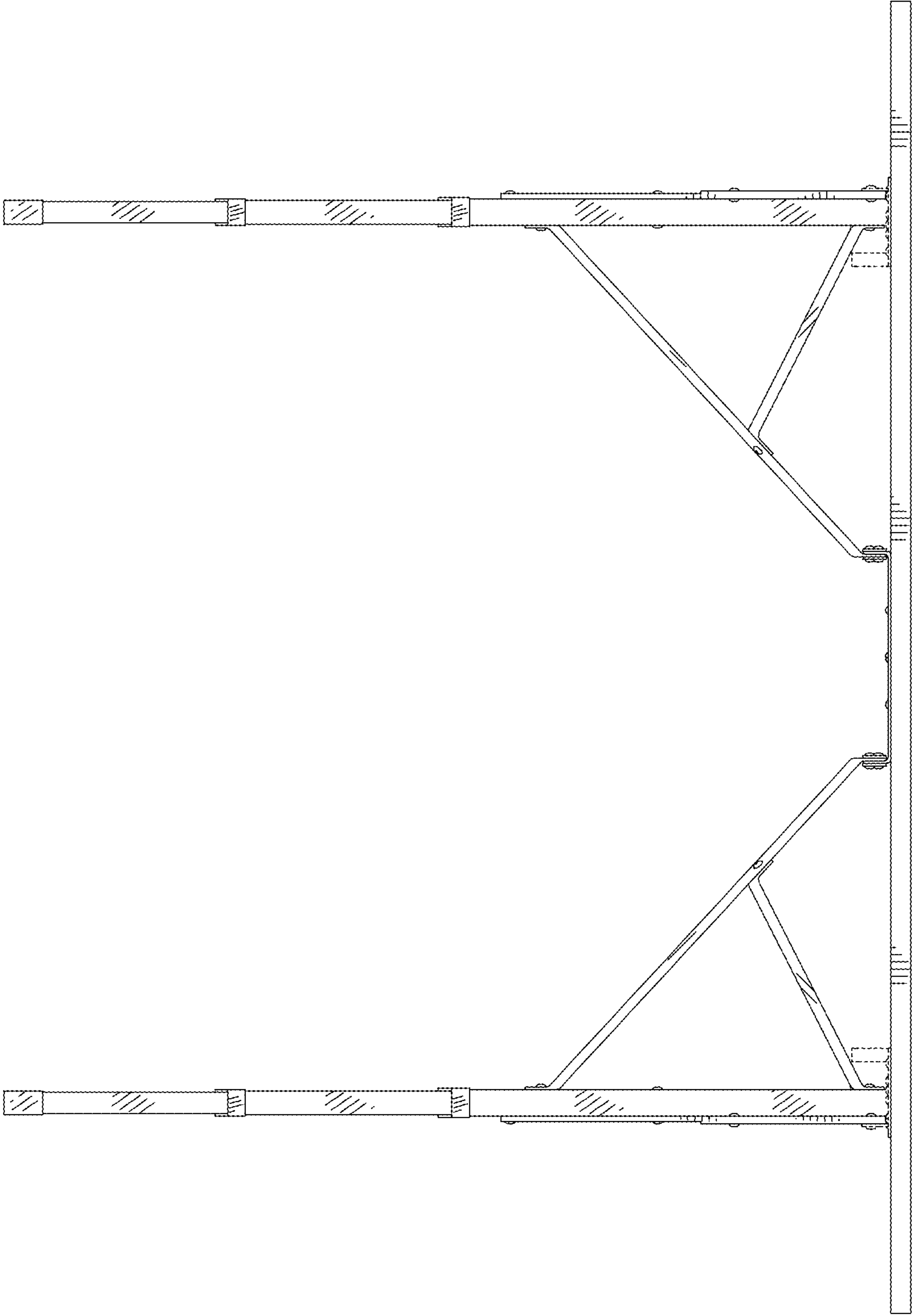

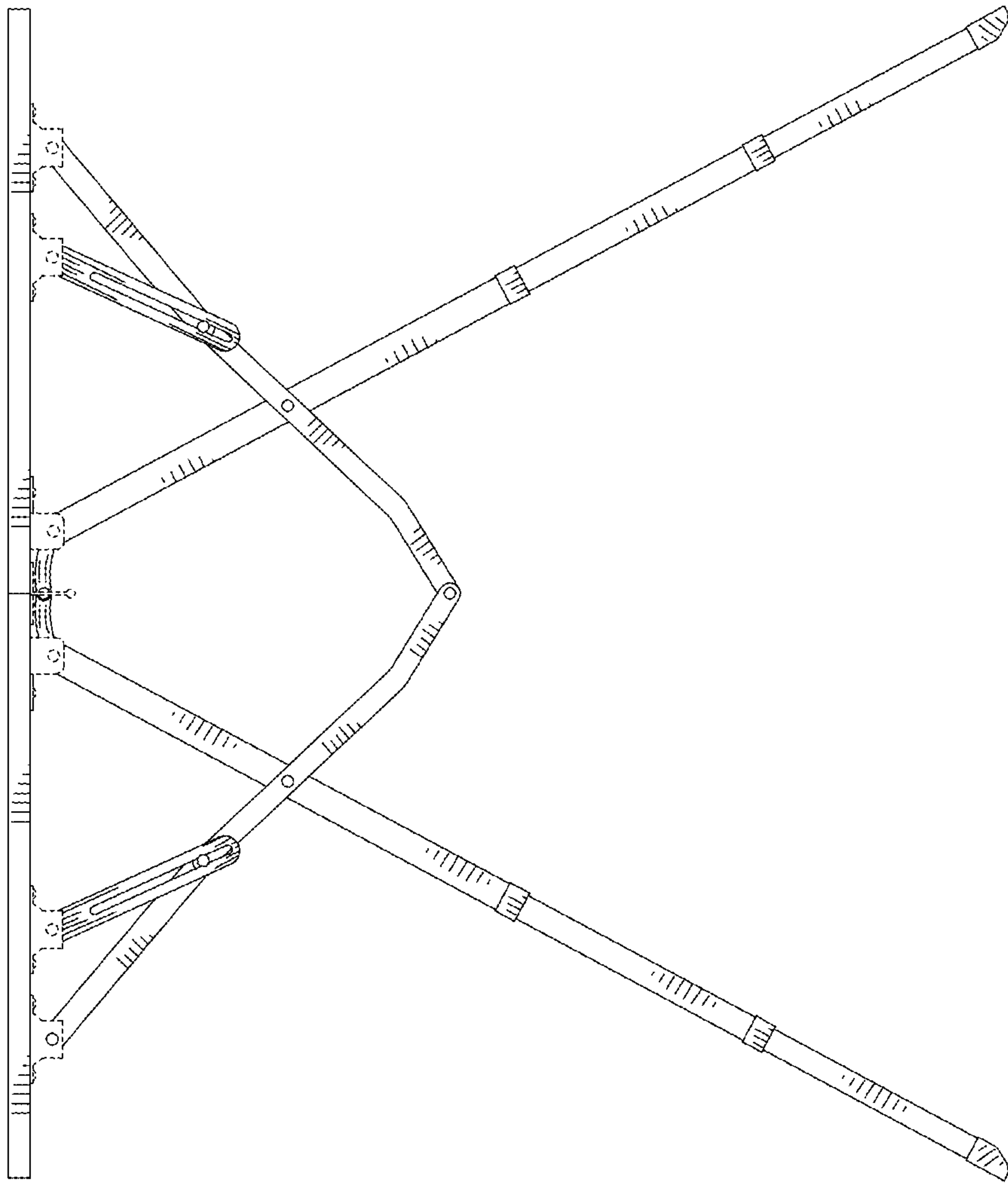

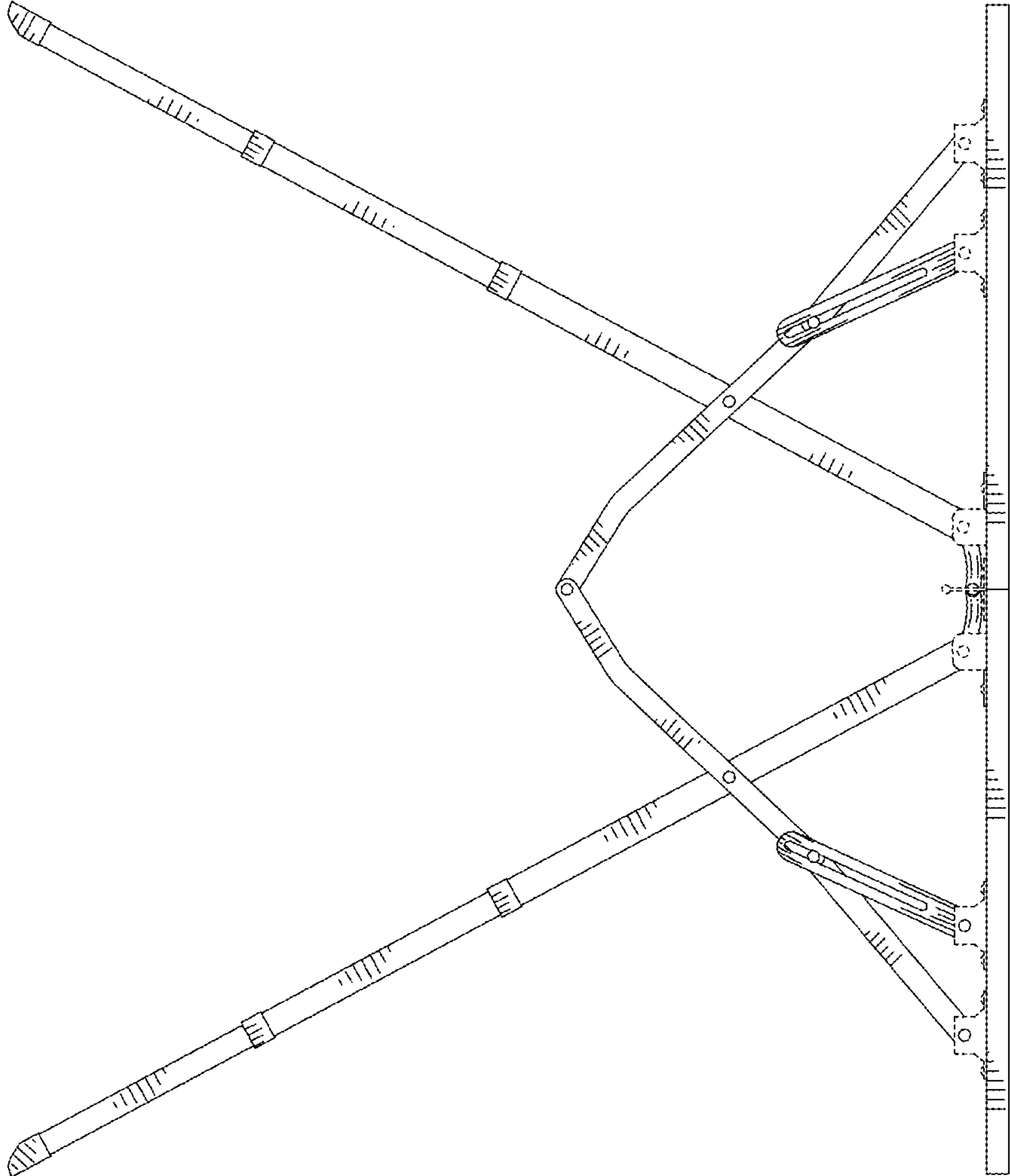

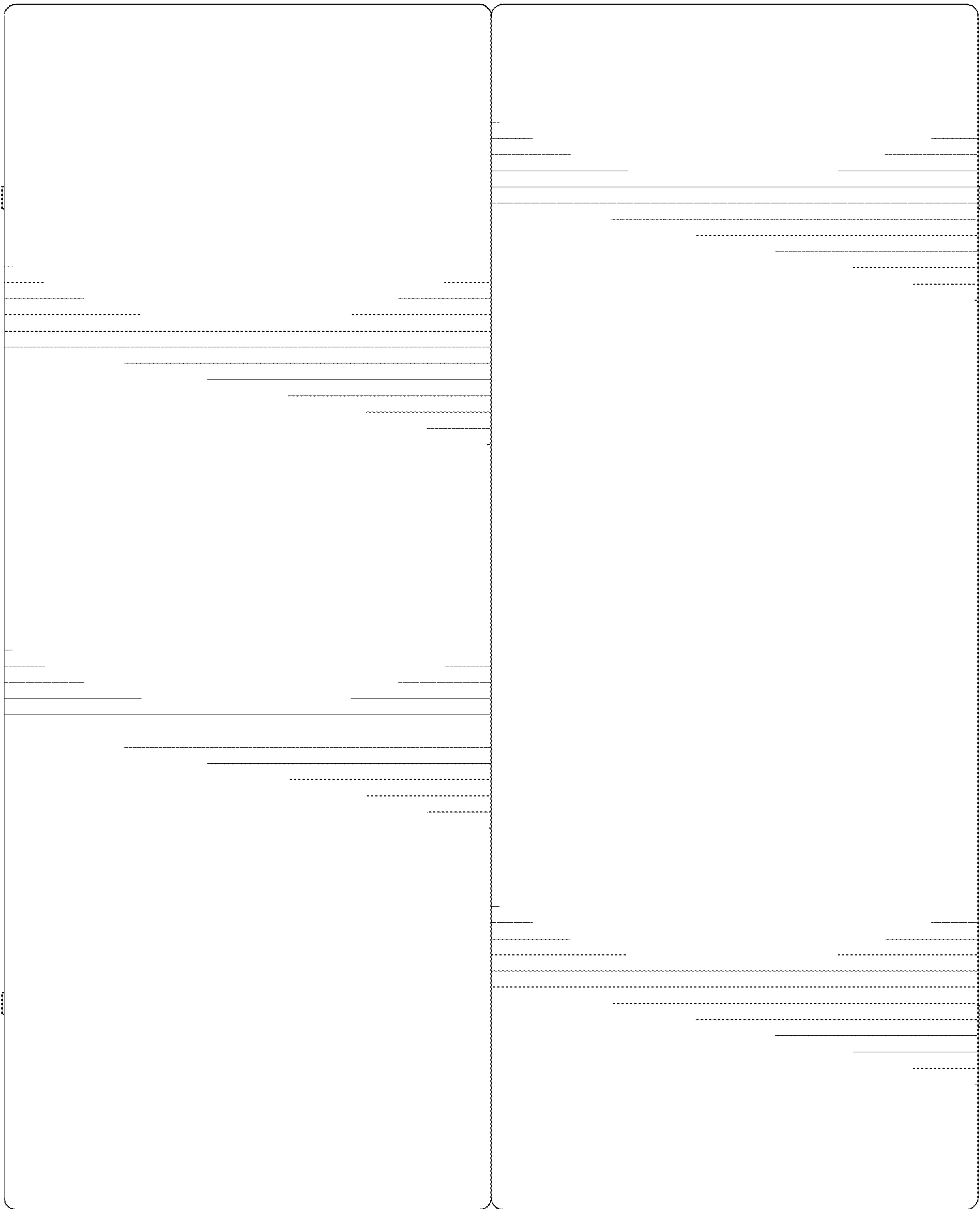

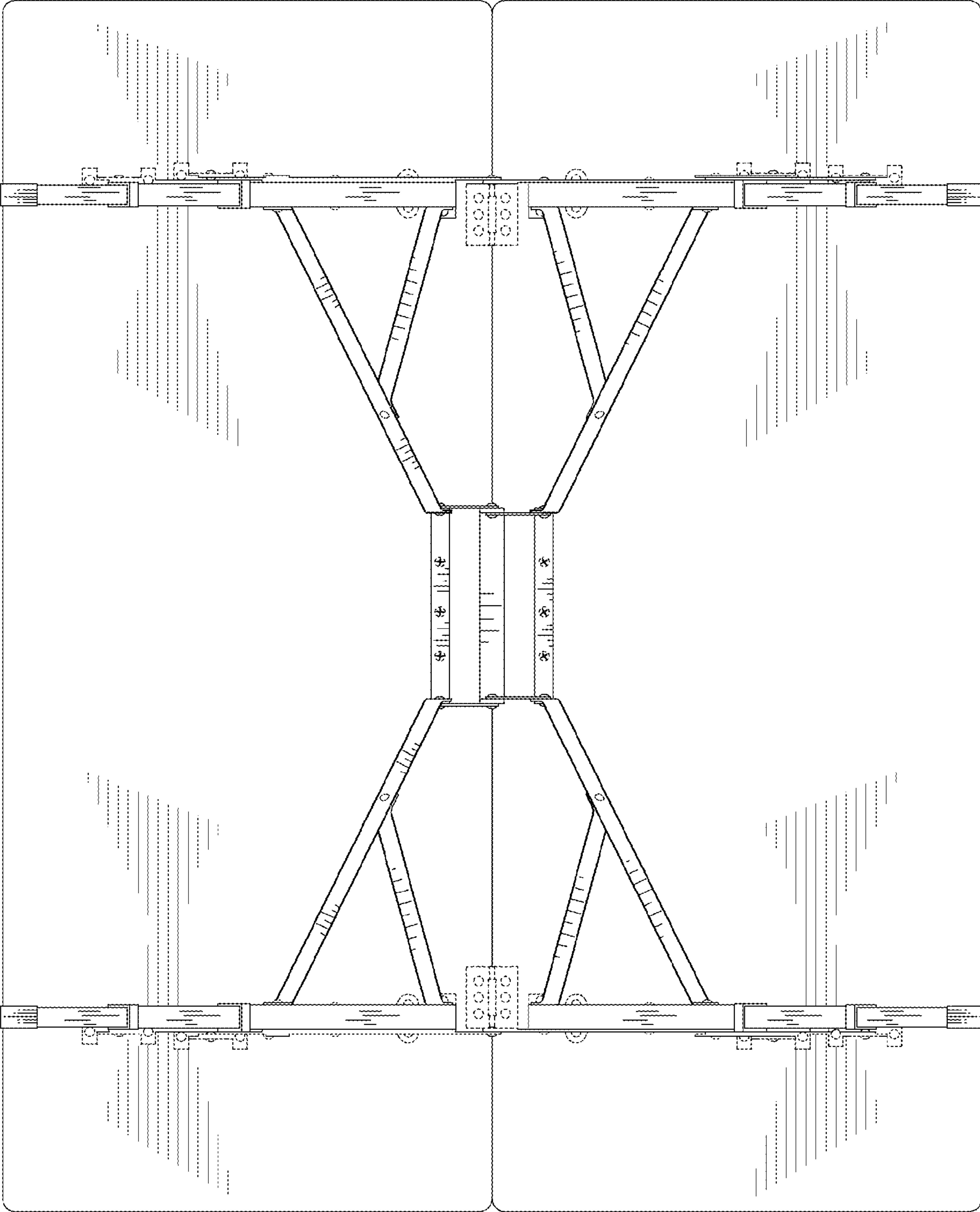

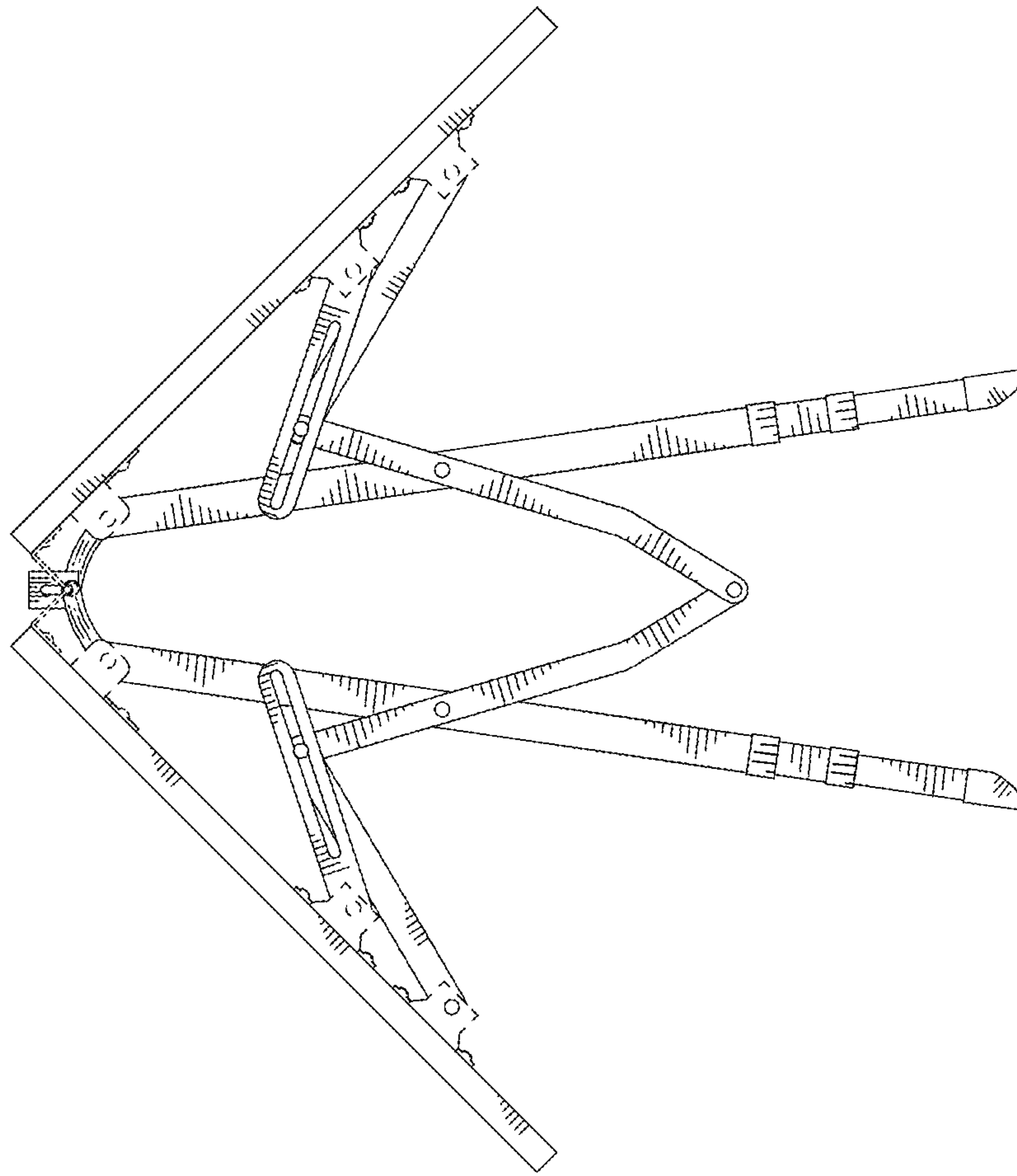

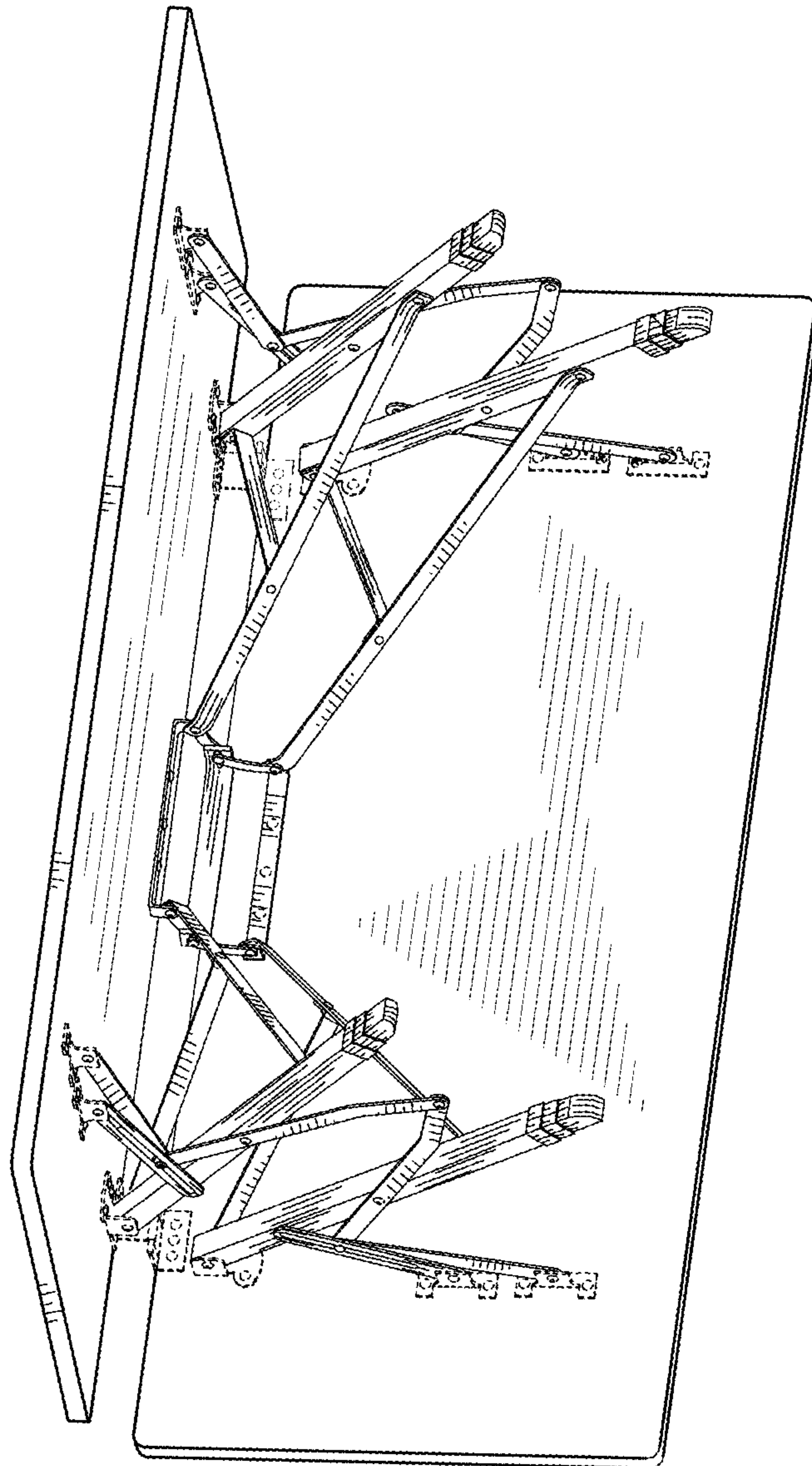
