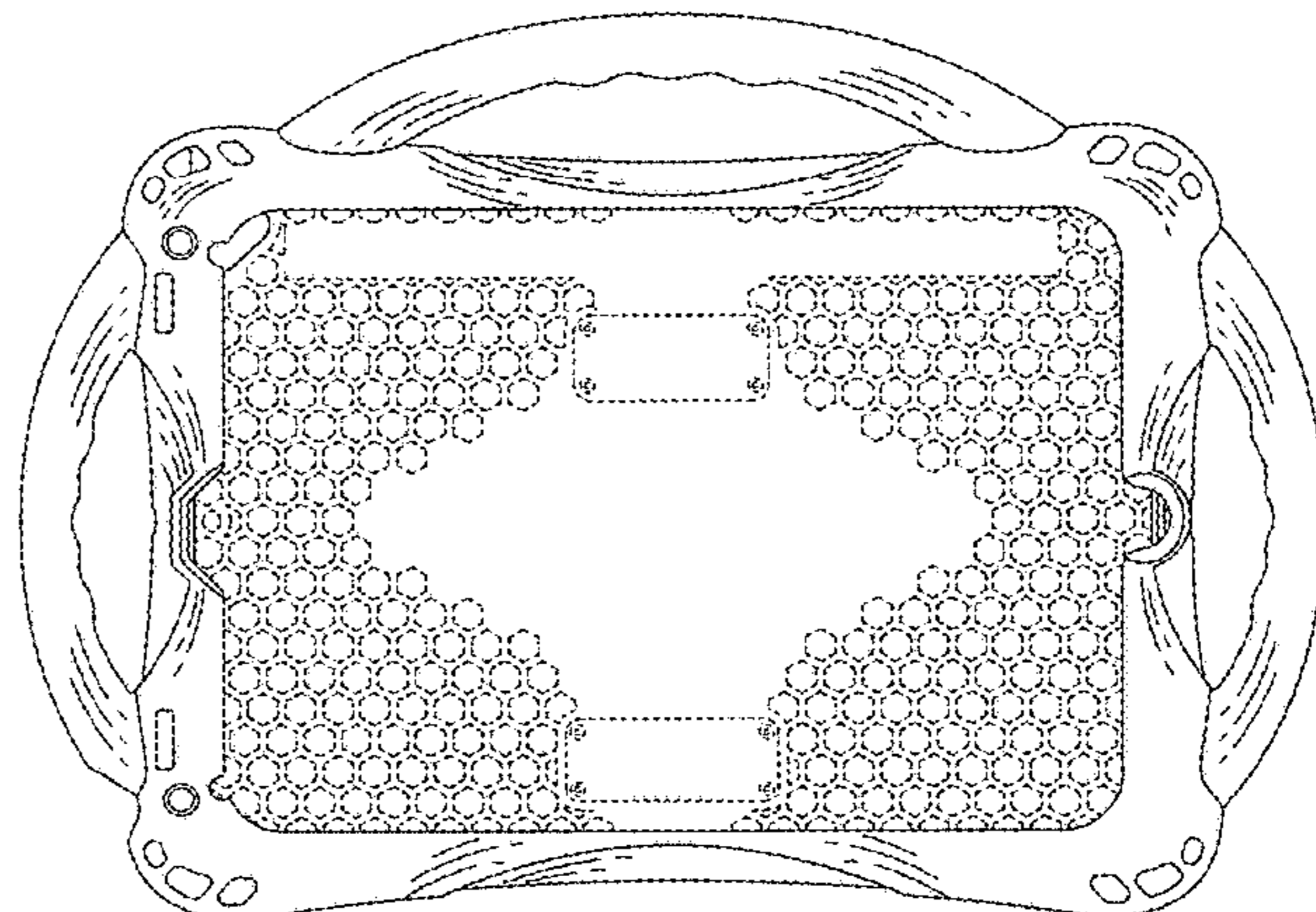
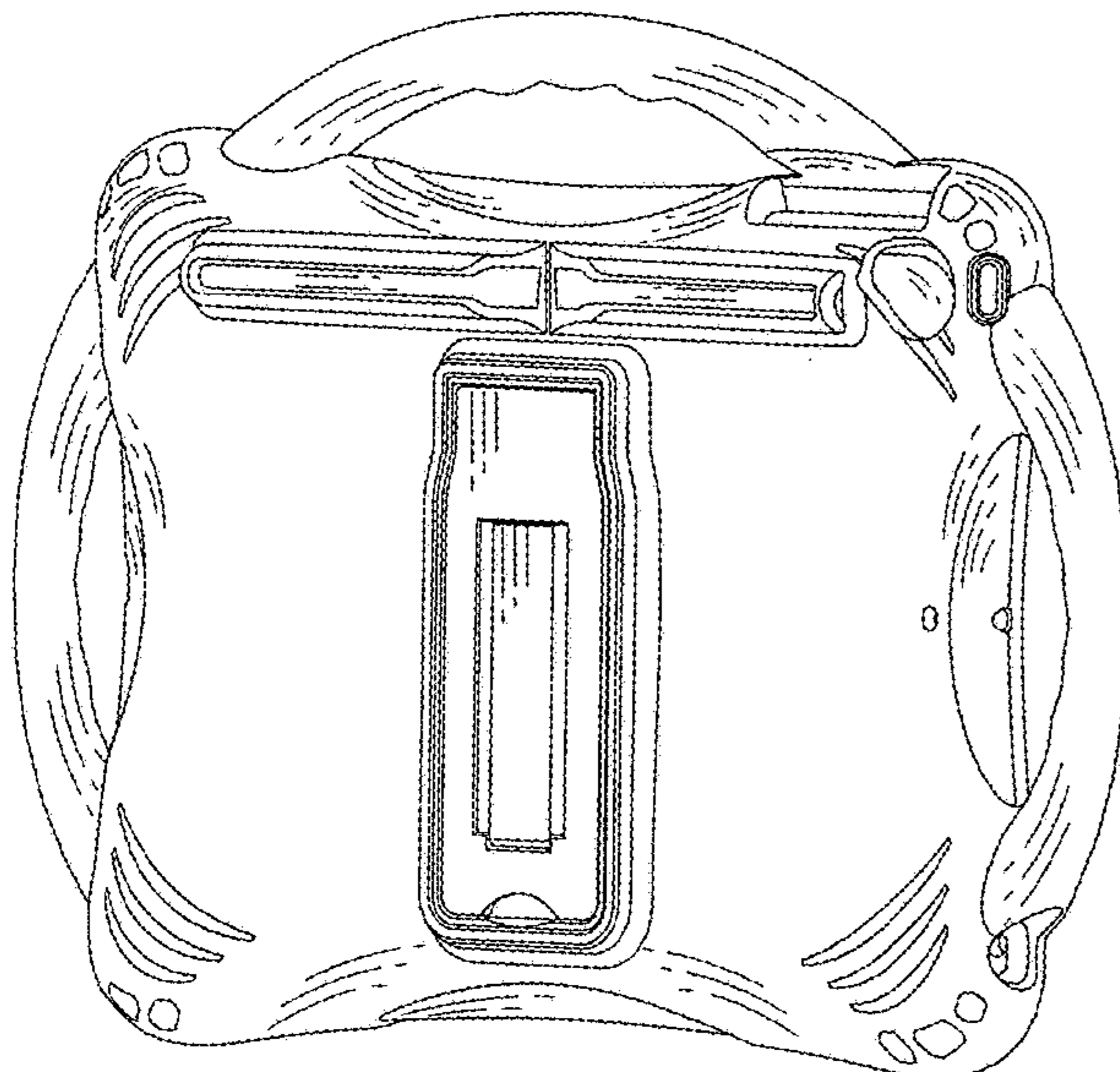
(57) **CLAIM**

The ornamental design for a case for a tablet computer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a case for a tablet computer showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof, shown enlarged in scale;
FIG. 5 is a right side elevation view thereof, shown enlarged in scale;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines depict portions of the case for a tablet computer and form no part of the claimed design.

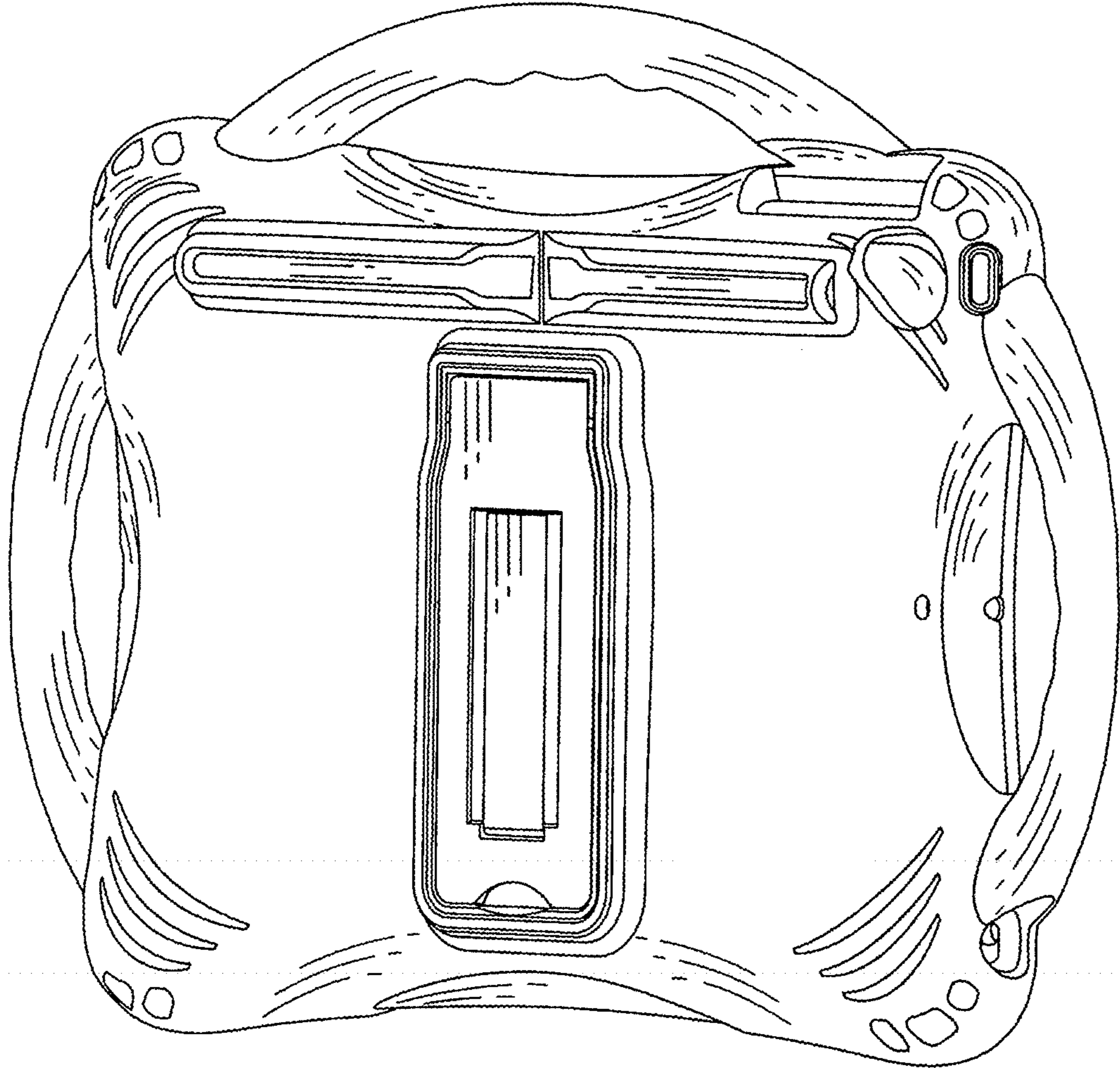

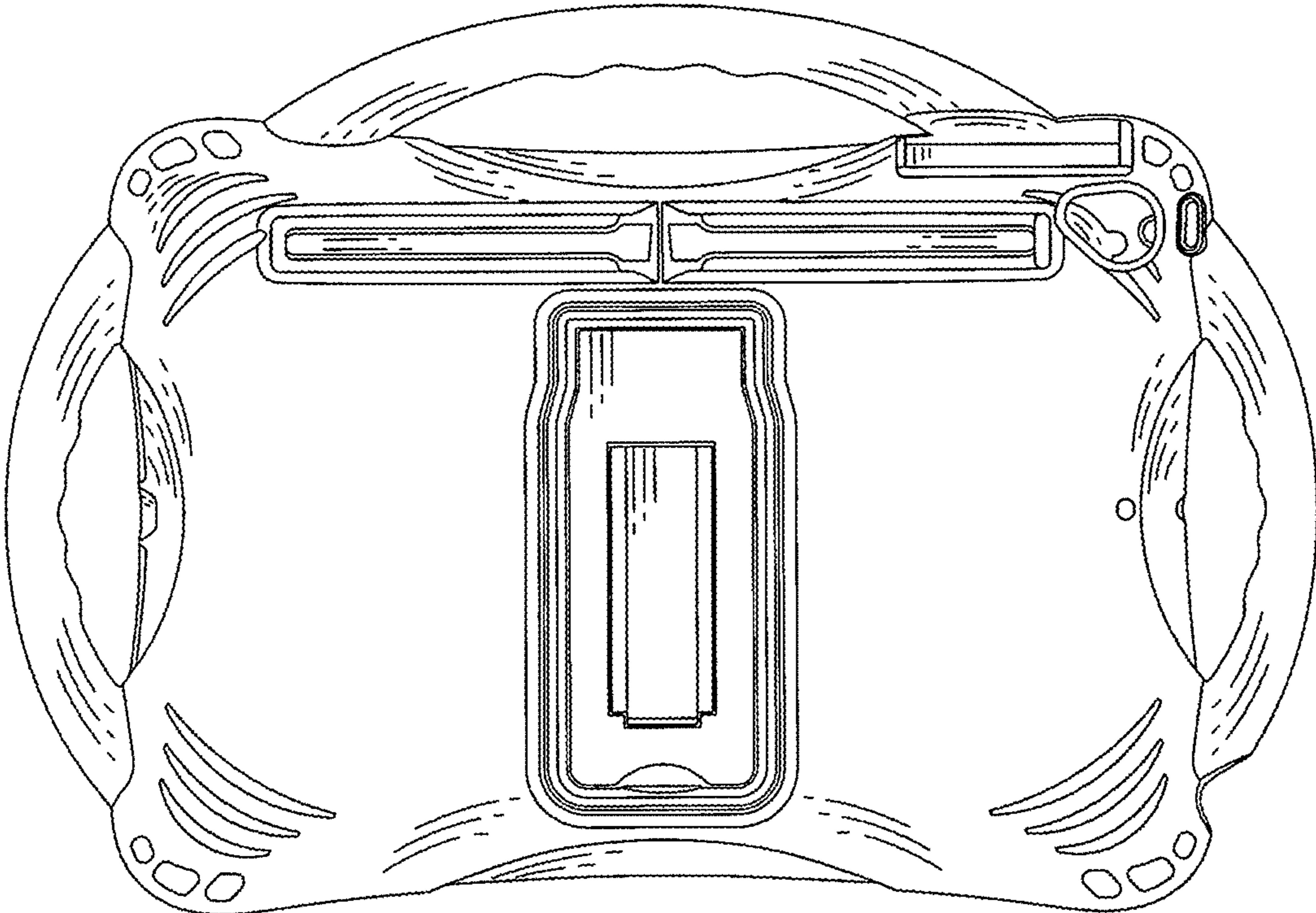

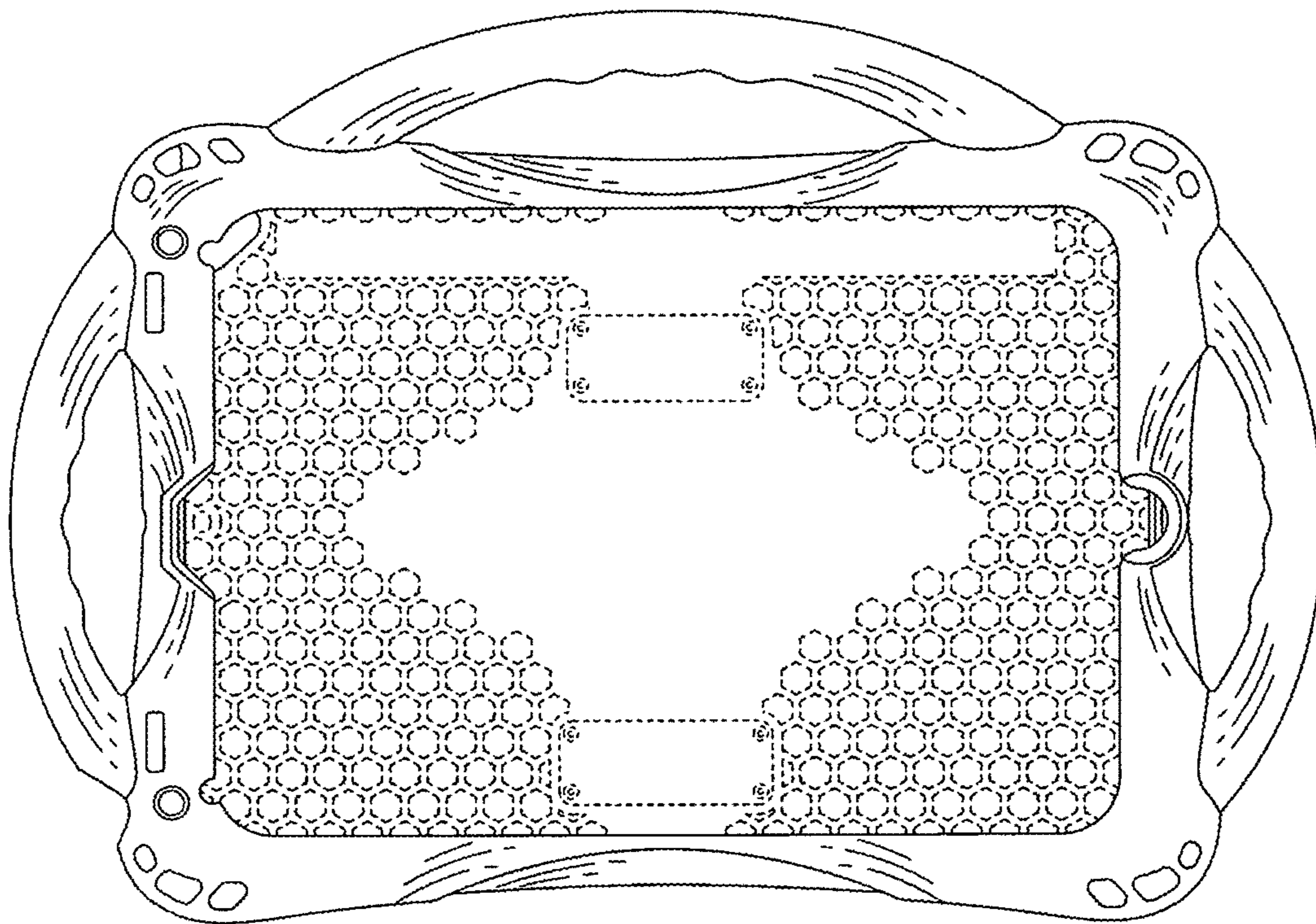

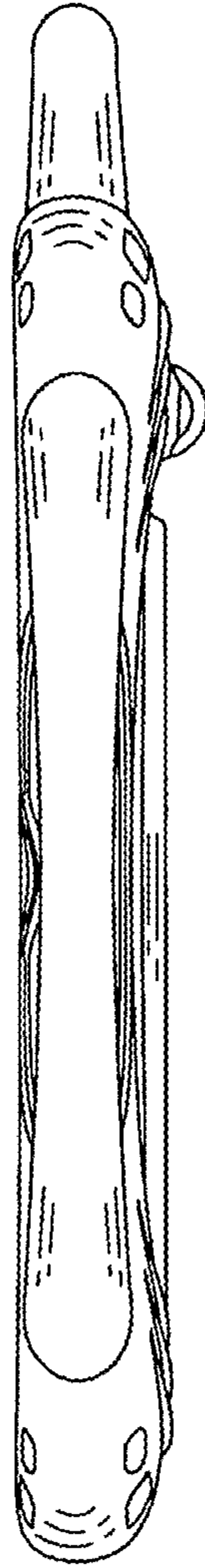

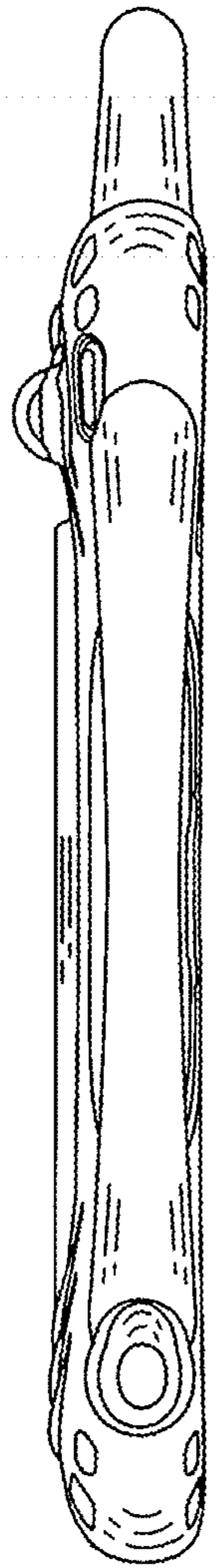

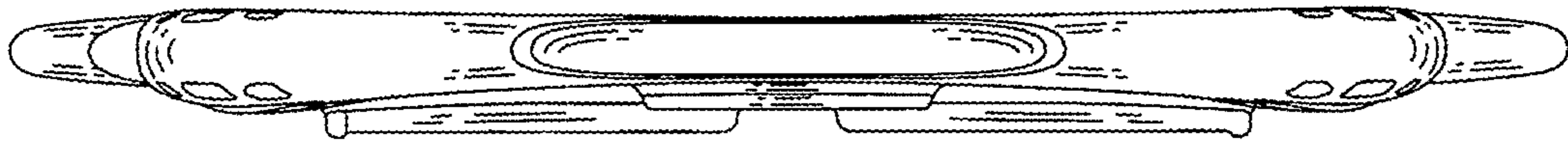

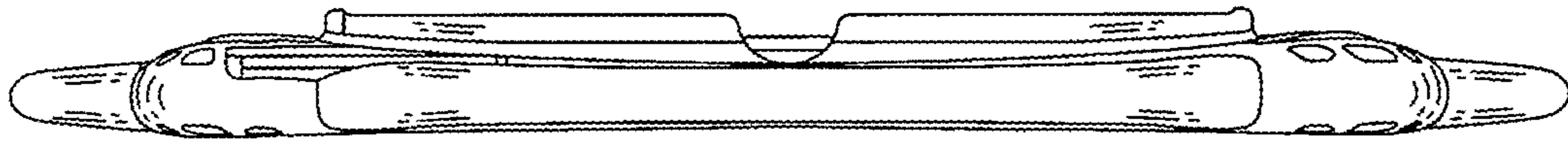
