(57) **CLAIM**

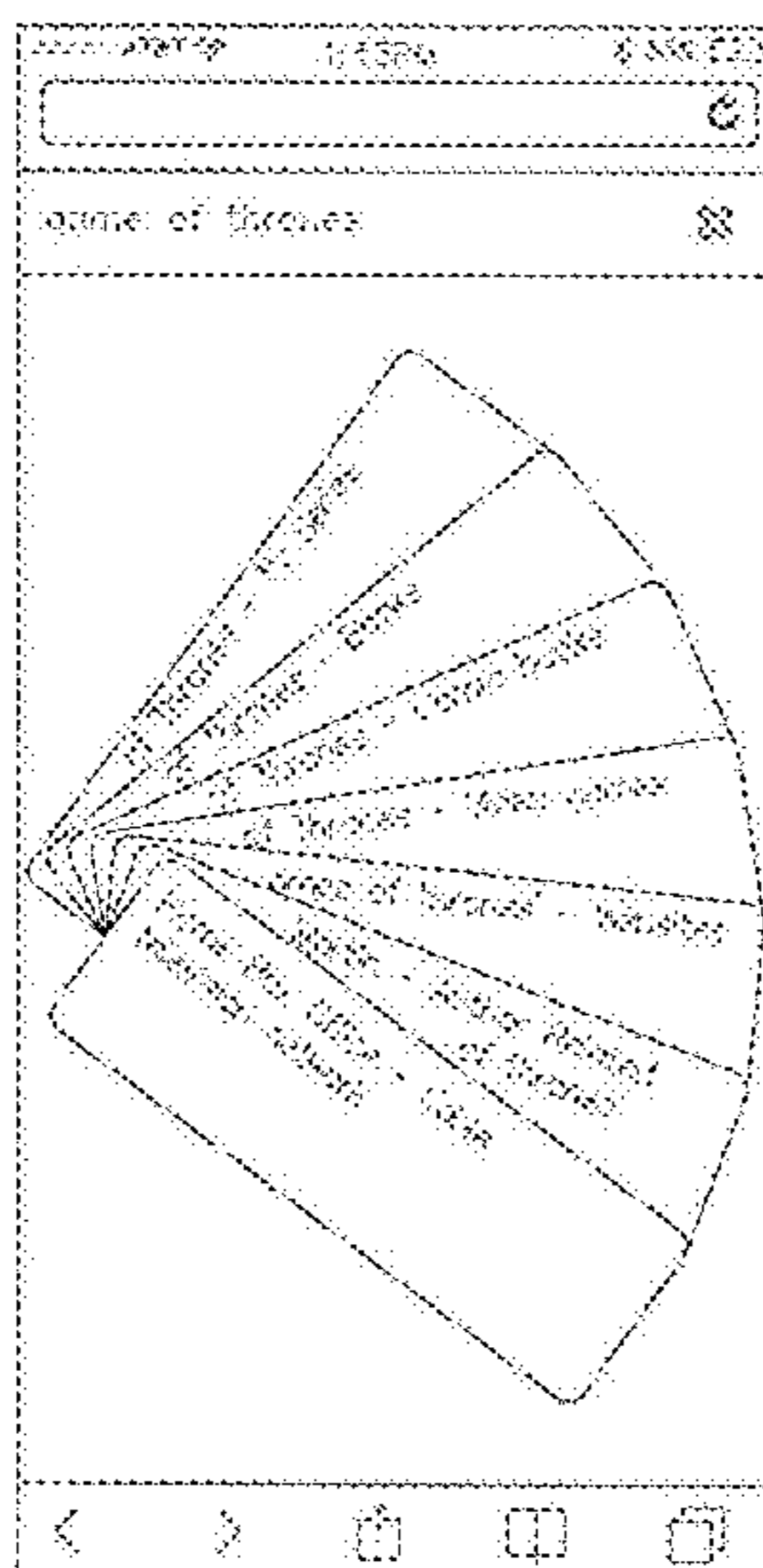
We claim the ornamental design for a display screen with graphical user interface for displaying search results as a stack of overlapping, actionable cards, as shown and described.
