The ornamental design for a display screen with animated graphical user interface, as shown and described.

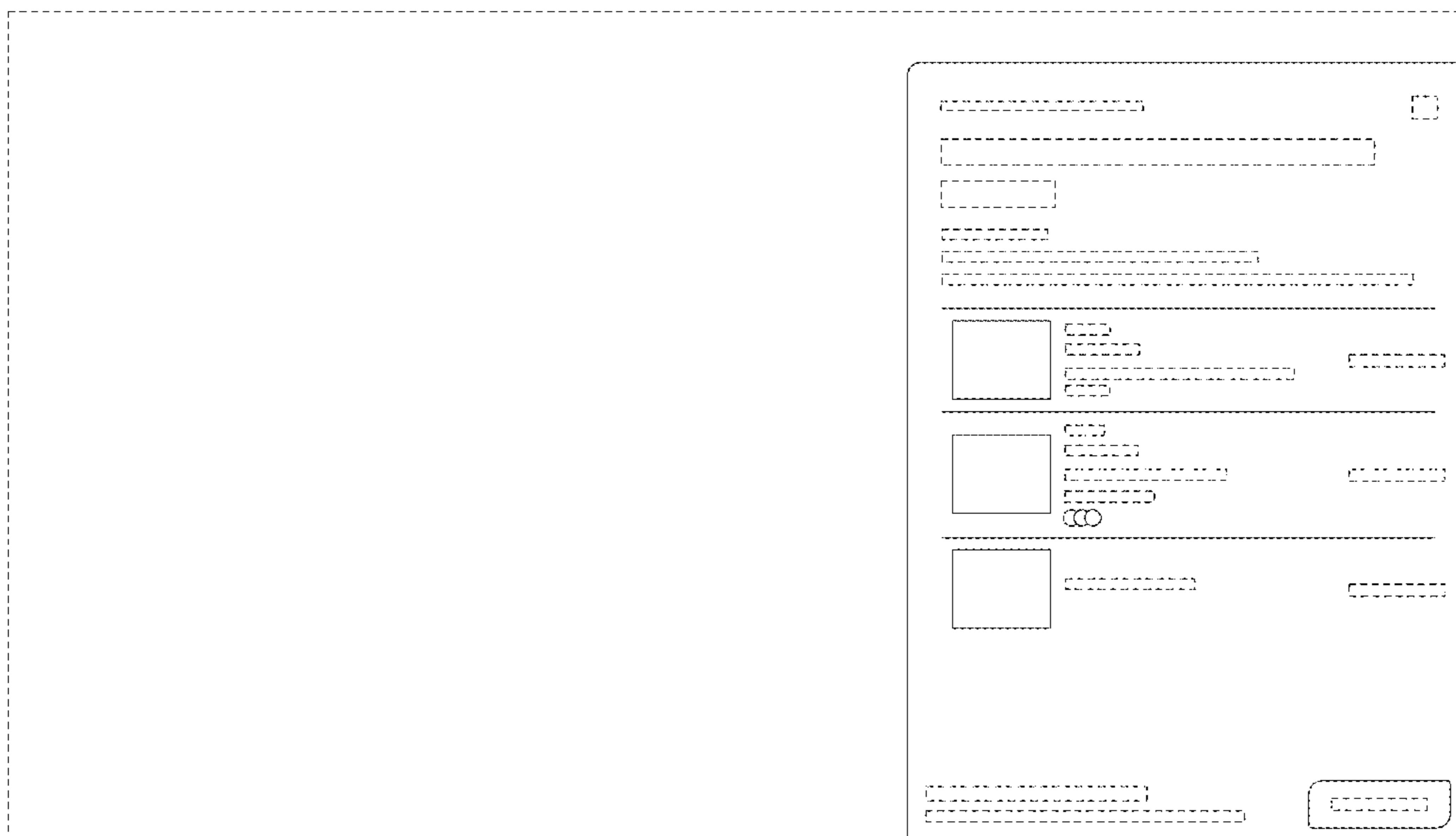
**DESCRIPTION**

FIG. 1 is the first image in a sequence for a display screen with animated graphical user interface; FIG. 2 is the second image thereof; FIG. 3 is the third image thereof; and, FIG. 4 is the fourth image thereof.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-4. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken lines showing the display screen, and all other broken lines showing portions of the animated graphical user interface, form no part of the claimed design.

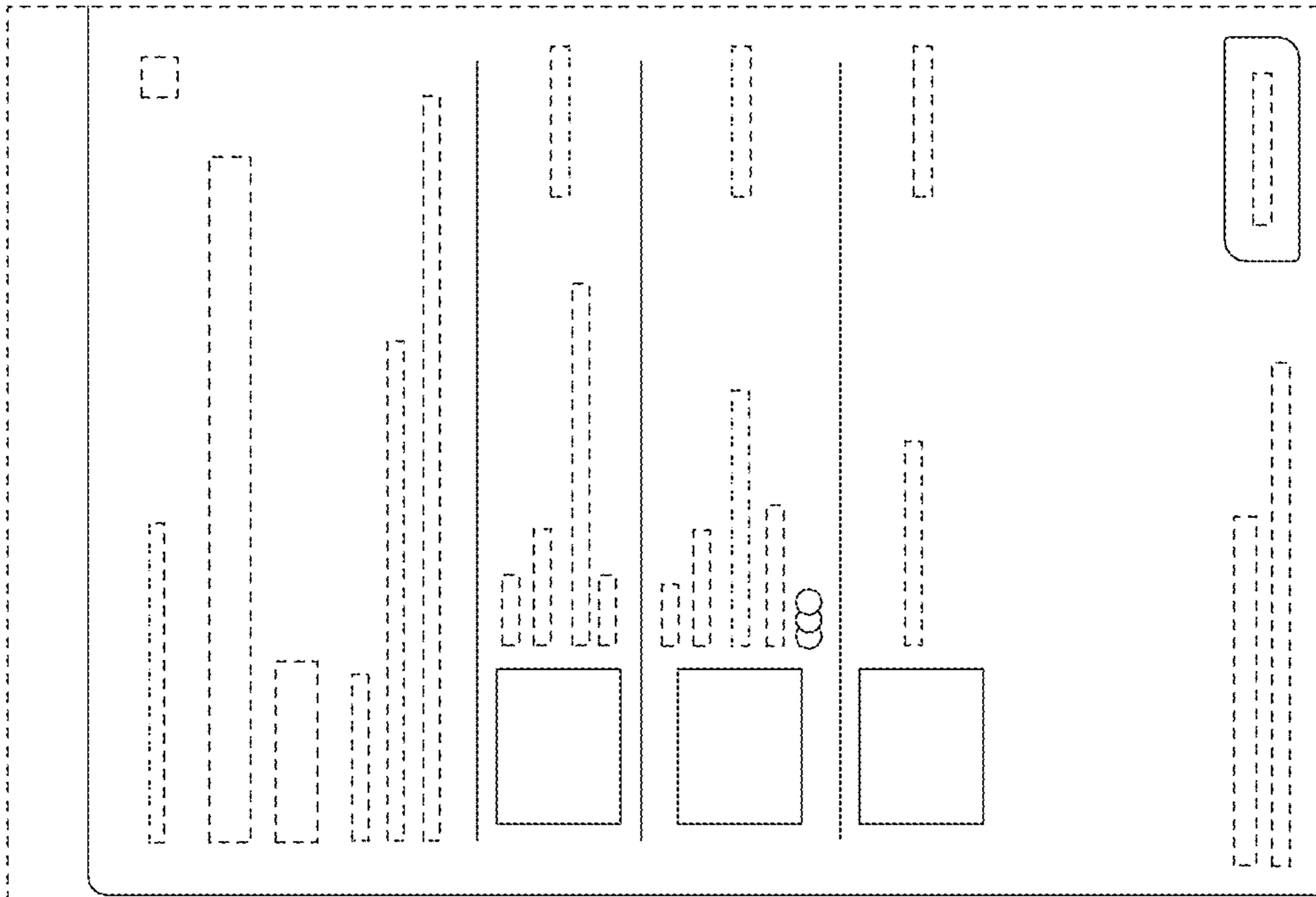

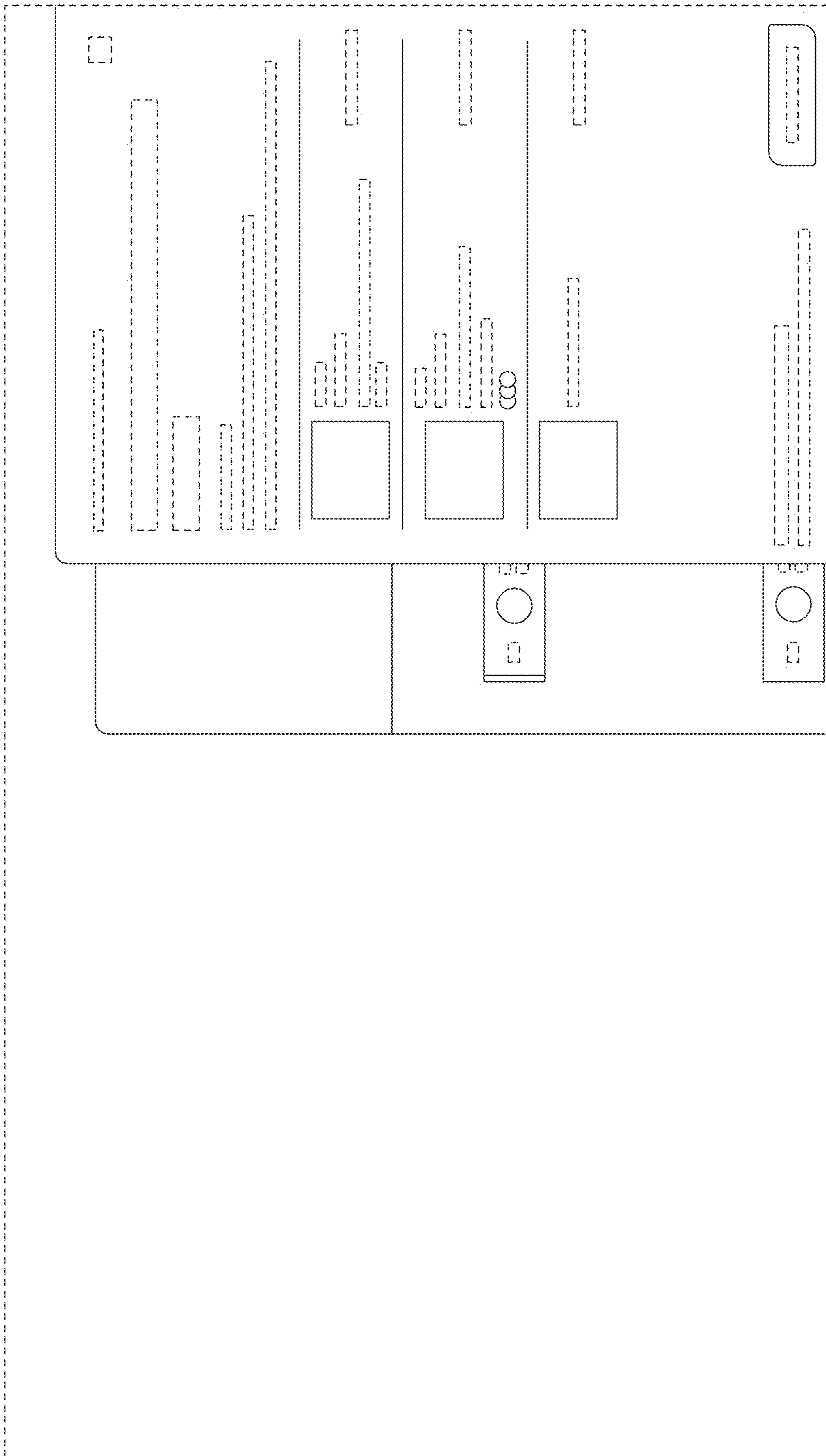

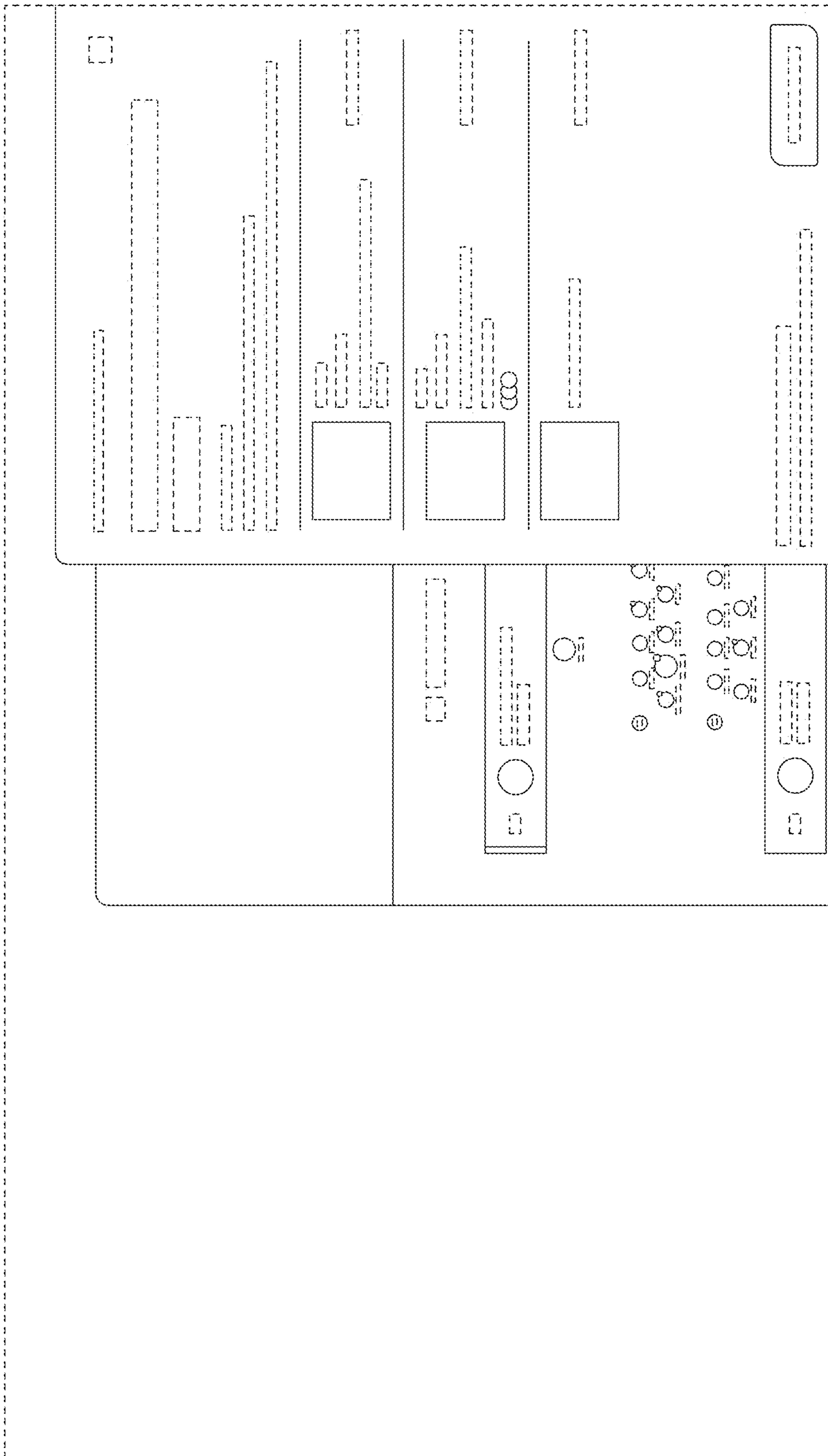

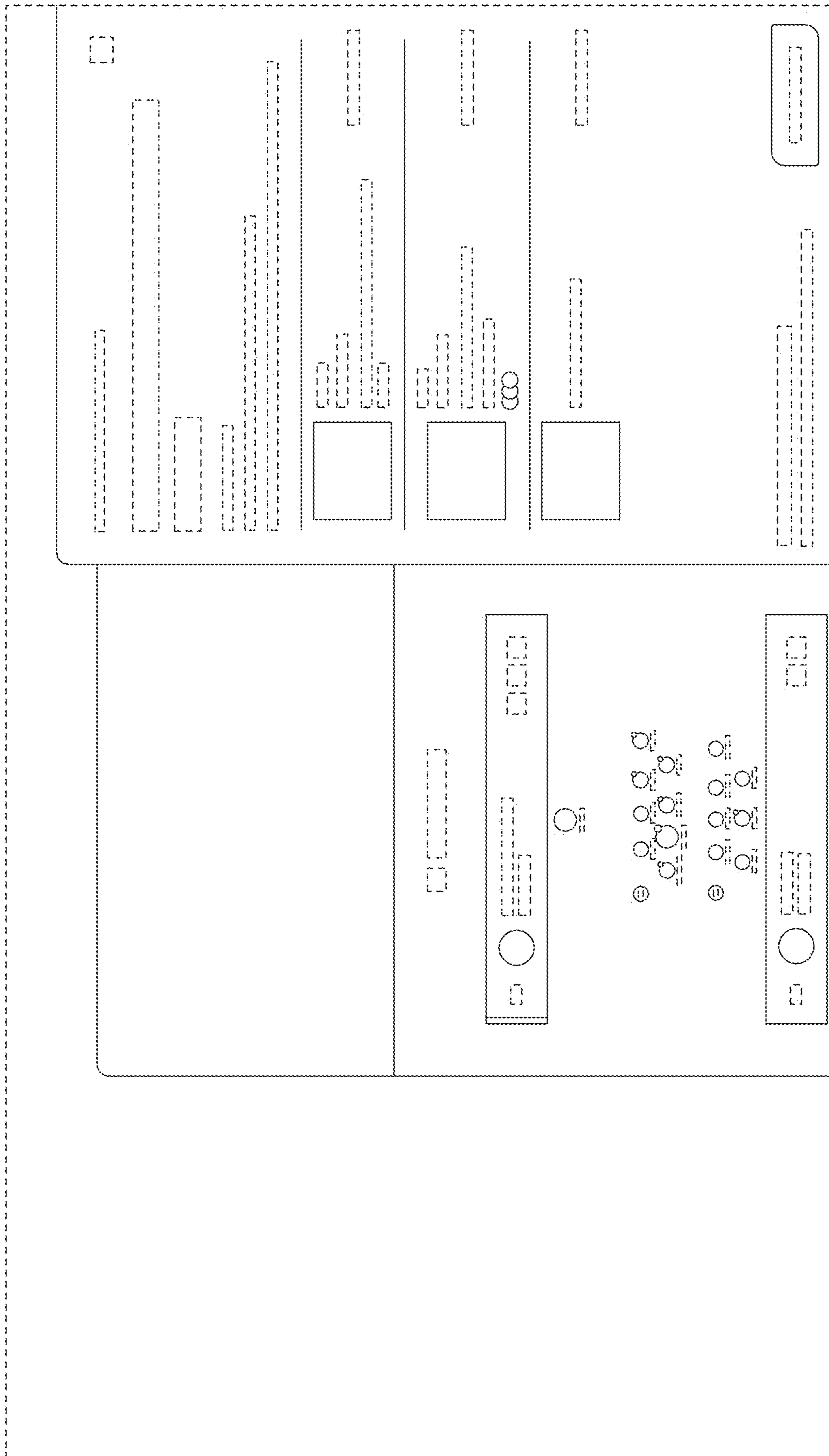
