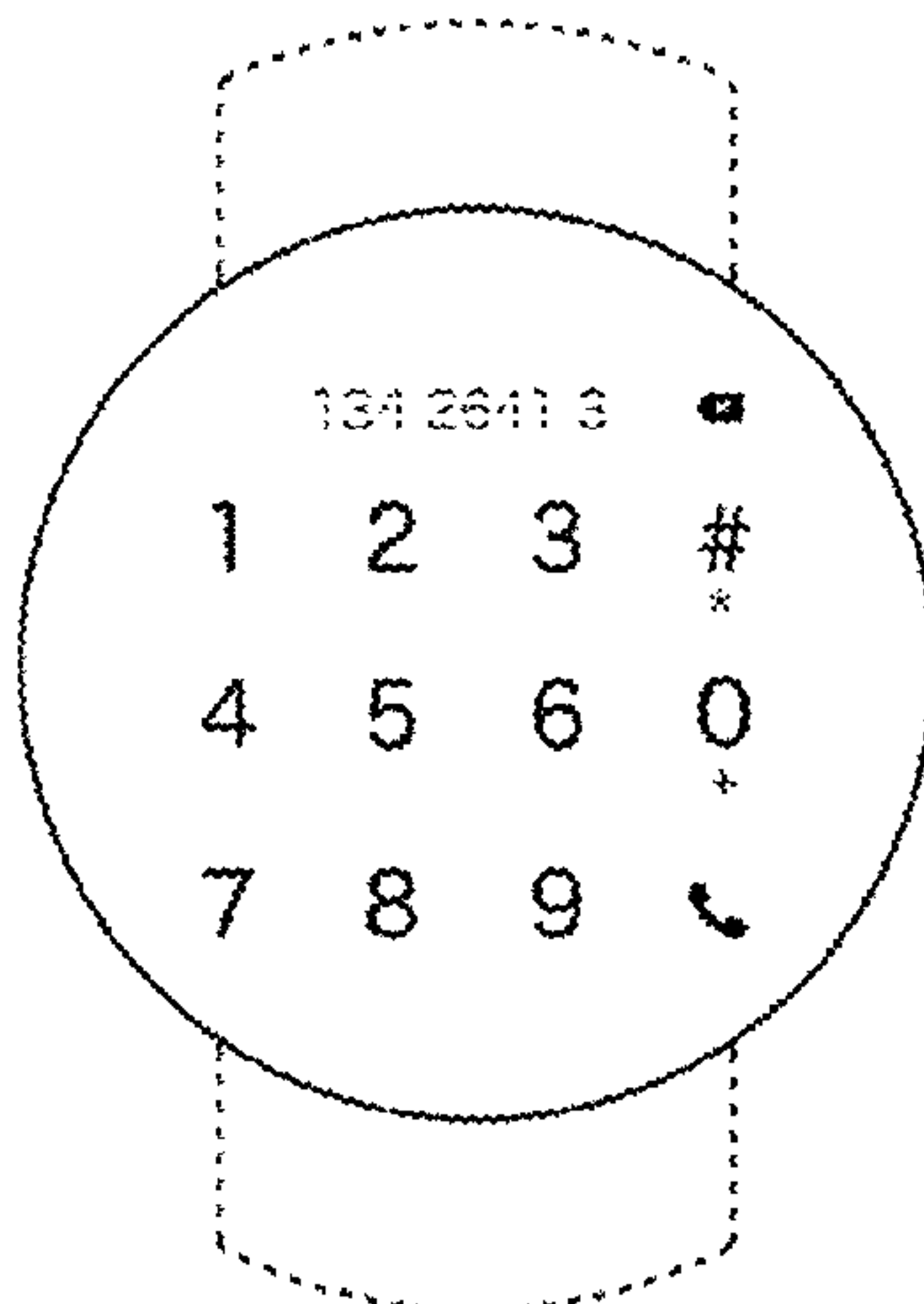


FIG. 12 is a front view of an image of the wearable device display screen with graphic user interface of a twelfth embodiment.

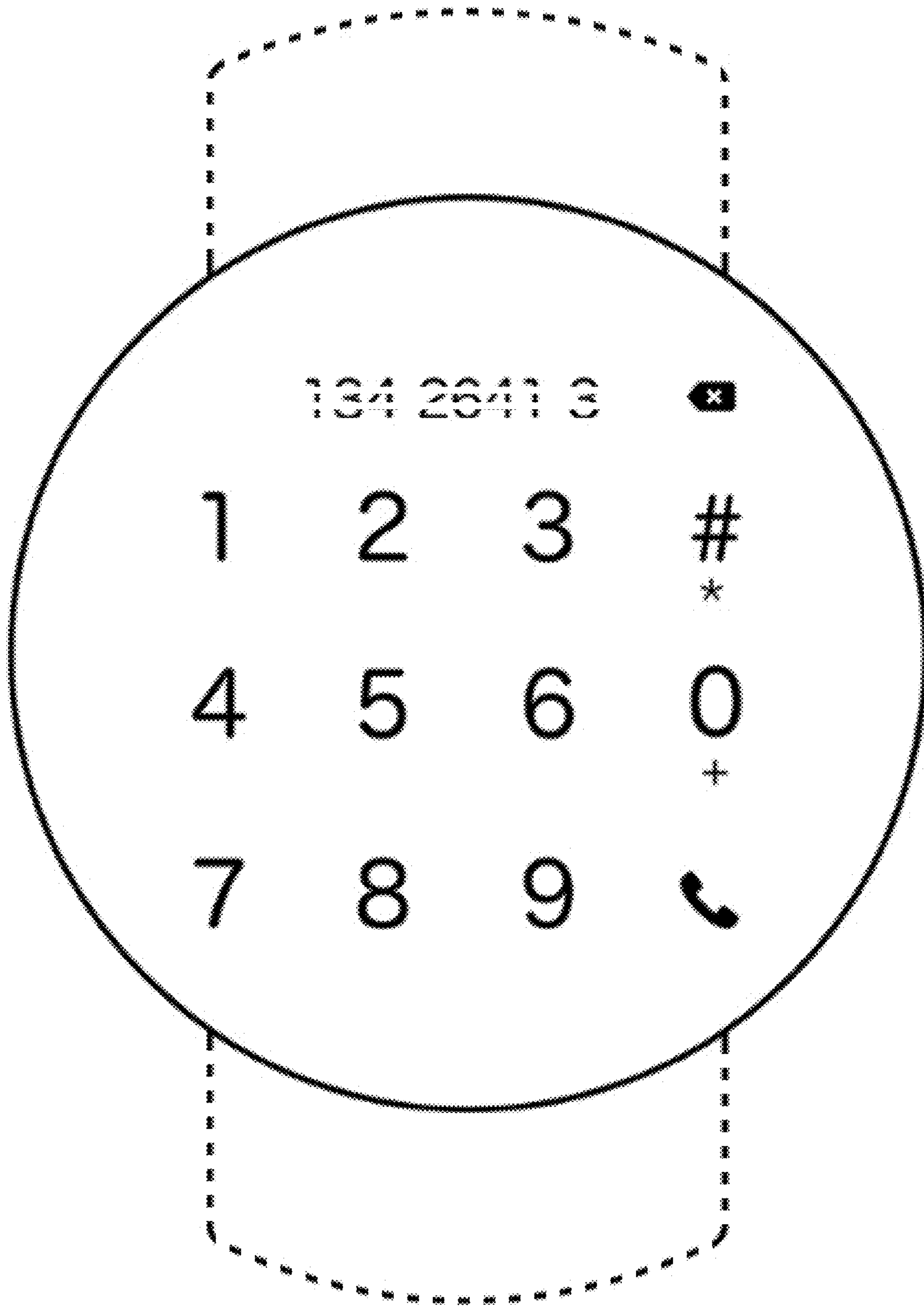

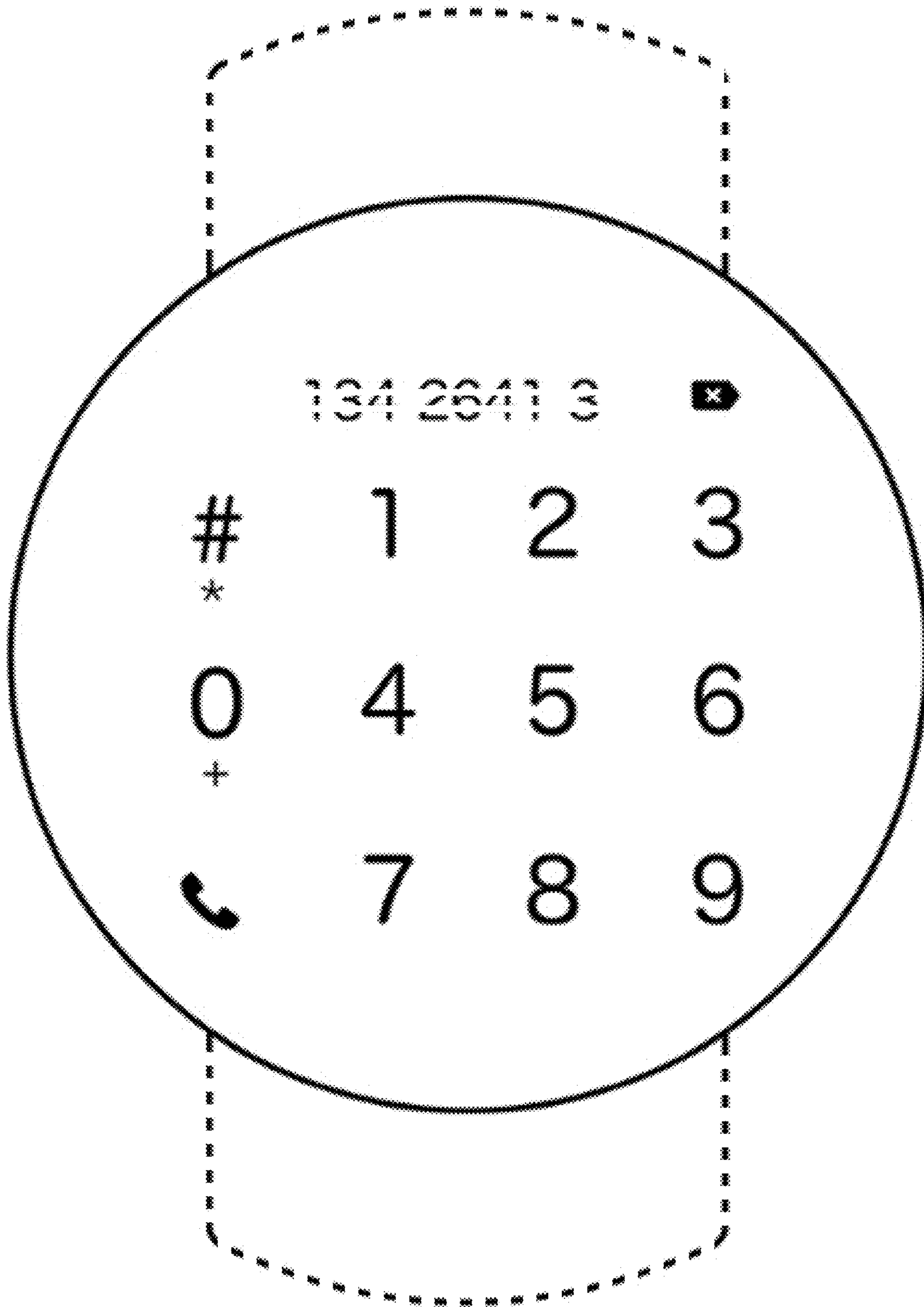

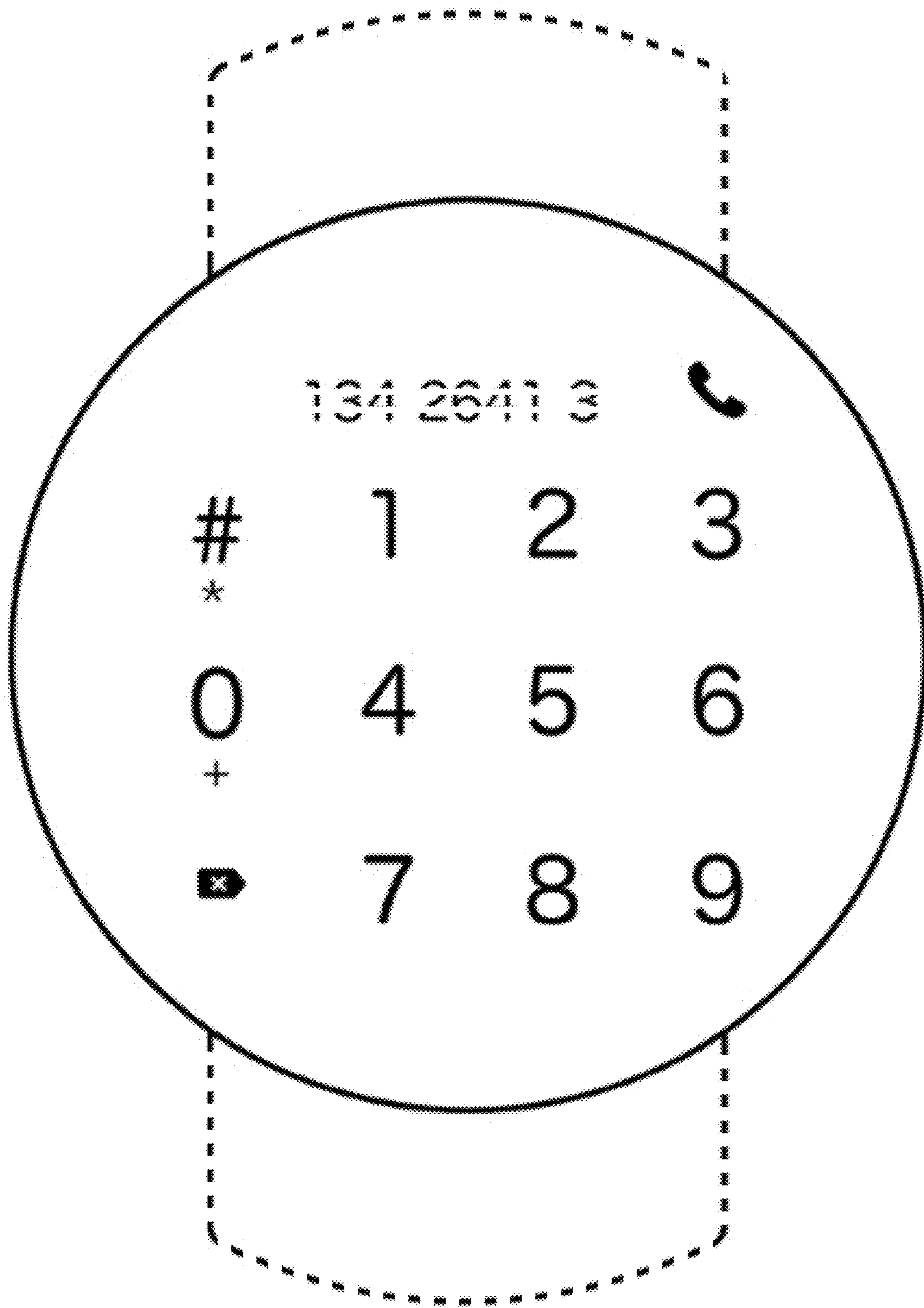

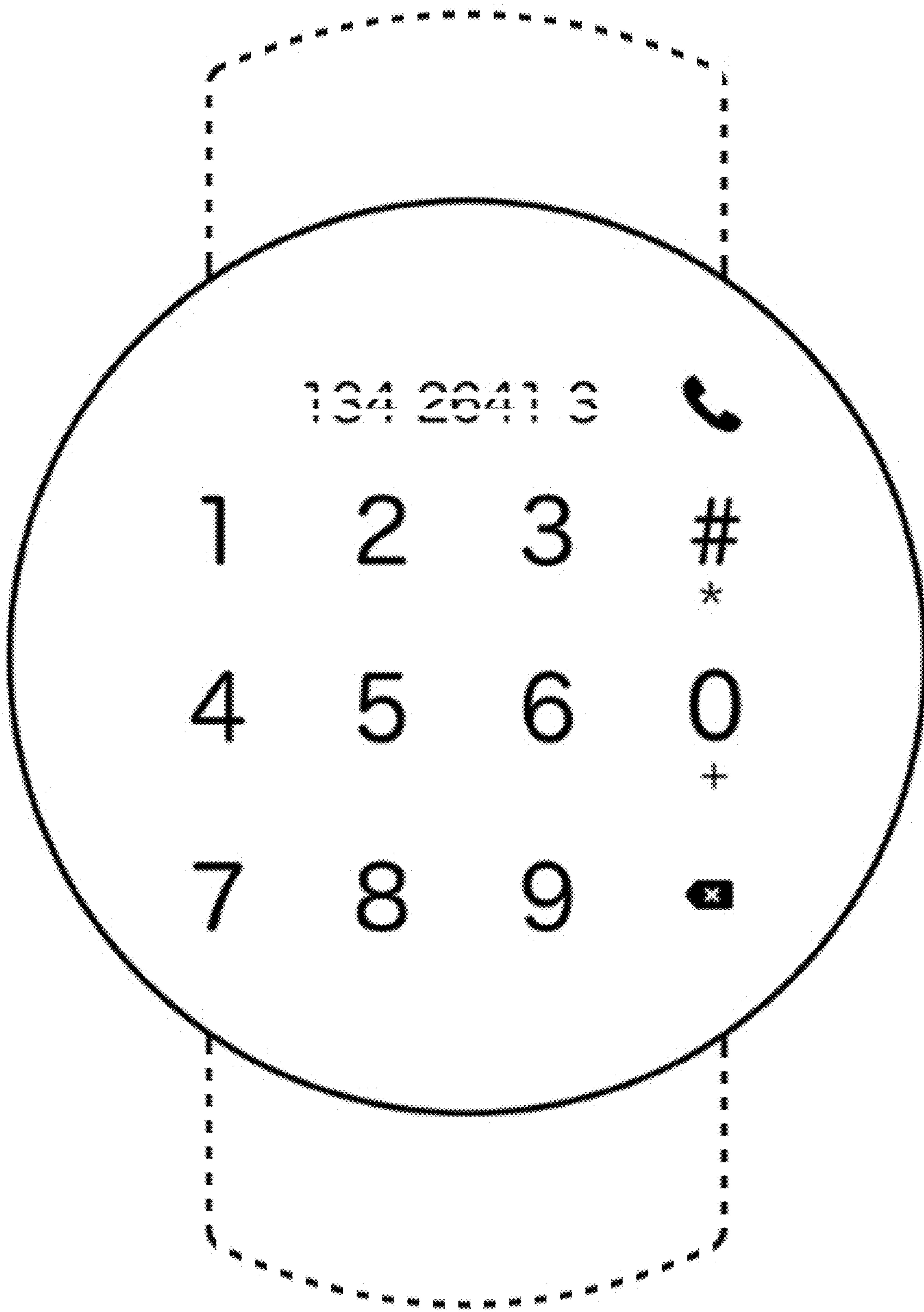

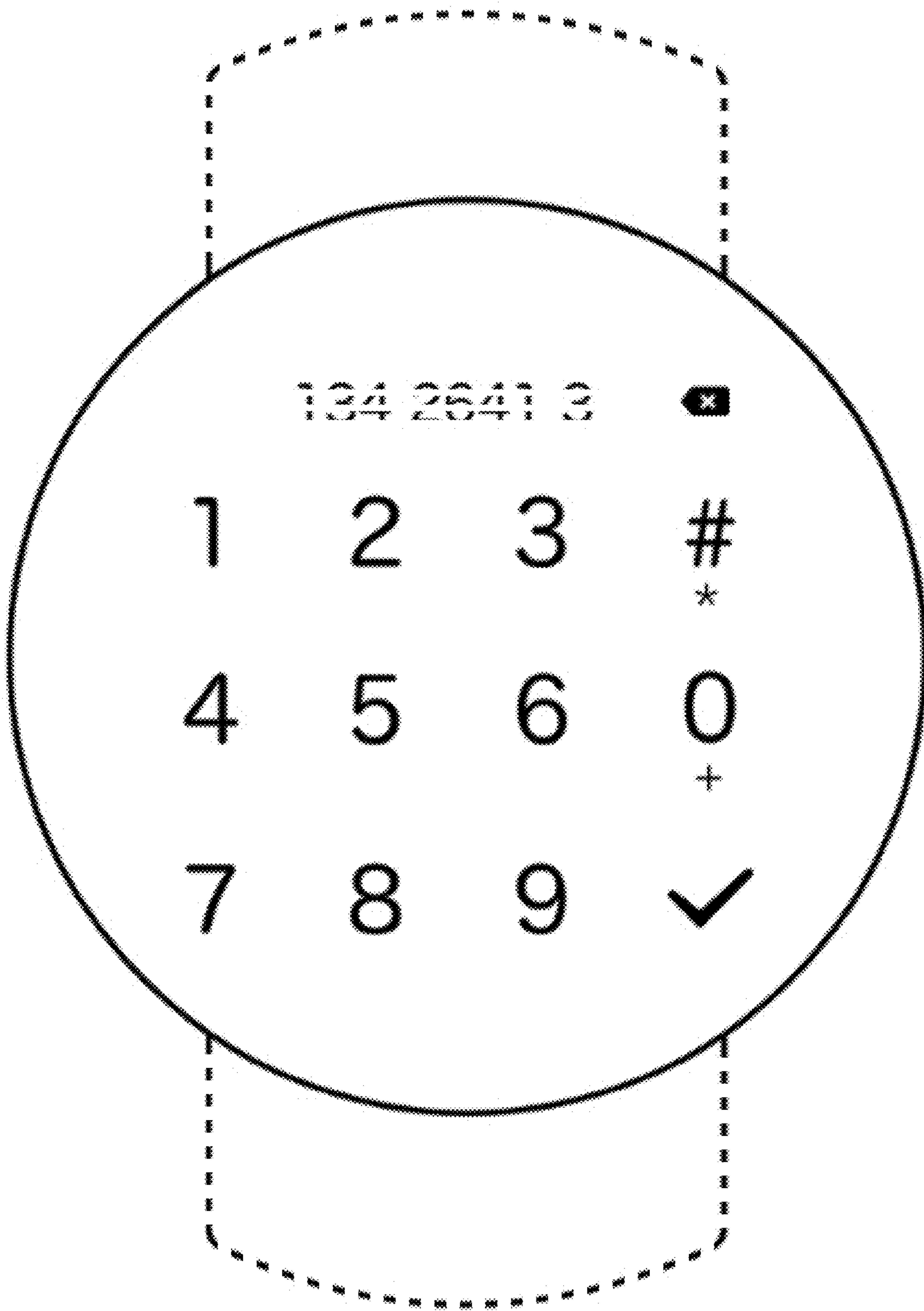

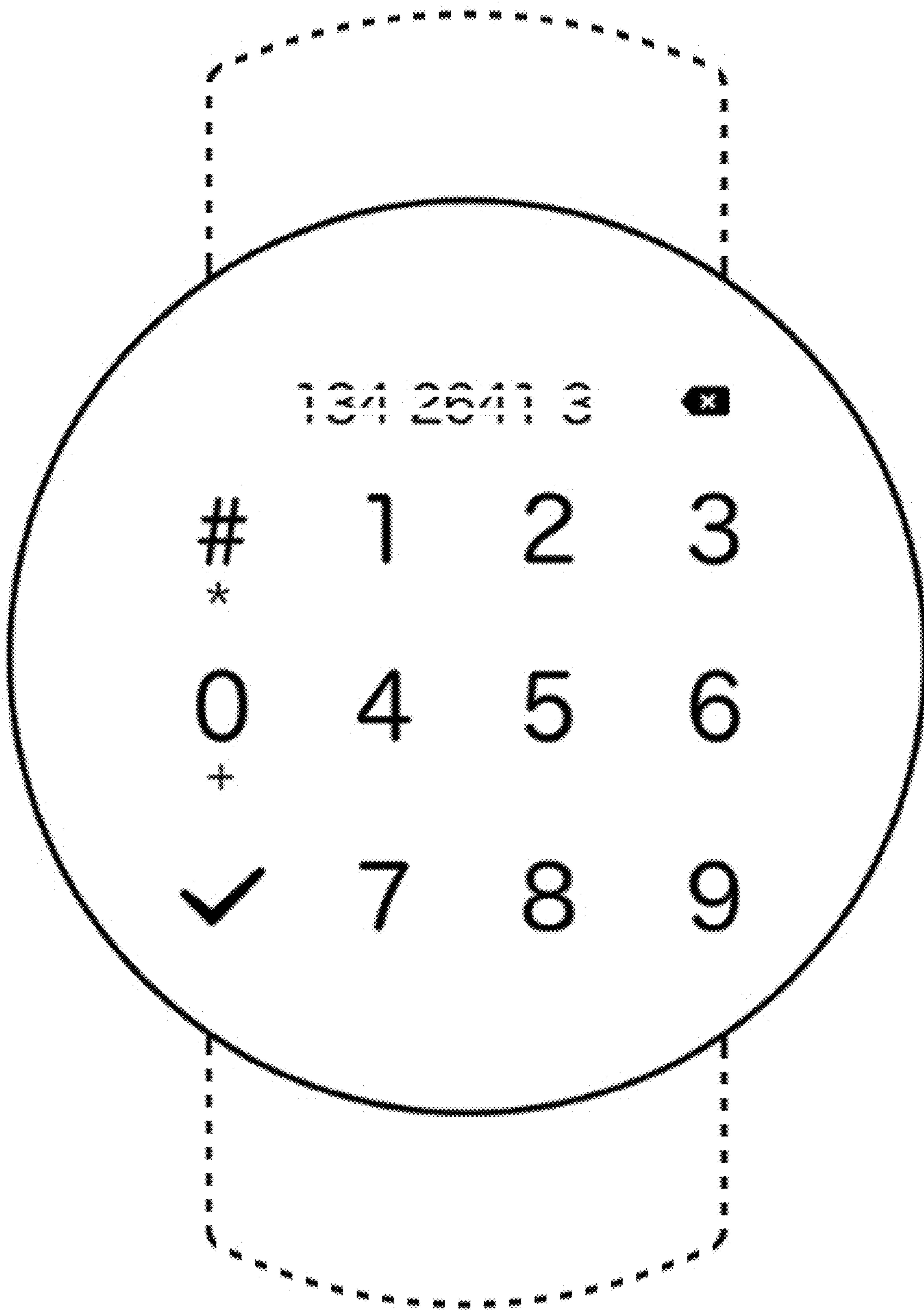

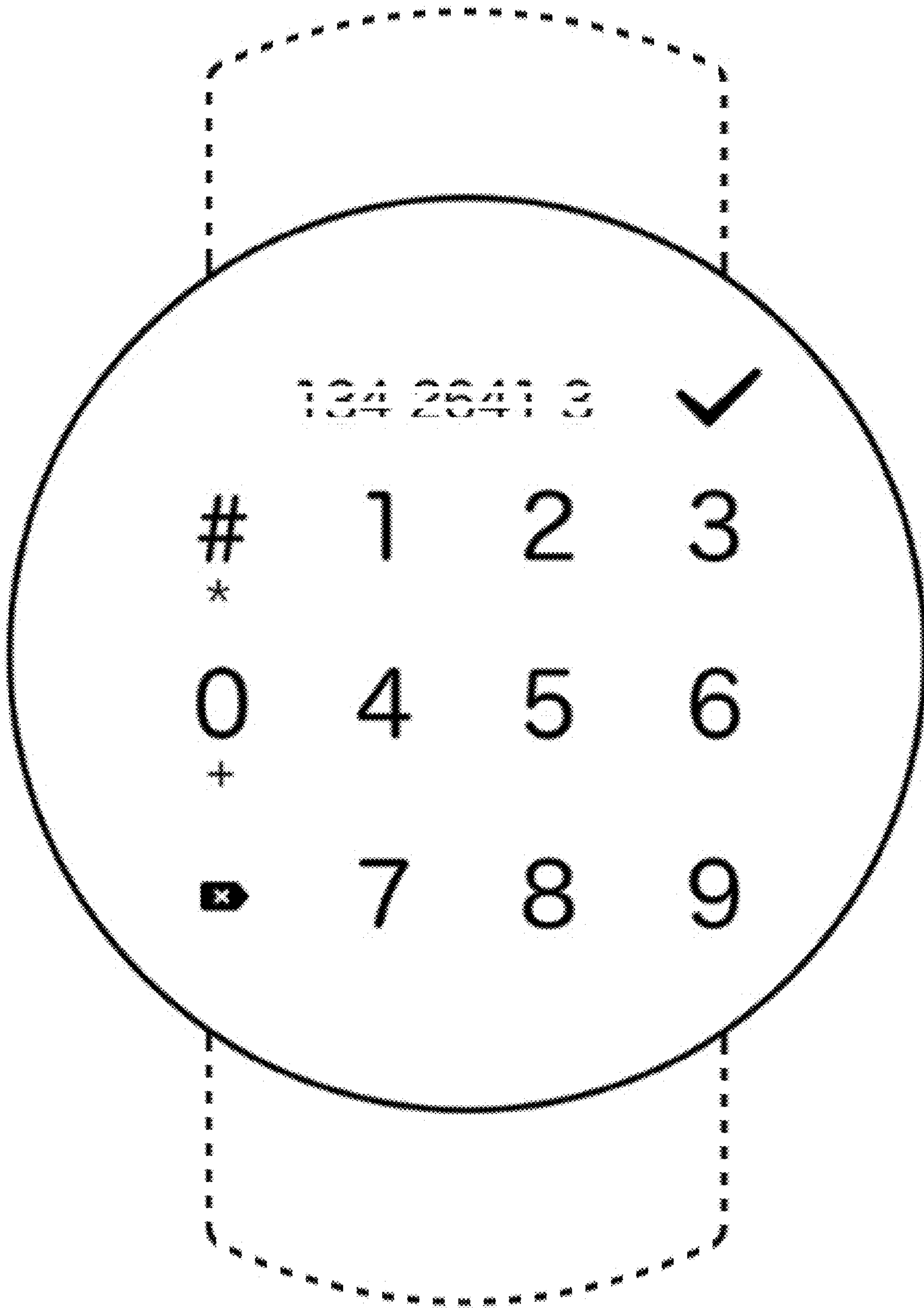

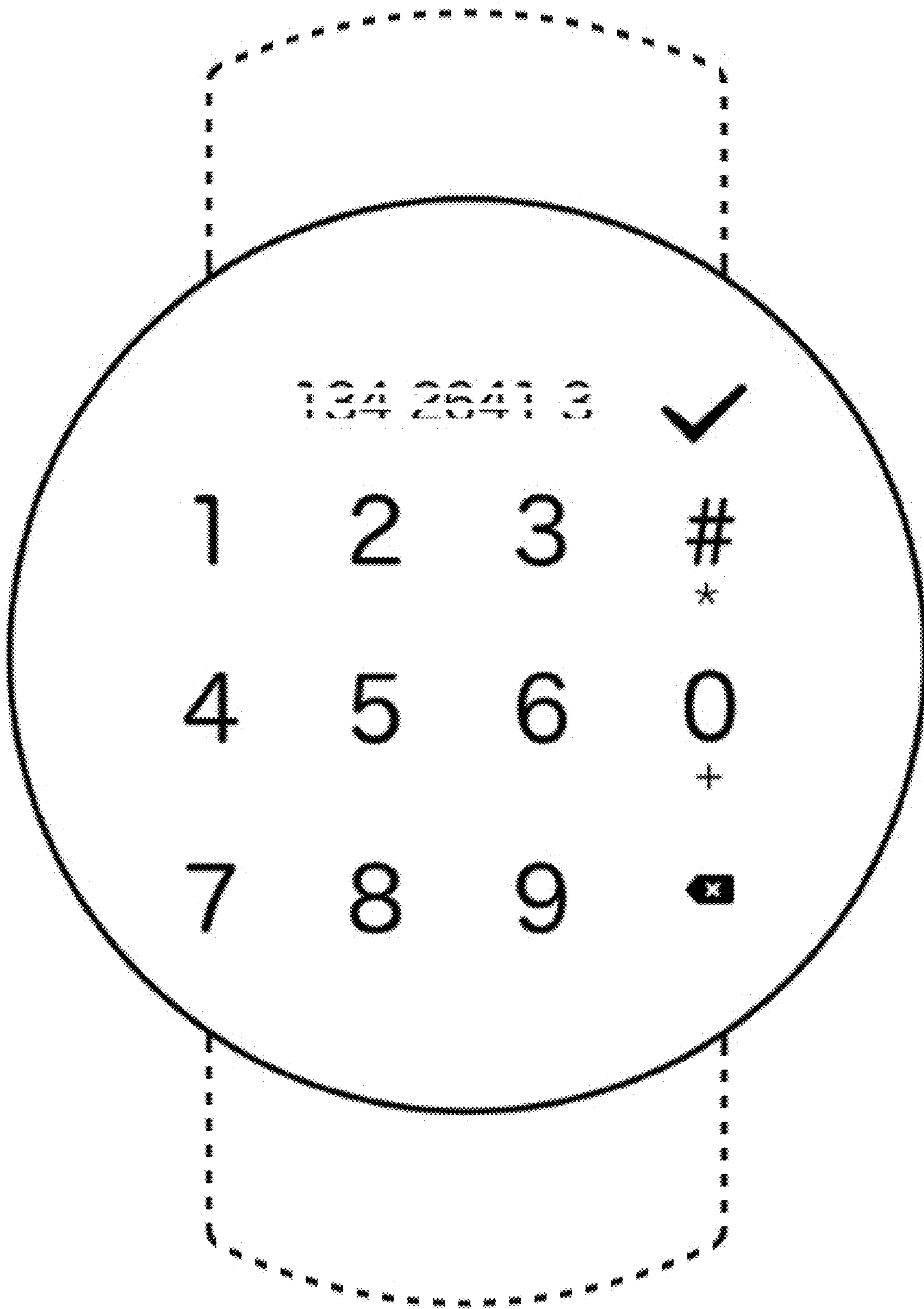

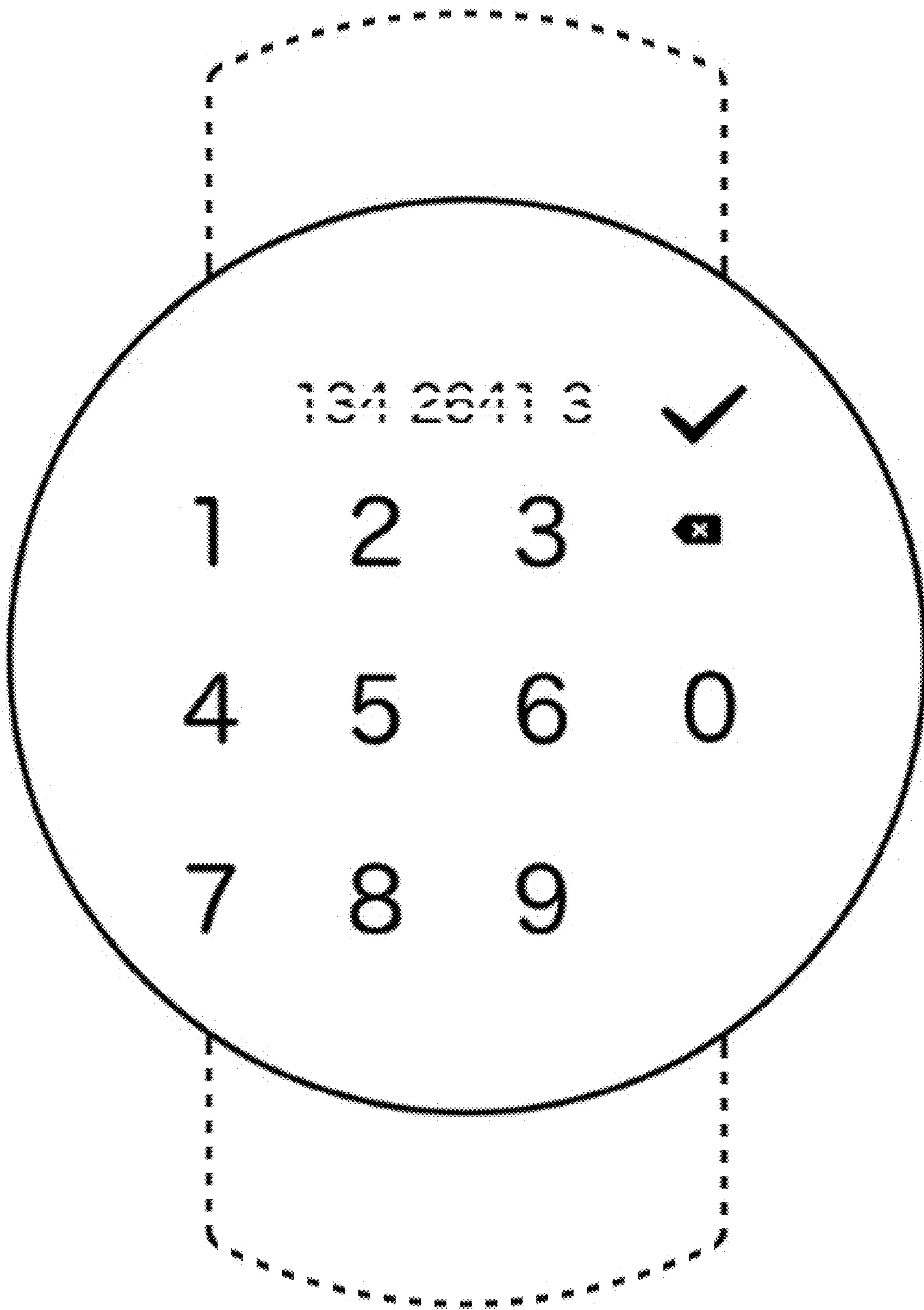

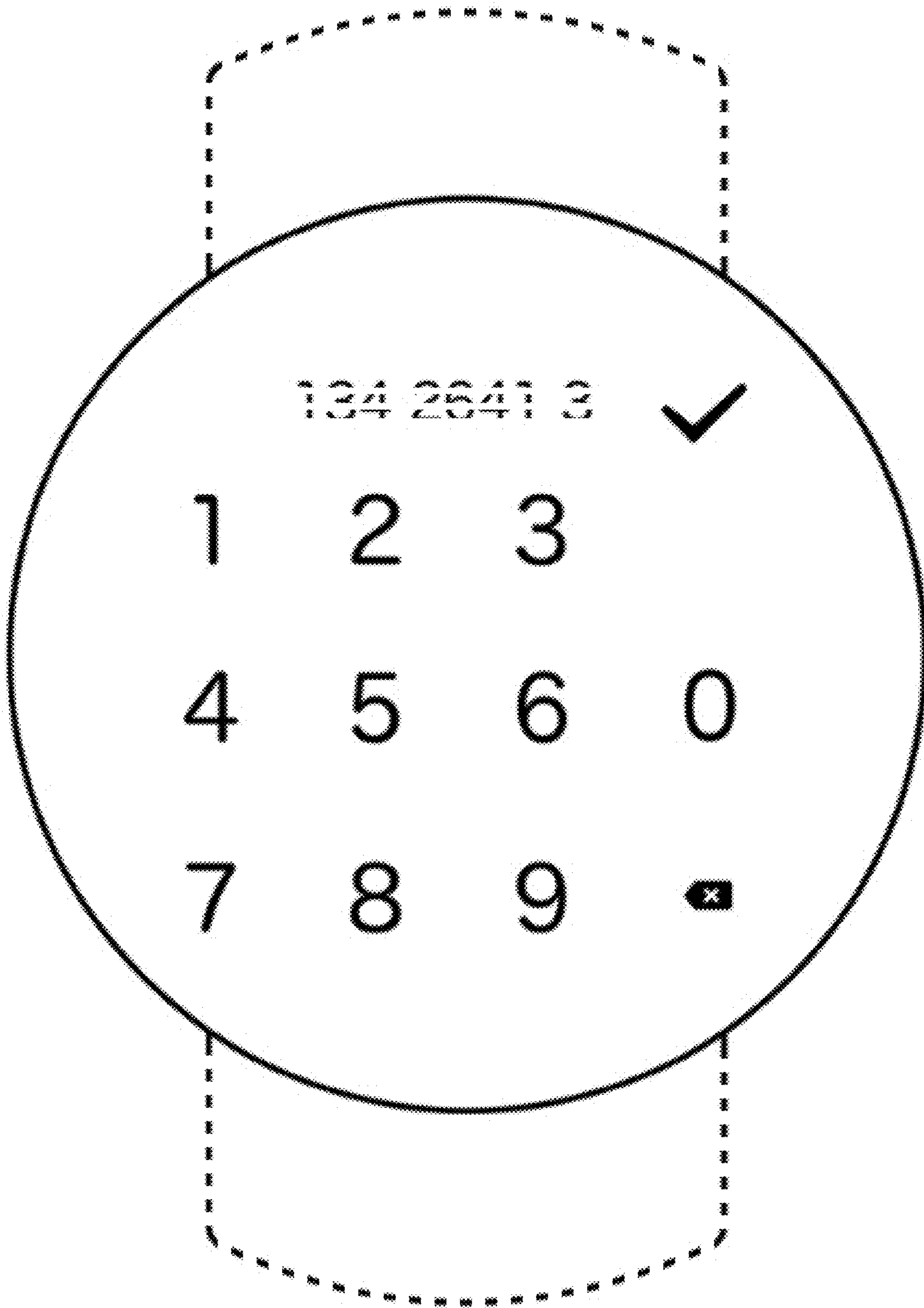

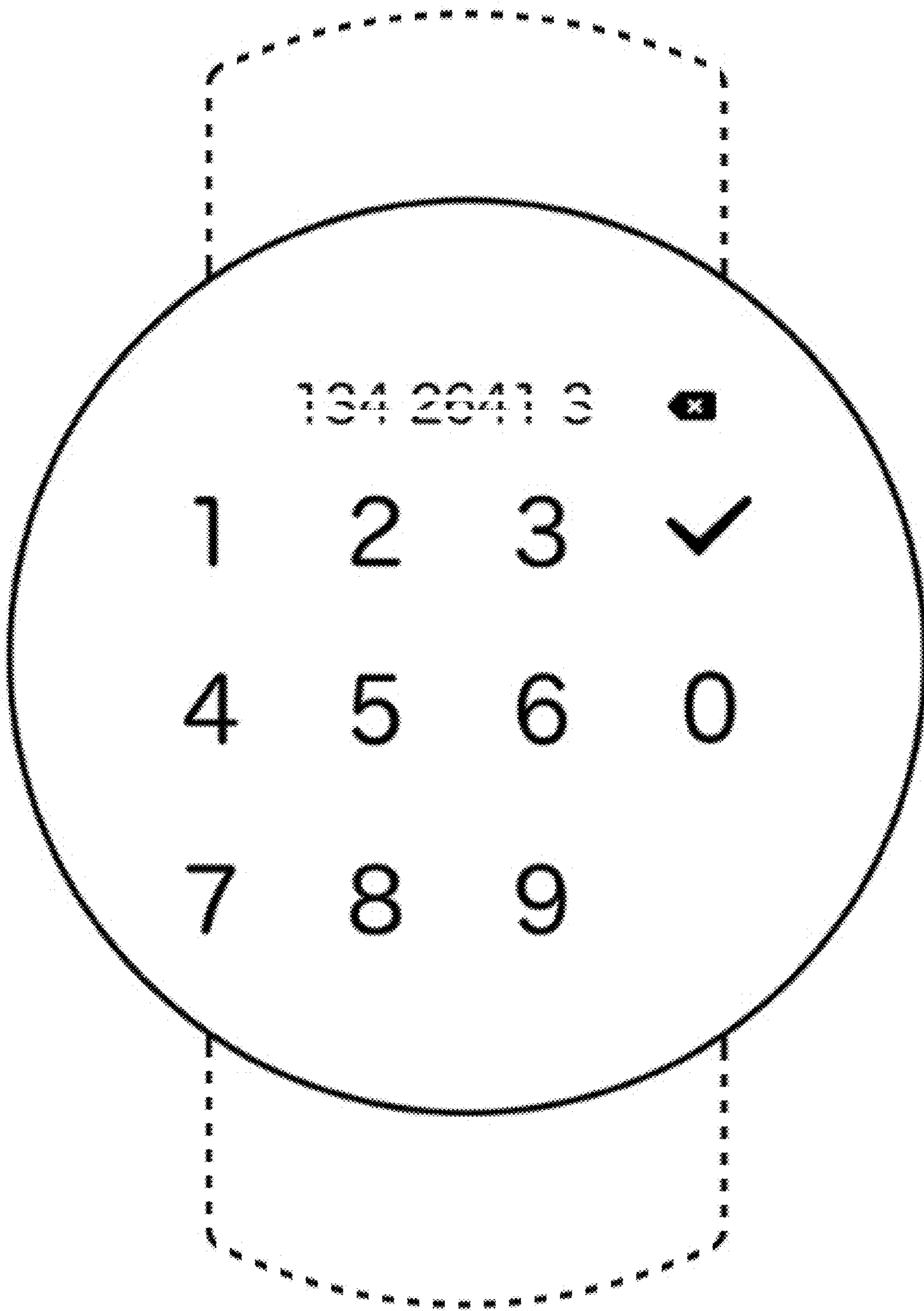

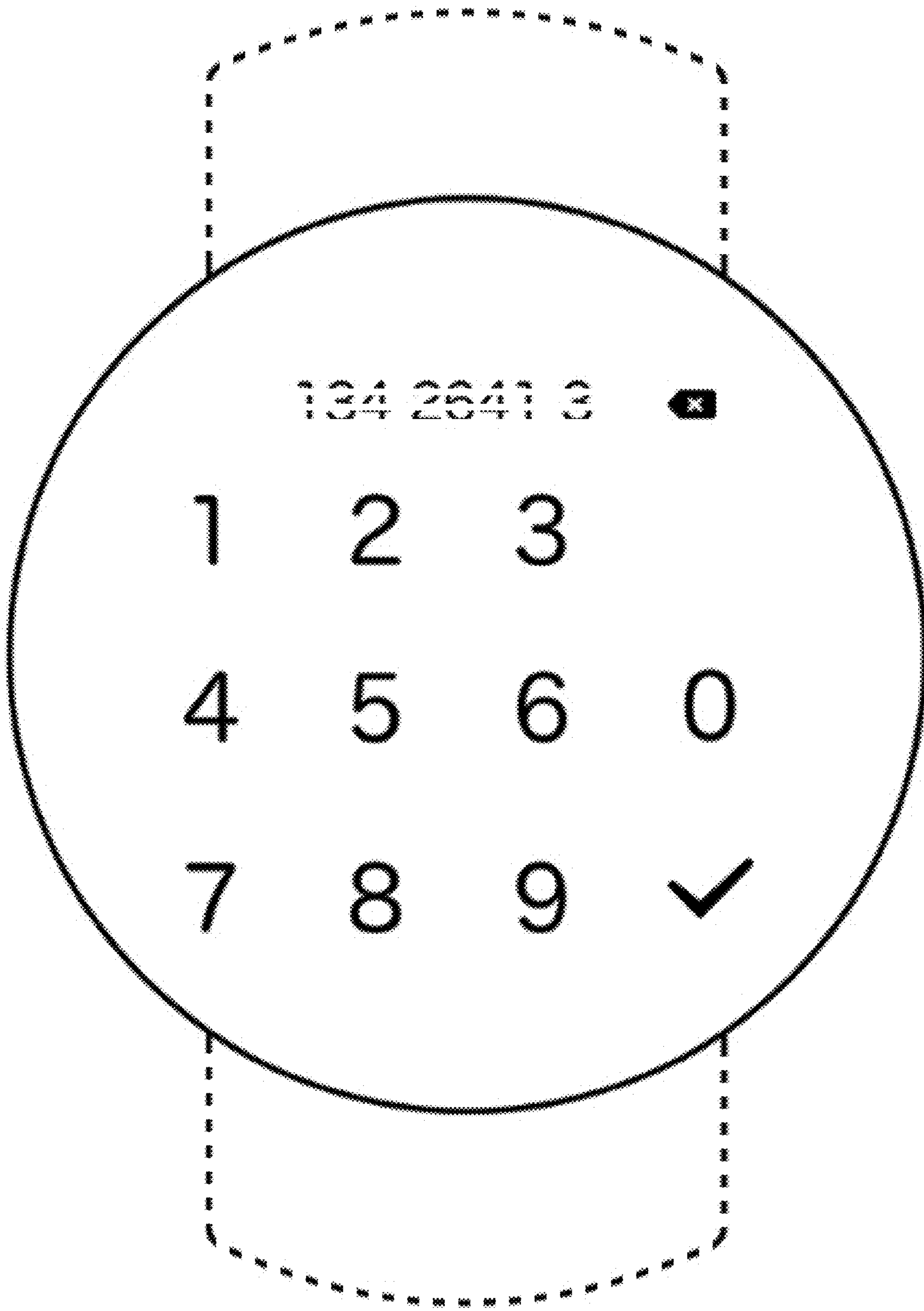
