The ornamental design for a display panel portion with a computer generated icon, as shown and described.

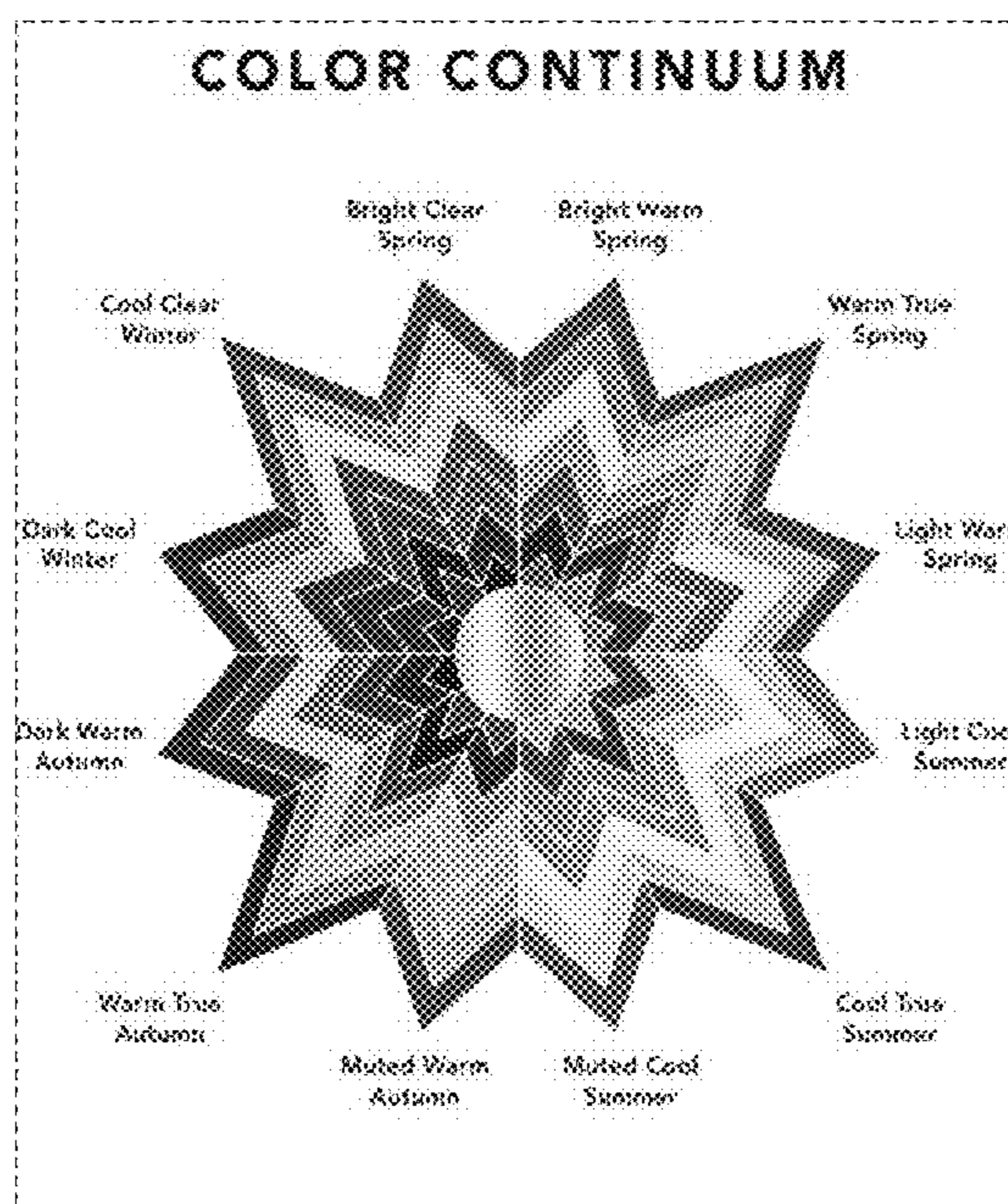
DESCRIPTION
