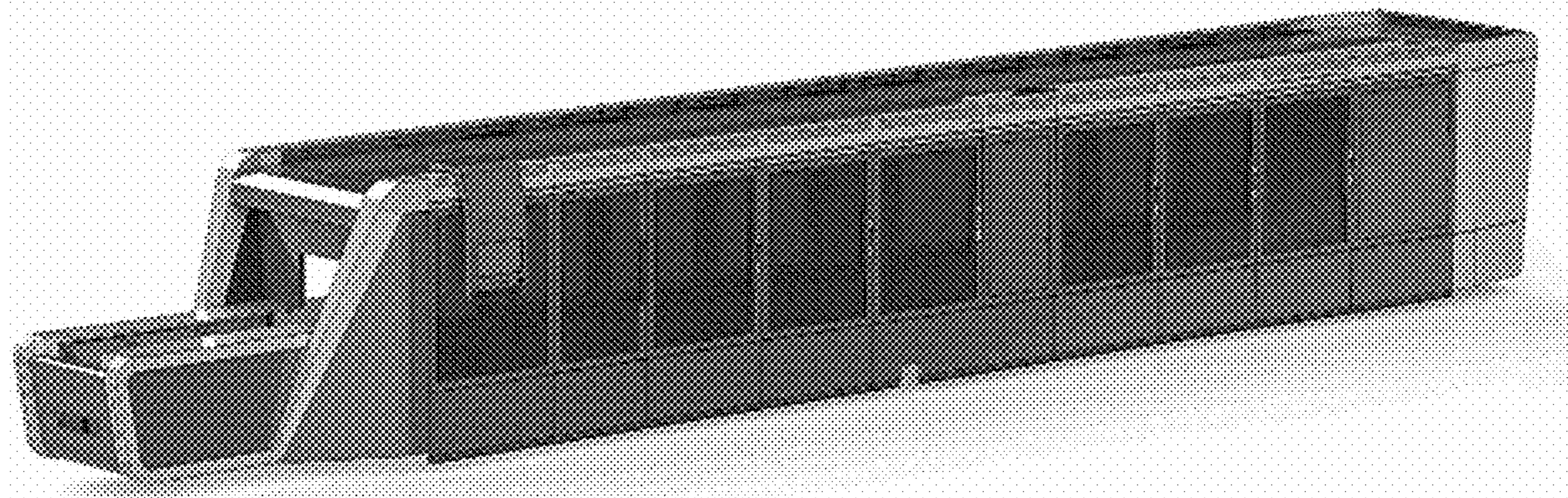

DESCRIPTION

FIG. 1.1 is a front perspective view of a packing machine showing my new design;

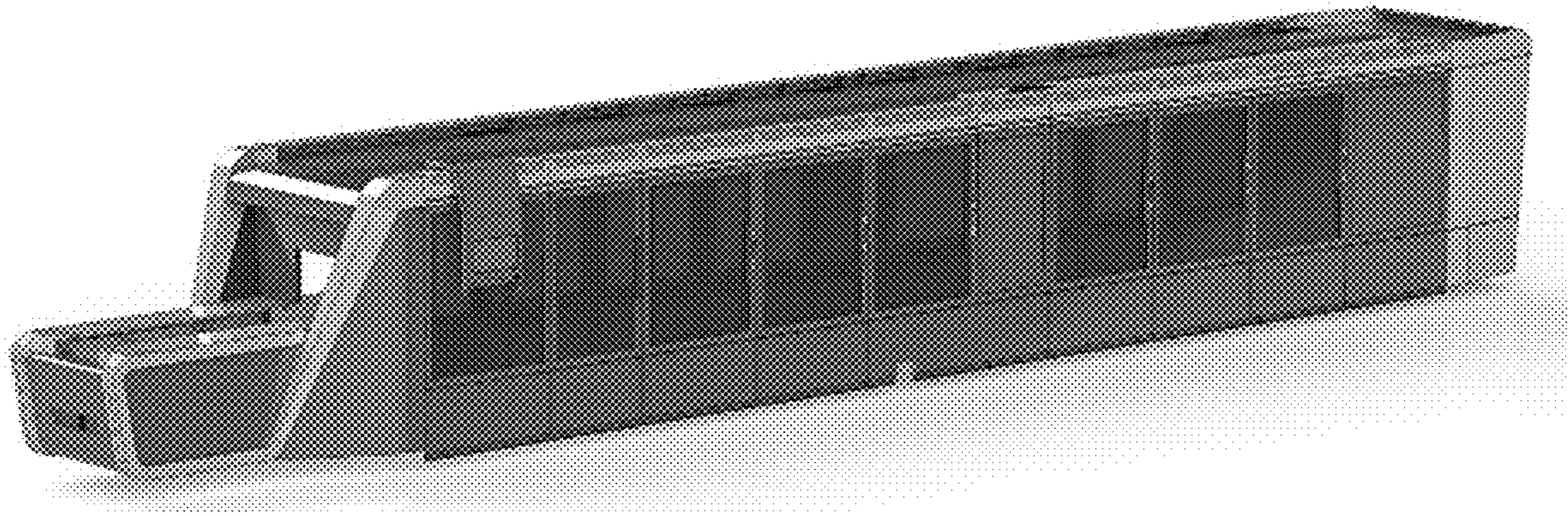

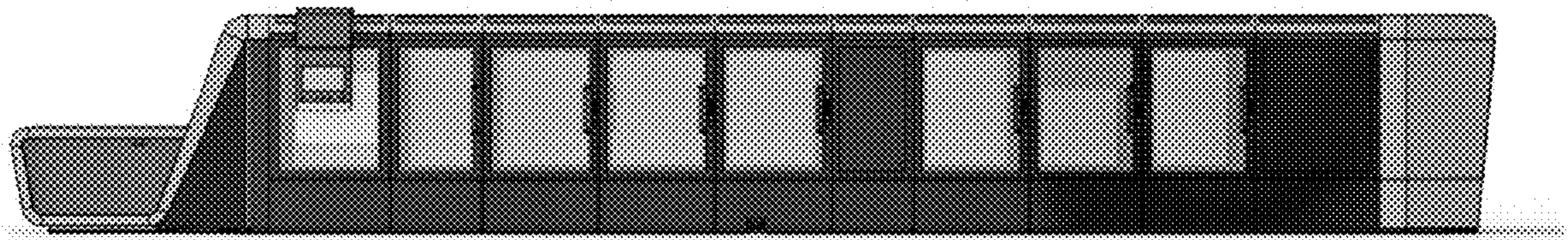

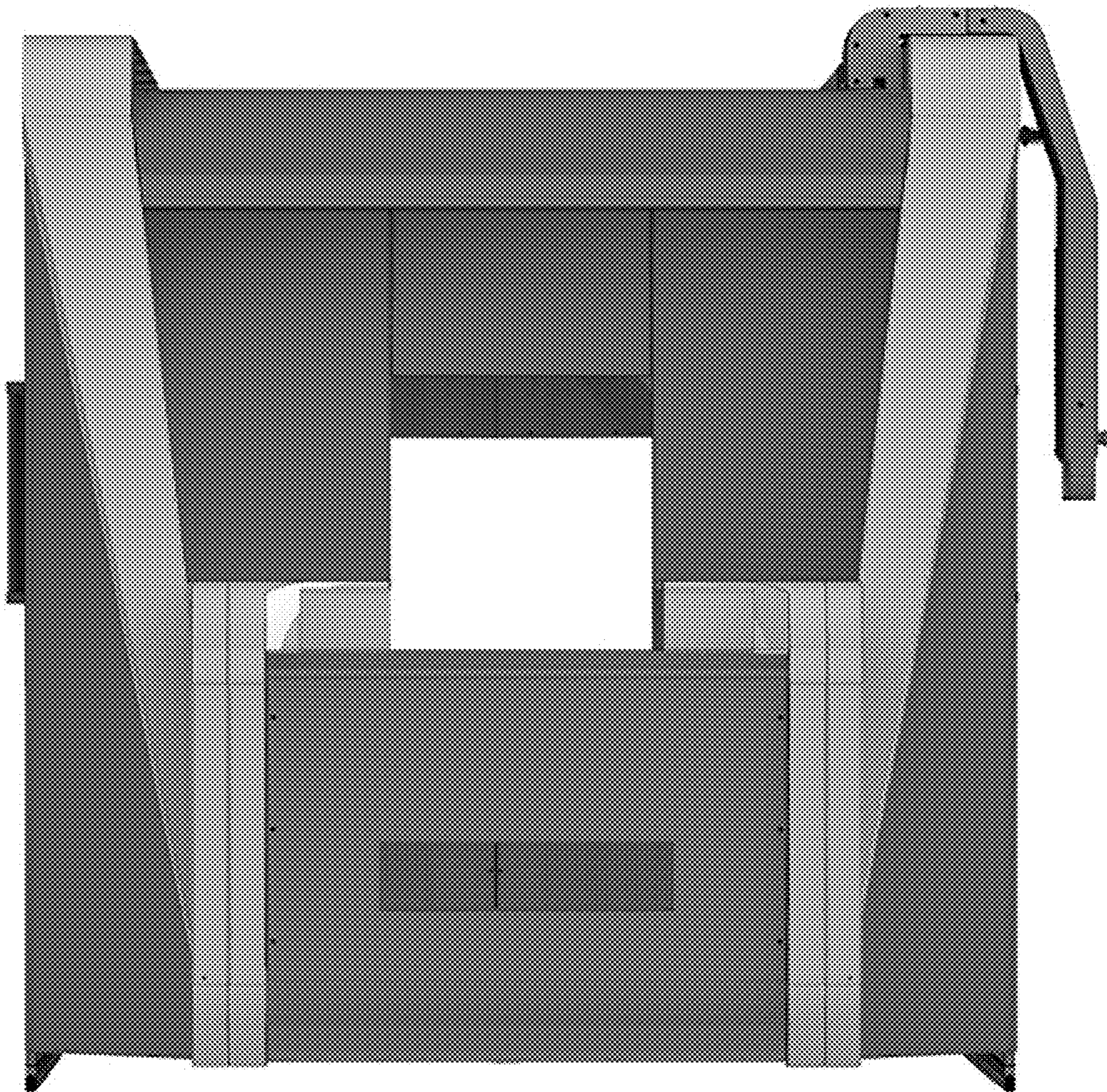
