**DESCRIPTION**

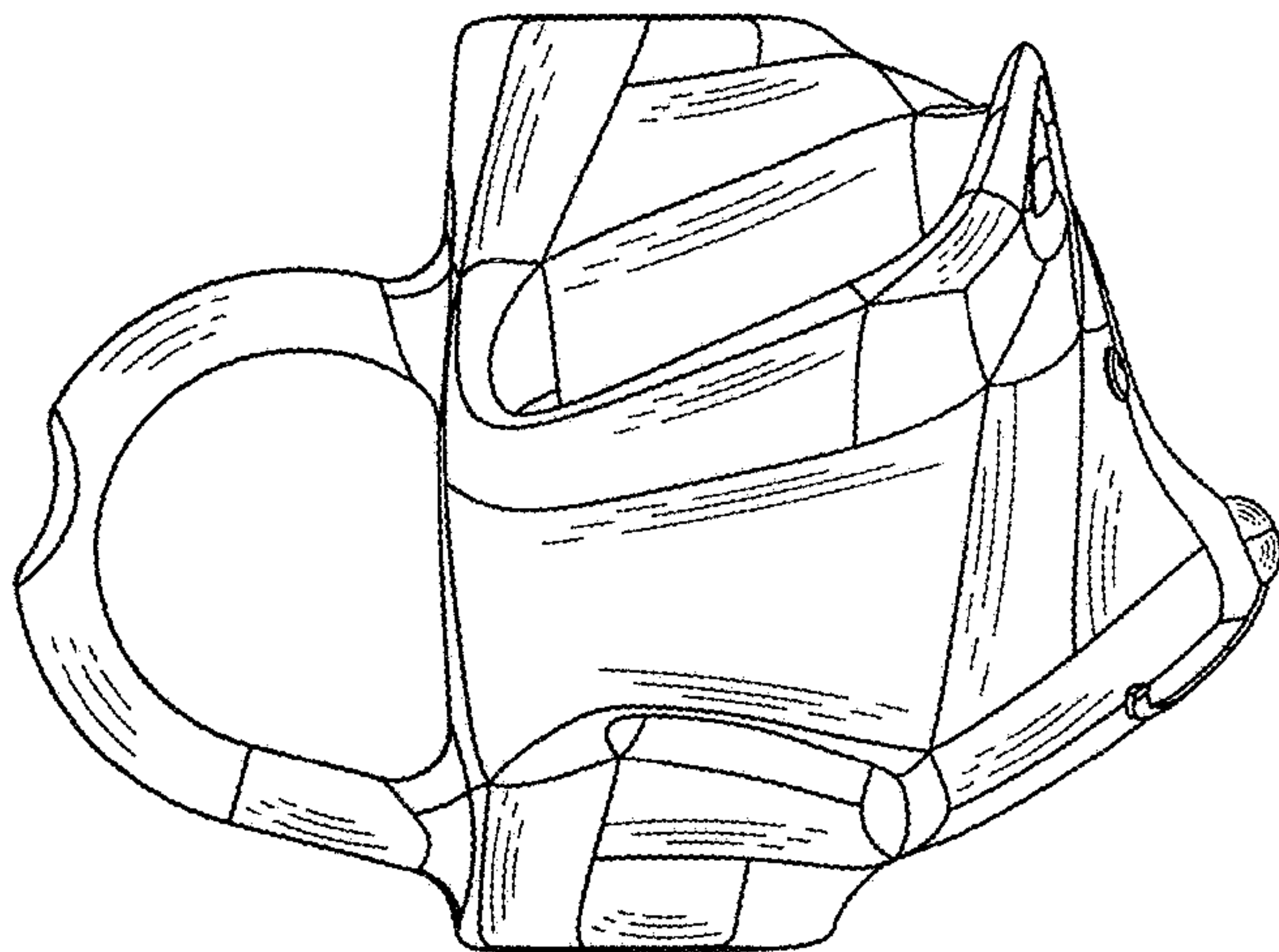
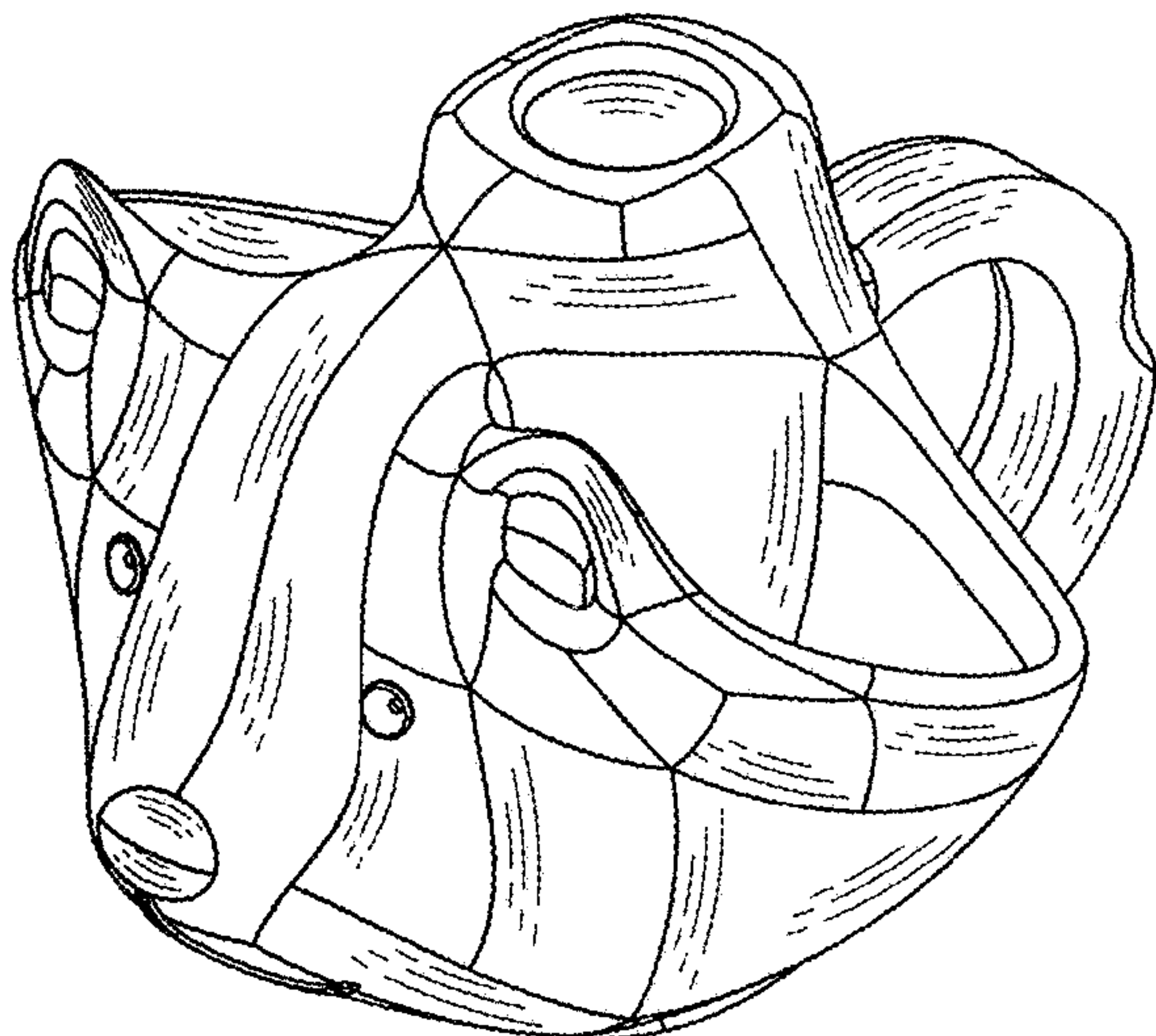
FIG. 1 is a perspective view of a pen grip showing my new design;

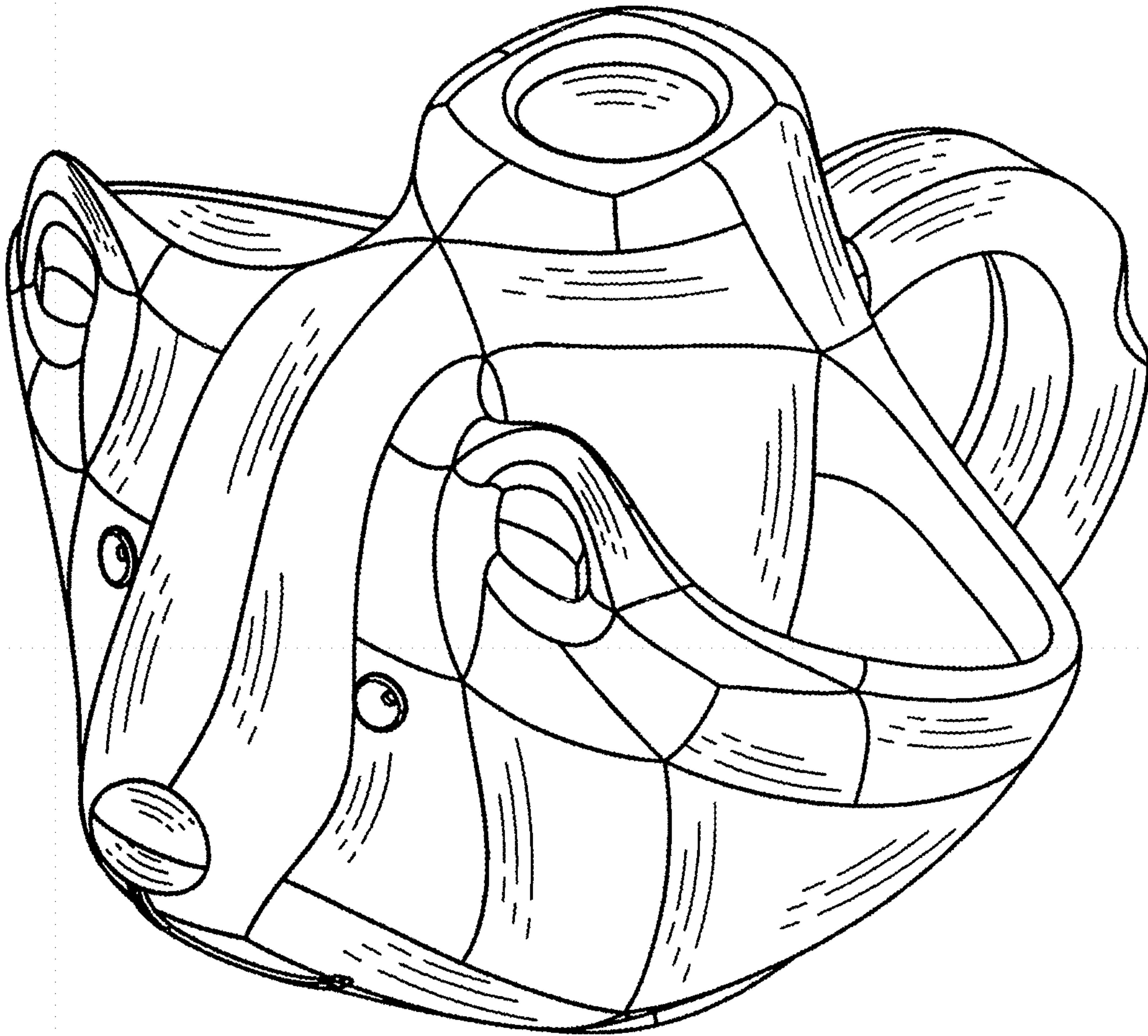

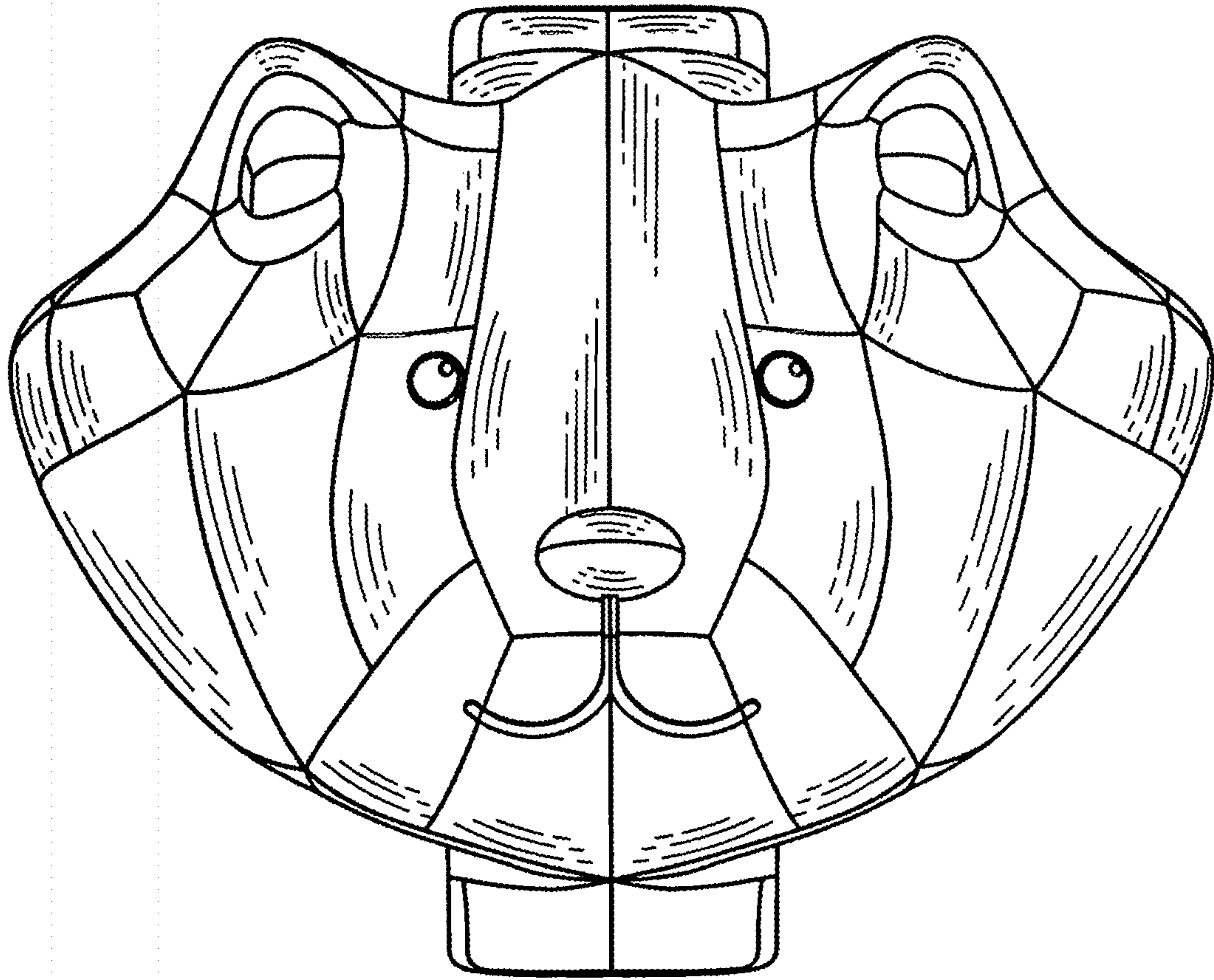

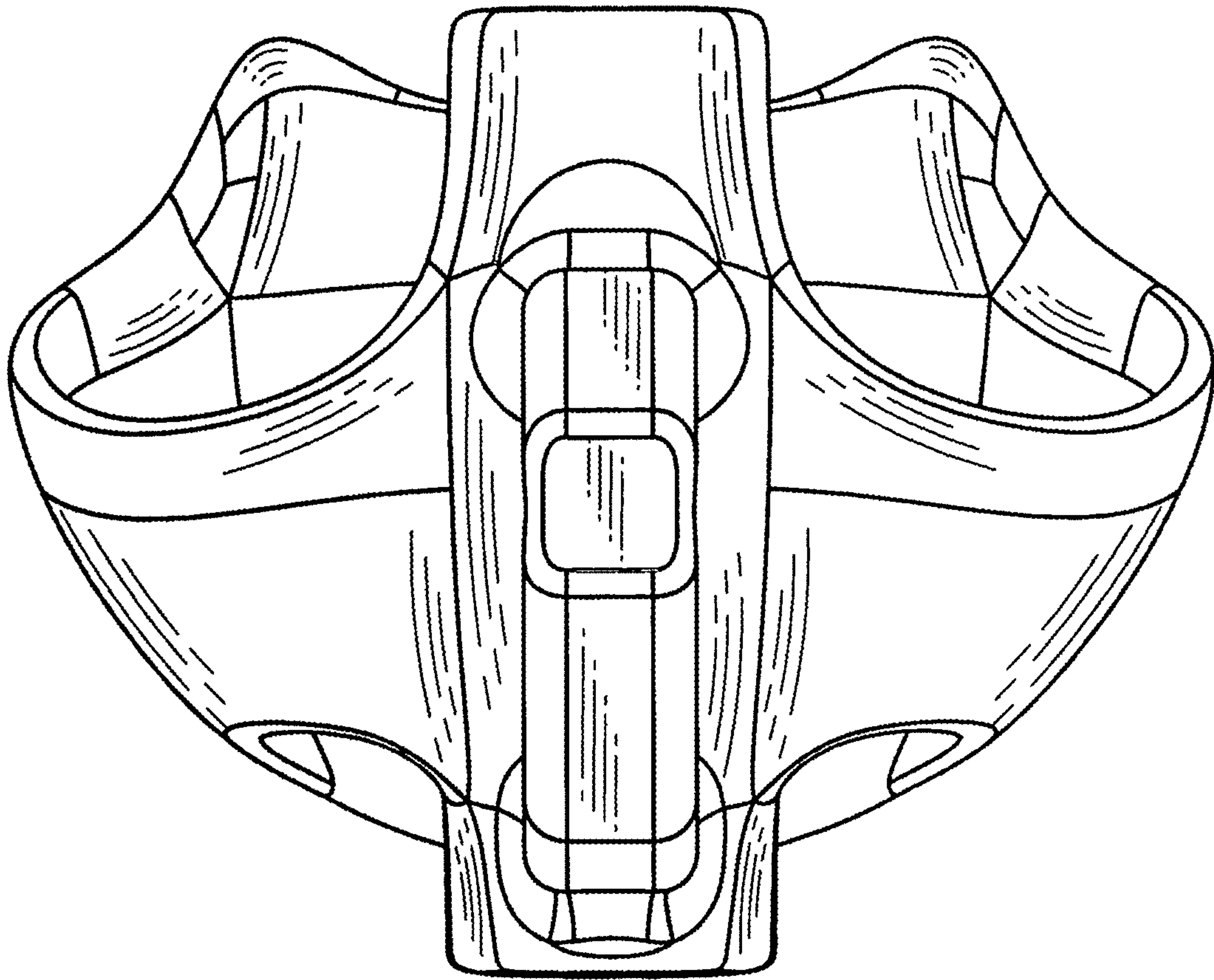

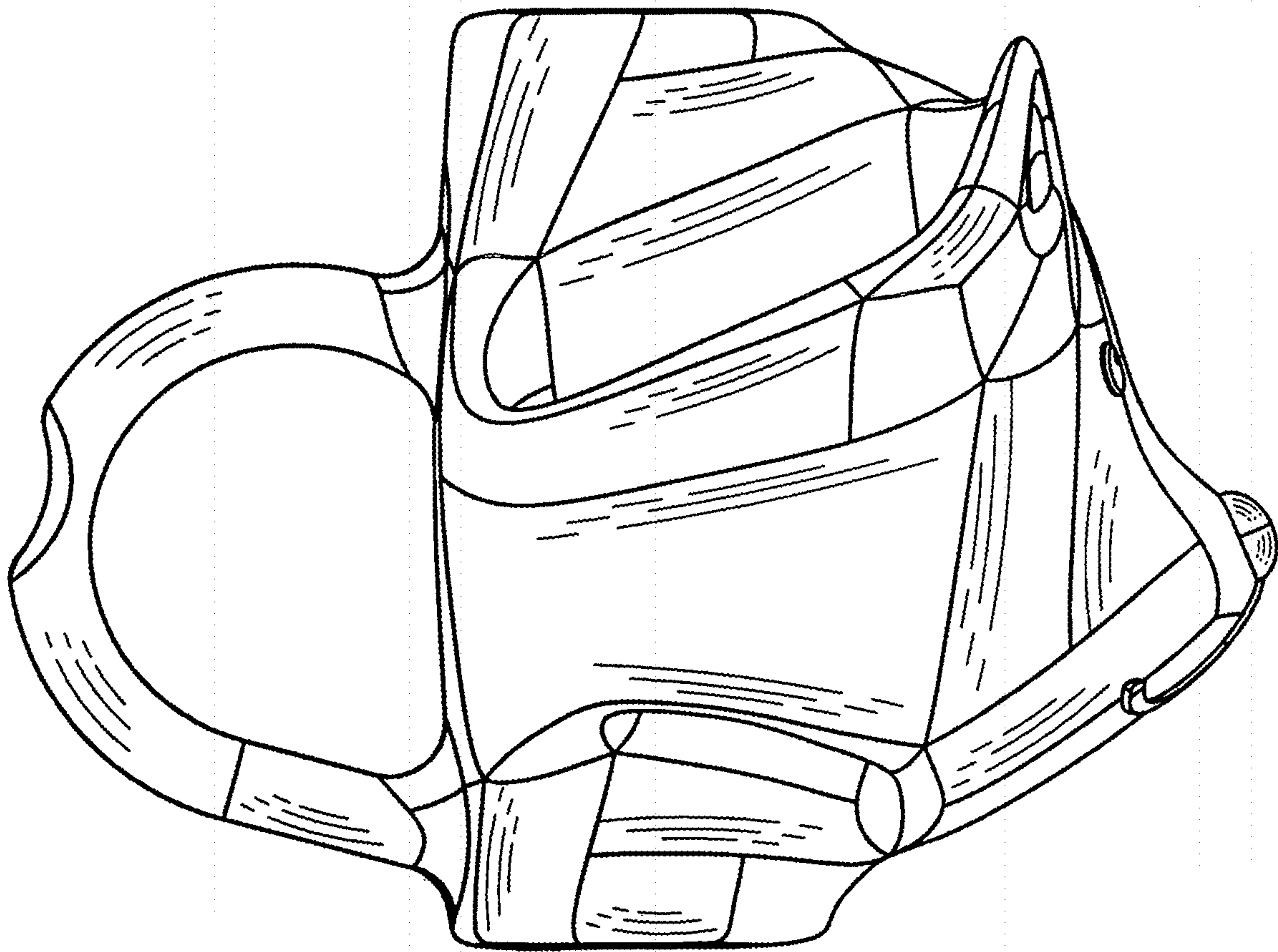

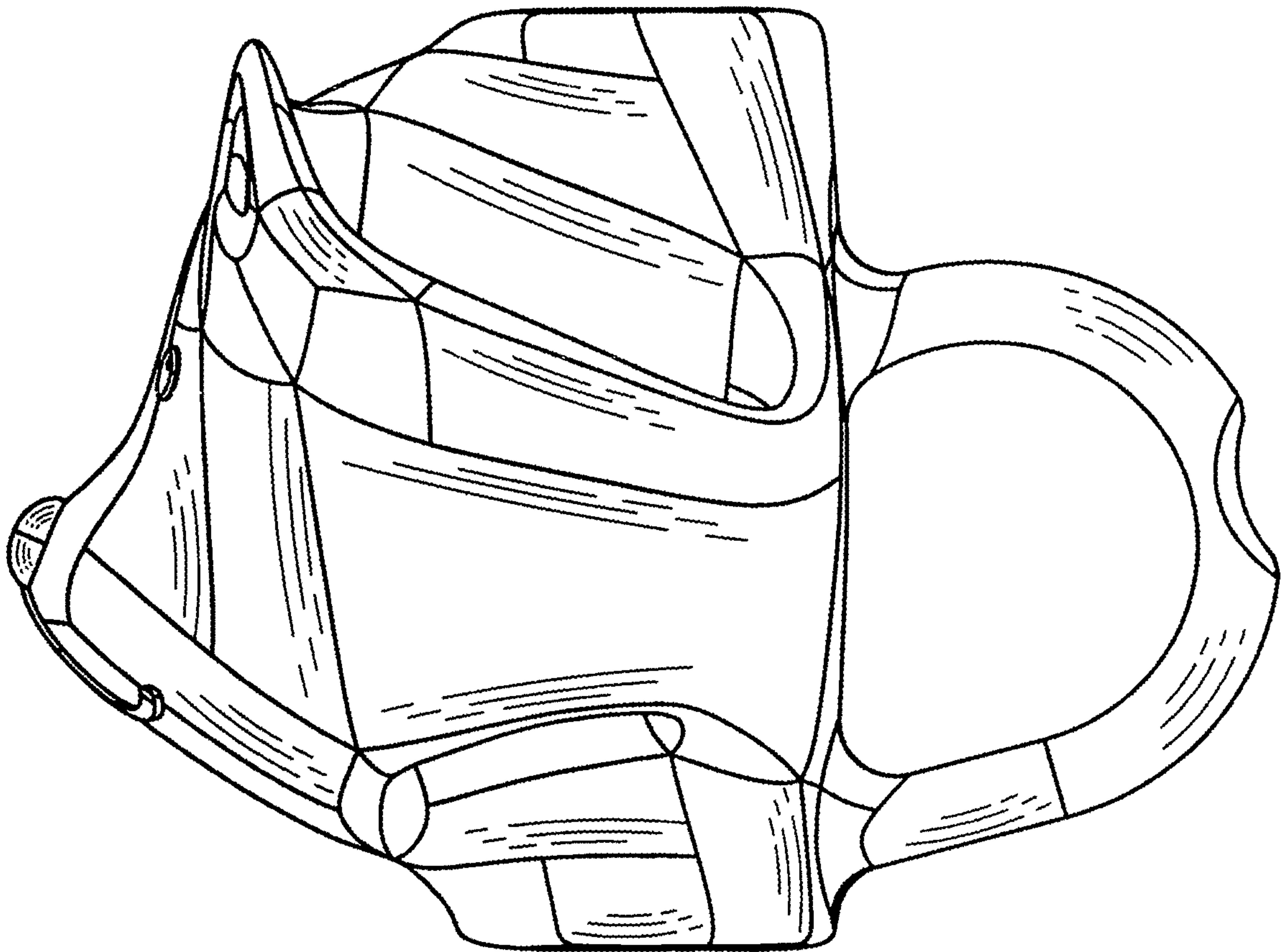

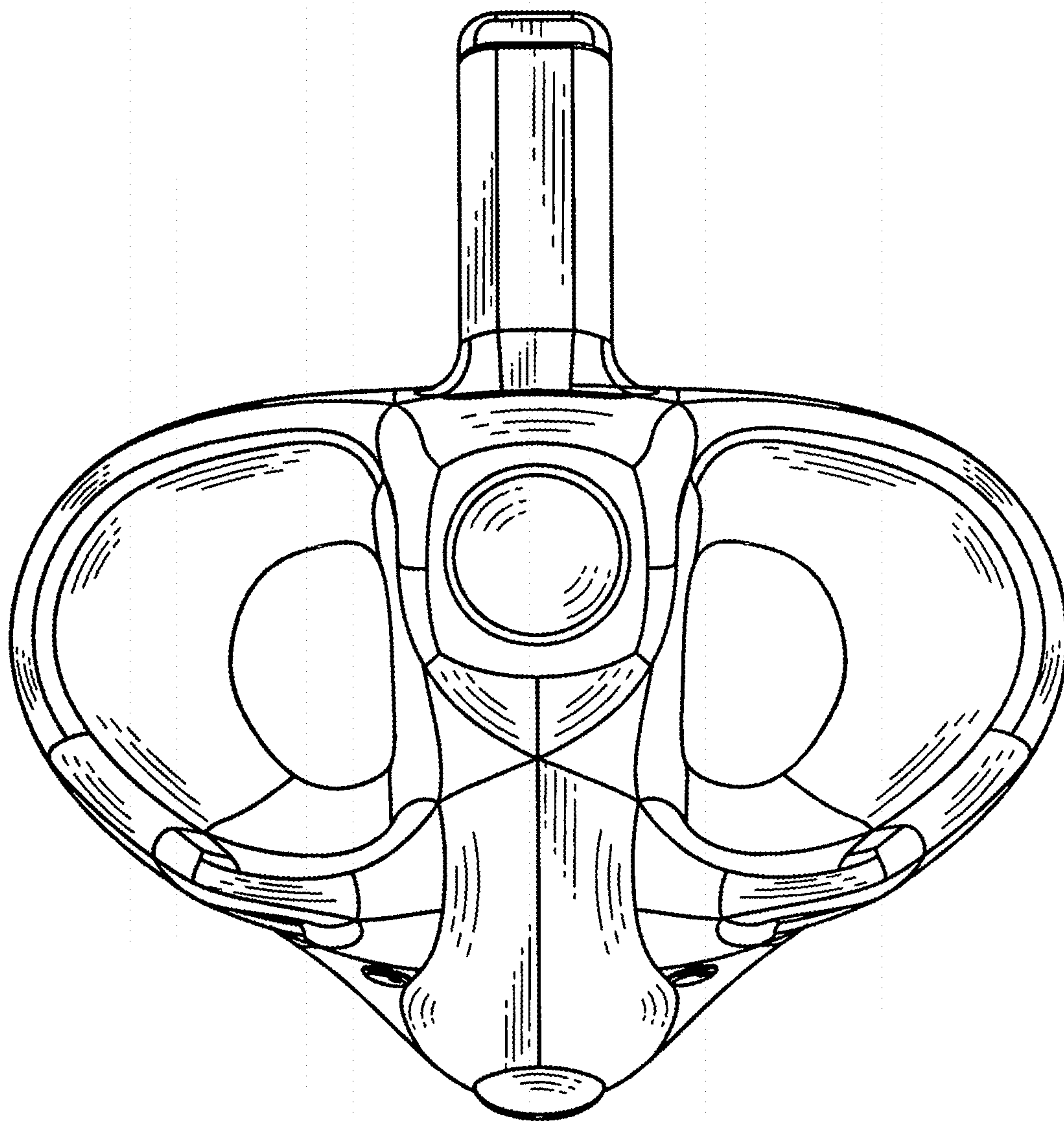

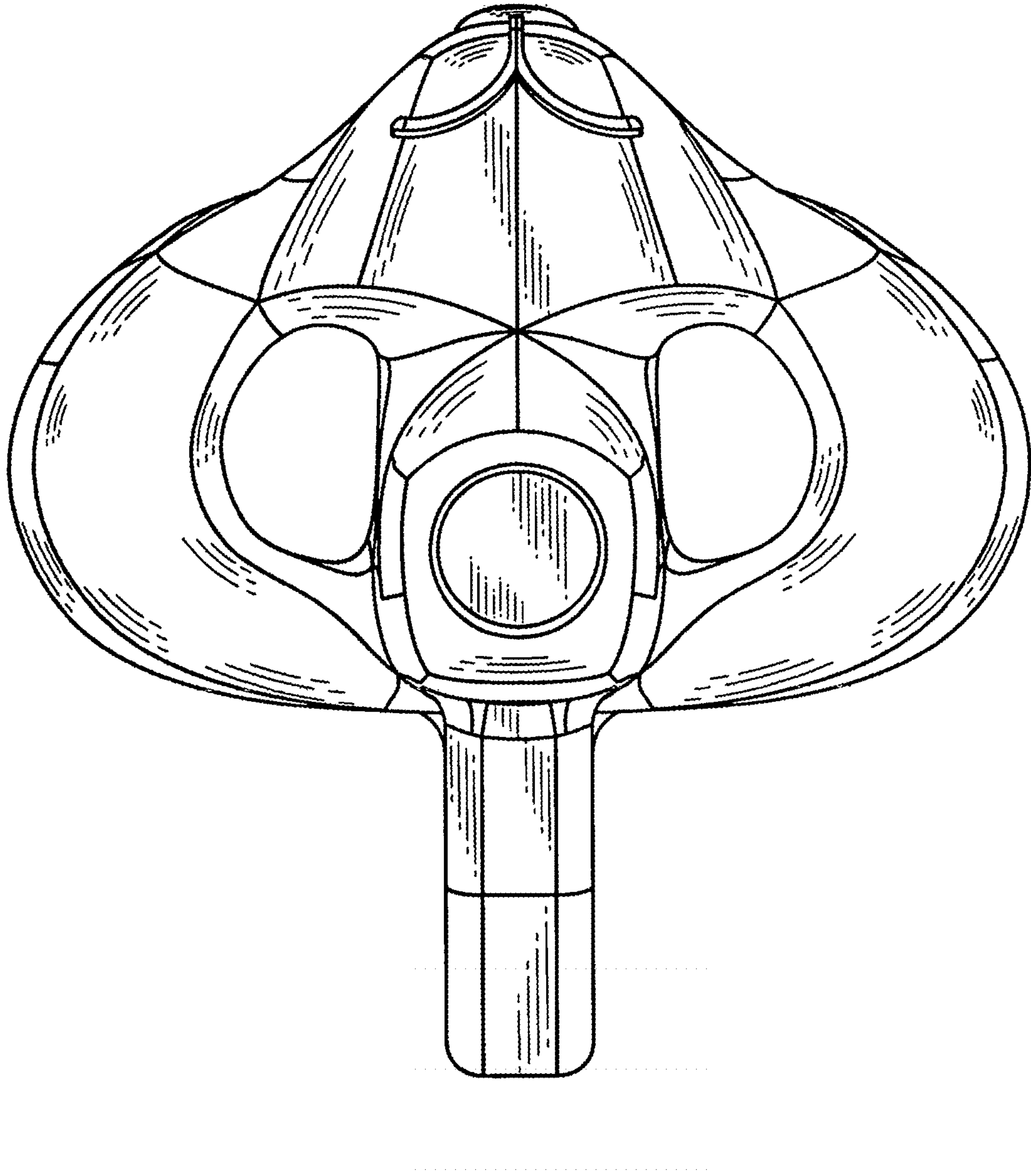
