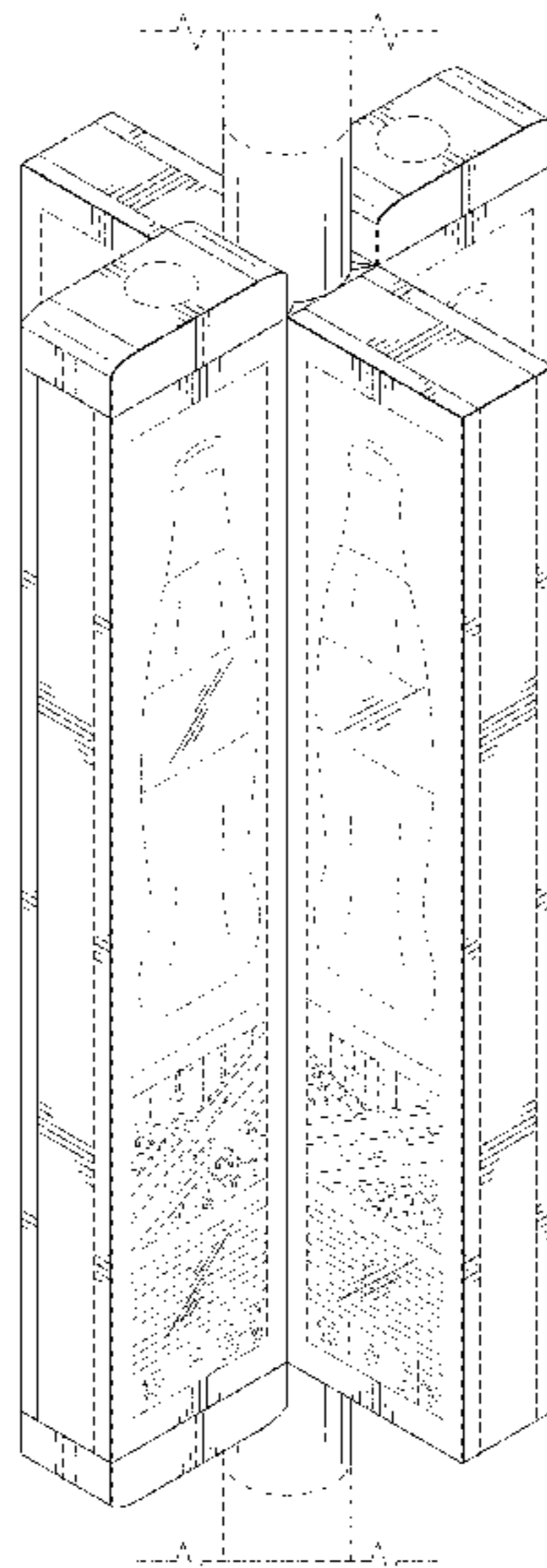
(57) **CLAIM**

I claim the ornamental design for a combined electronic display assemblies and pole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the electronic display assemblies and pole, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a left side elevation view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a perspective view of the combined electronic display assemblies and pole shown in an environment of use. The evenly spaced broken line portions show environment that form no part of the claimed design. The dot-dashed broken lines define the boundary of the claimed design and form no part thereof.

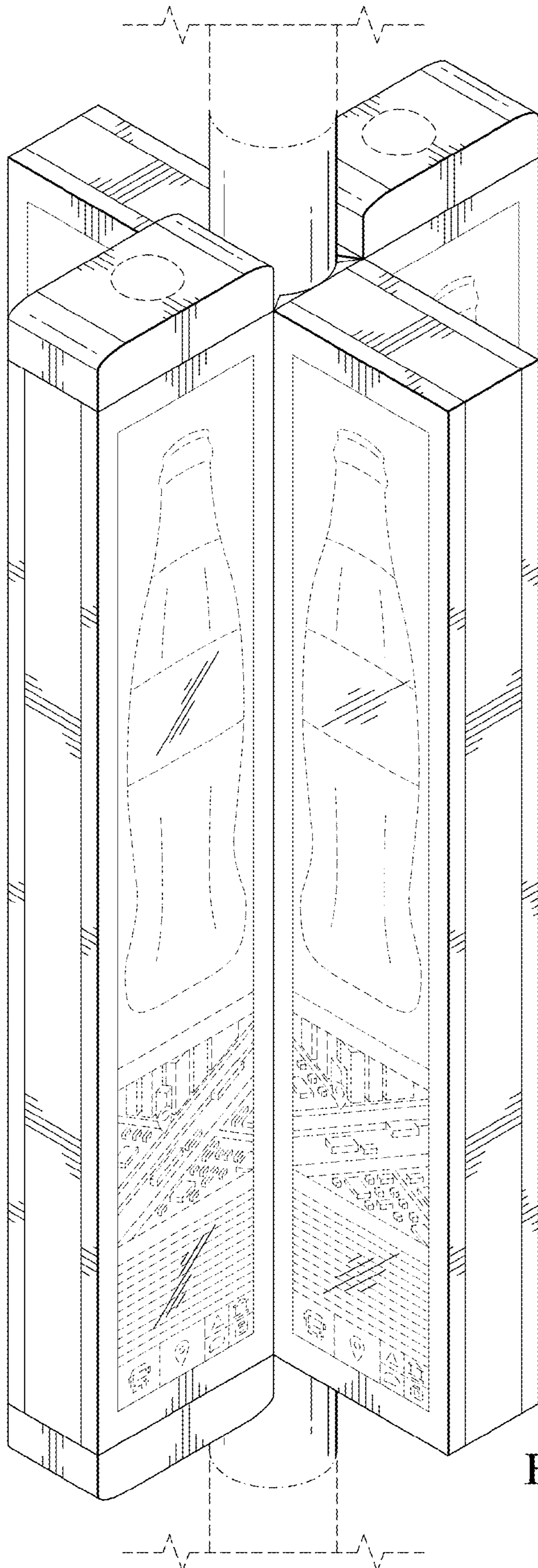

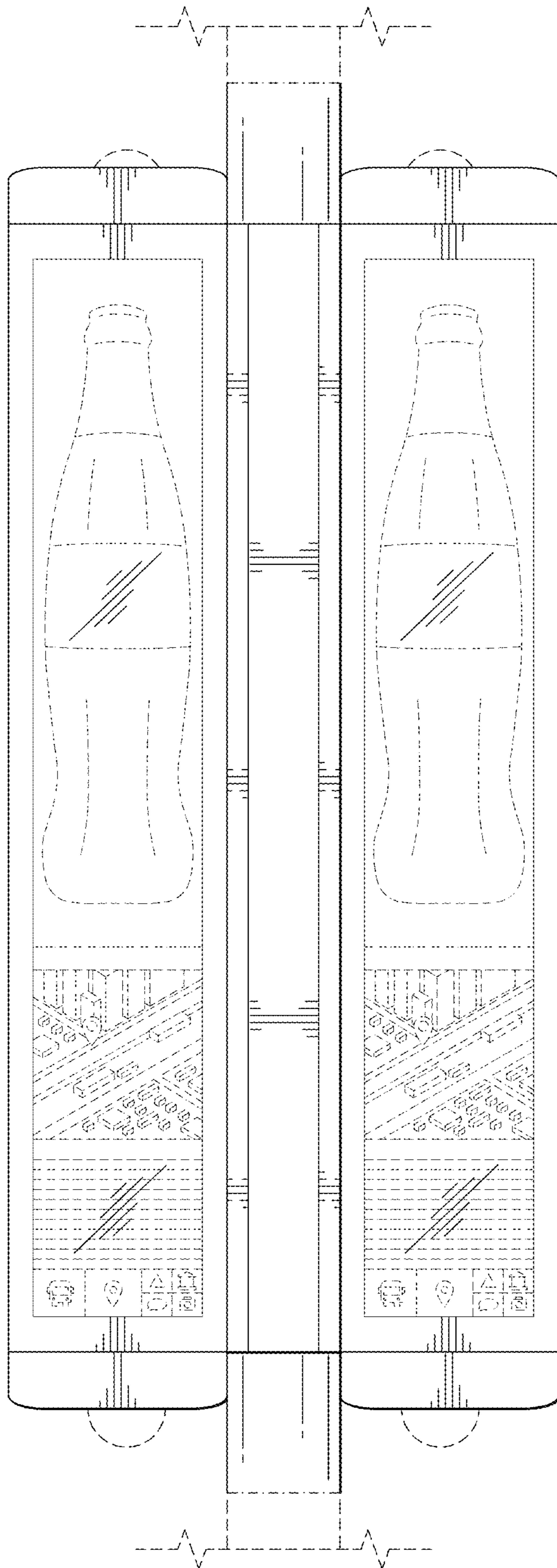

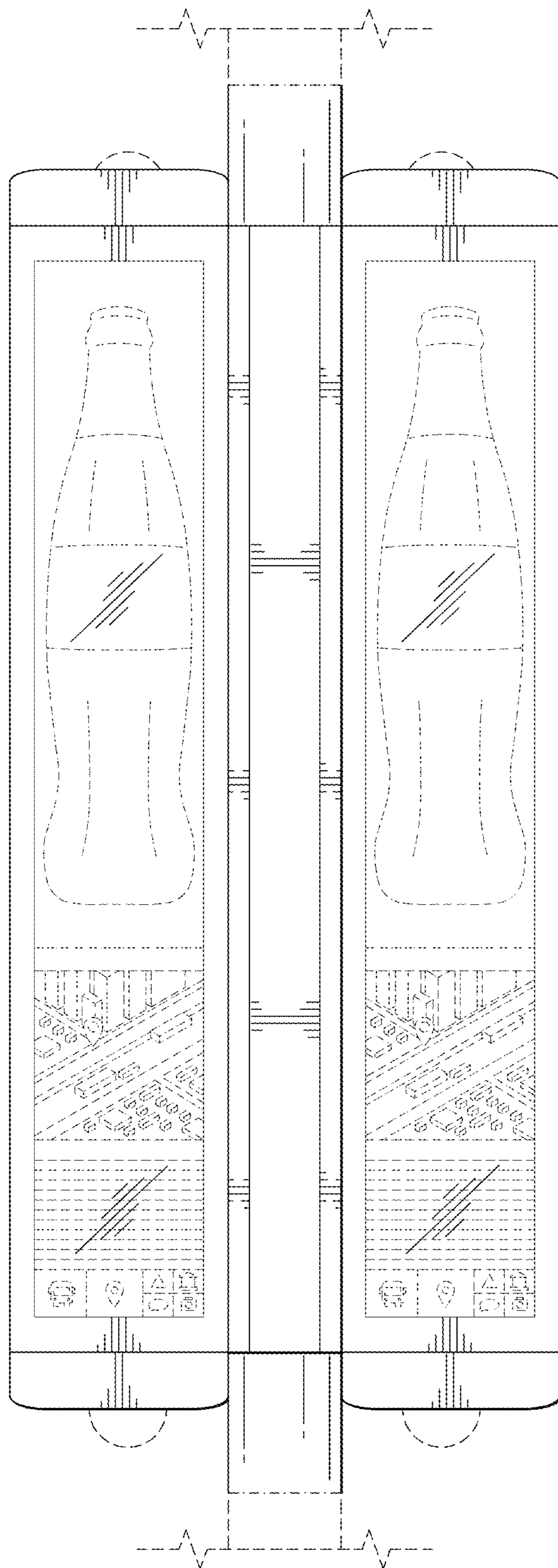

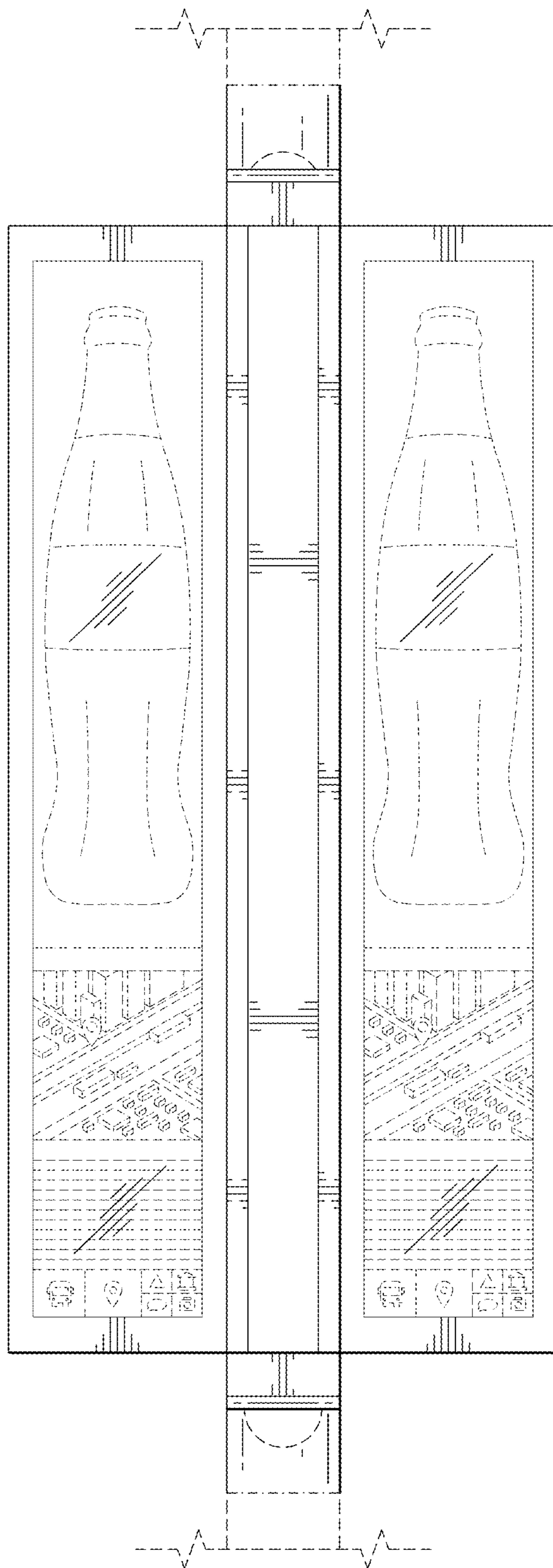

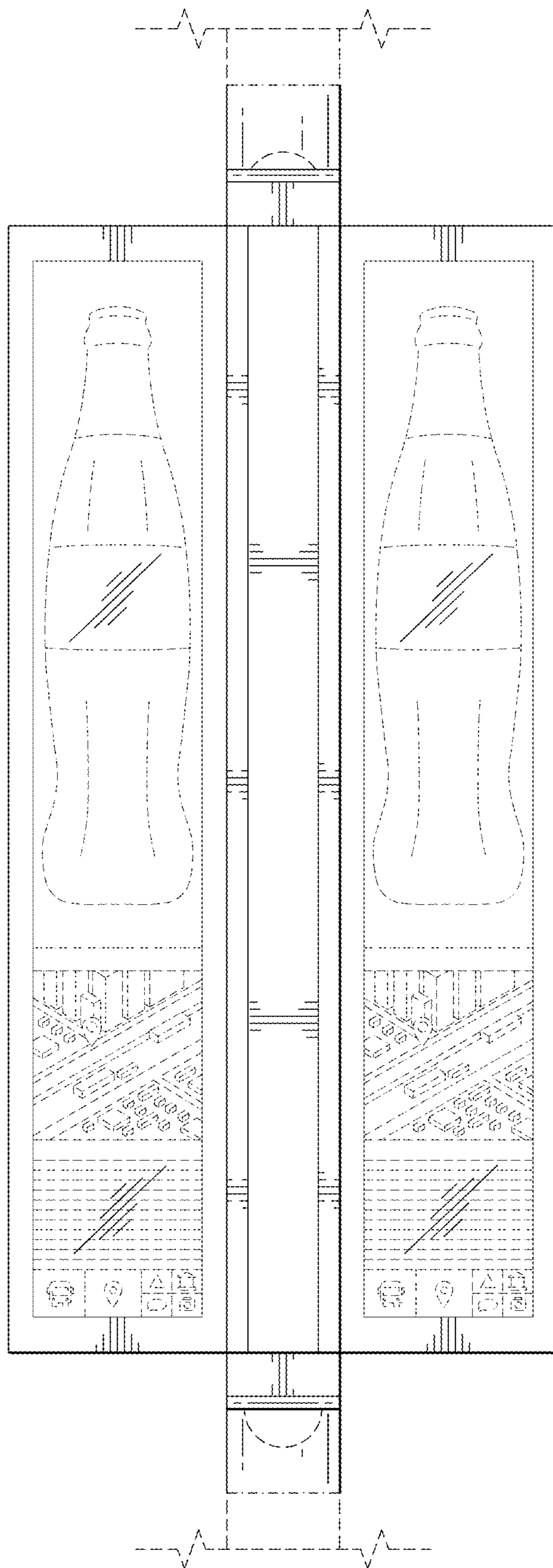

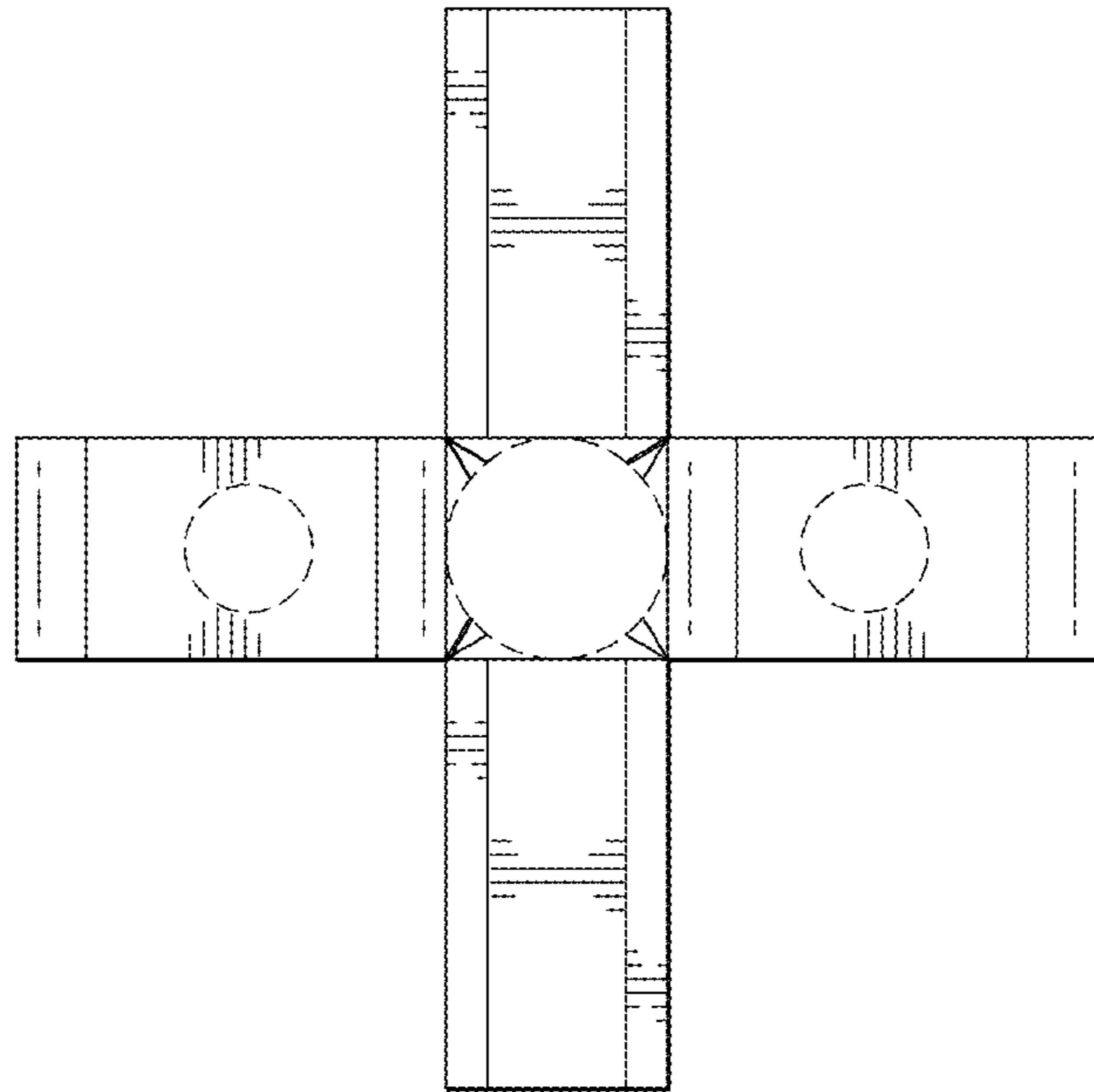

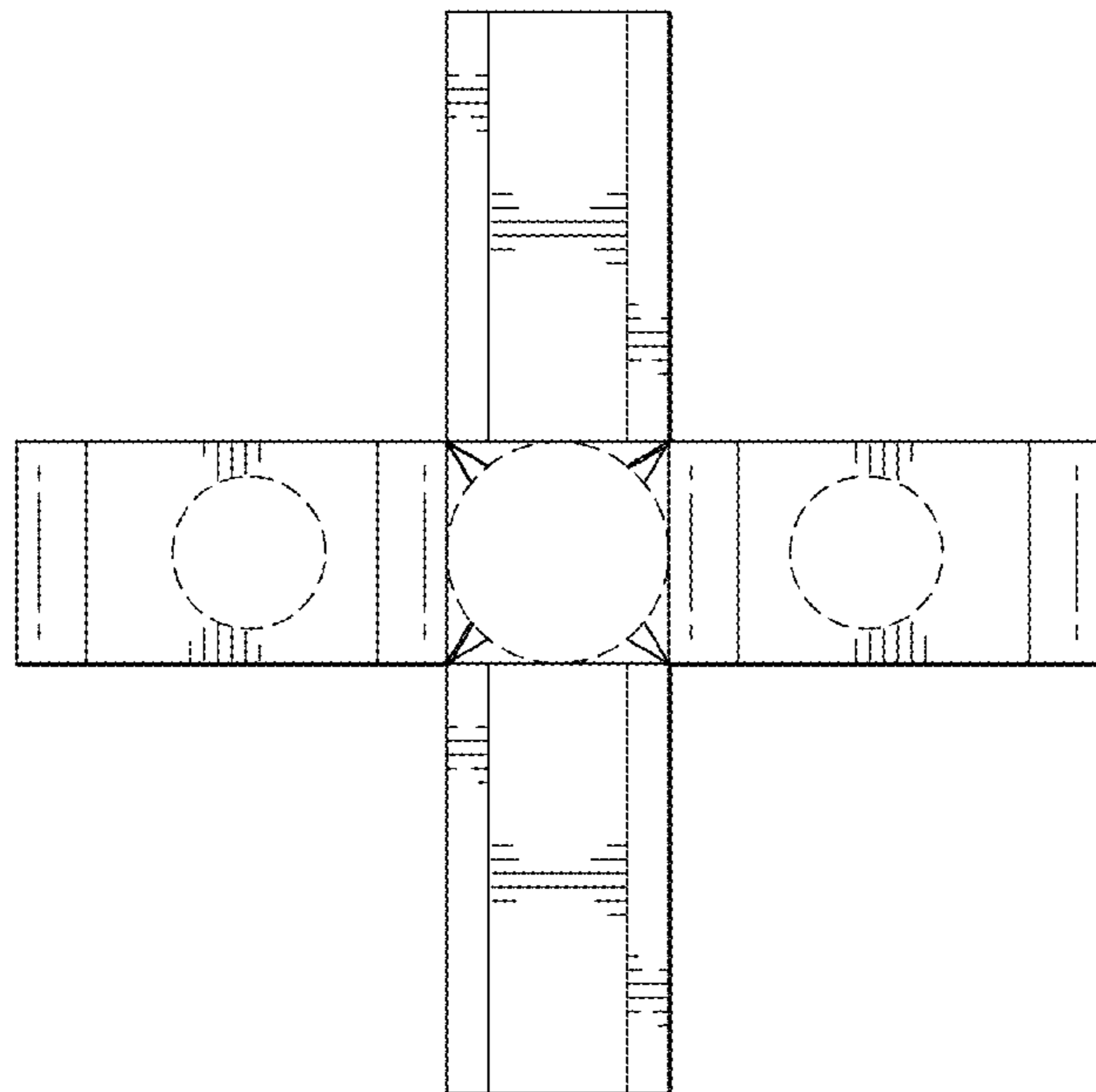

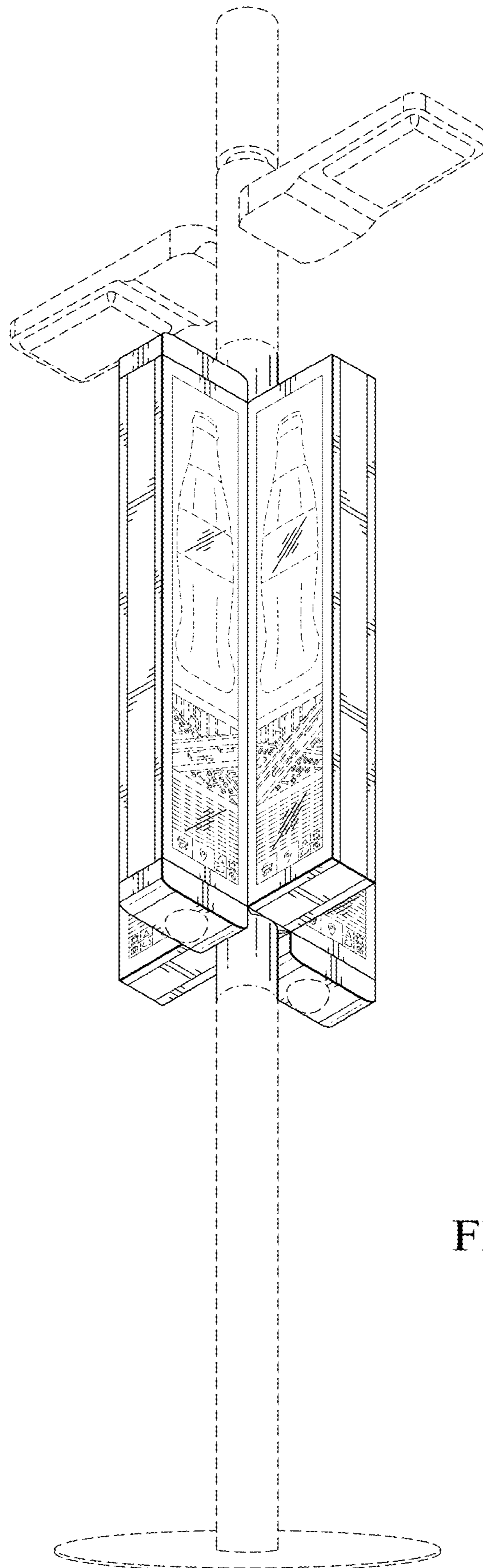
