The ornamental design for a pipe sealing gasket, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the pipe sealing gasket showing the new design;

FIG. 2 is a front elevation view of the pipe sealing gasket of the invention;

FIG. 3 is a rear elevation view of the pipe sealing gasket of the invention;

FIG. 4 is a right side view of the pipe sealing gasket of the invention;

FIG. 5 is a left side view of the F pipe sealing gasket of the invention.

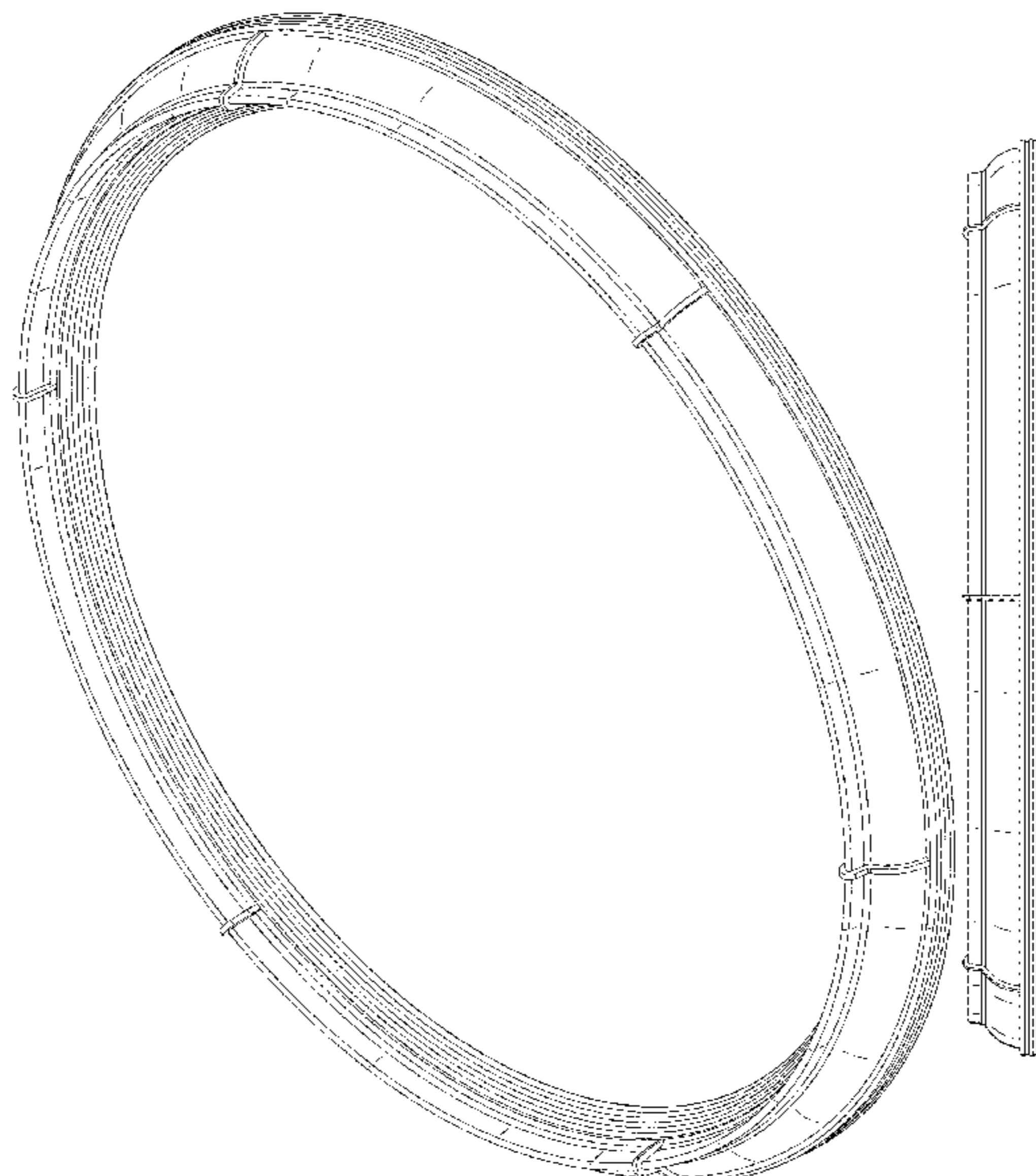
FIG. 6 is a top view of the pipe sealing gasket of the invention;

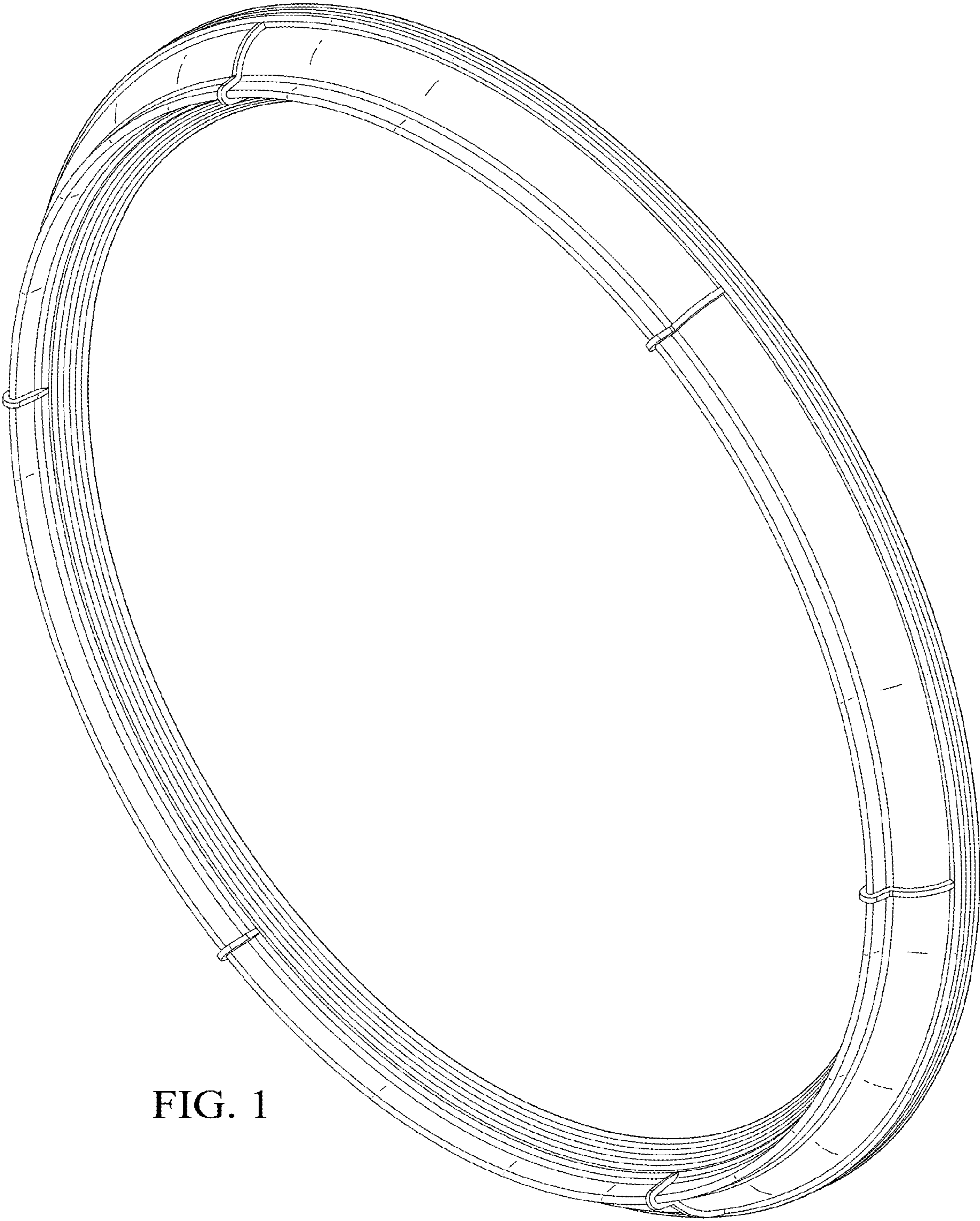

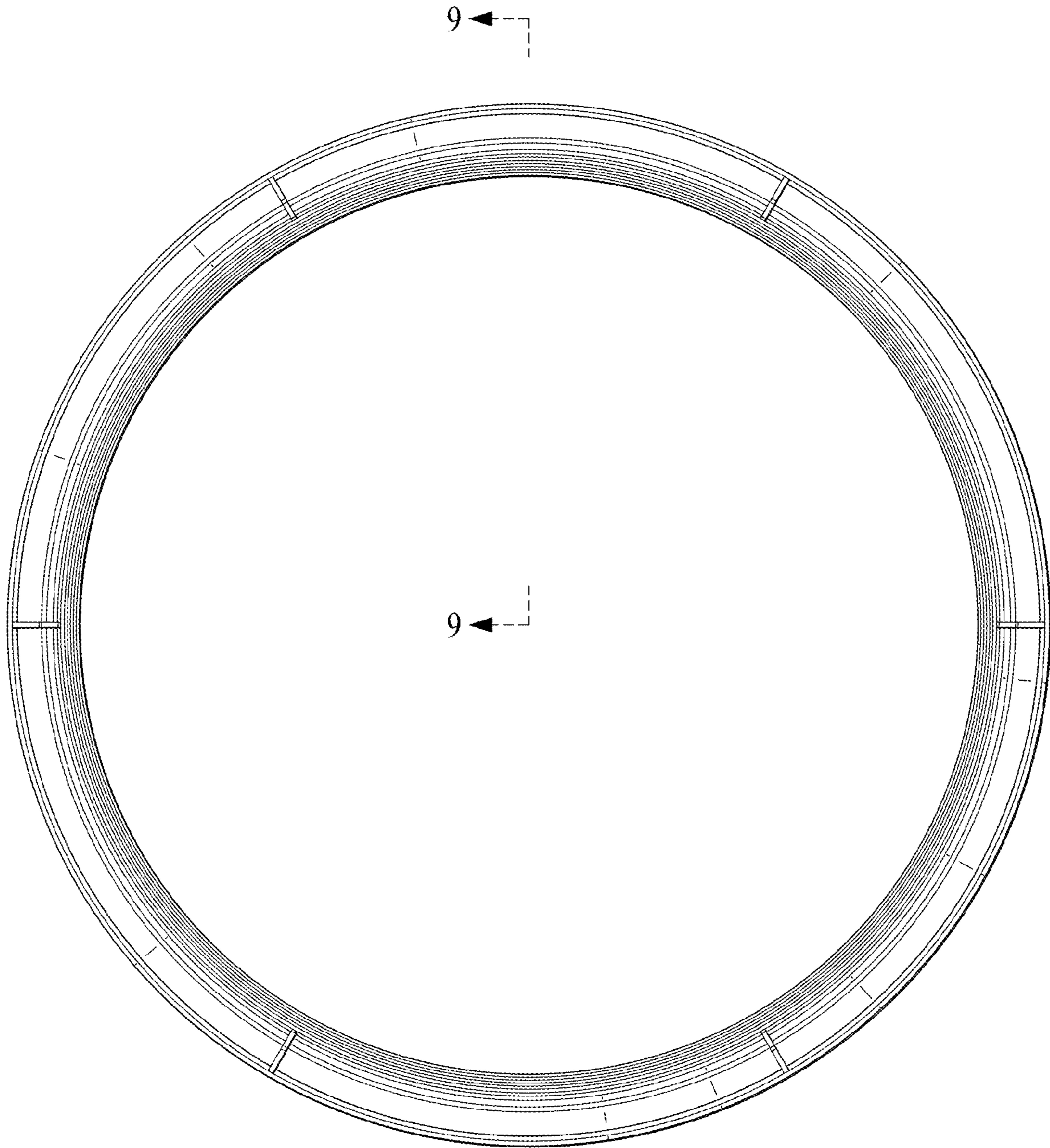

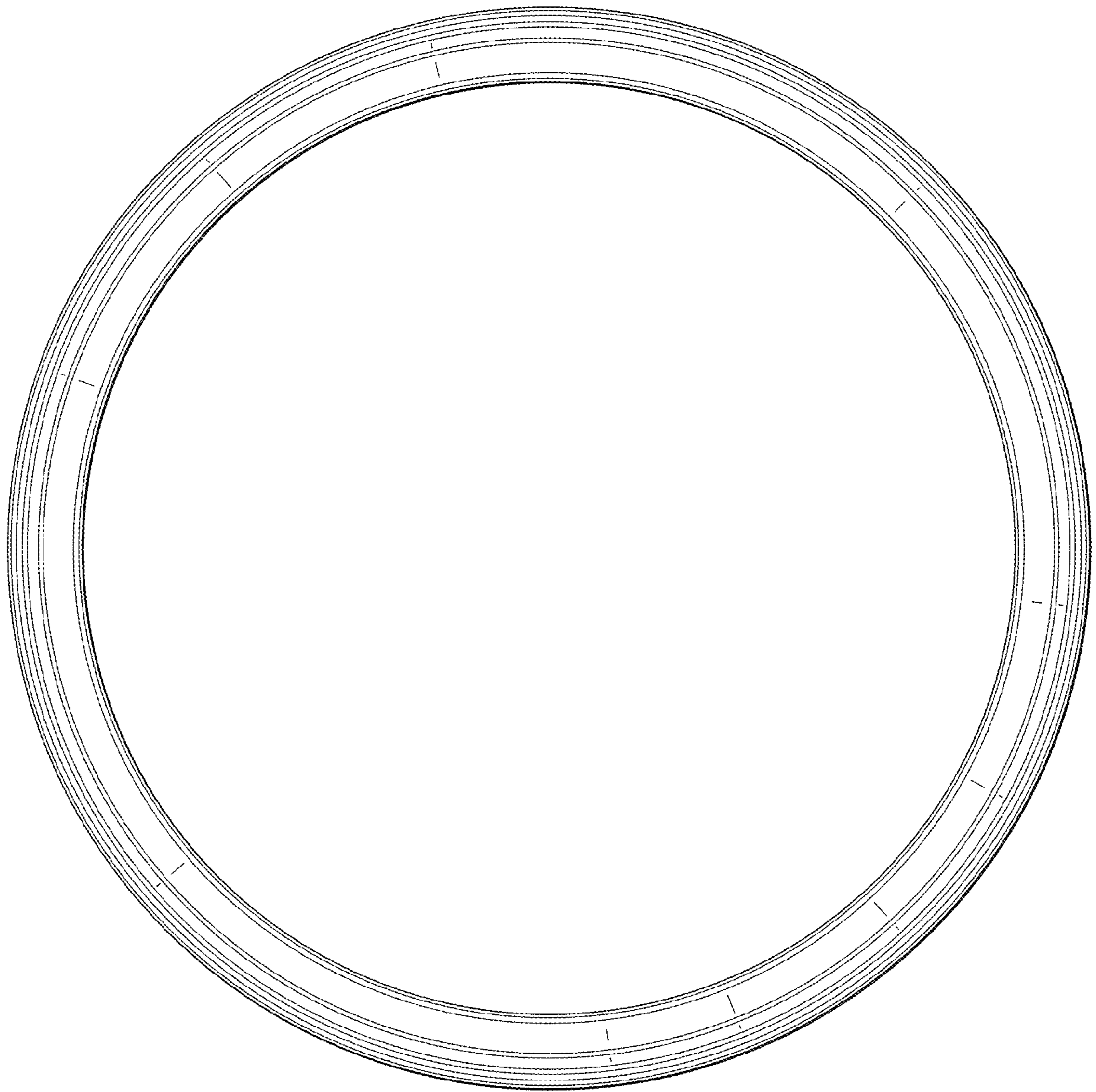

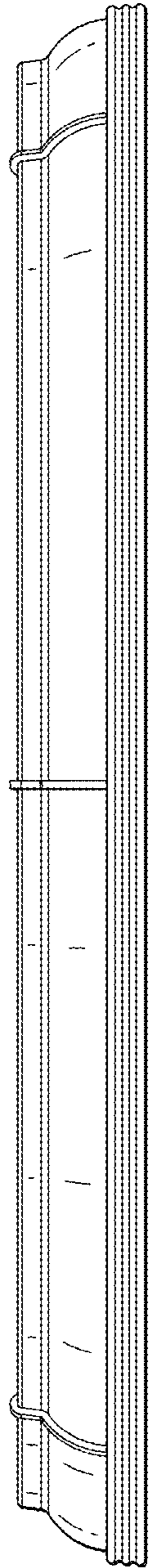

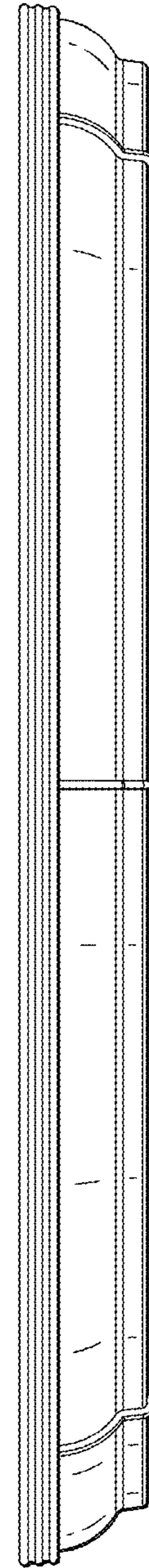

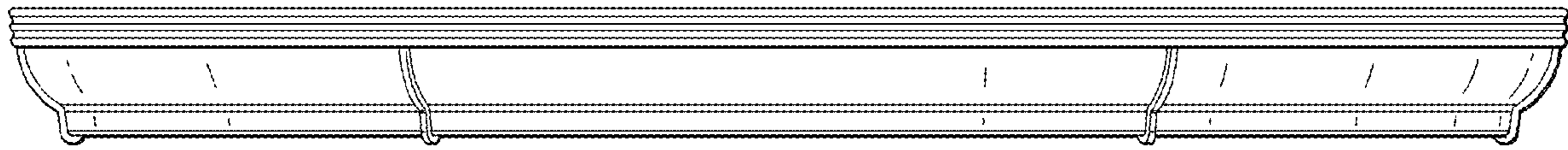

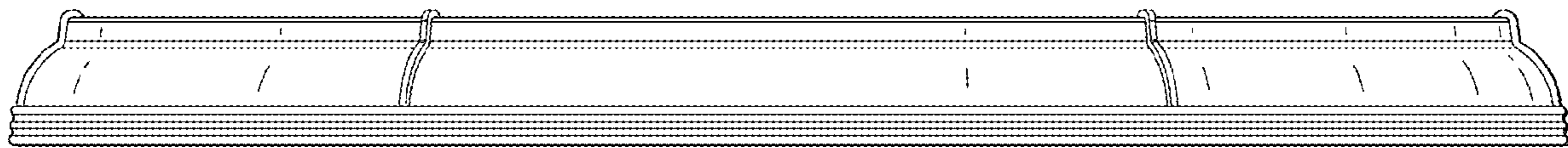

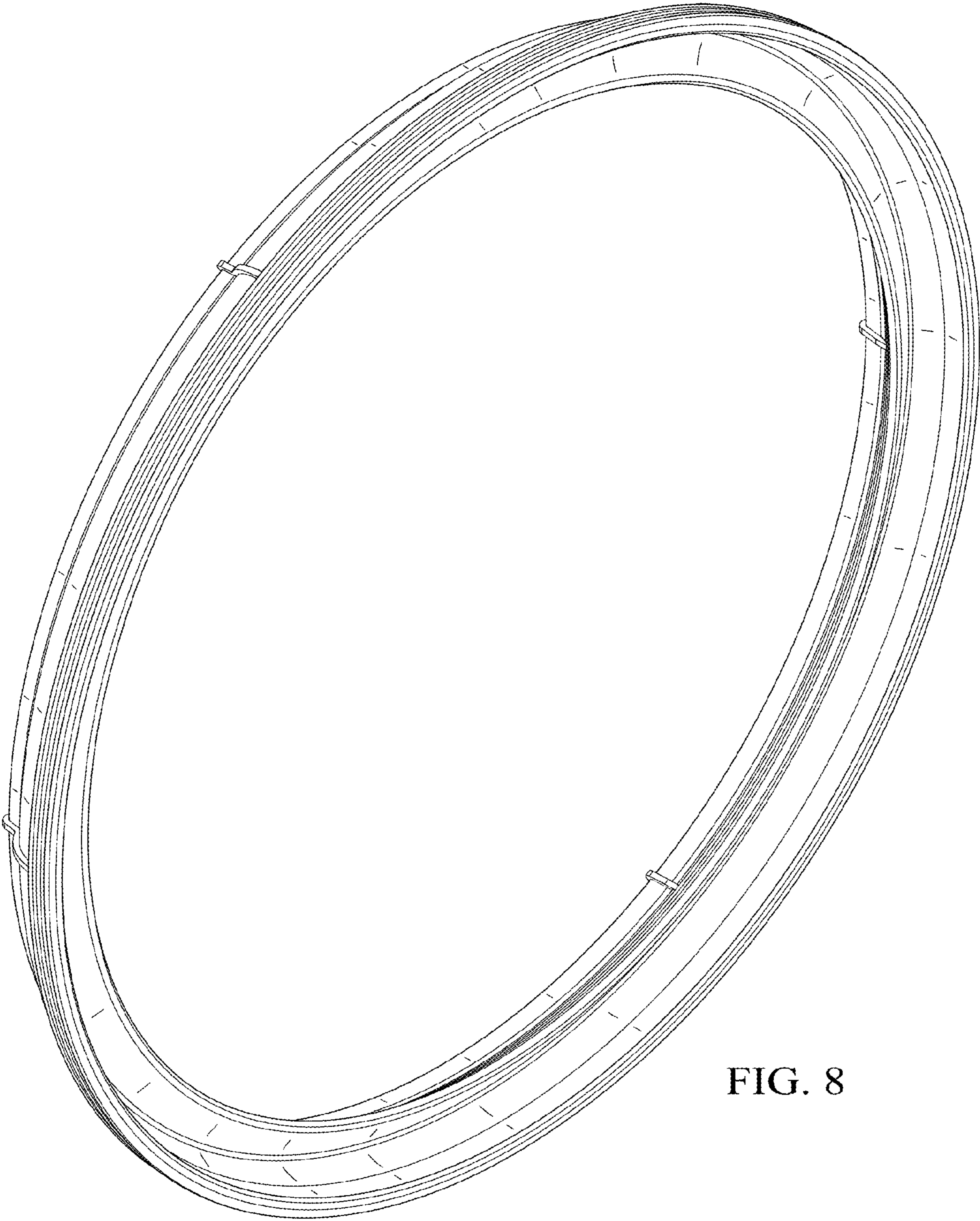

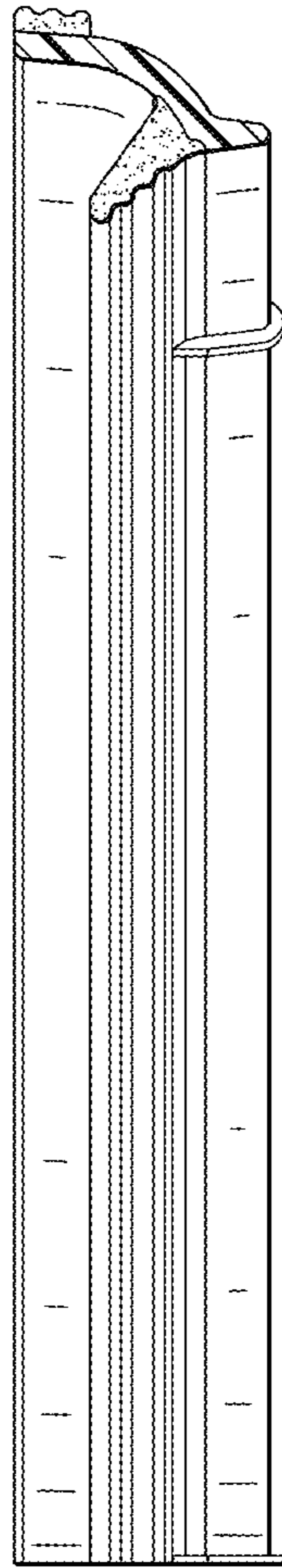
