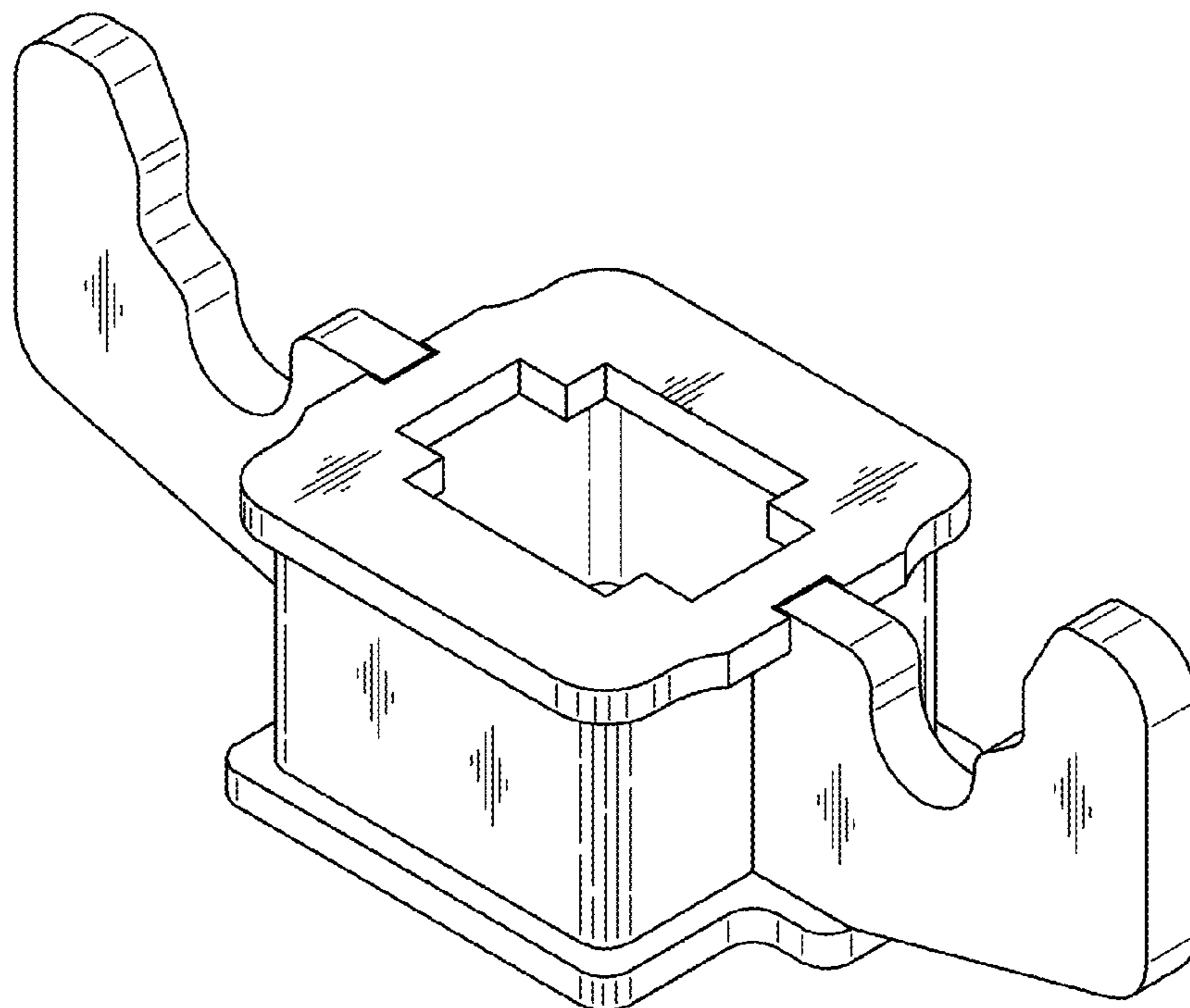

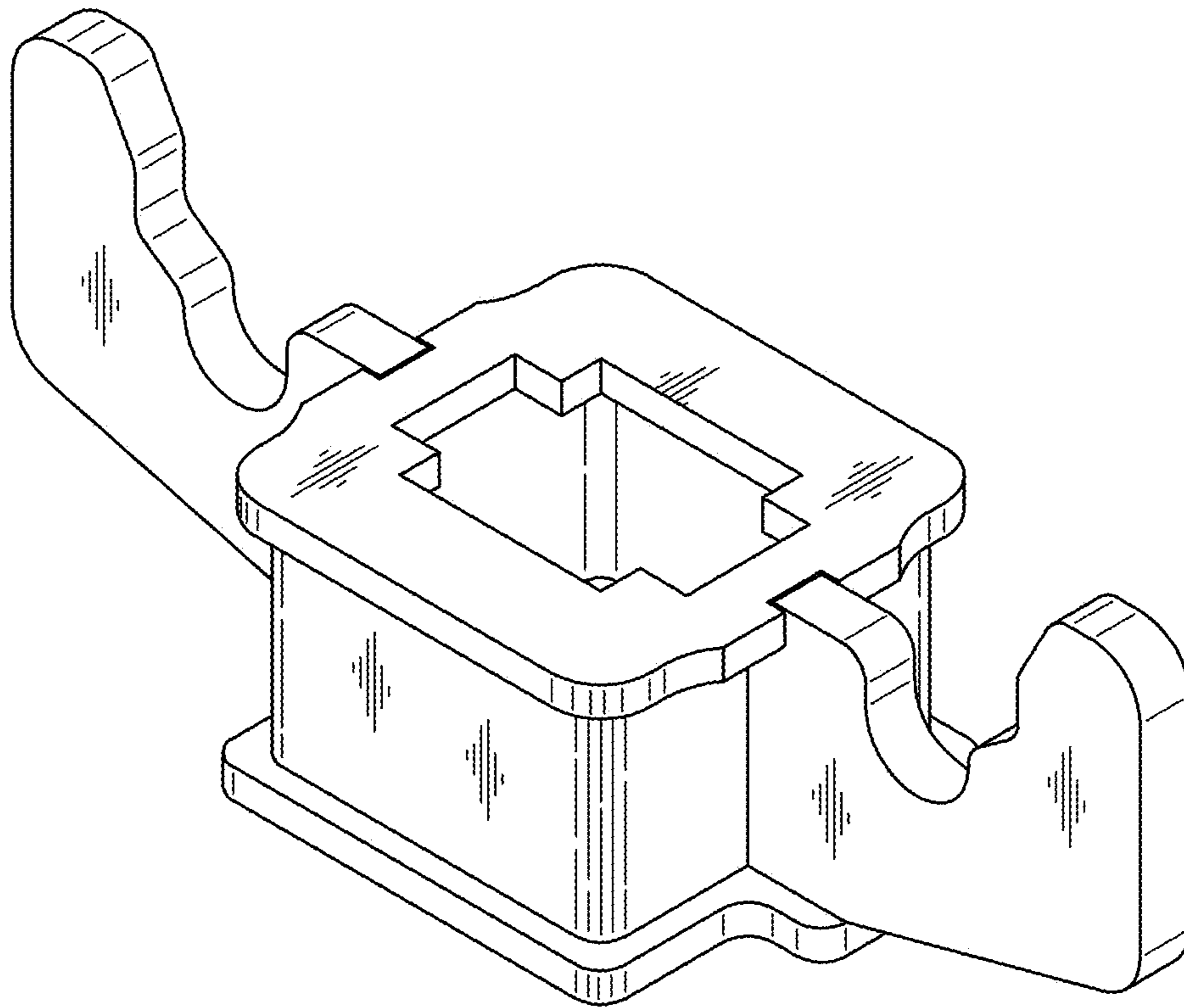
The ornamental design for a support head for a formwork system, as shown and described.

**DESCRIPTION**

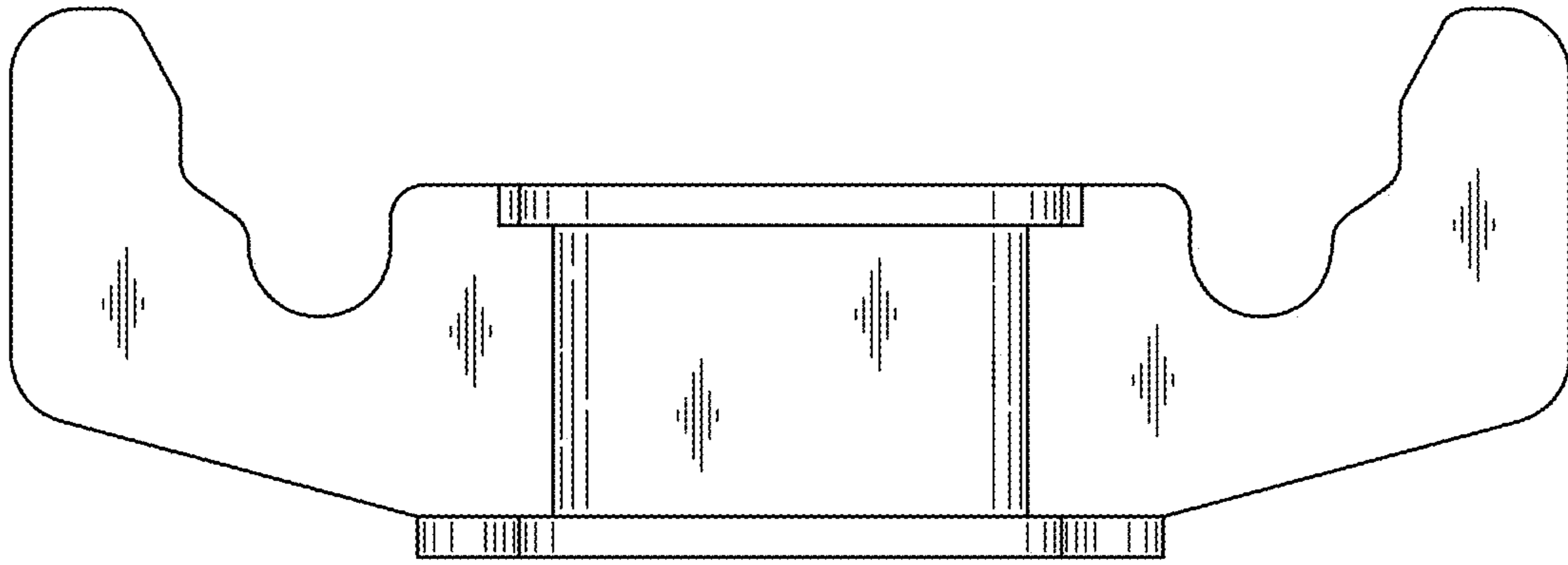
FIG. 1 is a front perspective view of a support head for a formwork system showing our new design;

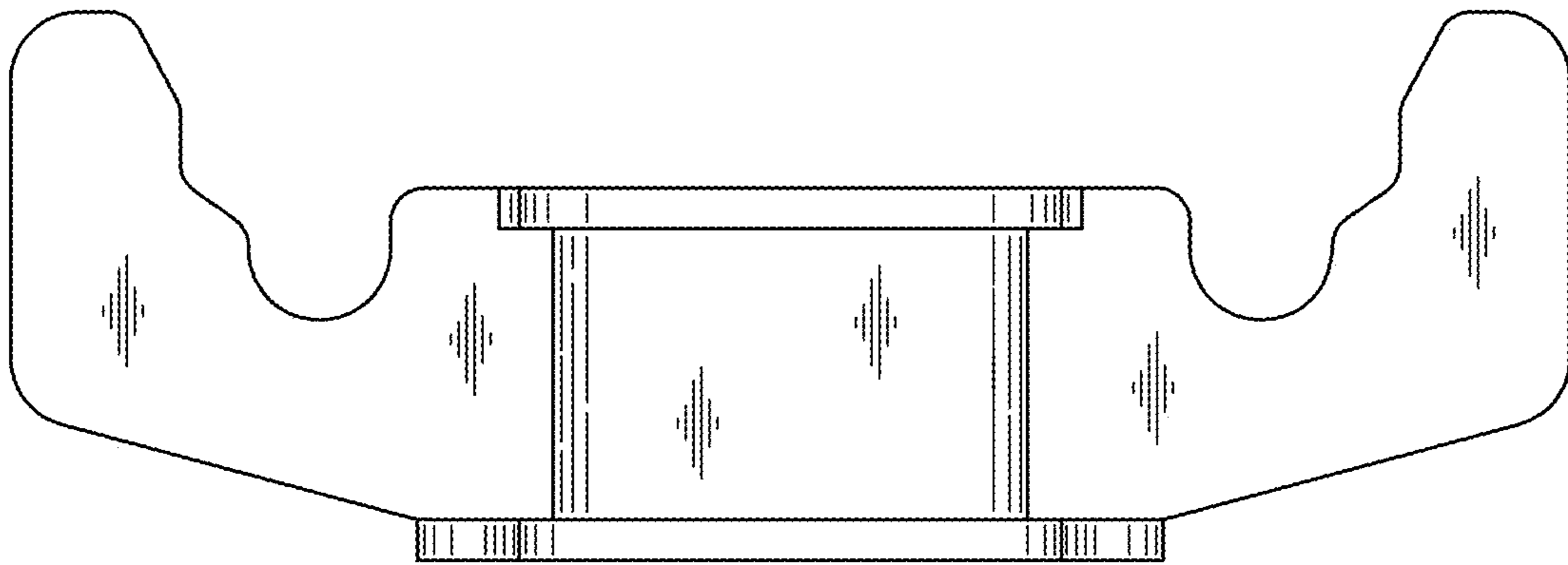




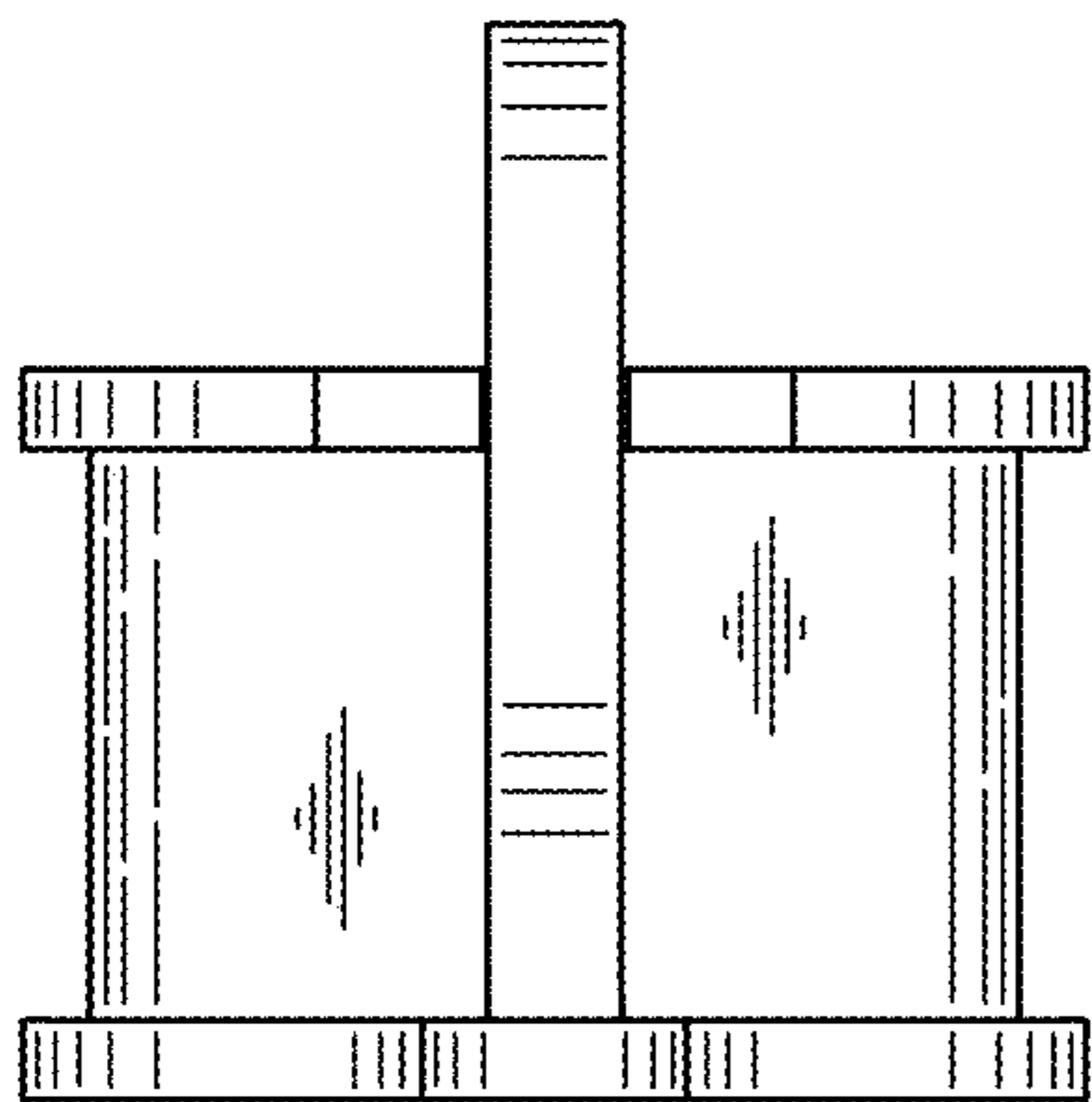

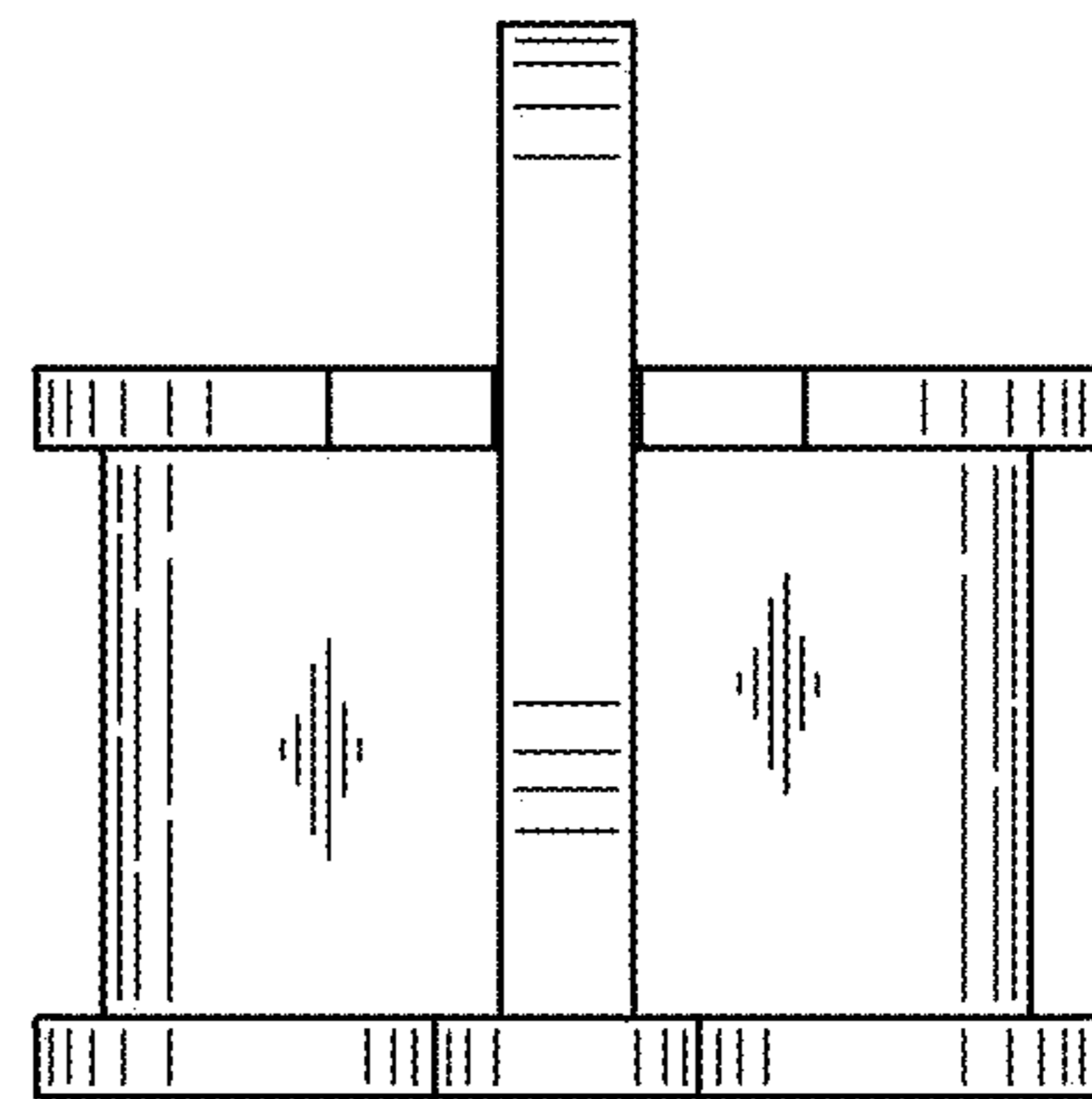

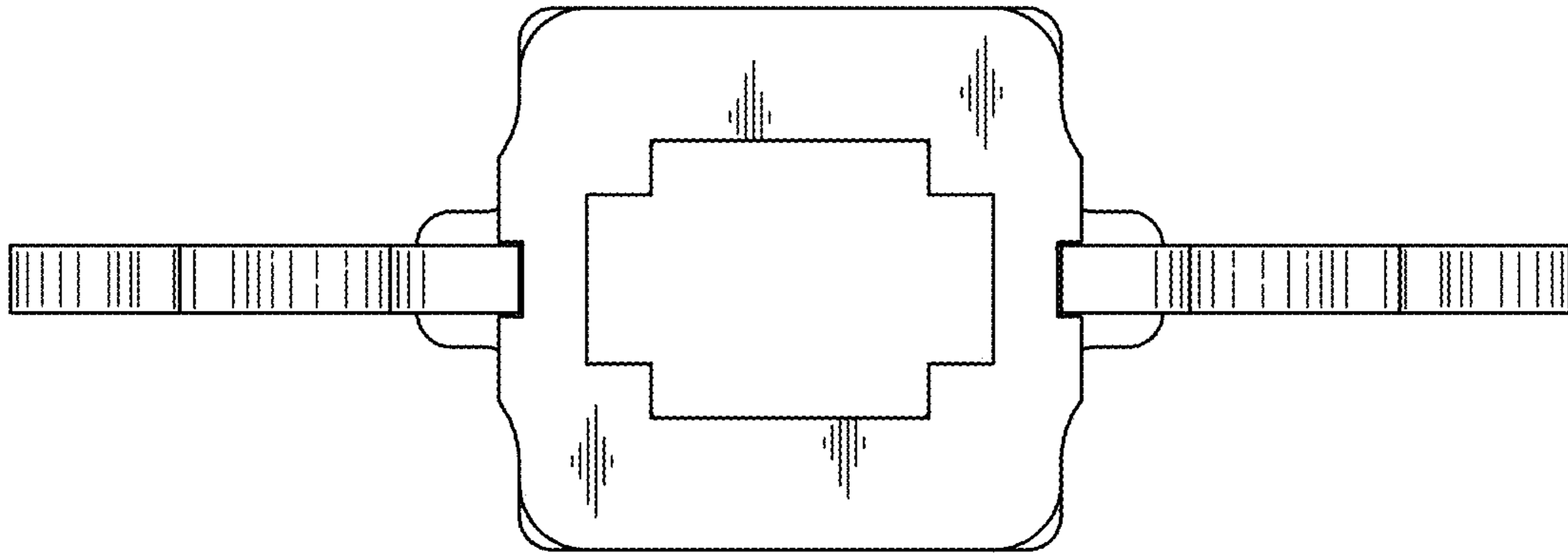

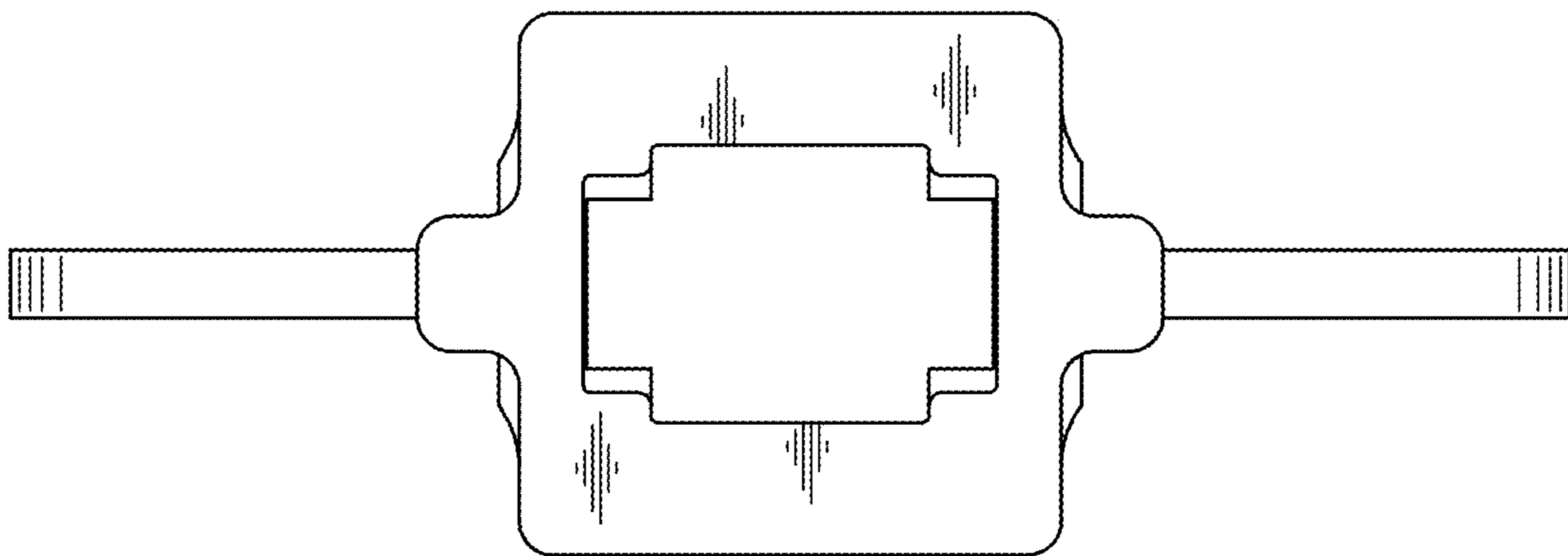
