patch in condition of use.

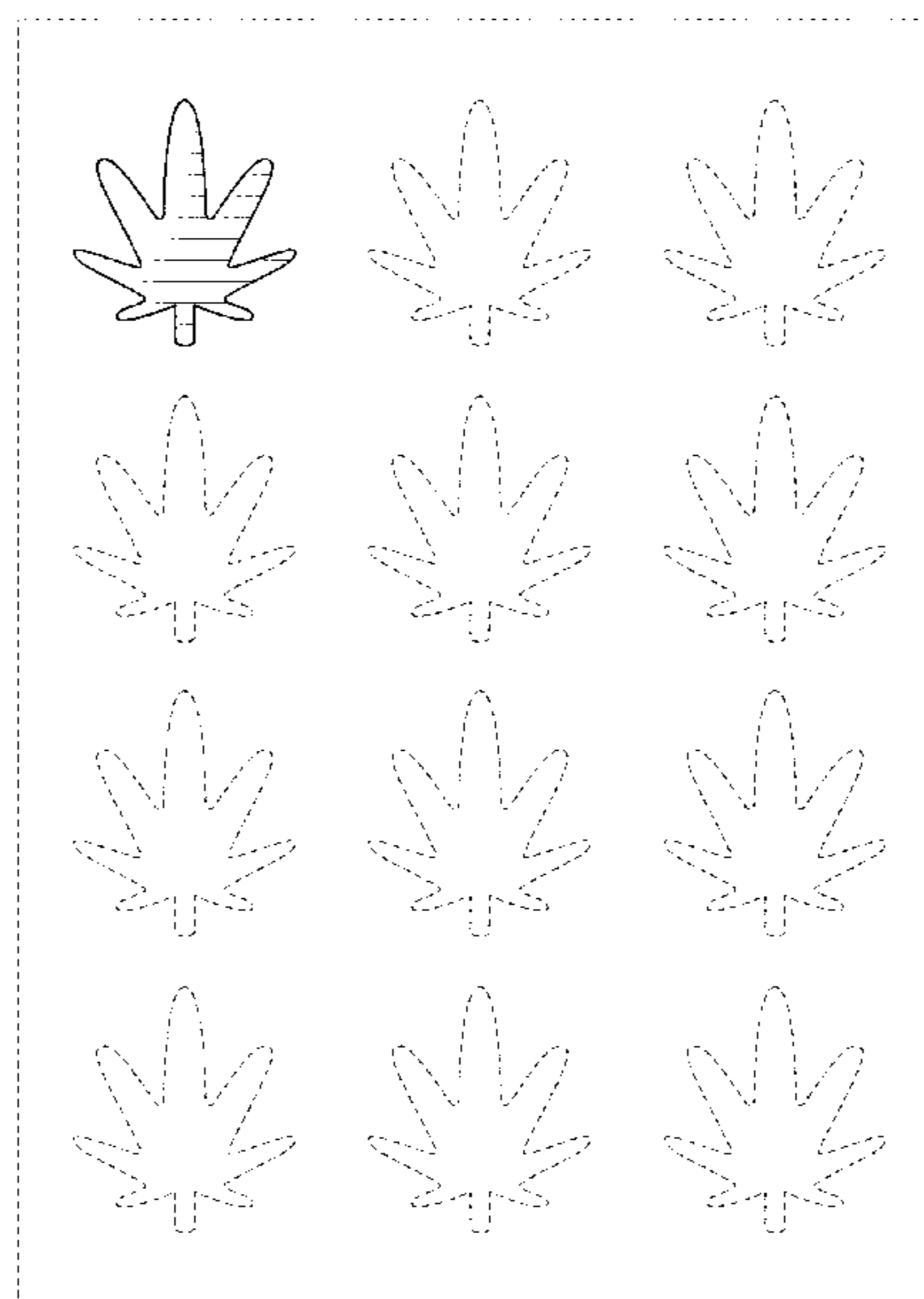

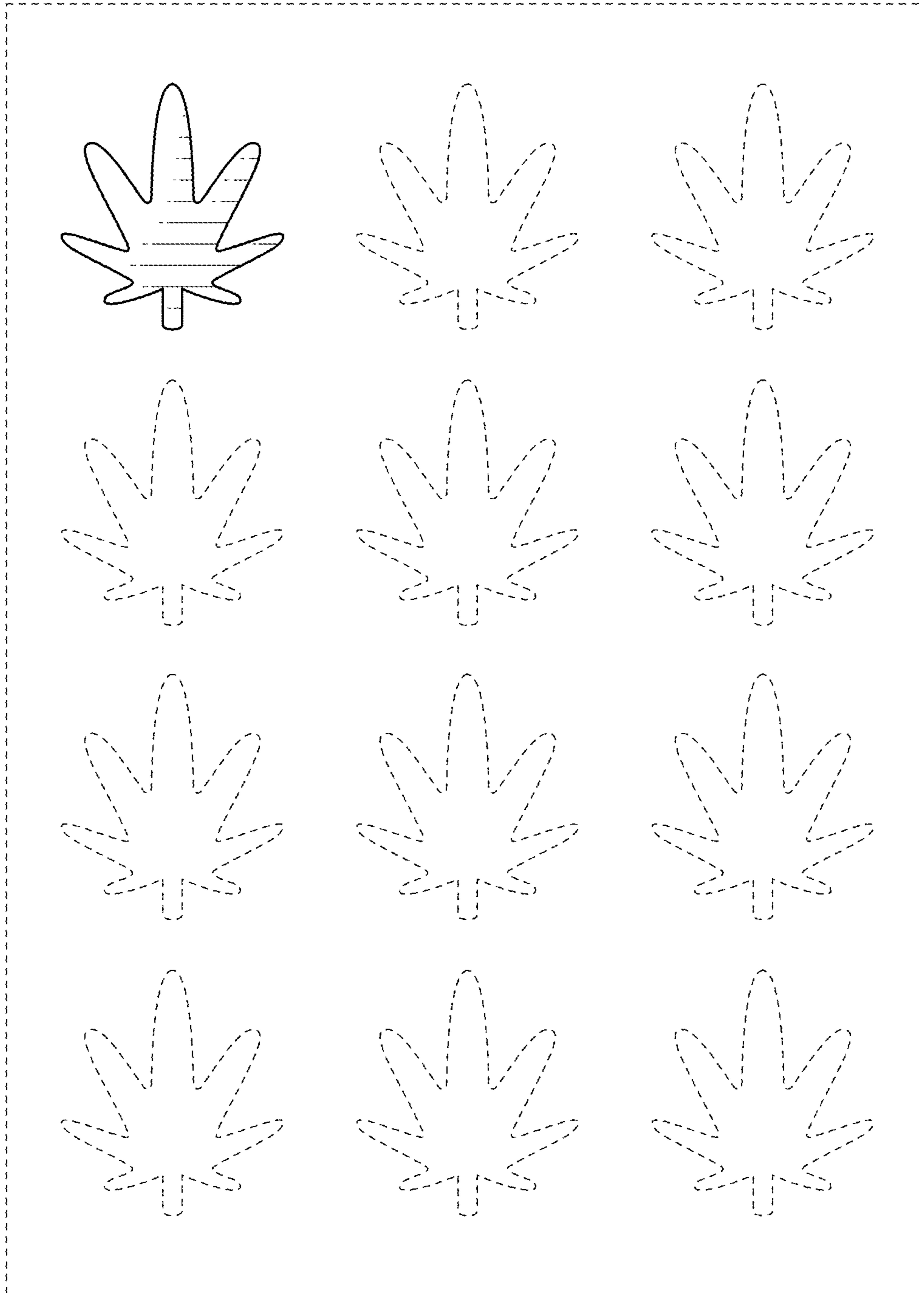

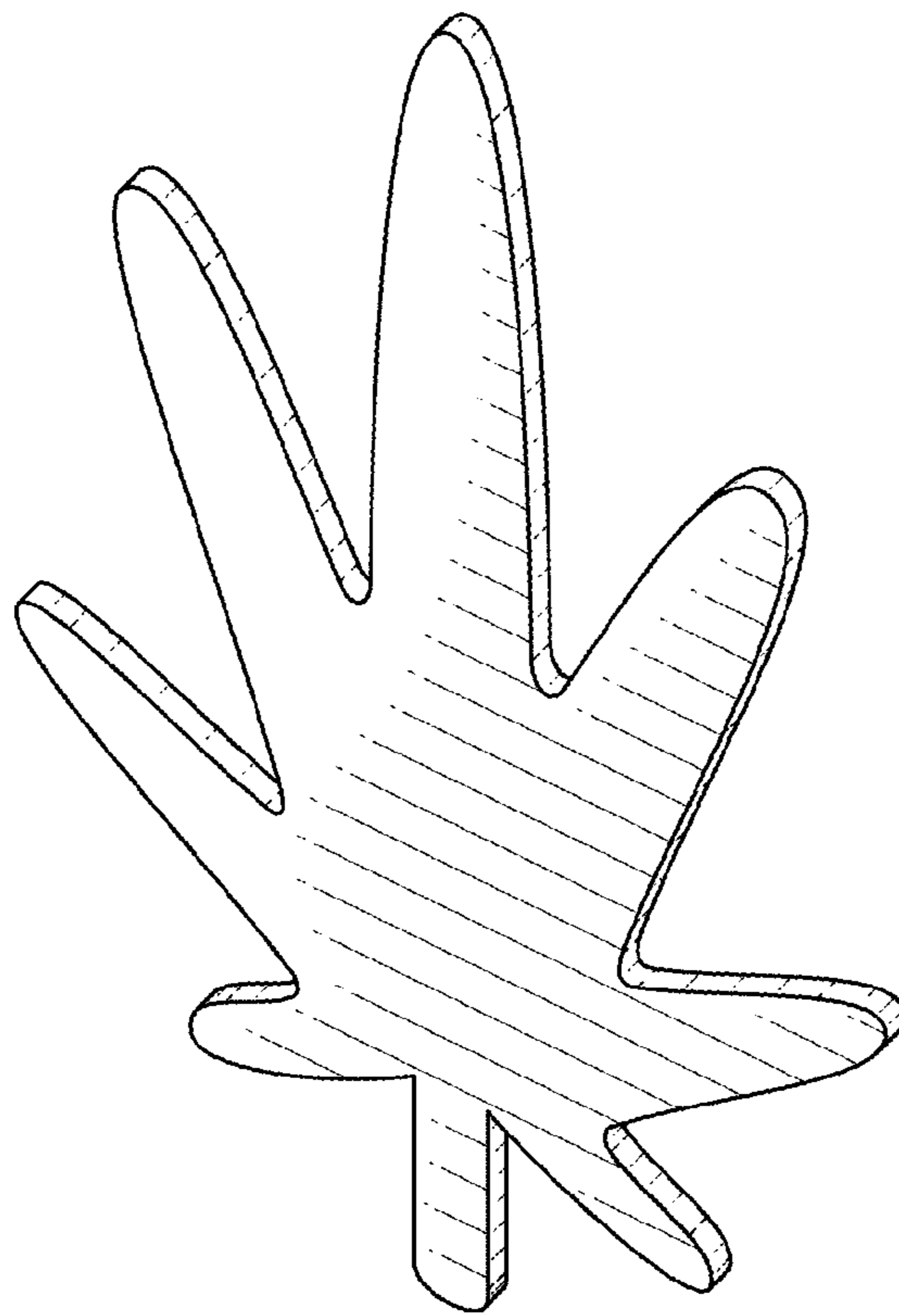

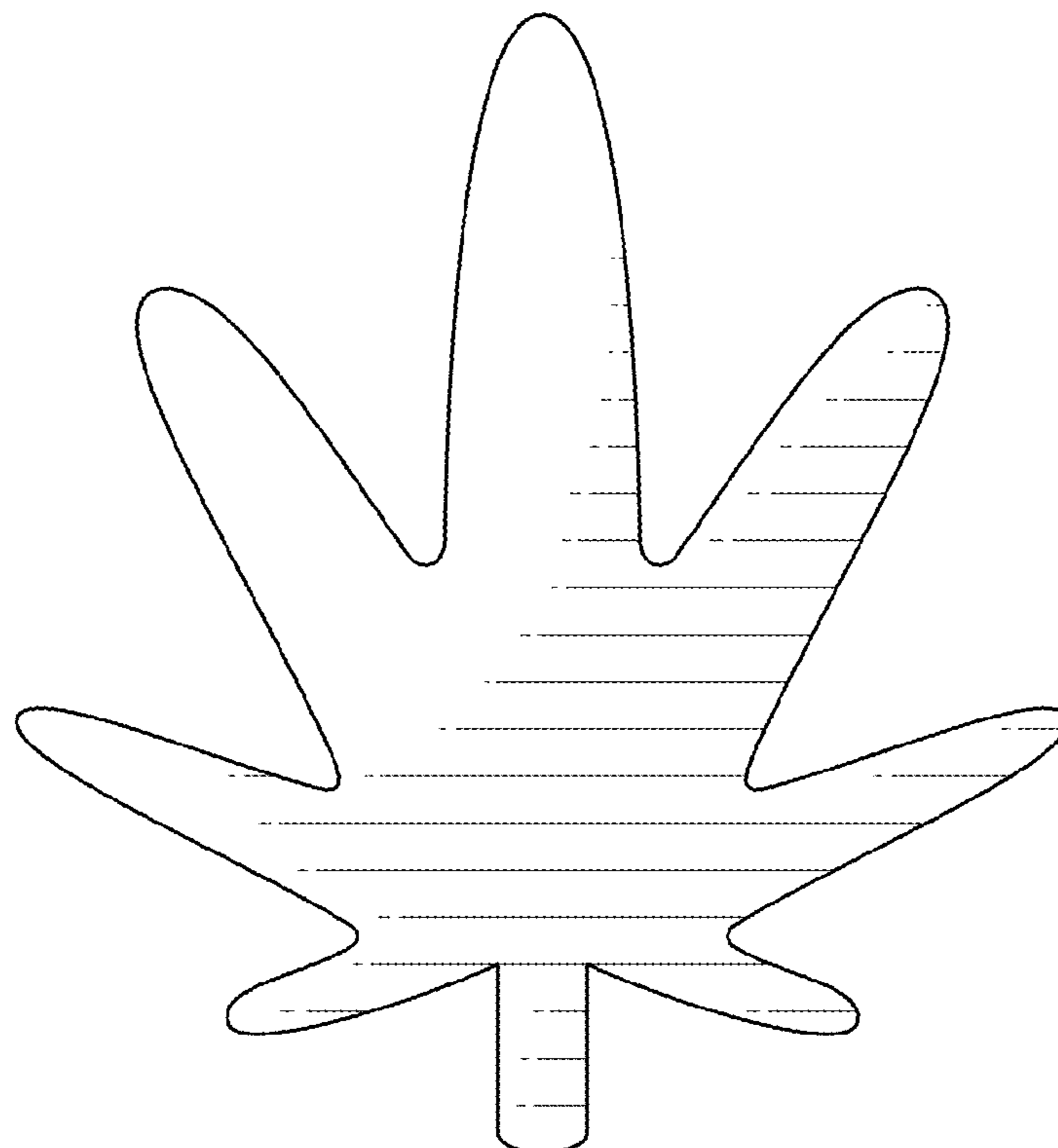

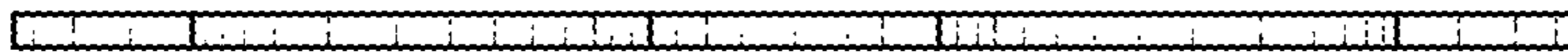

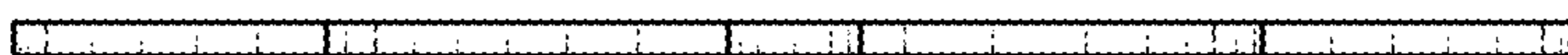

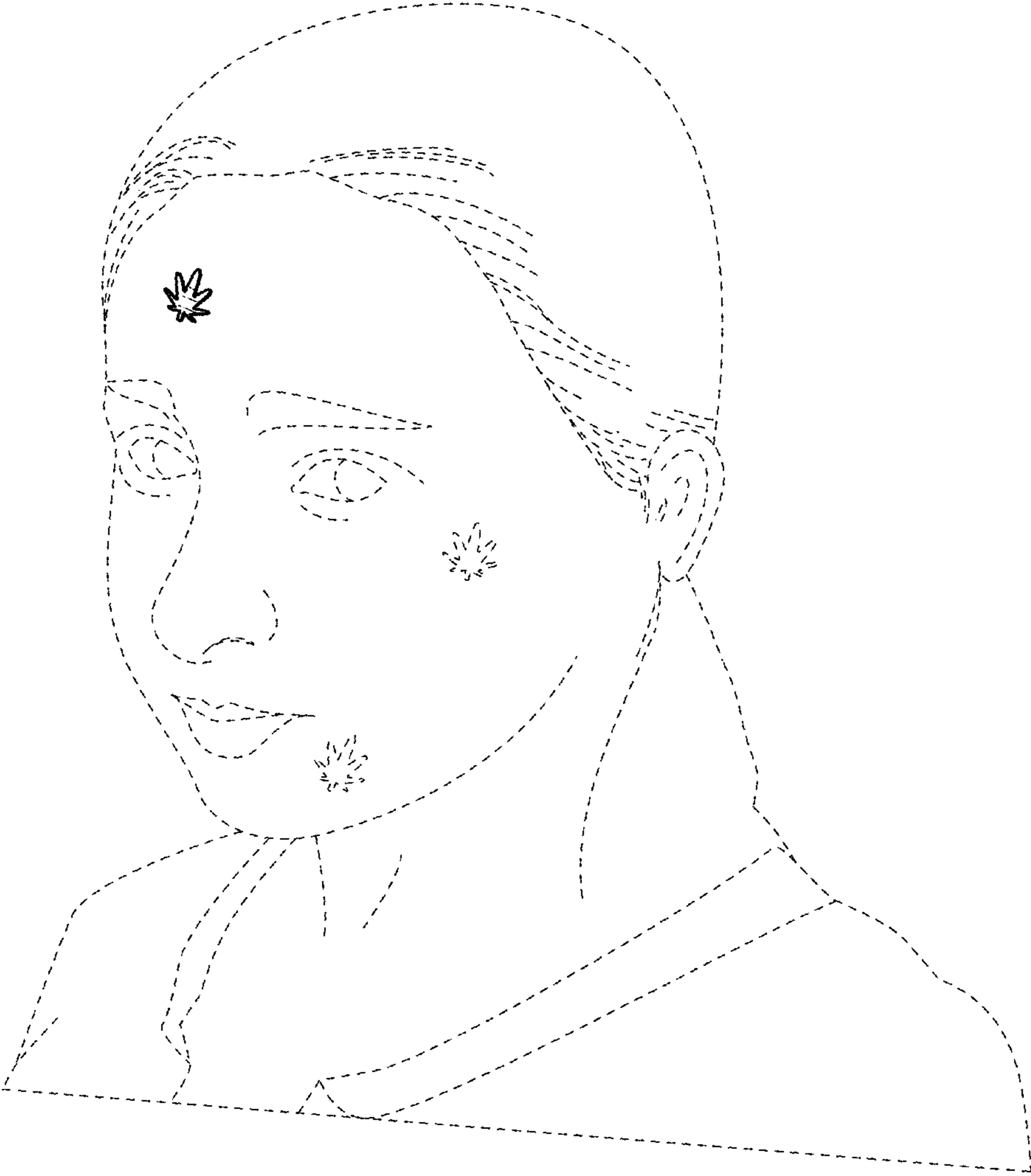
