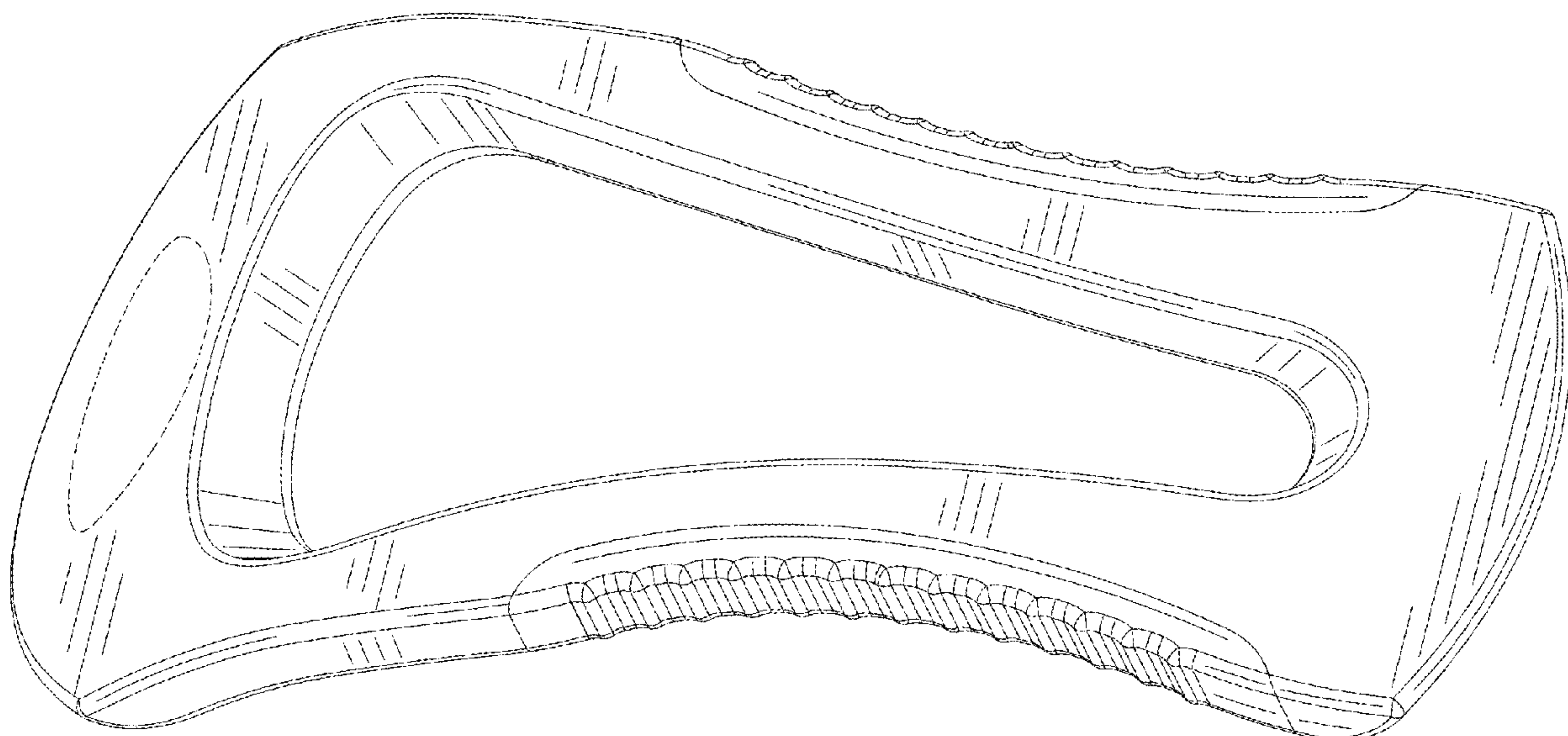

The ornamental design for a wide shaver handle, as shown and described.

DESCRIPTION

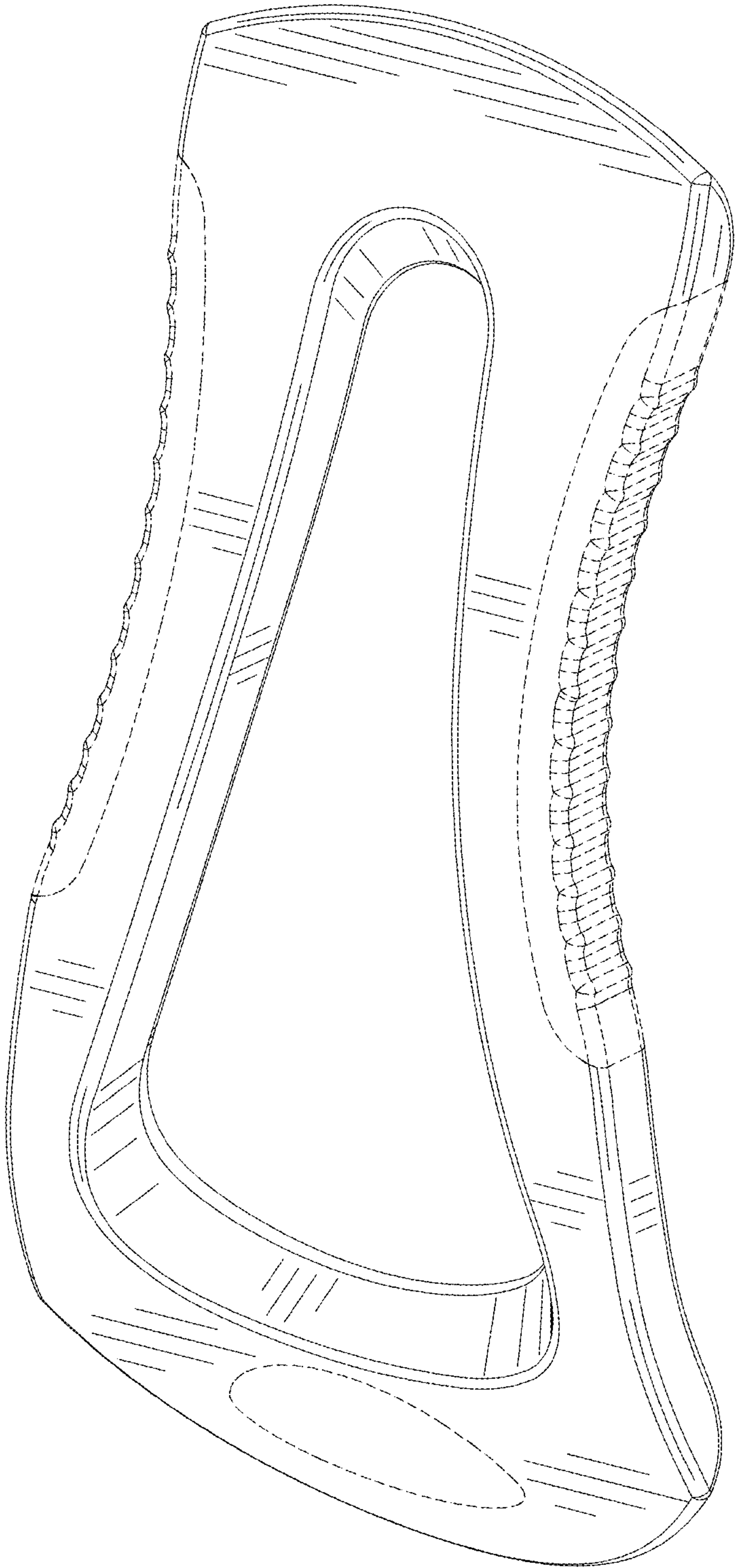

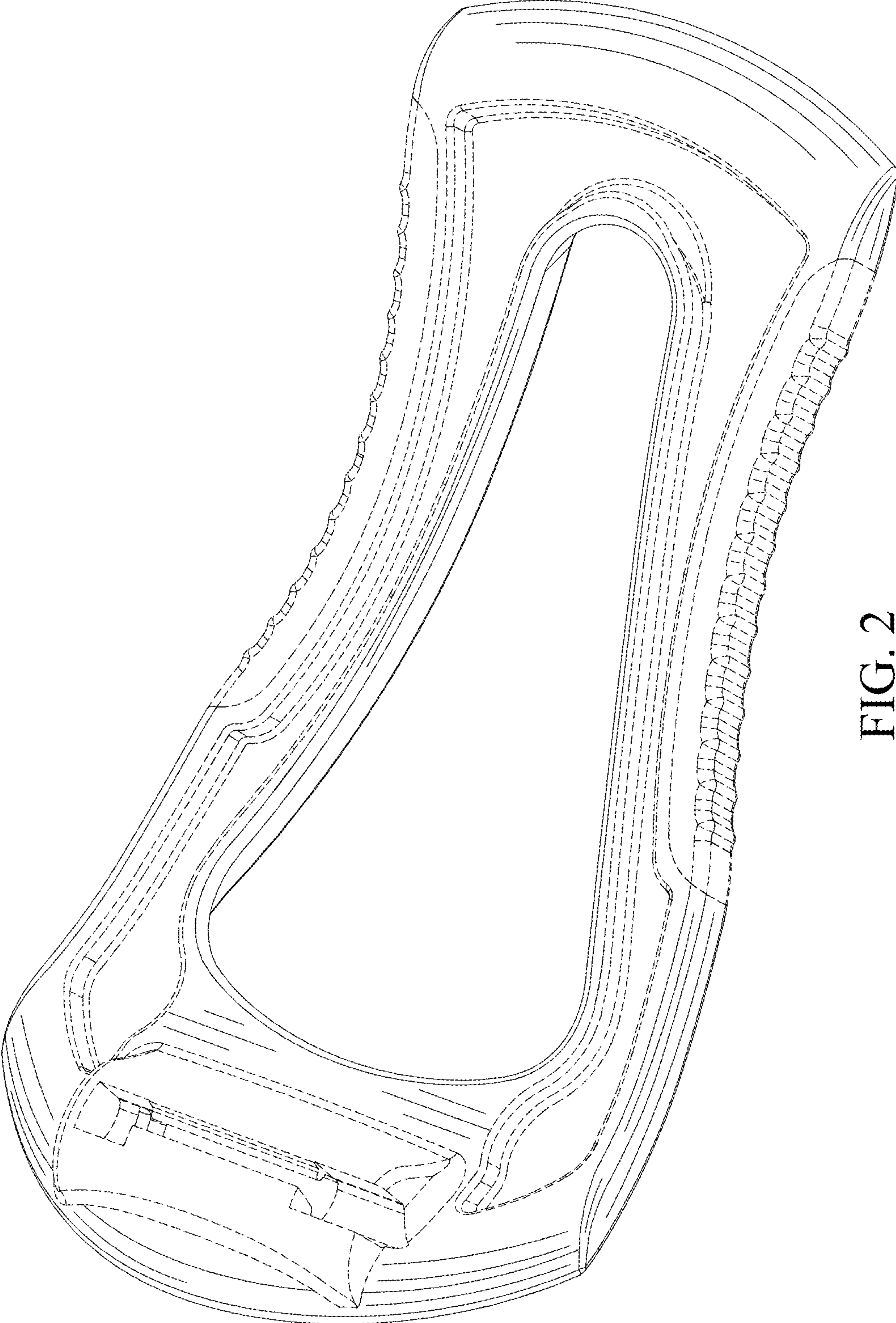

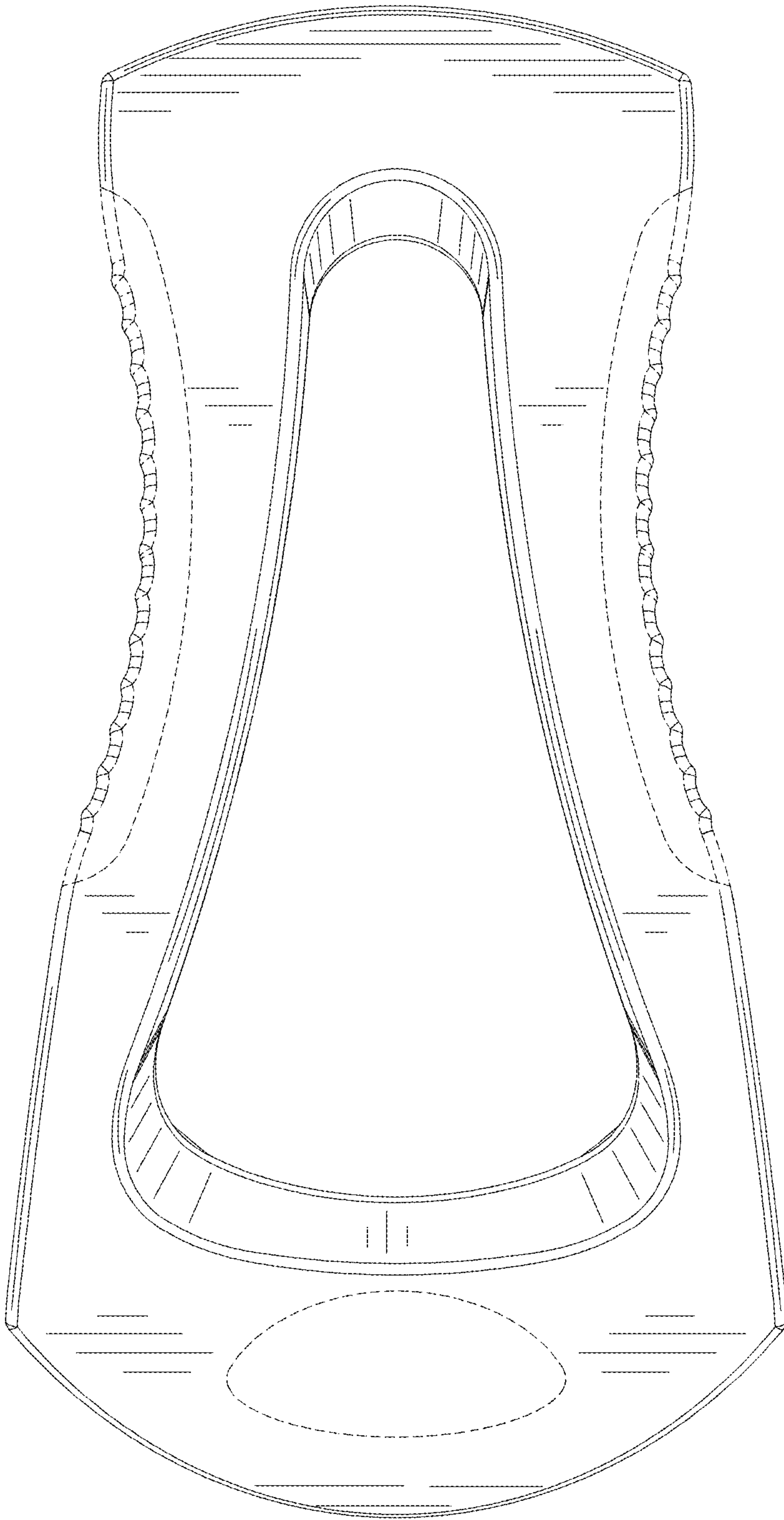

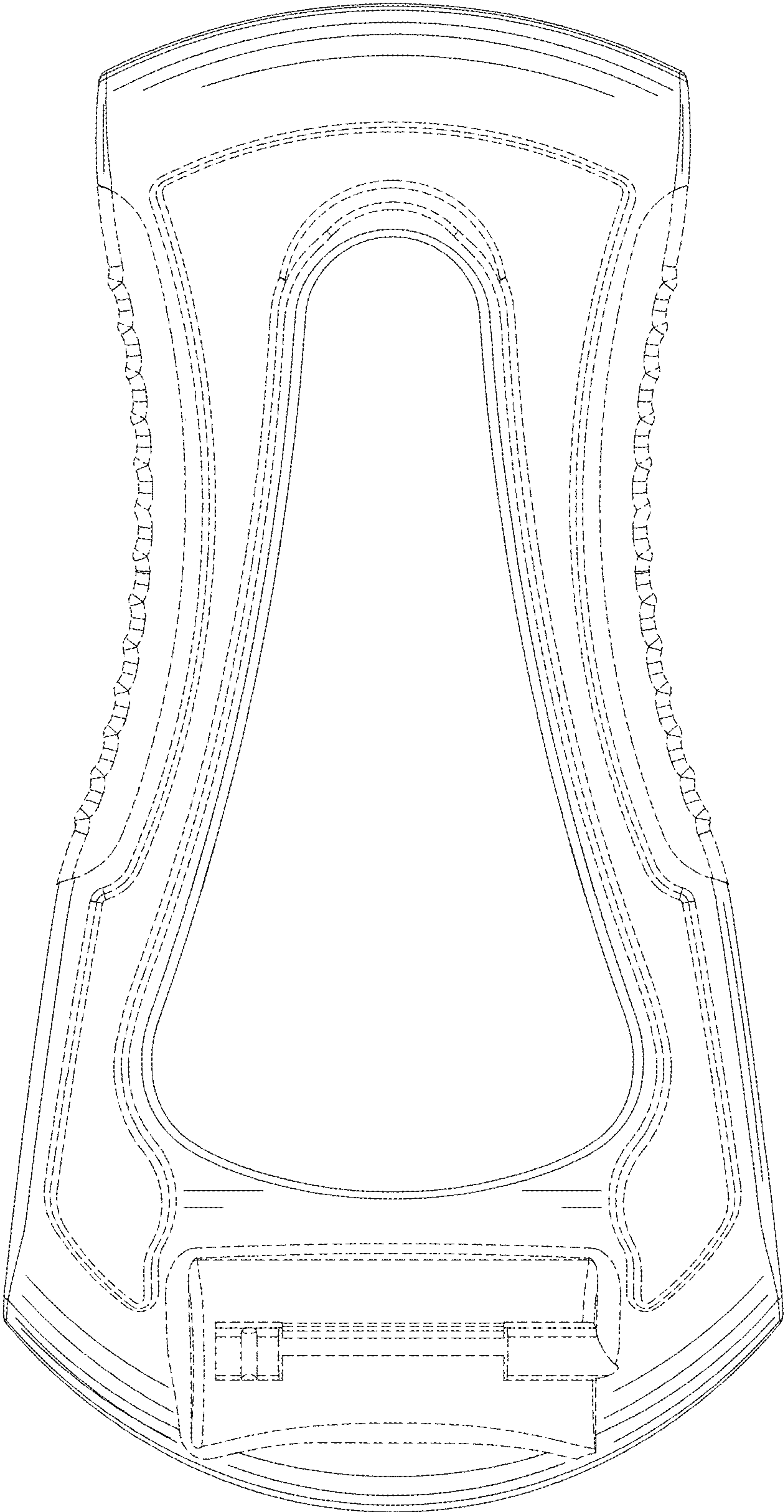

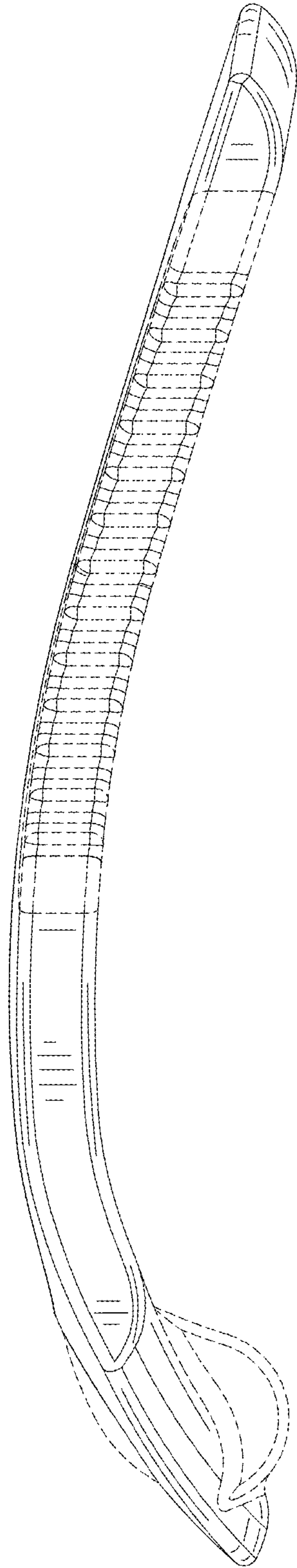

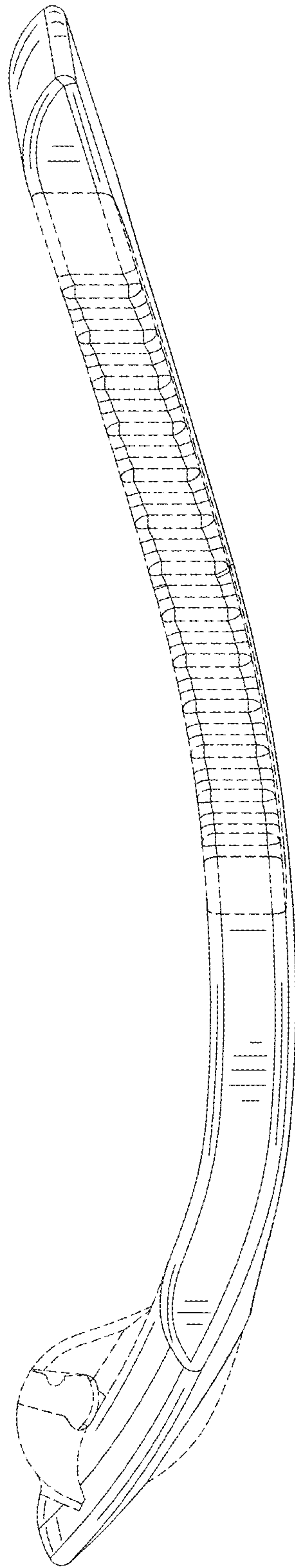

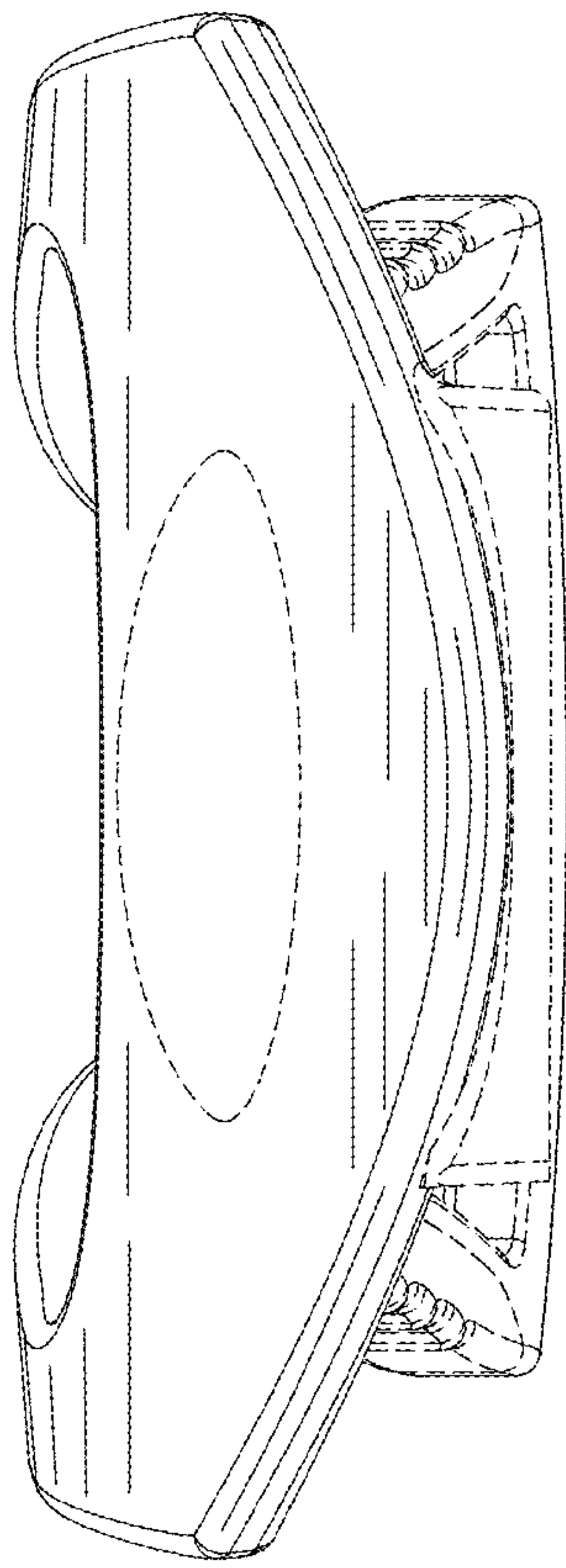

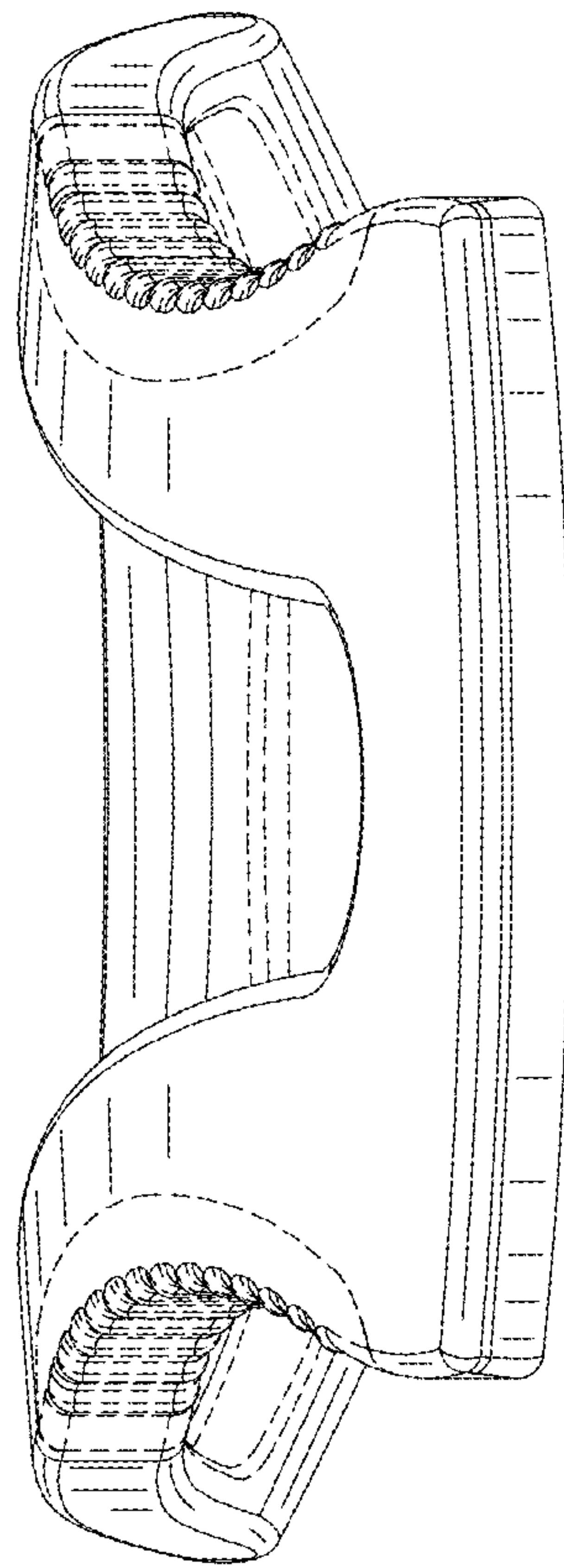

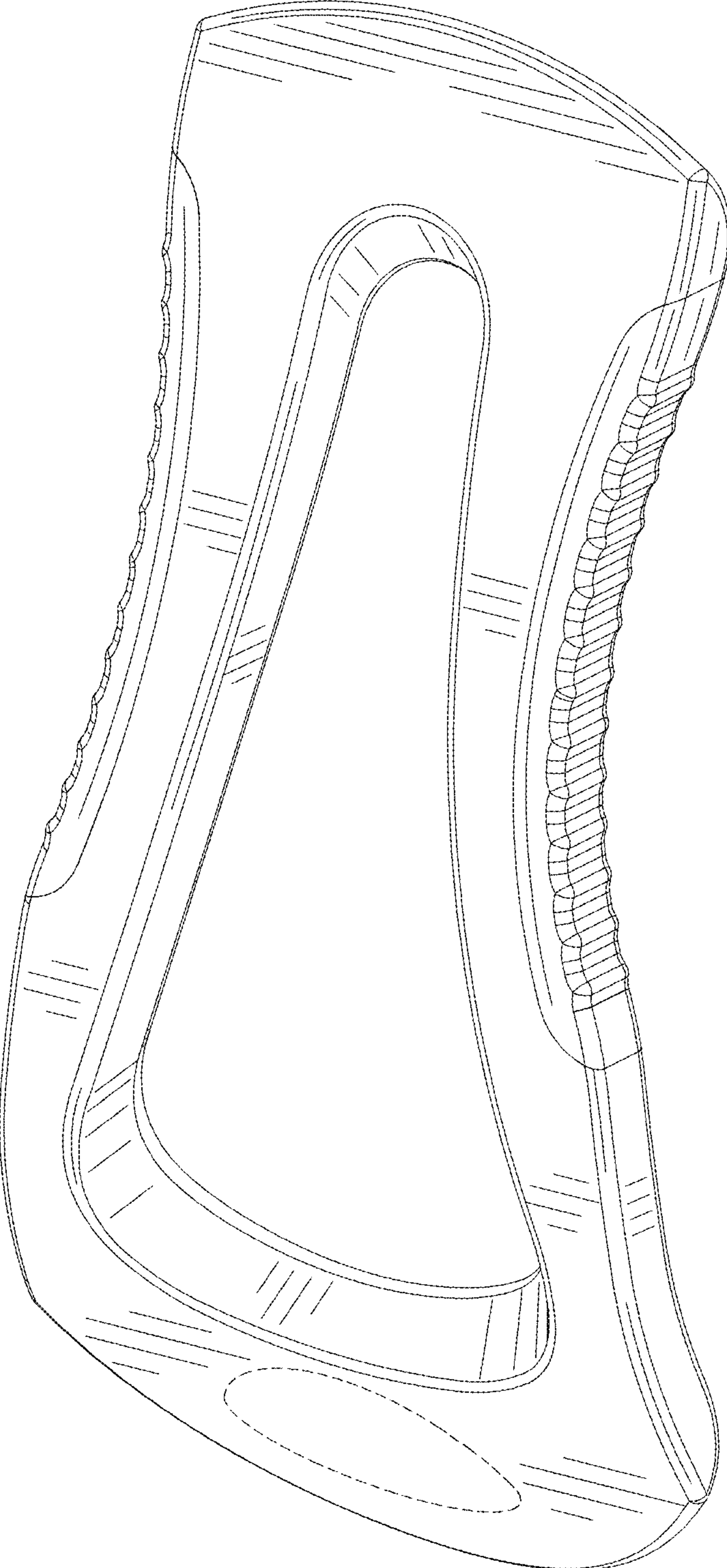

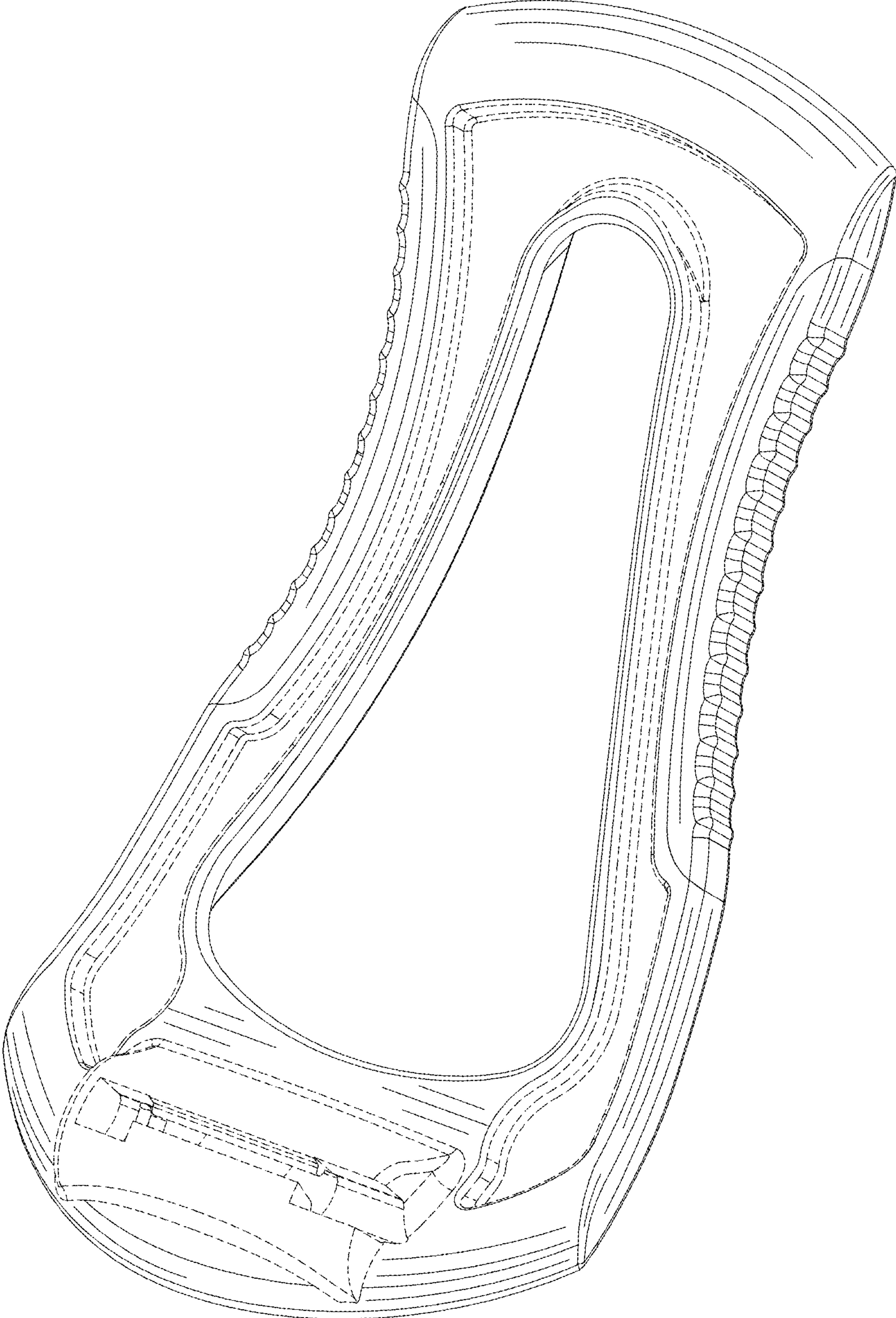

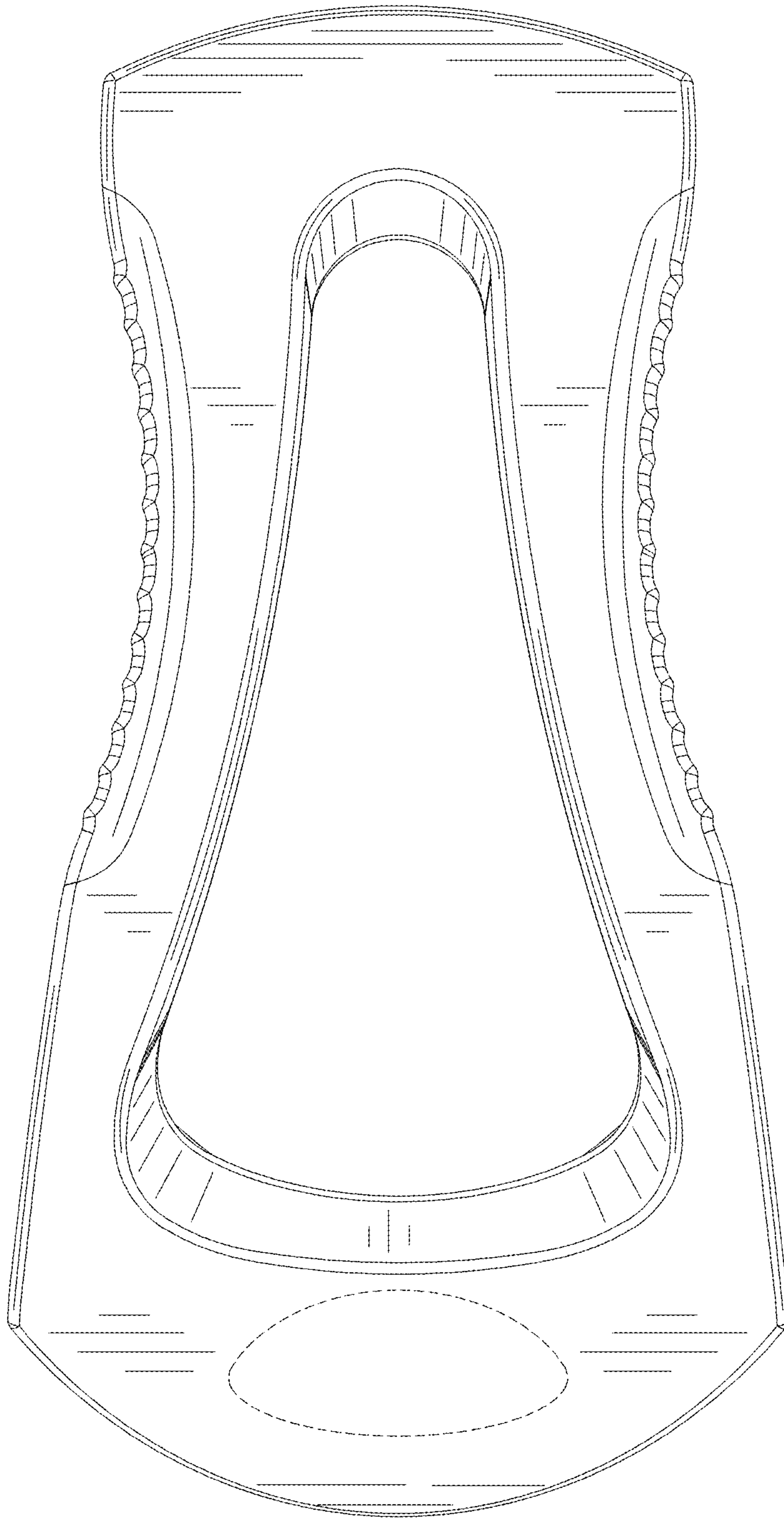

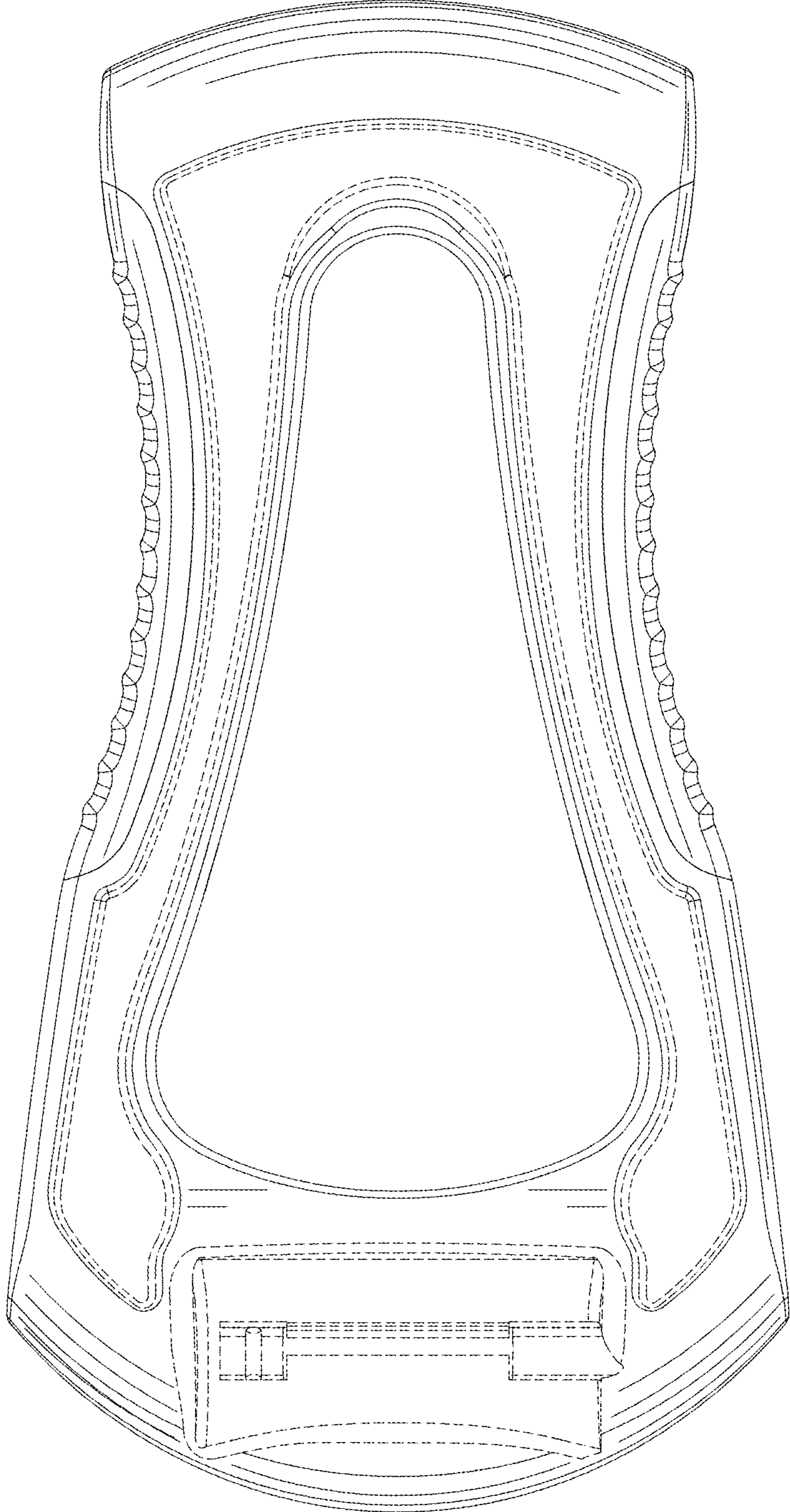

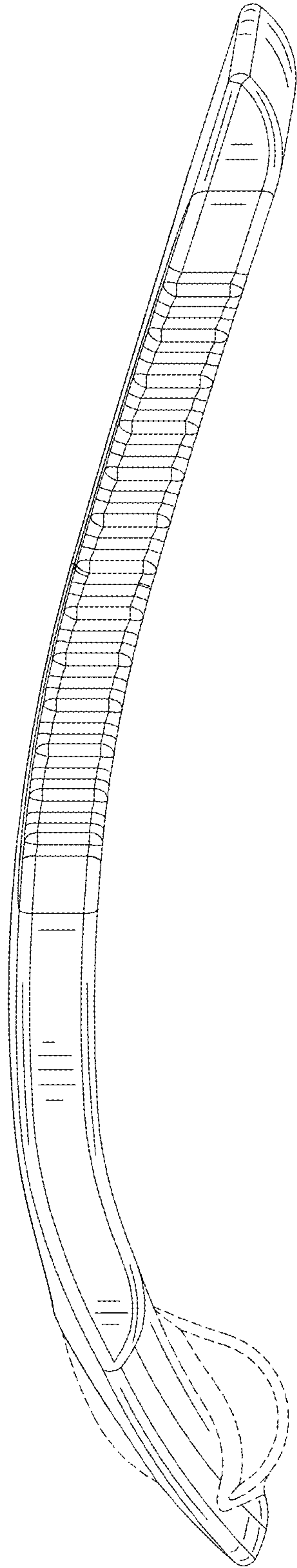

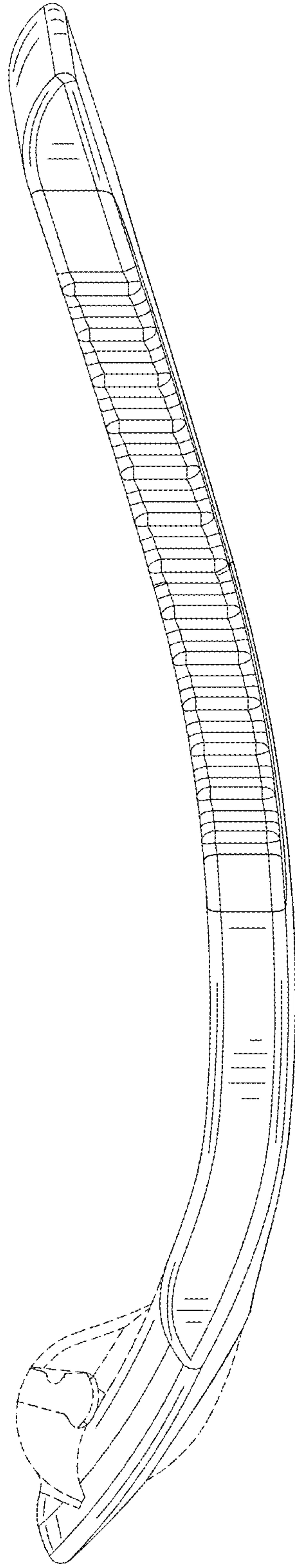

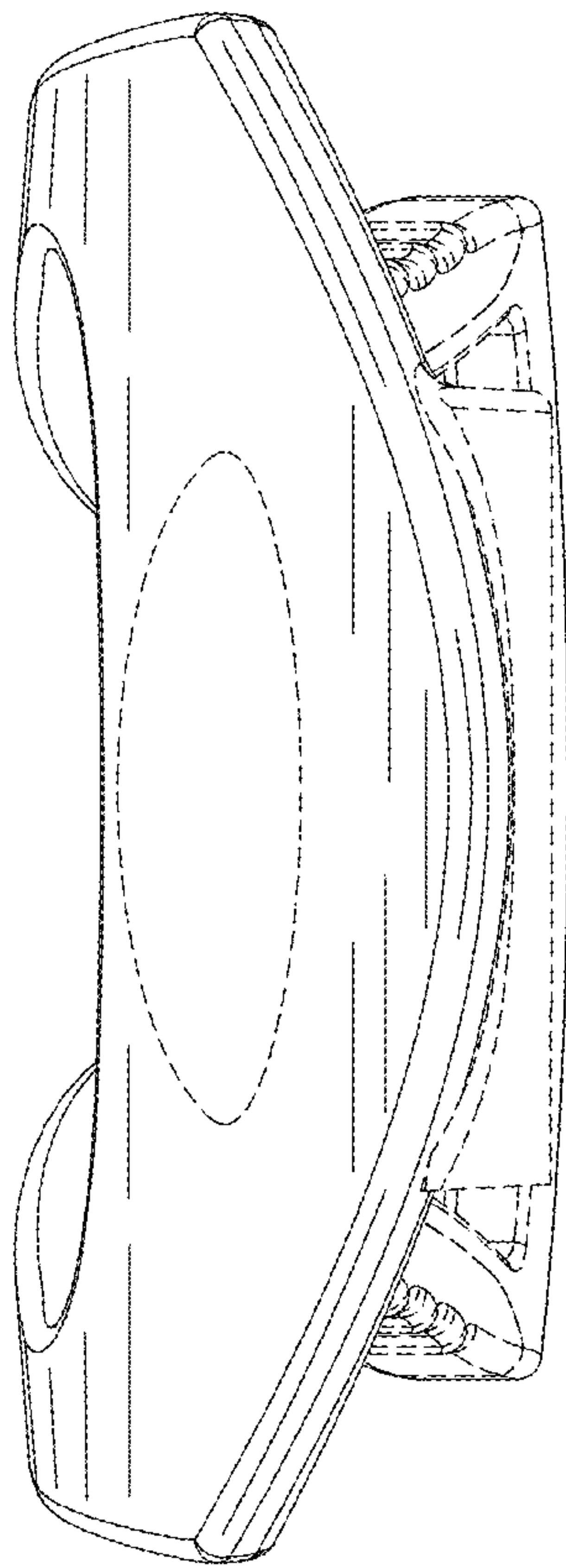

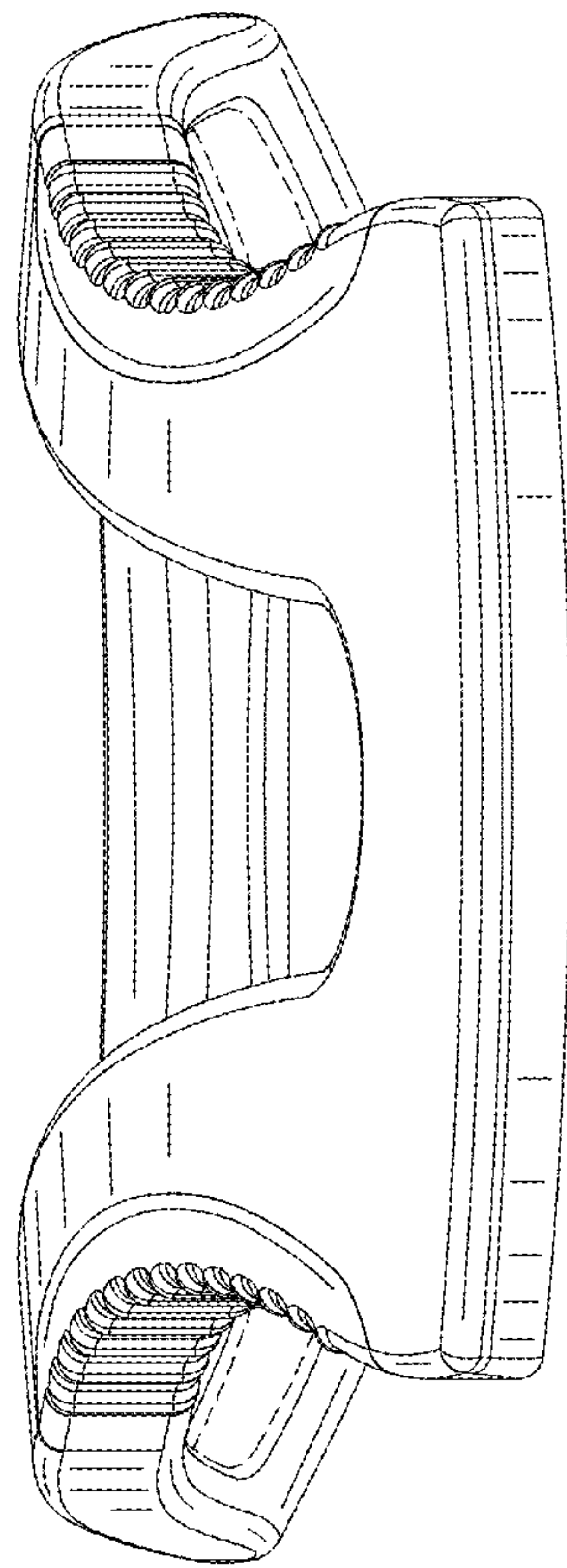
