The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;

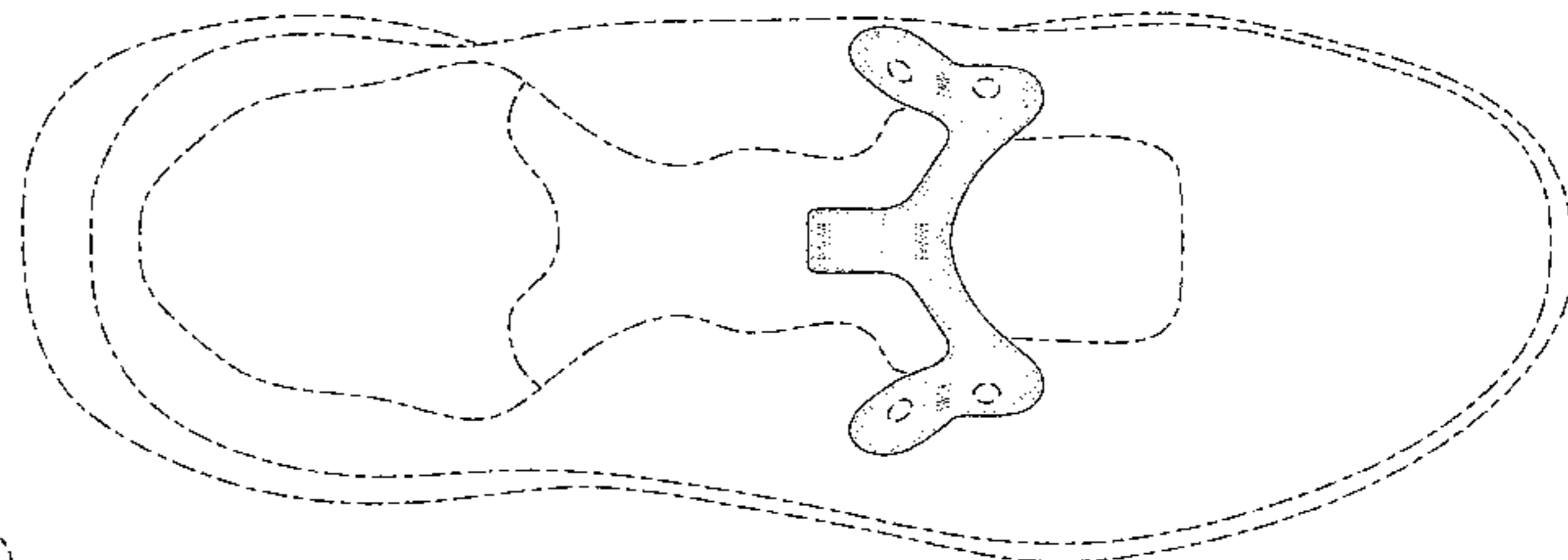
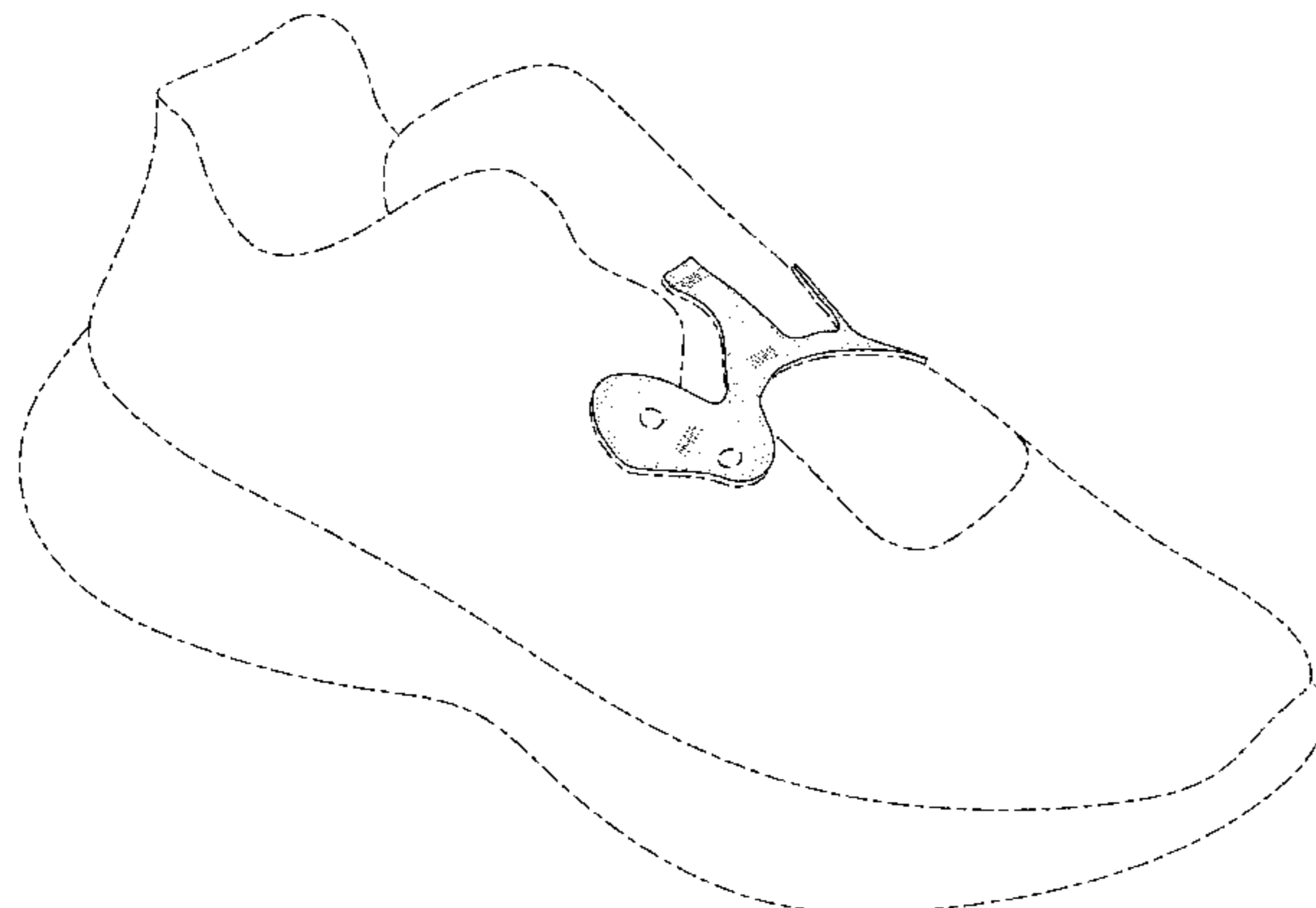
FIG. 2 is a side view thereof;

FIG. 4 is a top view thereof.

The four broken line circles within the shaded area represent eyelets which form no part of the claimed design. The even-length broken lines within the shaded area represent stitching. The uneven-length broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

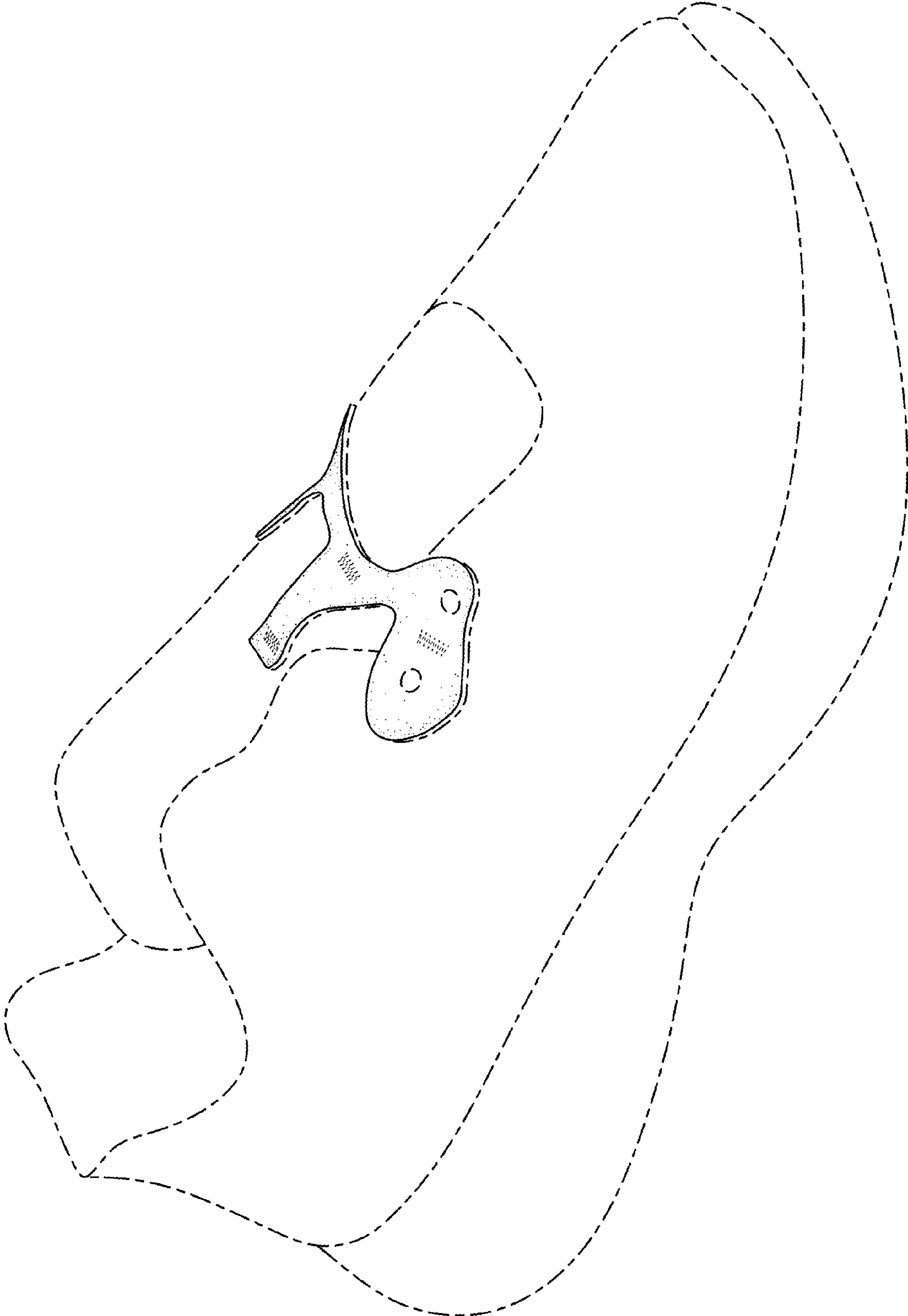

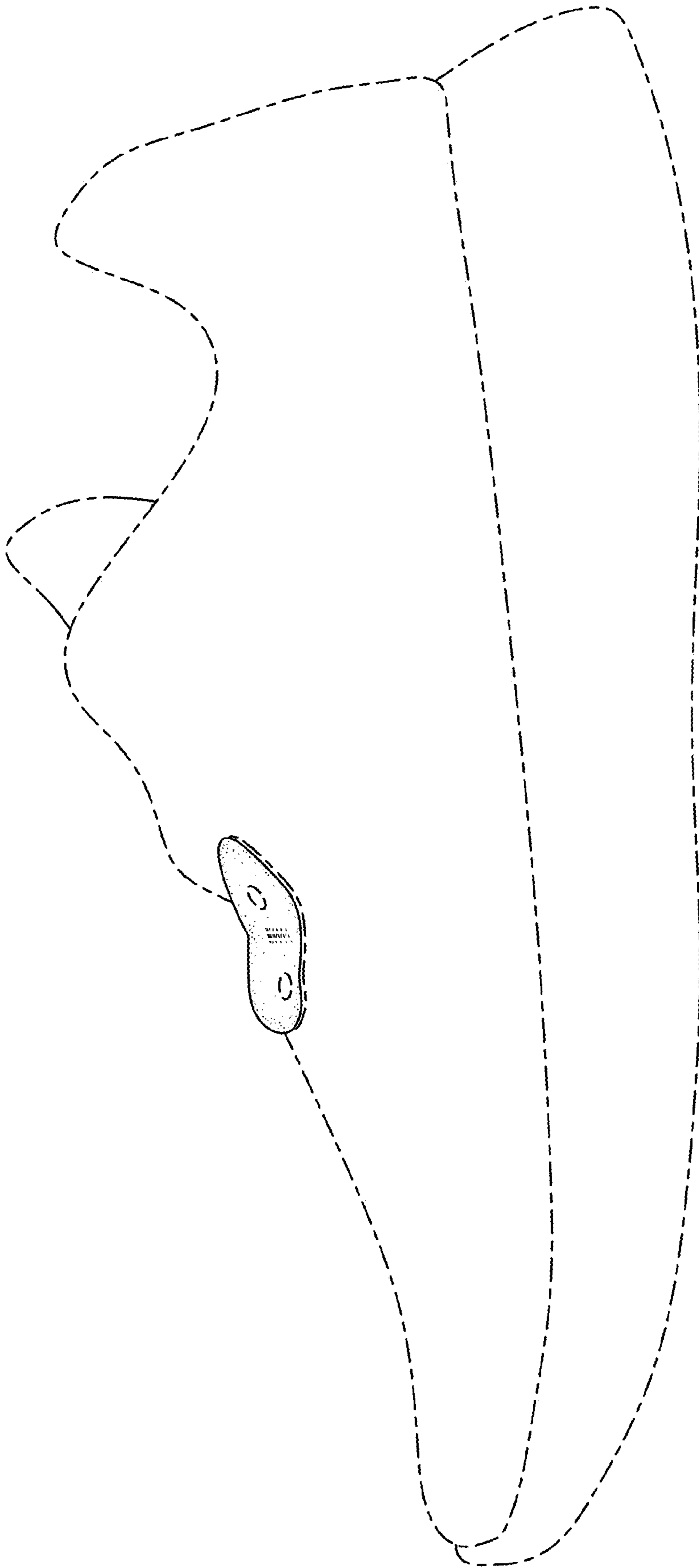

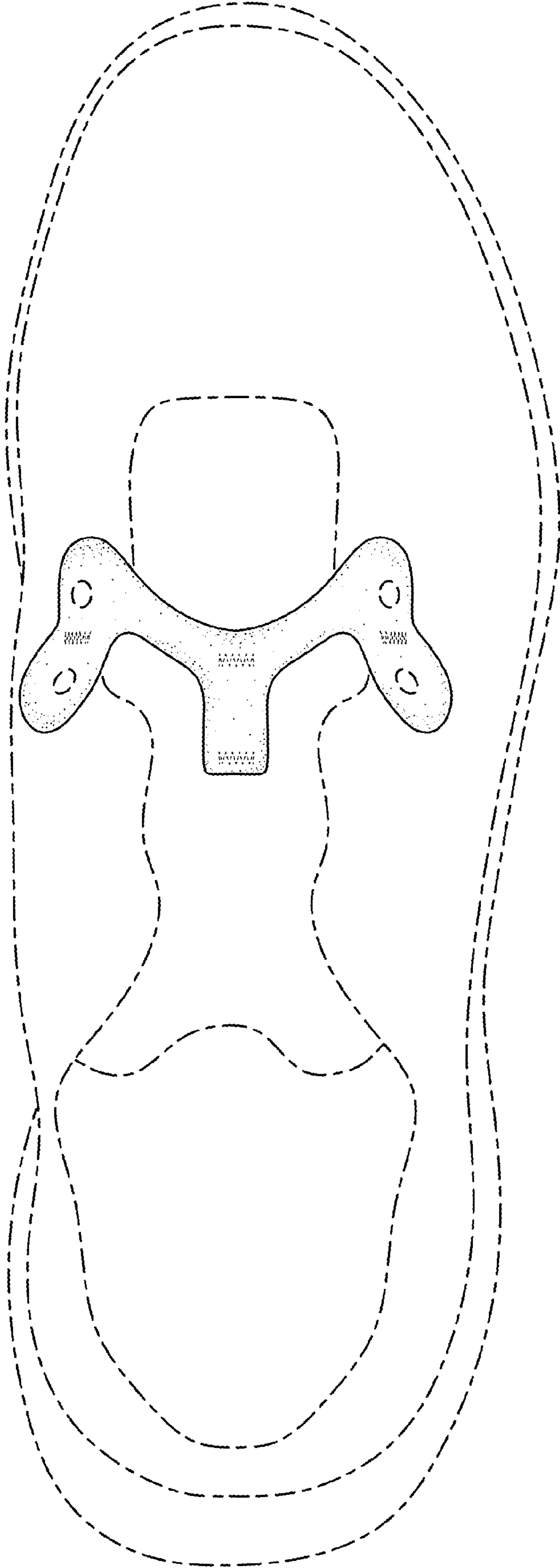
