The ornamental design for a side pack bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a top-front-right perspective view of a side pack bag showing my new design;

FIG. 2 is a bottom-rear-left perspective view thereof;

FIG. 3 is a top-rear-right perspective view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a rear elevational view thereof;

FIG. 6 is a right elevational view thereof;

FIG. 7 is a left elevational view thereof;

FIG. 8 is a top plan view thereof;

FIG. 9 is a bottom plan view thereof;

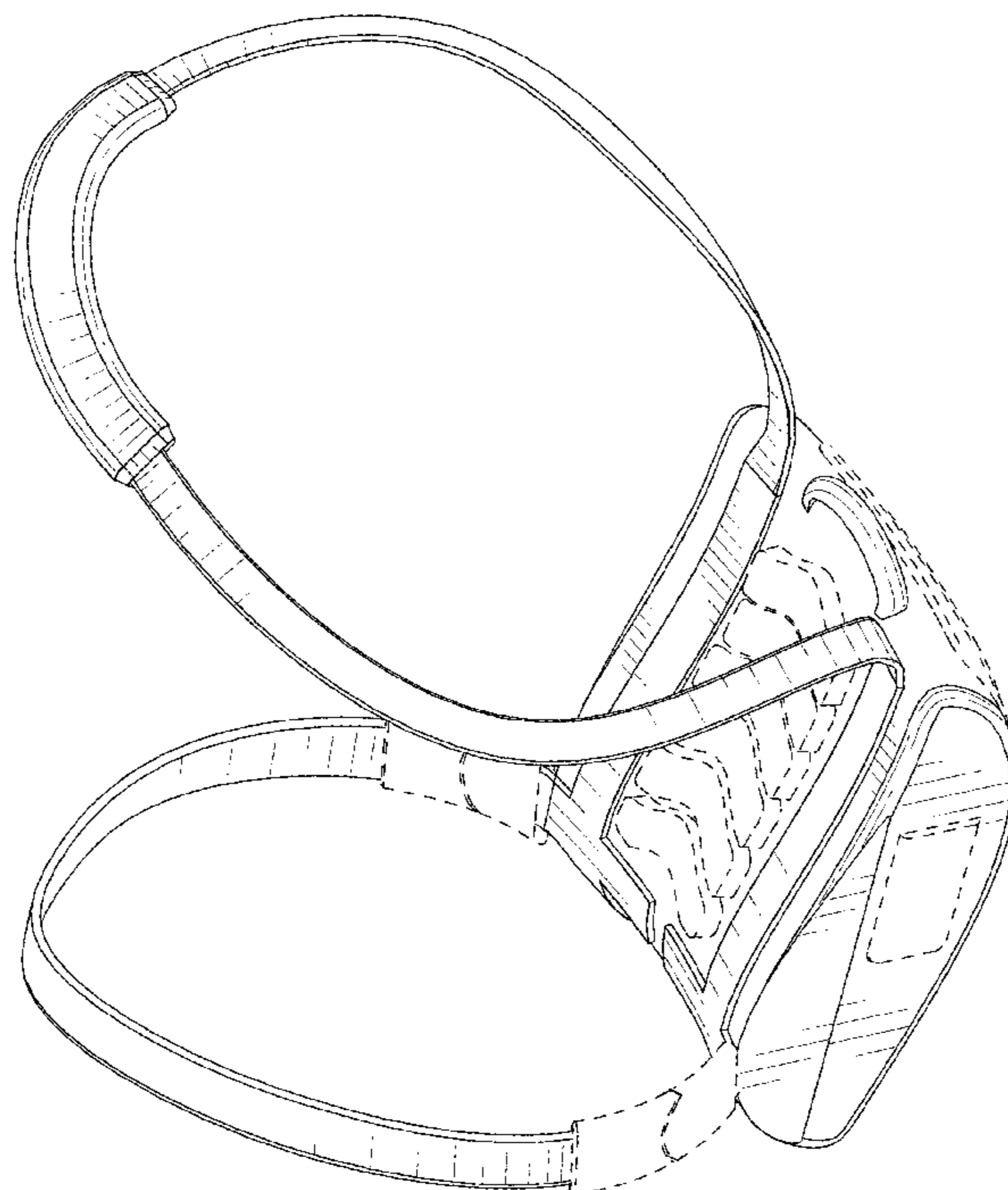
FIG. 10 is a top-rear-right perspective view thereof, wherein the side pack bag has been mounted to an exemplary mannequin; and,

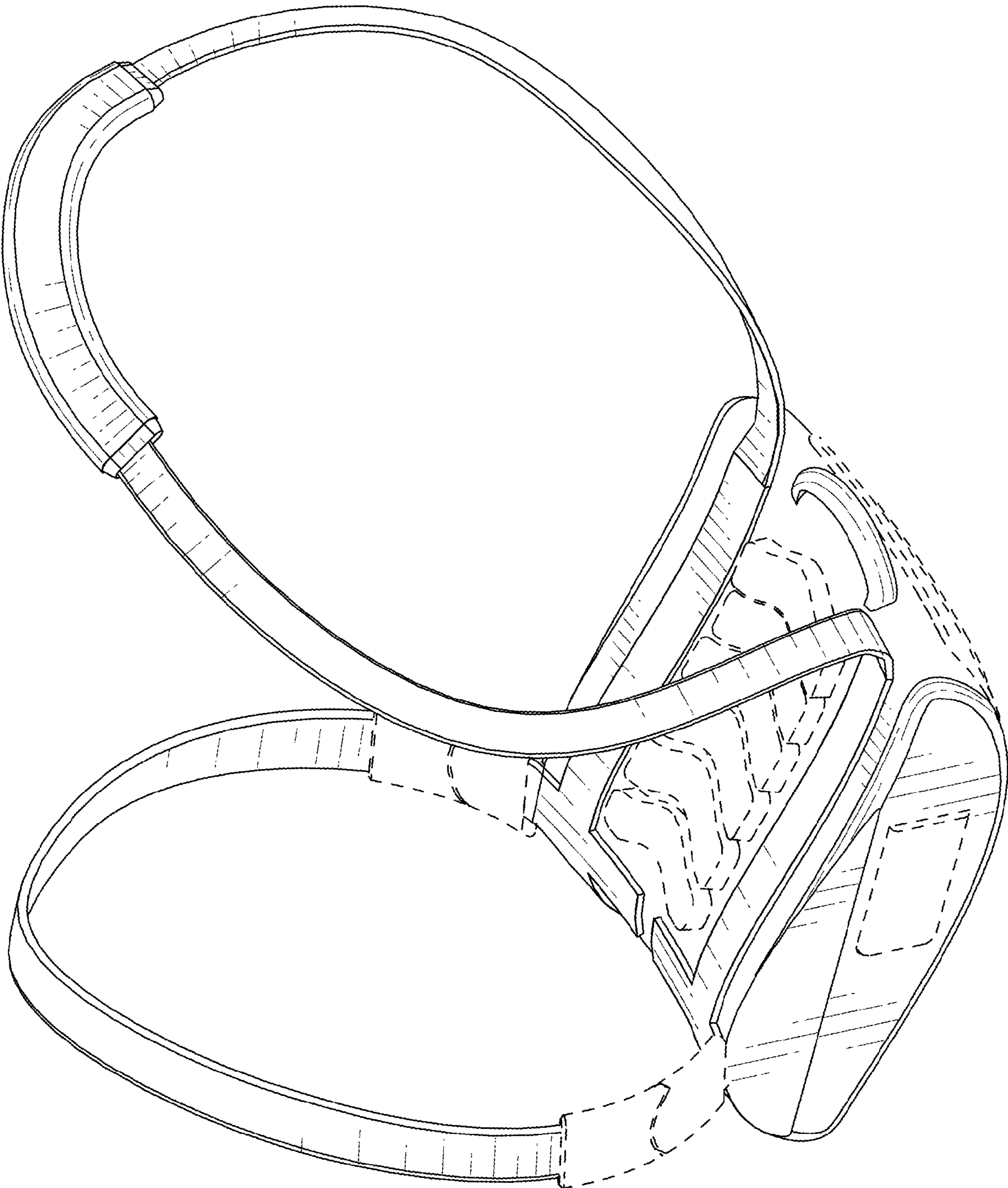

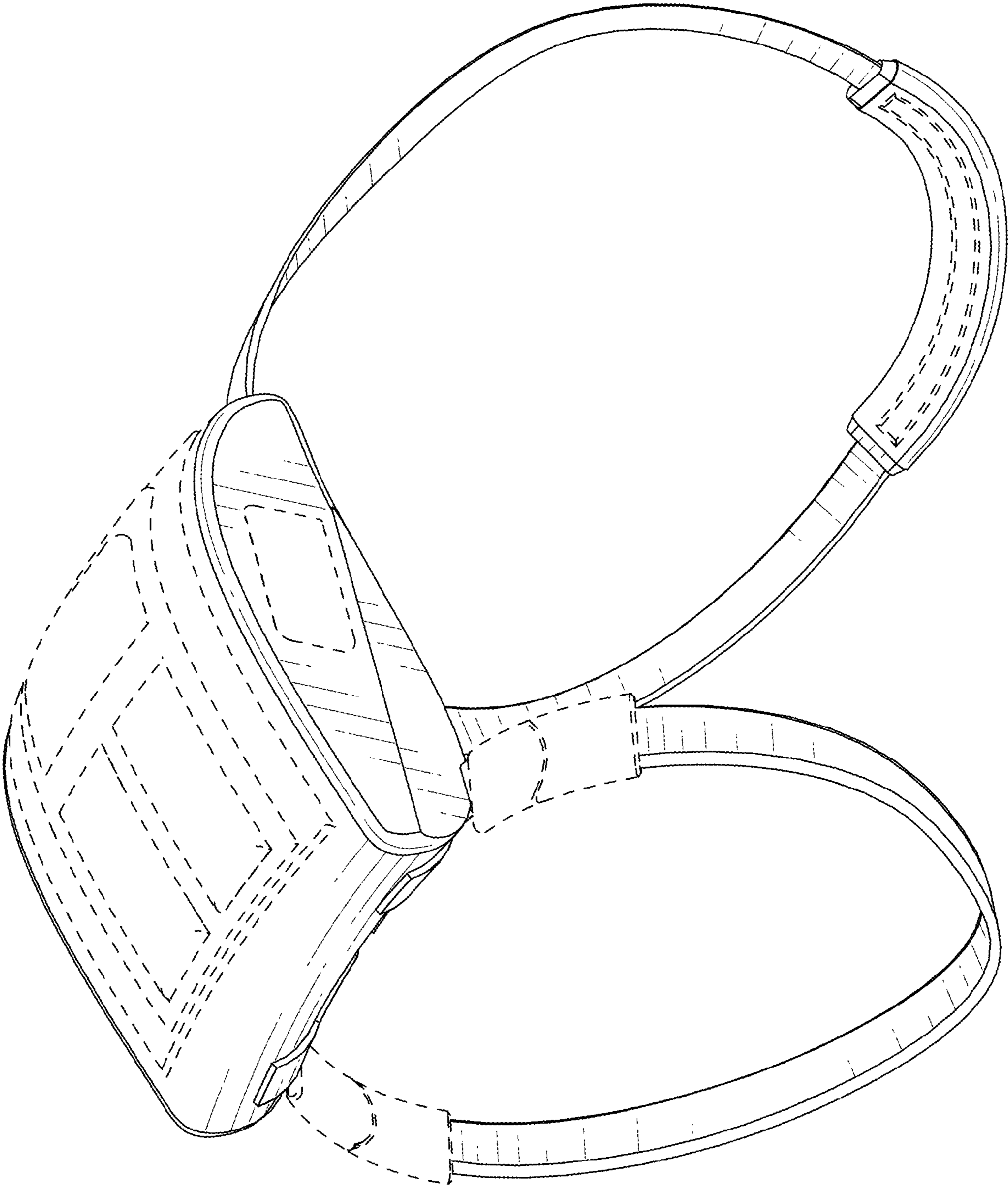

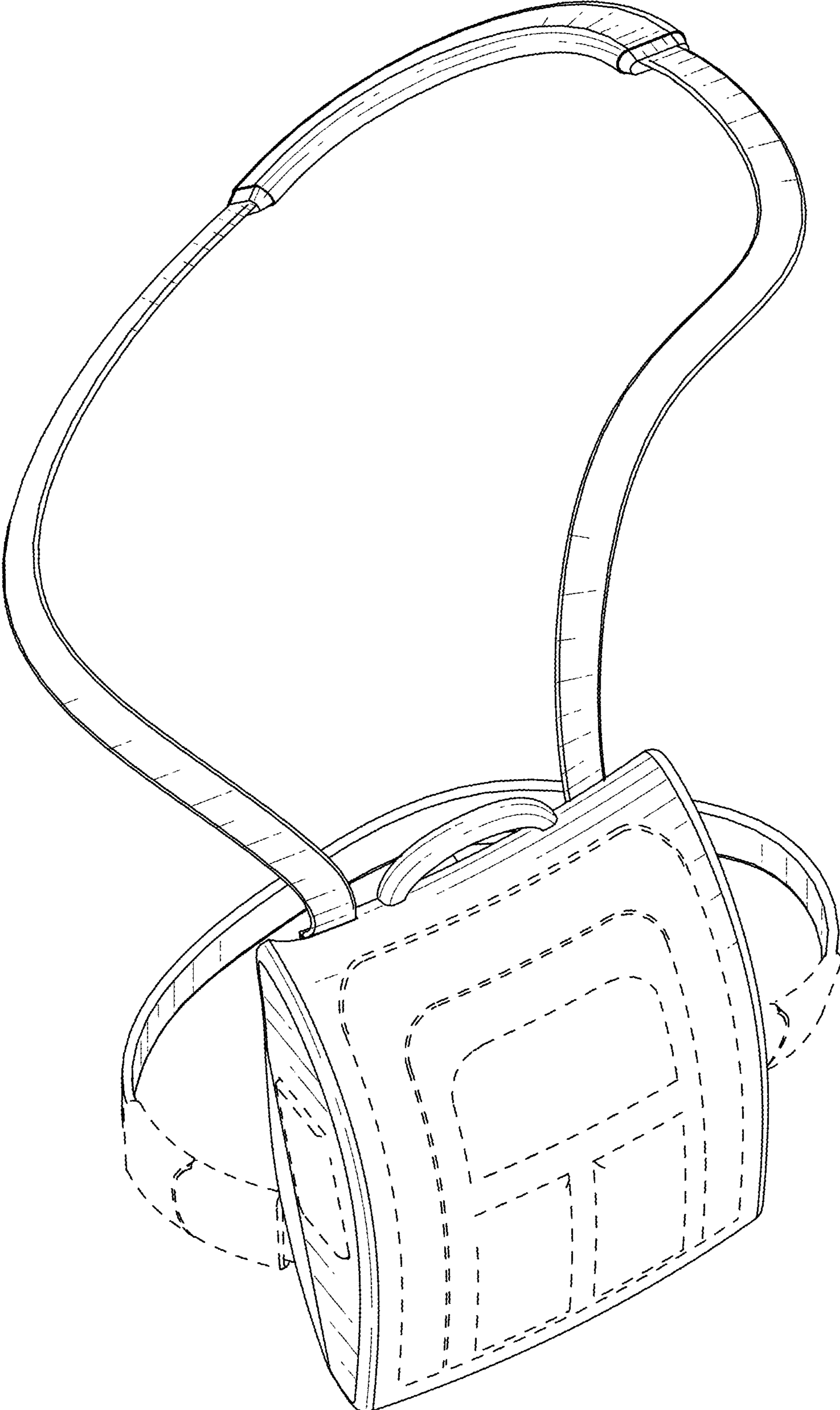

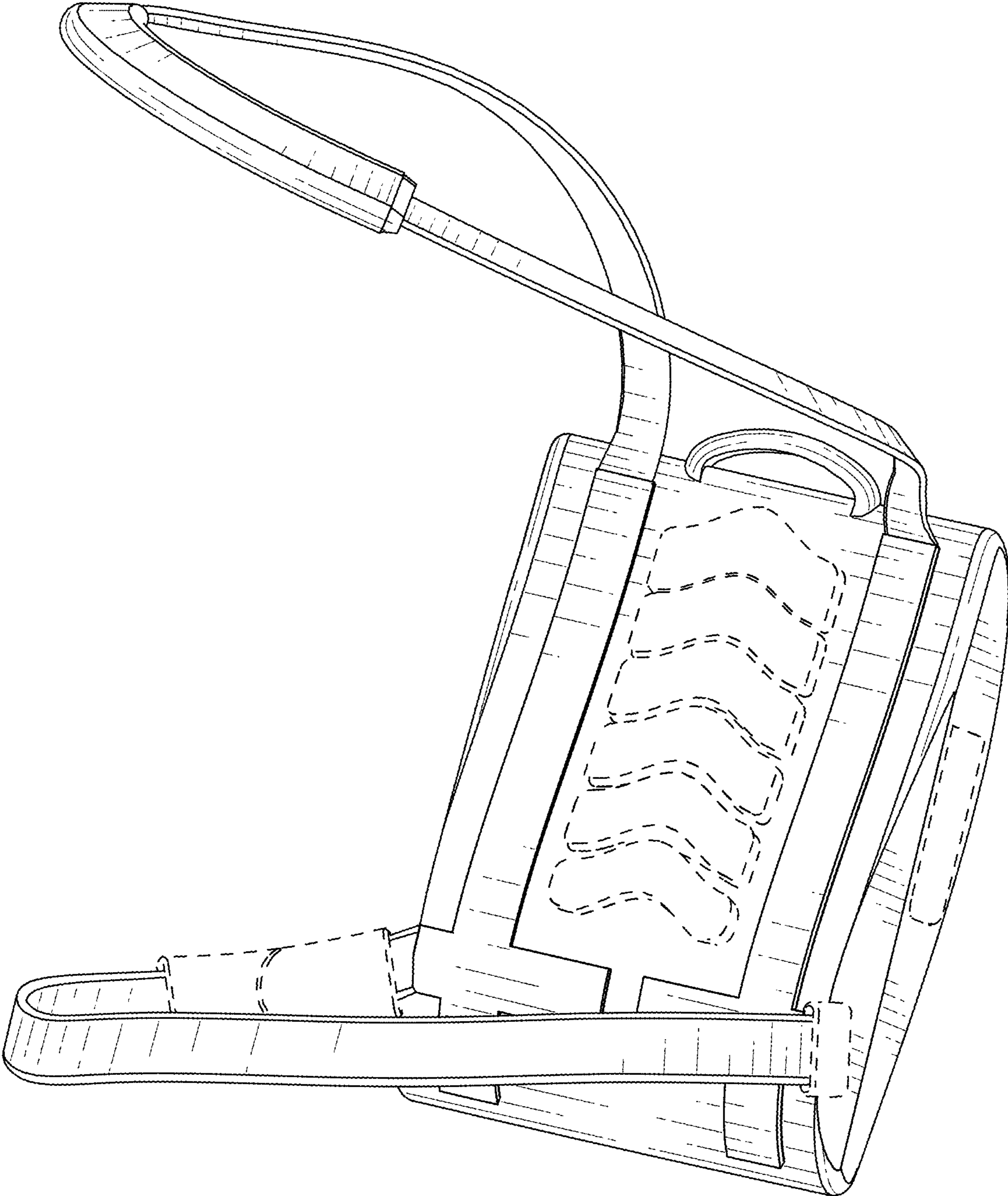

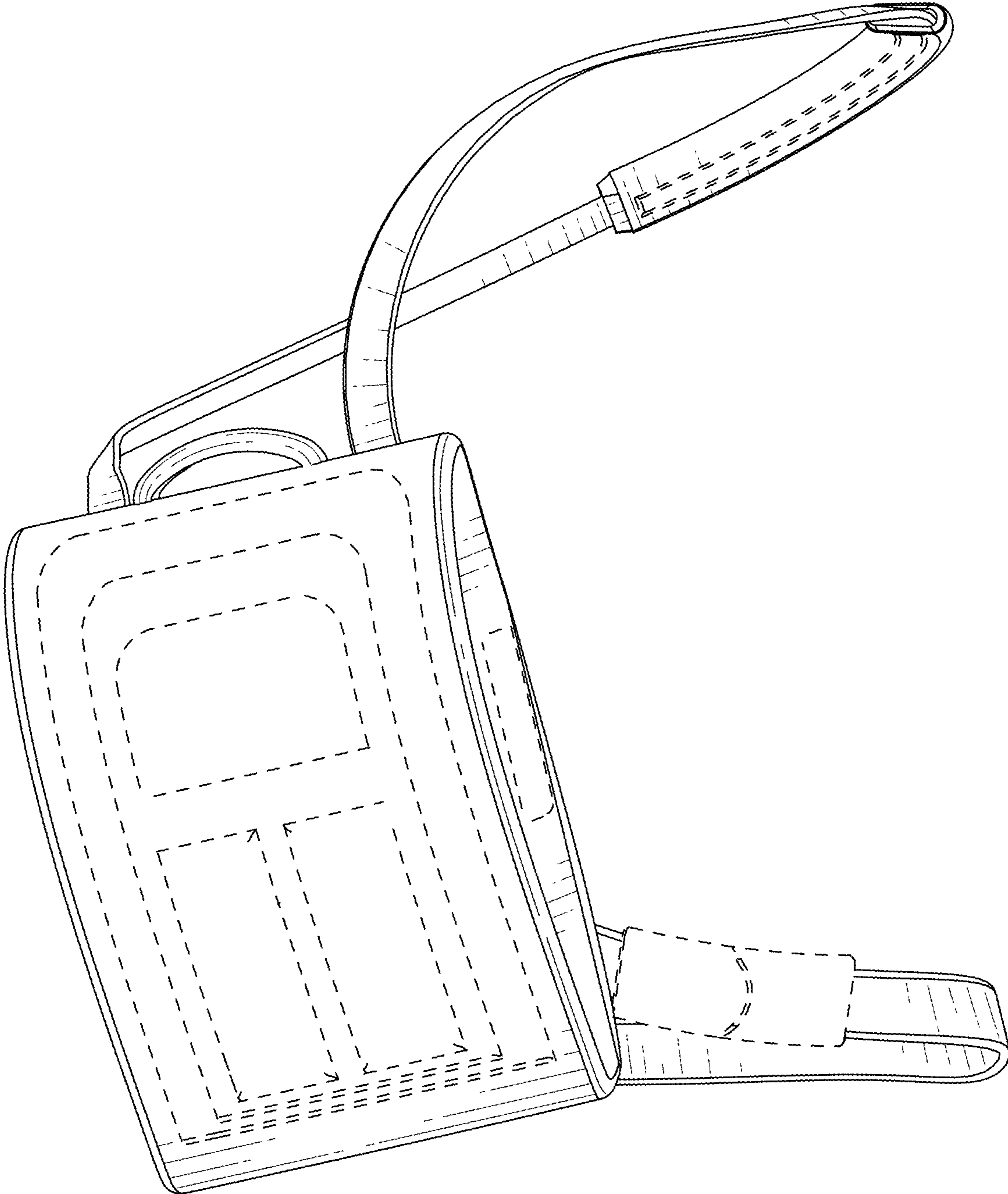

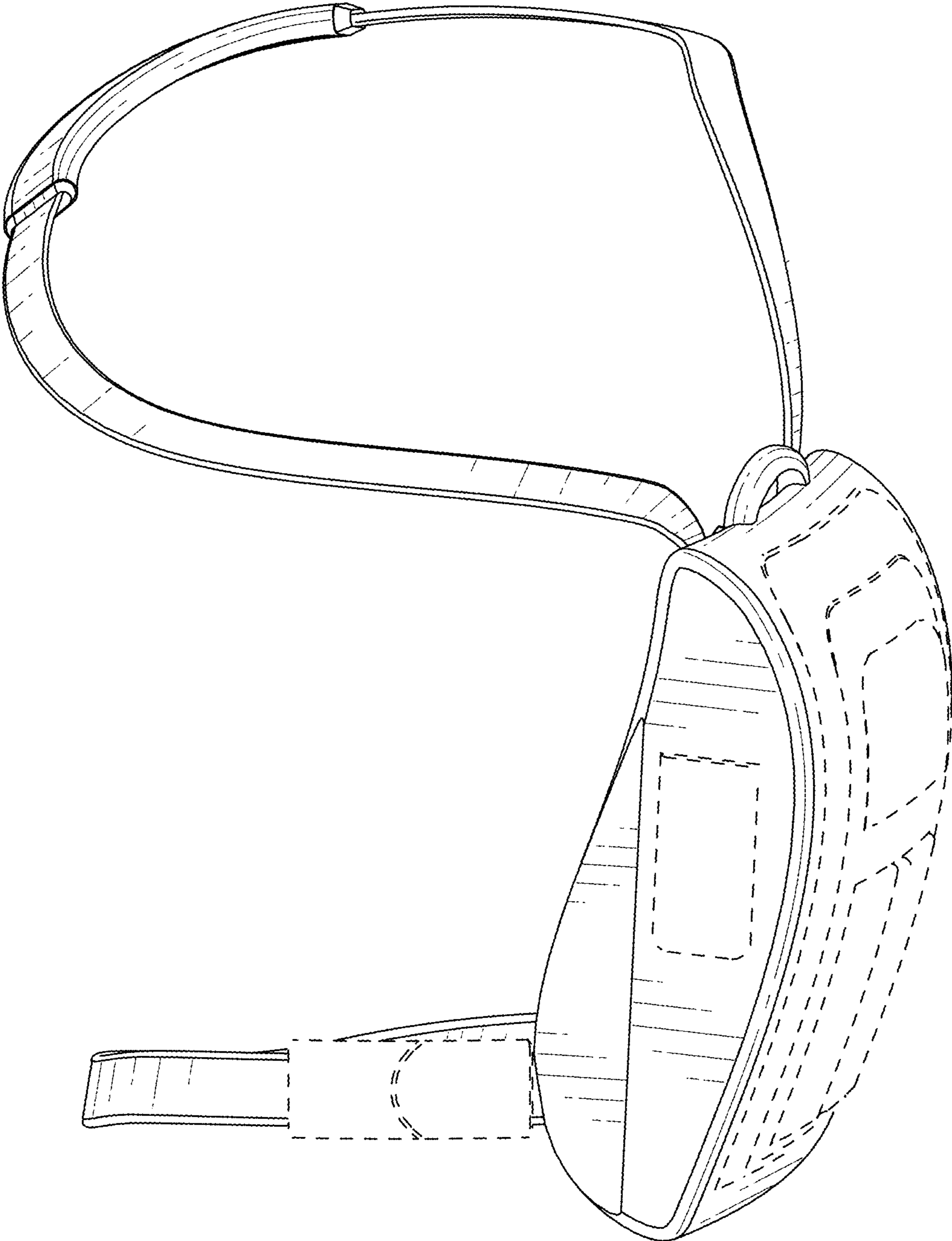

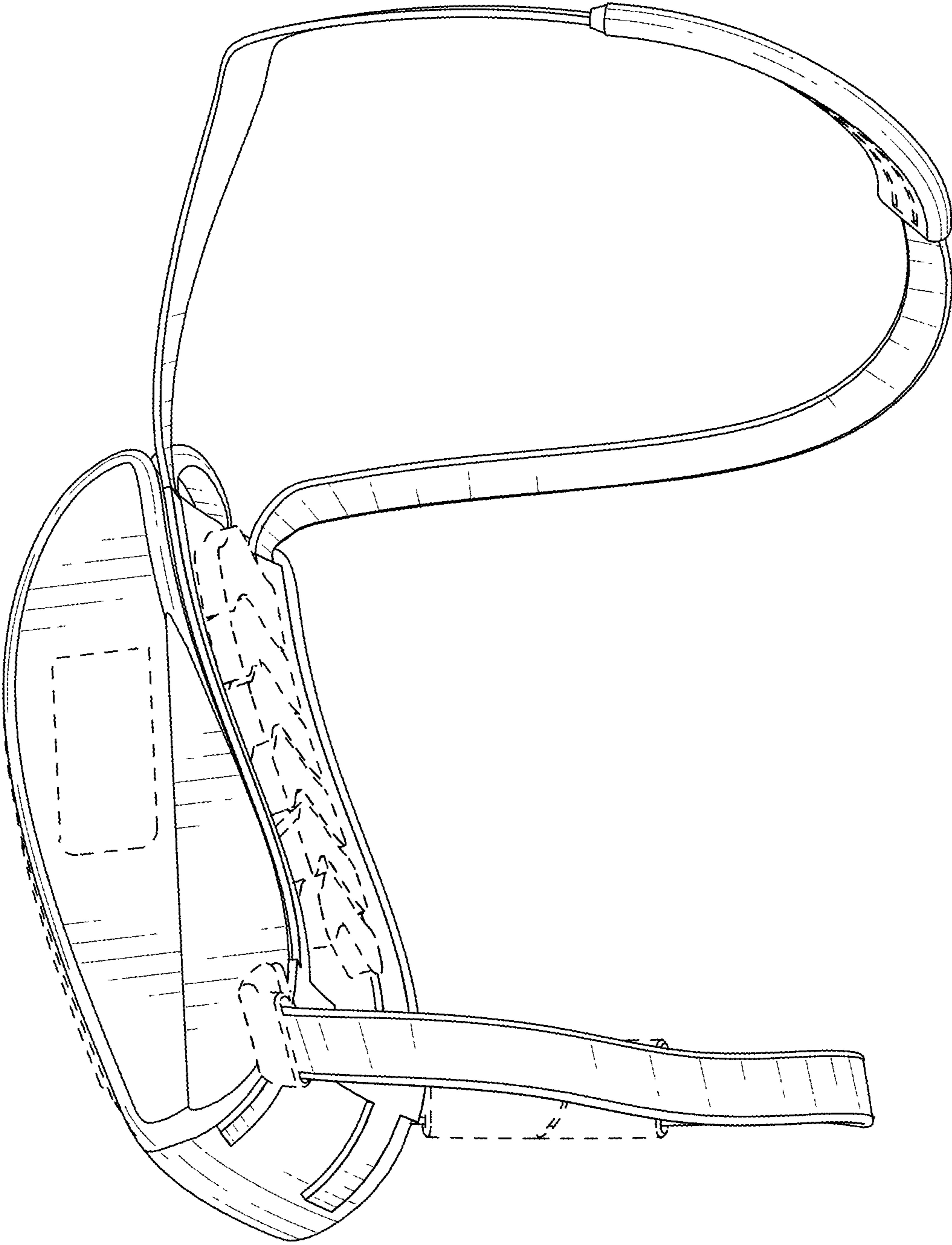

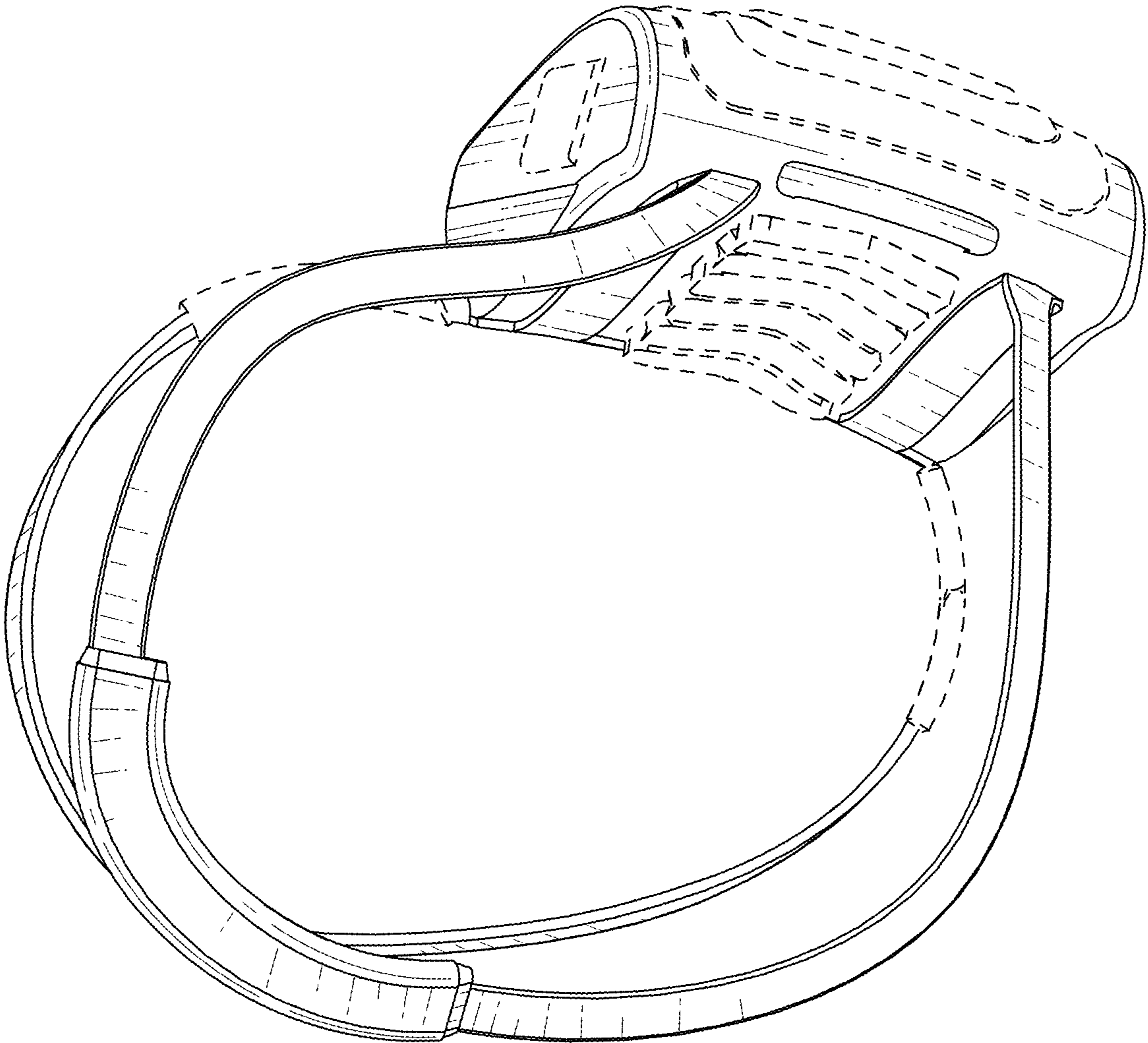

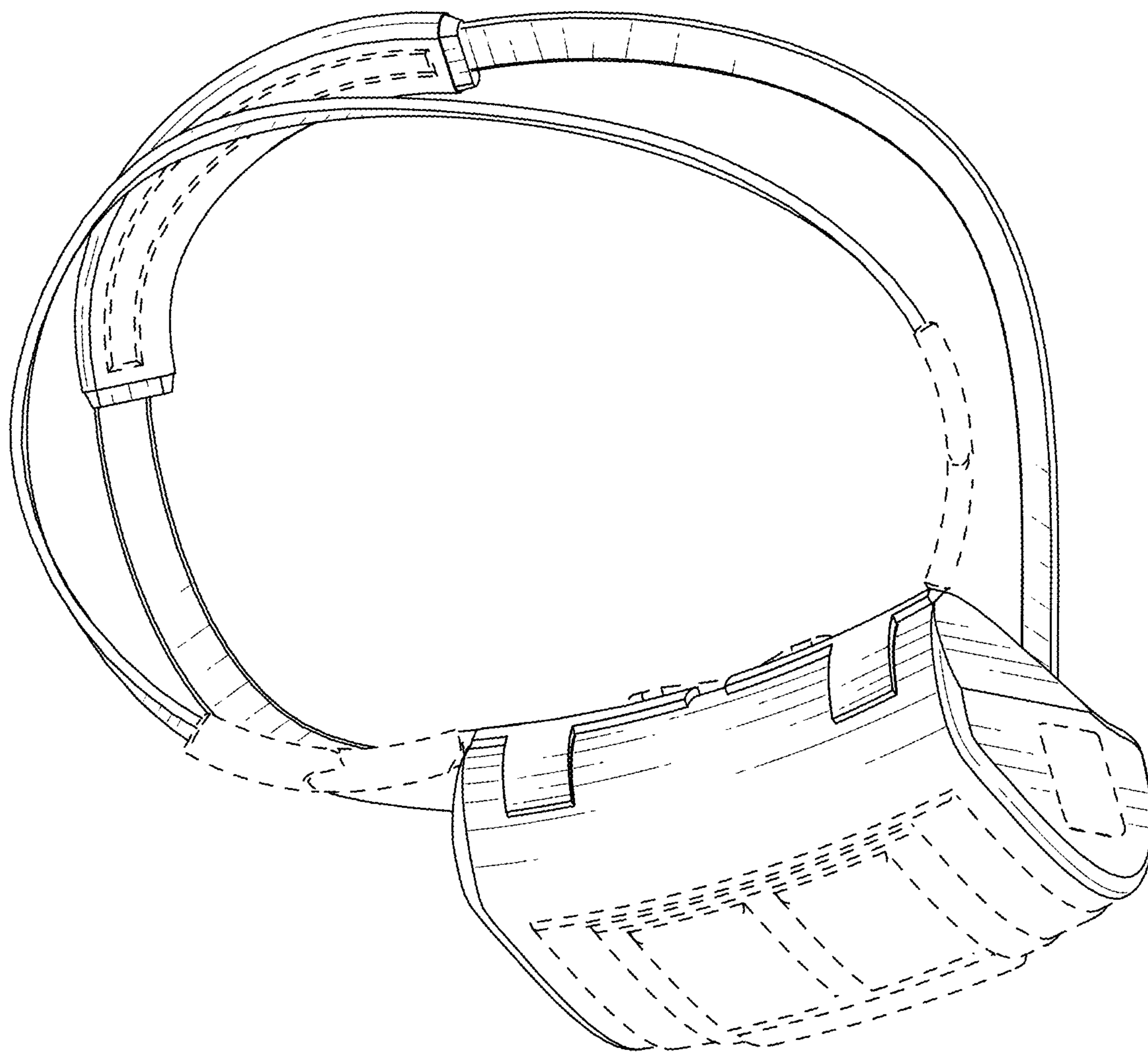

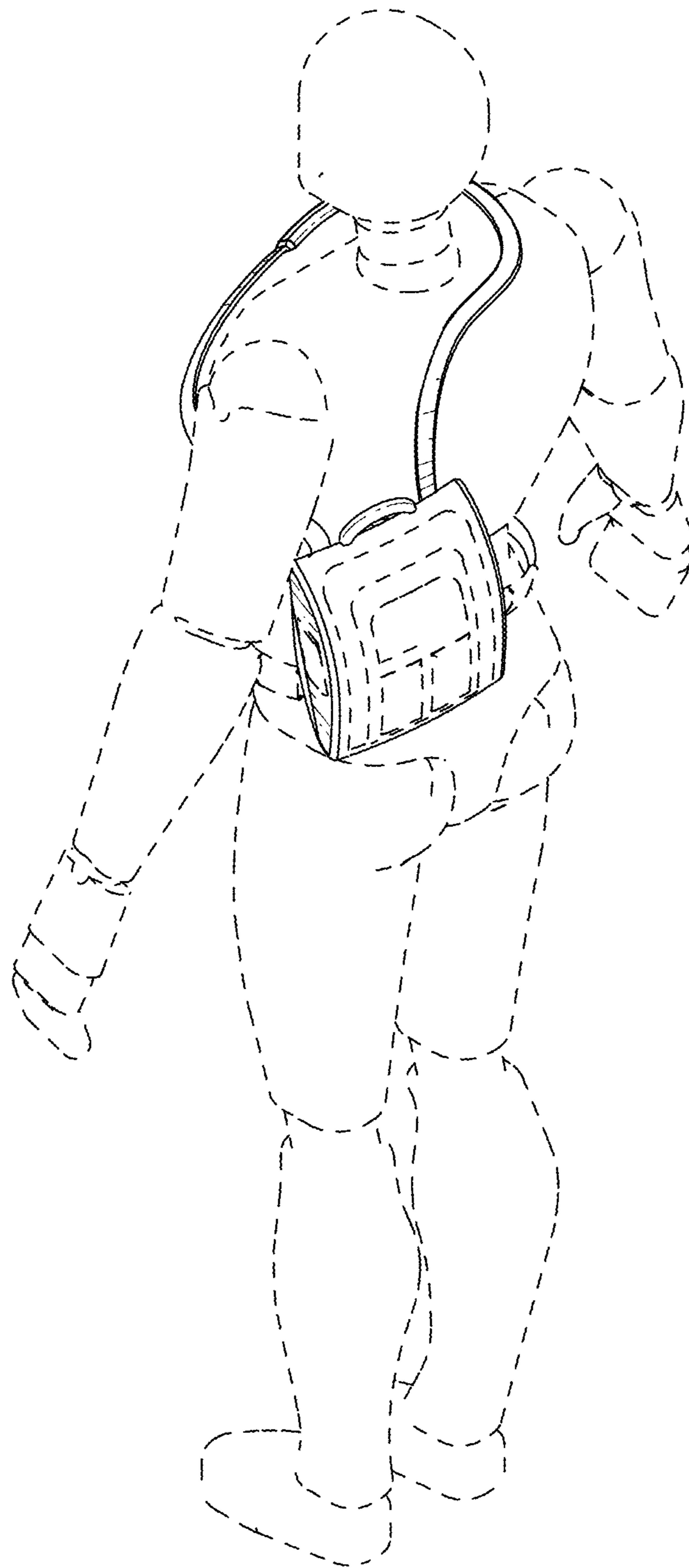

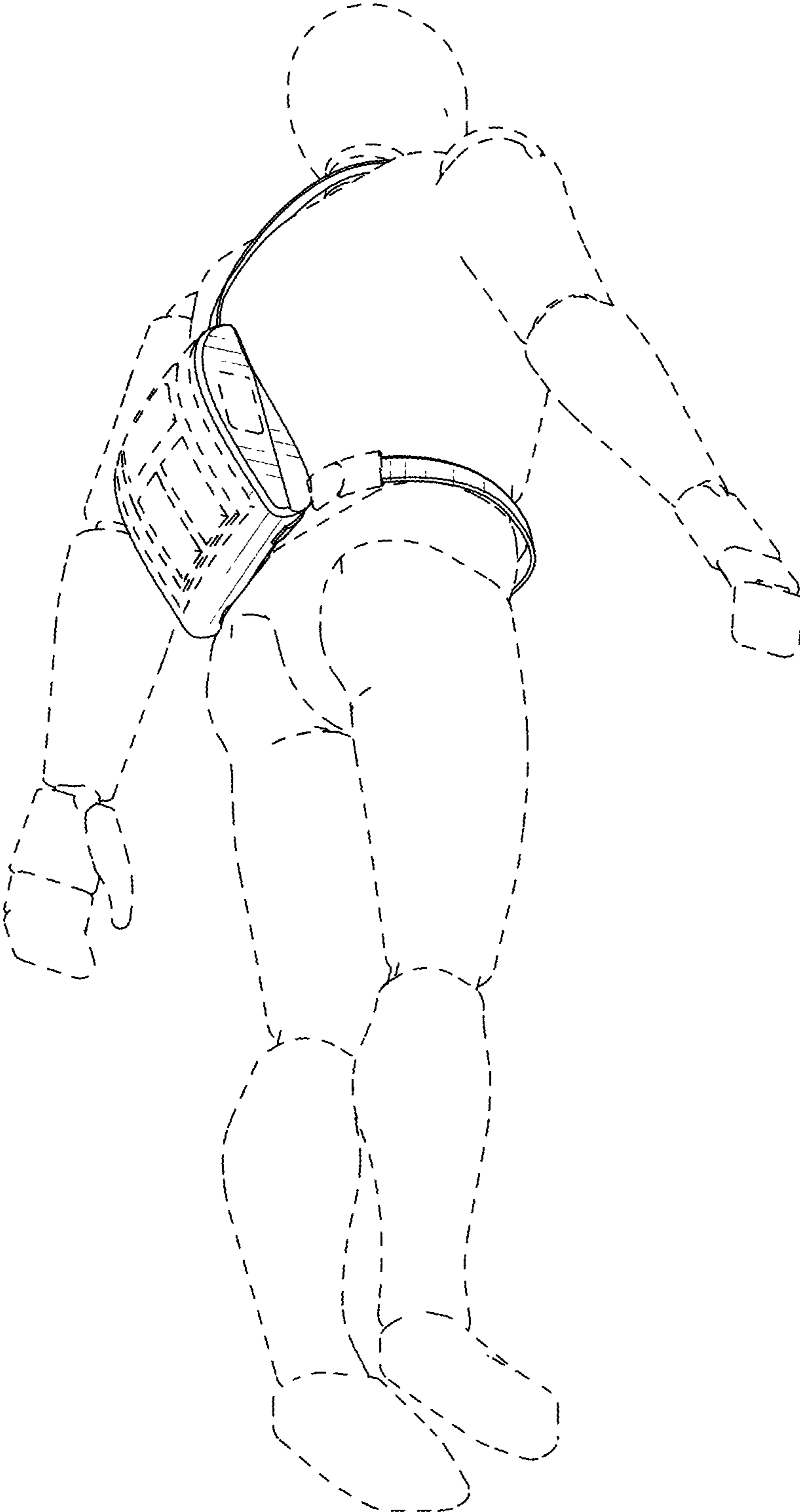
