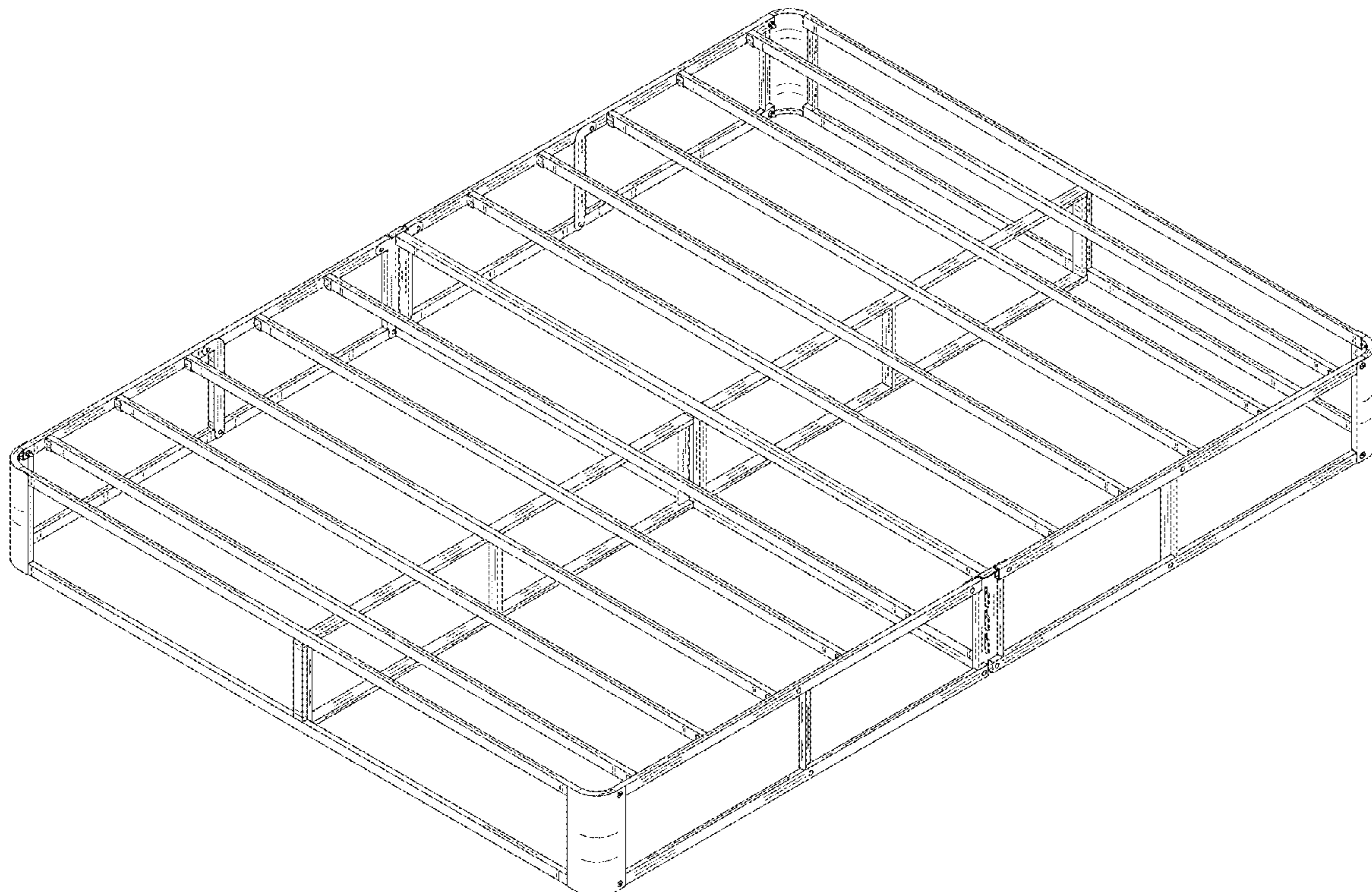
The ornamental design for a metal bed, as shown and described.

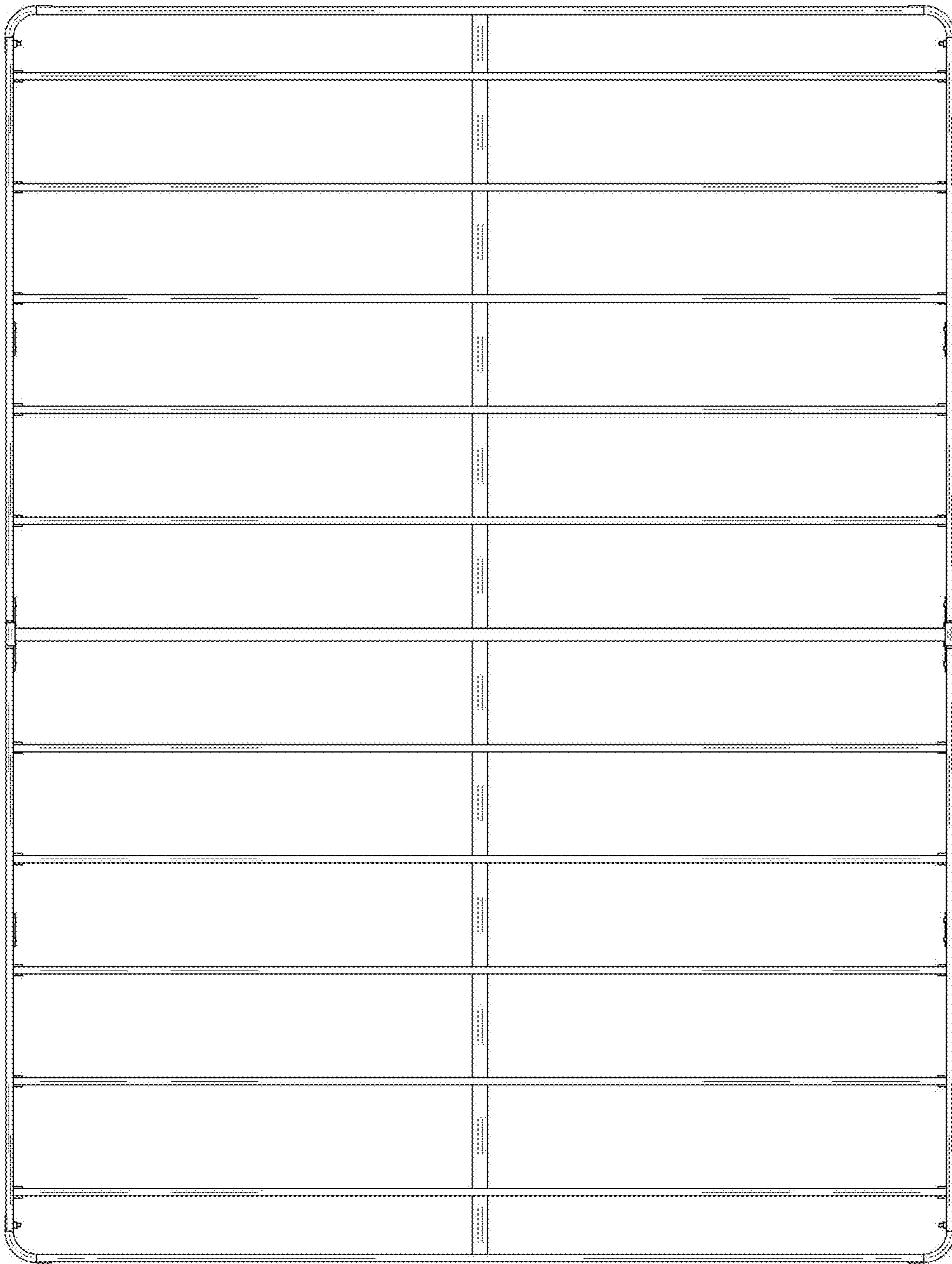

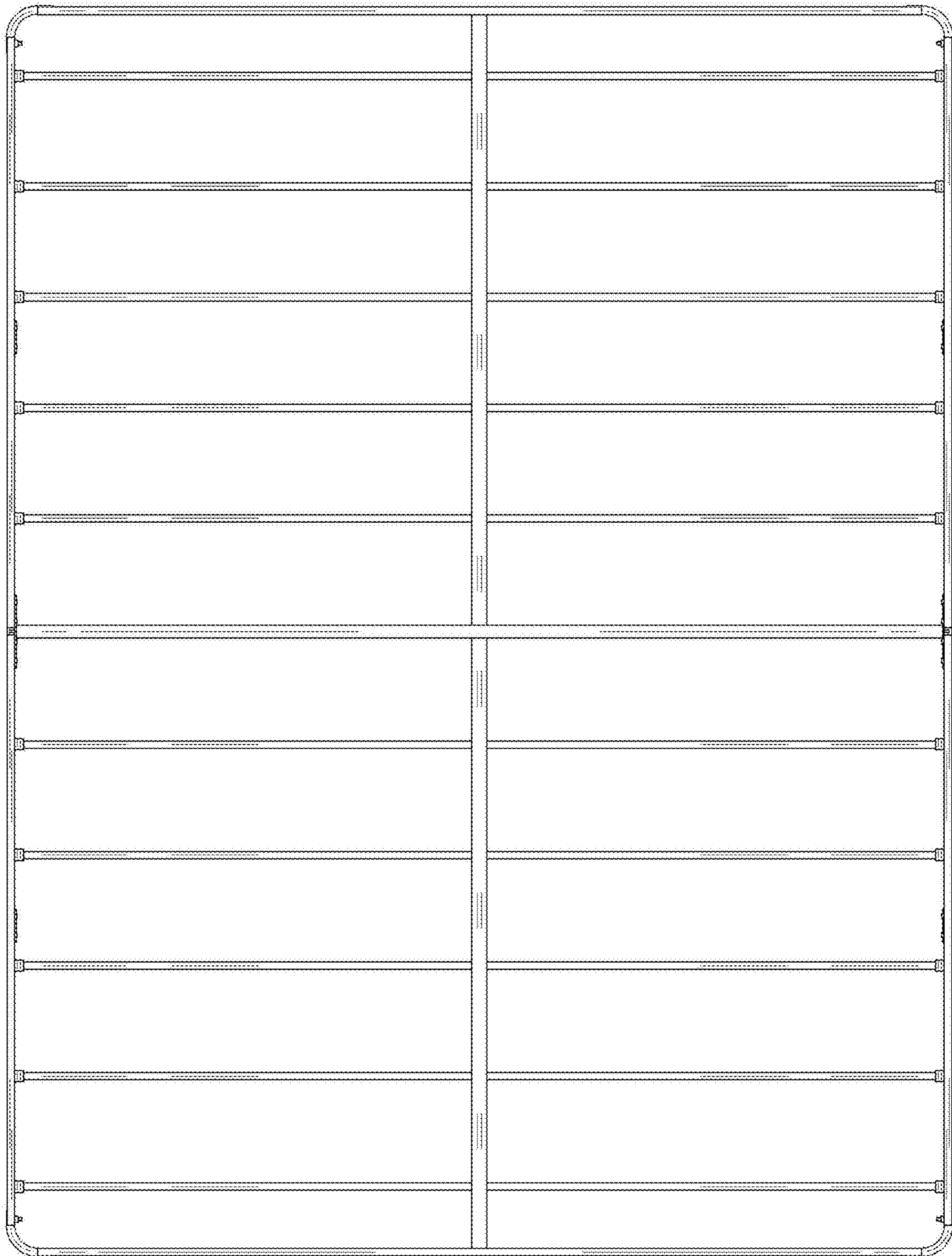

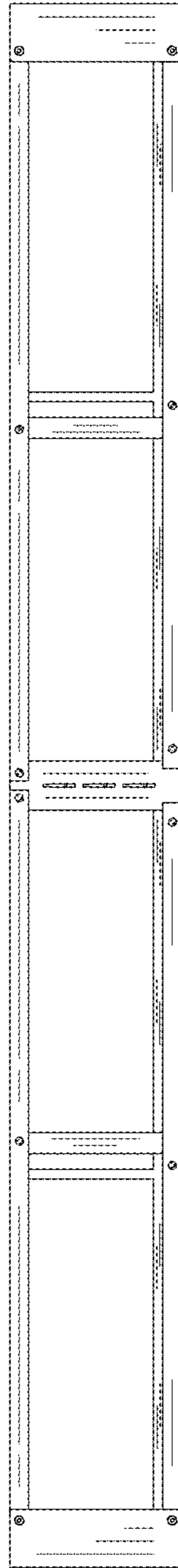

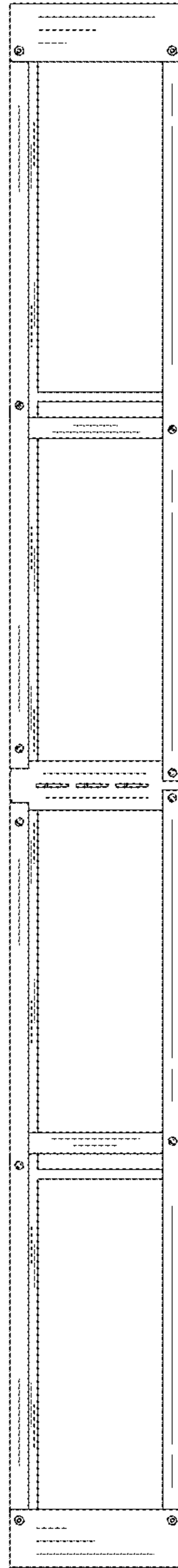

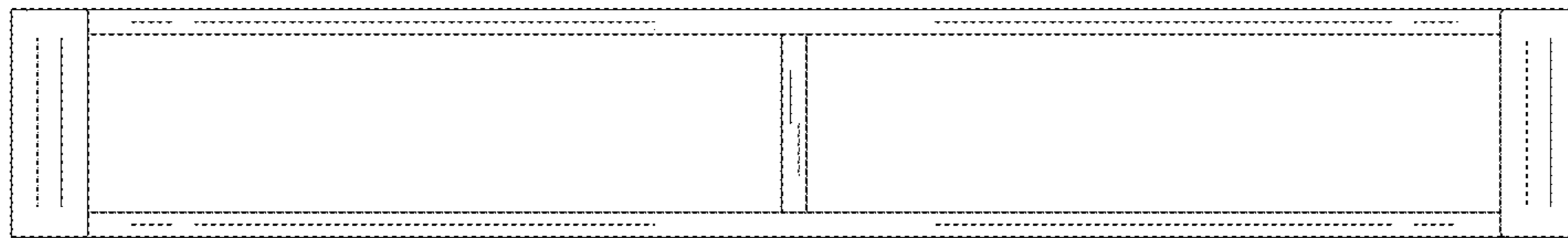

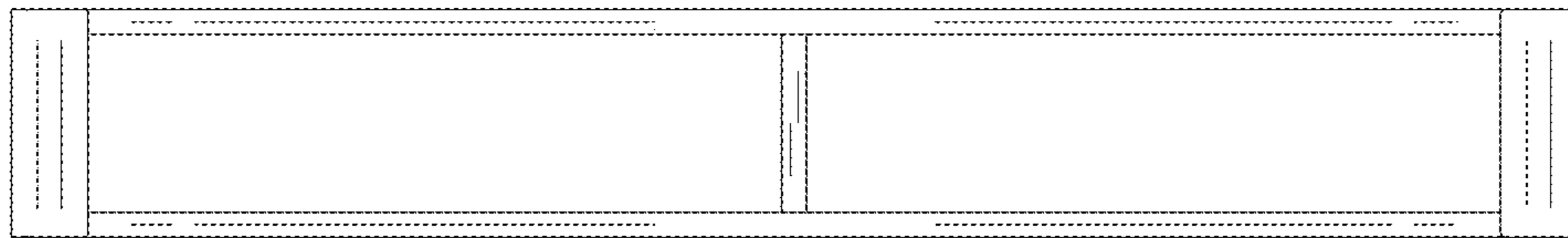

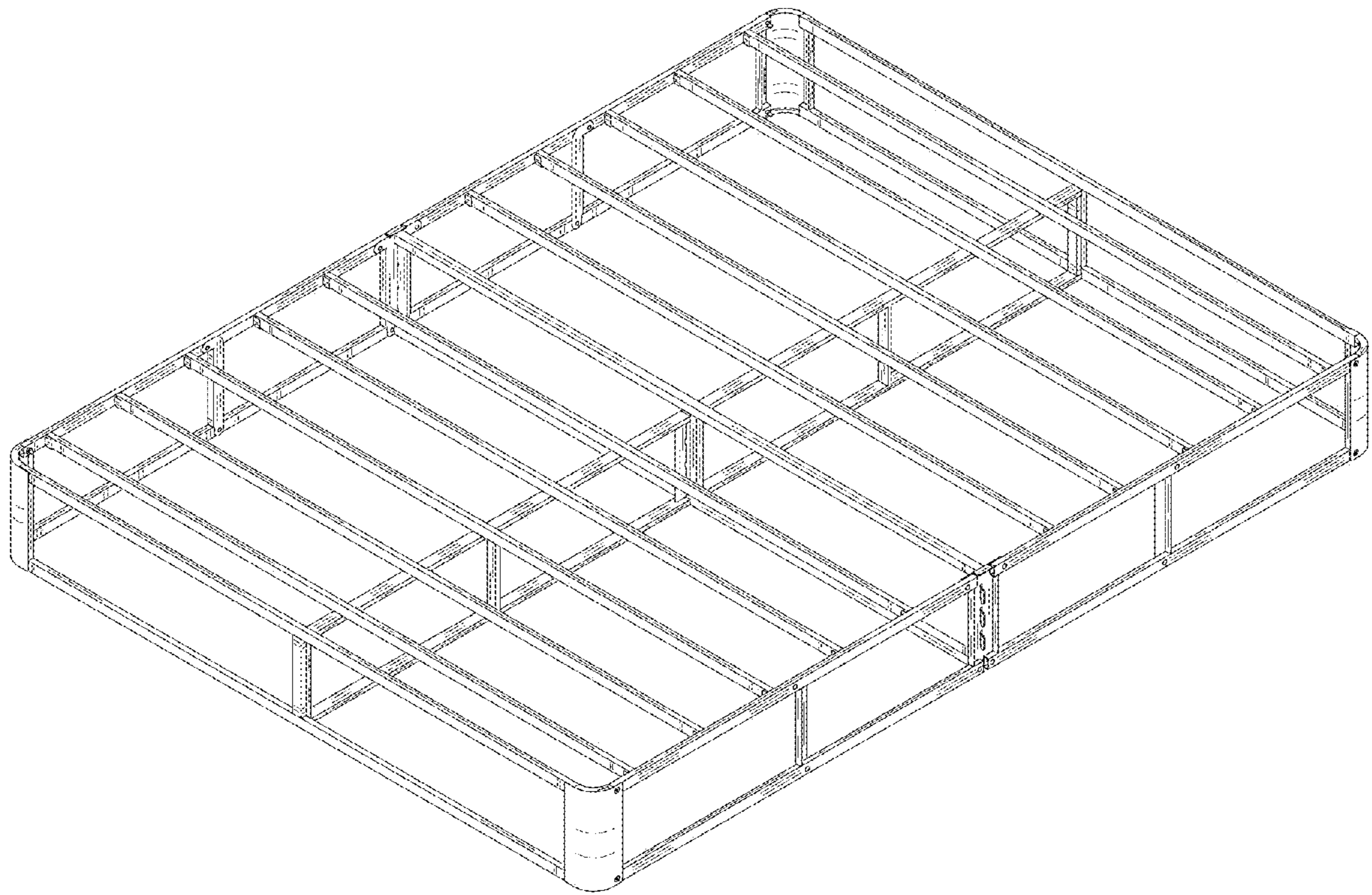
