DESCRIPTION

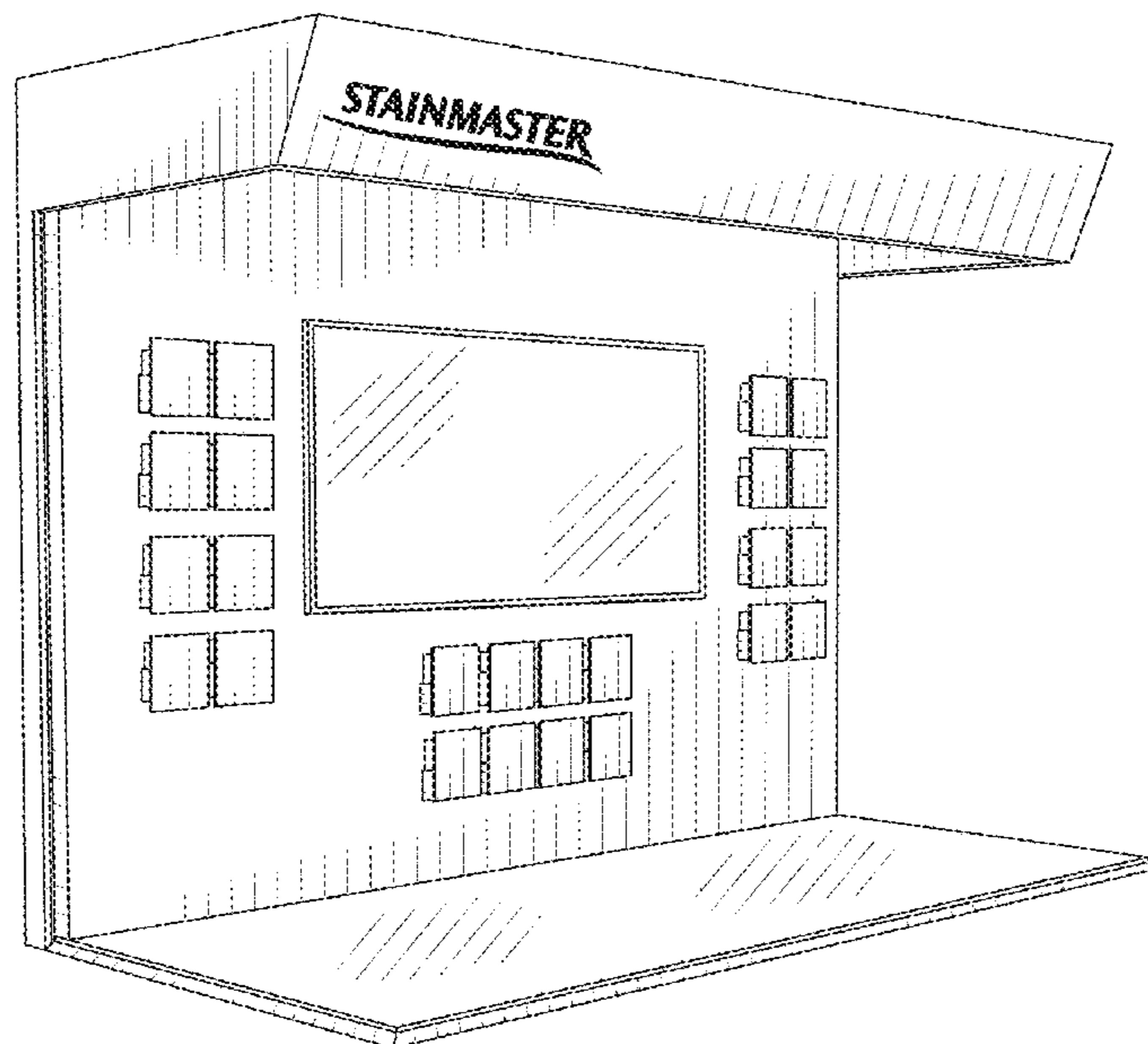
FIG. 1 is a front view of a walk-in structure (e.g., a walk-in booth or a walk-in kiosk), showing our new design.

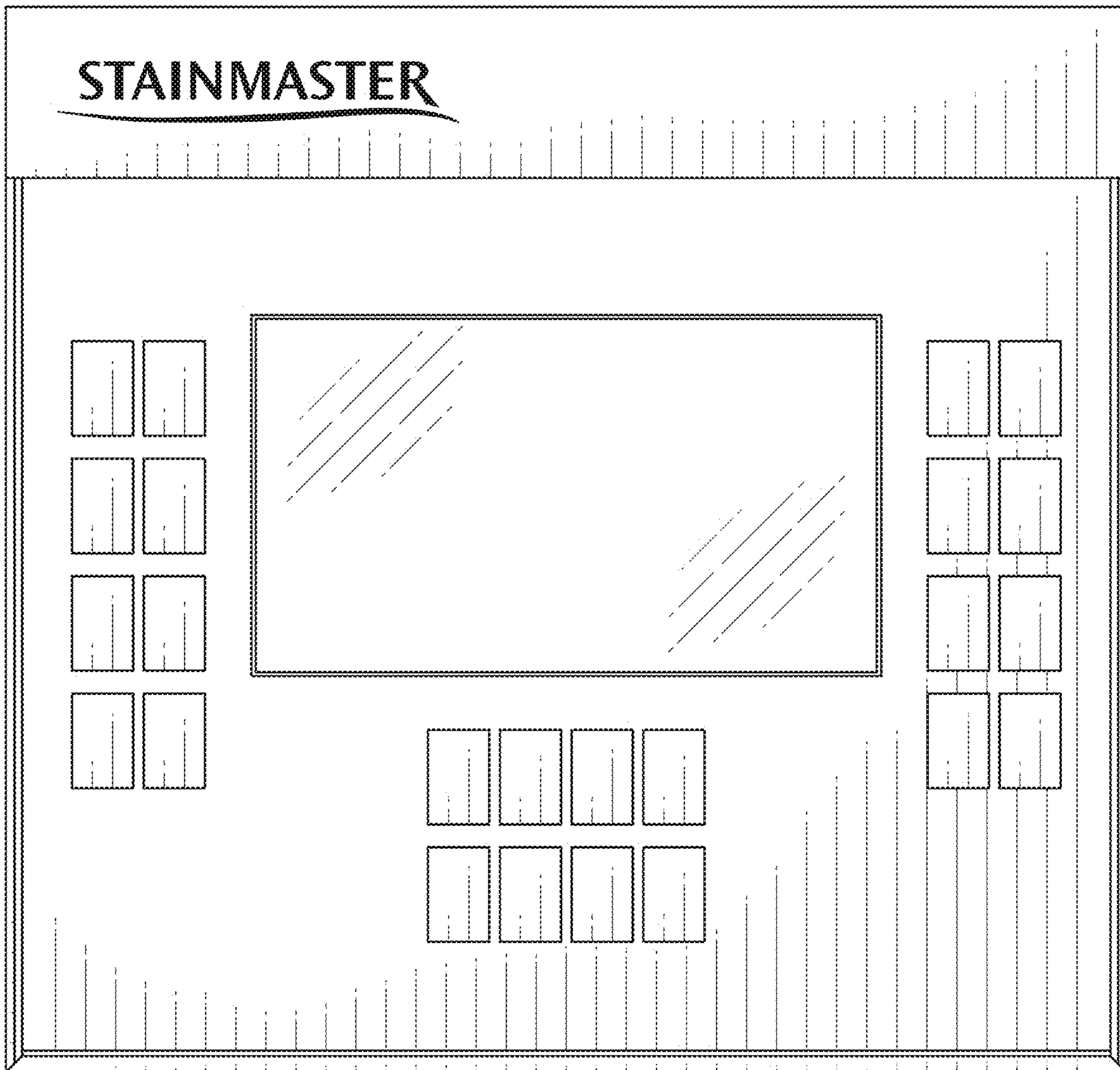

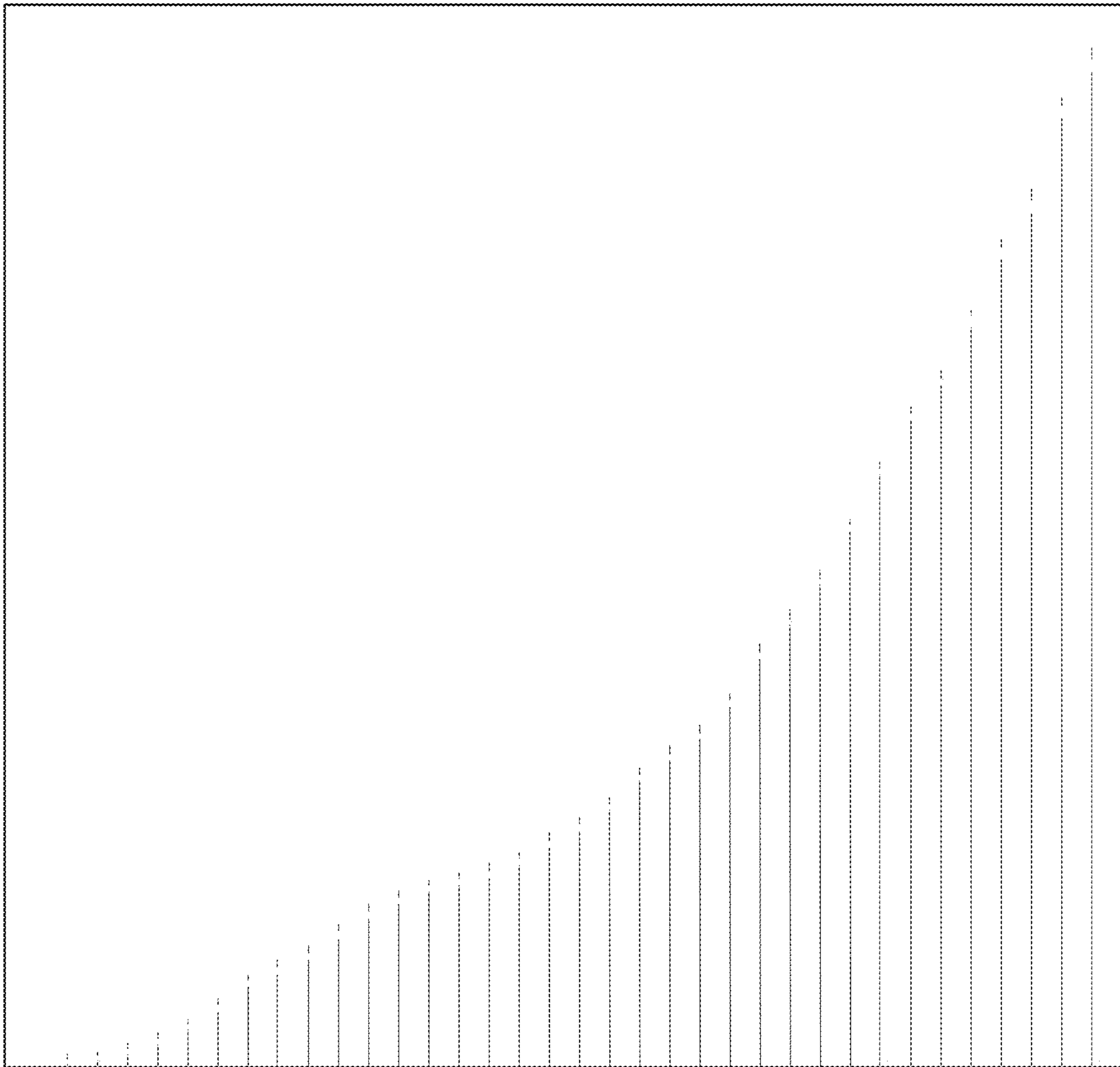

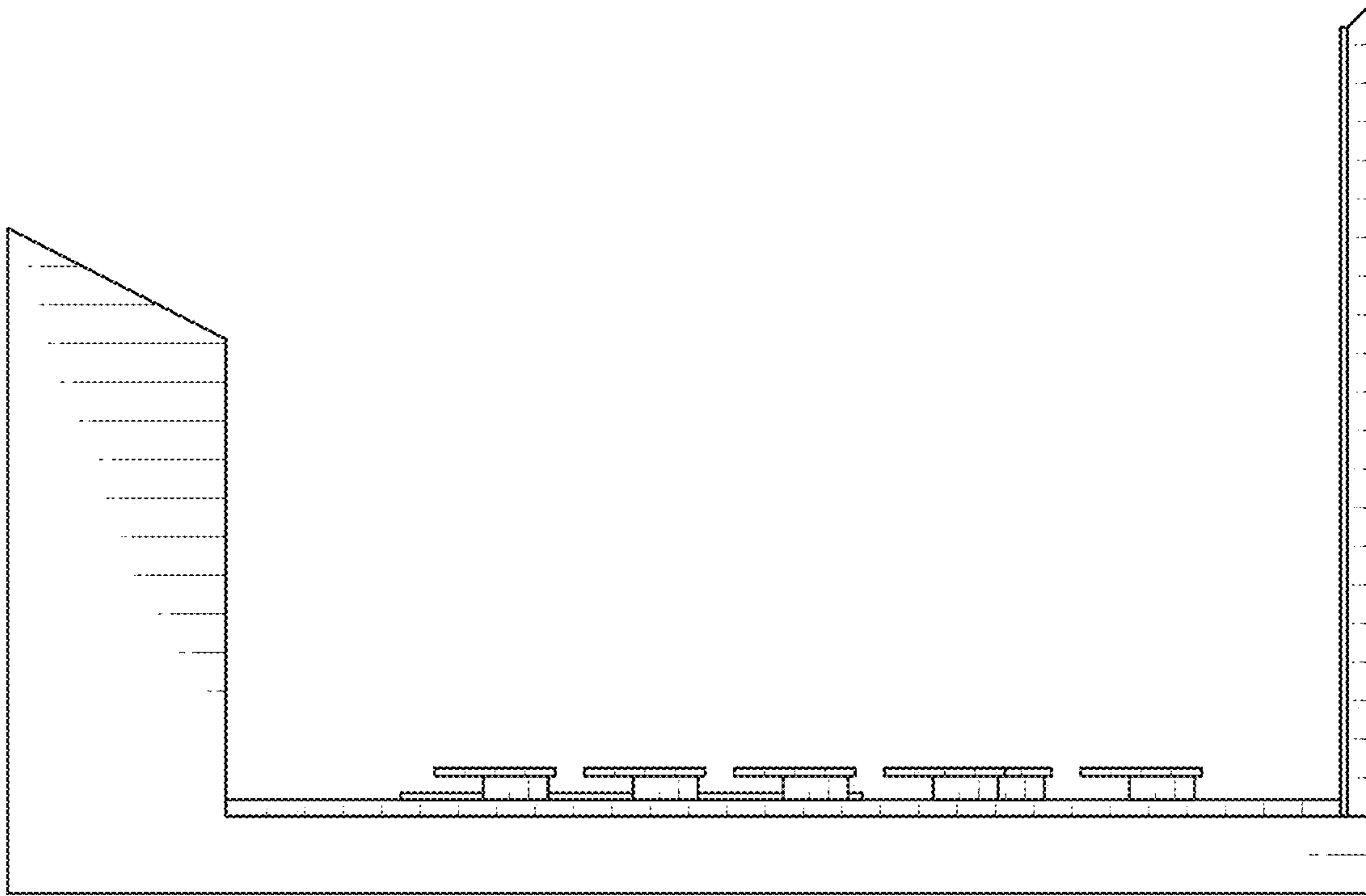

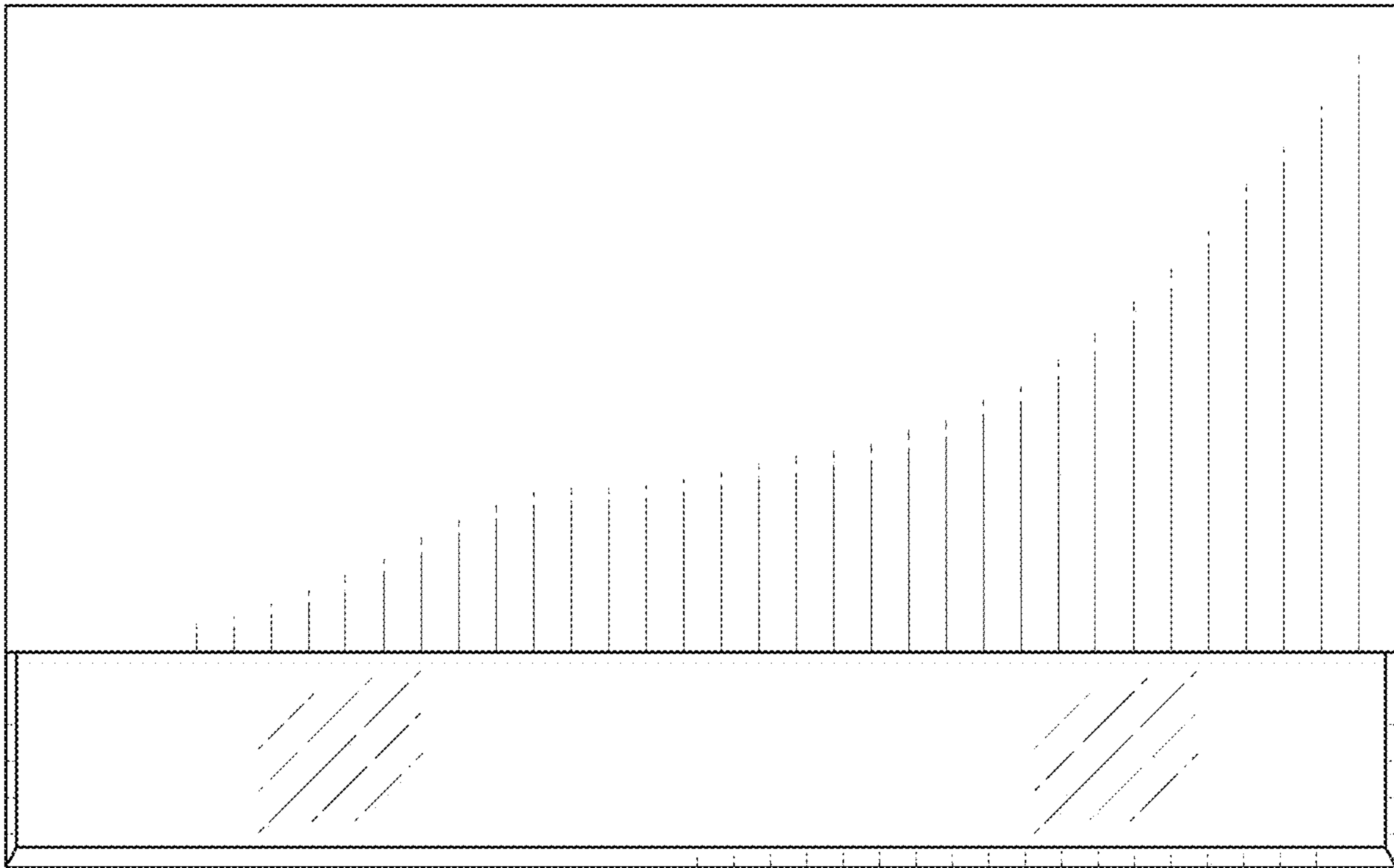

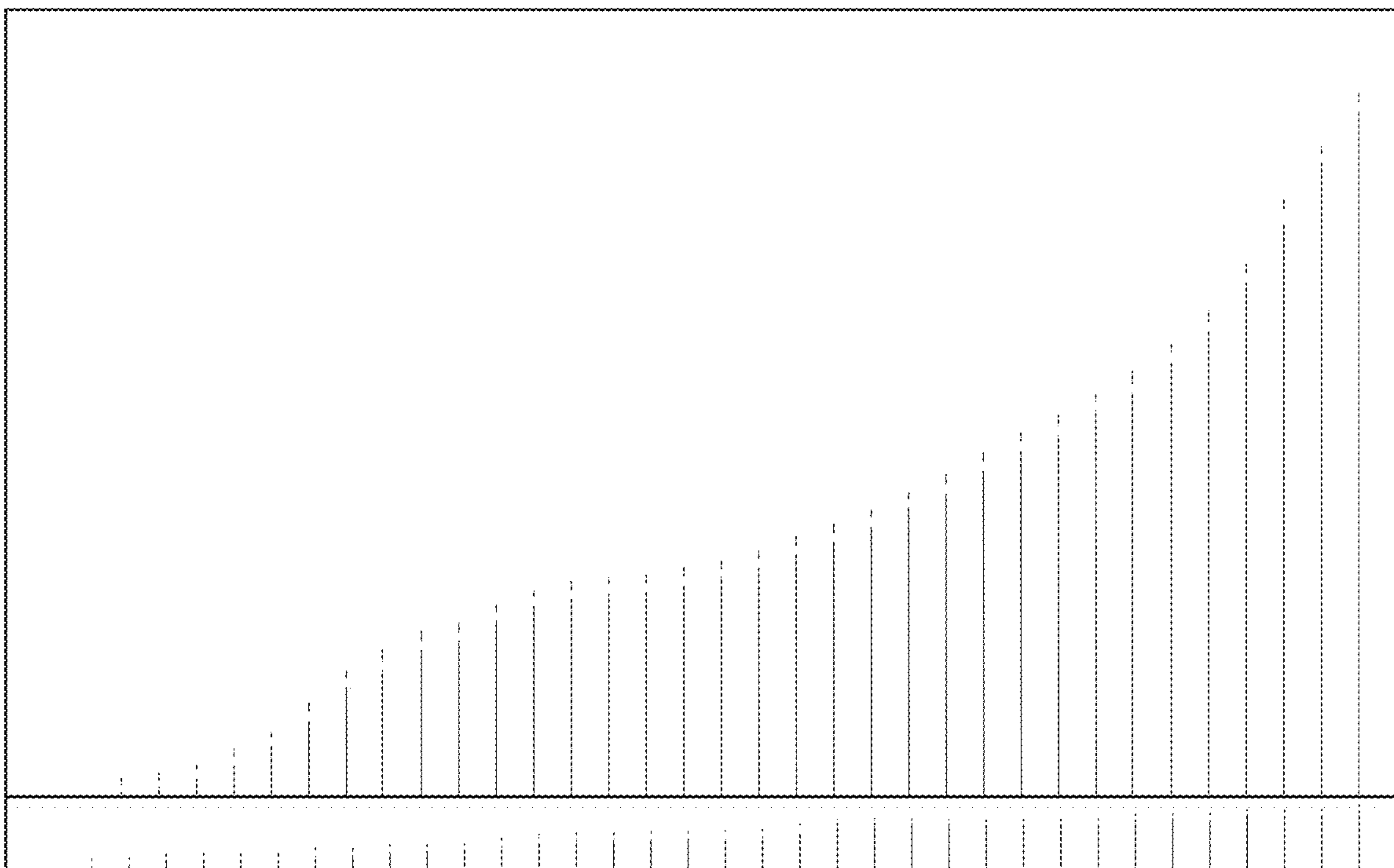

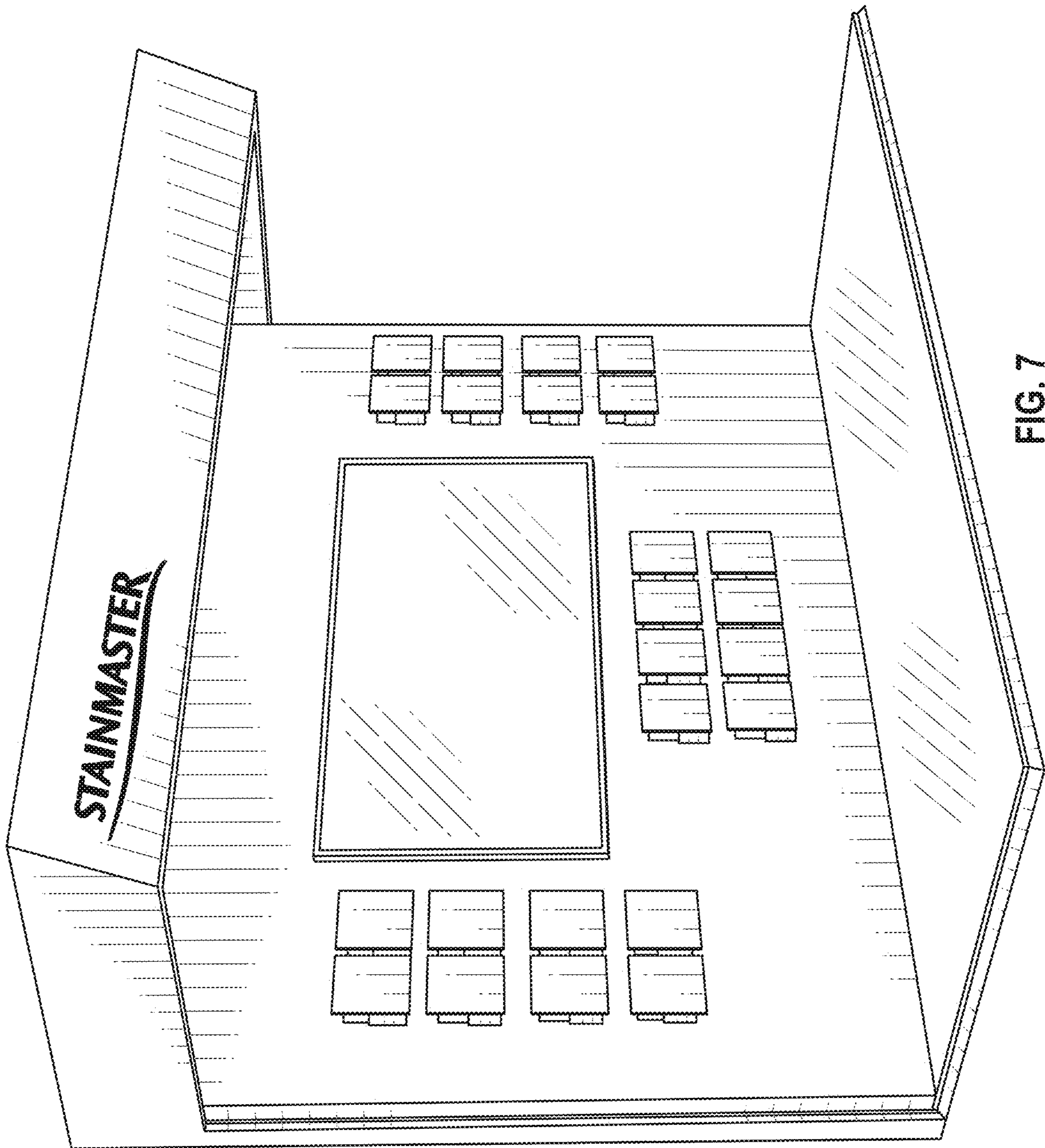
