(57) **CLAIM**

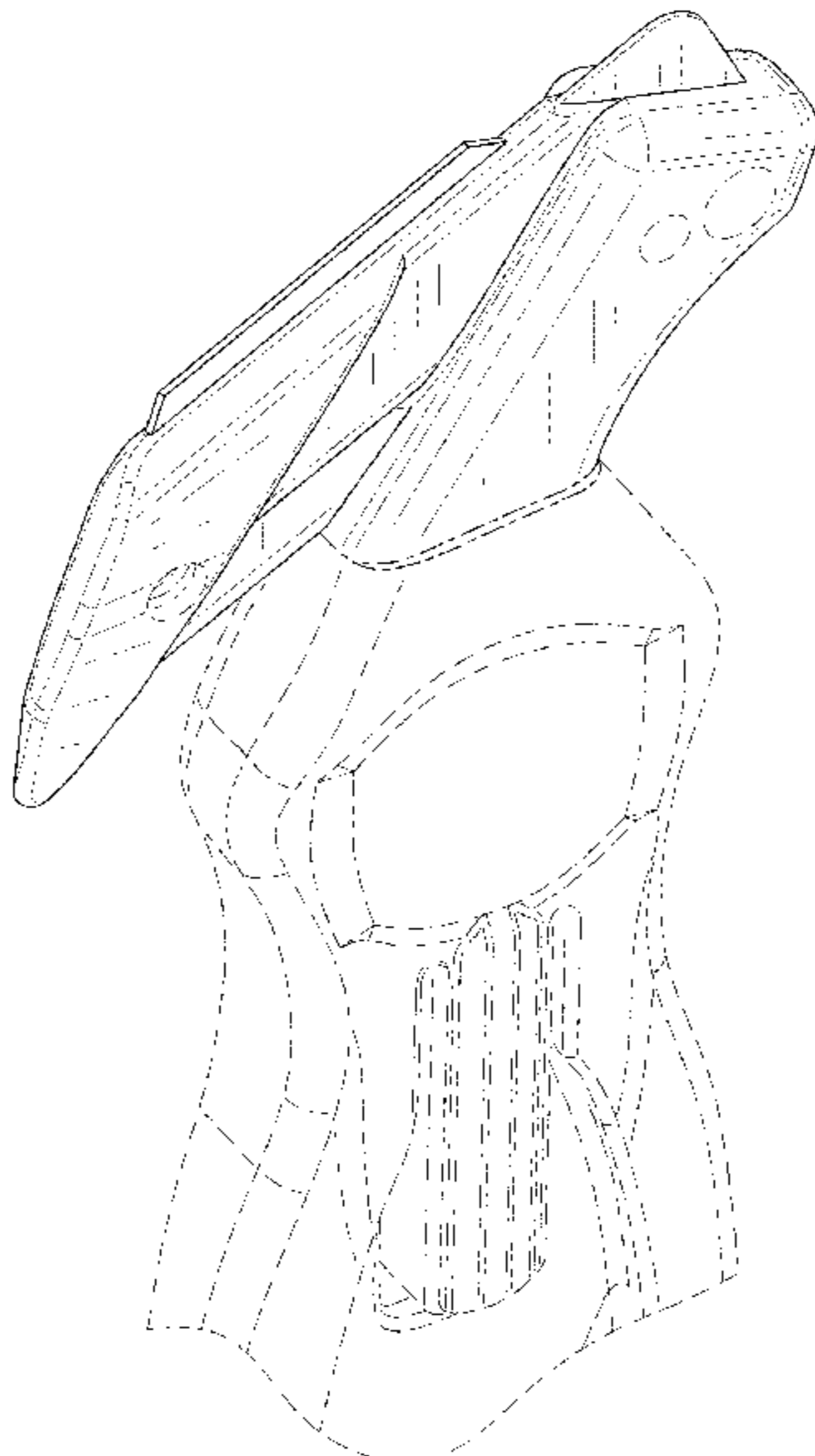
The ornamental design for a cutting head, as shown and described.

DESCRIPTION

FIG. 1 is a left side perspective view of a cutting head (of a cutter) showing my/our new design;
FIG. 2 is a right side perspective view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a rear elevation view thereof; and,
FIG. 7 is a top plan view thereof.

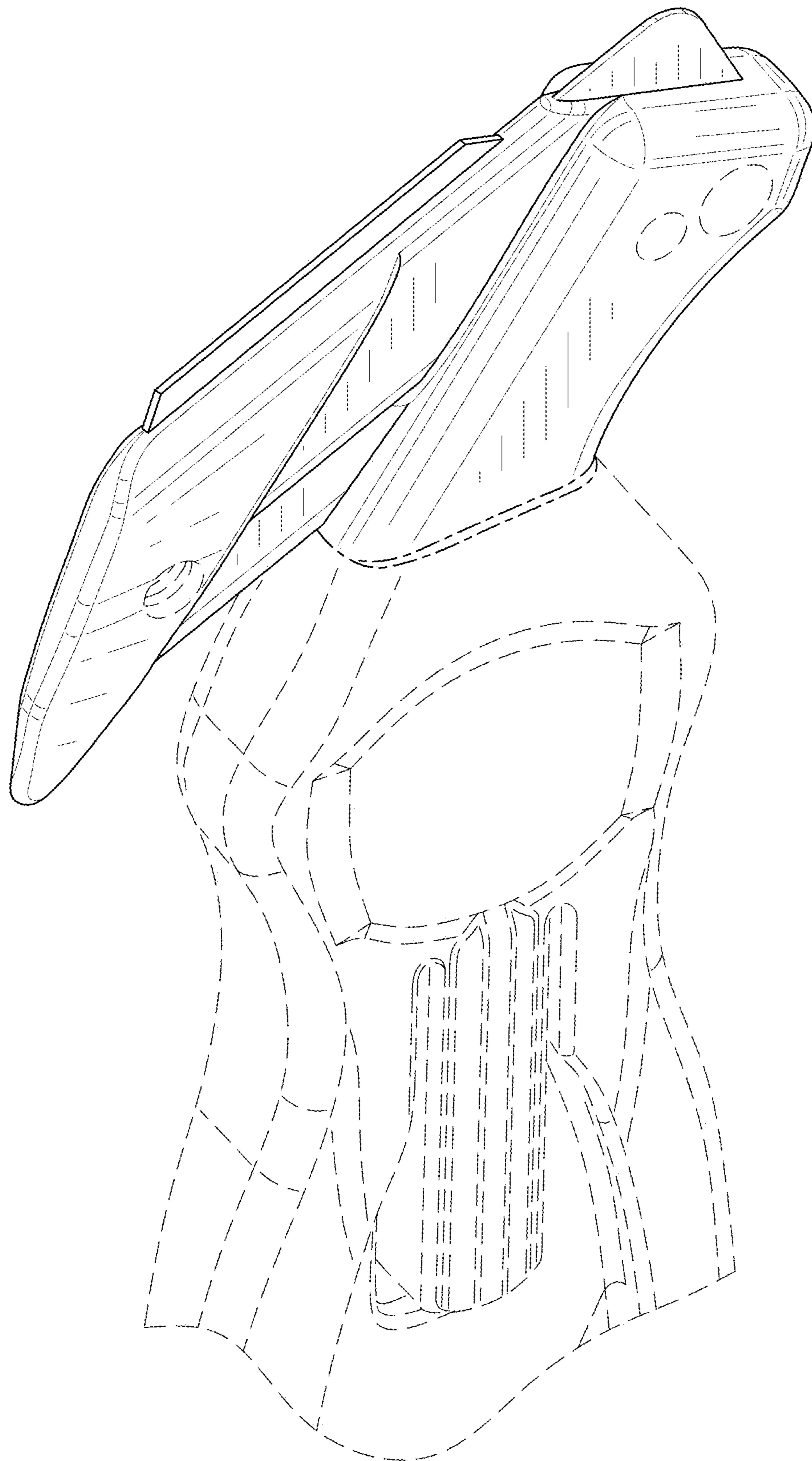

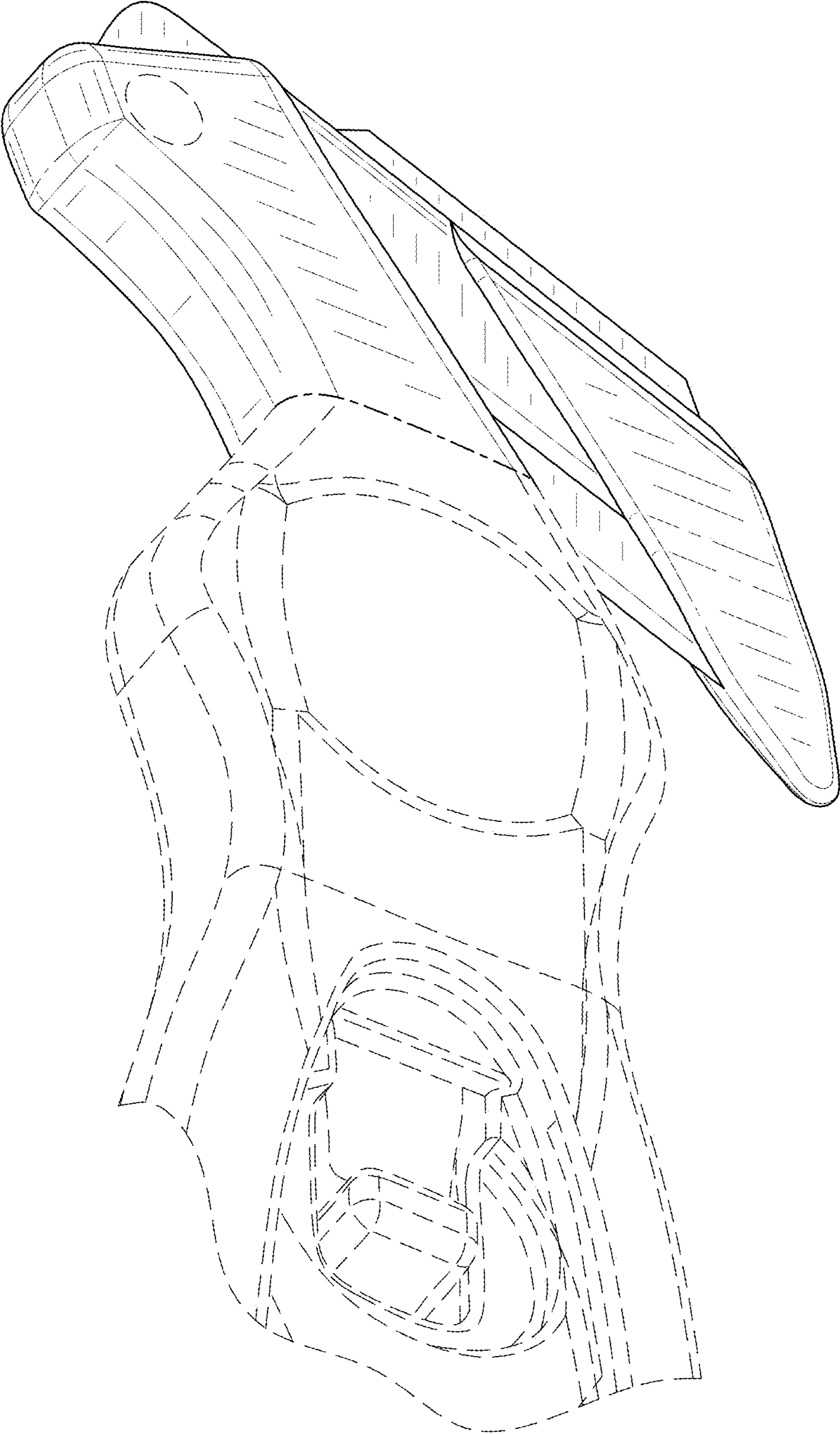

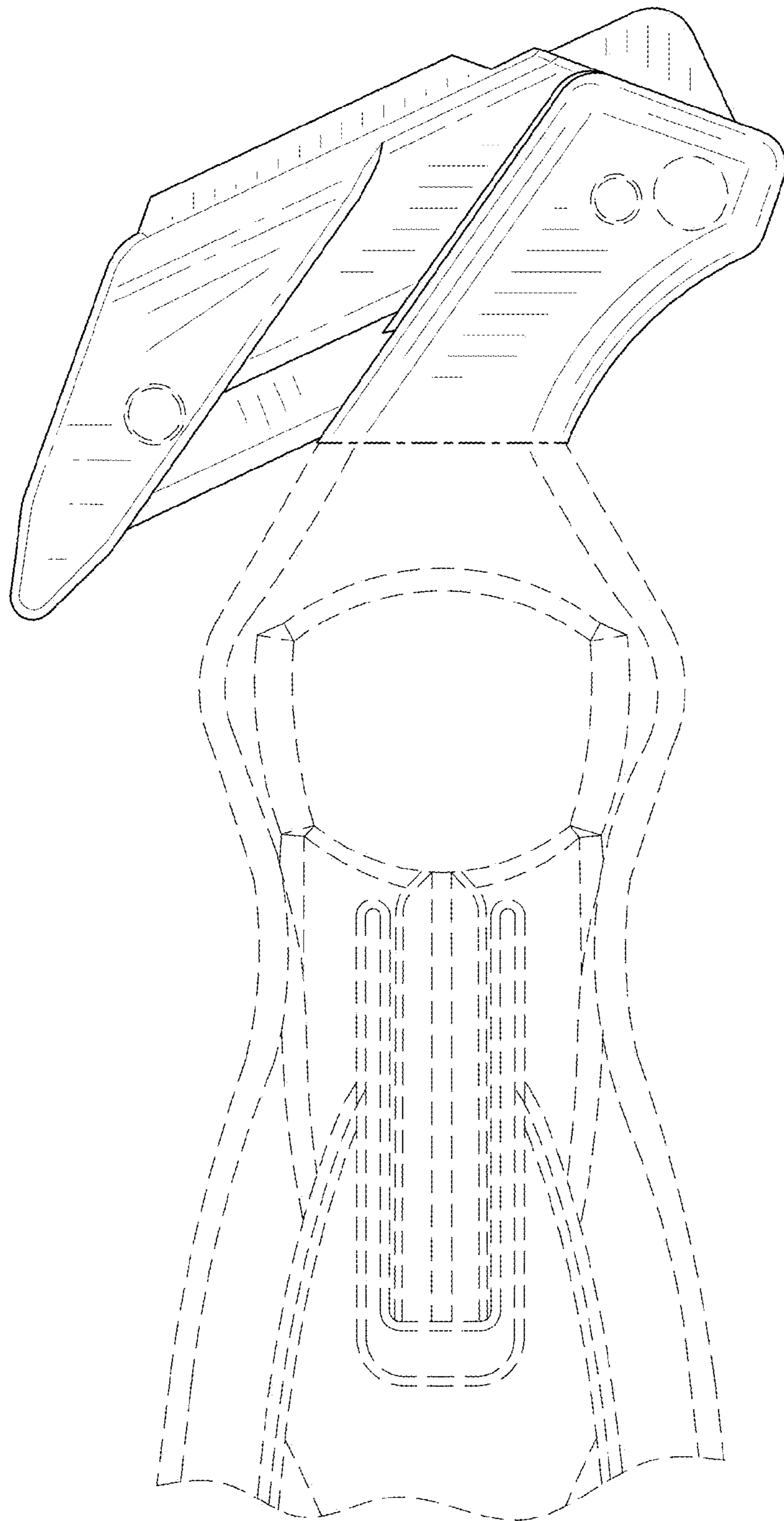

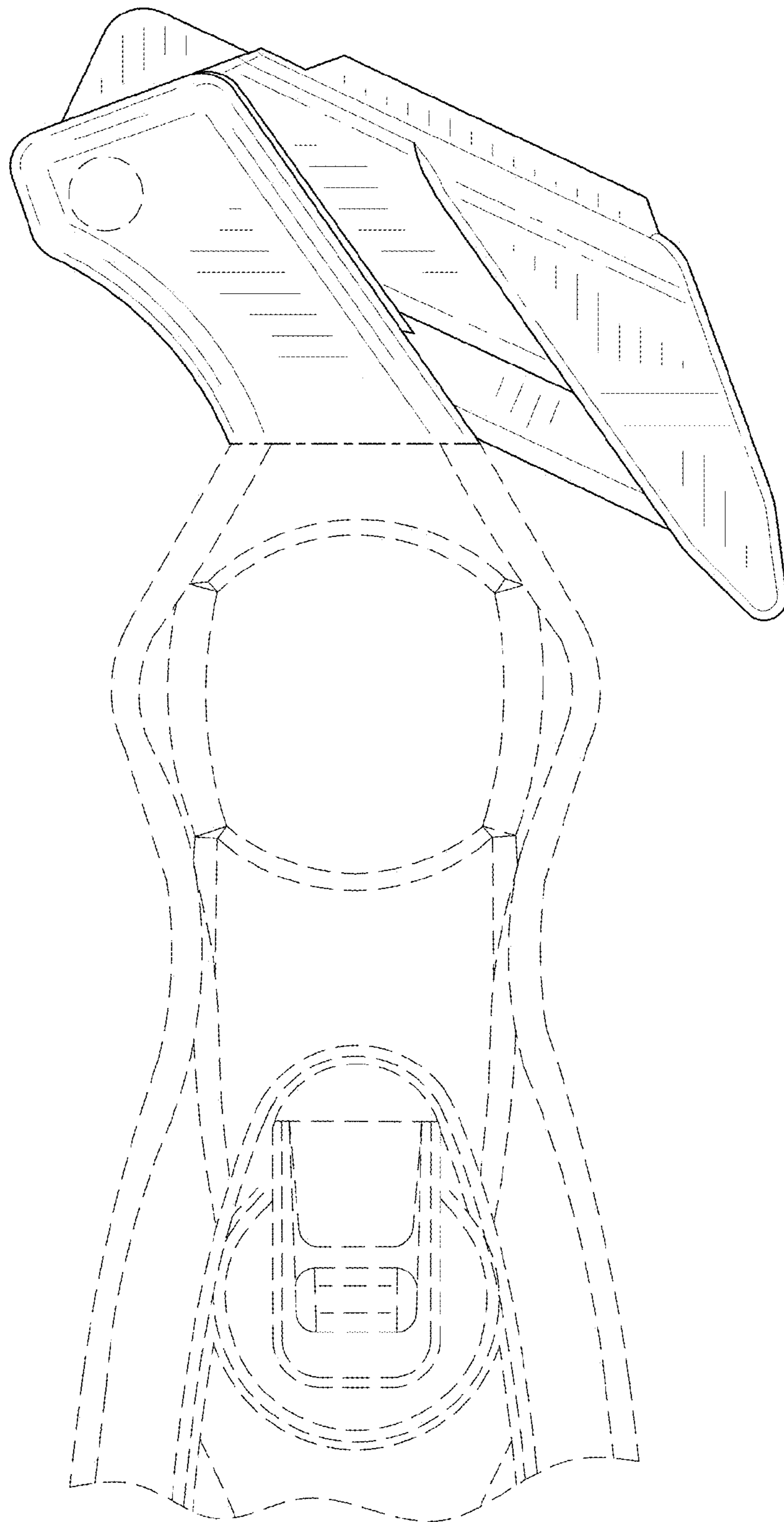

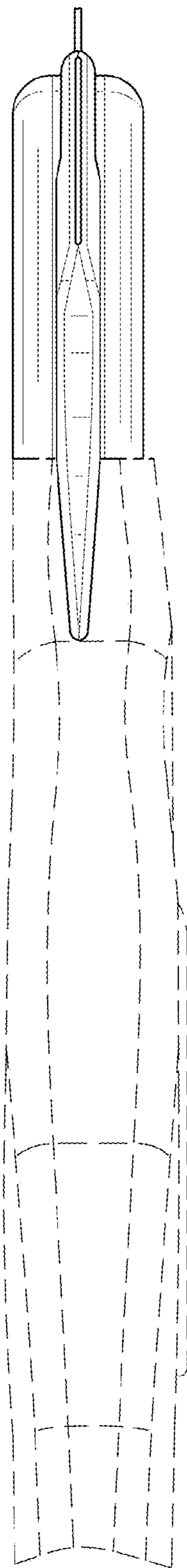

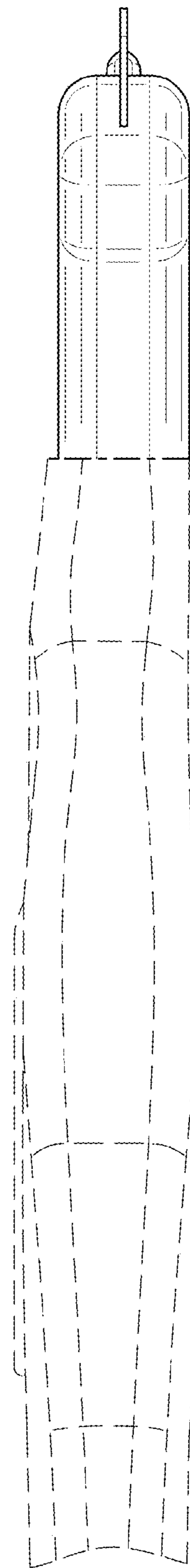

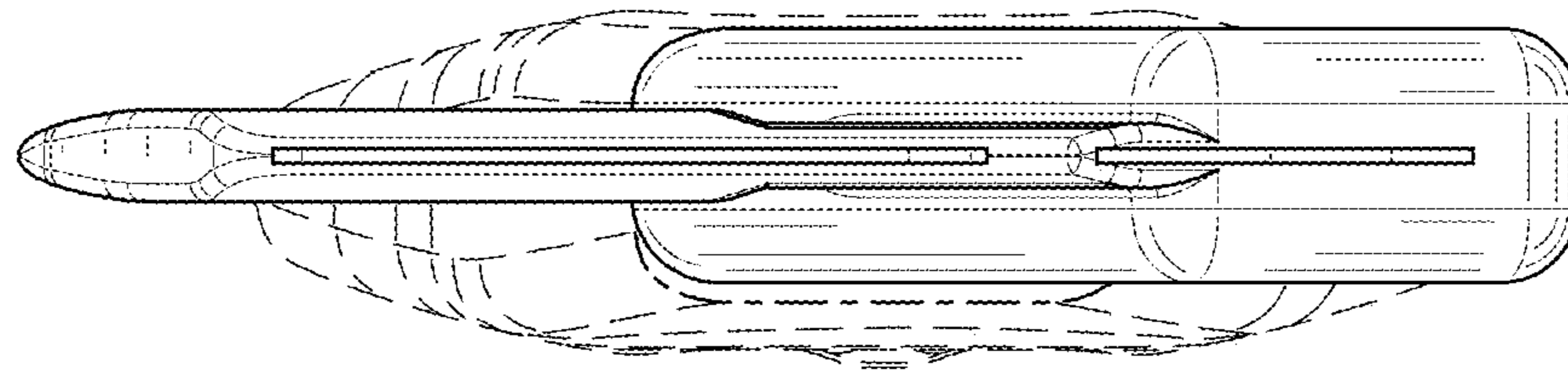
