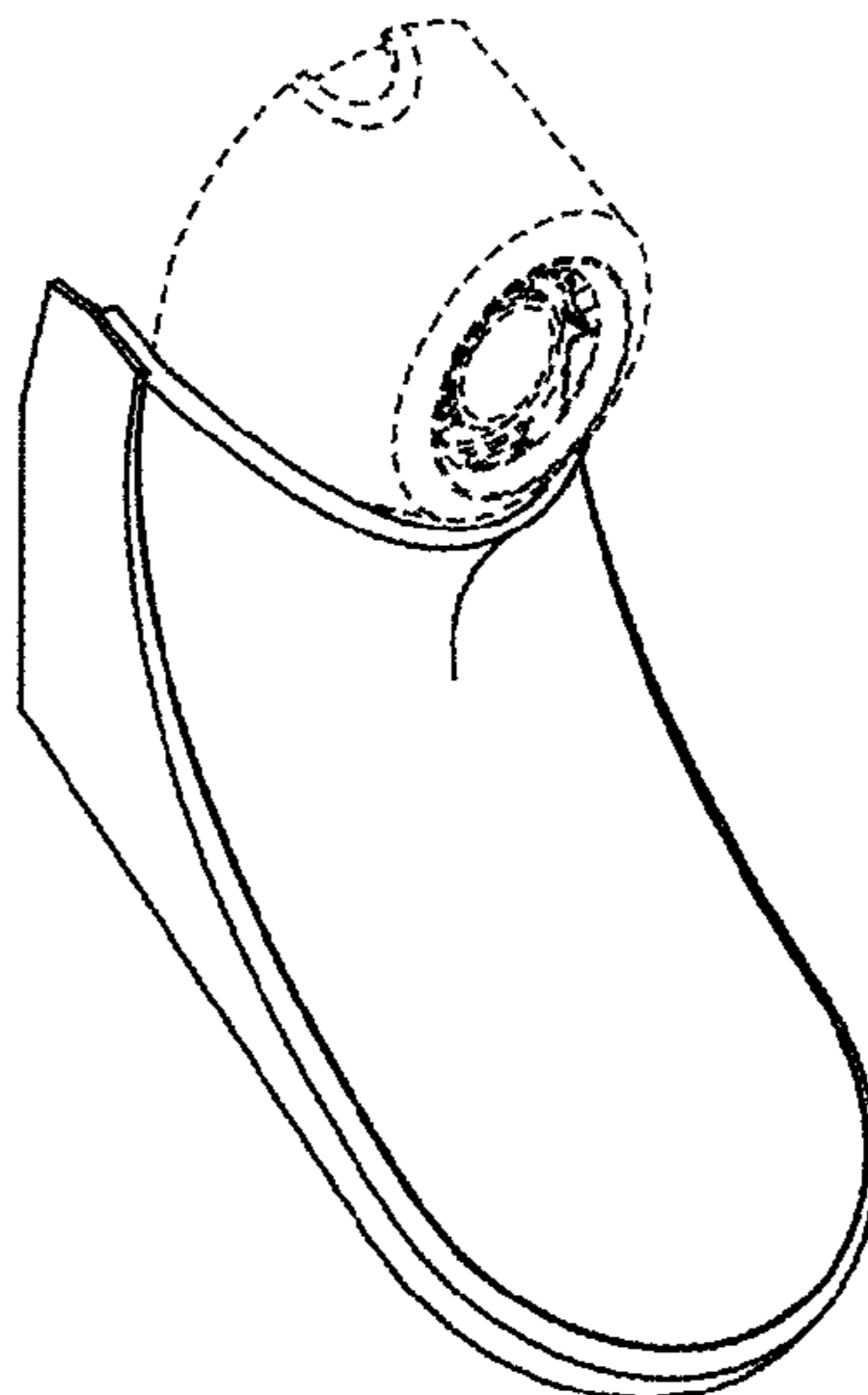
The broken lines depict portions of the trigger for spray head that form no part of the claimed design.

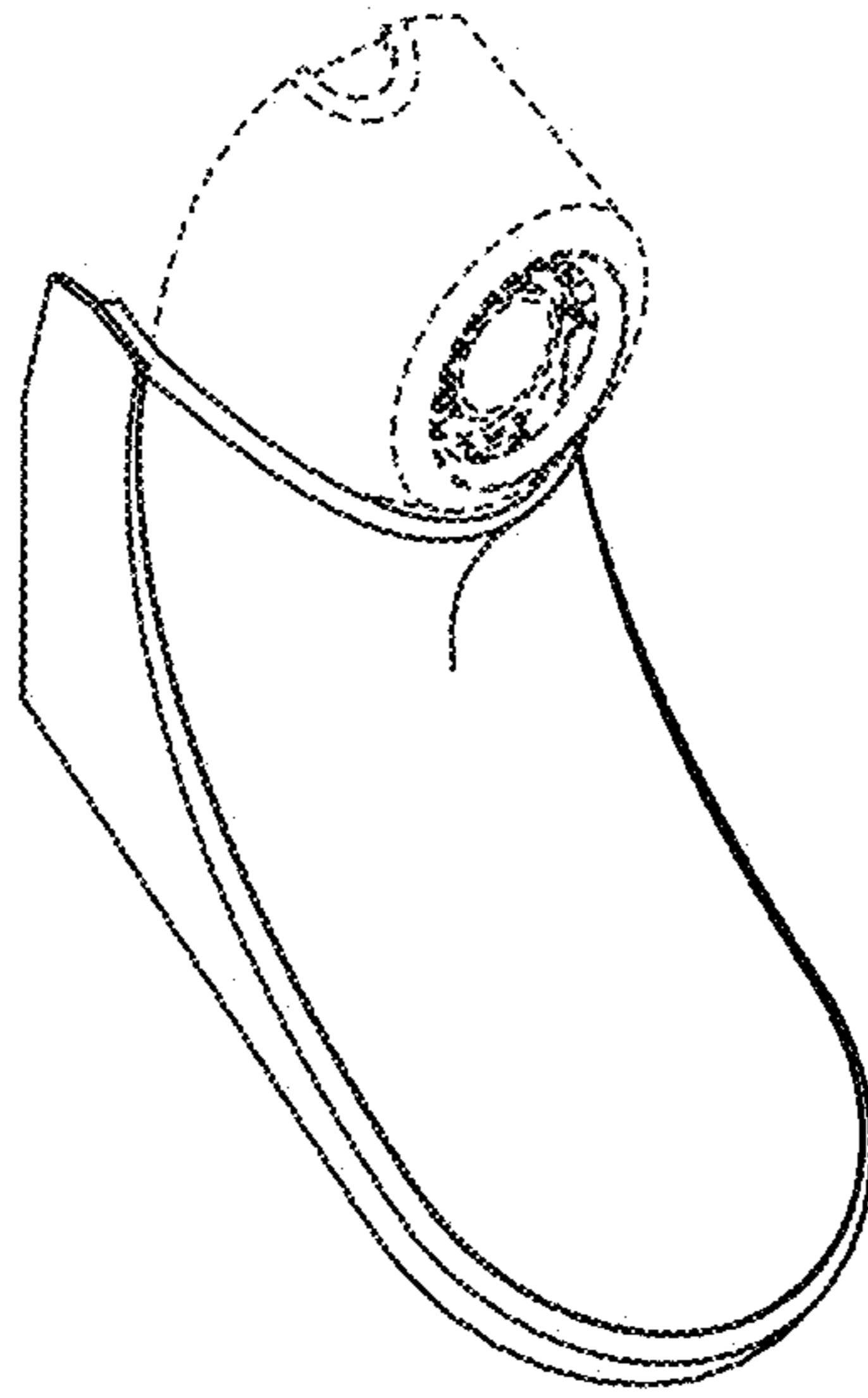

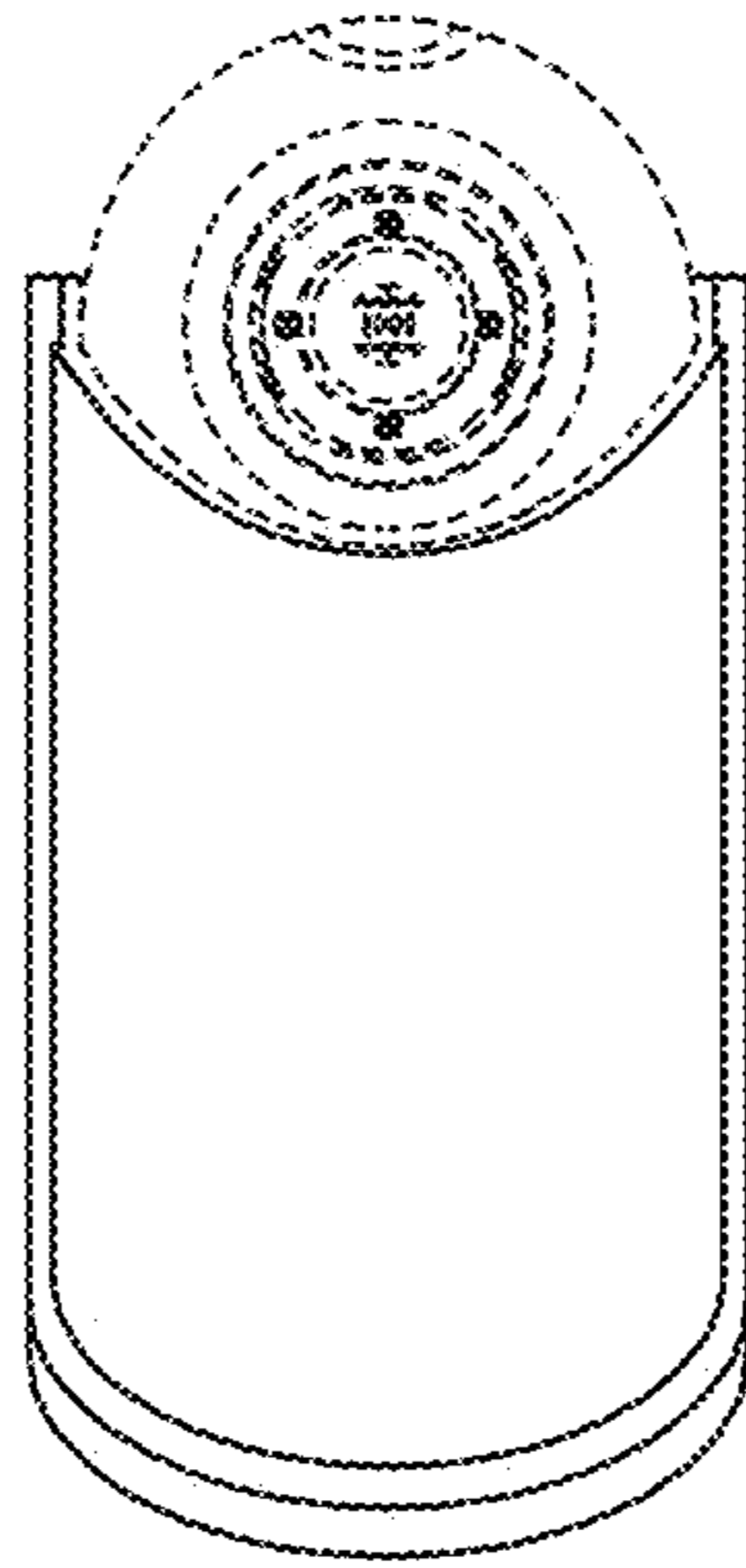

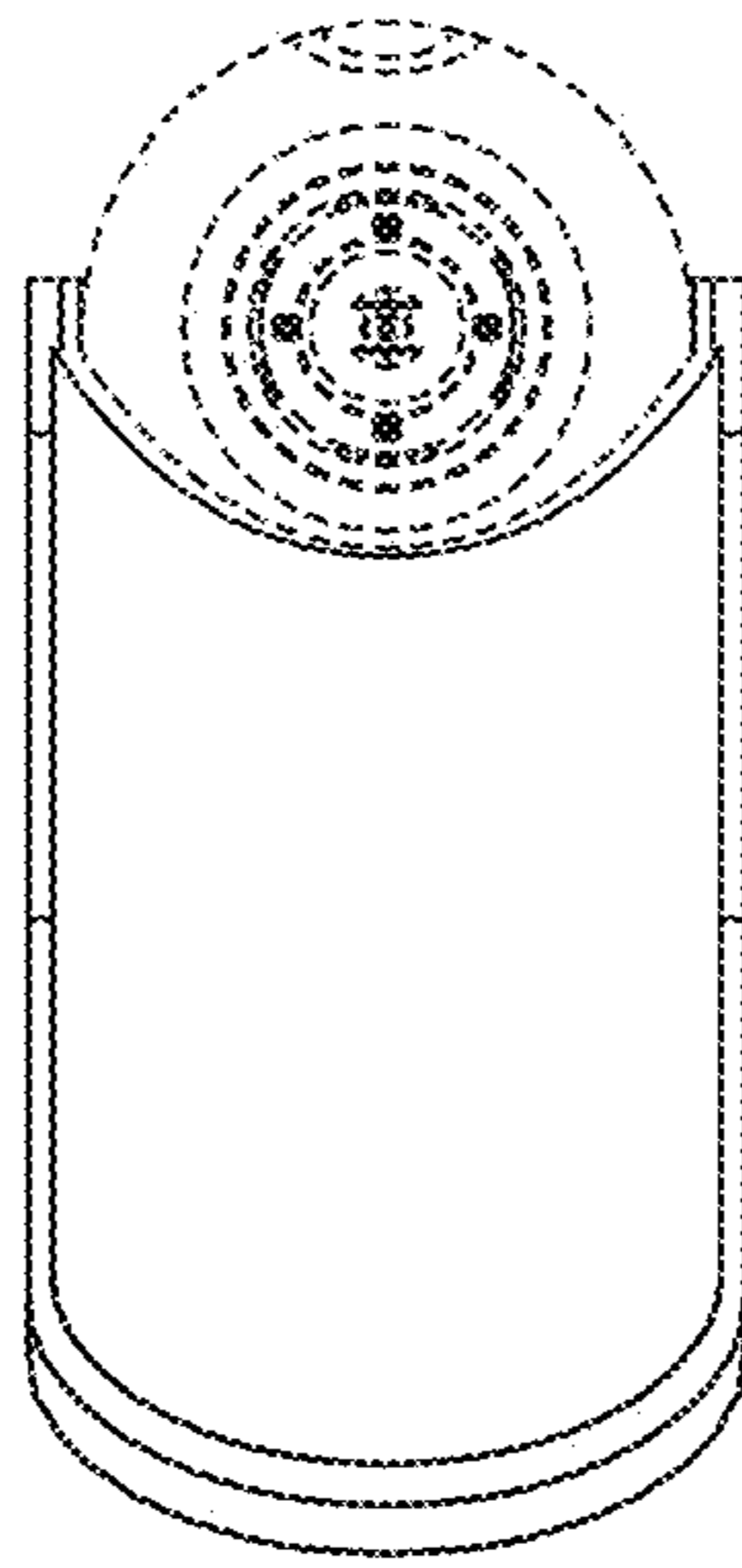

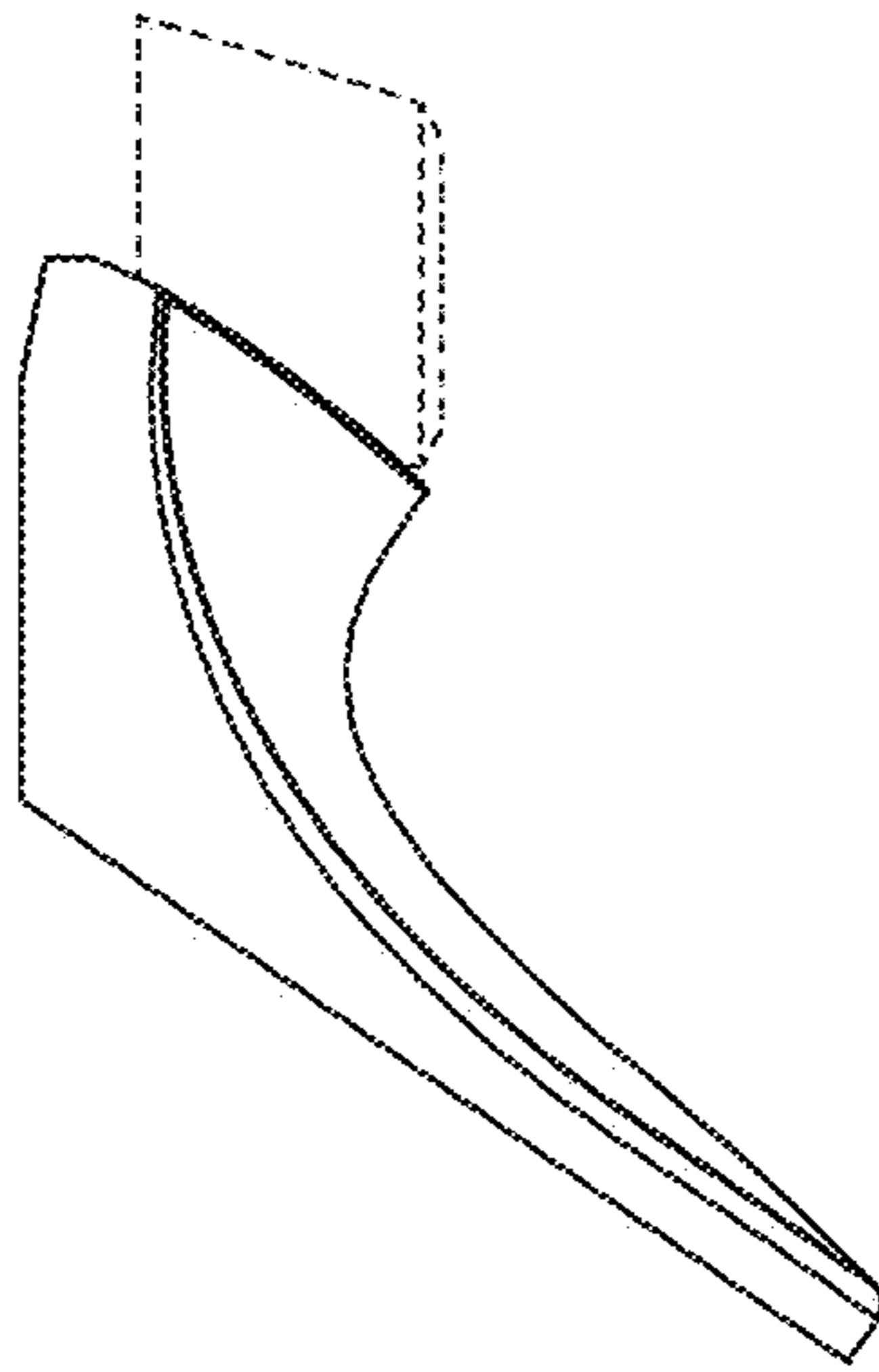

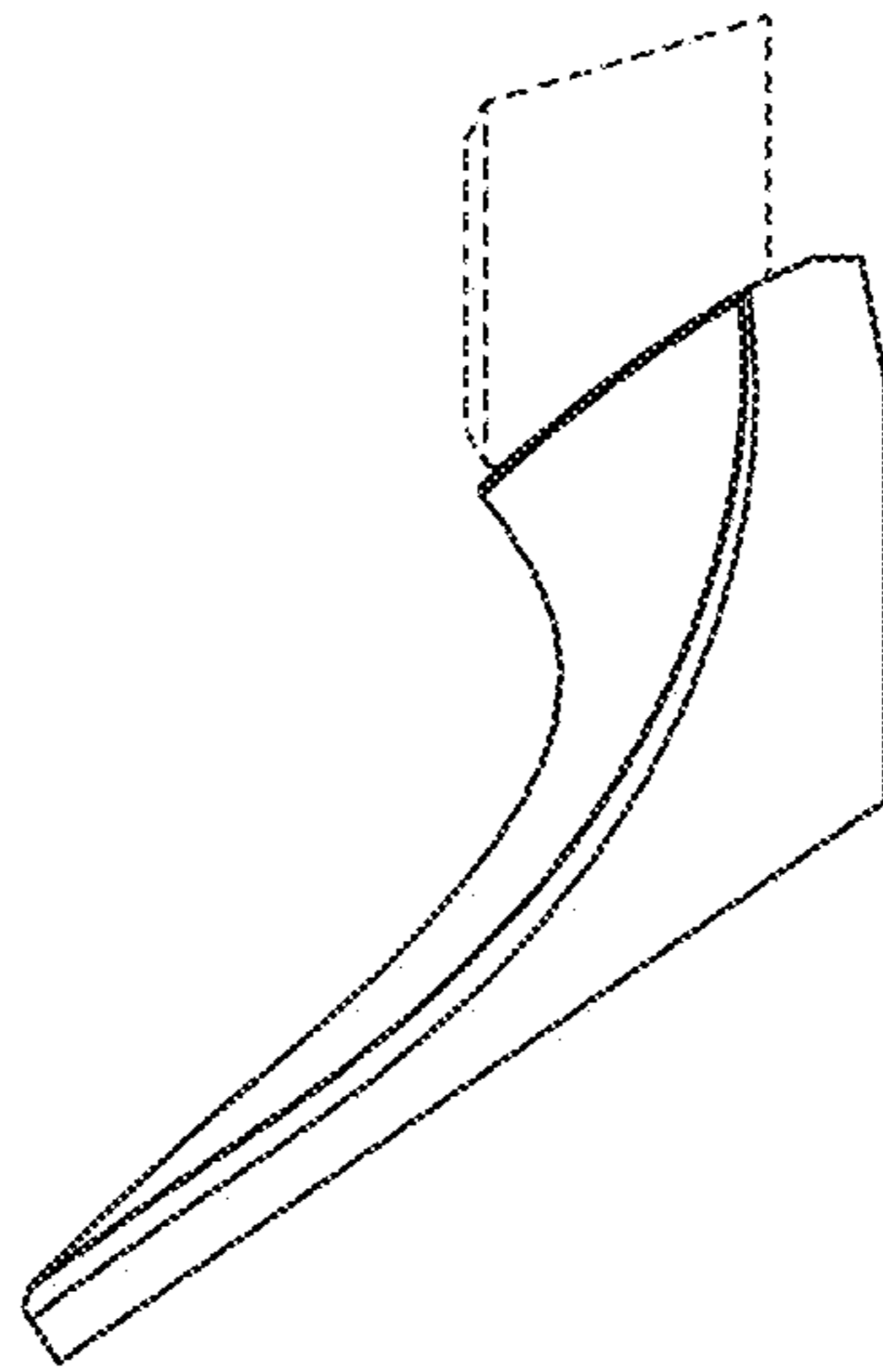

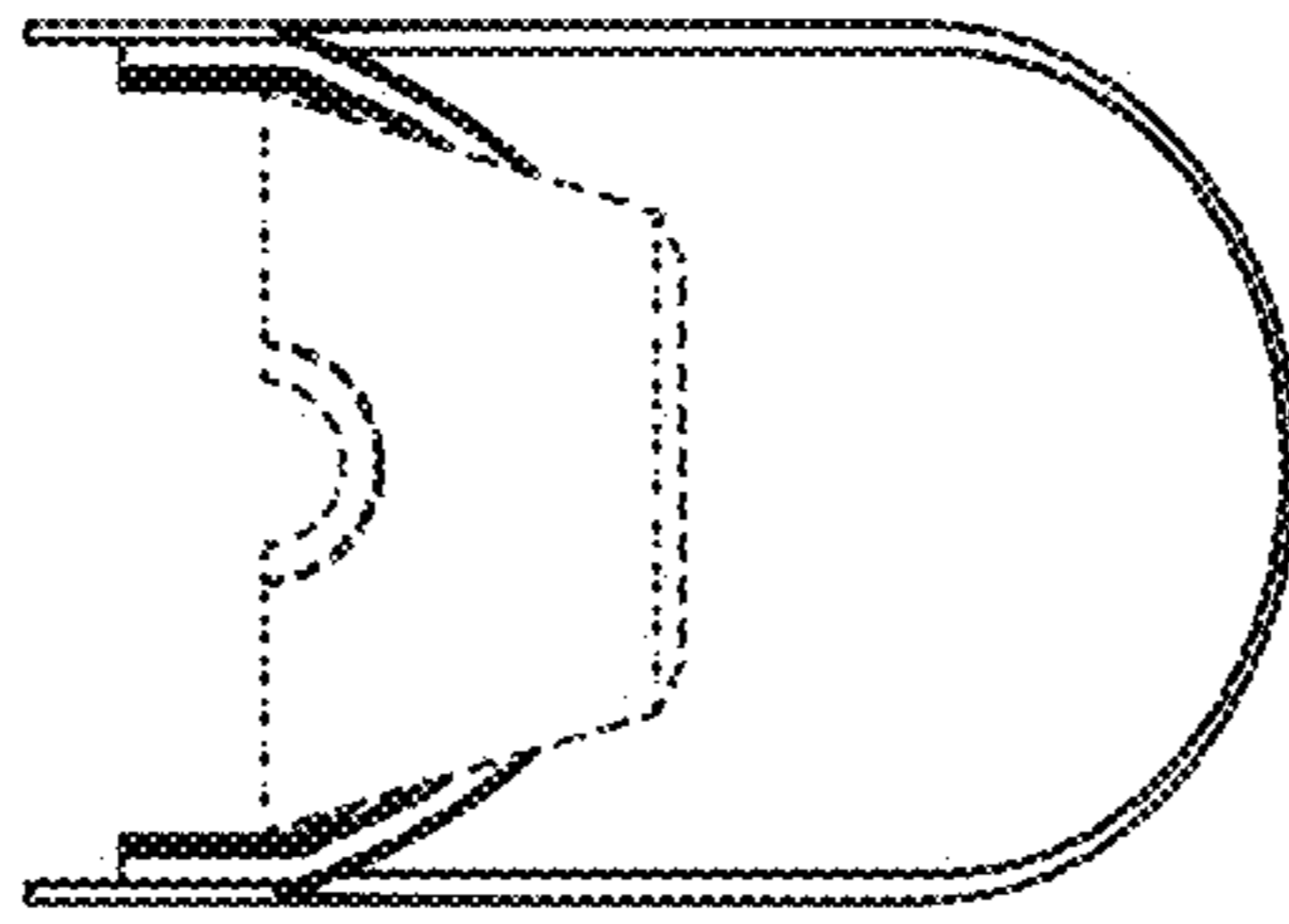

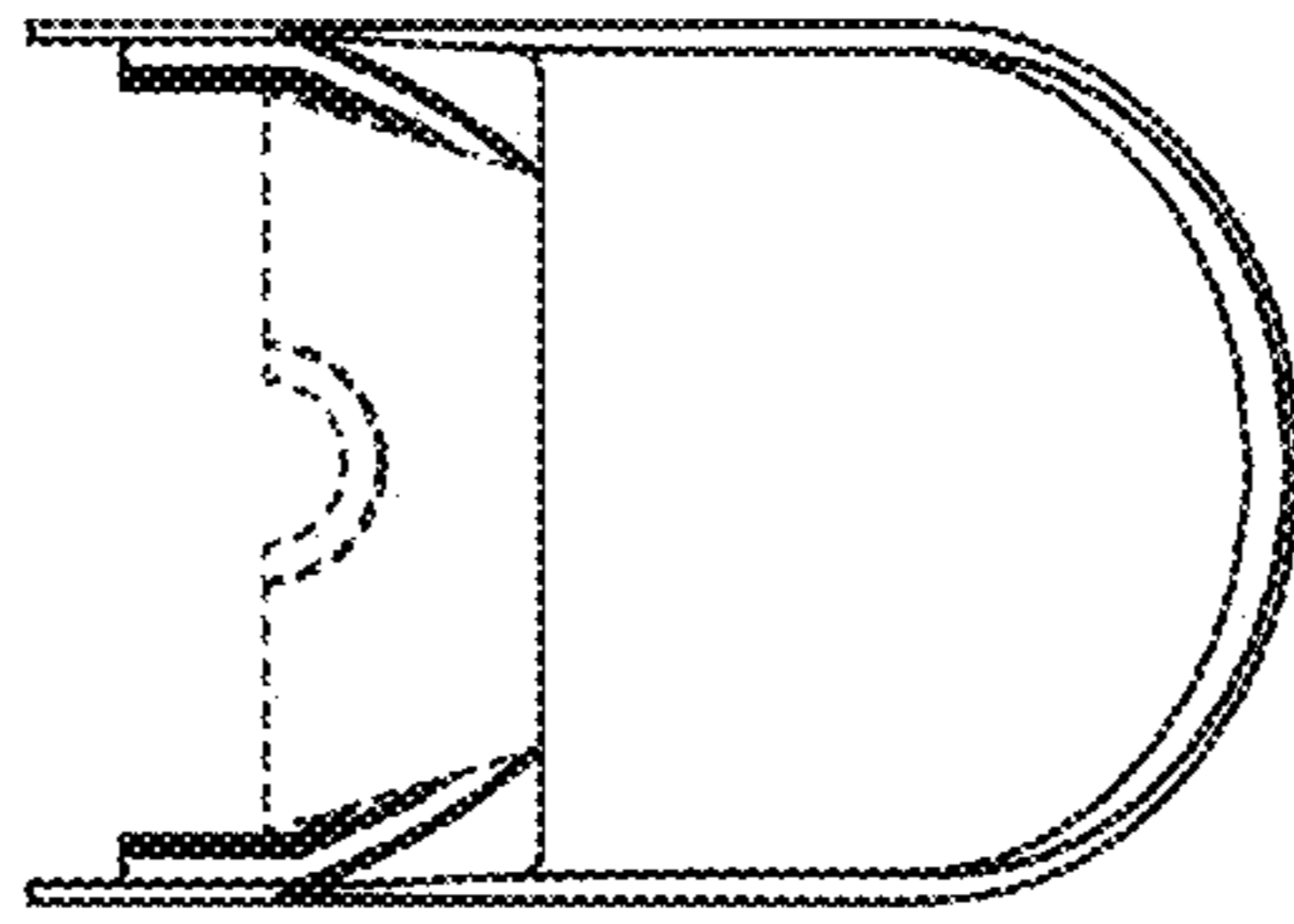
