The ornamental design for a friction ring for a motorcycle  
brake disc, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view showing the front, top and left  
side of a friction ring for a motorcycle brake disc which  
forms my new design;

FIG. 2 is a perspective view showing the rear, top and right  
side thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front elevational view thereof;

FIG. 5 is a left side elevational view thereof;

FIG. 6 is a right side elevational view thereof;

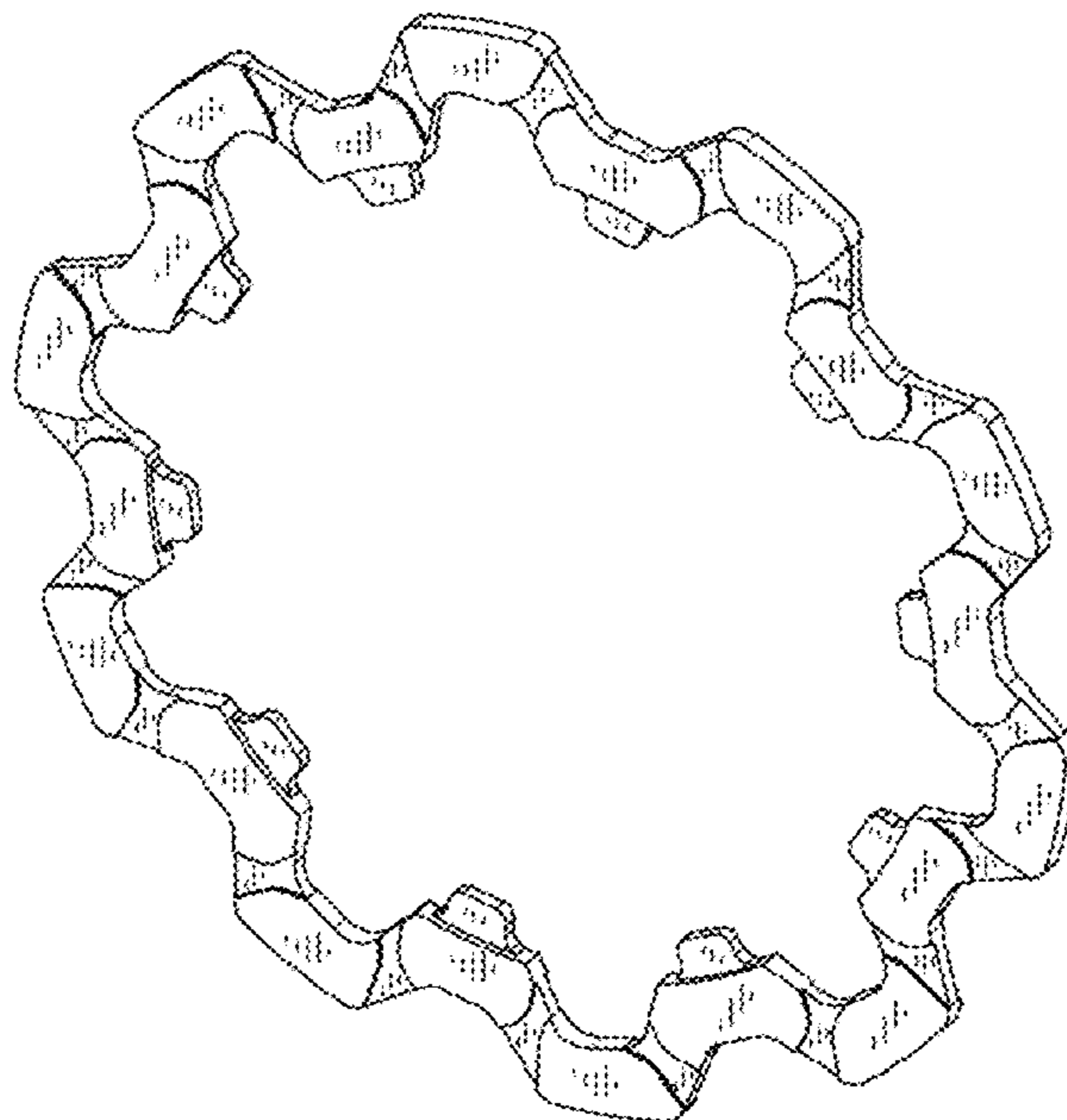
FIG. 7 is a rear elevational view thereof;

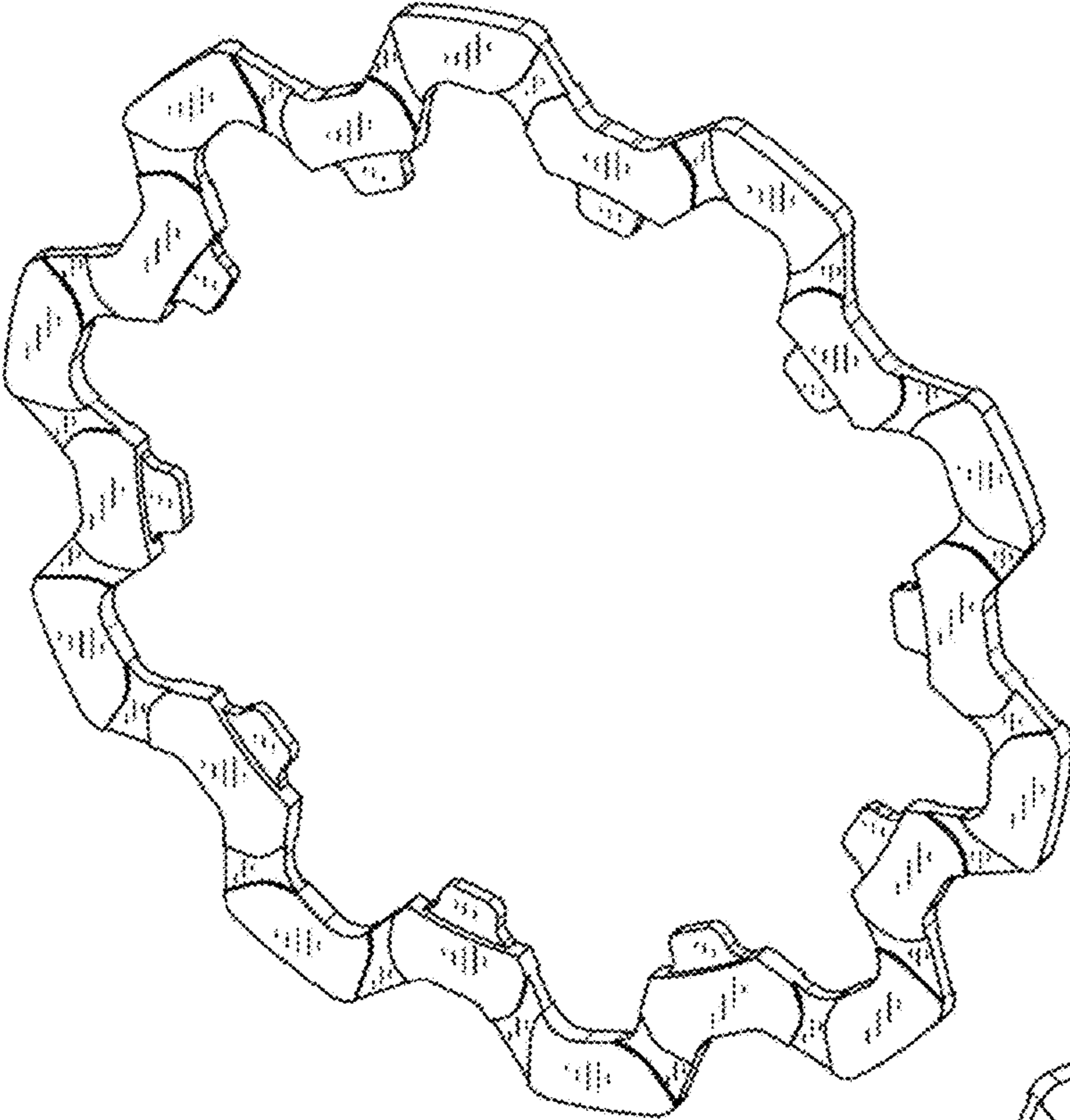

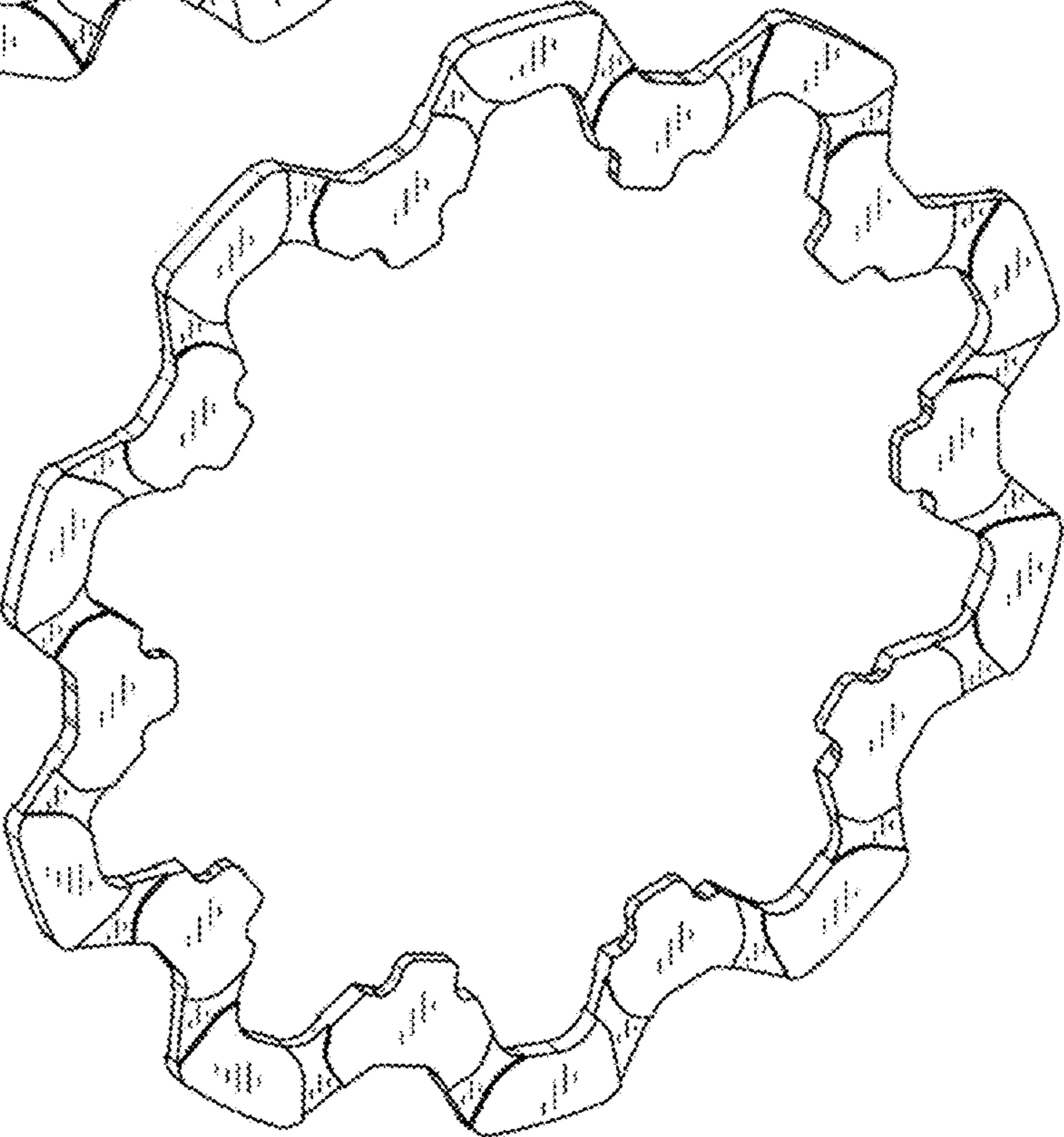

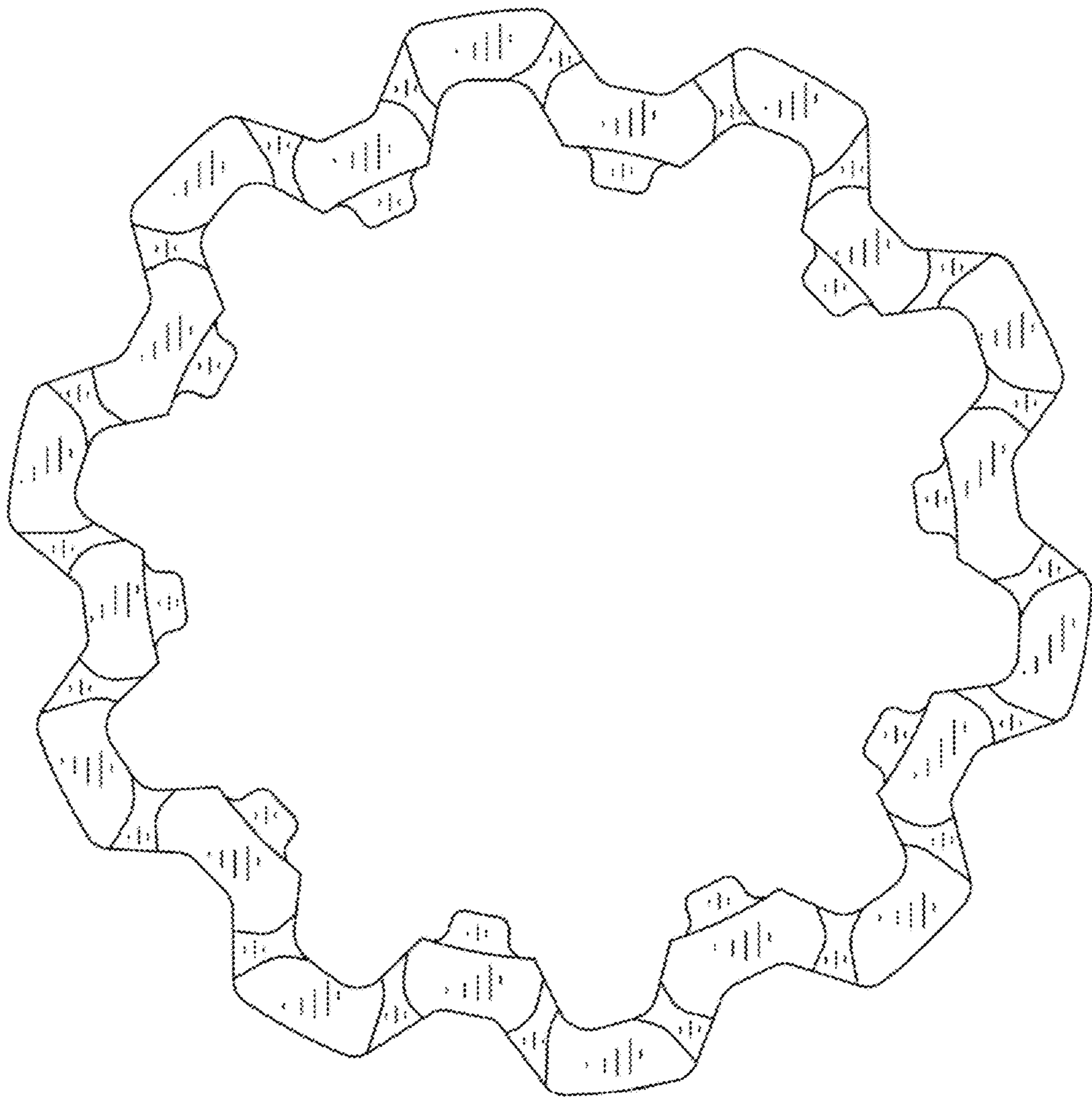

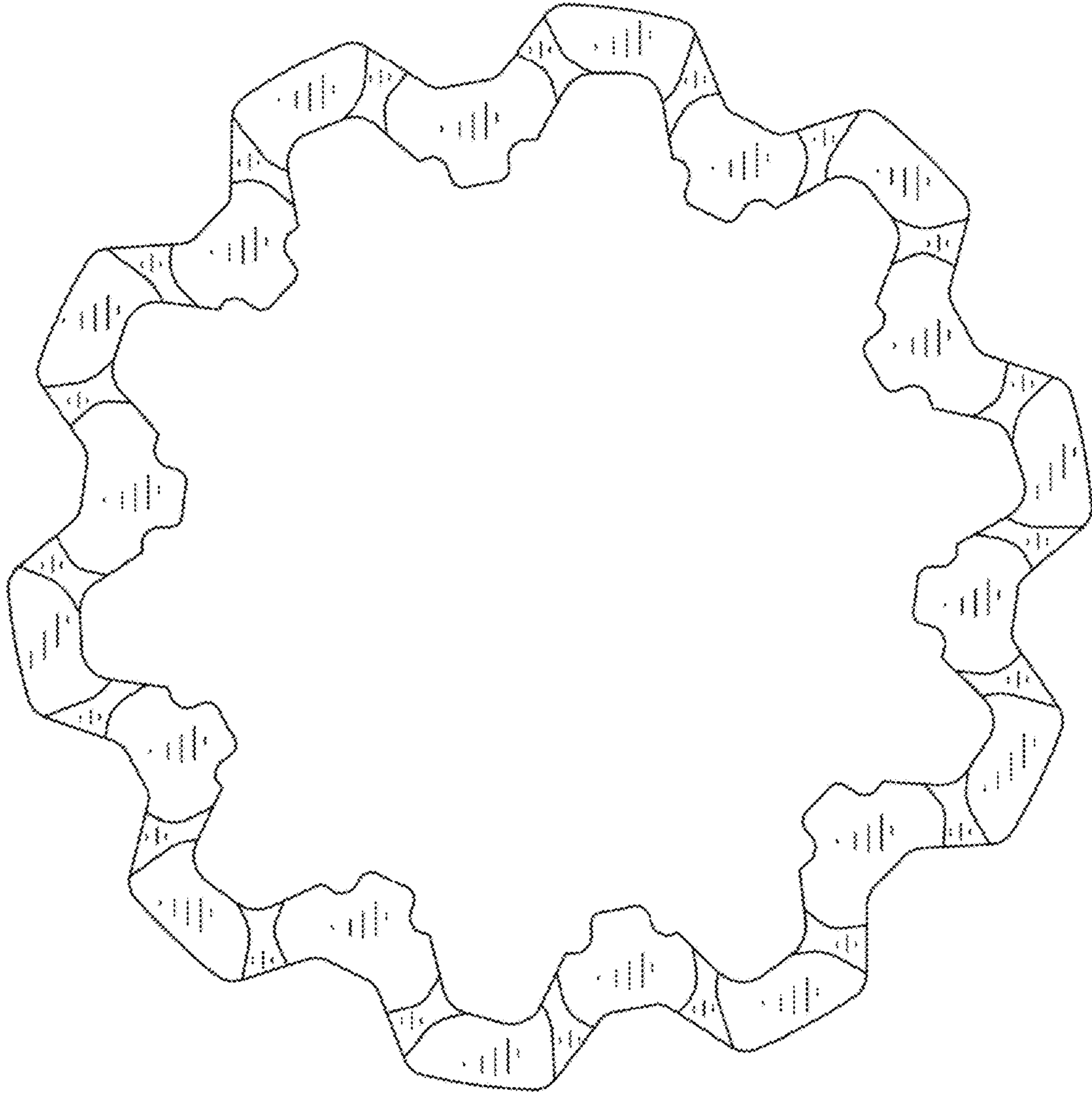

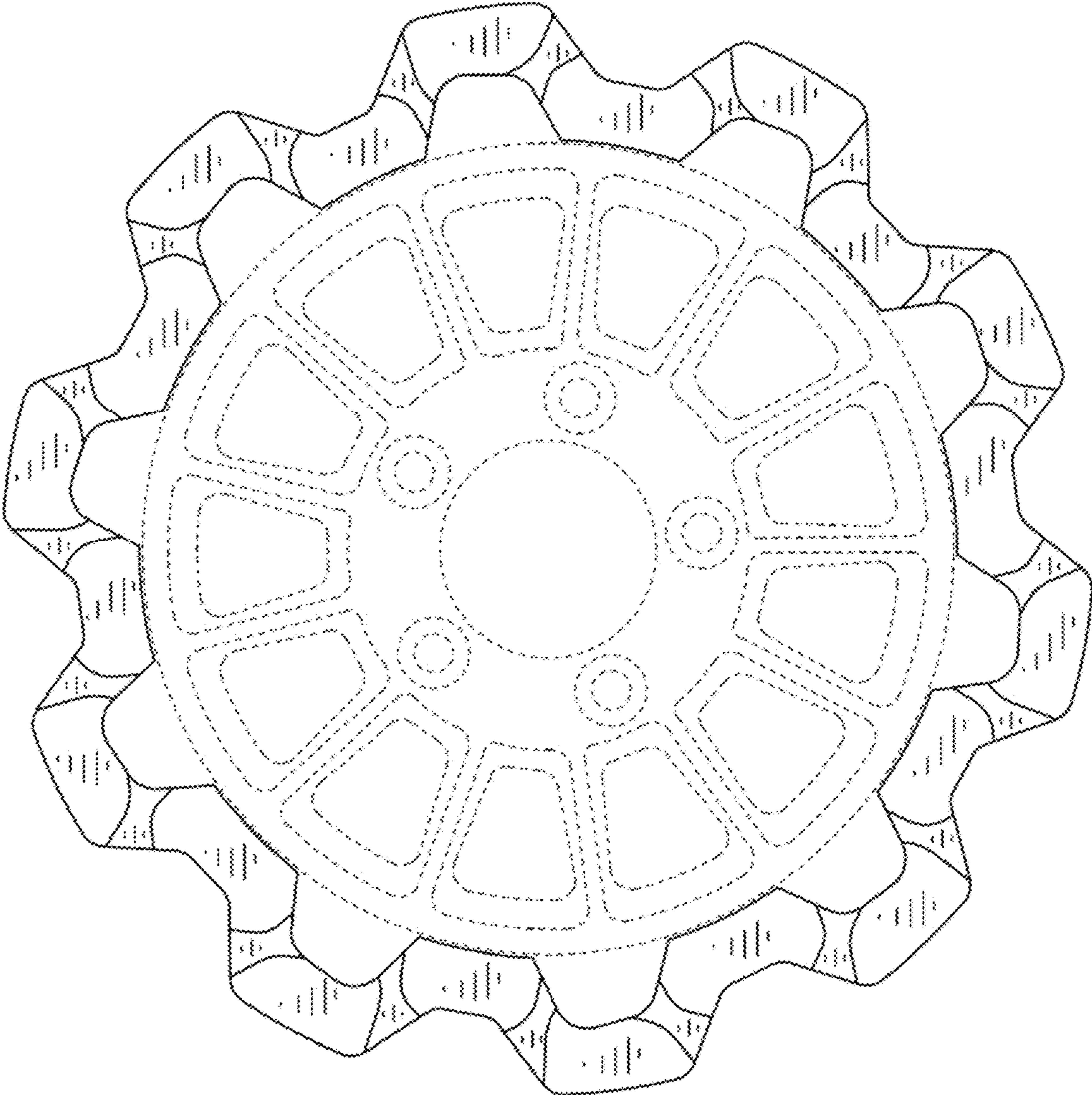
