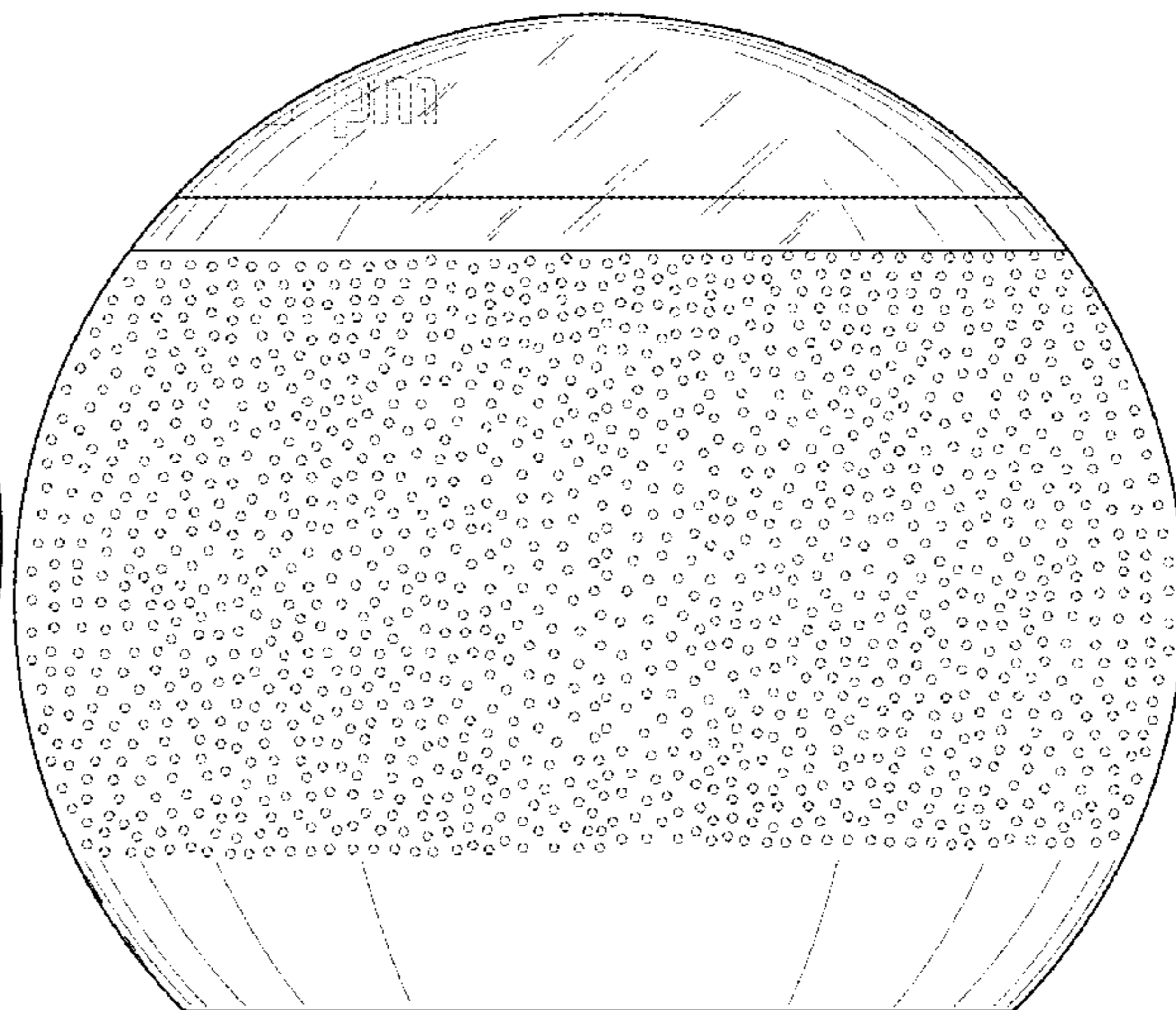
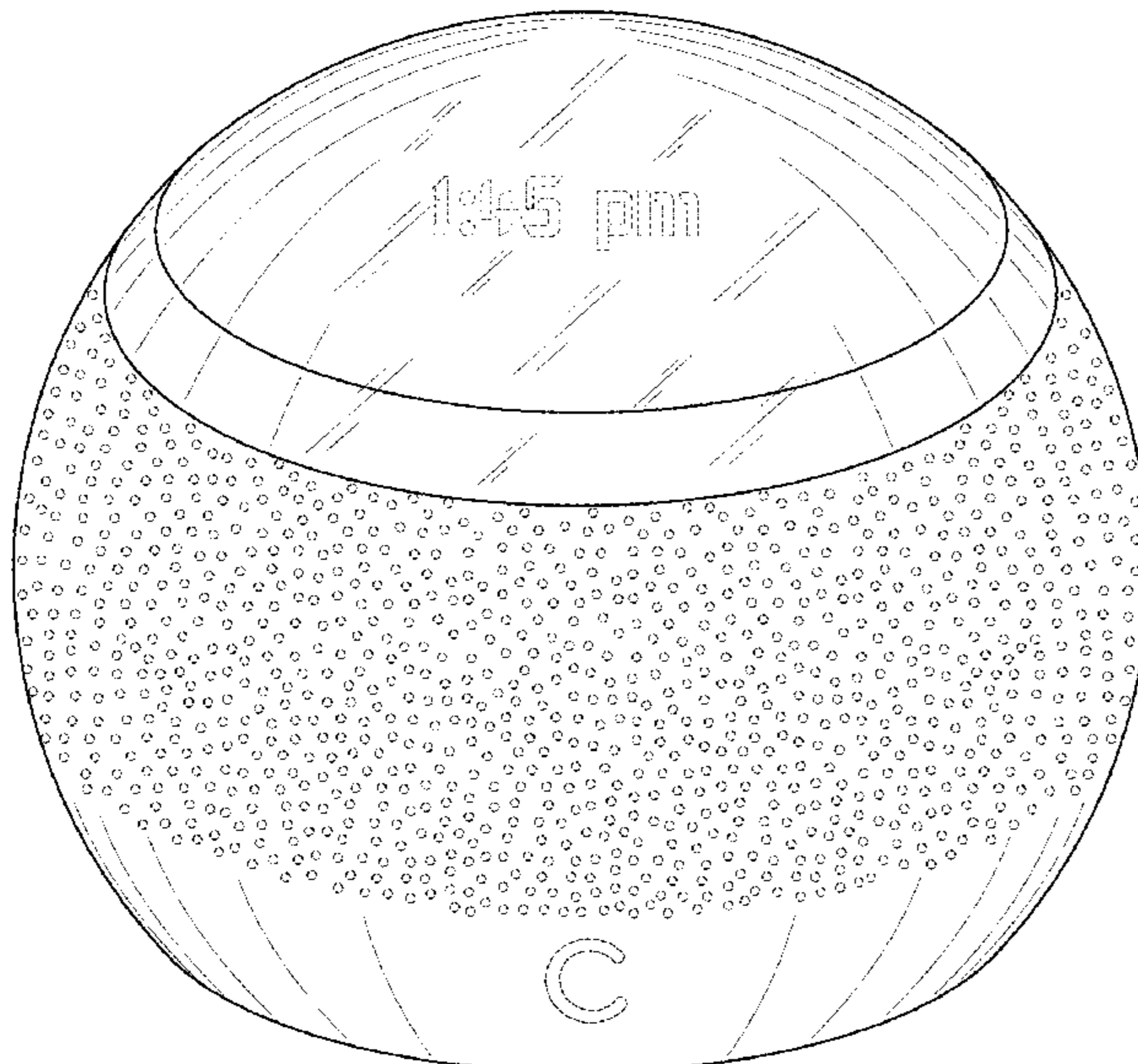
The ornamental design for a free standing personal voice assisted digital interface device, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a free standing personal voice assisted digital interface device, showing my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top view thereof; and, FIG. 7 is a bottom view thereof.

The broken dot-dash lines showing the time depict an environmental state of use and form no part of the claimed design. All other broken lines depict portions of the free standing personal voice assisted digital interface device that form no part of the claimed design.

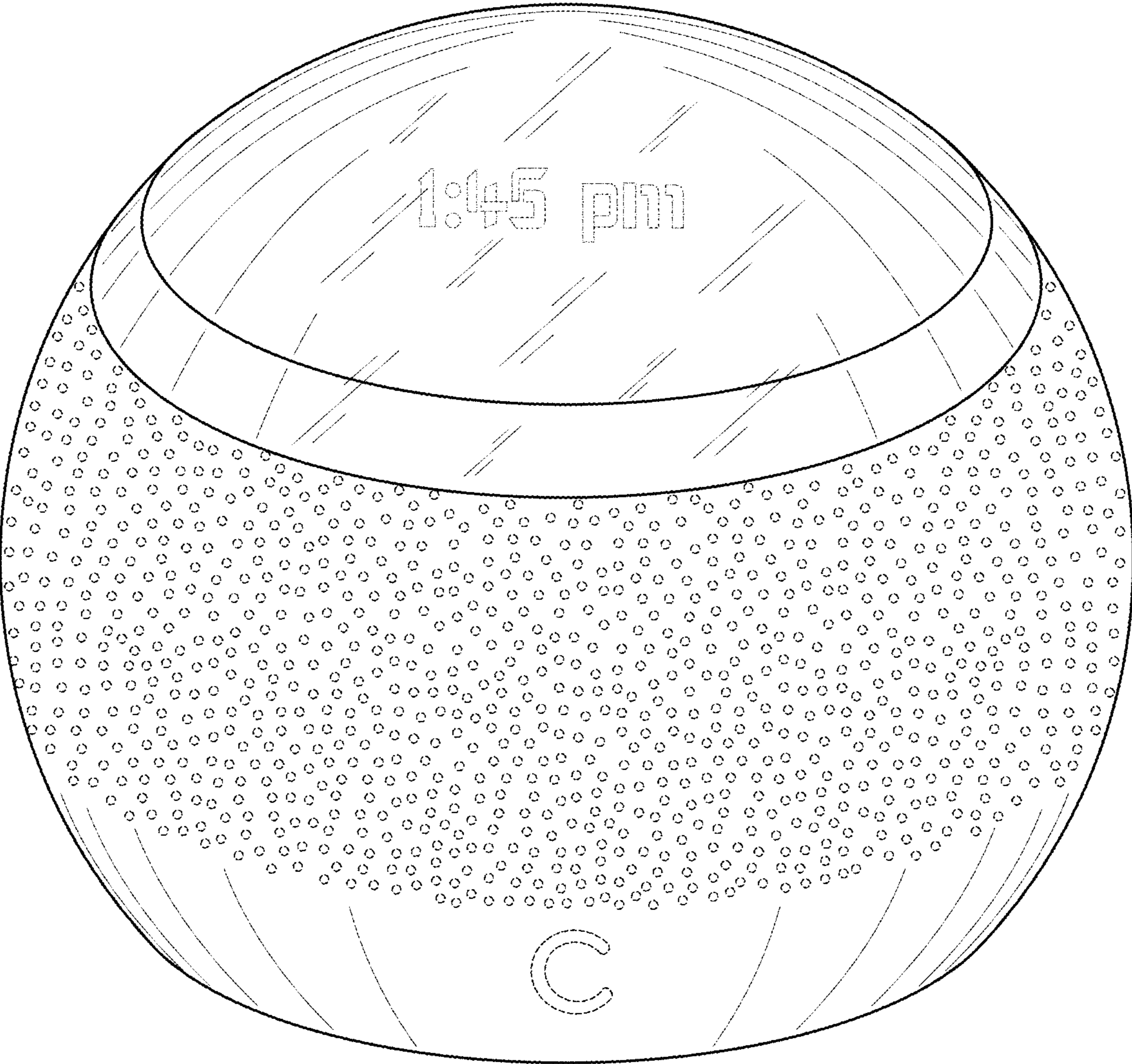

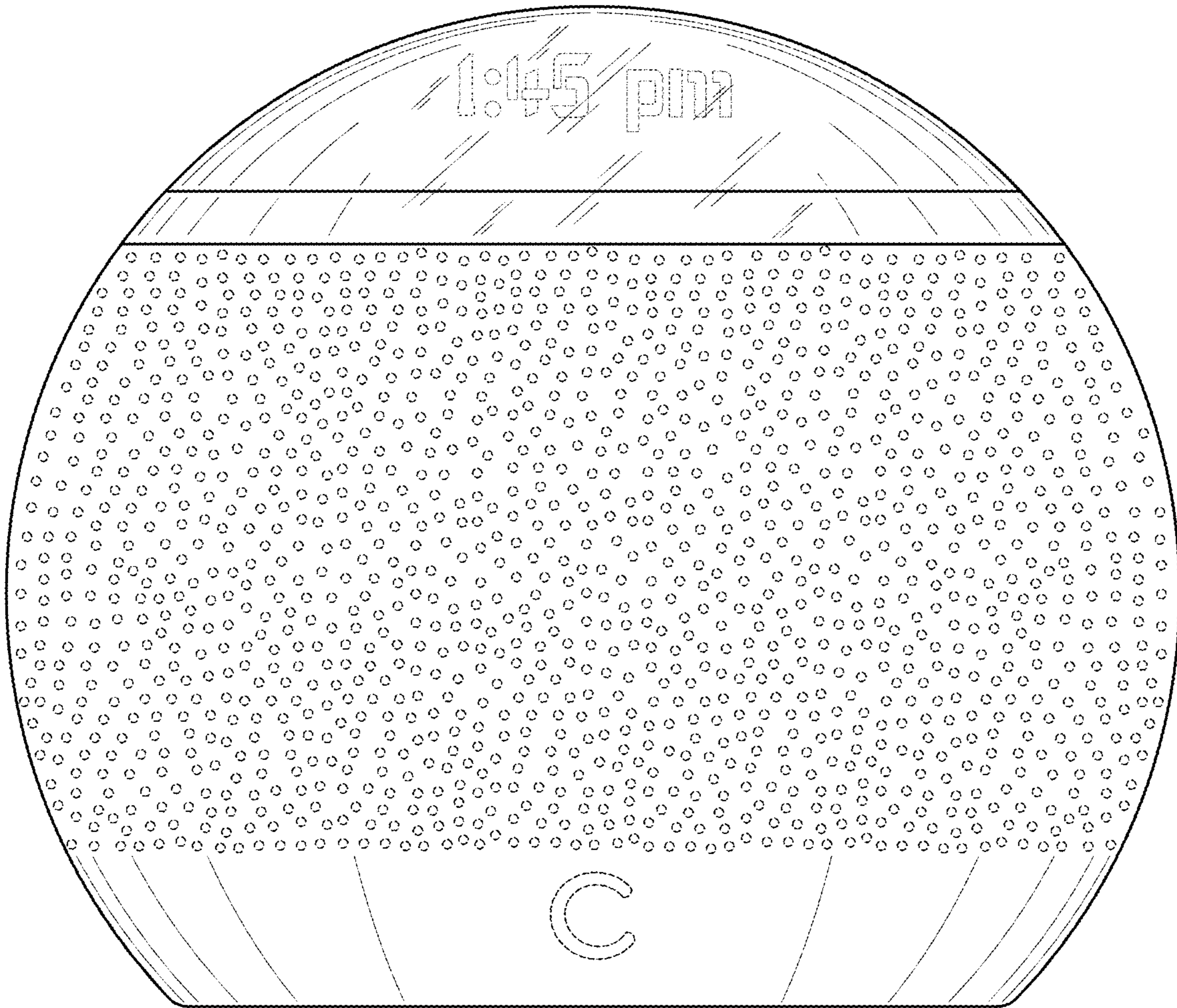

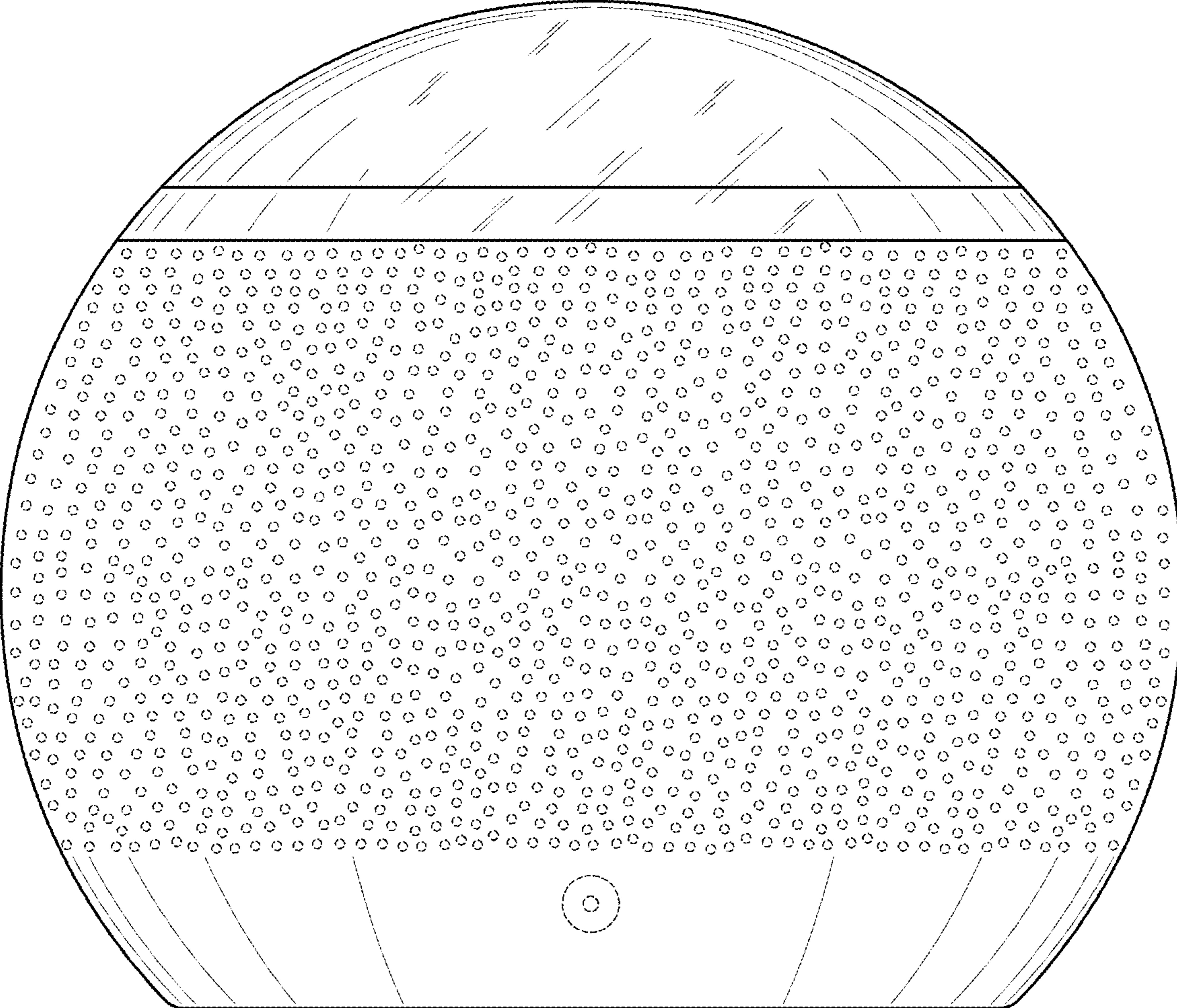

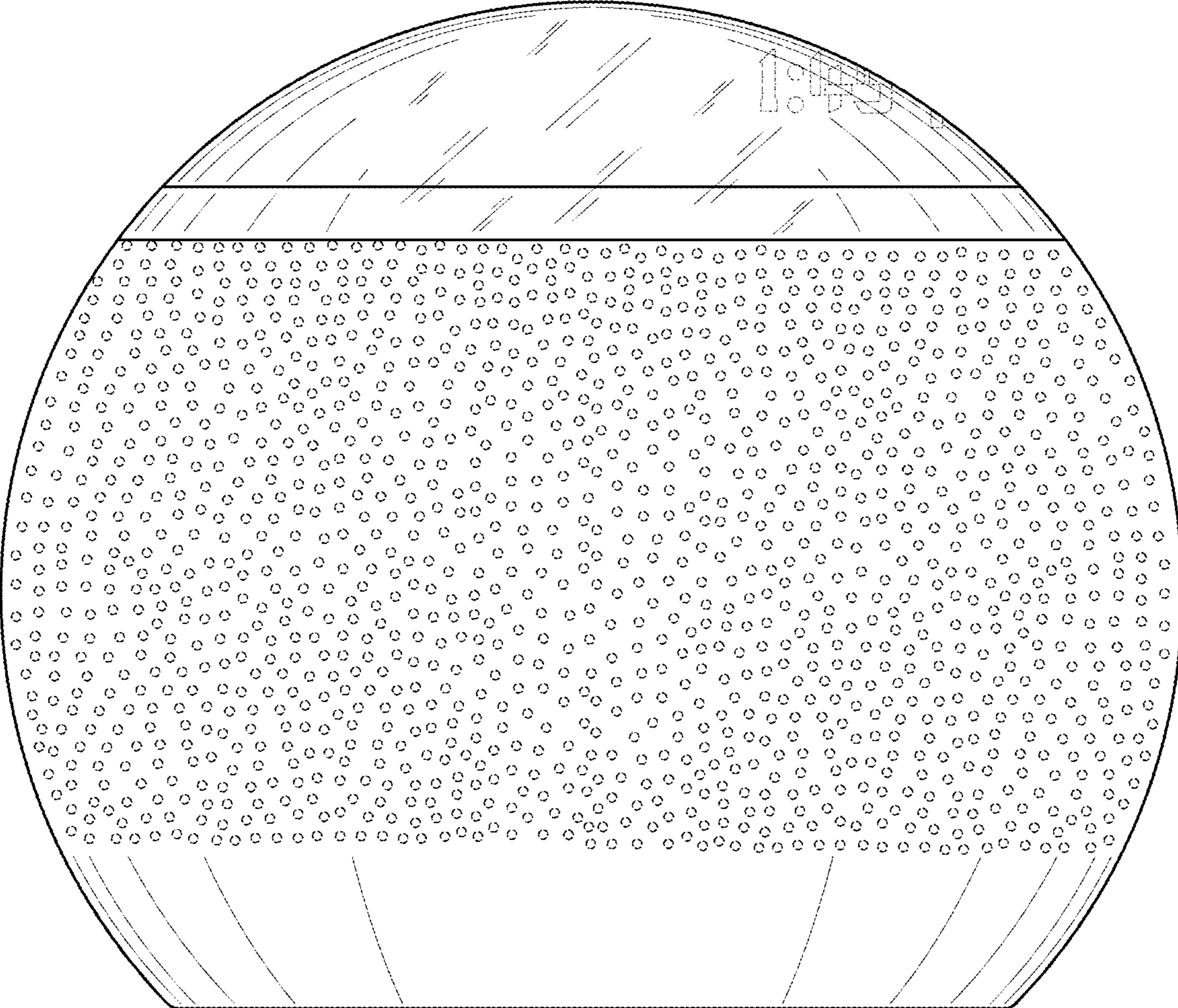

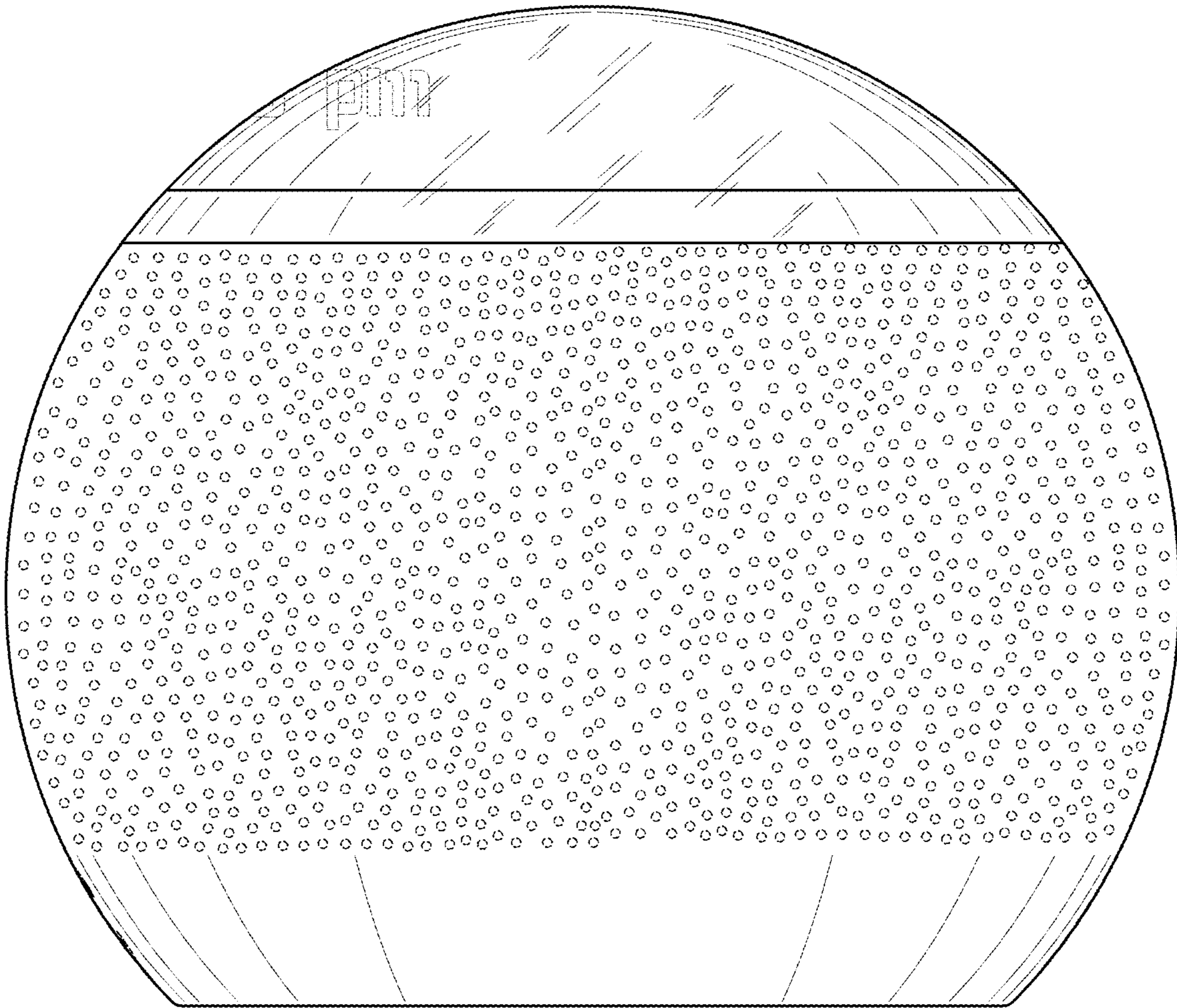

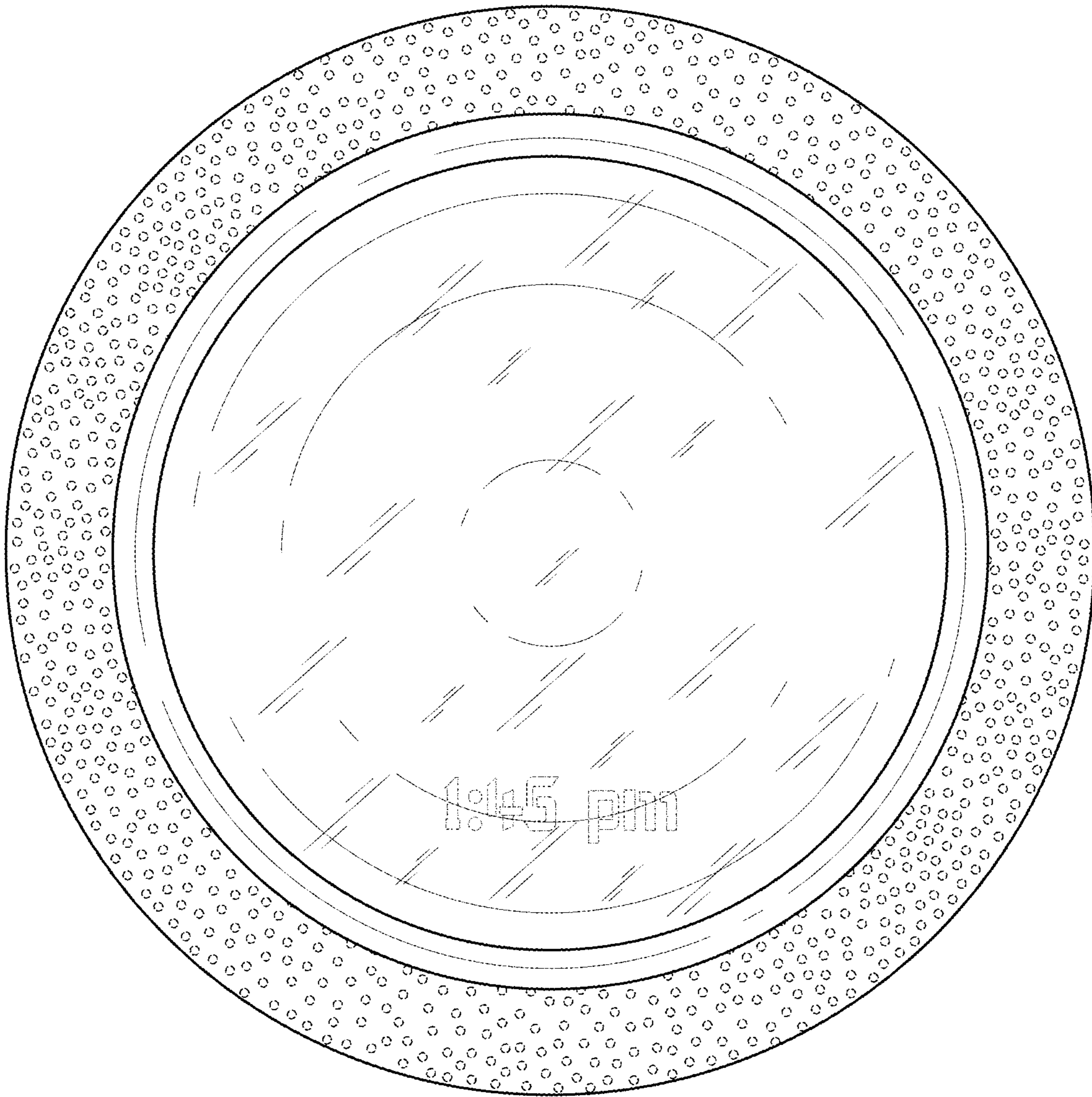

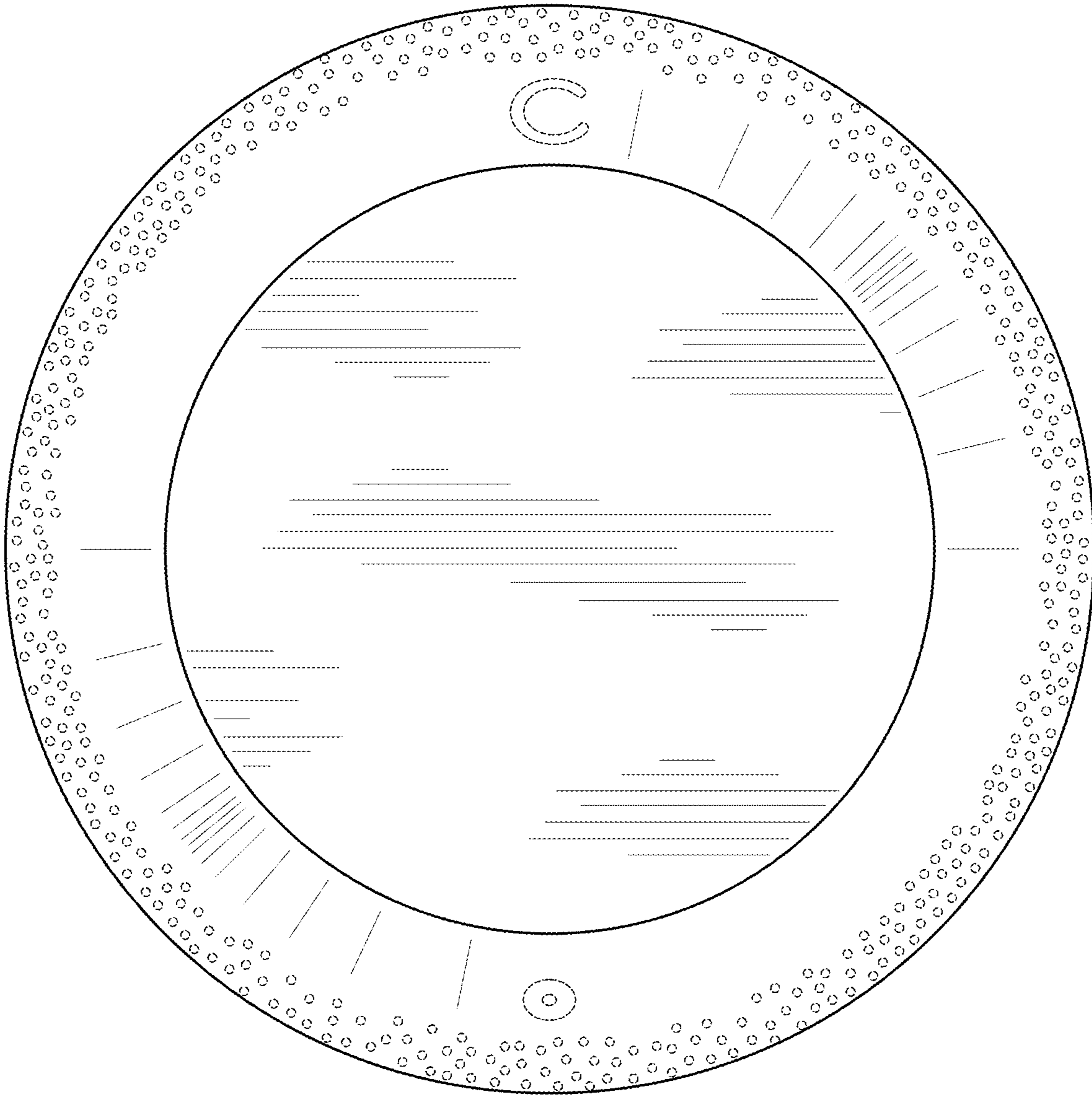
