FIG. 1 is a front view of a display screen or portion thereof with graphical user interface according to a first embodiment, showing my new design;

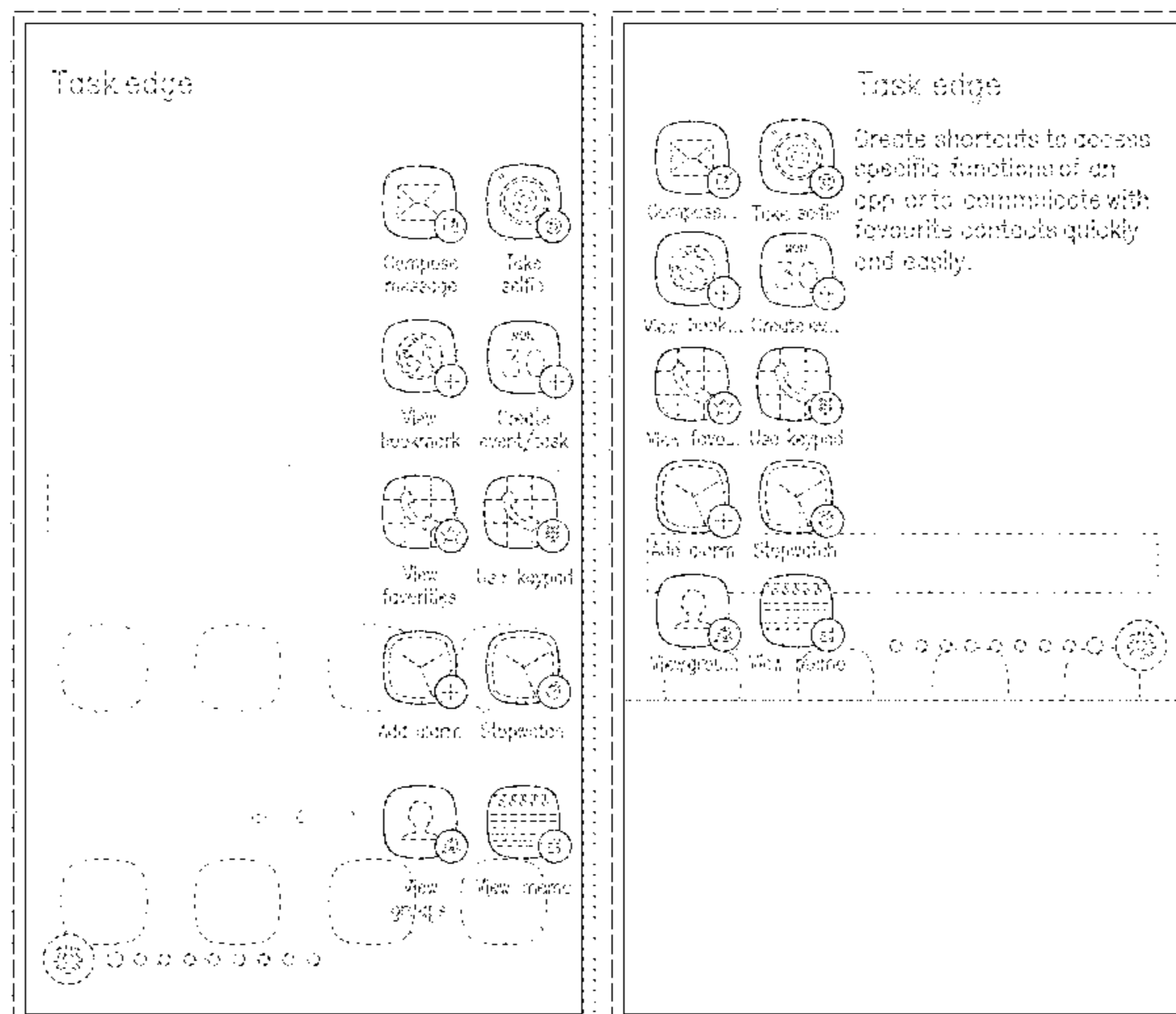
FIG. 2 is a front view thereof according to a second embodiment;

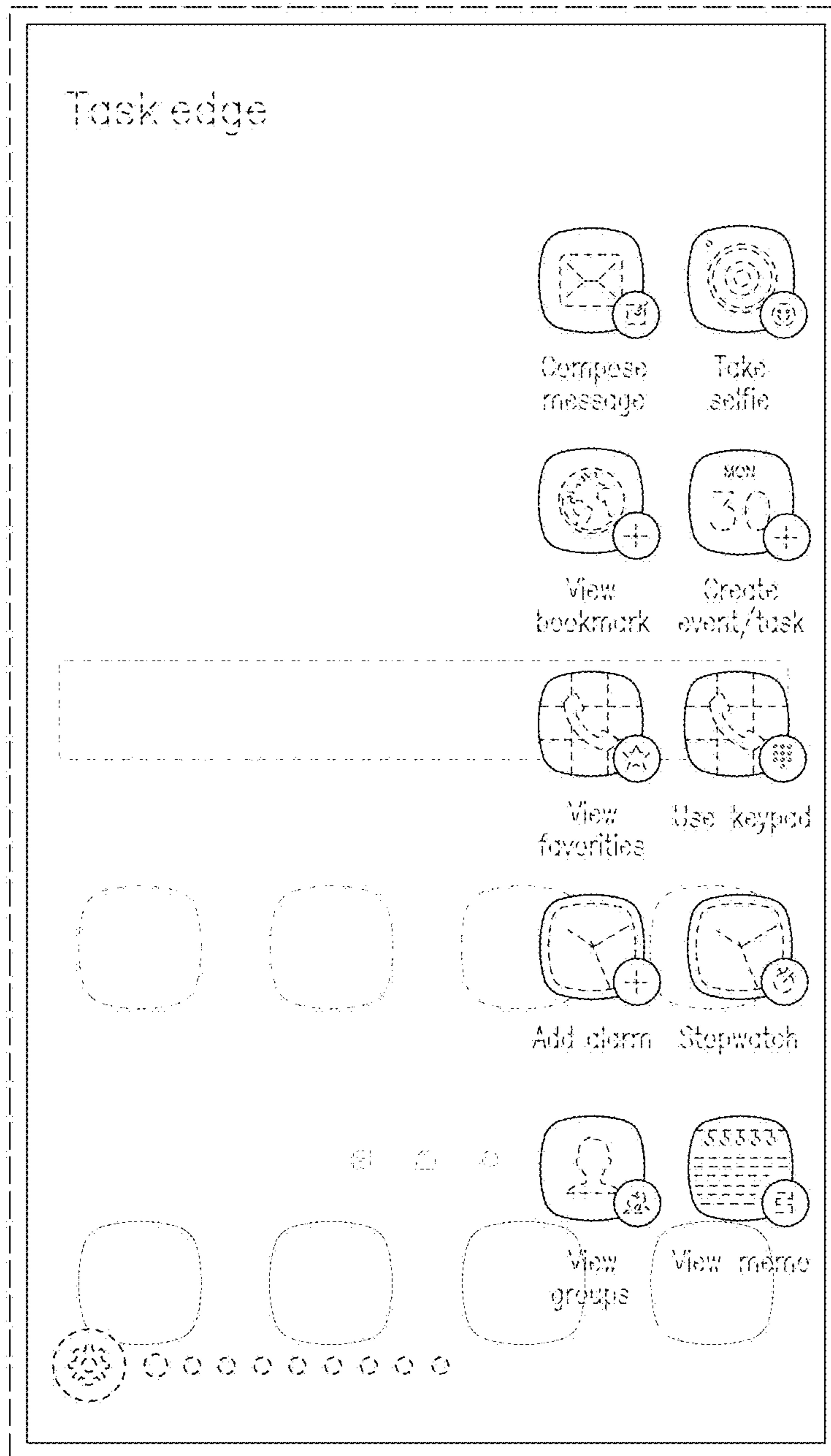

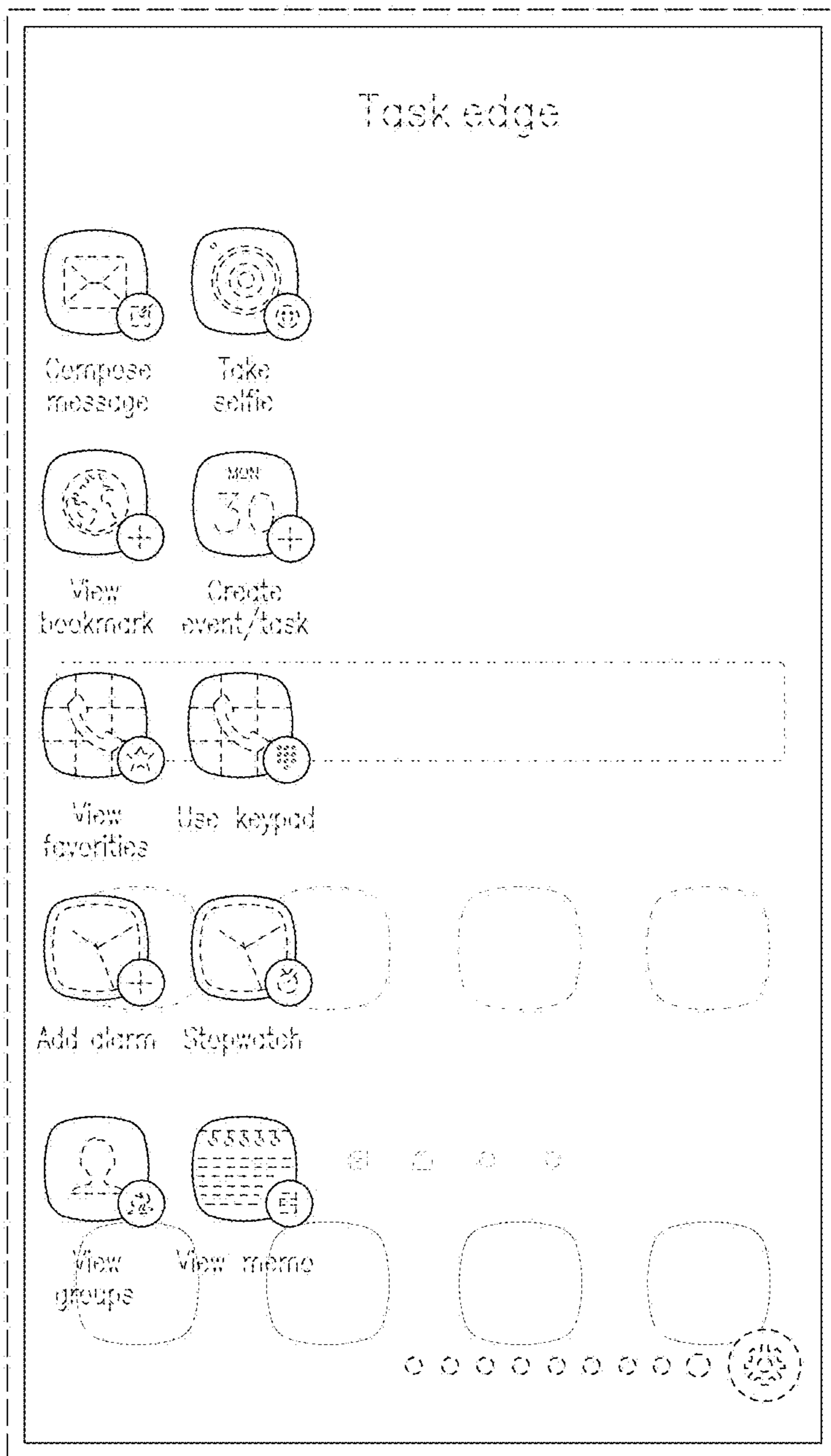

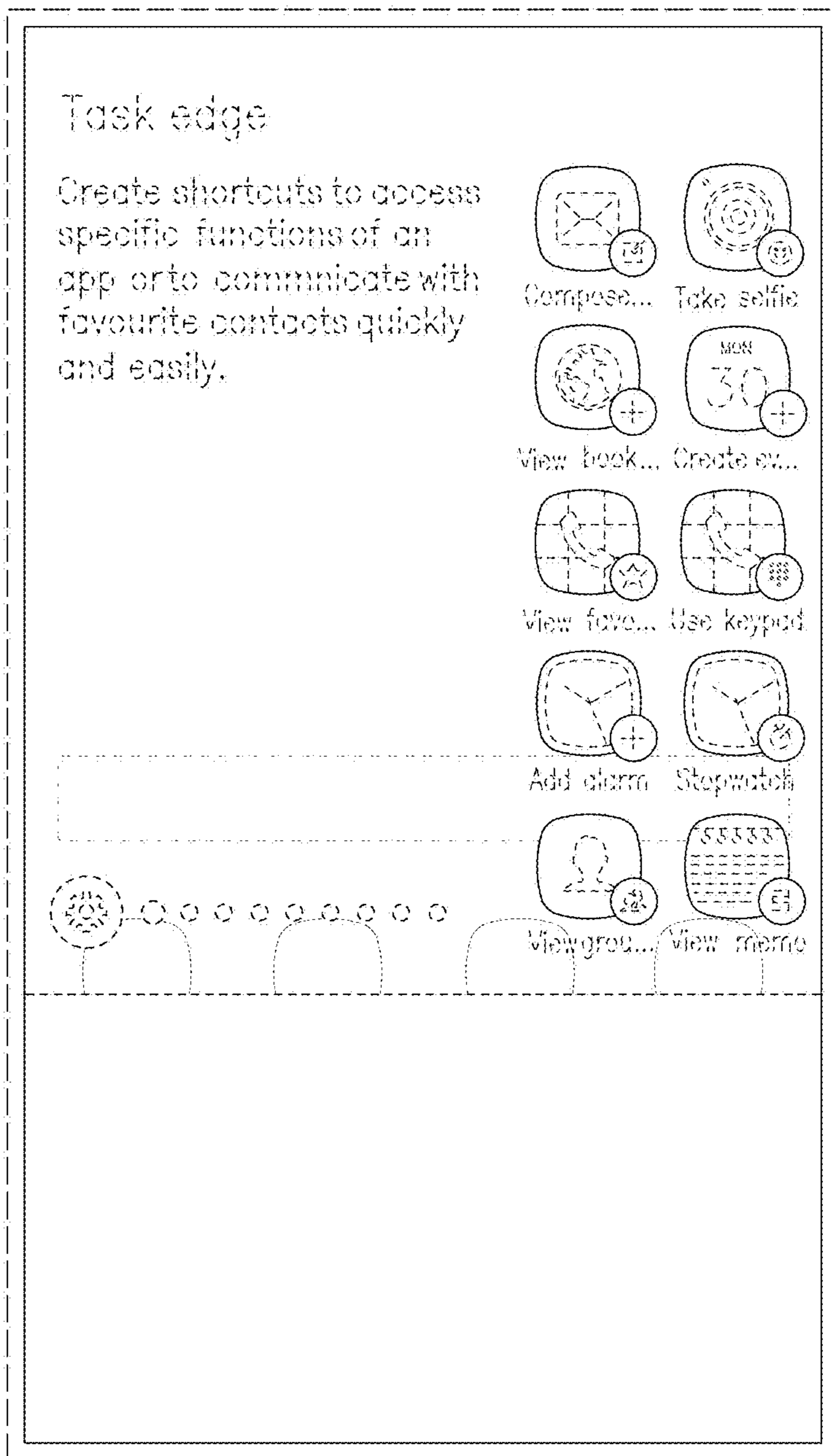
