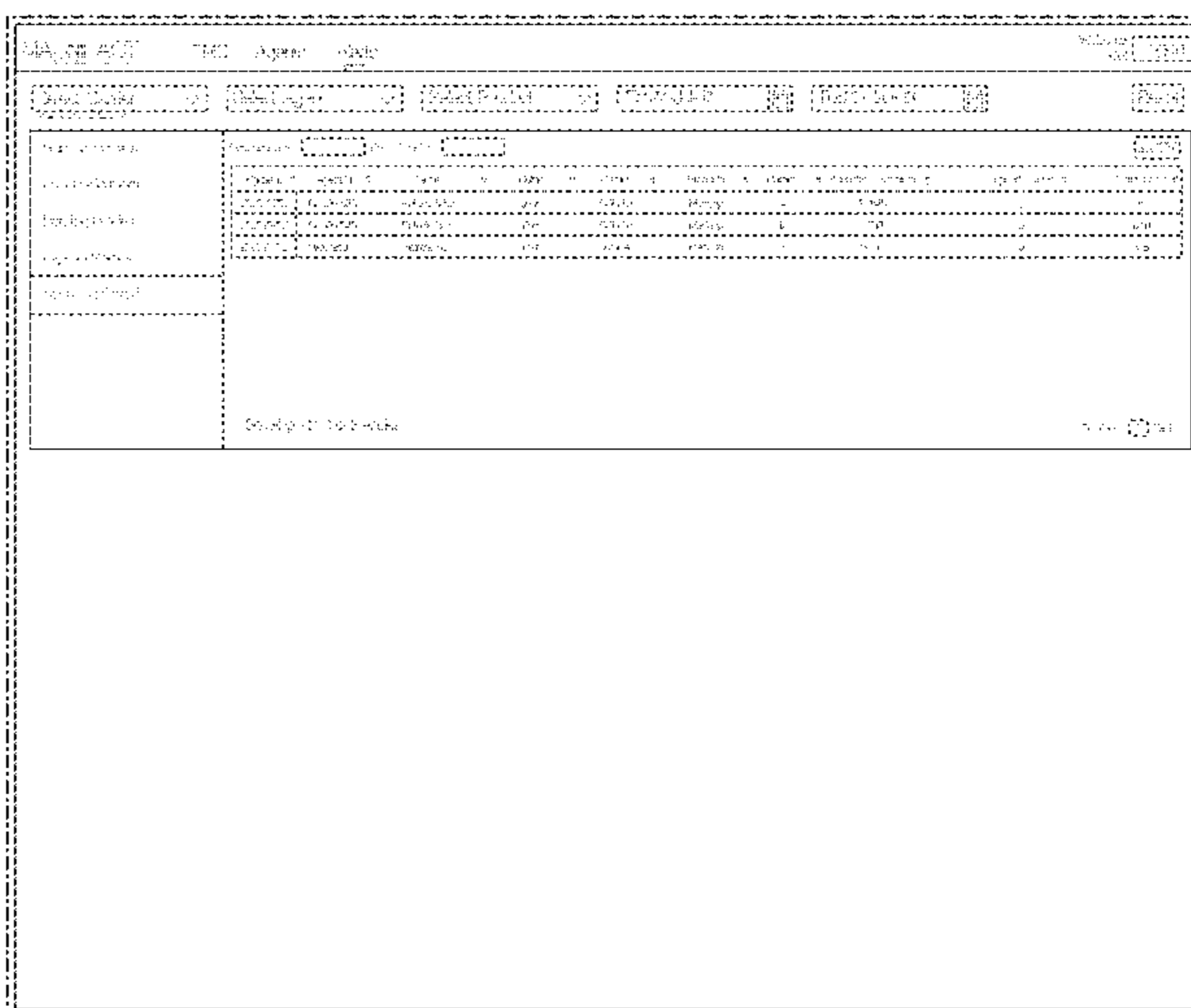
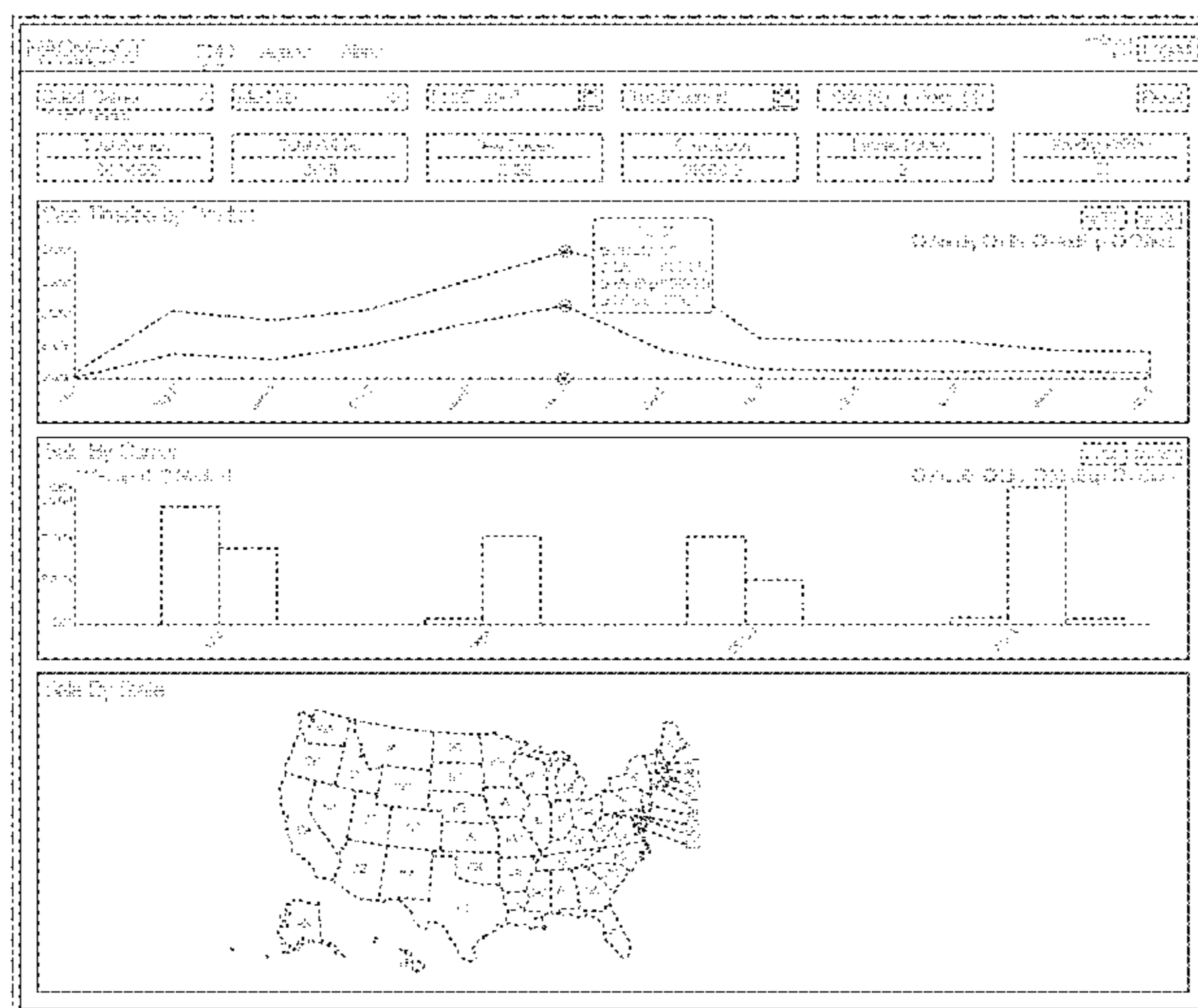
The ornamental design for a display screen with a transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image of a display screen with a transitional graphical user interface;

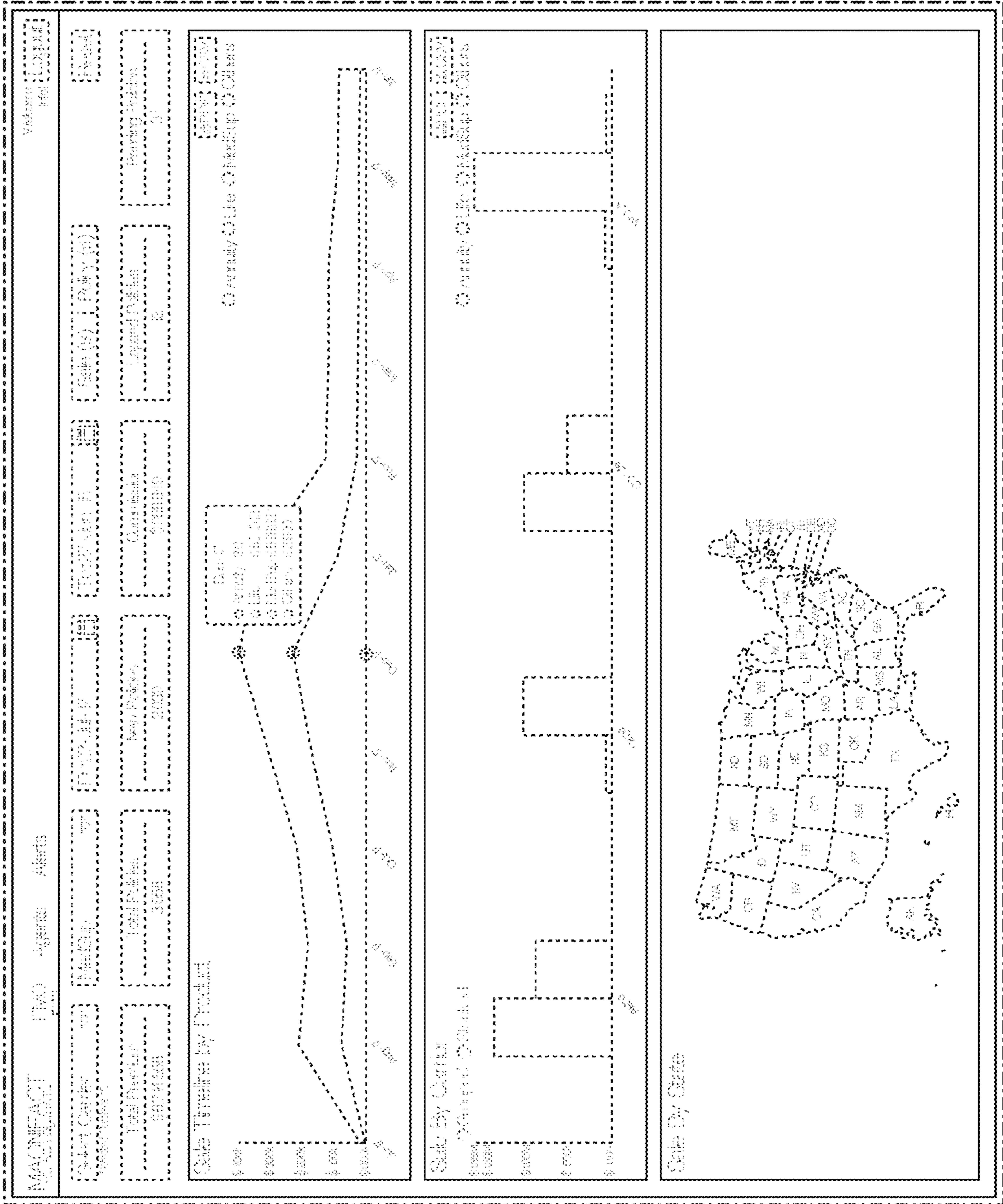

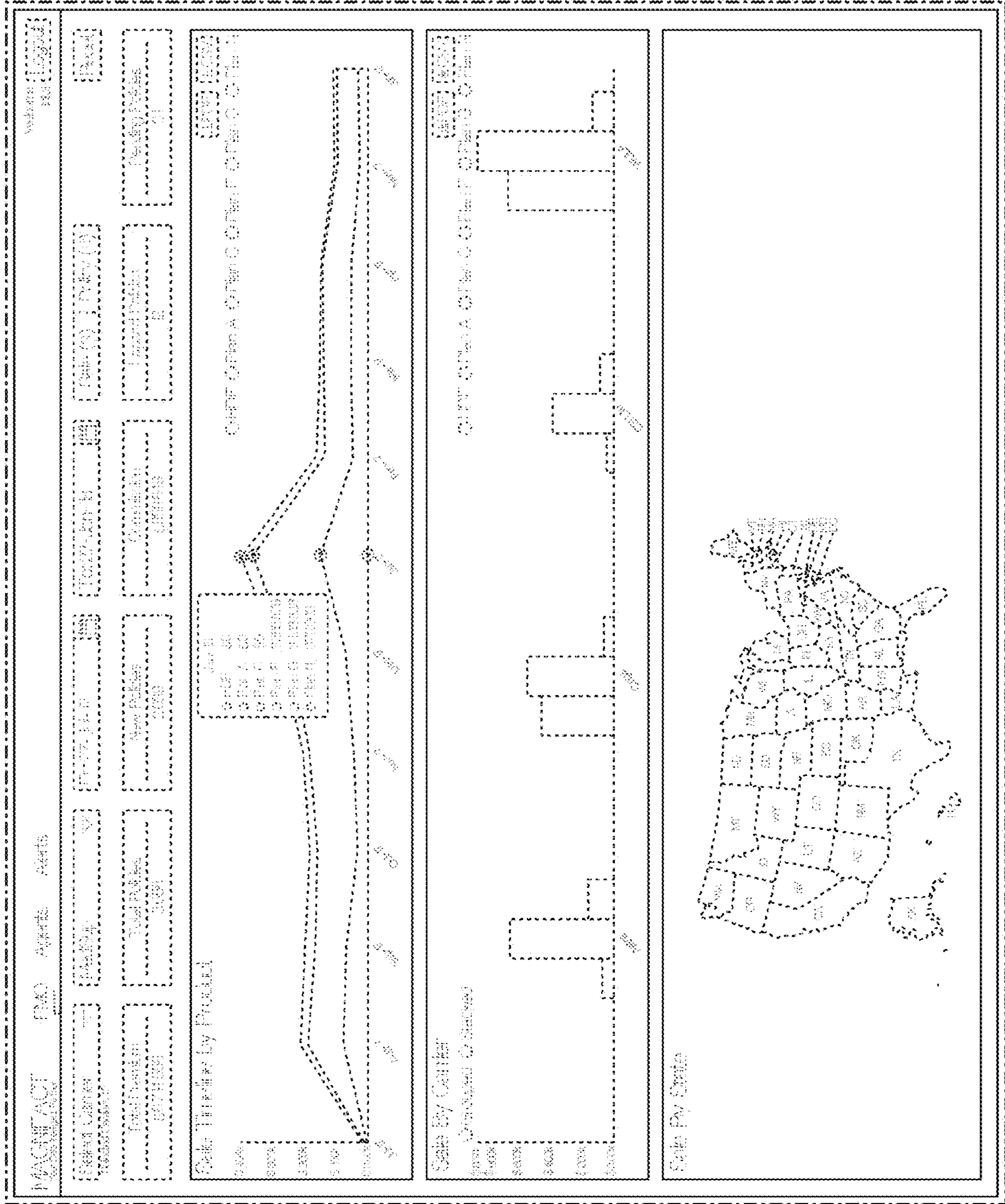

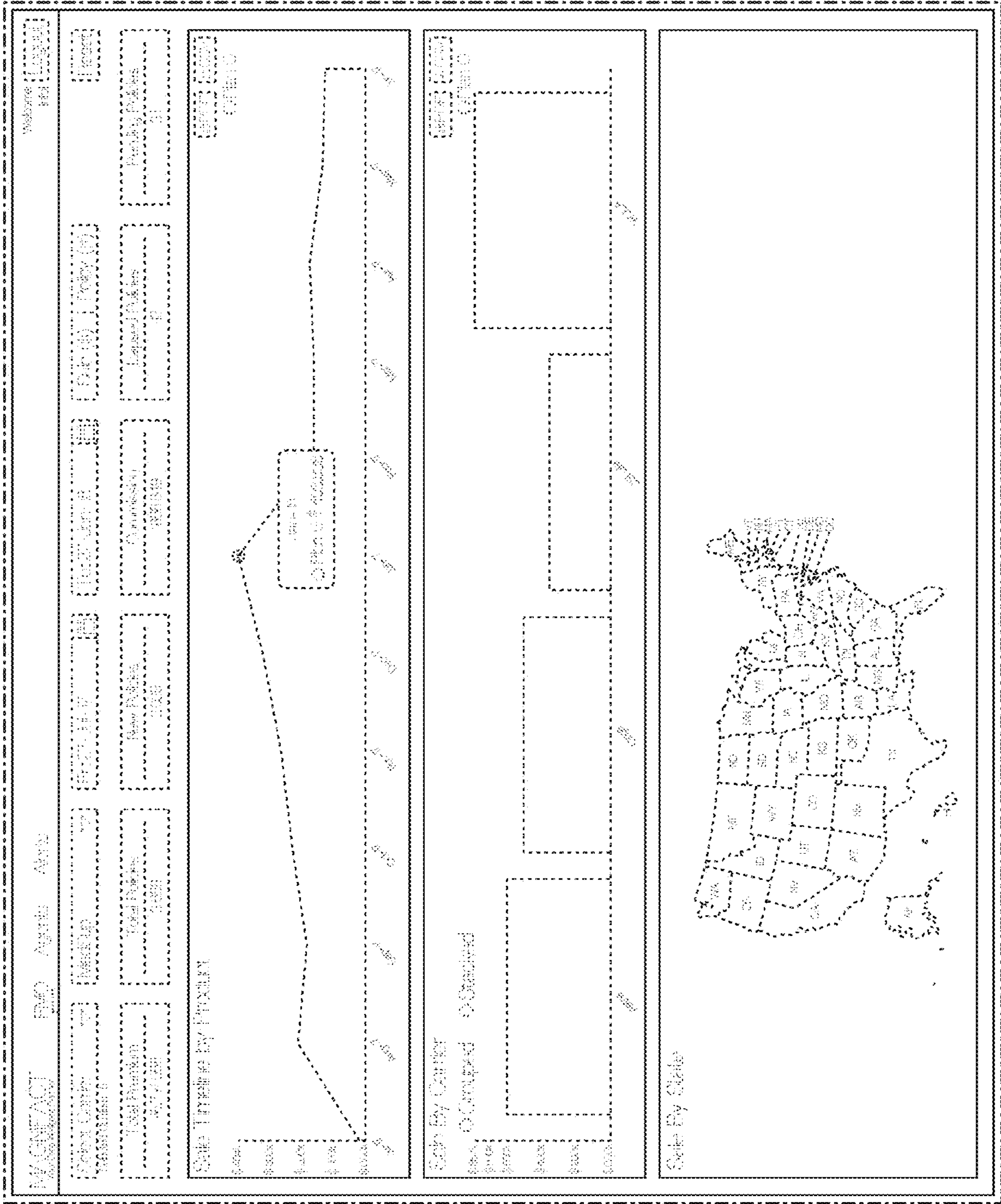

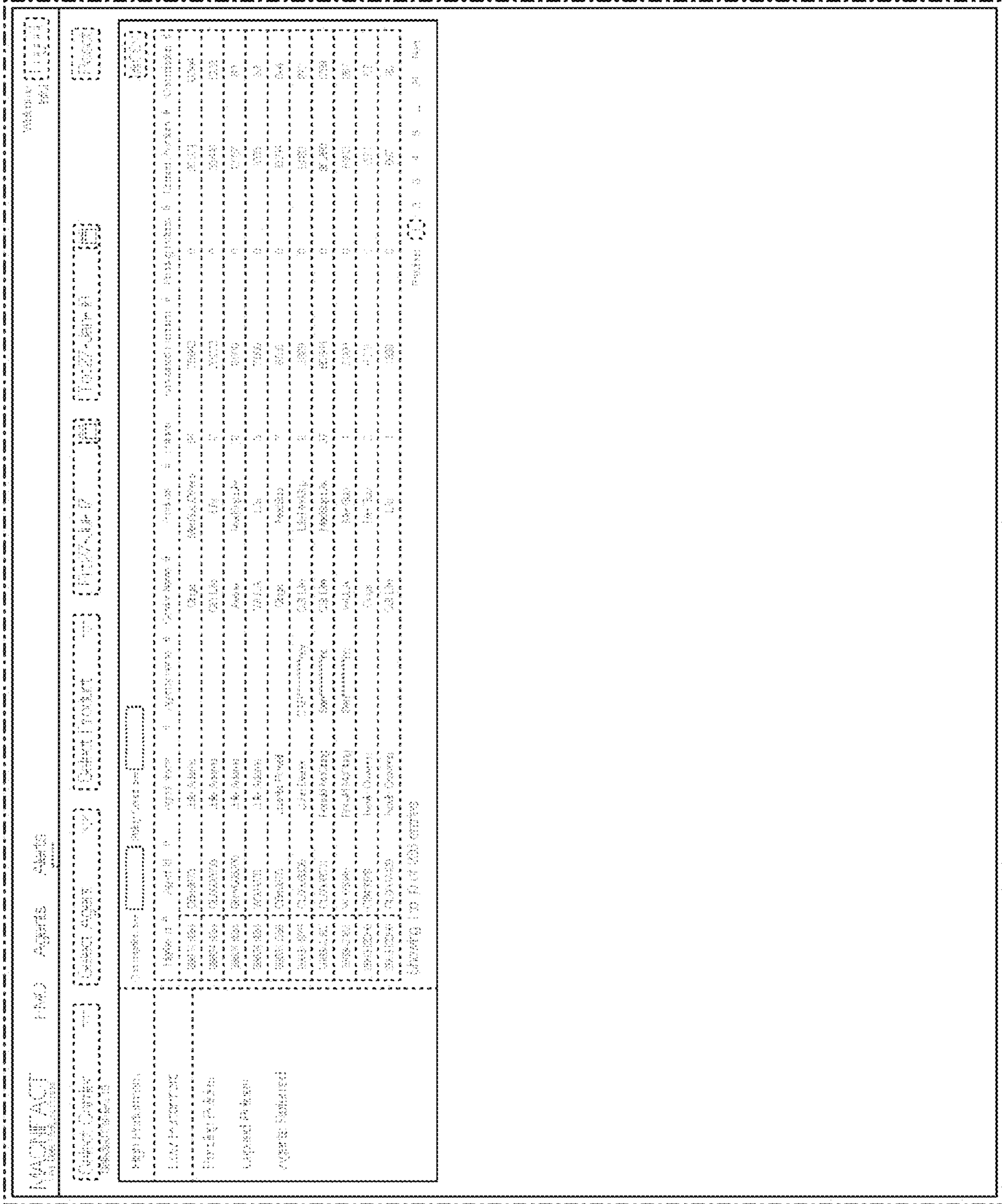

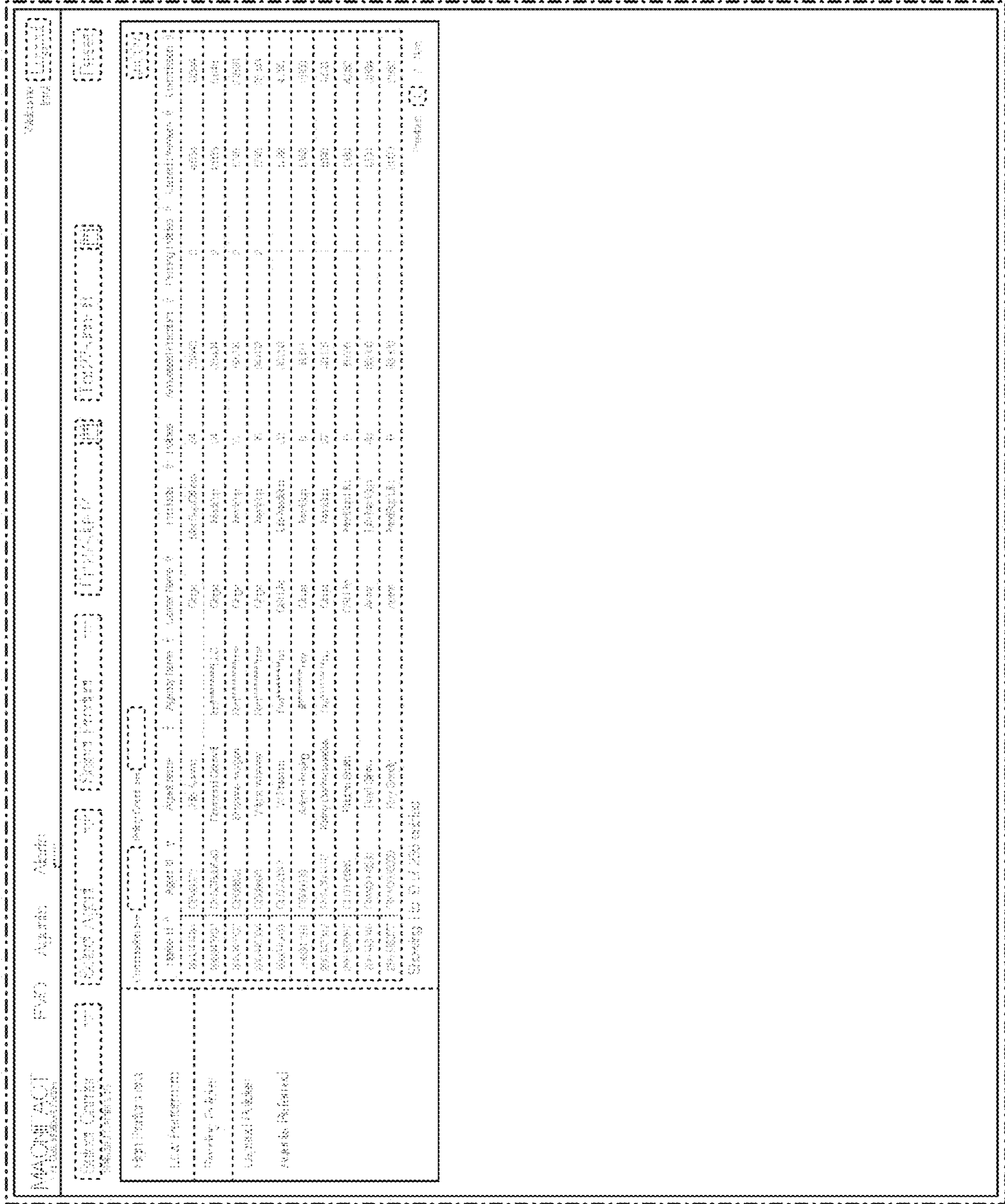

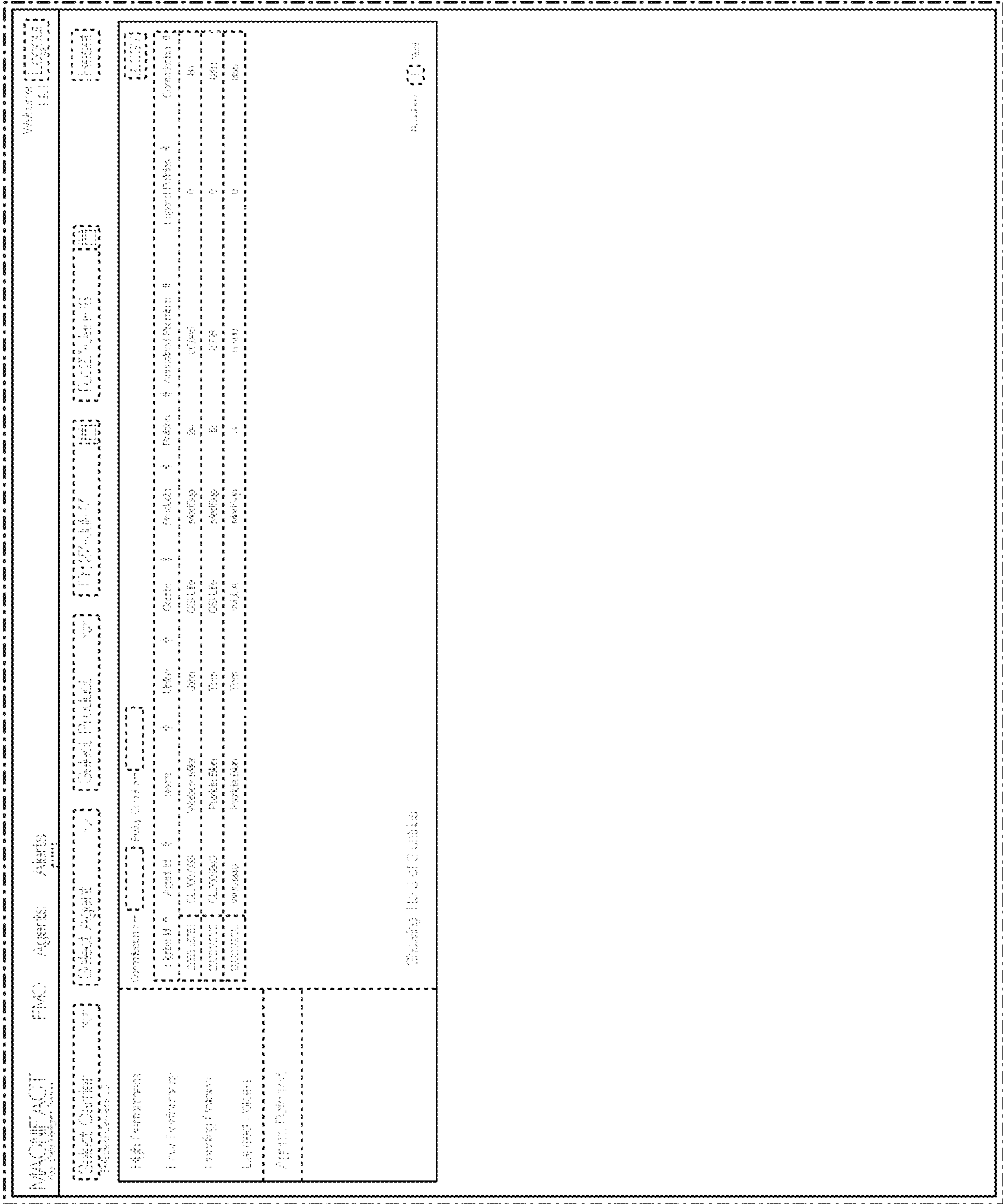

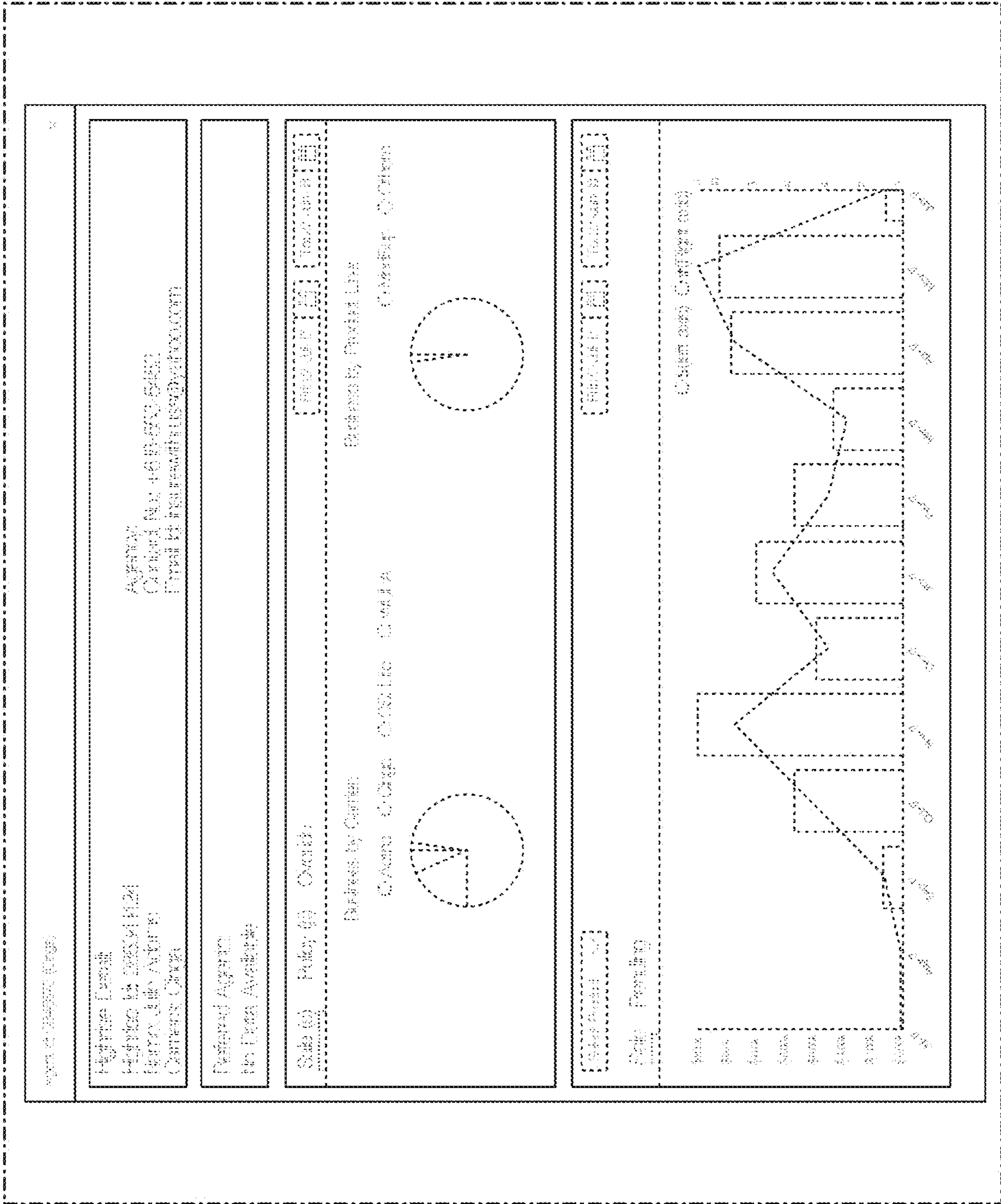
