FIG. 2 shows a second image thereof;

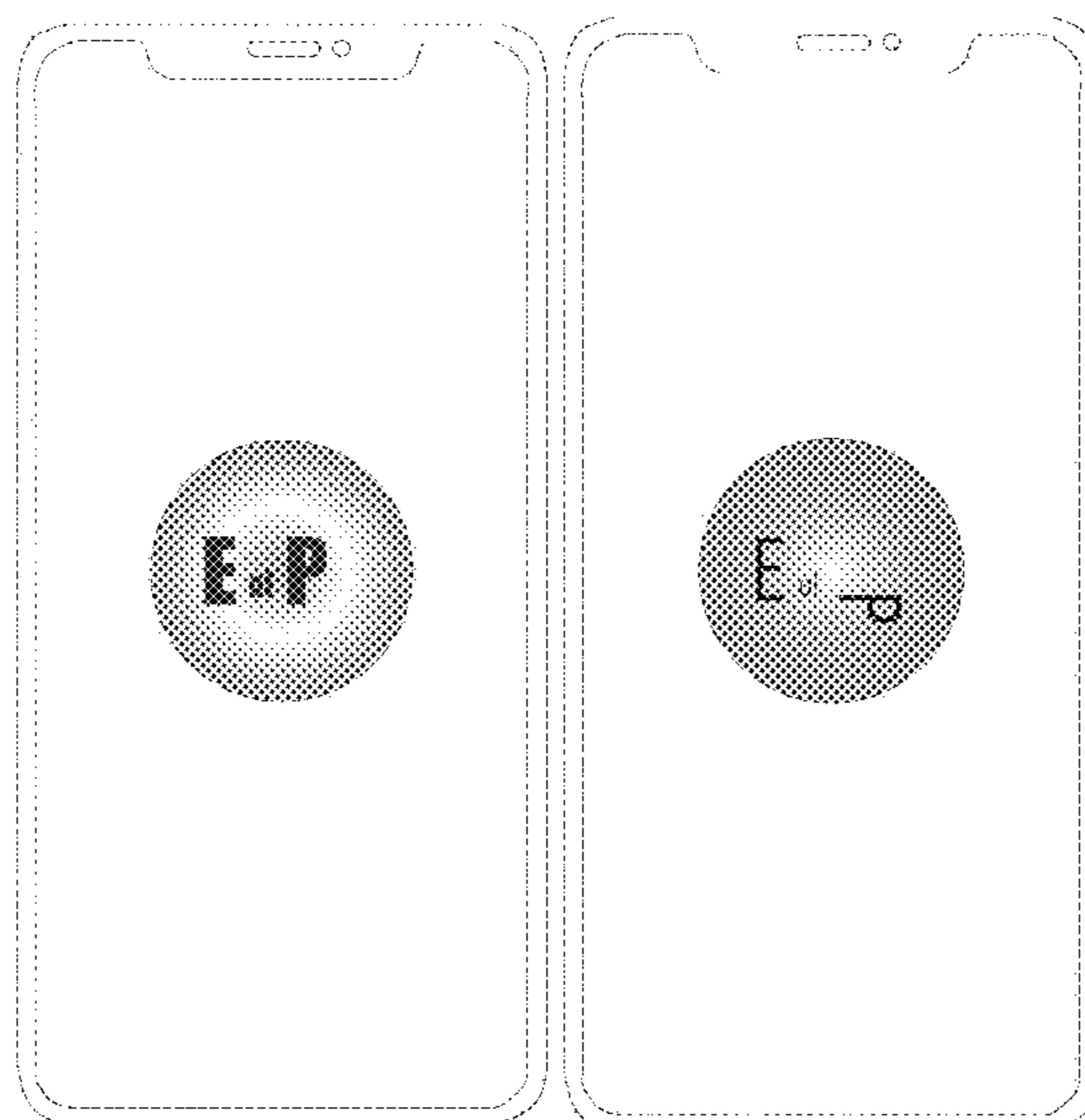
FIG. 3 shows a third image thereof; and,

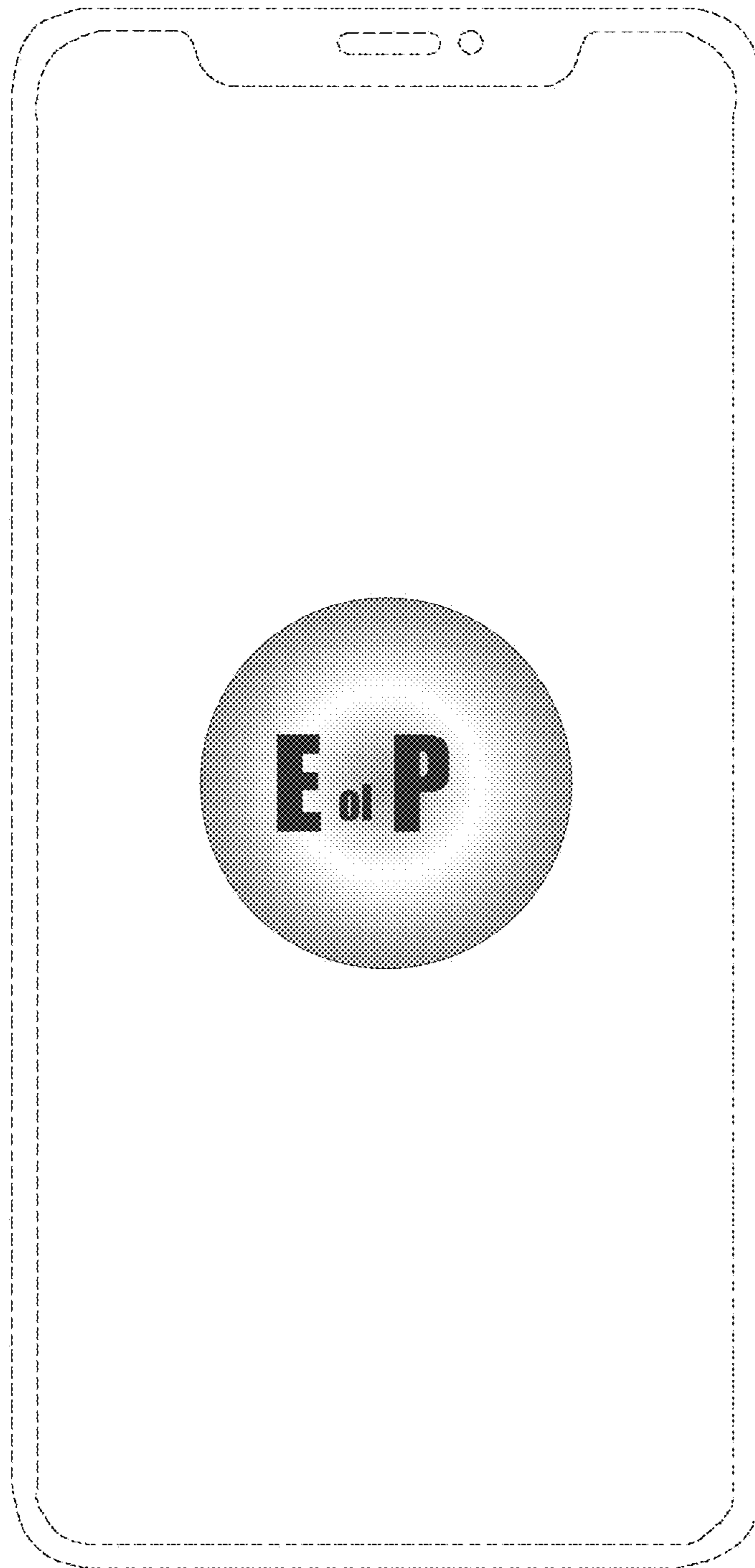

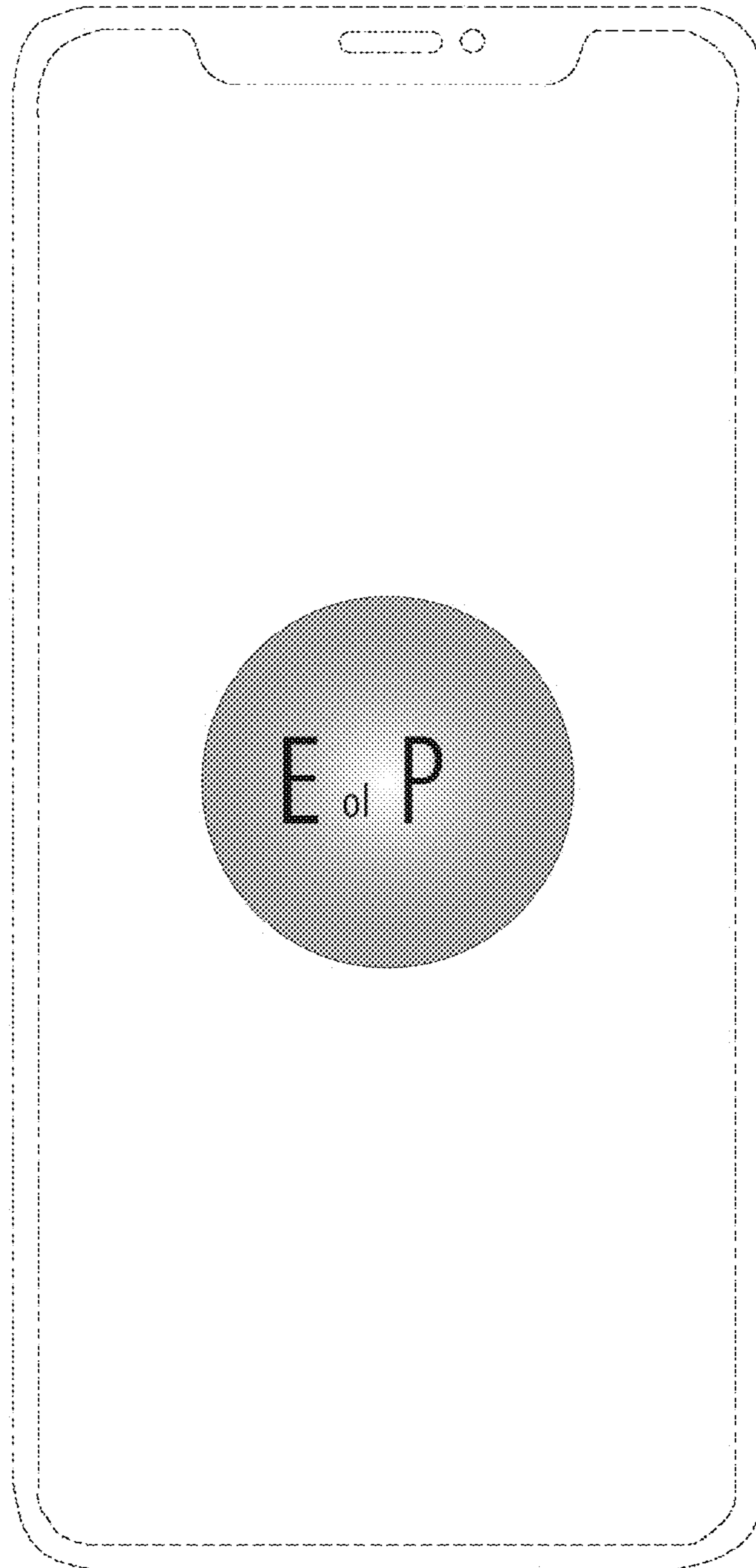

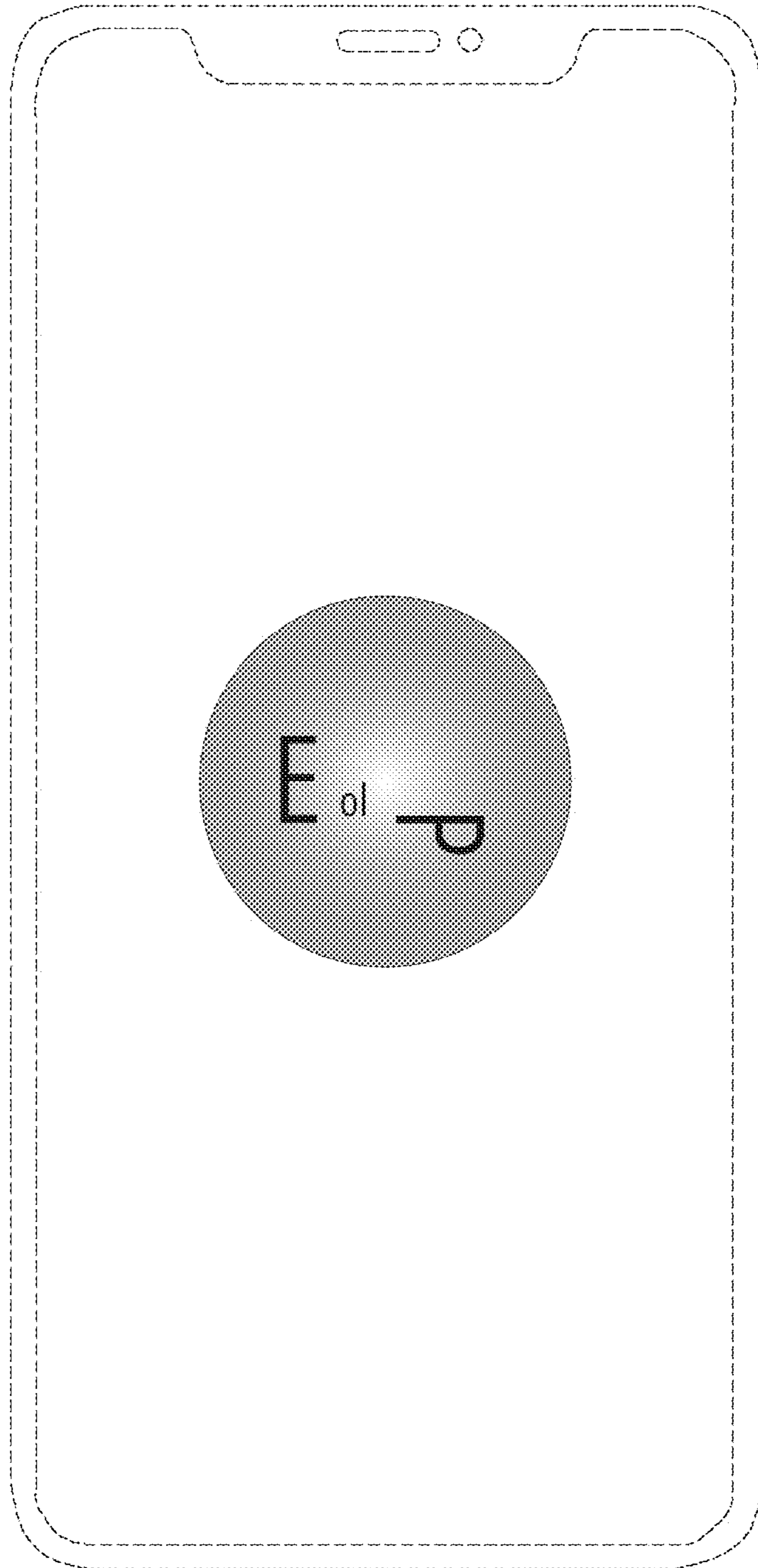

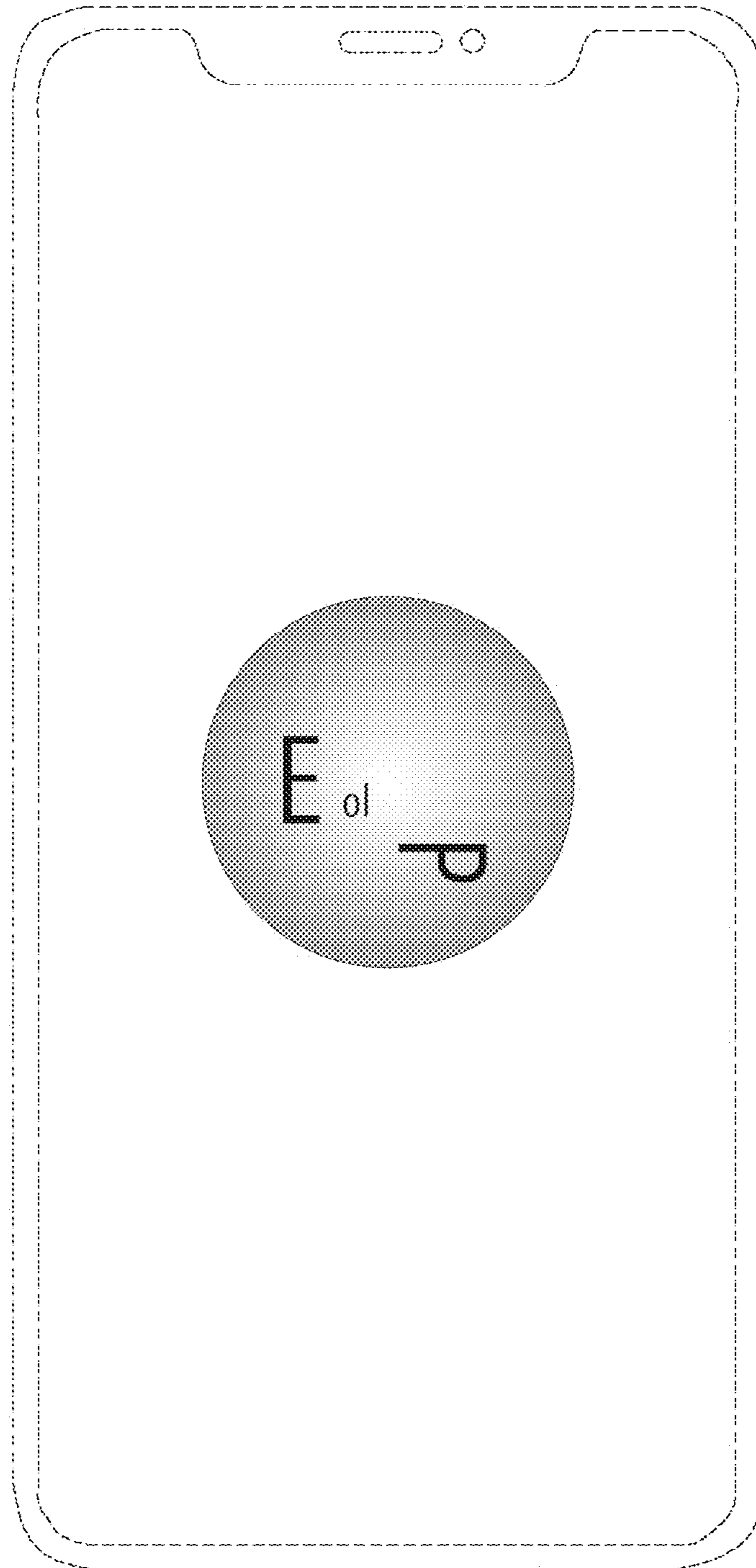
