DESCRIPTION

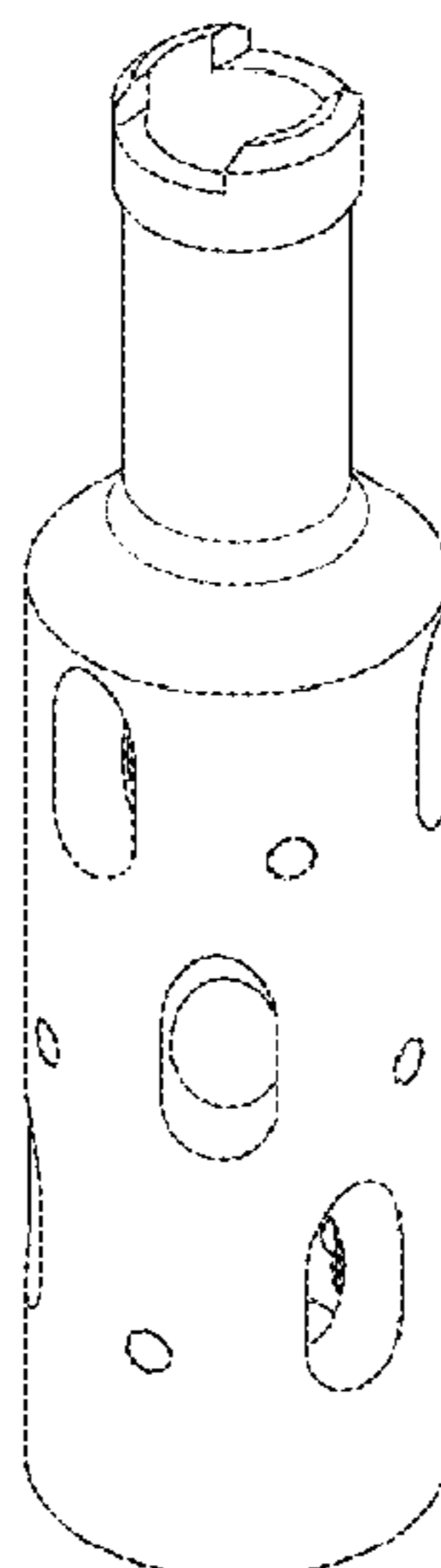
FIG. 1 is a top view of our new design for a roller valve rod guide;

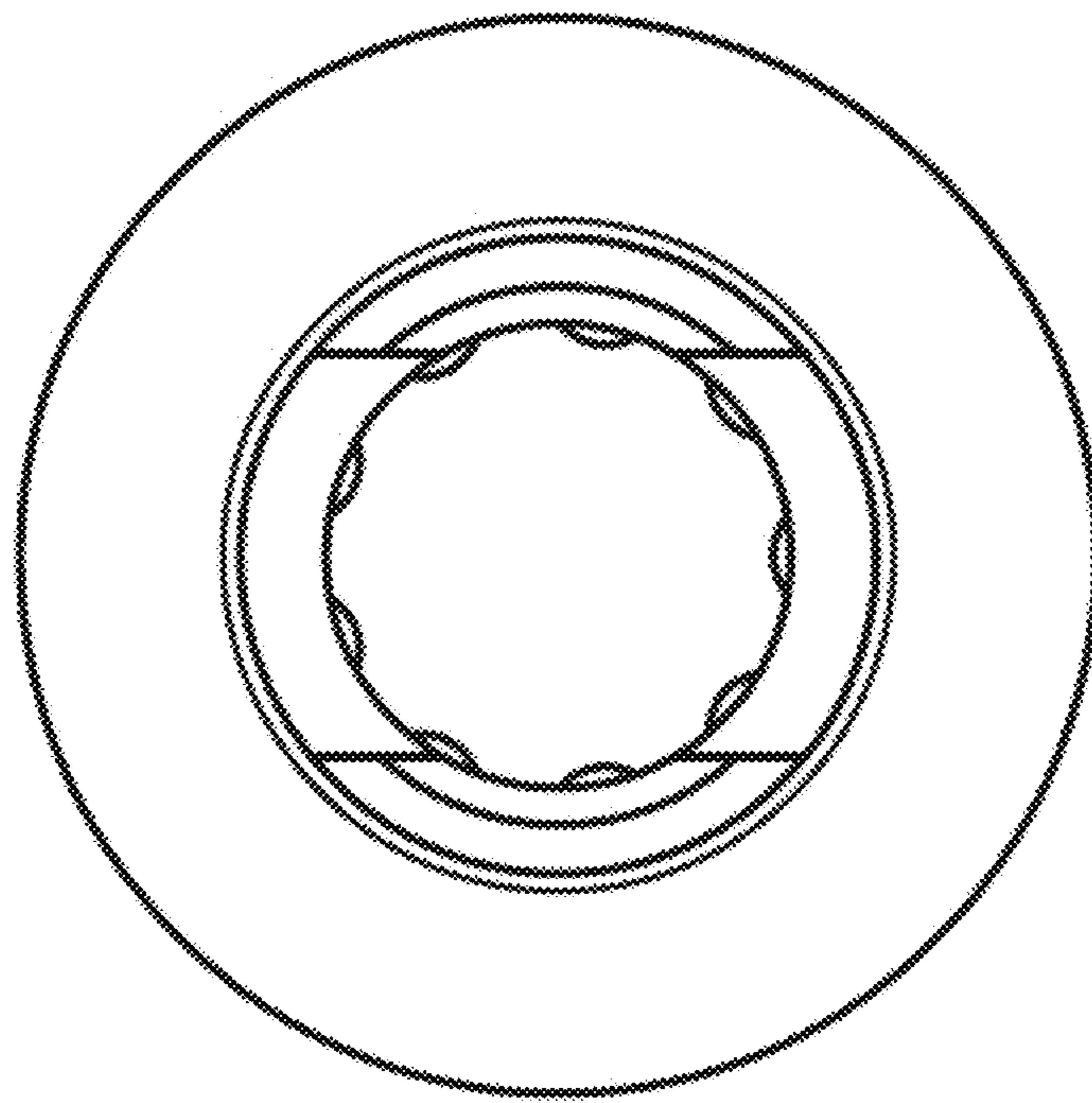

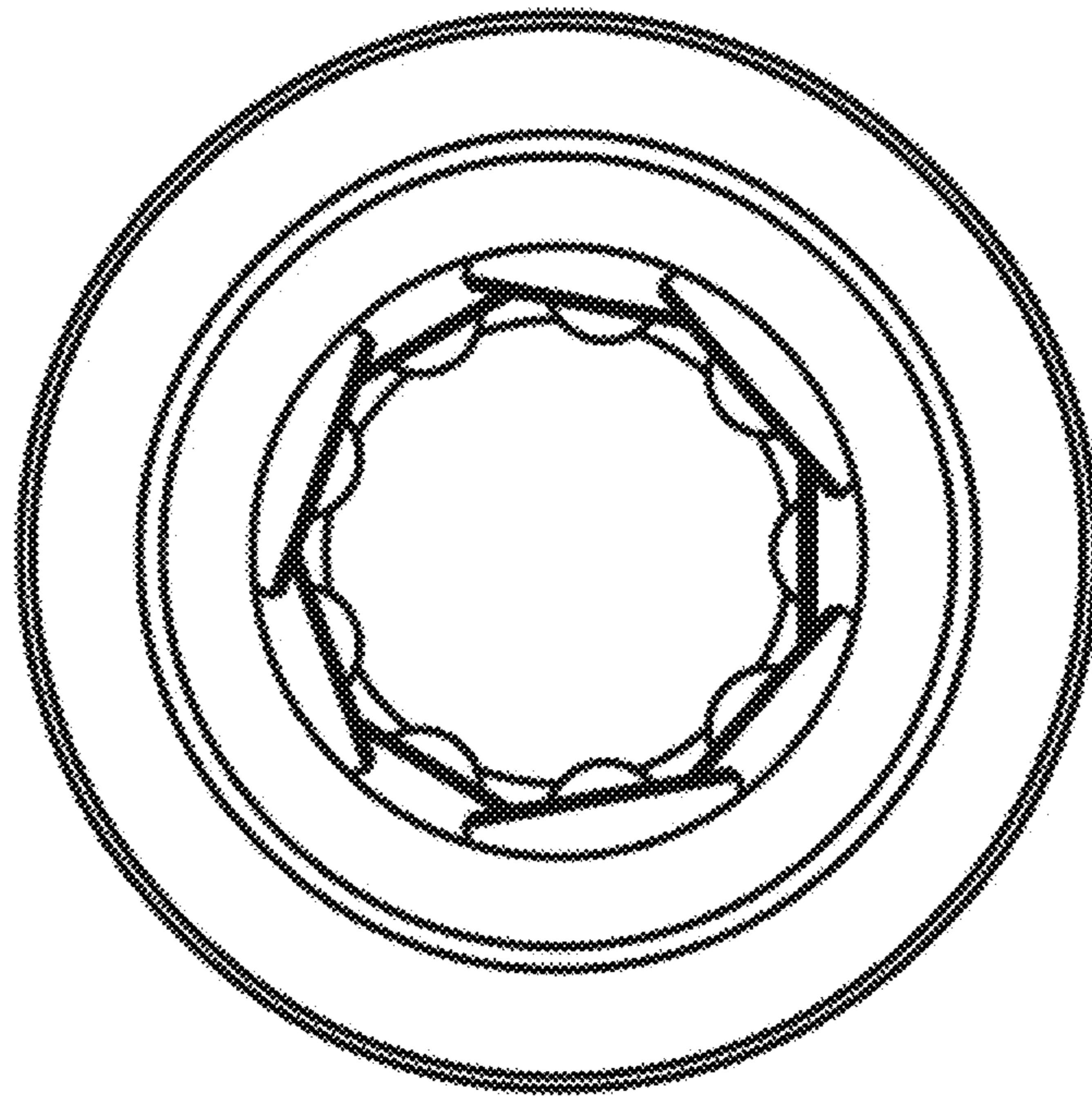

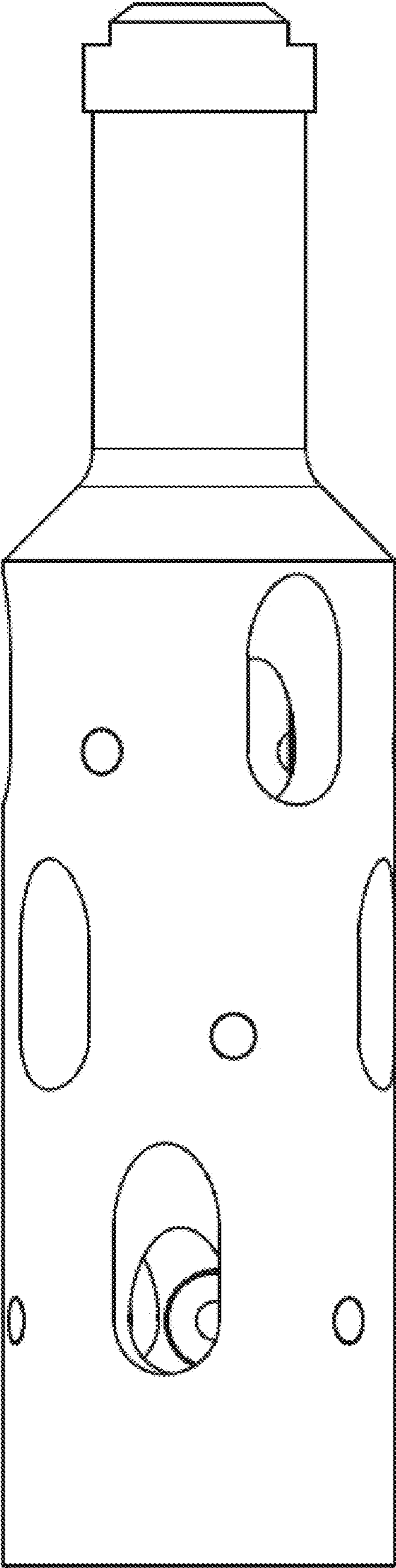

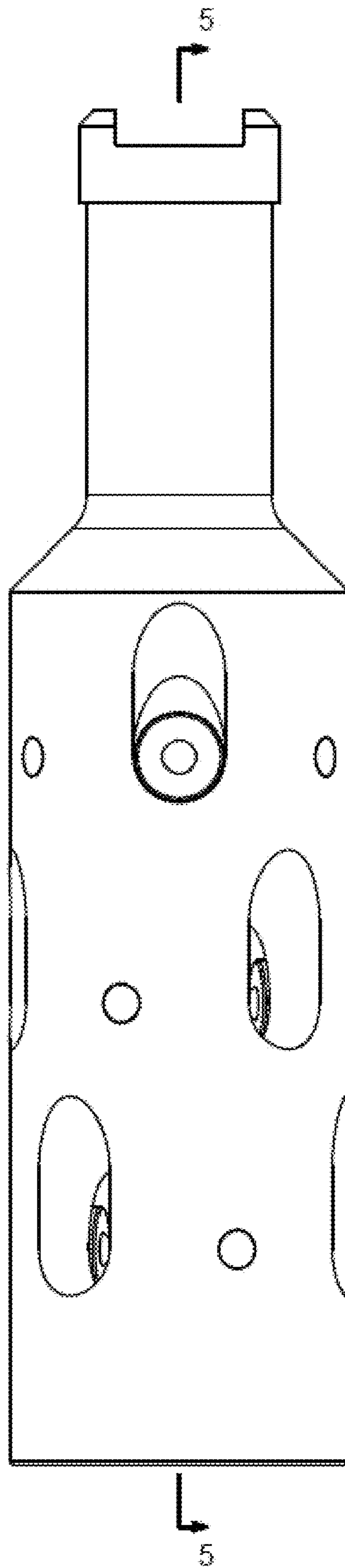

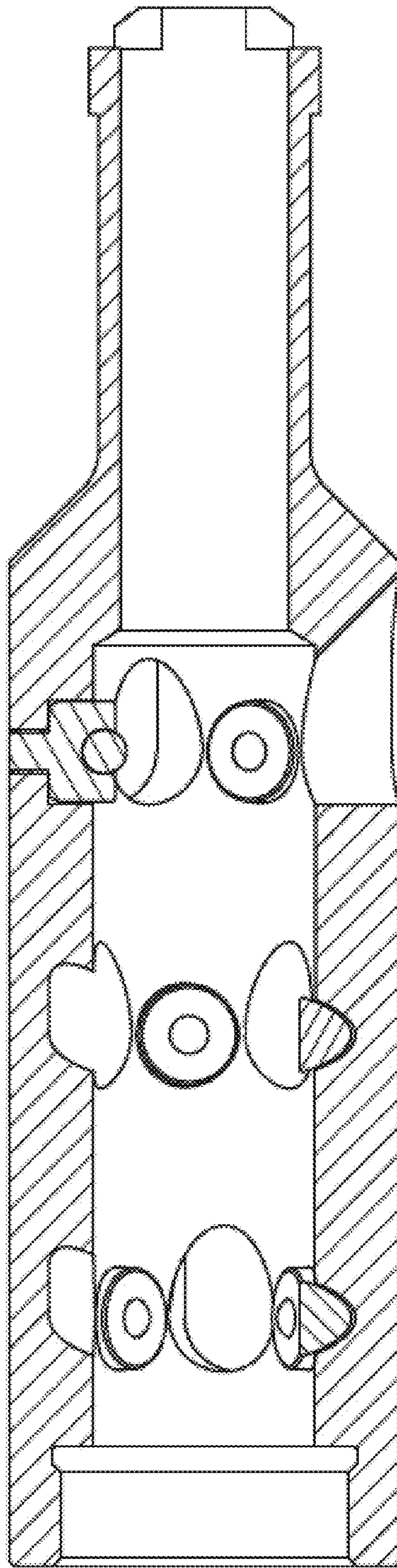

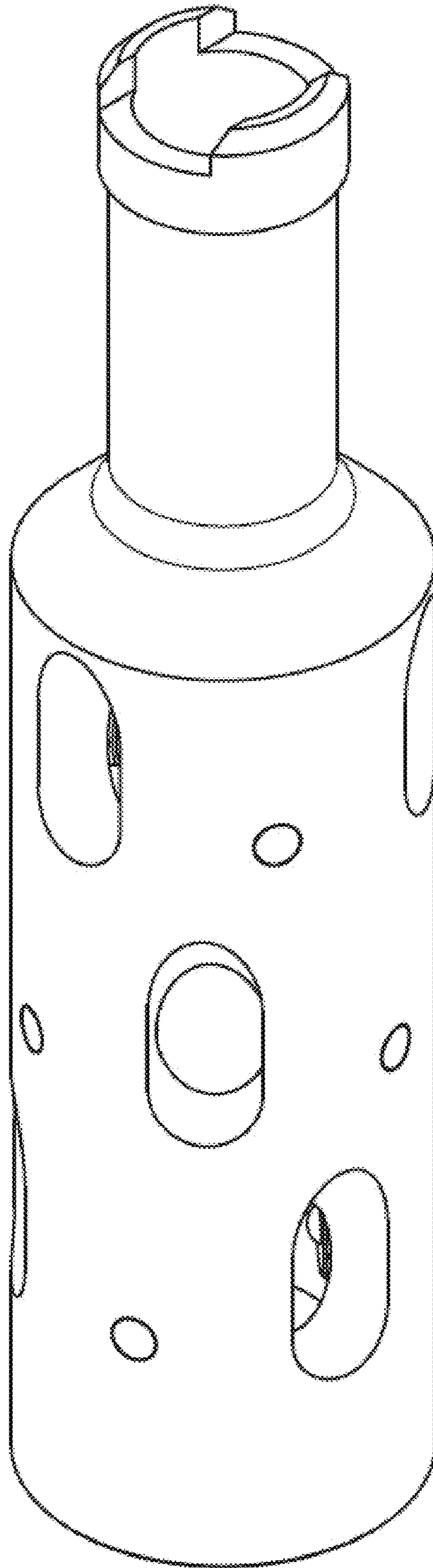

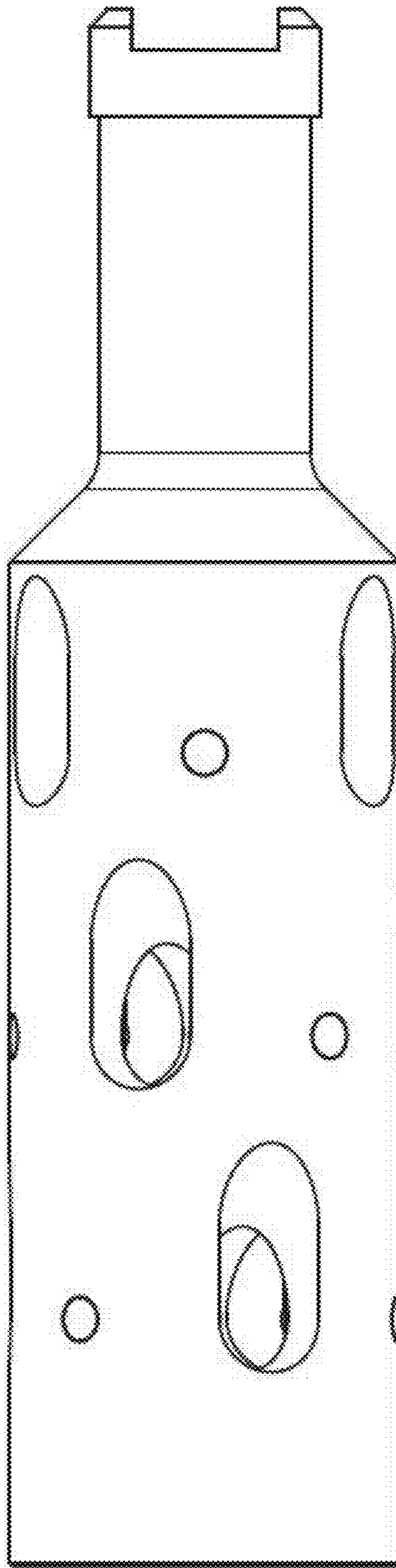

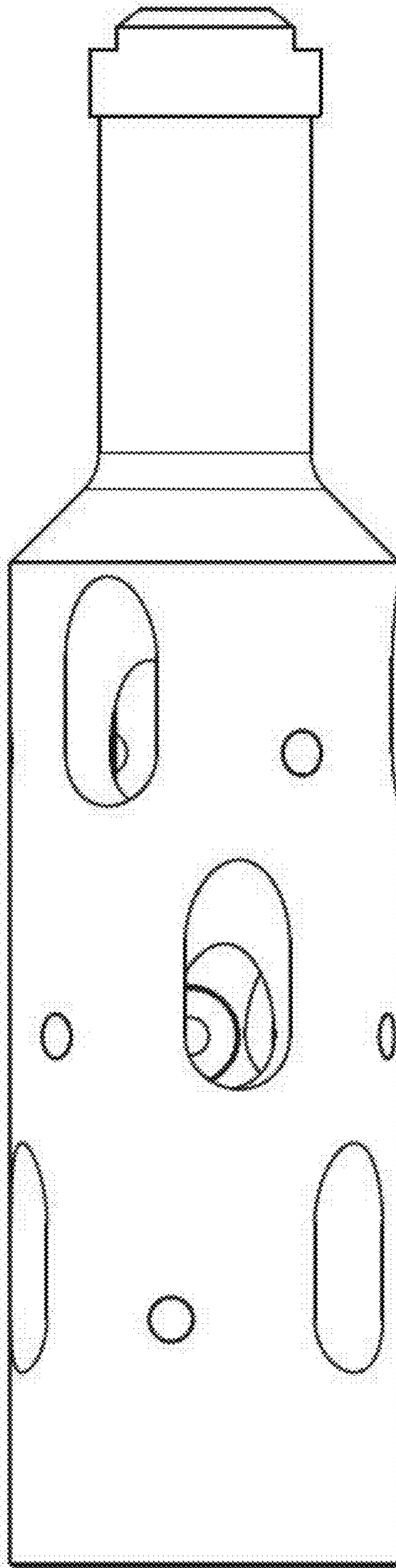
