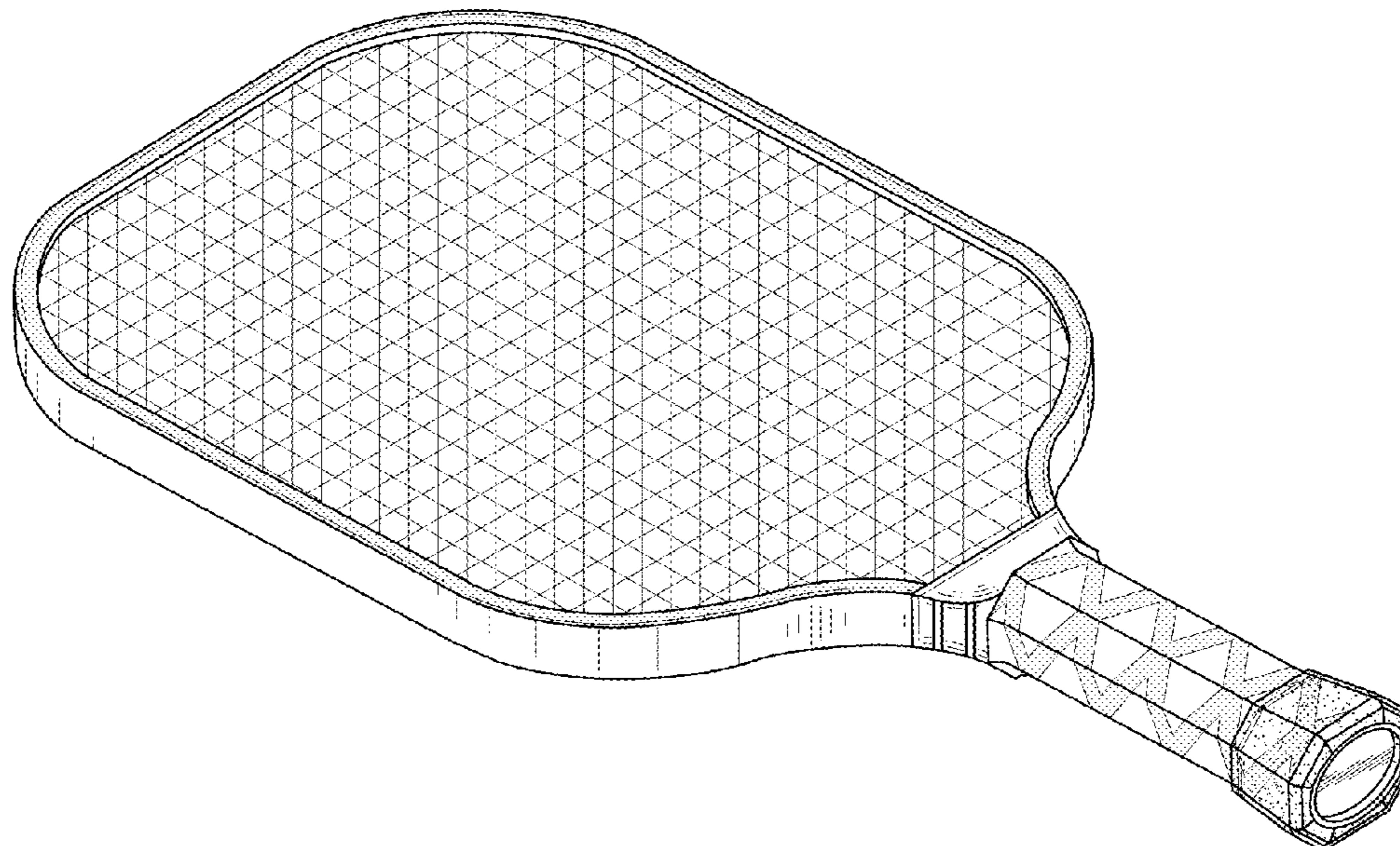
FIG. 1 is a perspective view of a racket showing my new design;

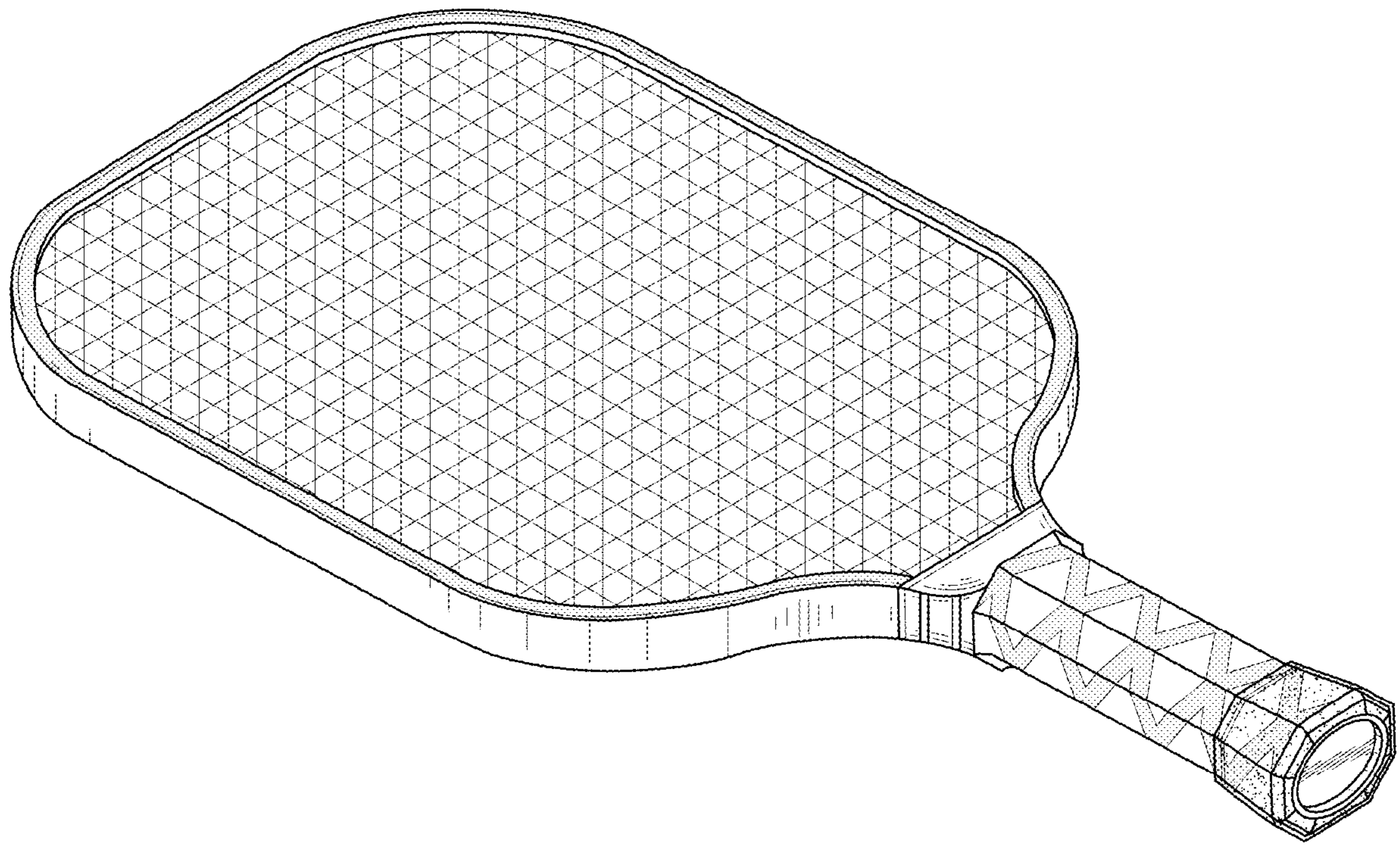

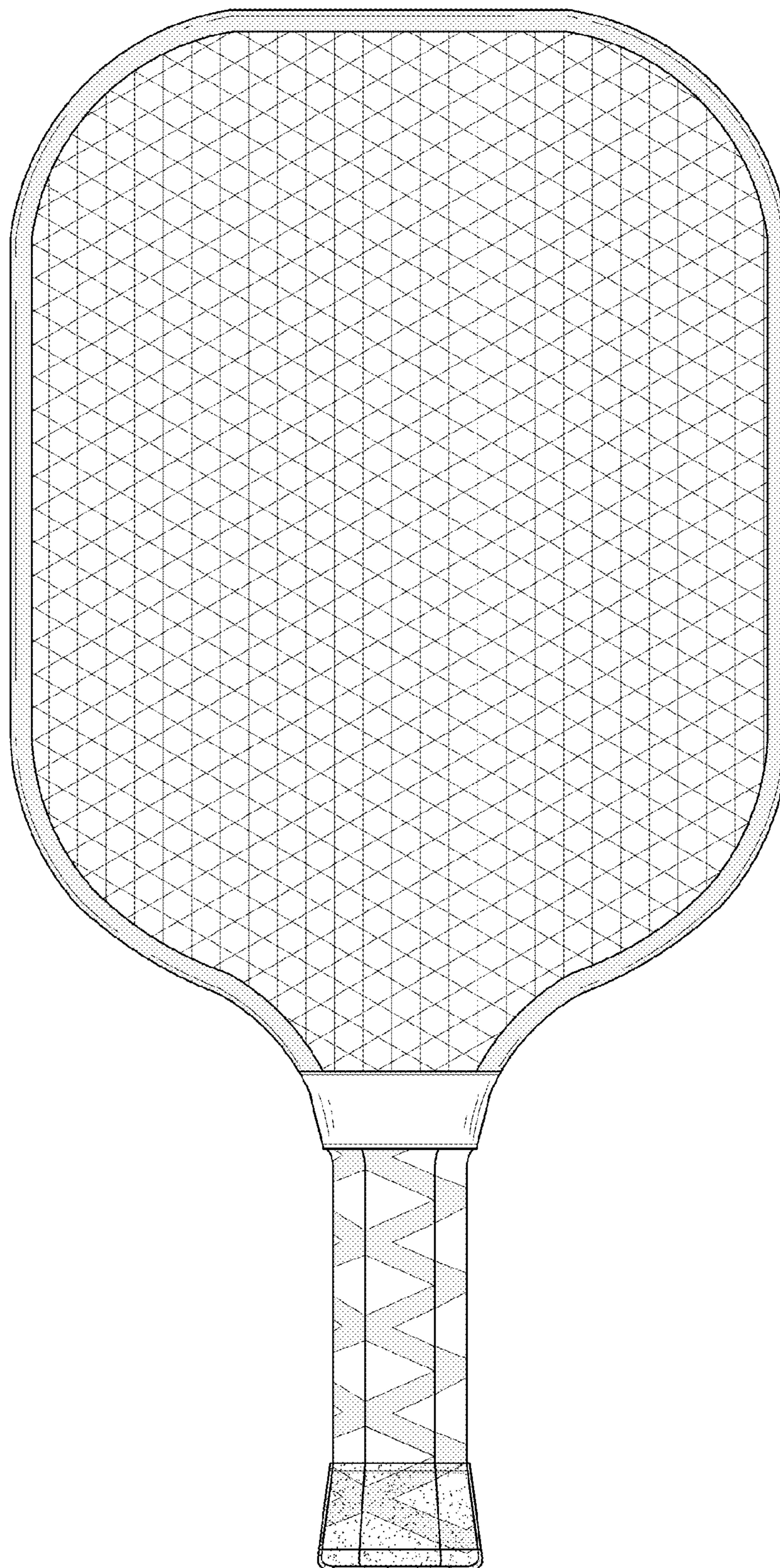

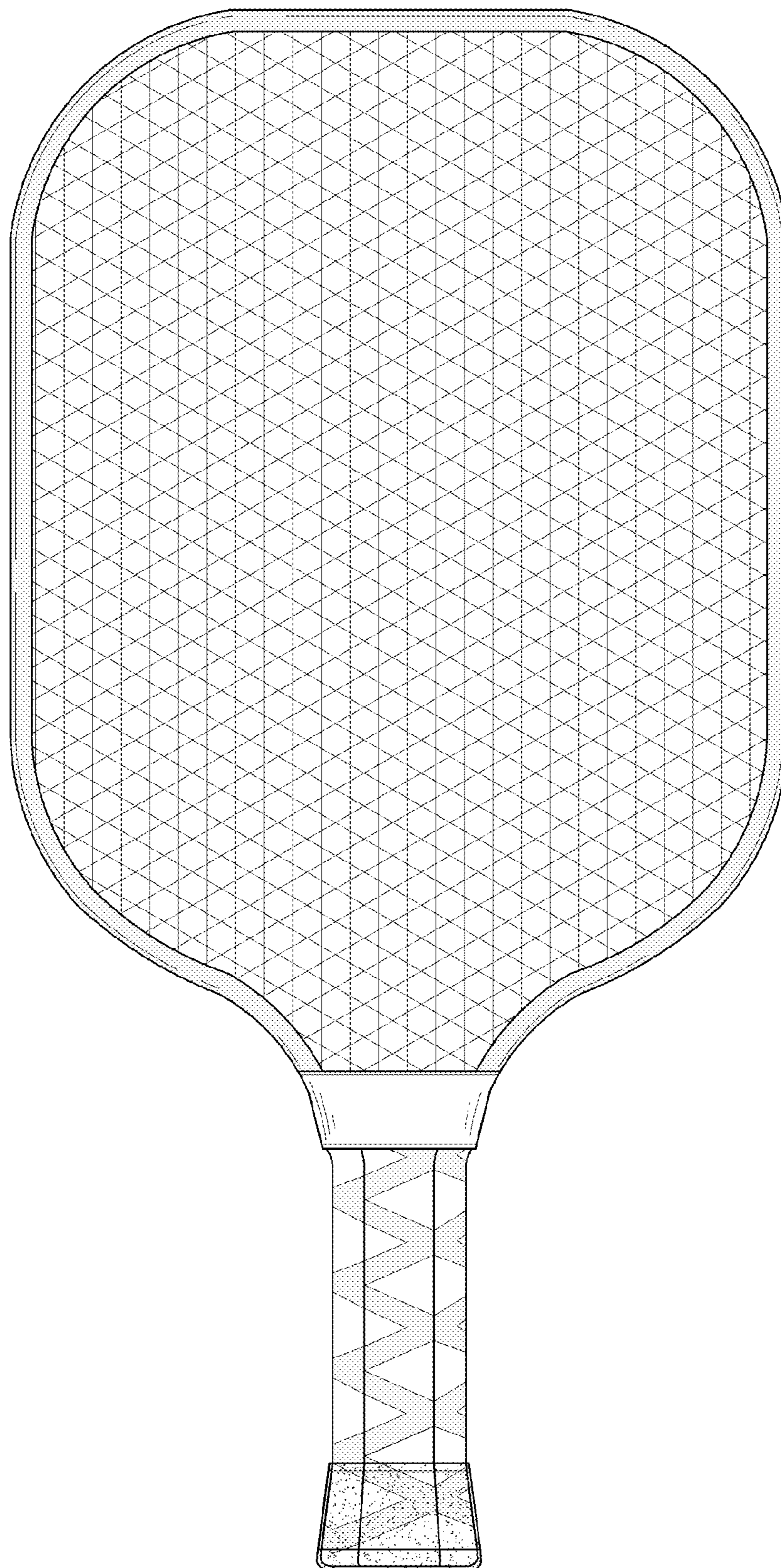

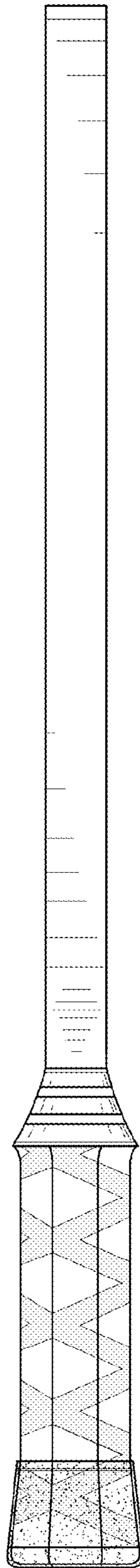

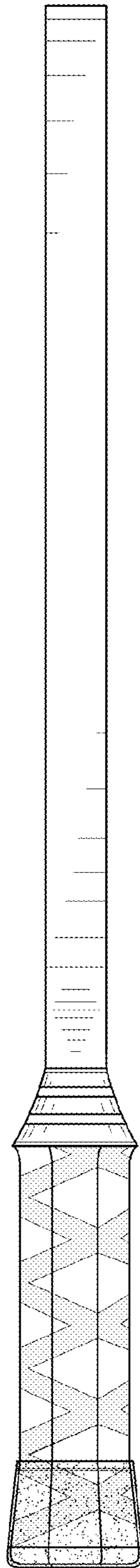

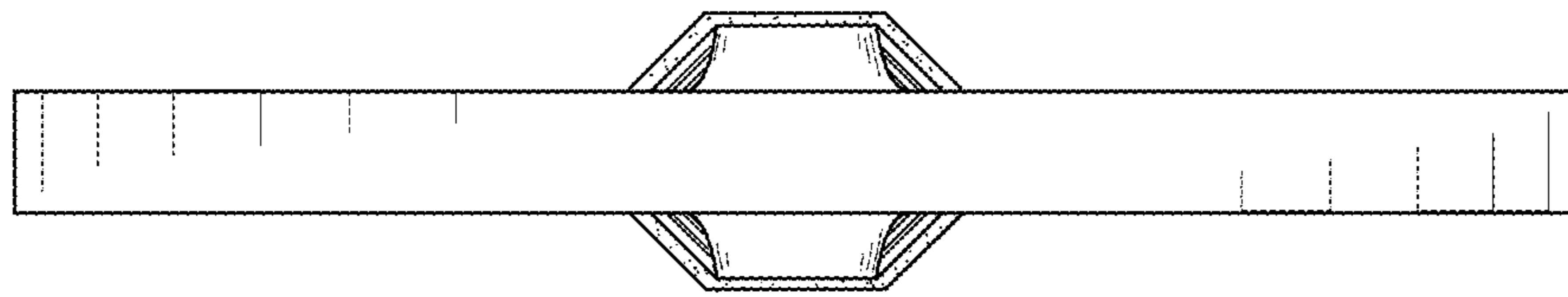

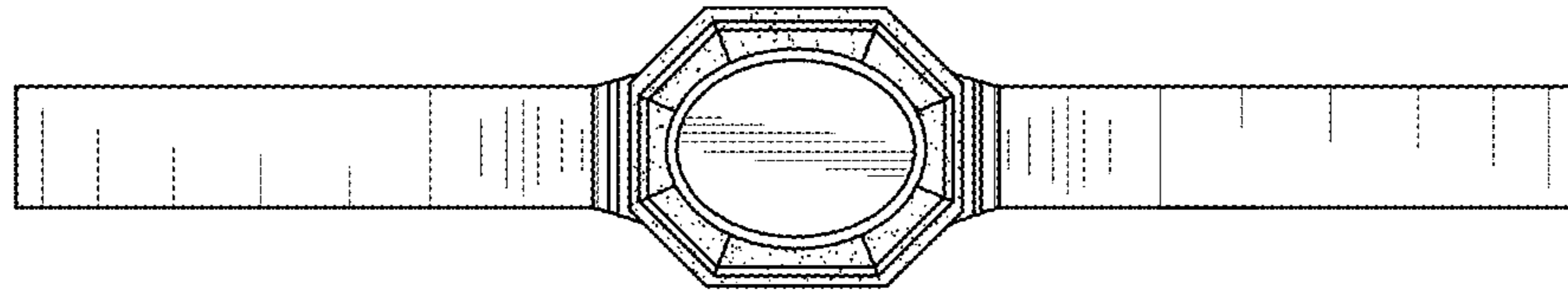
