FIG. 4 is a rear elevation view thereof.

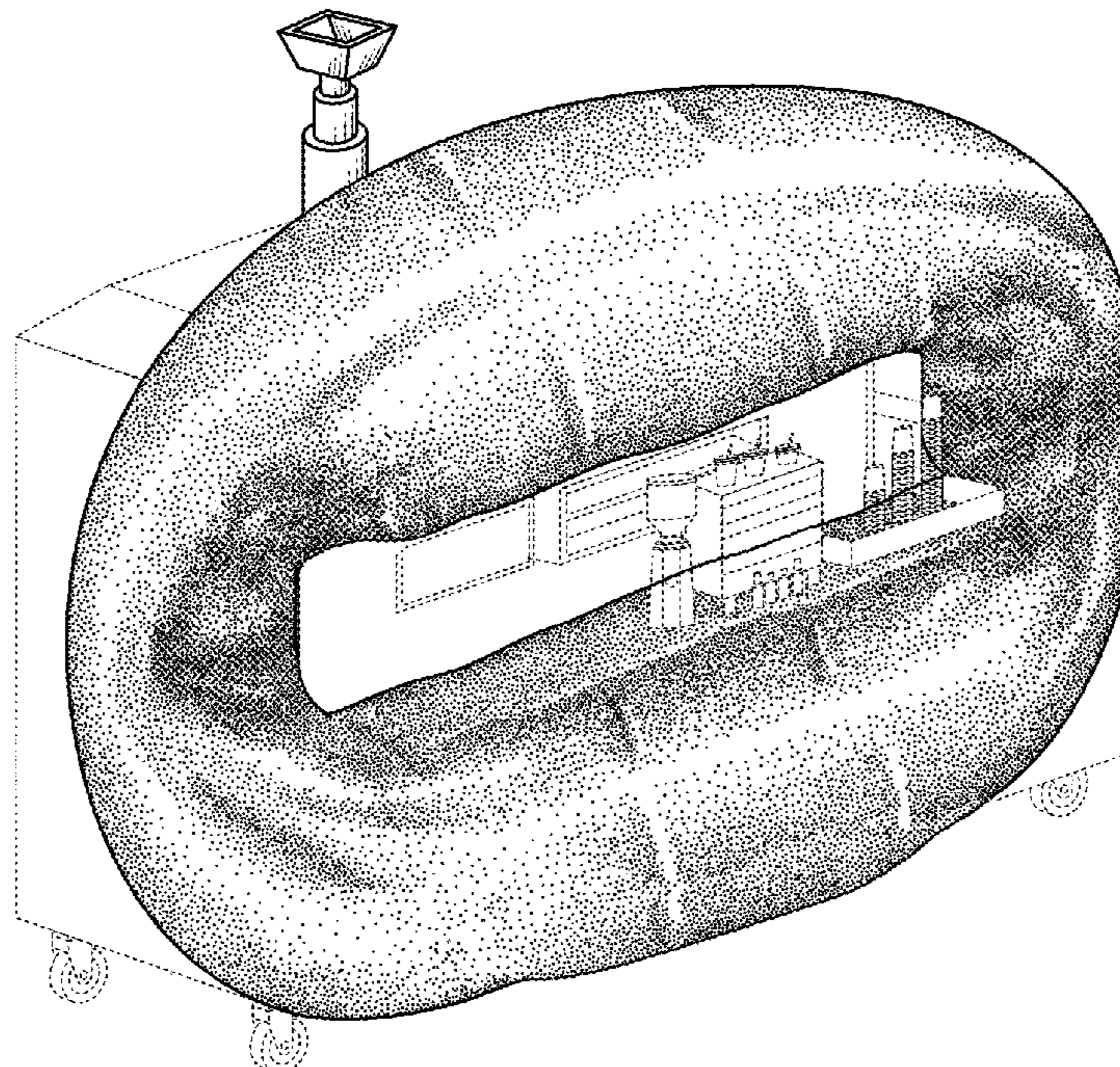
FIG. 5 is a front upper right perspective view thereof; and,

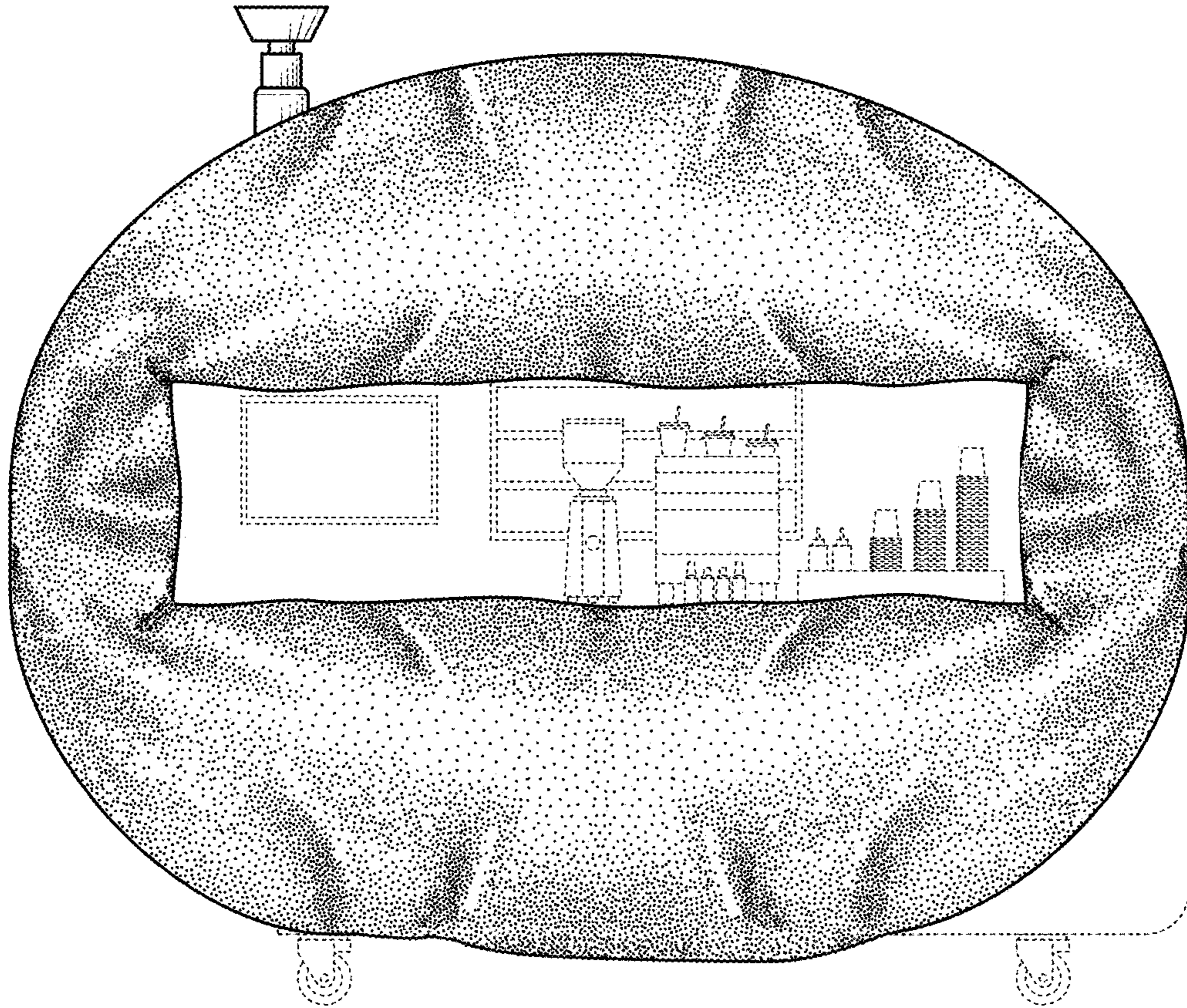

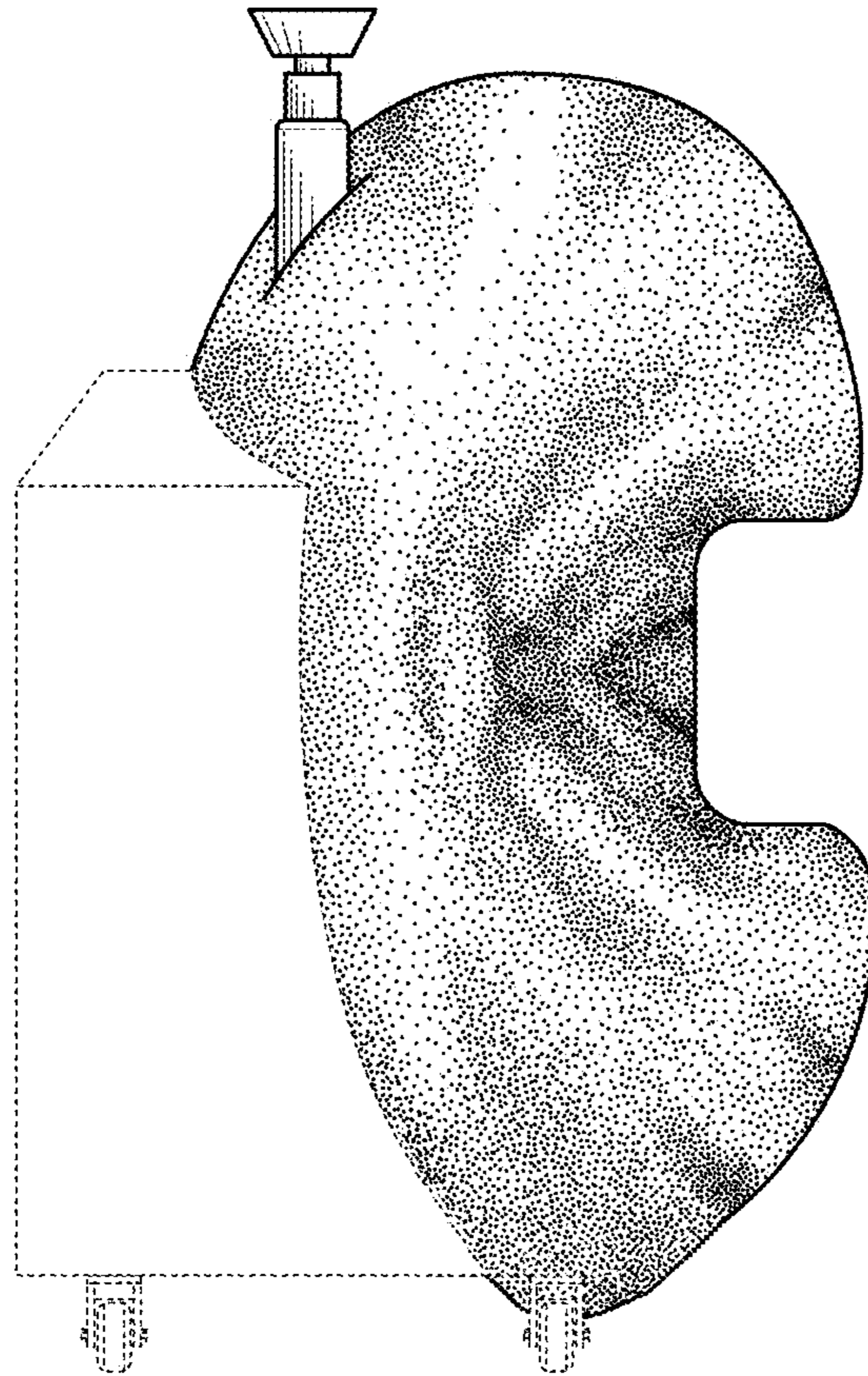

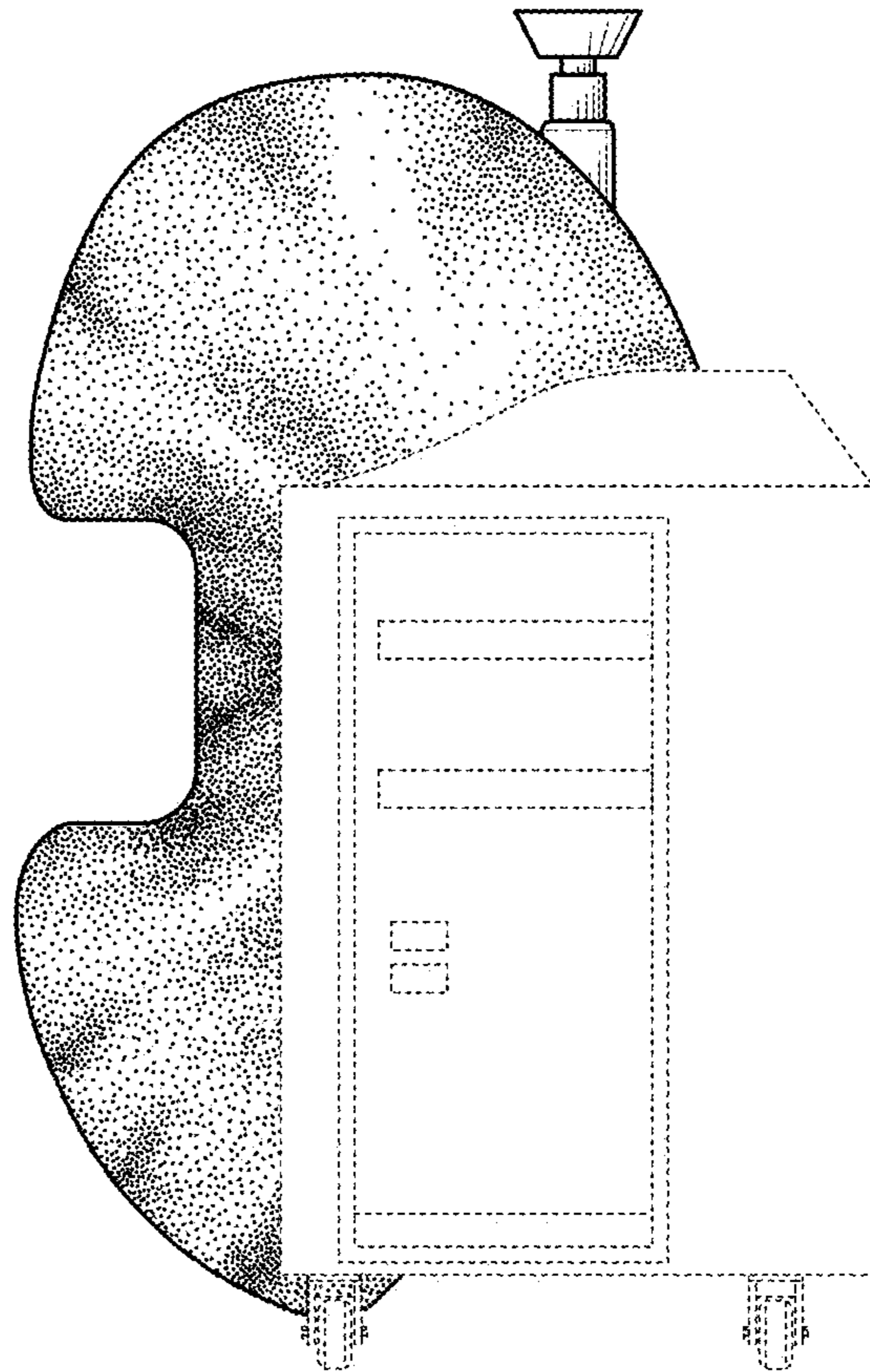

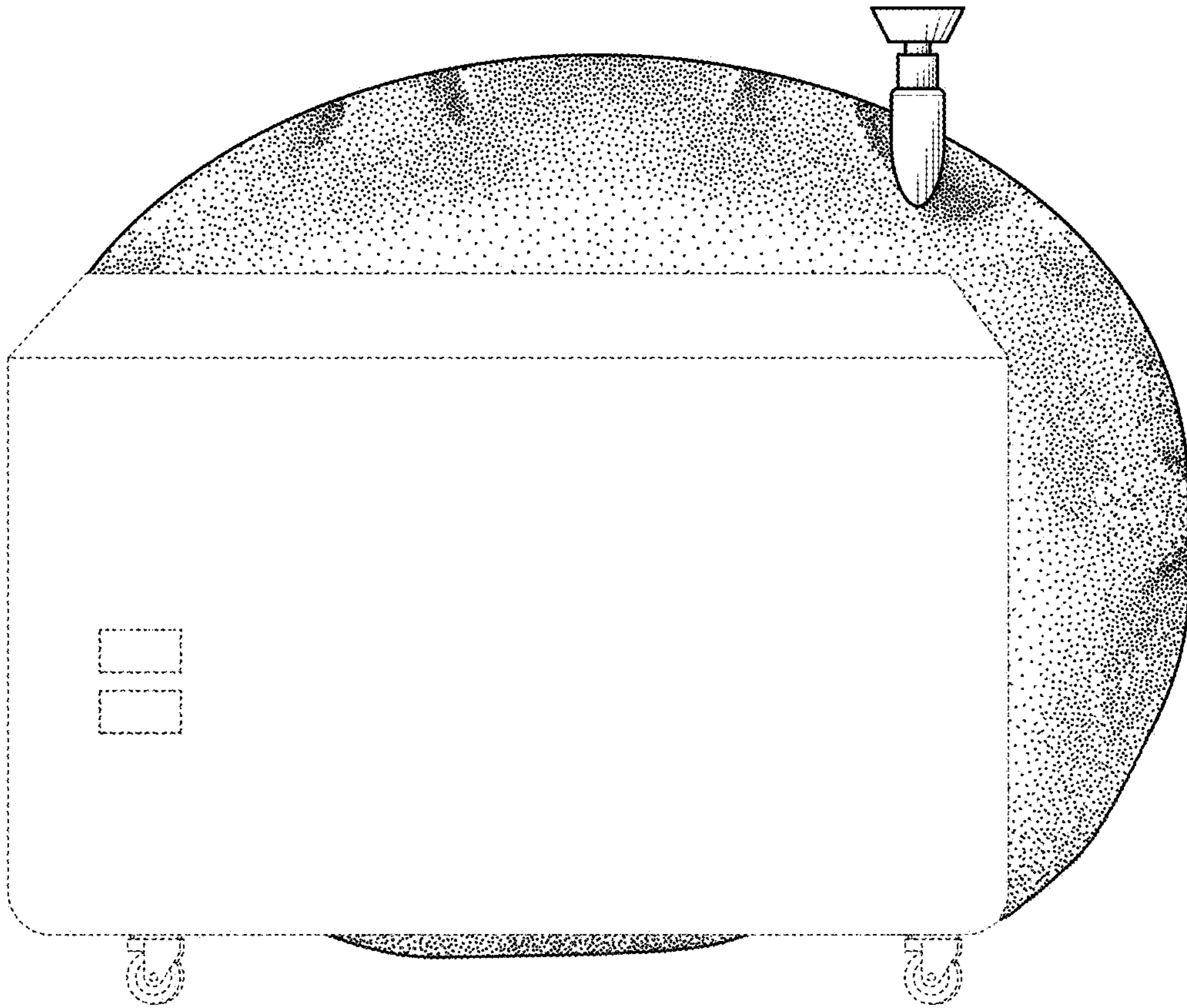

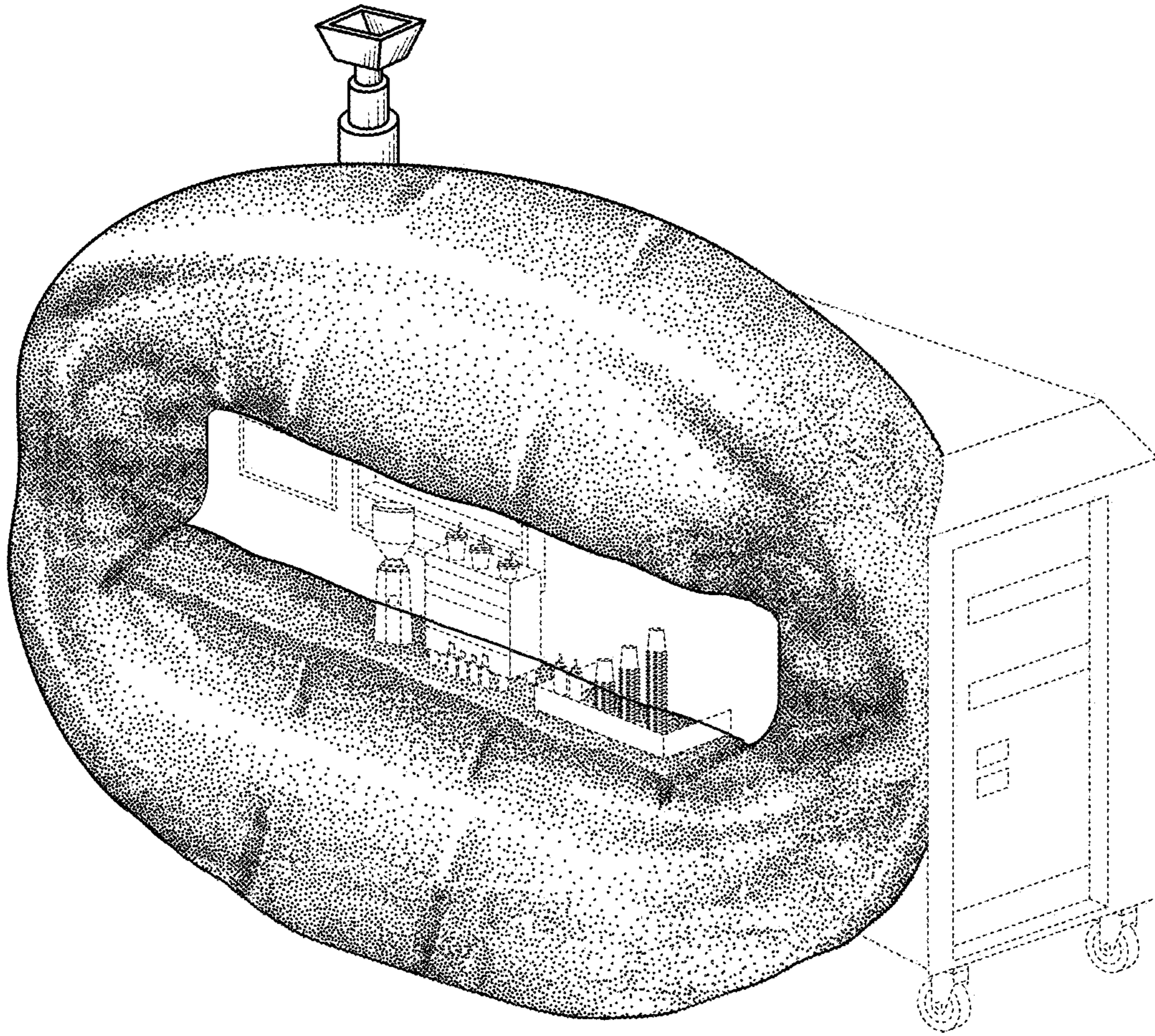

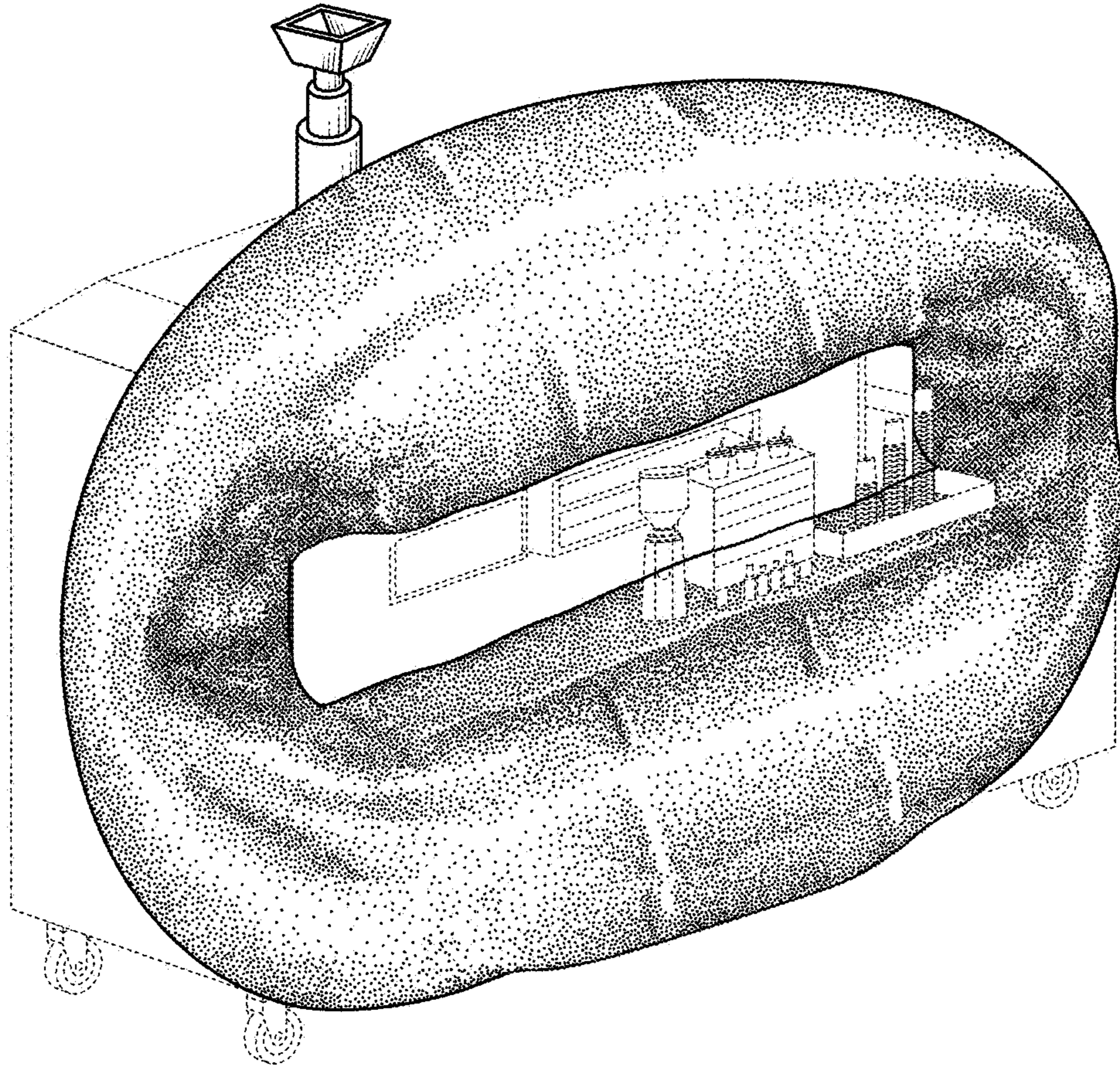
