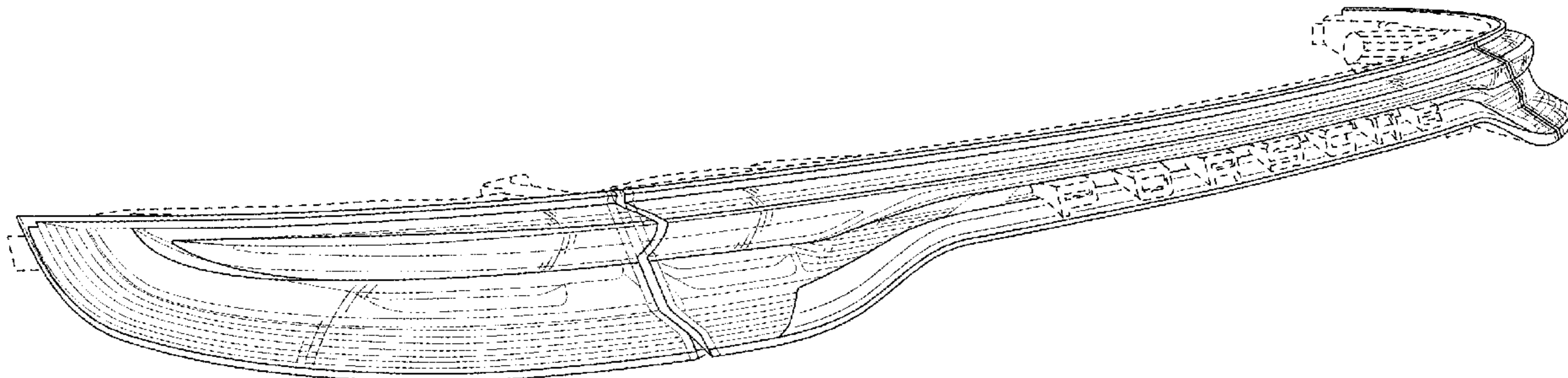
(57) **CLAIM**

The ornamental design for the rear light assembly for a motor vehicle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of rear light assembly for a motor vehicle;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is an elevation view from the left side thereof, the right side being a substantial mirror image thereof; and,  
FIG. 4 is a top plan view thereof.  
The portions of the rear light assembly for a motor vehicle shown in broken lines are for illustrative and environmental purposes and form no part of the claimed design.

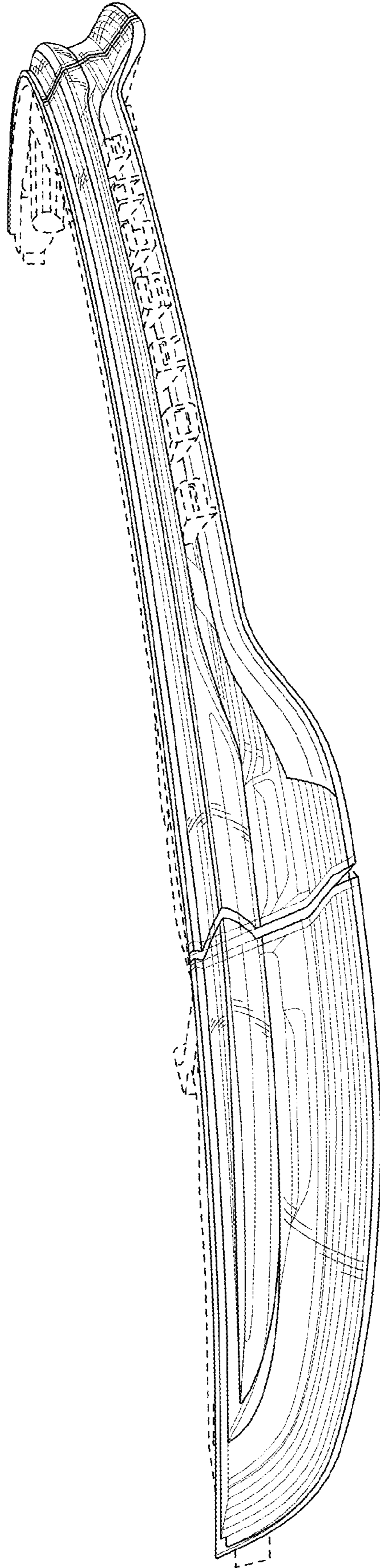

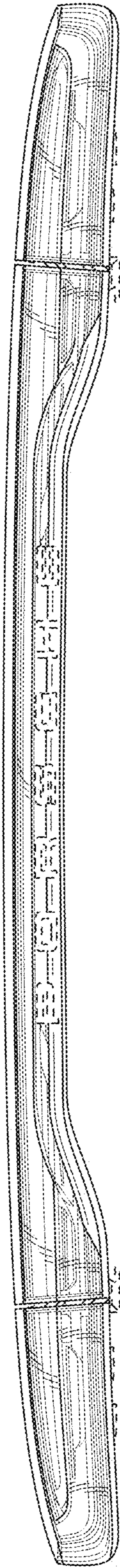

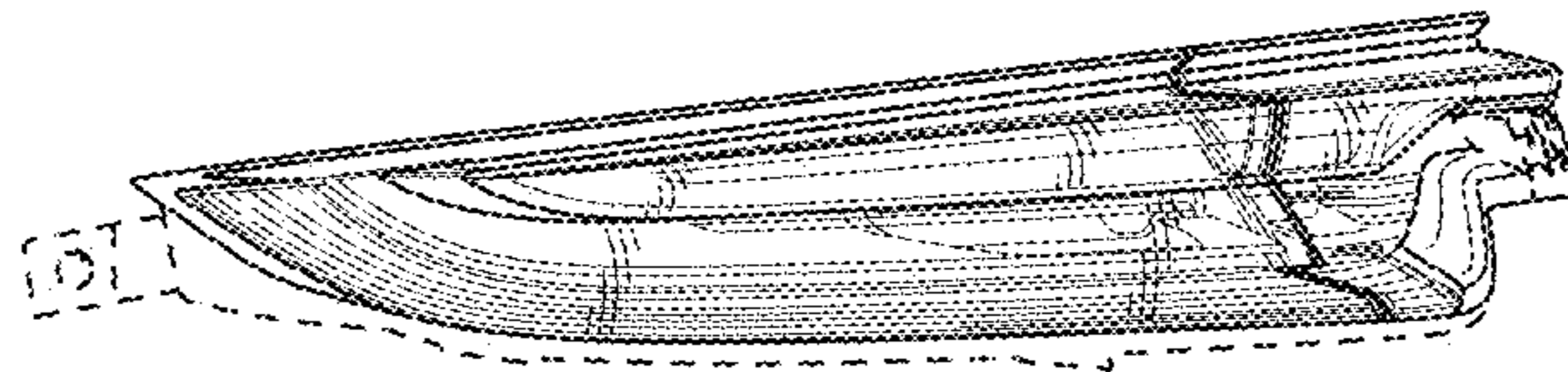
