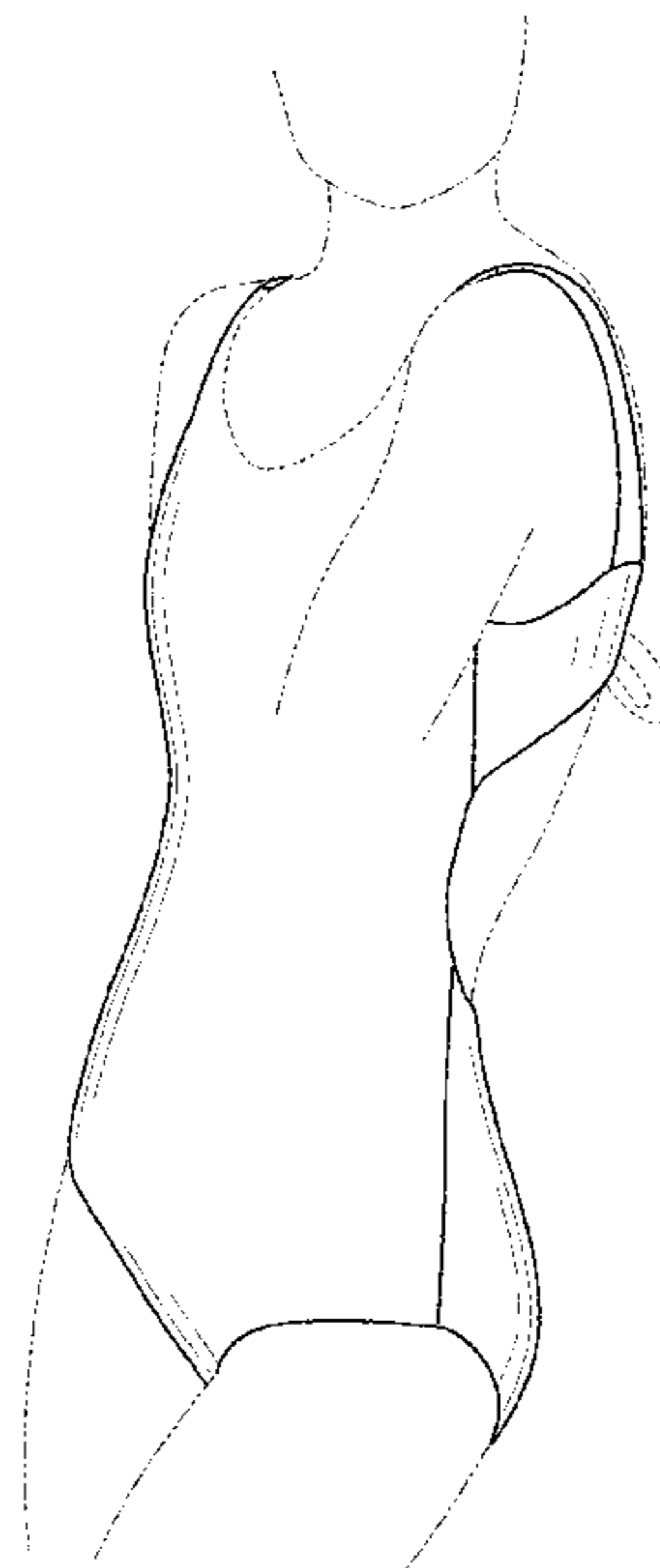
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of swimwear, showing my new design;
FIG. 2 is a front side view thereof;
FIG. 3 is a back side view thereof;
FIG. 4 is a left side view thereof; and,
FIG. 5 is a right side view thereof.
The broken lines shown in the drawings depicting the outline of a human body illustrate the unclaimed environment in which the swimwear is used. The remaining broken lines illustrate portions of the article that are not claimed. None of the broken lines form part of the claimed design.

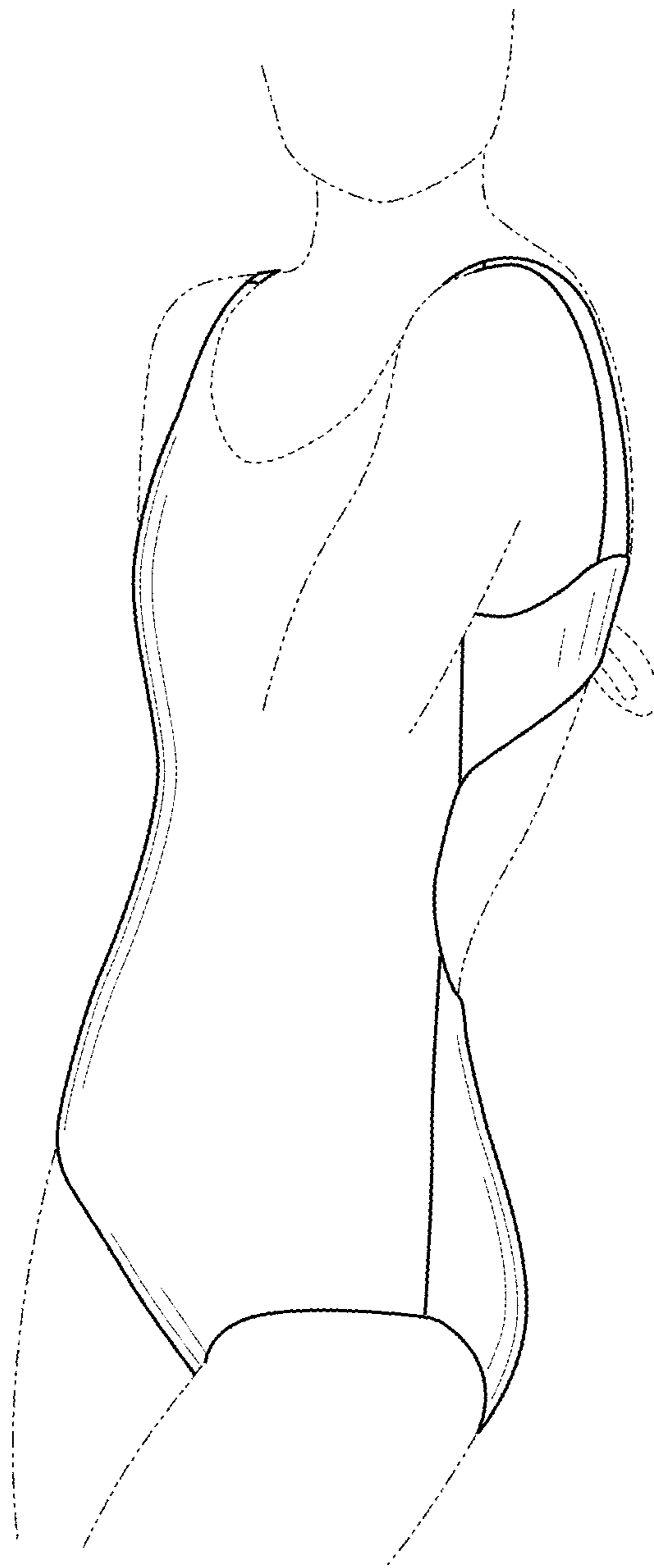

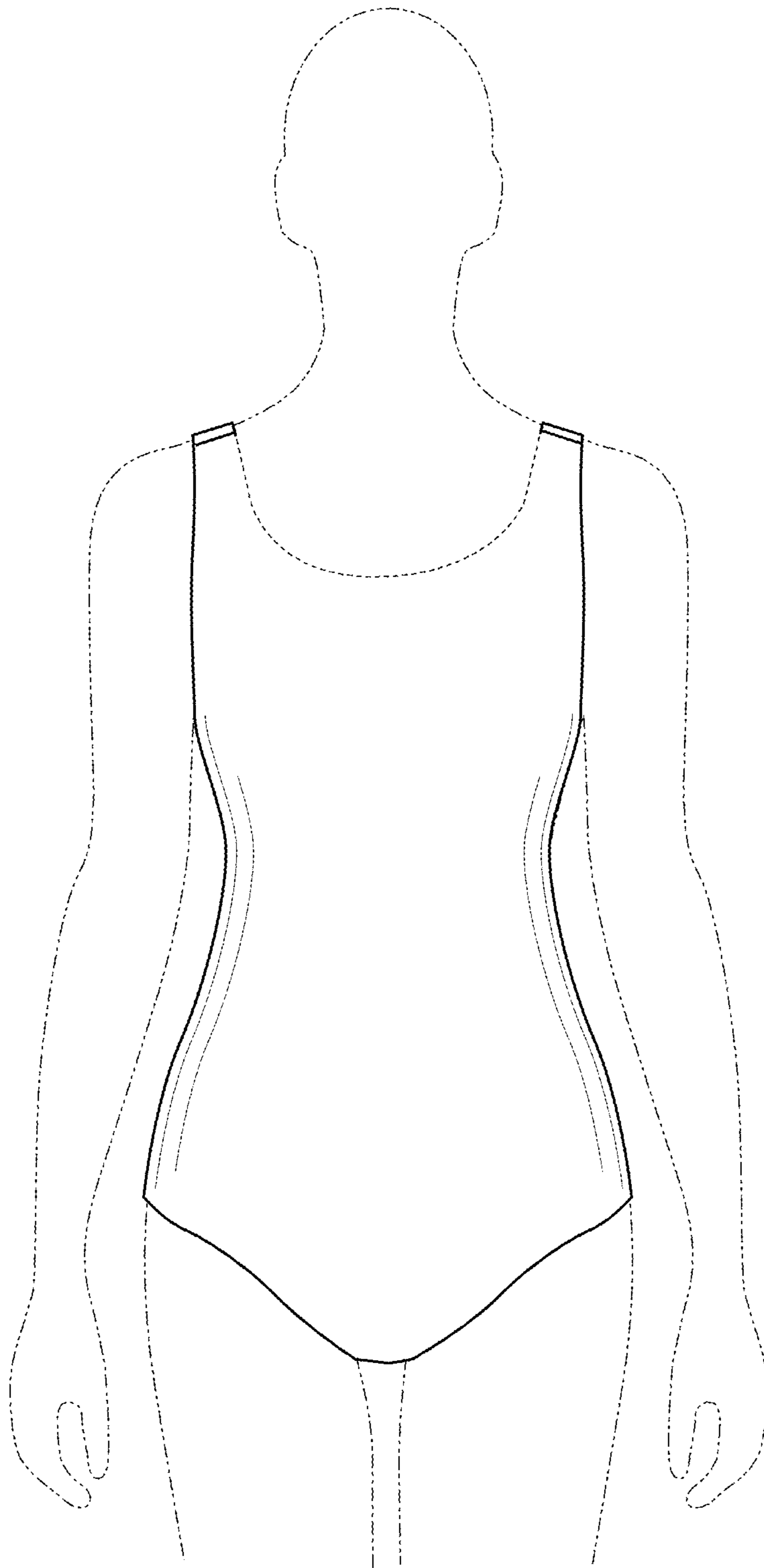

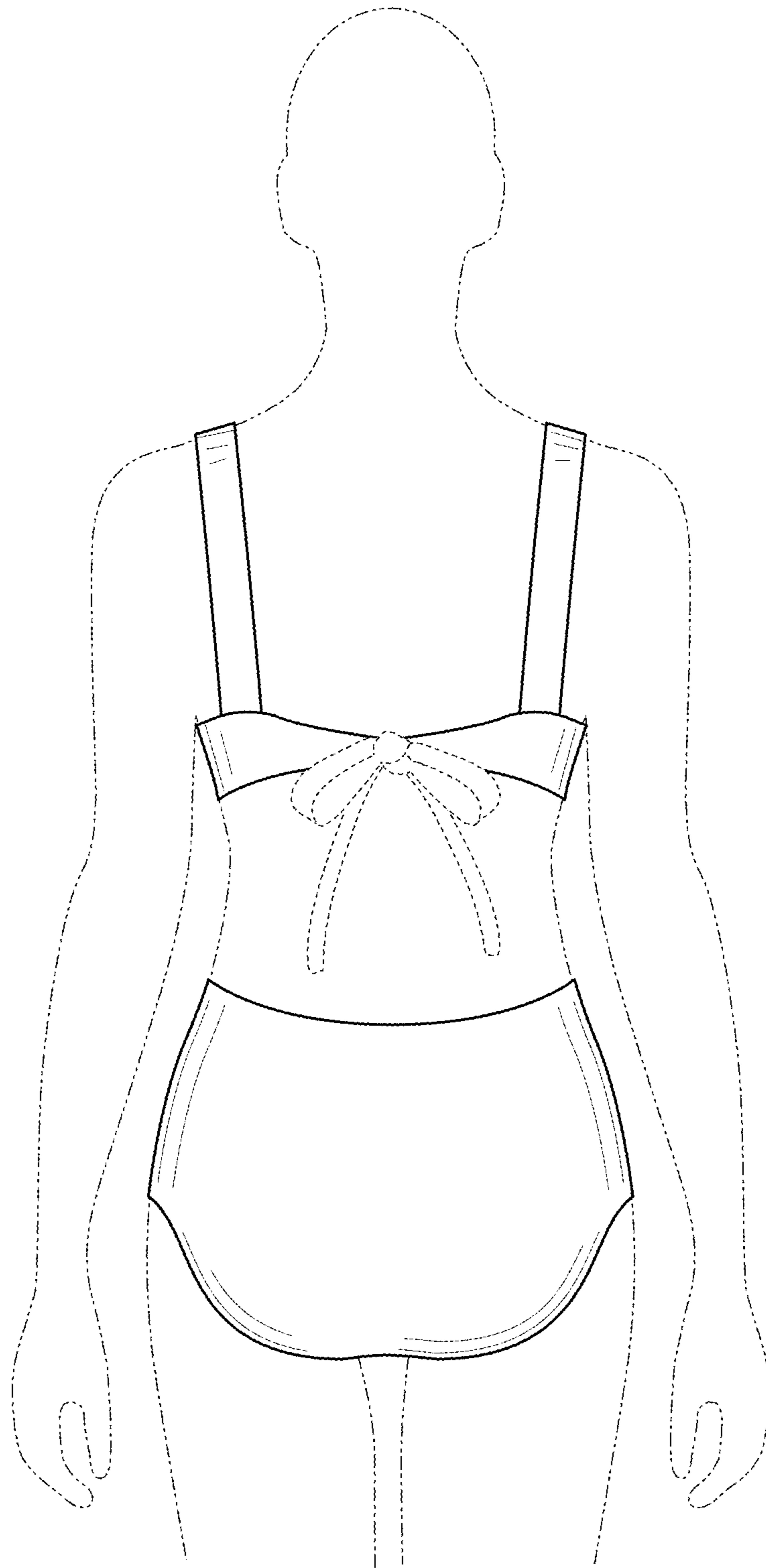

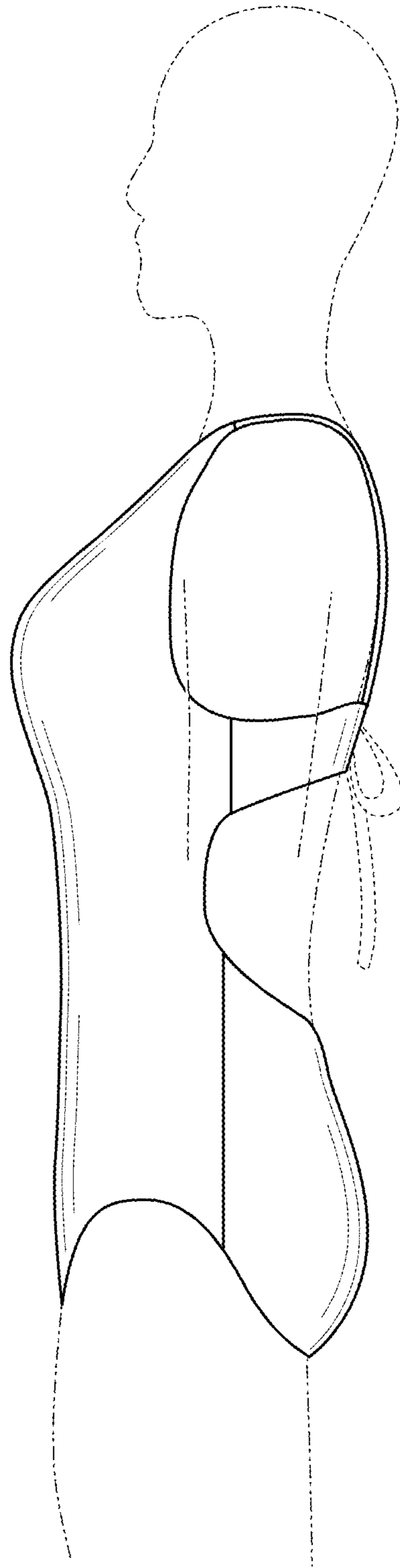

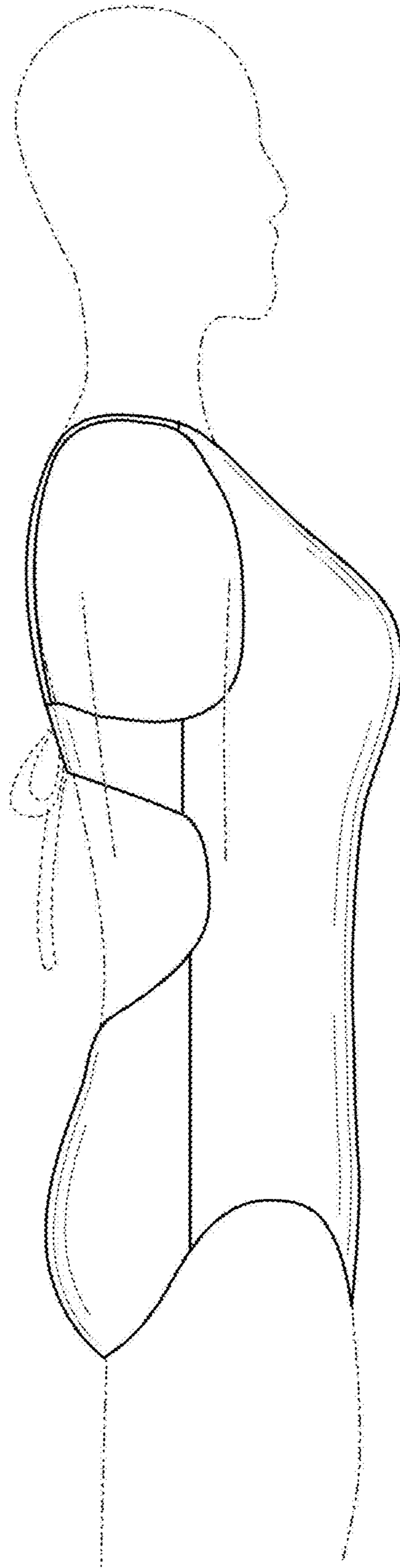
