(57) **CLAIM**

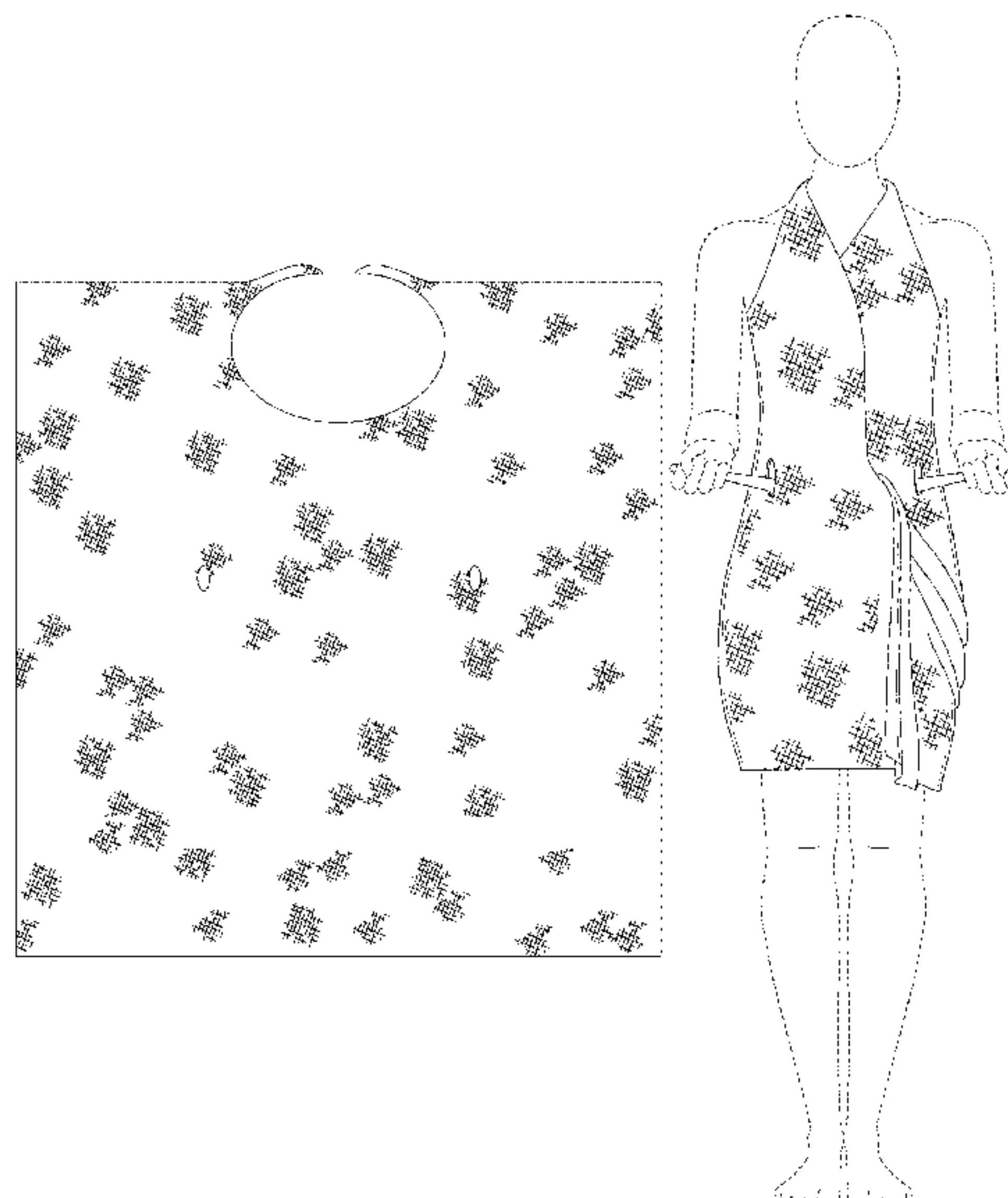
The ornamental design for a clothing wrap, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a clothing wrap, showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side elevational view thereof
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 shows the clothing wrap being worn by a person in a first configuration; and,
FIG. 8 shows the clothing wrap being worn by a person in a second configuration.
The broken lines shown in the drawings illustrate environment of the clothing wrap that forms no part of the claimed design.

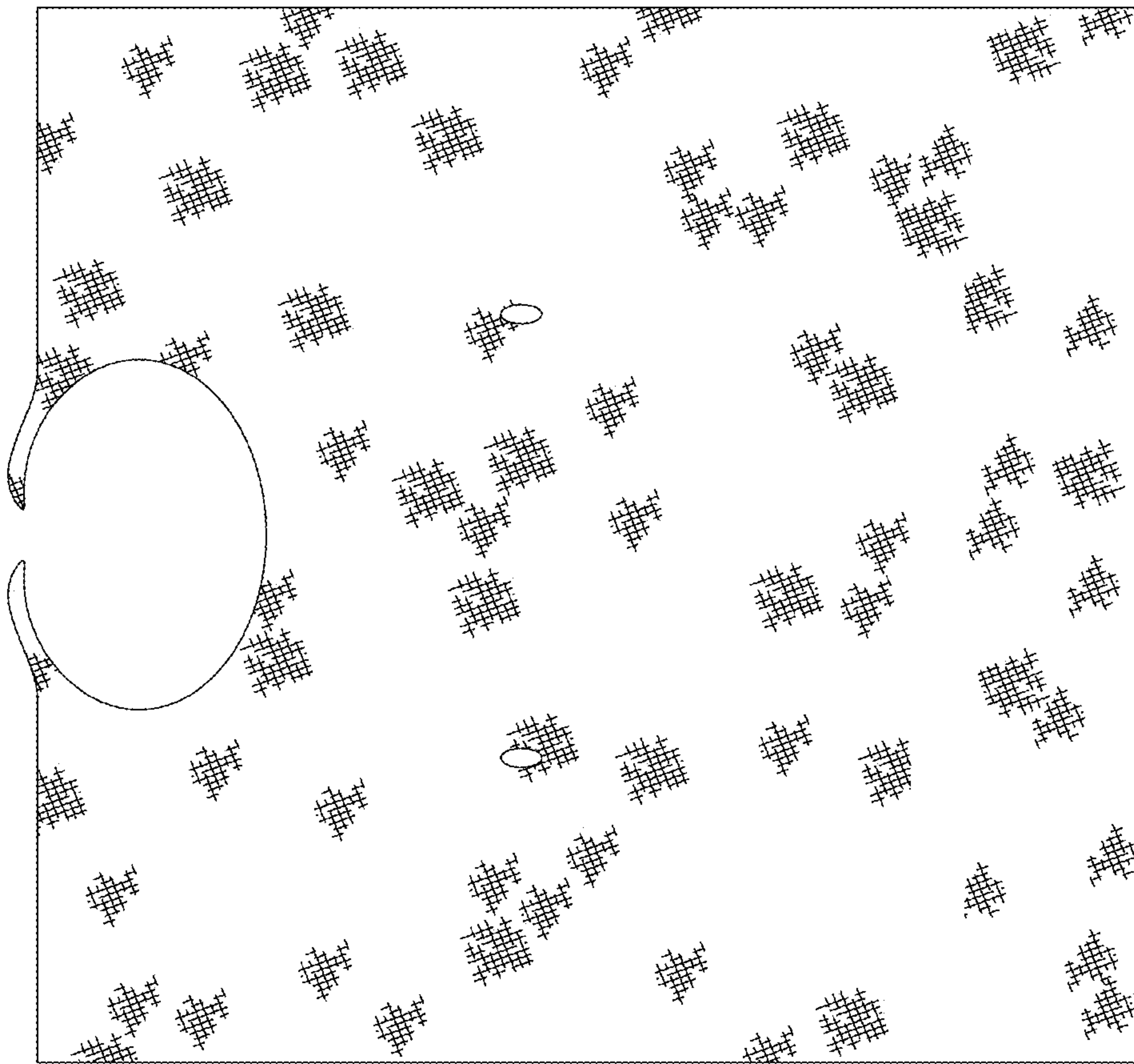

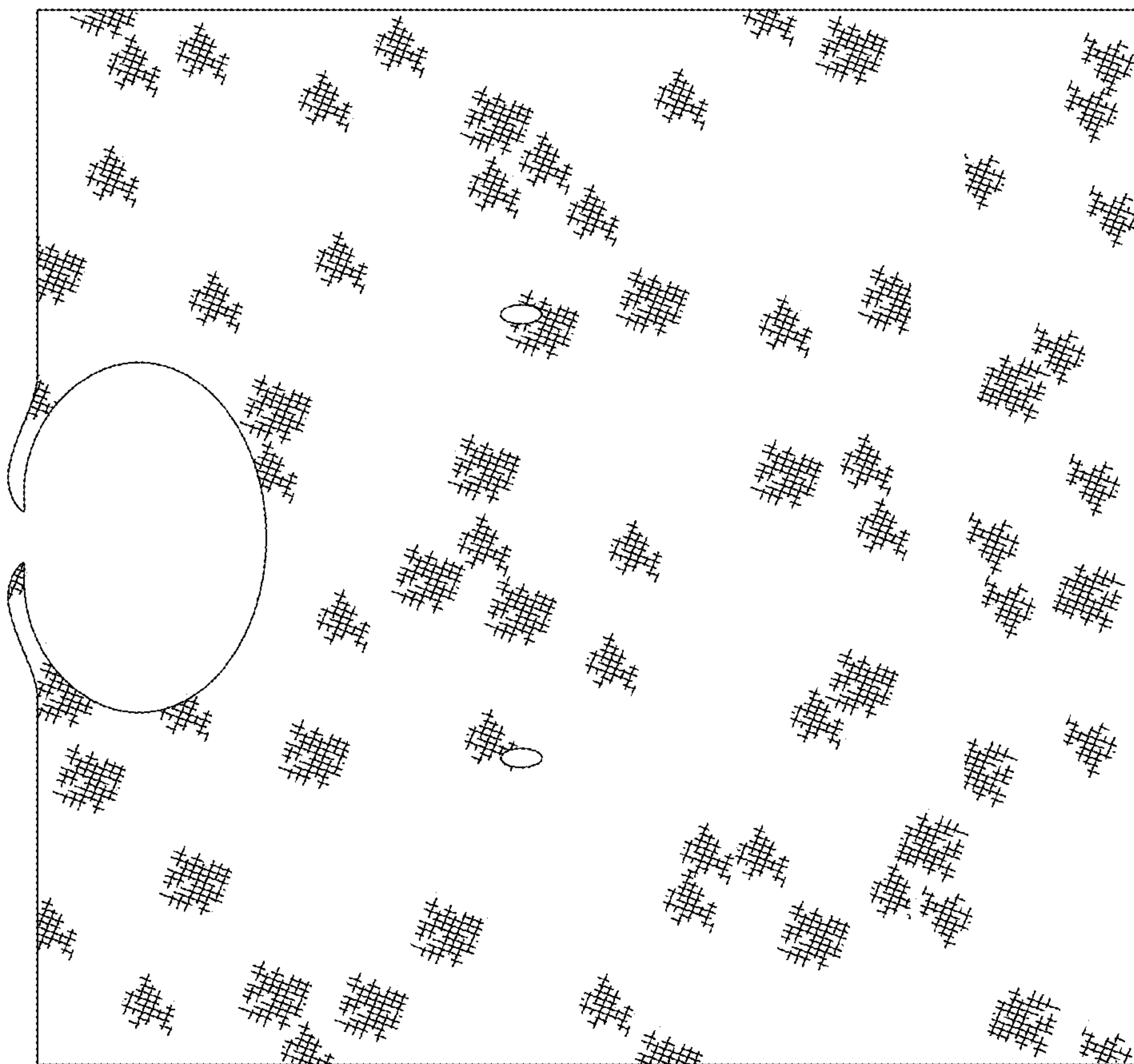

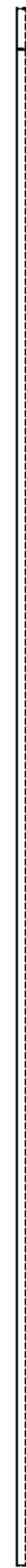

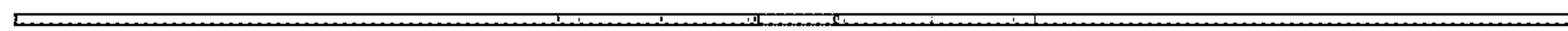

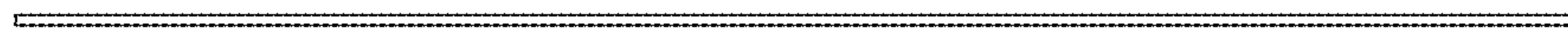

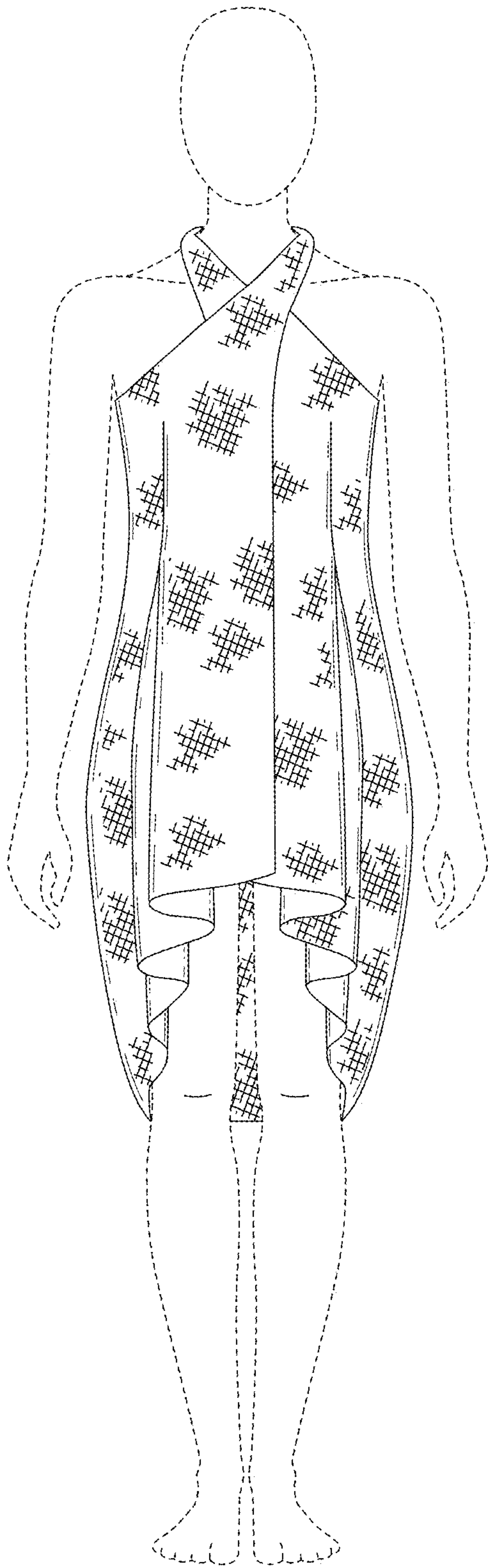

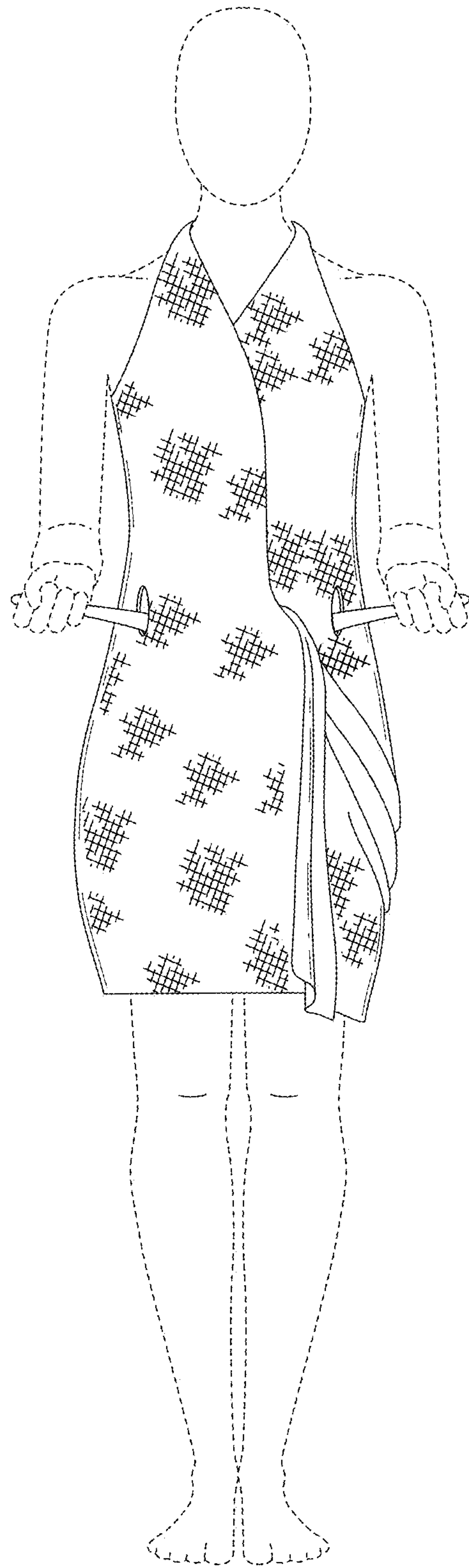
