(57) **CLAIM**

The ornamental design for a workout top with non-slip hand portions, as shown and described.

DESCRIPTION

FIG. 1 is a front view of my new workout top with non-slip hand portions design;
FIG. 2 is a rear view thereof;
FIG. 3 is a side view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof; and,
FIG. 6 is an enlarged detail view of the sleeve of my workout top with non-slip hand portions as shown in use.
The dash-dot-dash line depicts a cut line for the purpose of defining the extent of the enlarged detail view of the workout top with non-slip hand portions in FIG. 6 and forms no part of the claimed design. The human fingers outlined by evenly dashed broken lines in FIG. 6 assist to illustrate the workout top with non-slip hand portions in a position of use and forms no part of the claimed design.

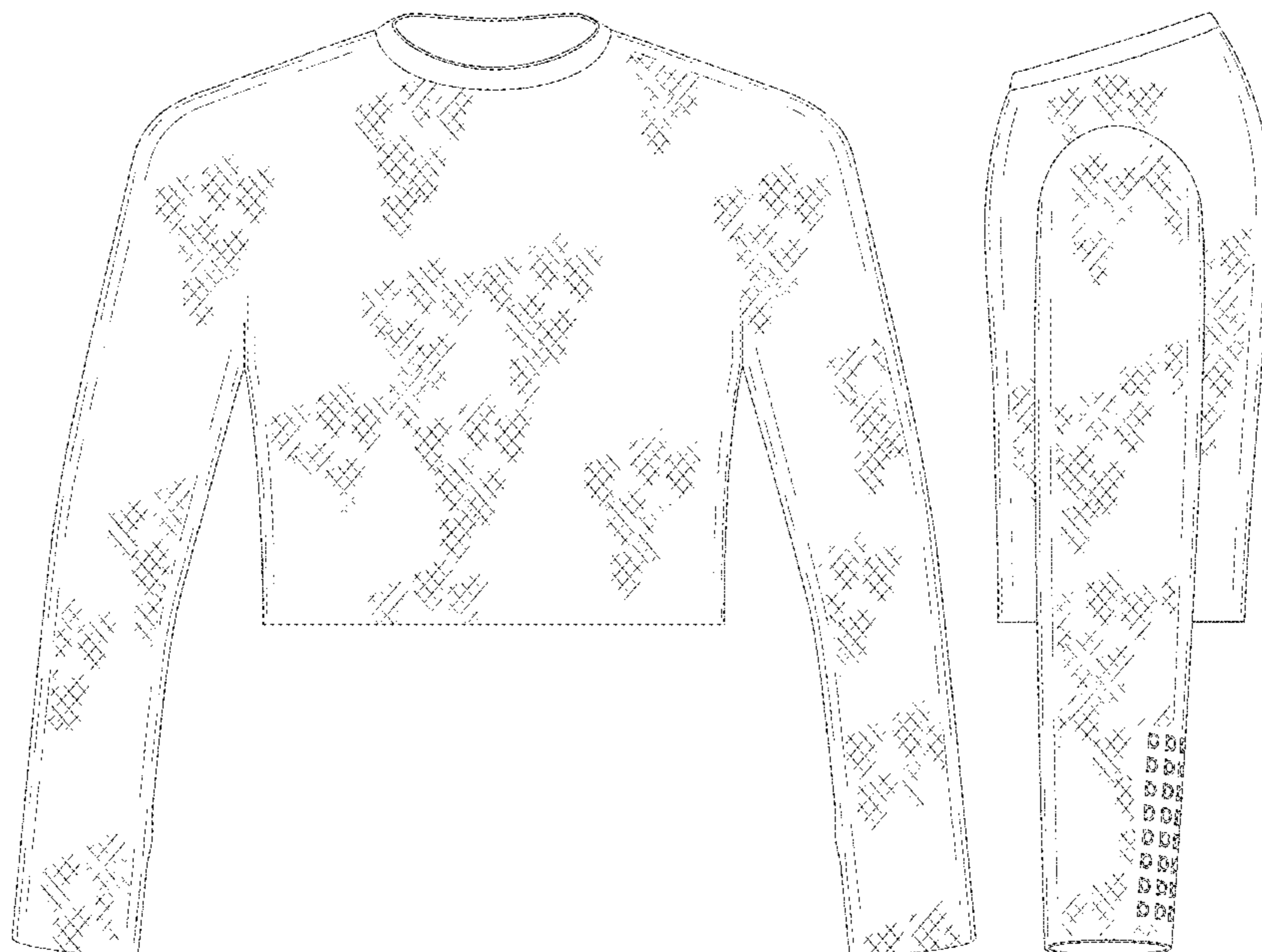

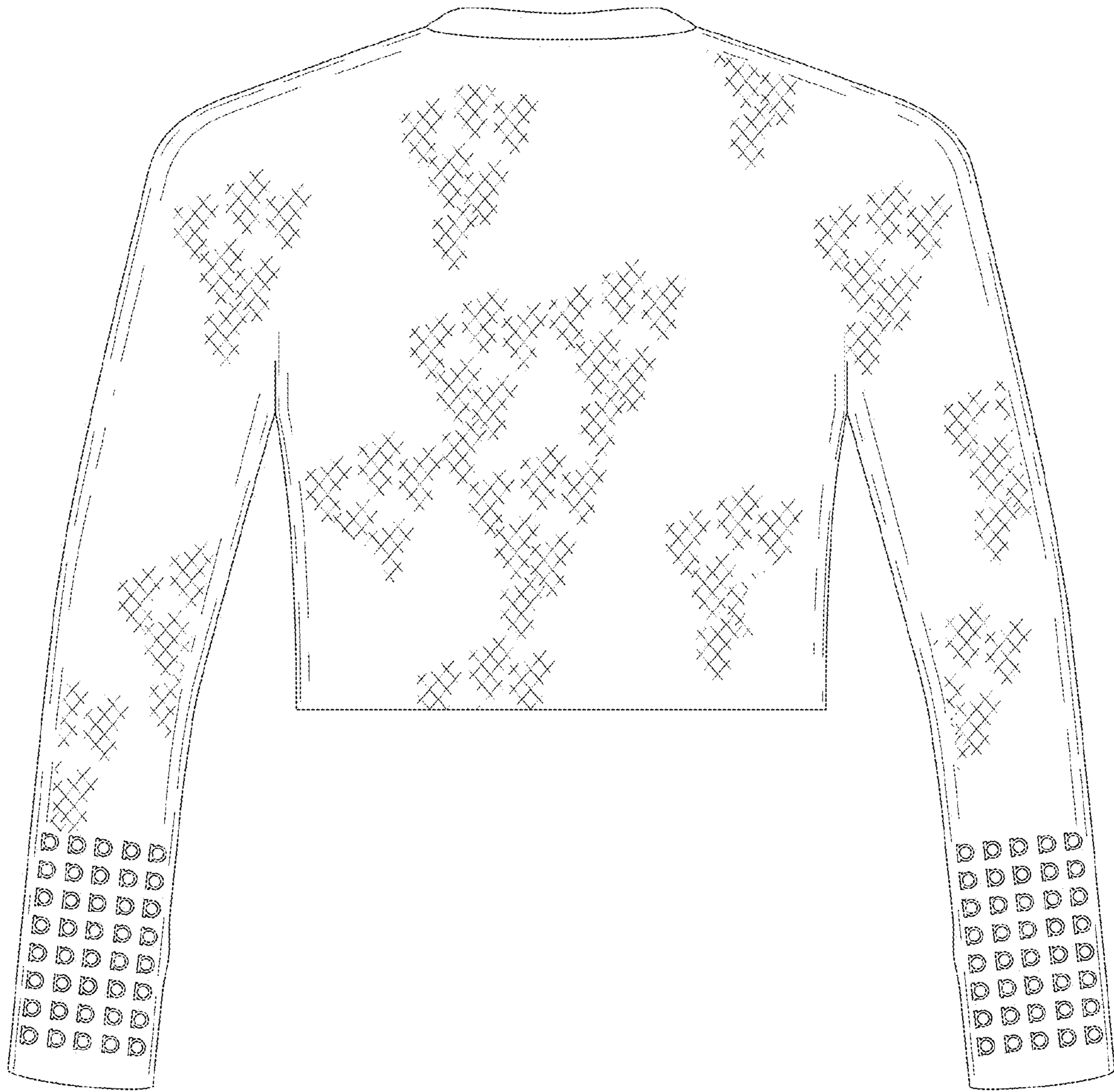

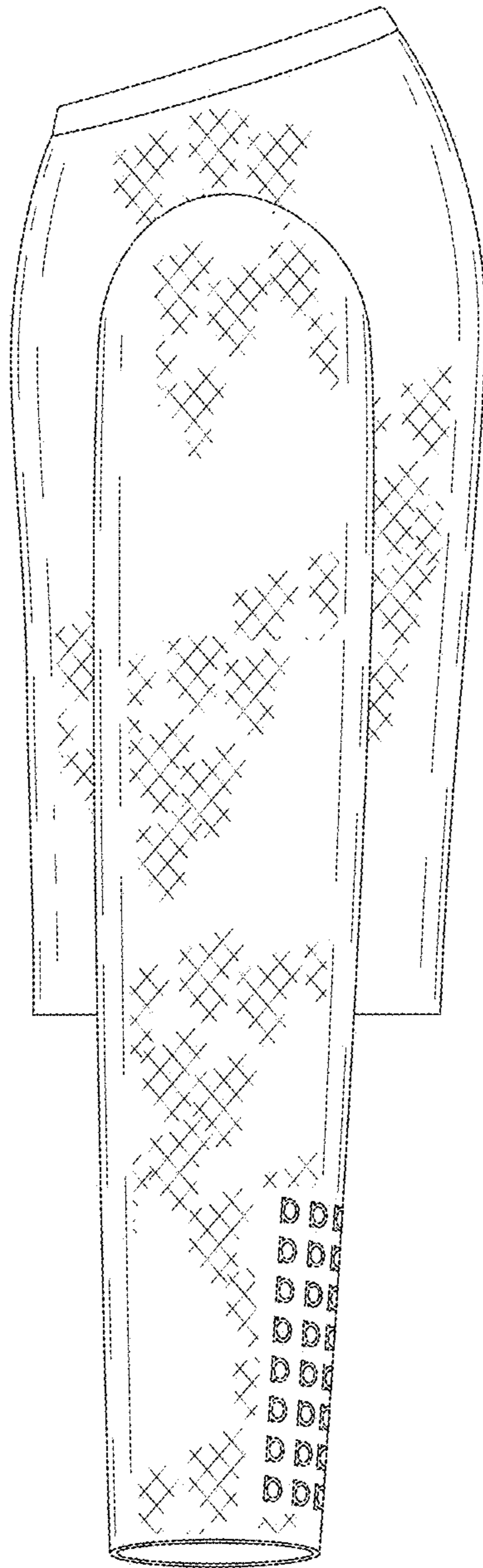

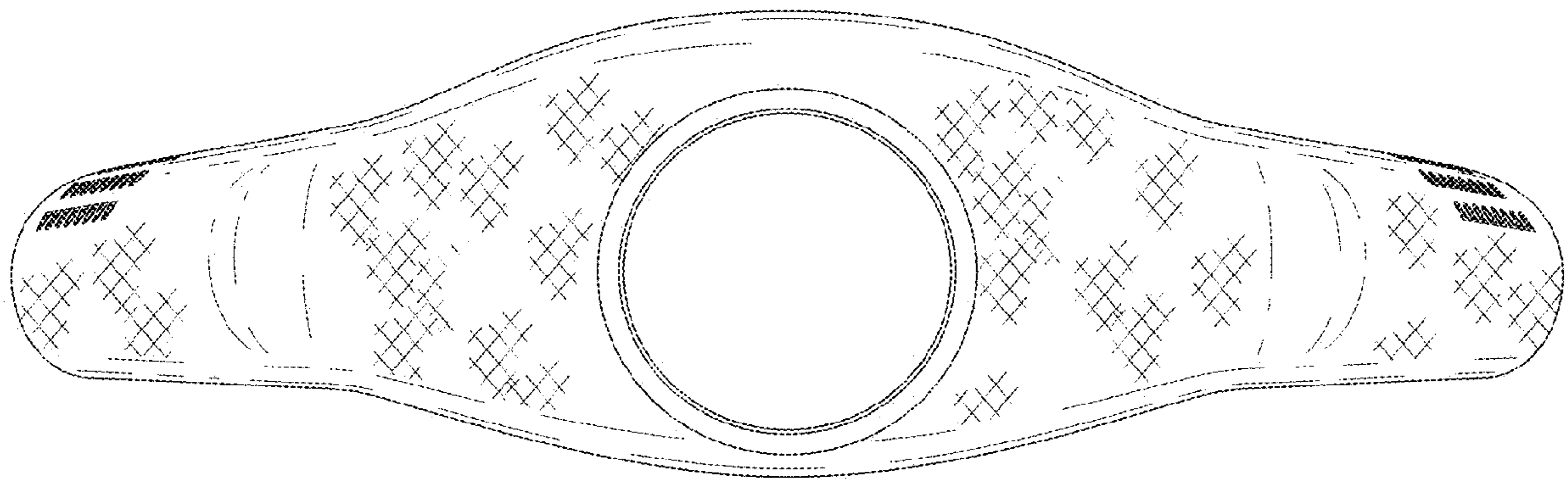

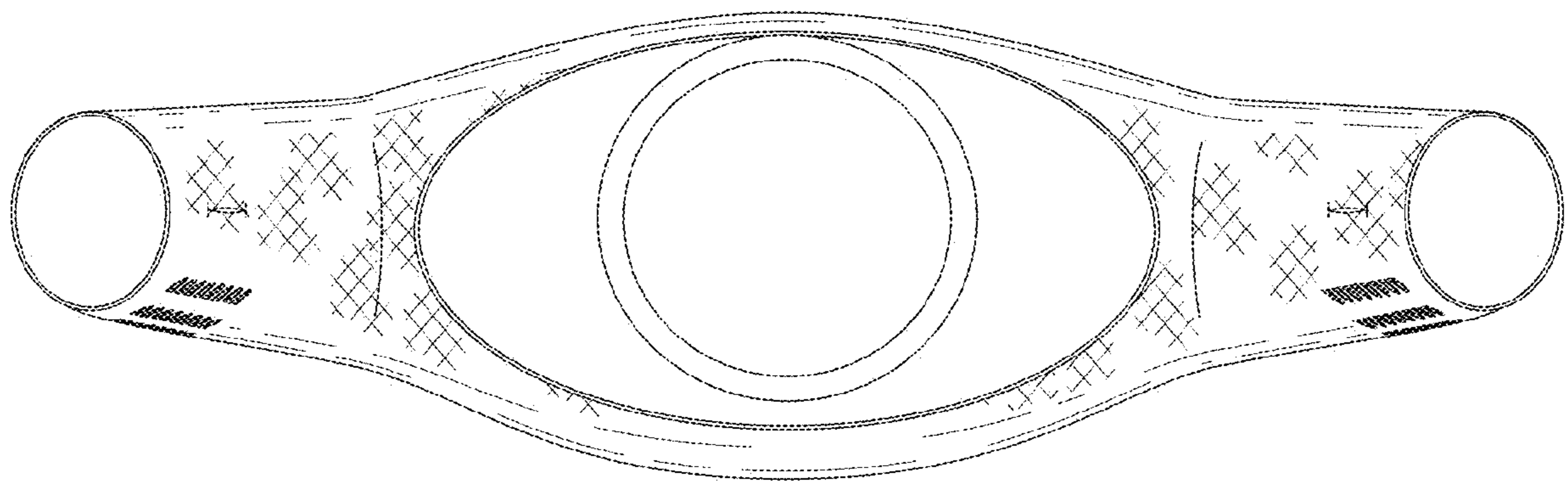

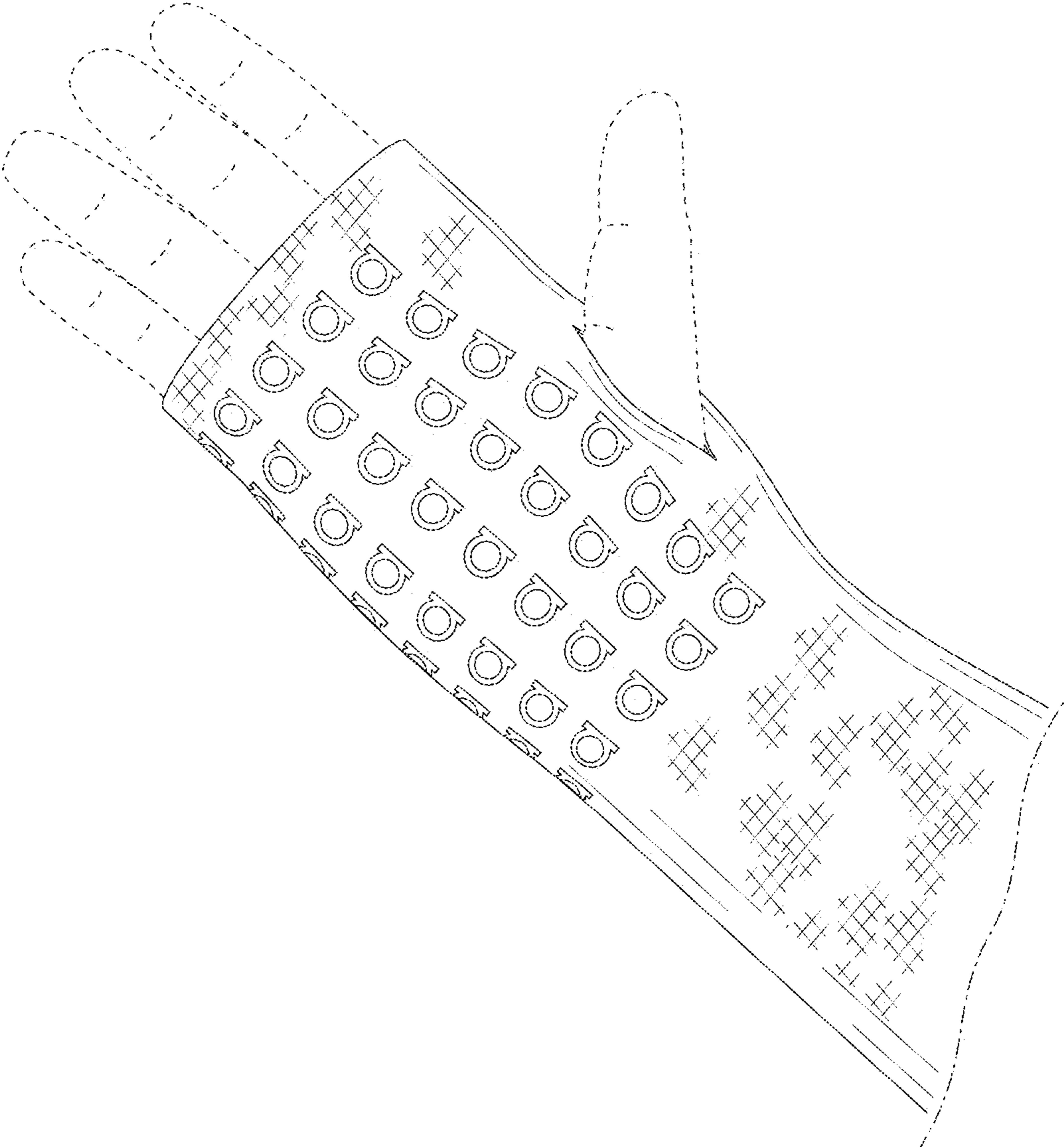
