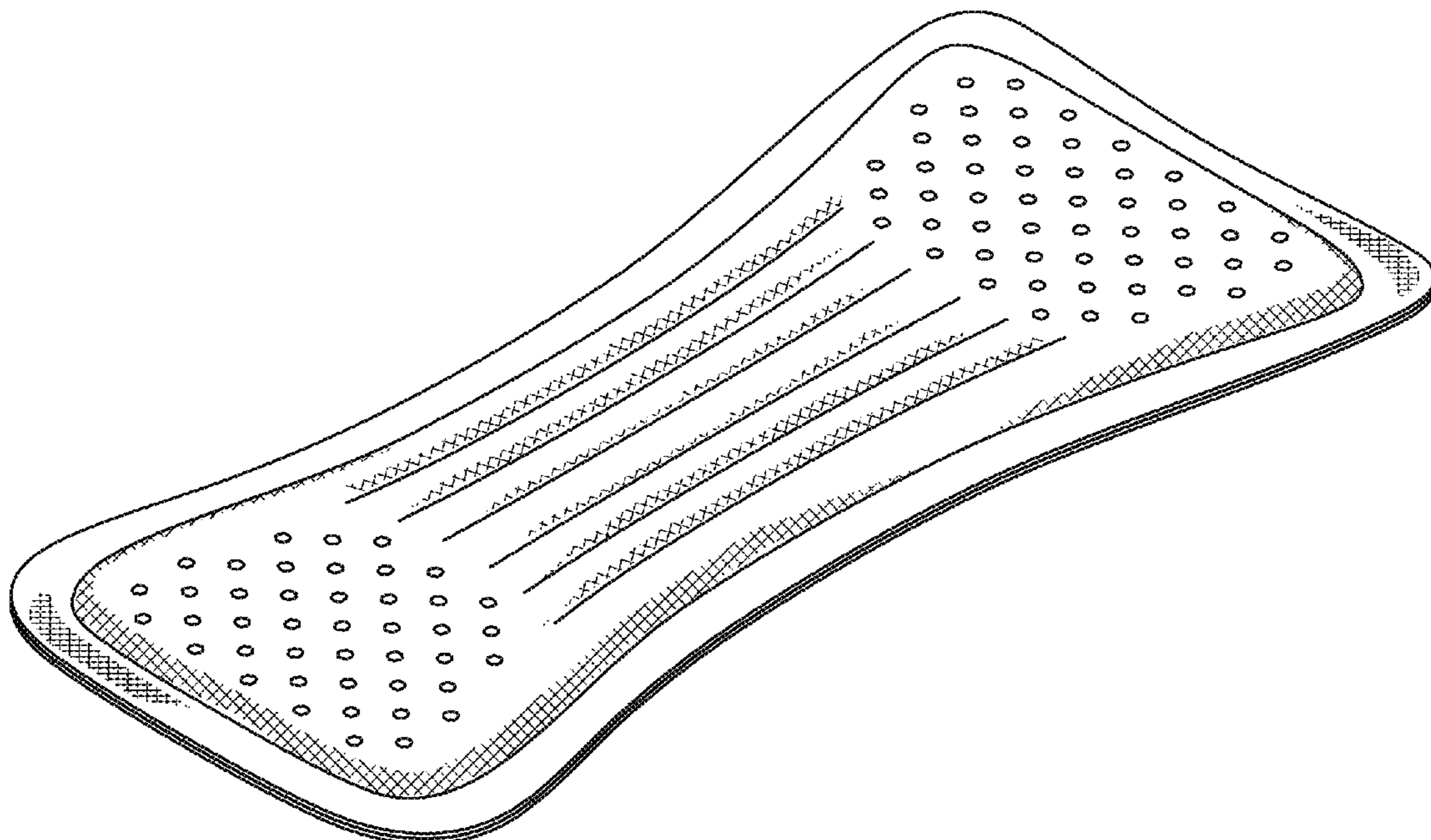
The ornamental design for a garment shield, as shown and described.

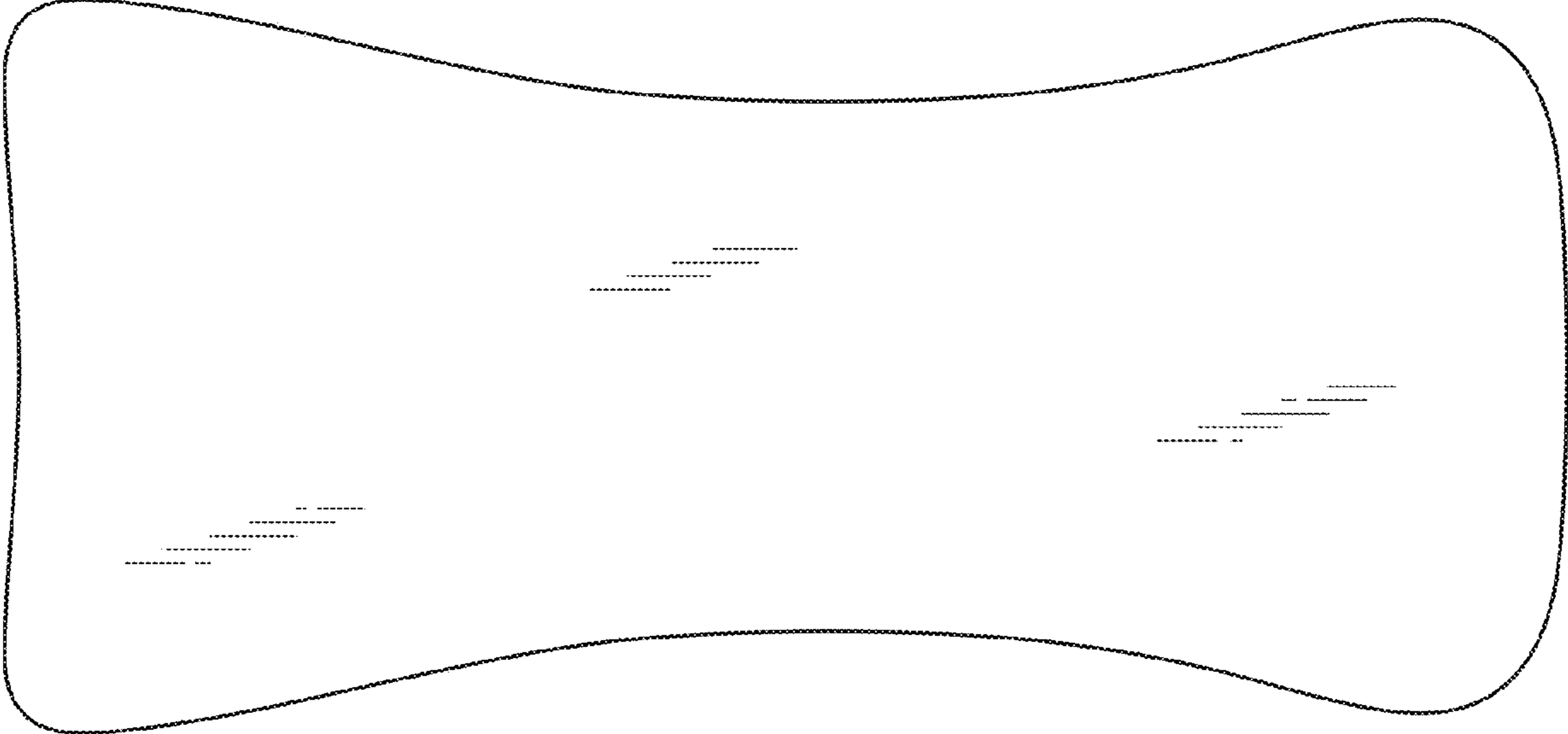

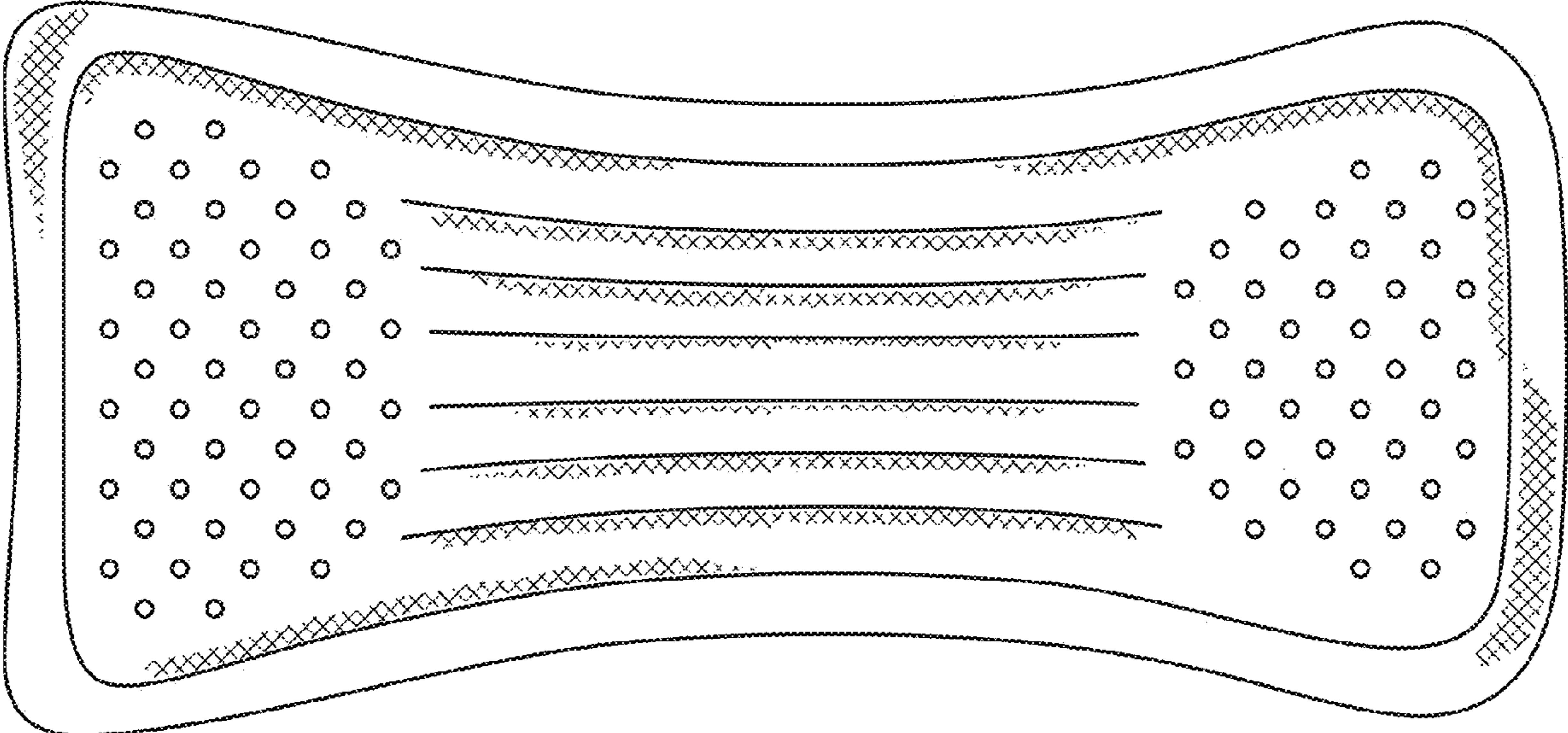

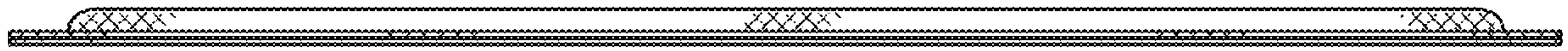

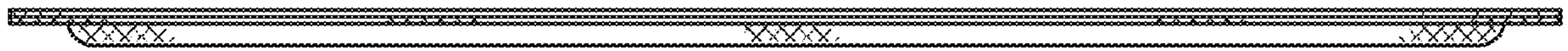

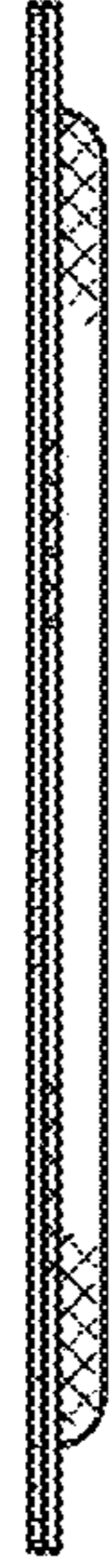
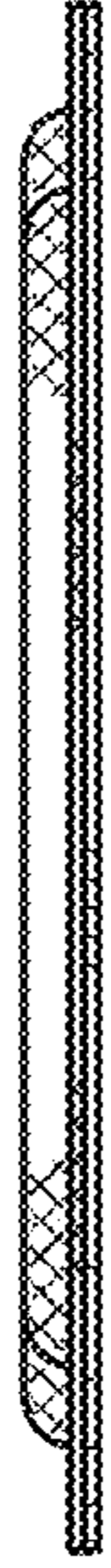

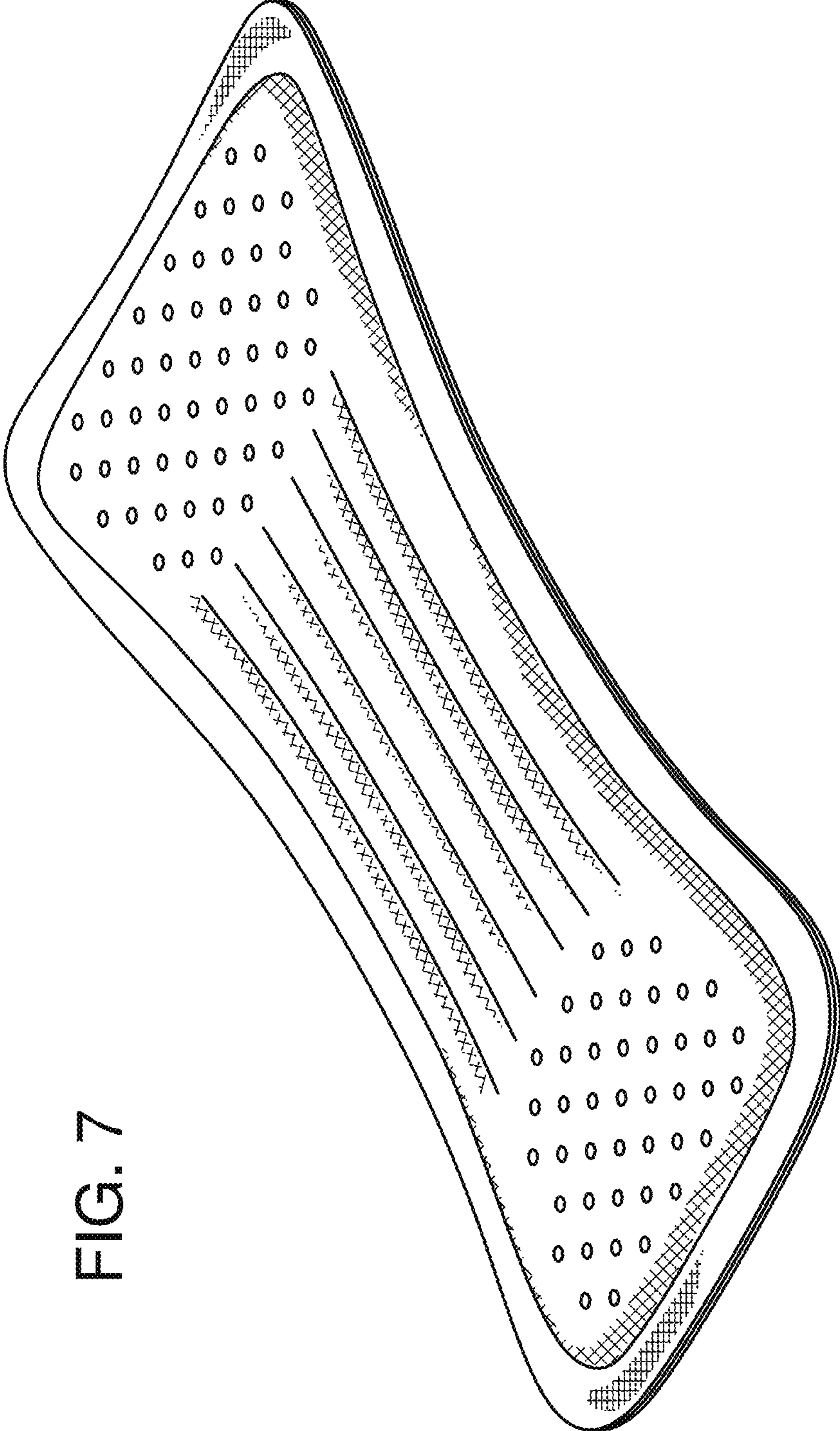
