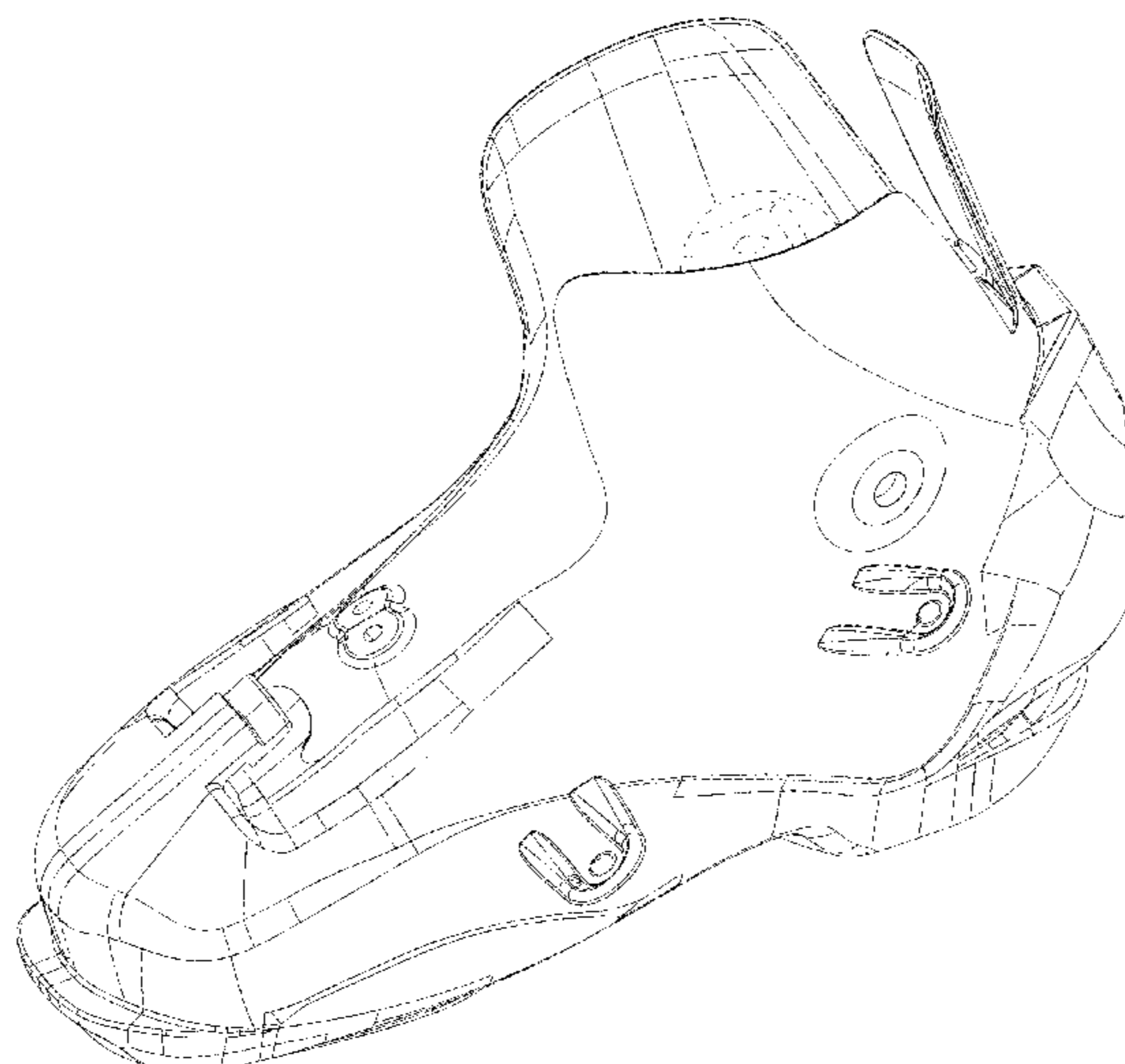

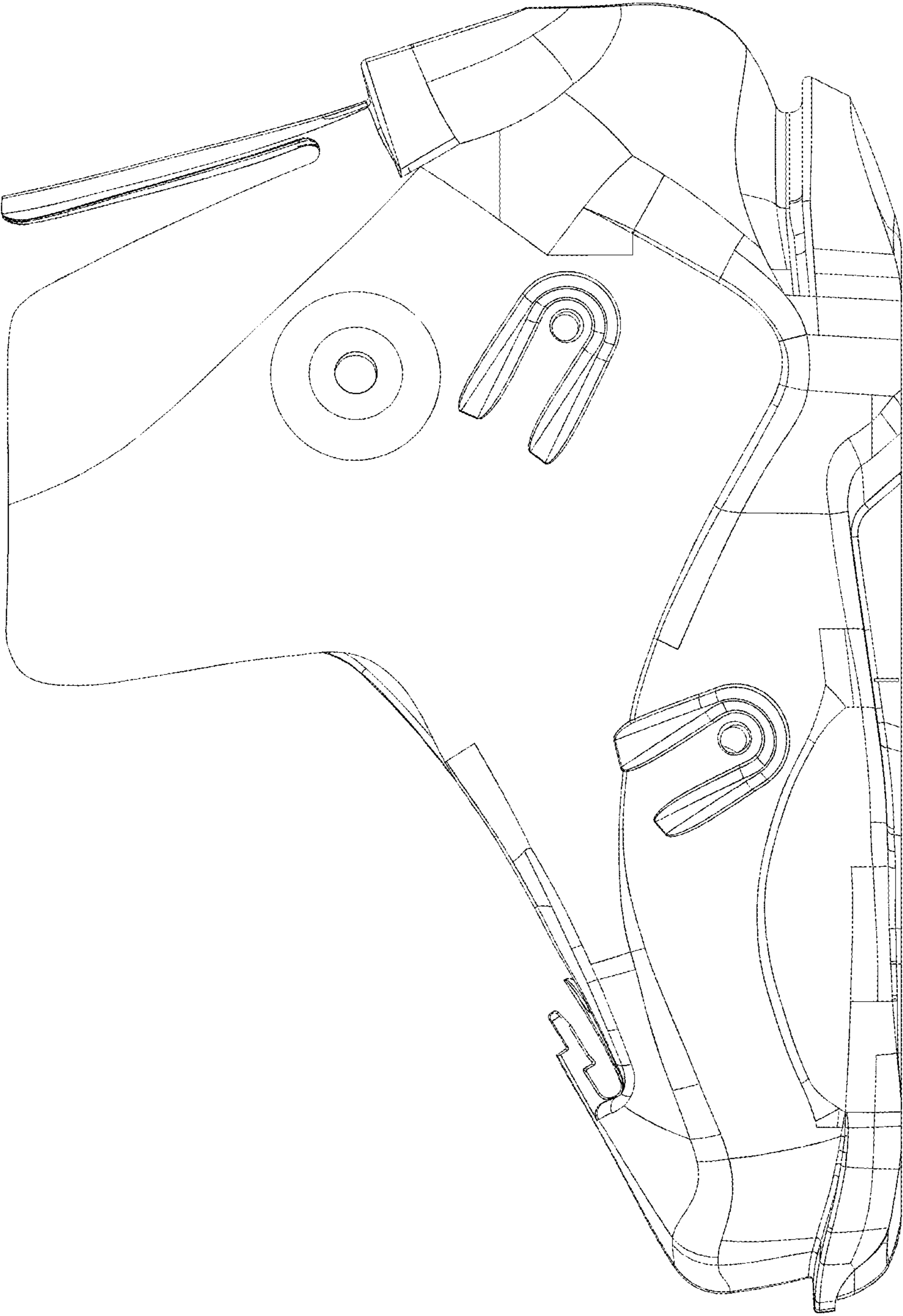
DESCRIPTION

The broken lines in the figures depict portions of a snowboard boot and form no part of the claim.

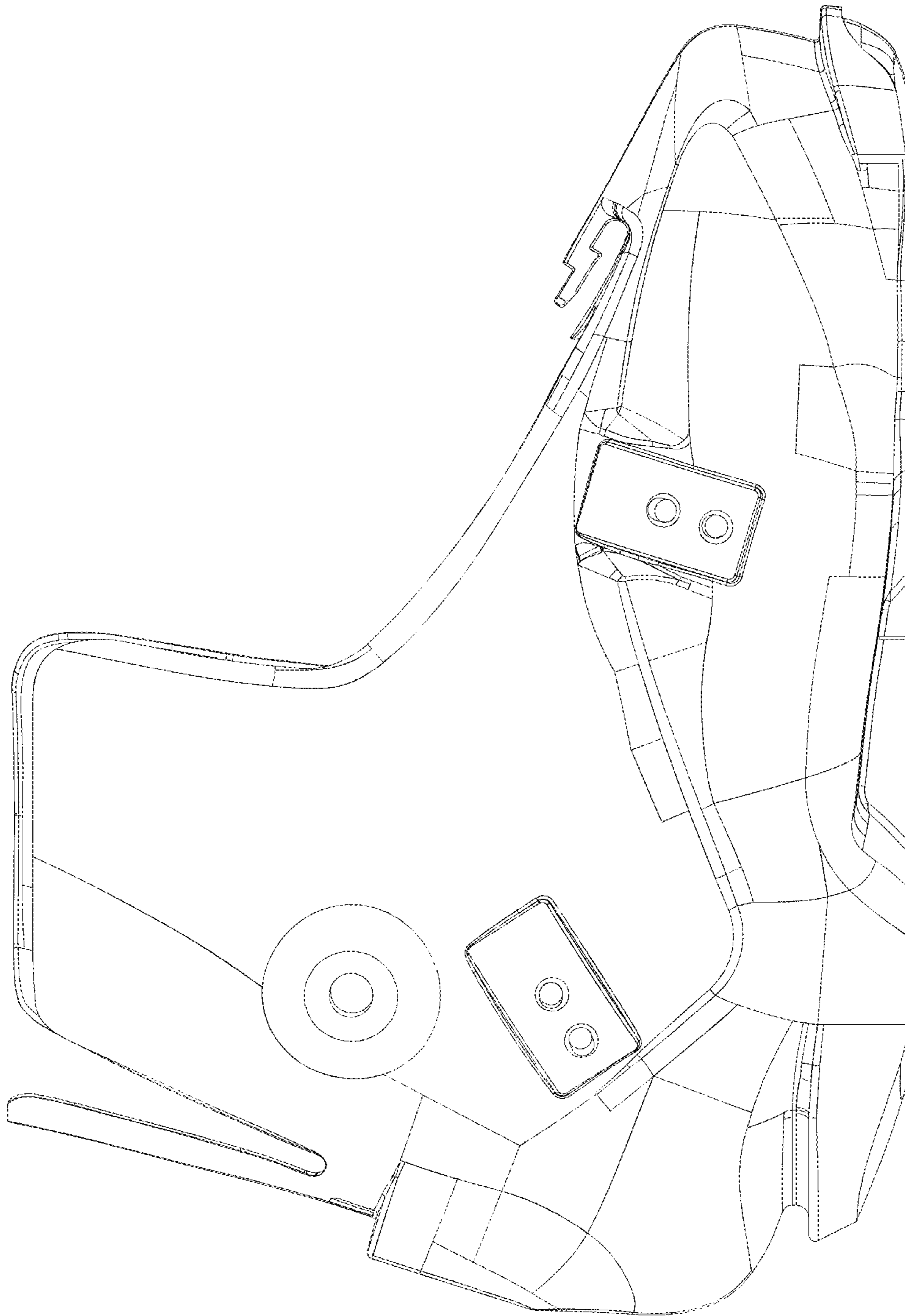

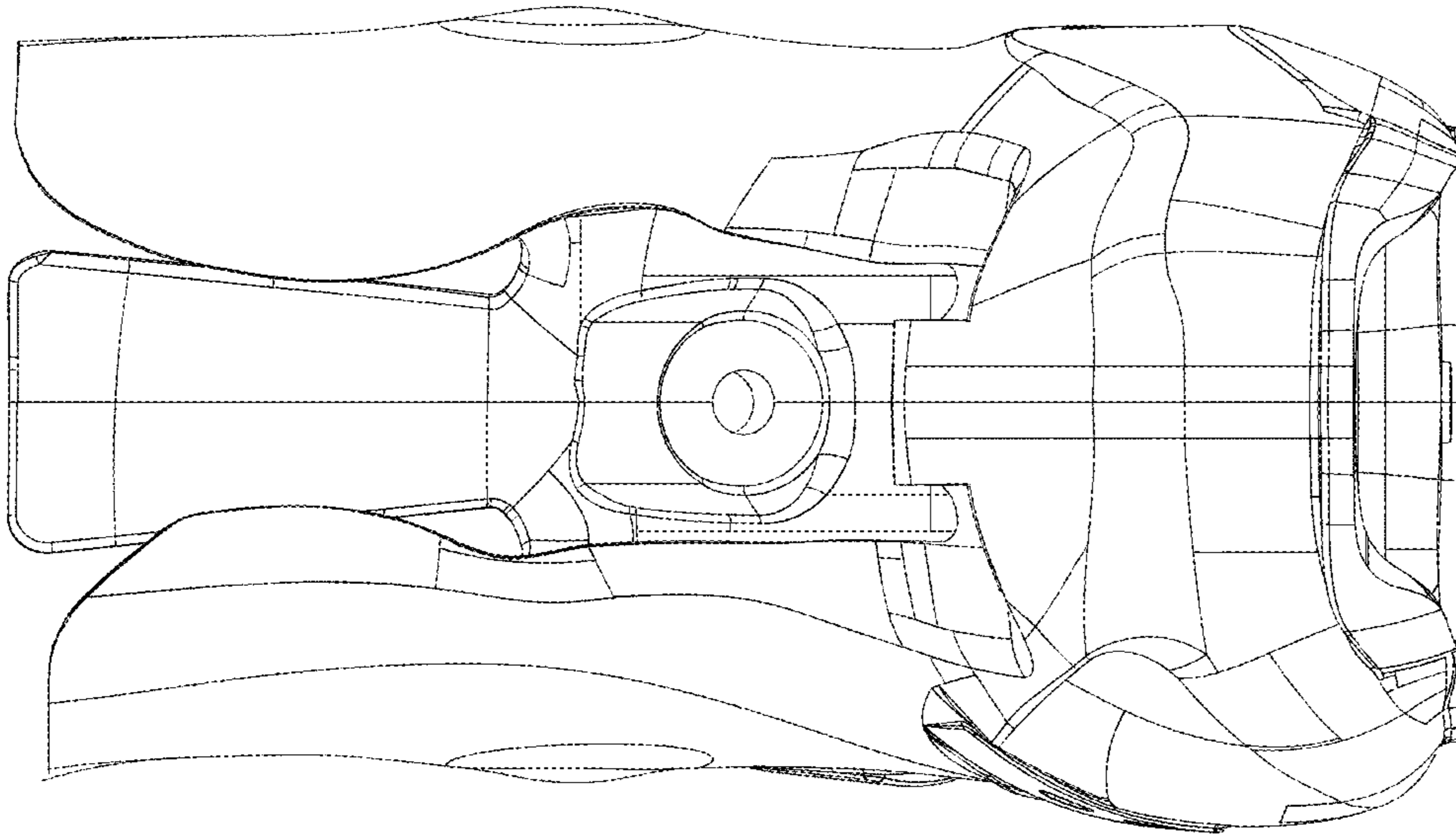




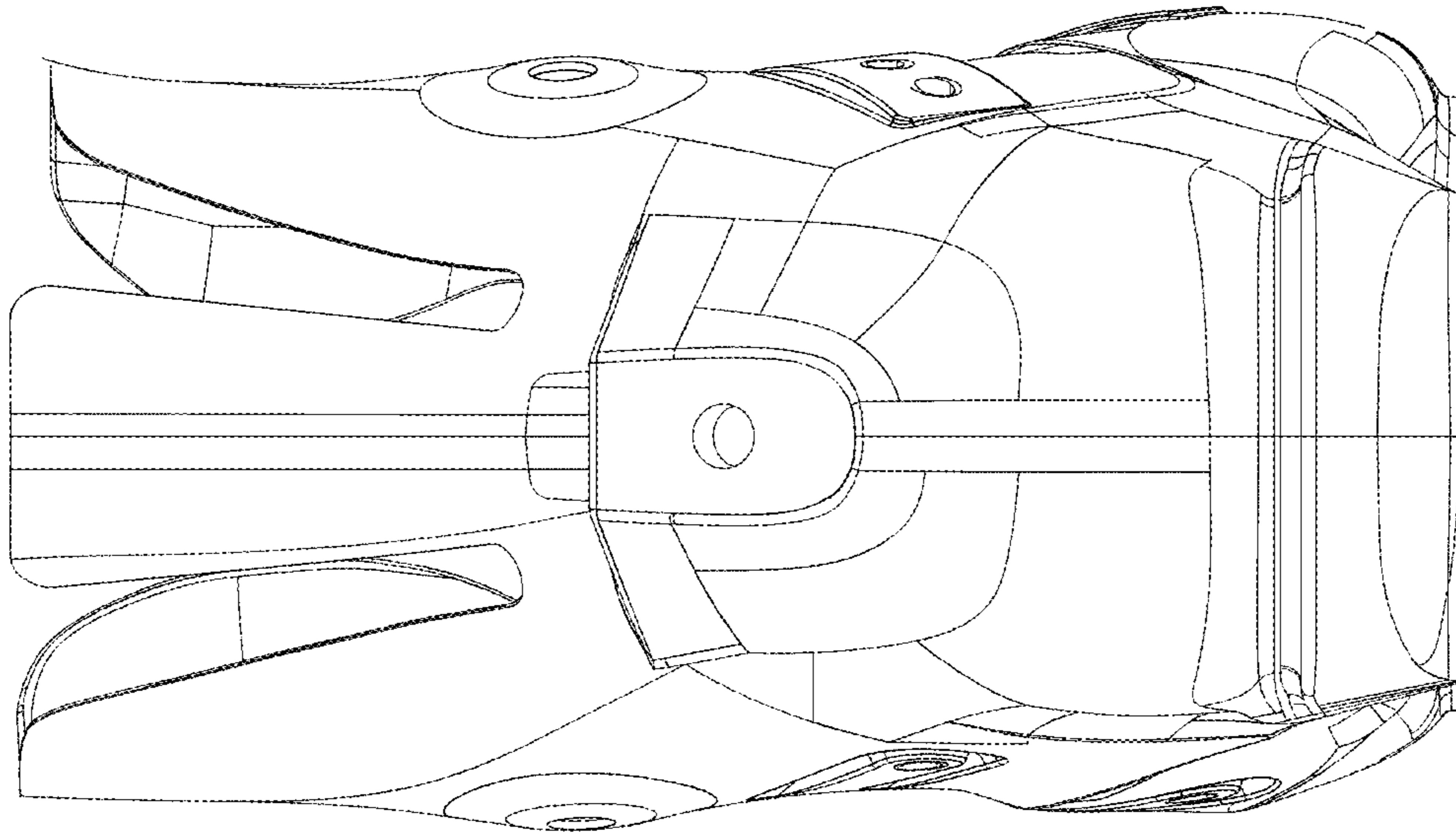

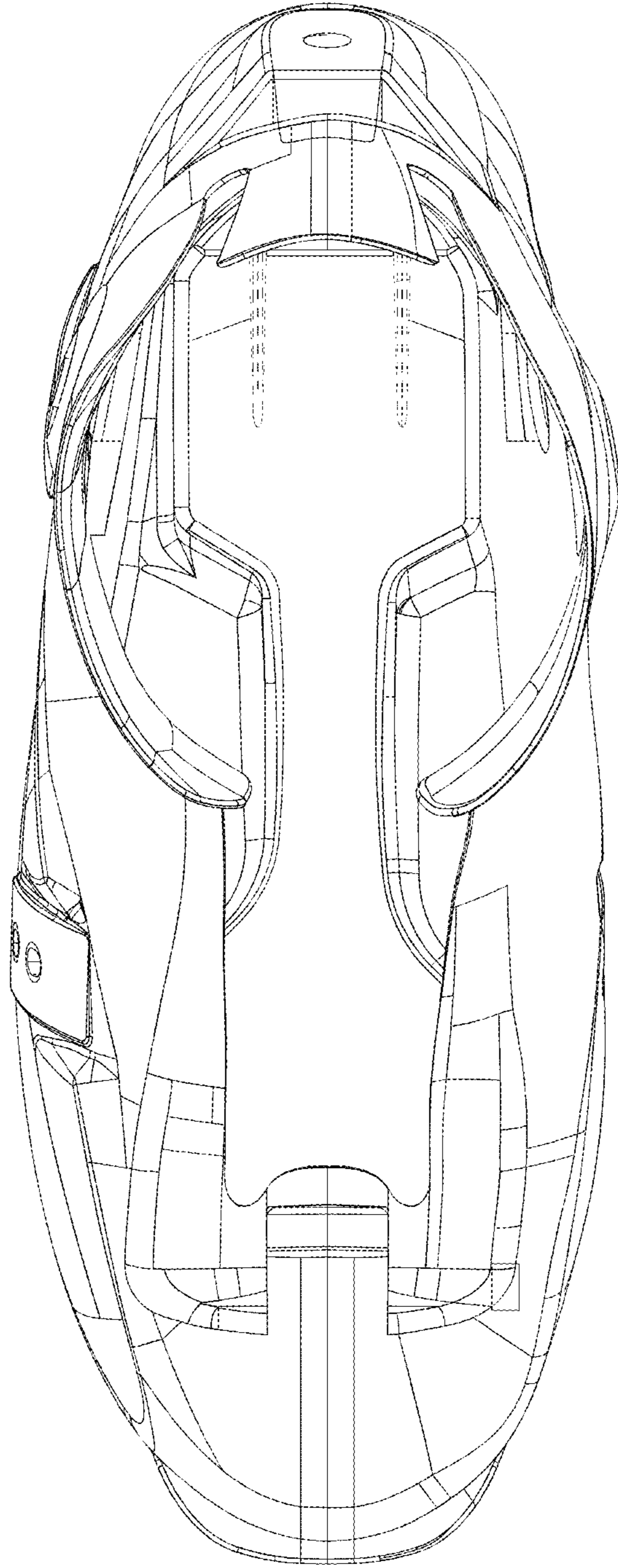

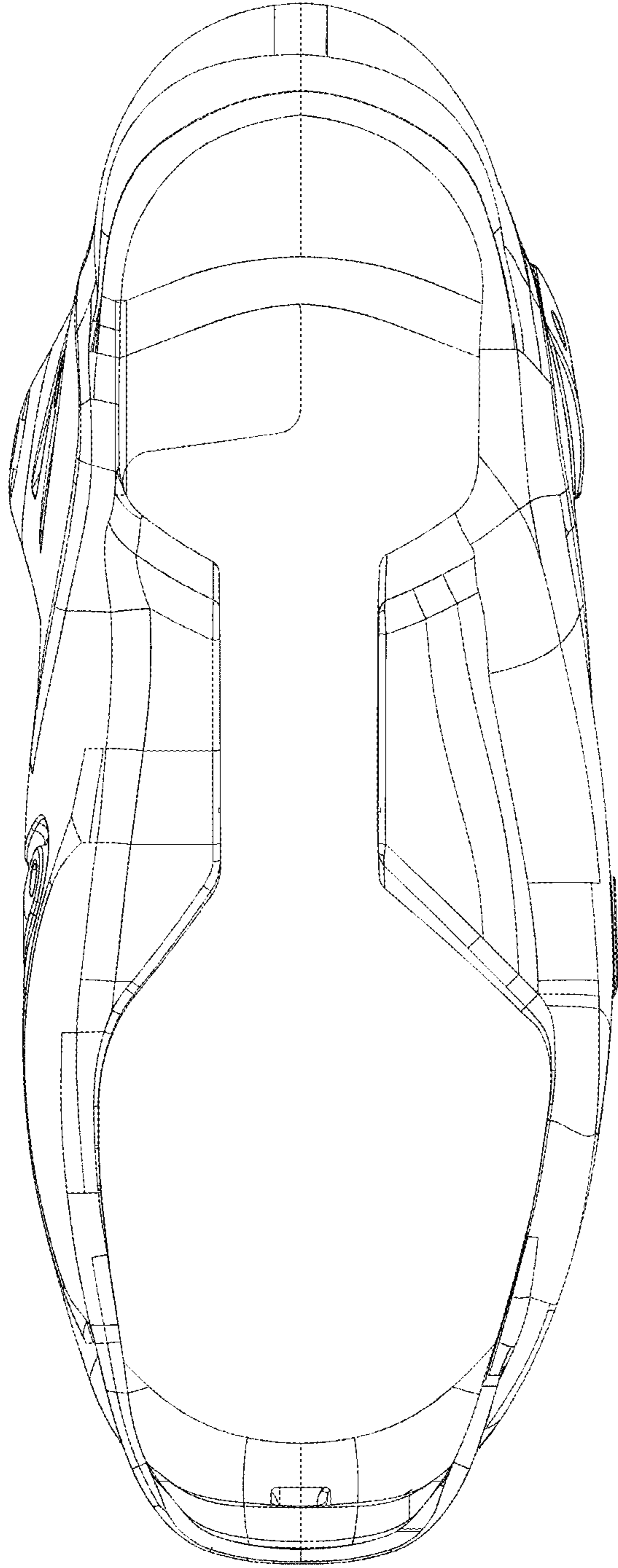

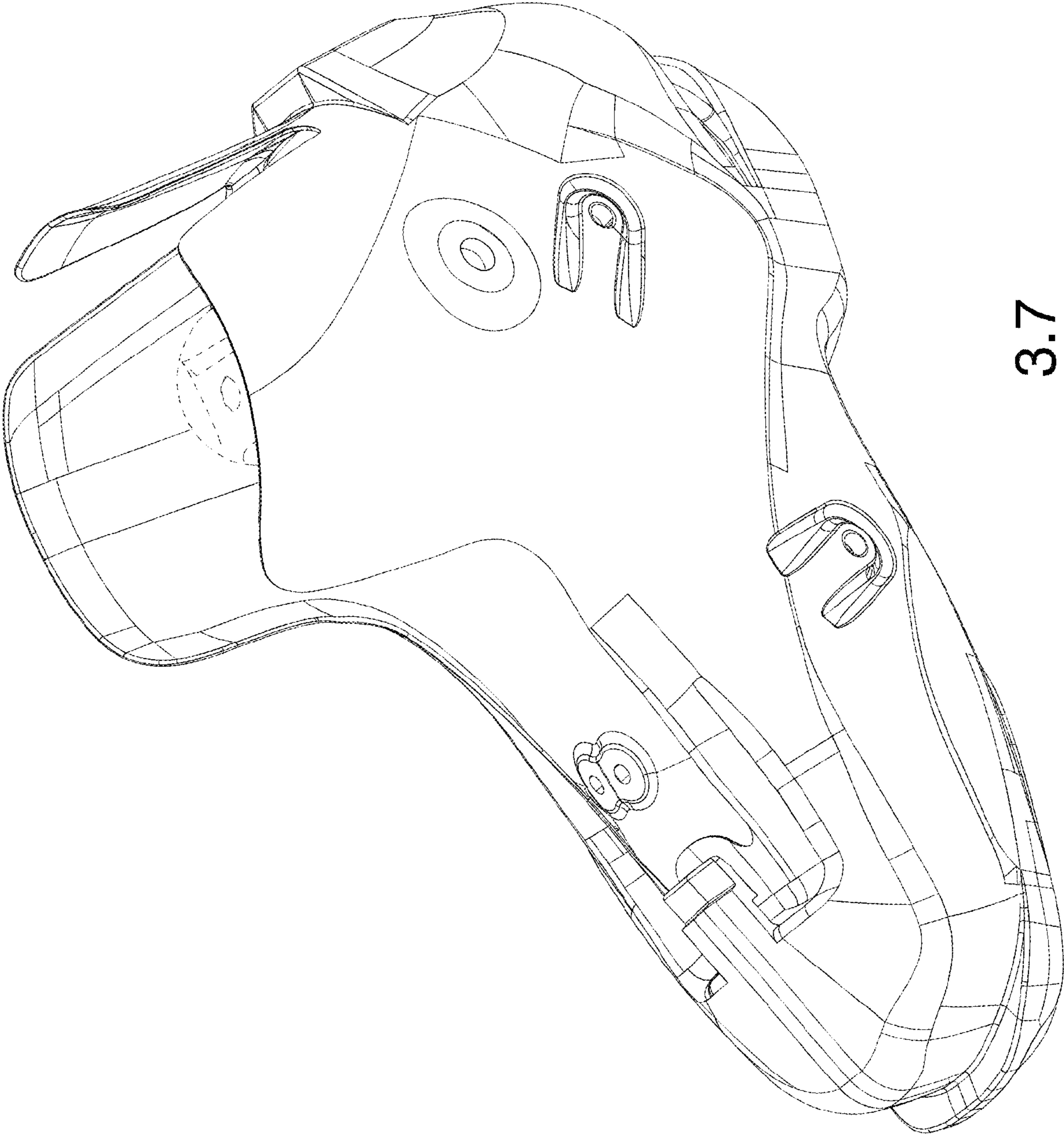

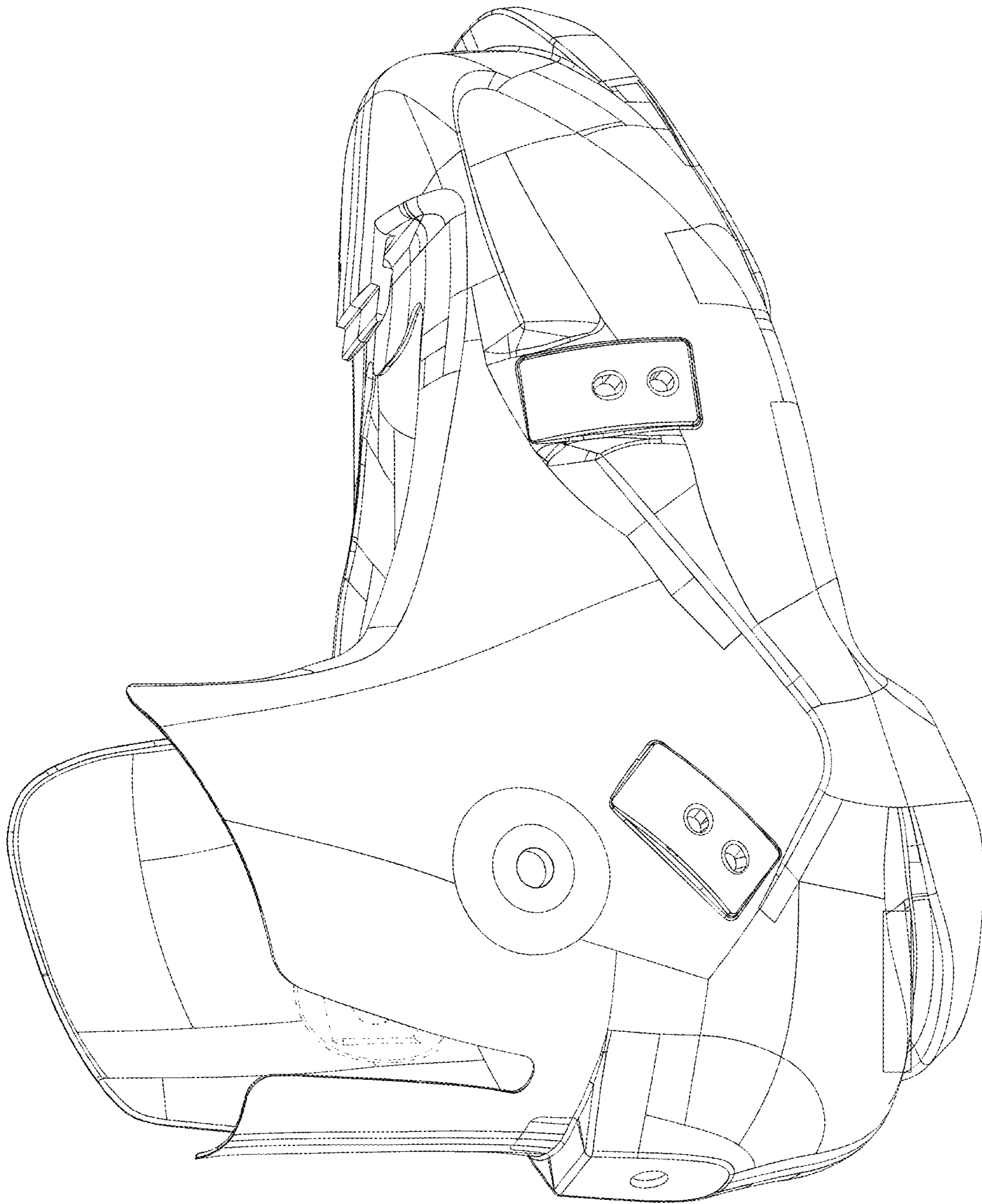
