FIG. 4 is a rear view thereof;

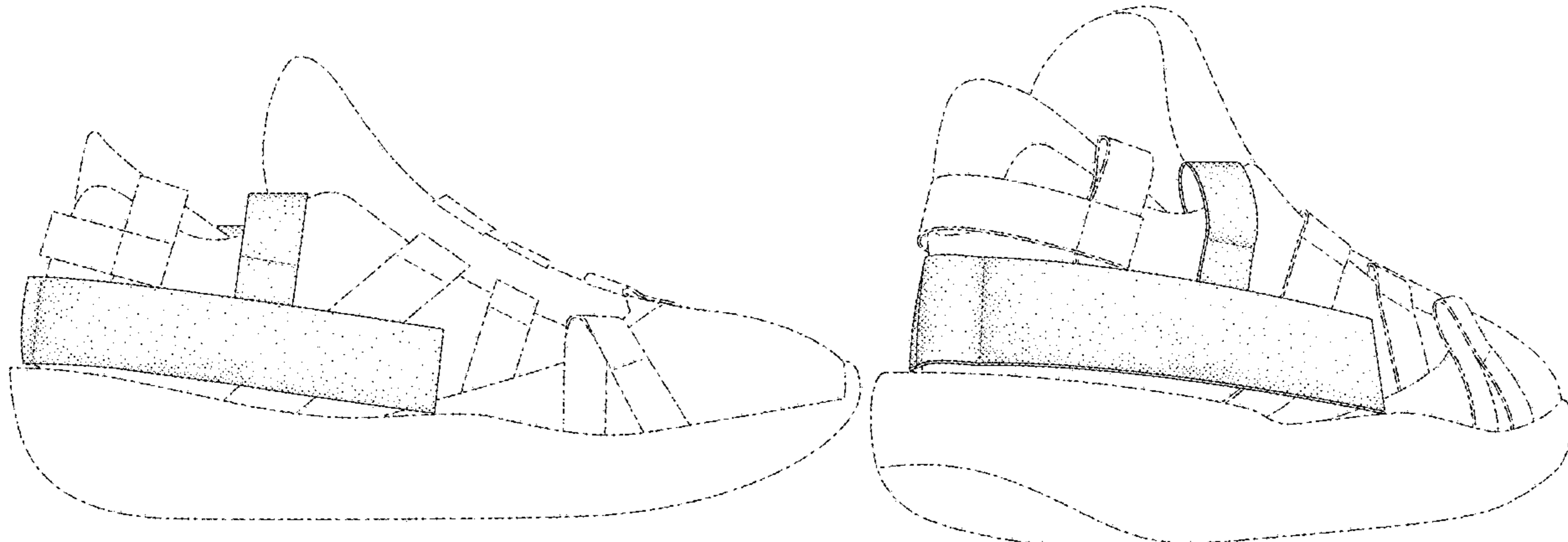
FIG. 5 is an opposite side rear perspective view thereof;

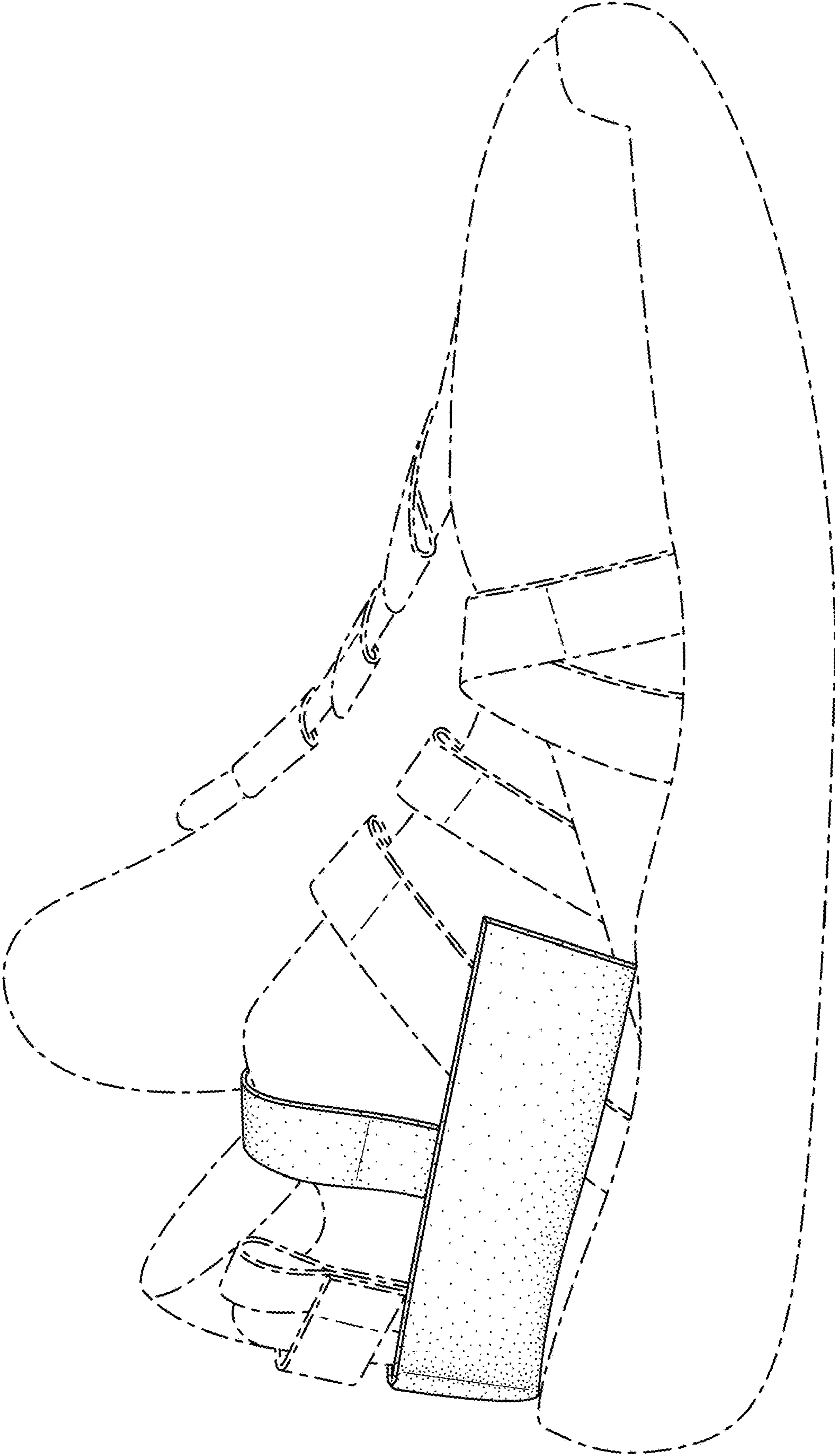

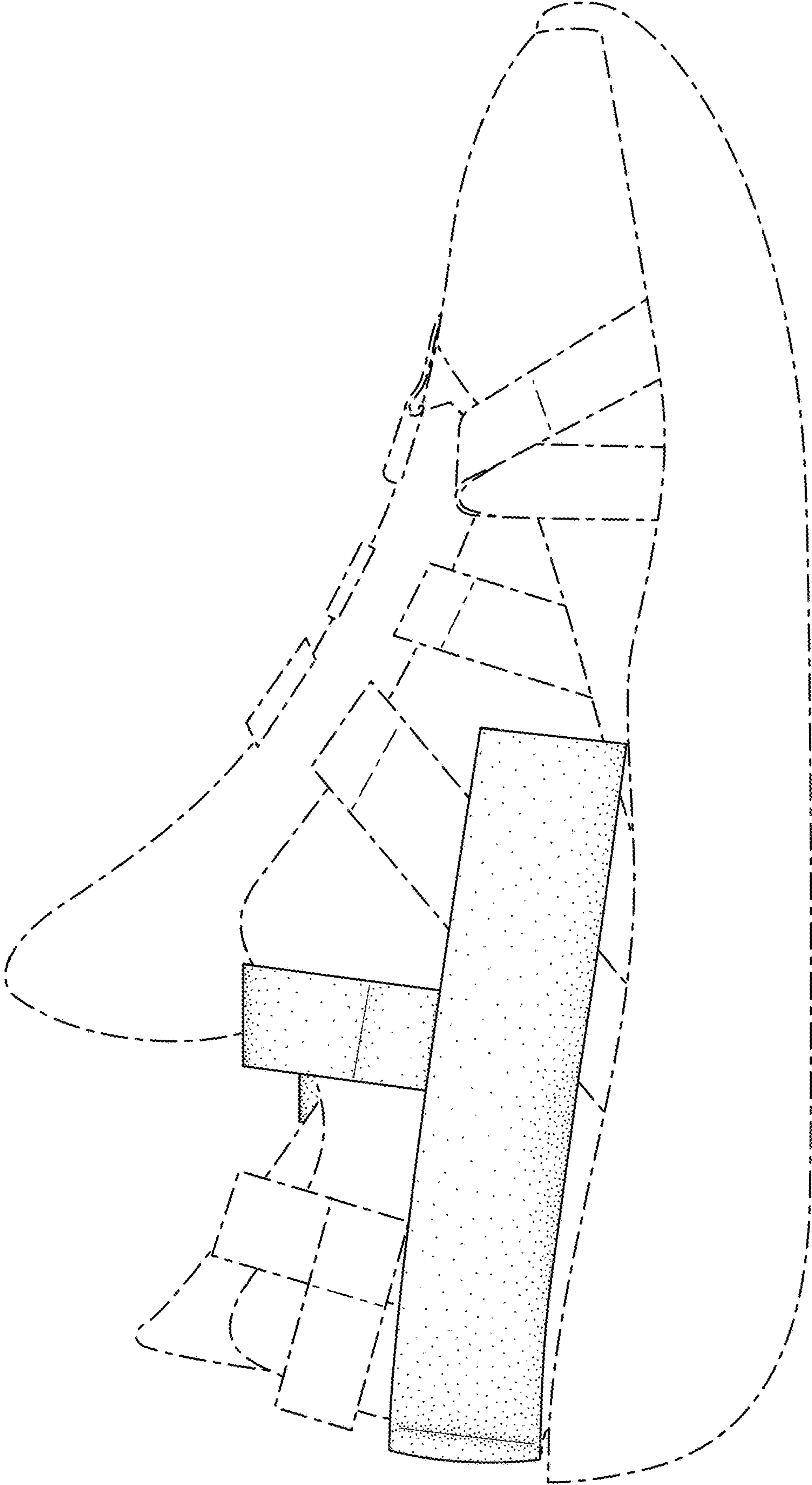

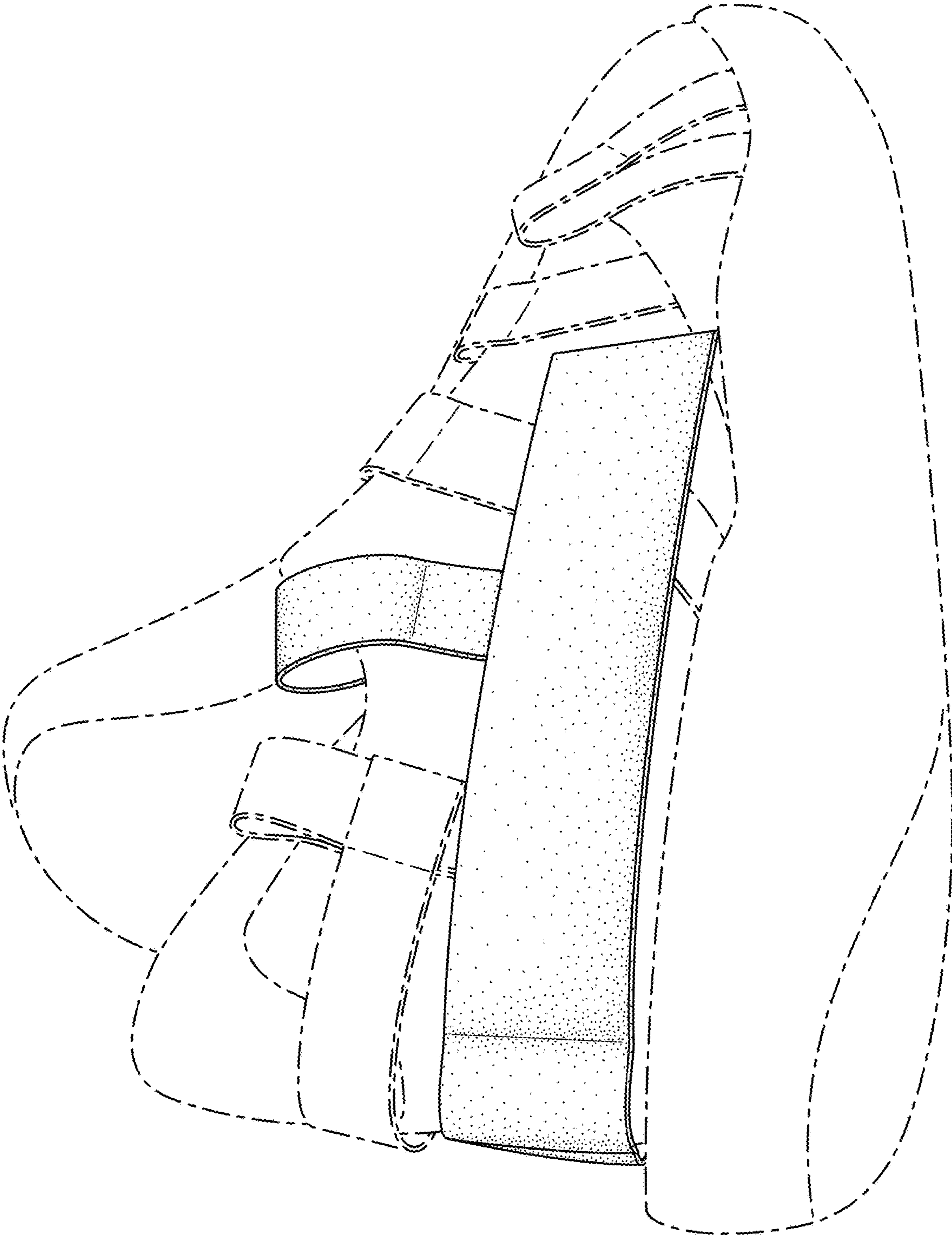

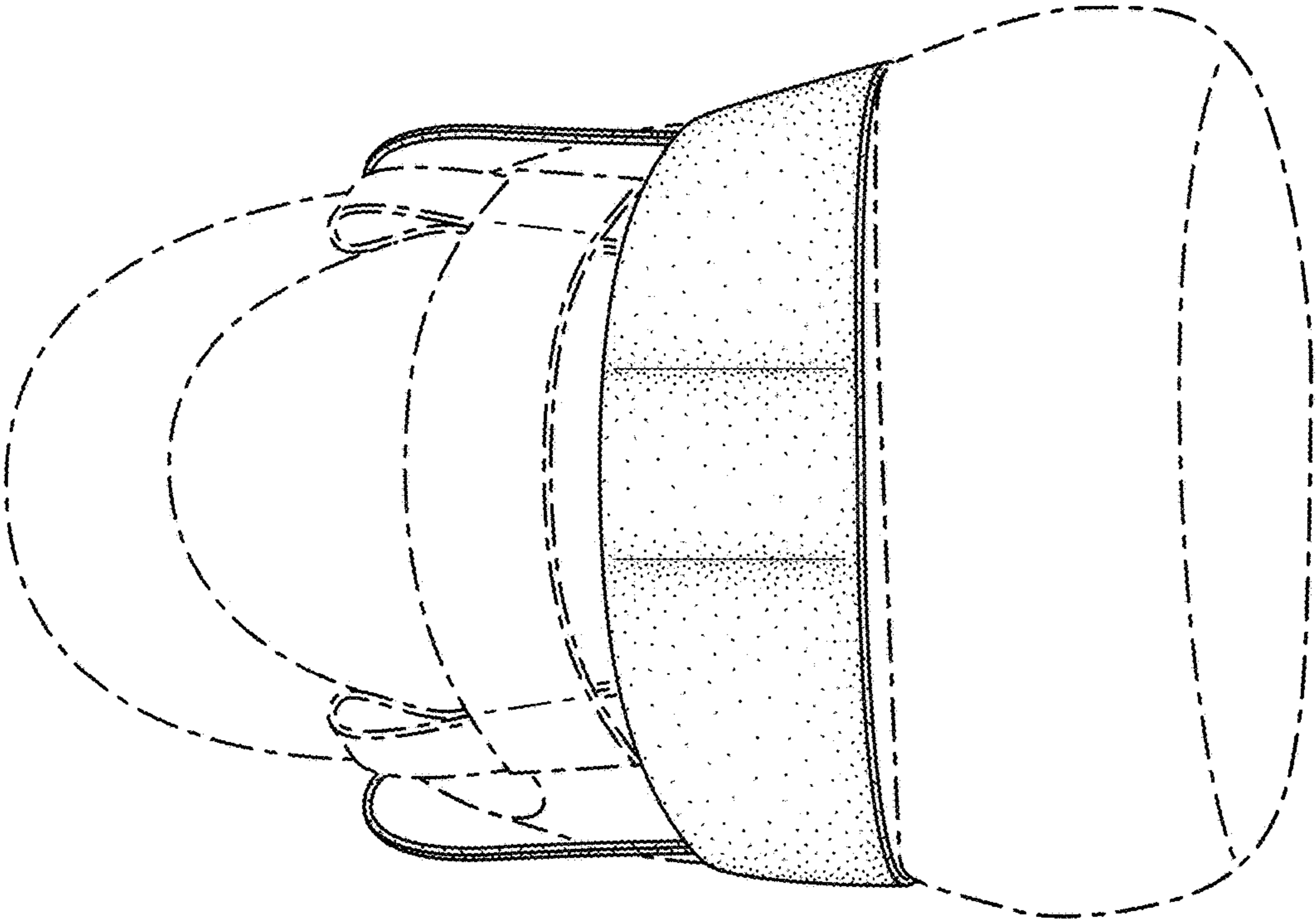

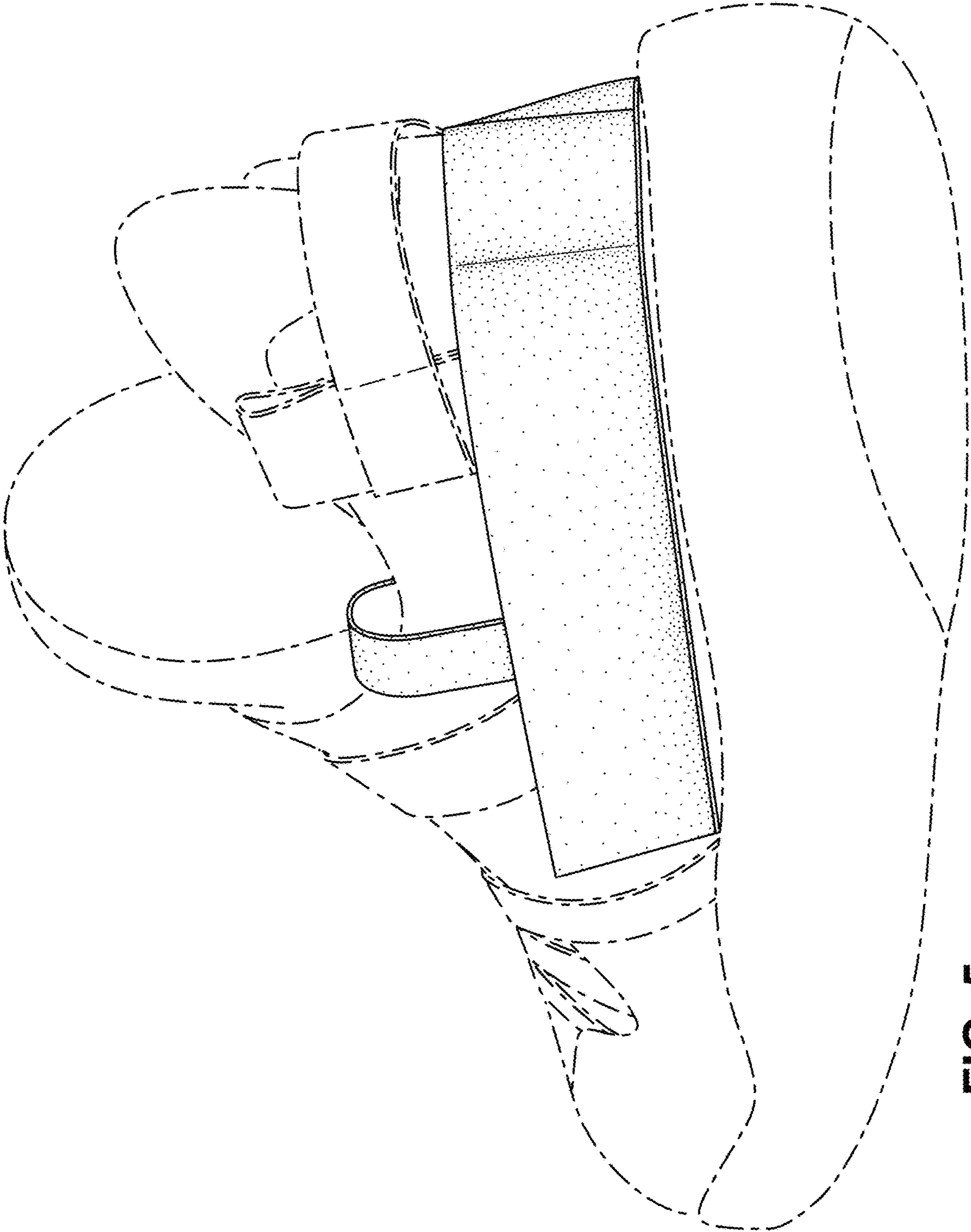

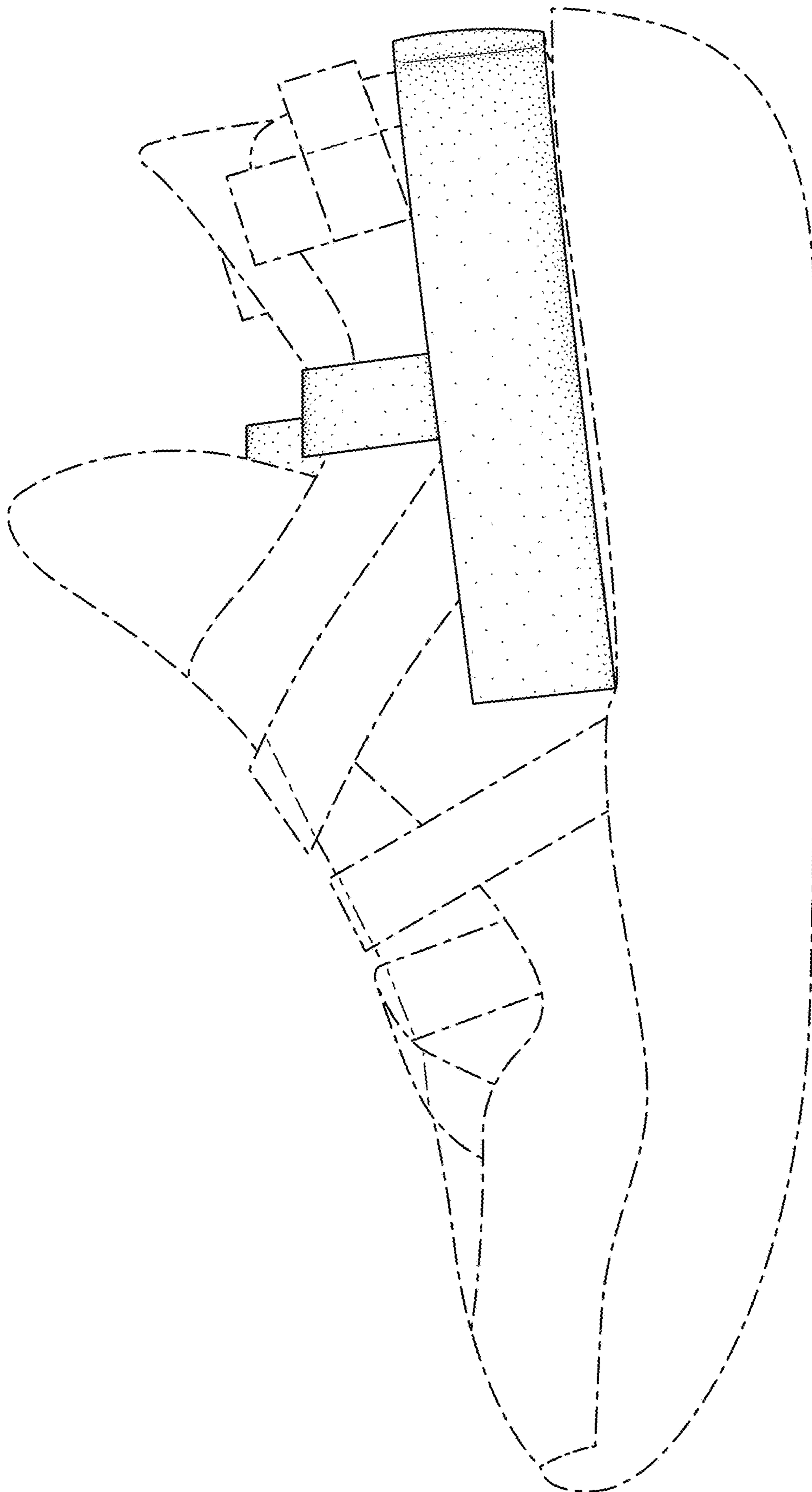

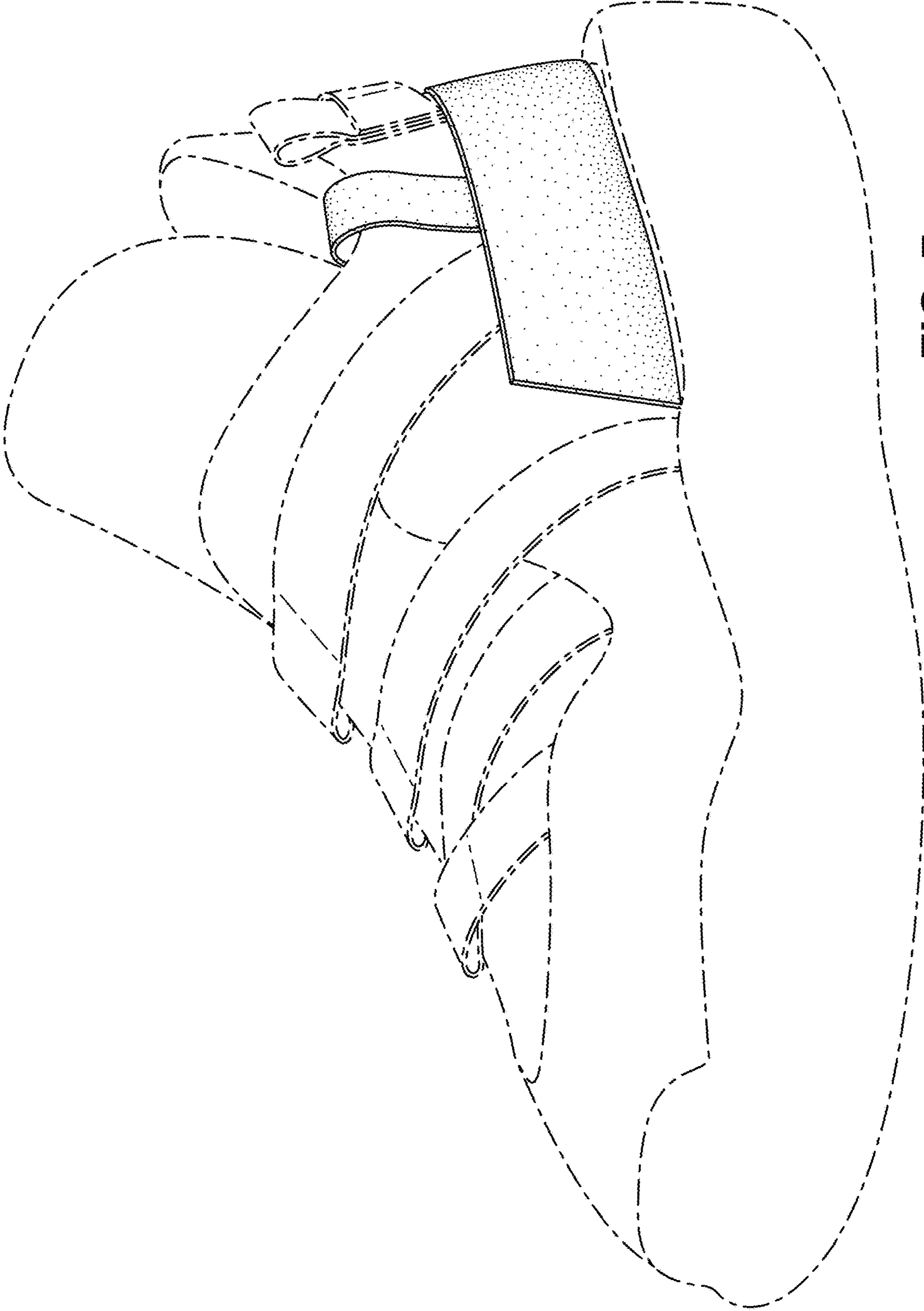
