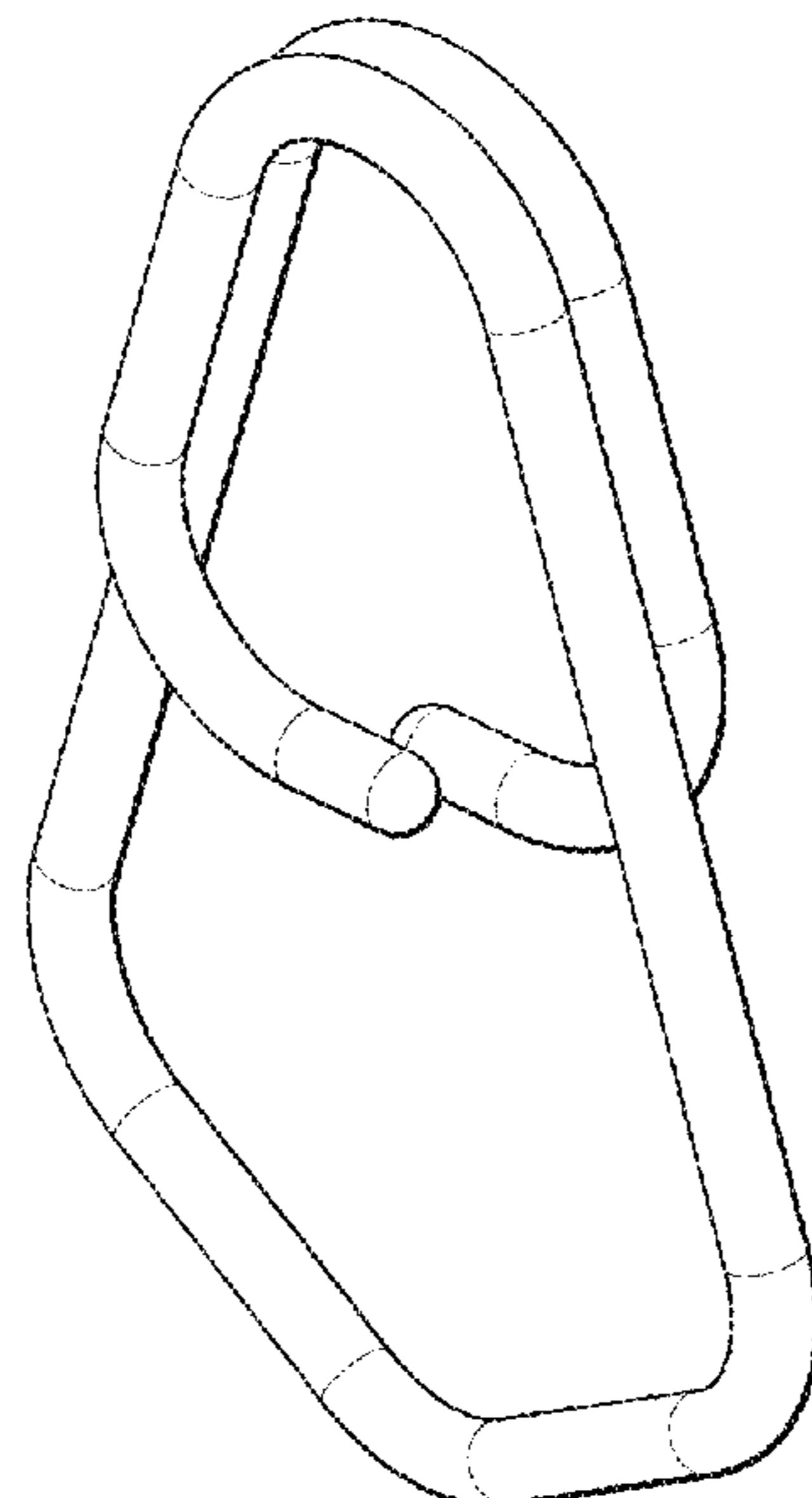
(57) **CLAIM**

The ornamental design for a connection device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a connection device embodying a first embodiment of our design;  
FIG. 2 is a front elevation view of the connection device shown in FIG. 1, with the rear elevation view being an identical image;  
FIG. 3 is a cross-sectional view of the connection device taken along line 3-3 in FIG. 2; and,  
FIG. 4 is a side elevation view of the connection device shown in FIGS. 1-3, with the opposite side elevation view being an identical image.

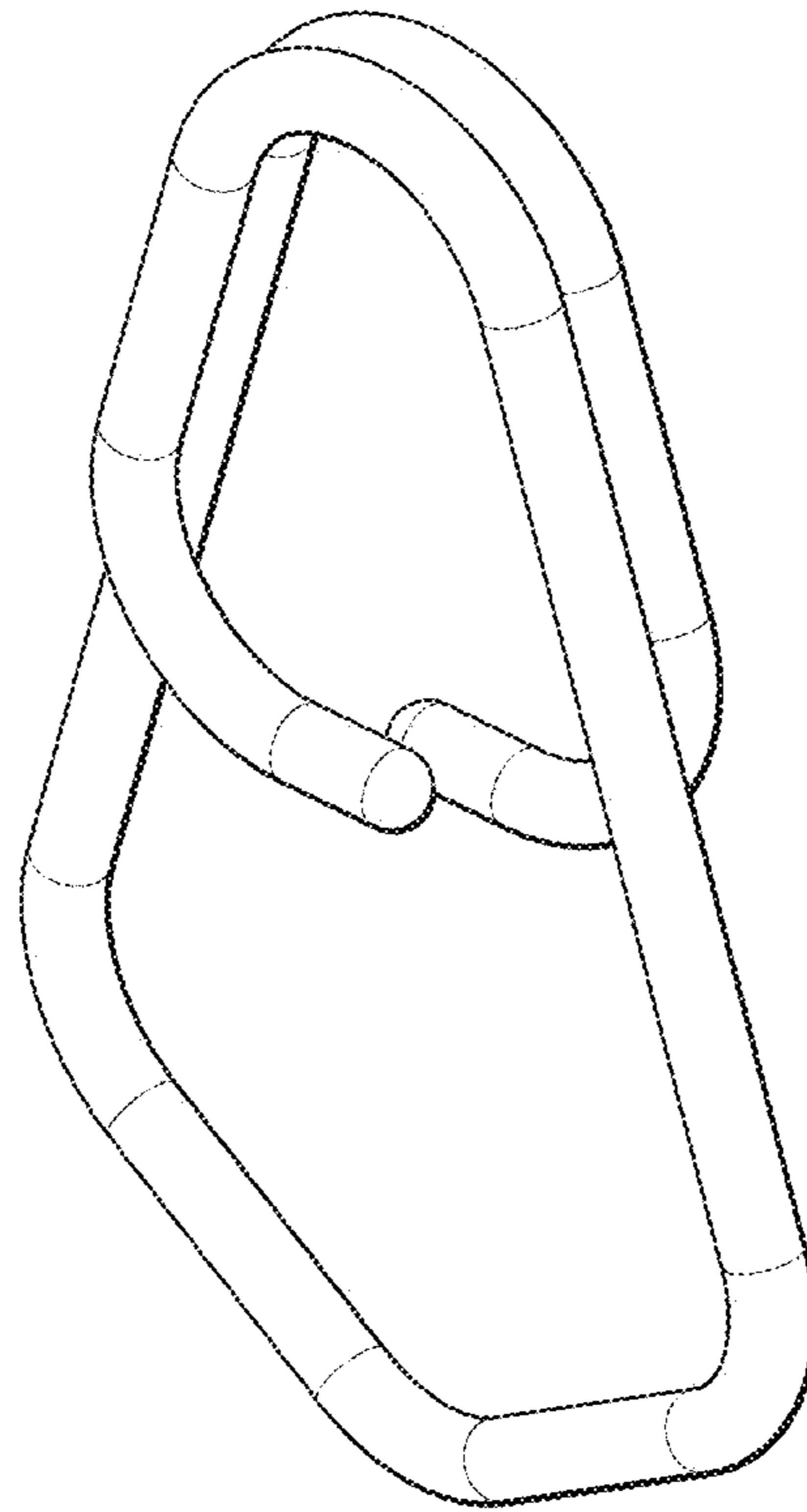

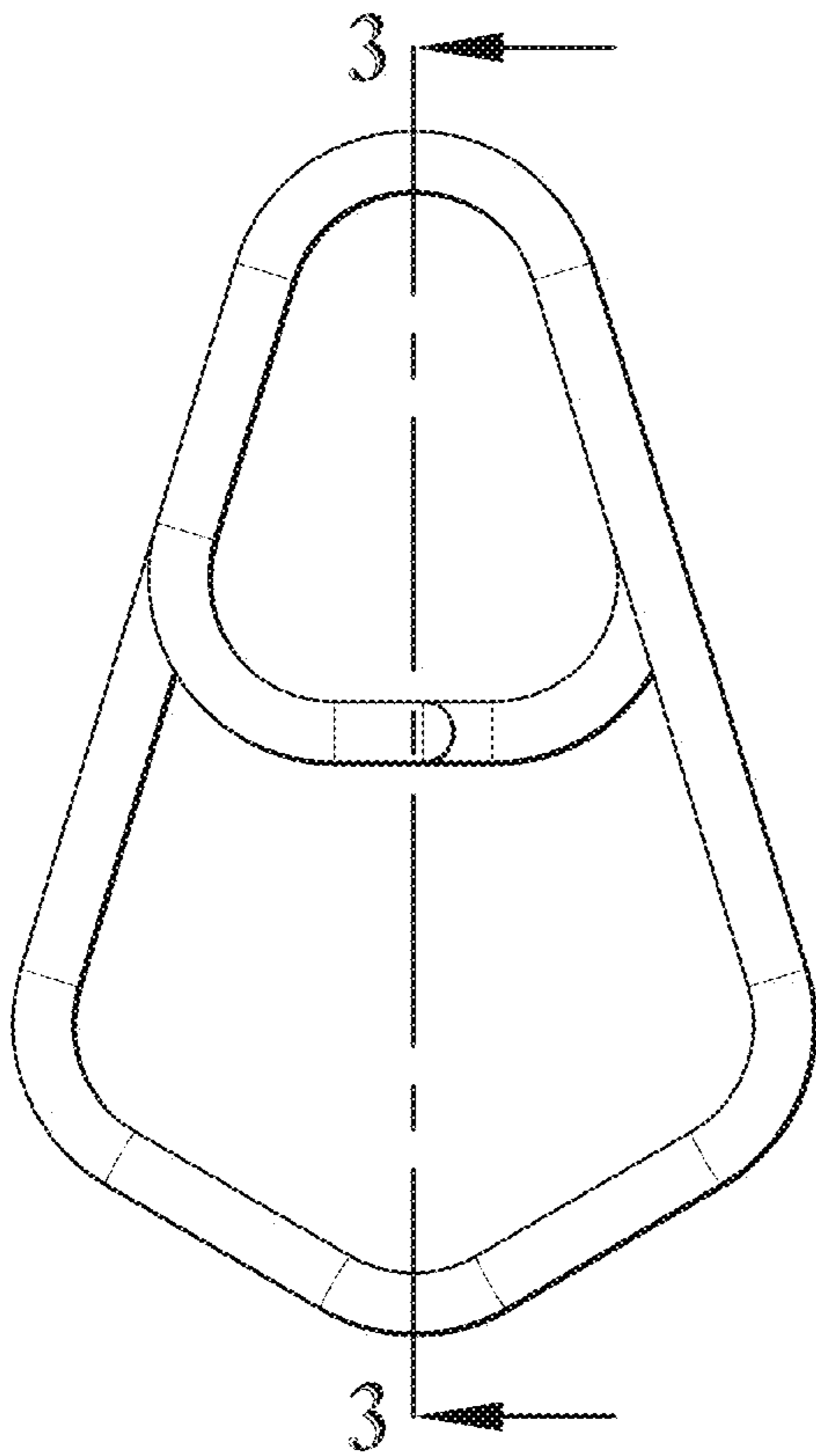

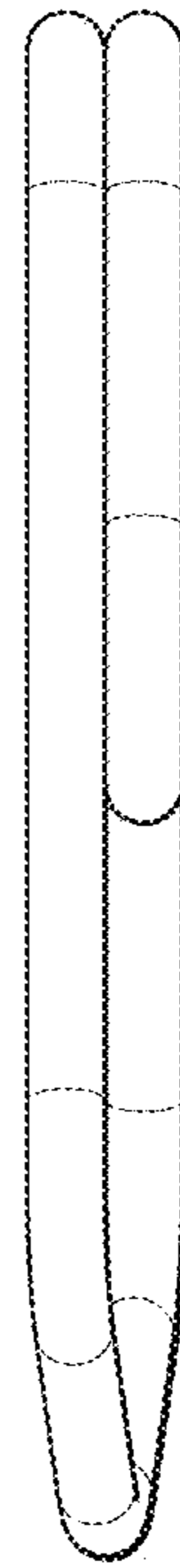
