The ornamental design for a beverage container, as shown and described.

DESCRIPTION

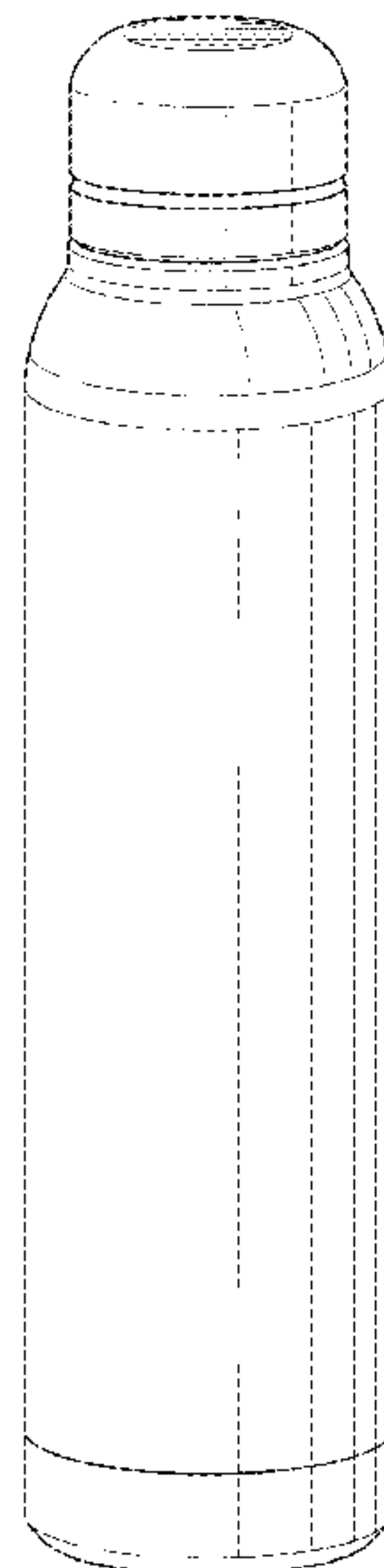

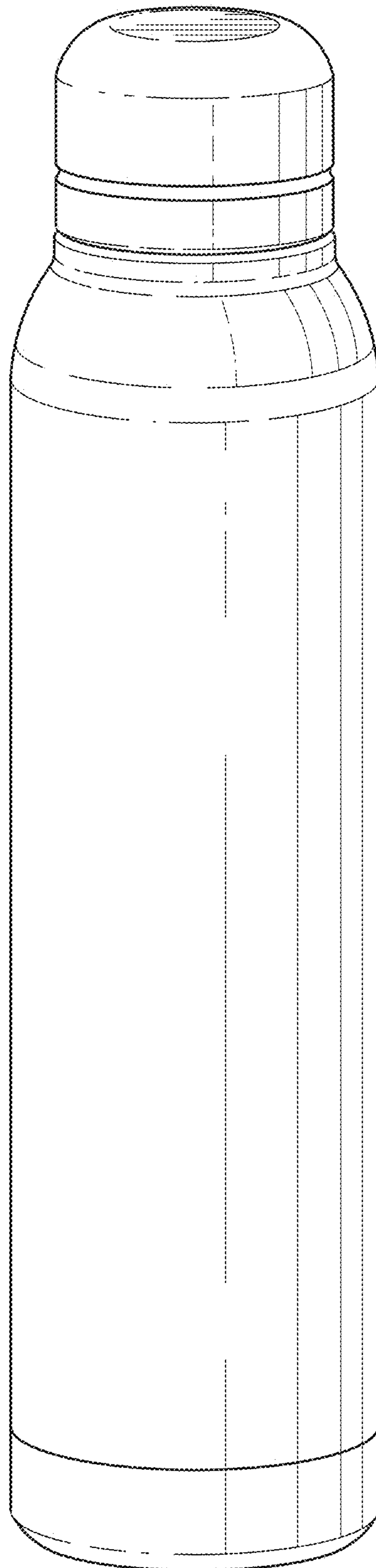

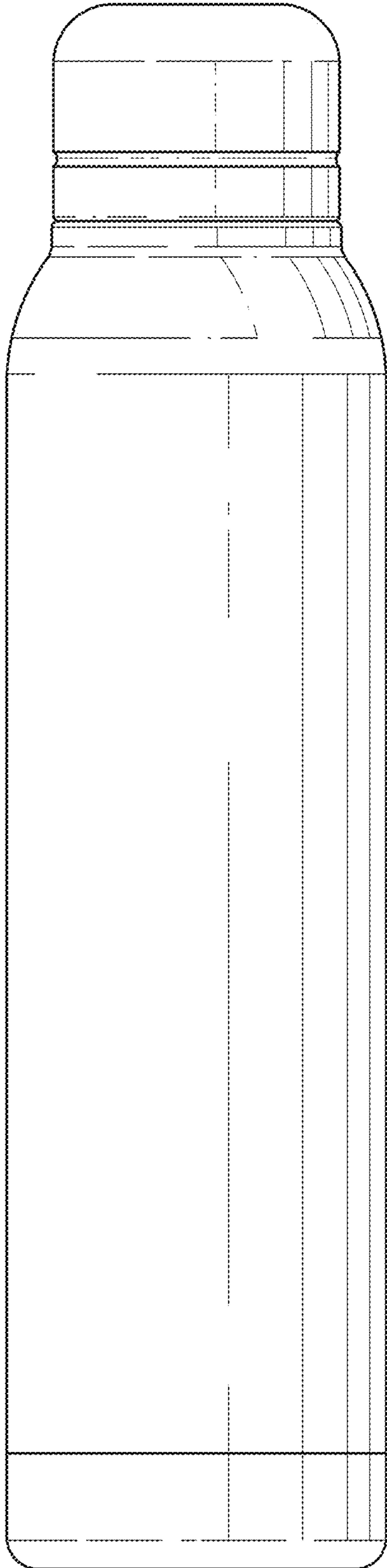

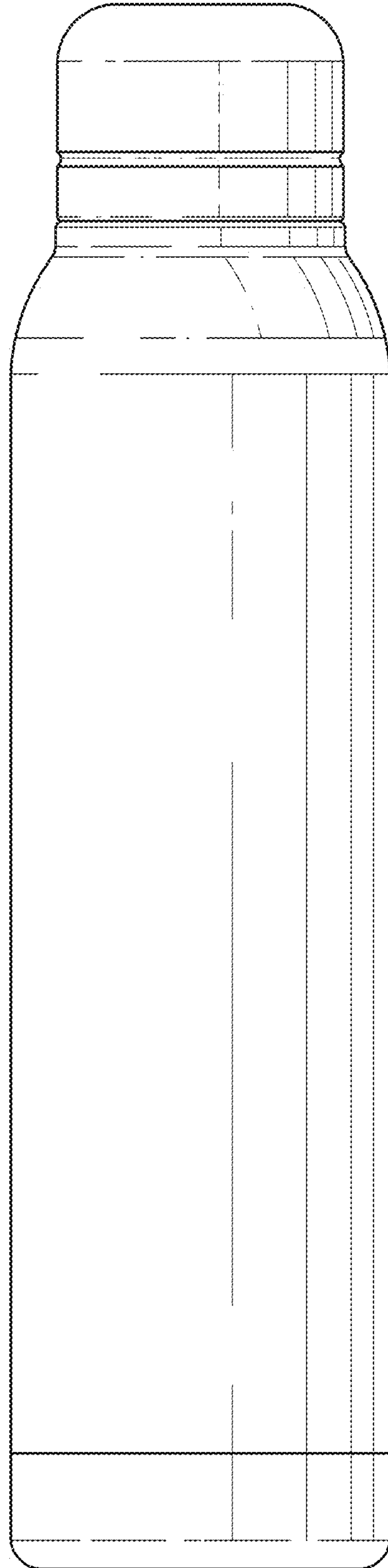

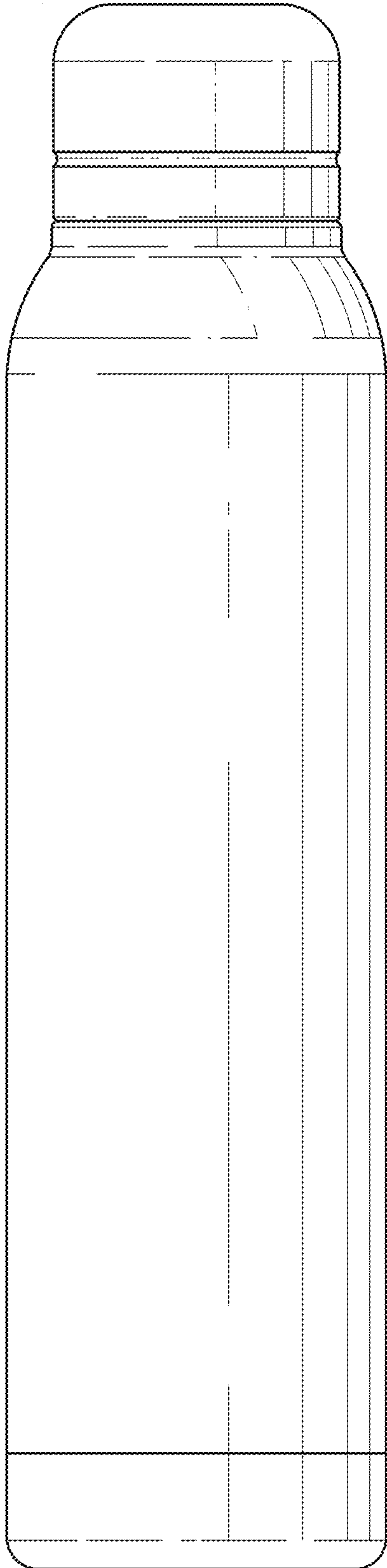
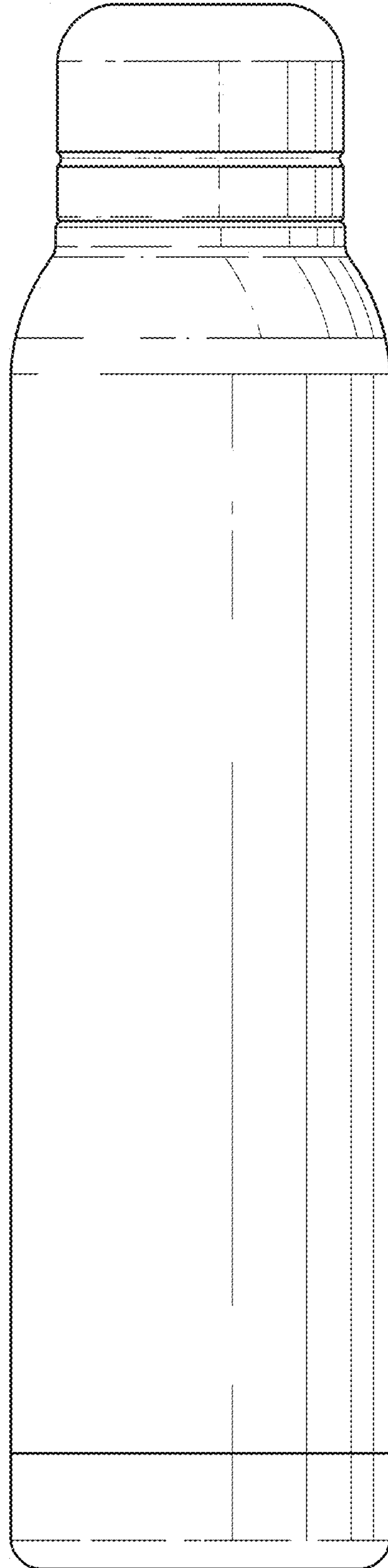

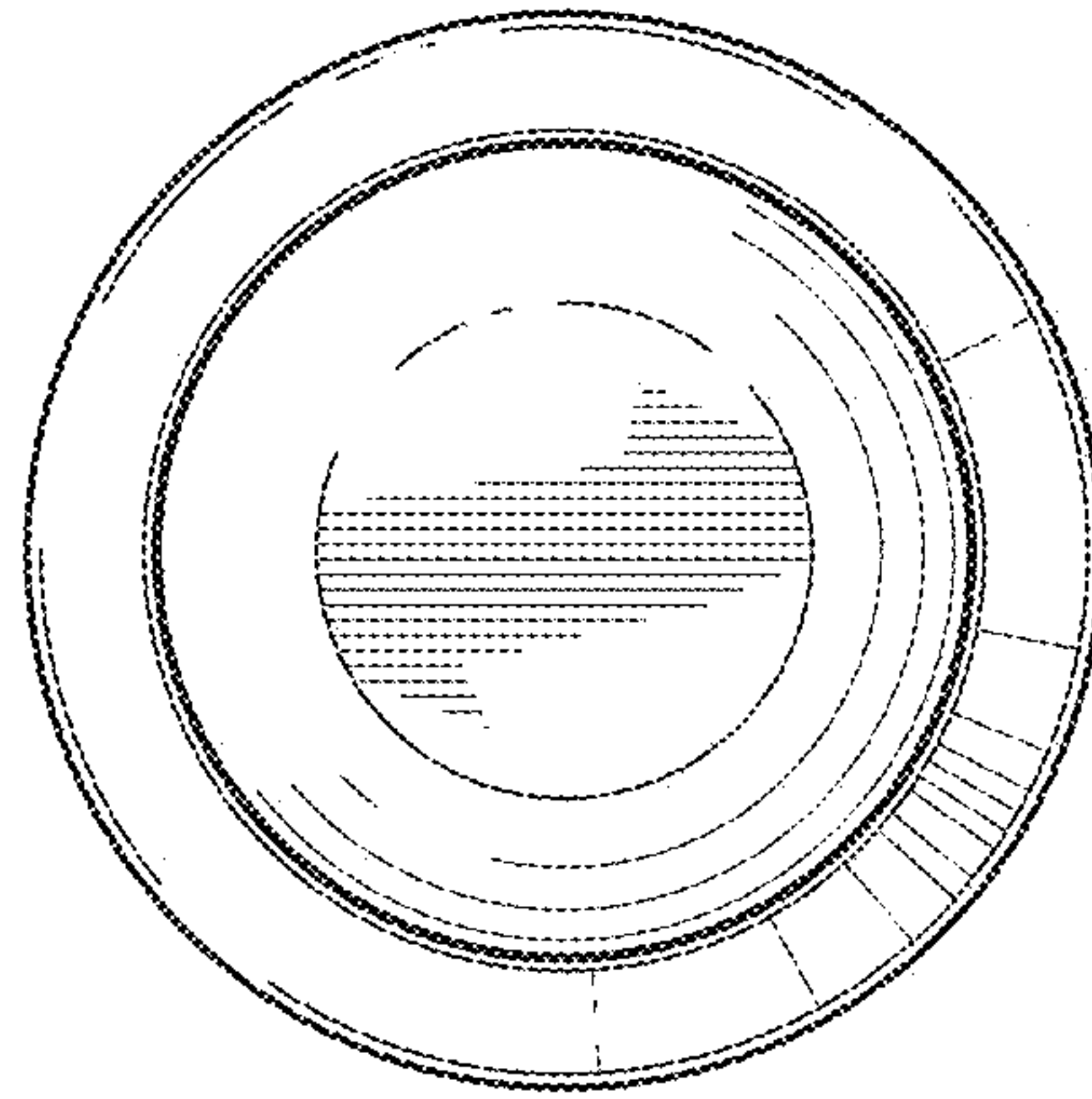

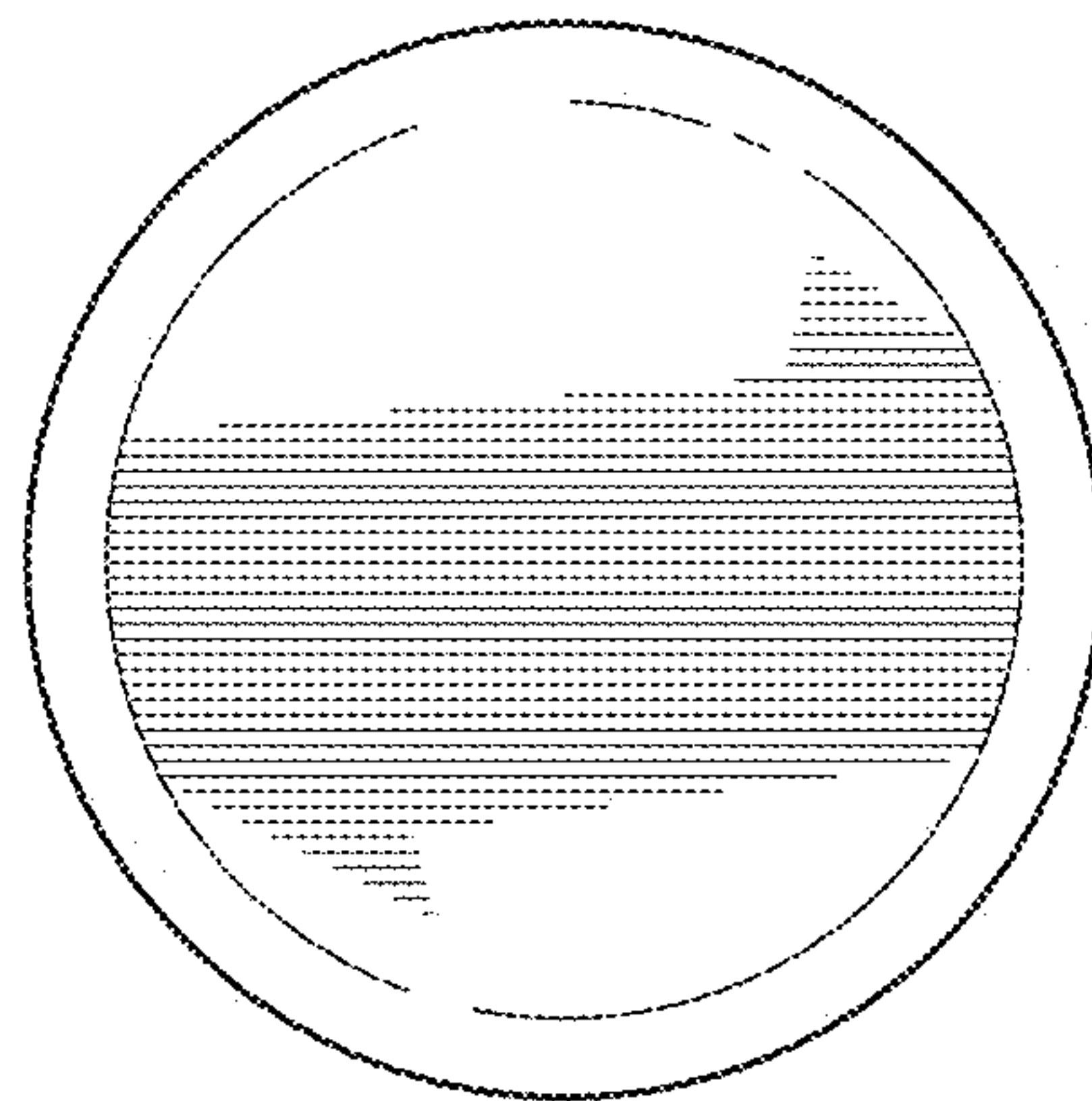

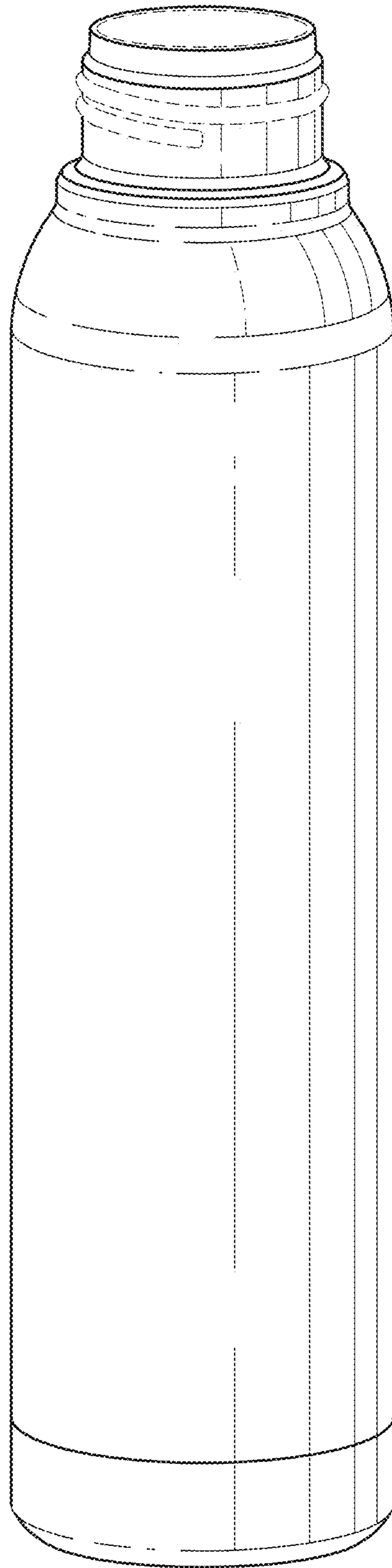

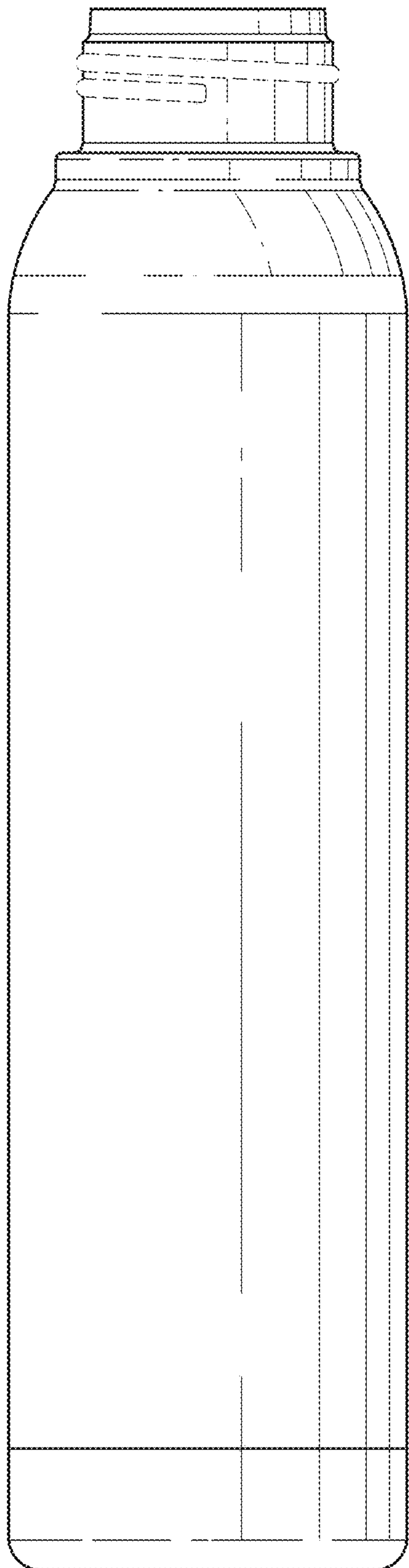

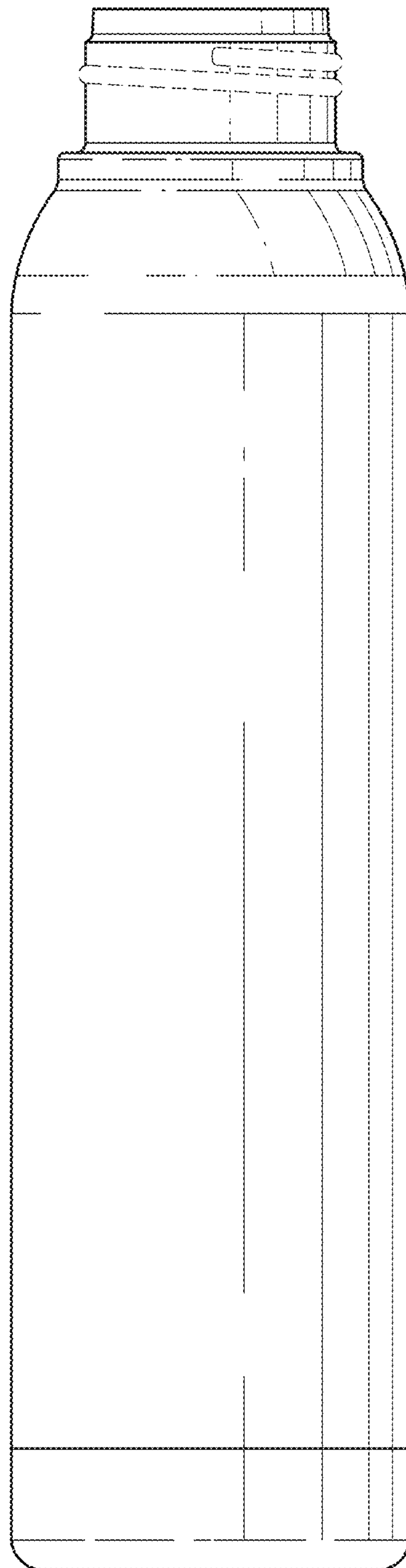

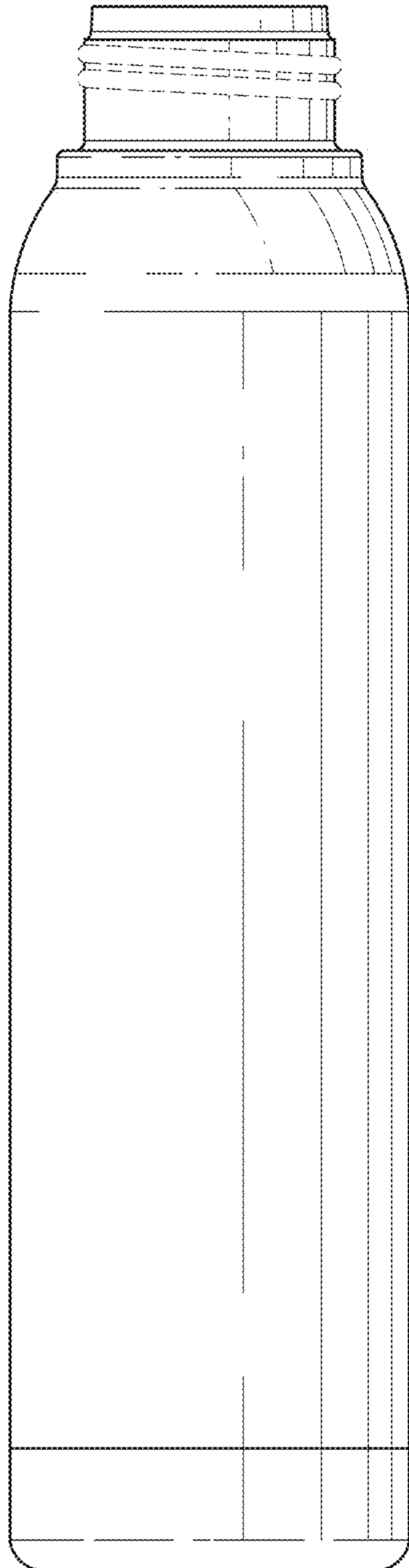
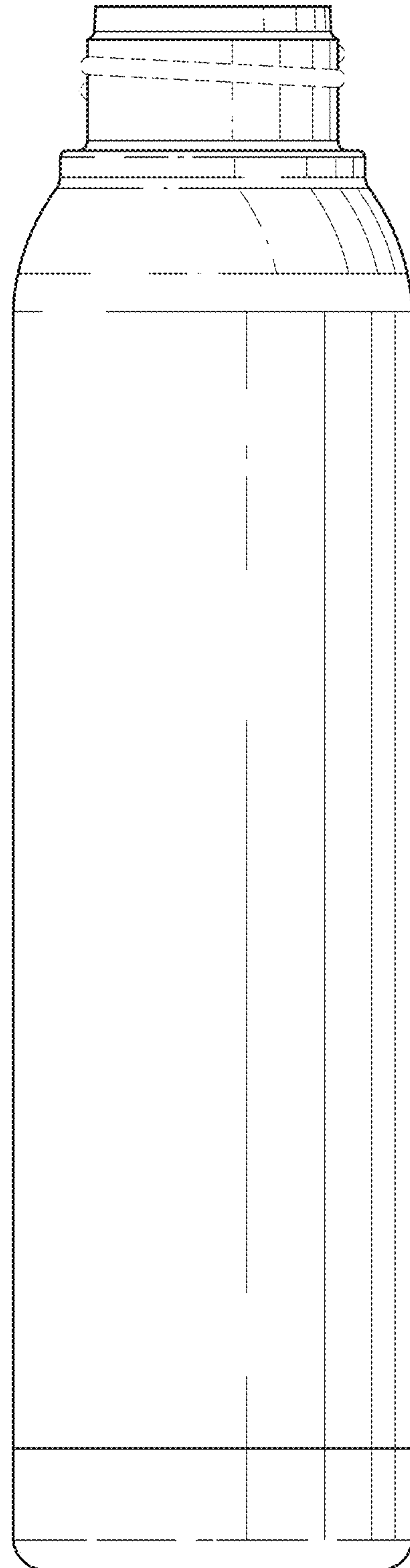

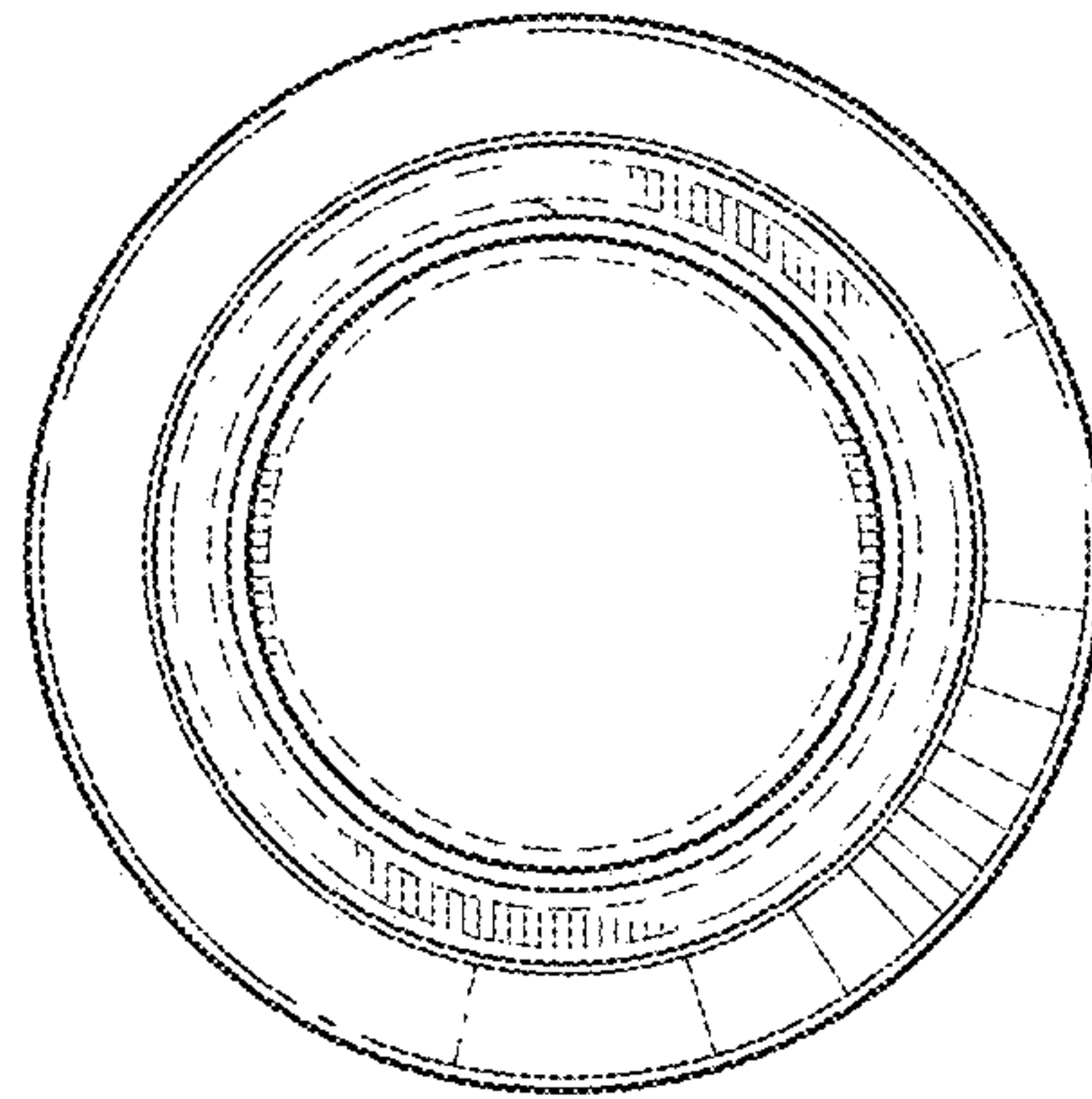

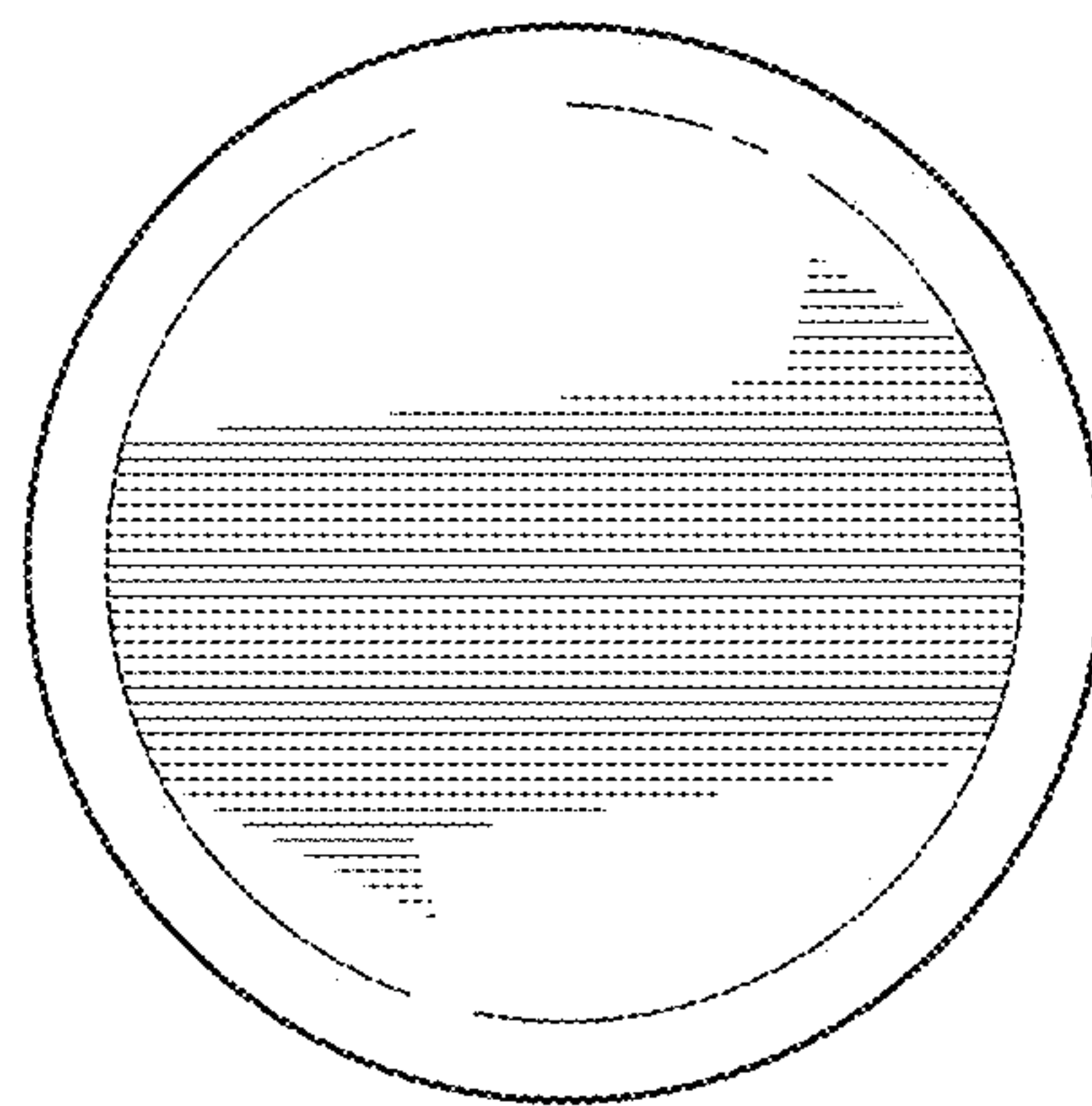
